**DESCRIPTION**

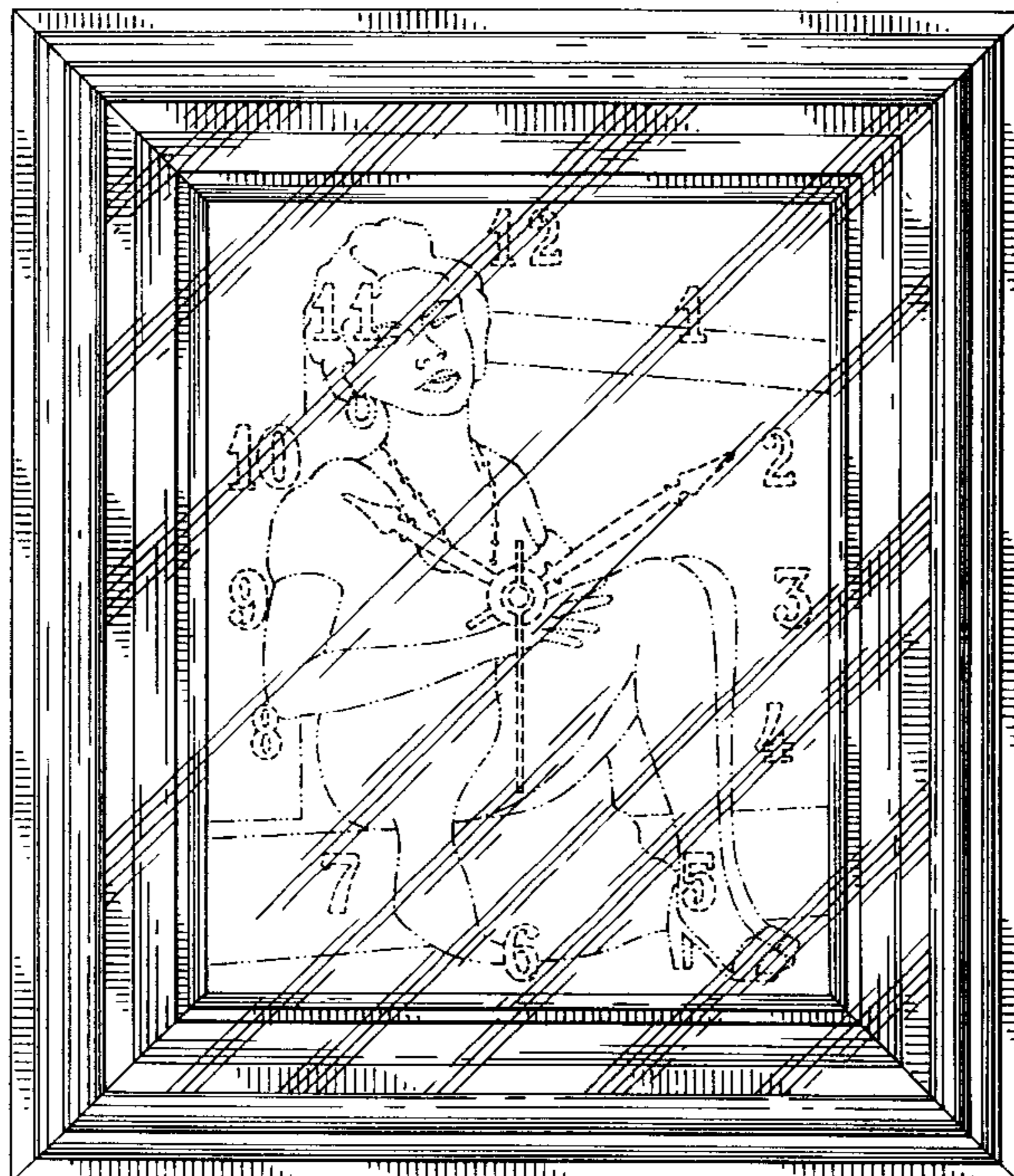

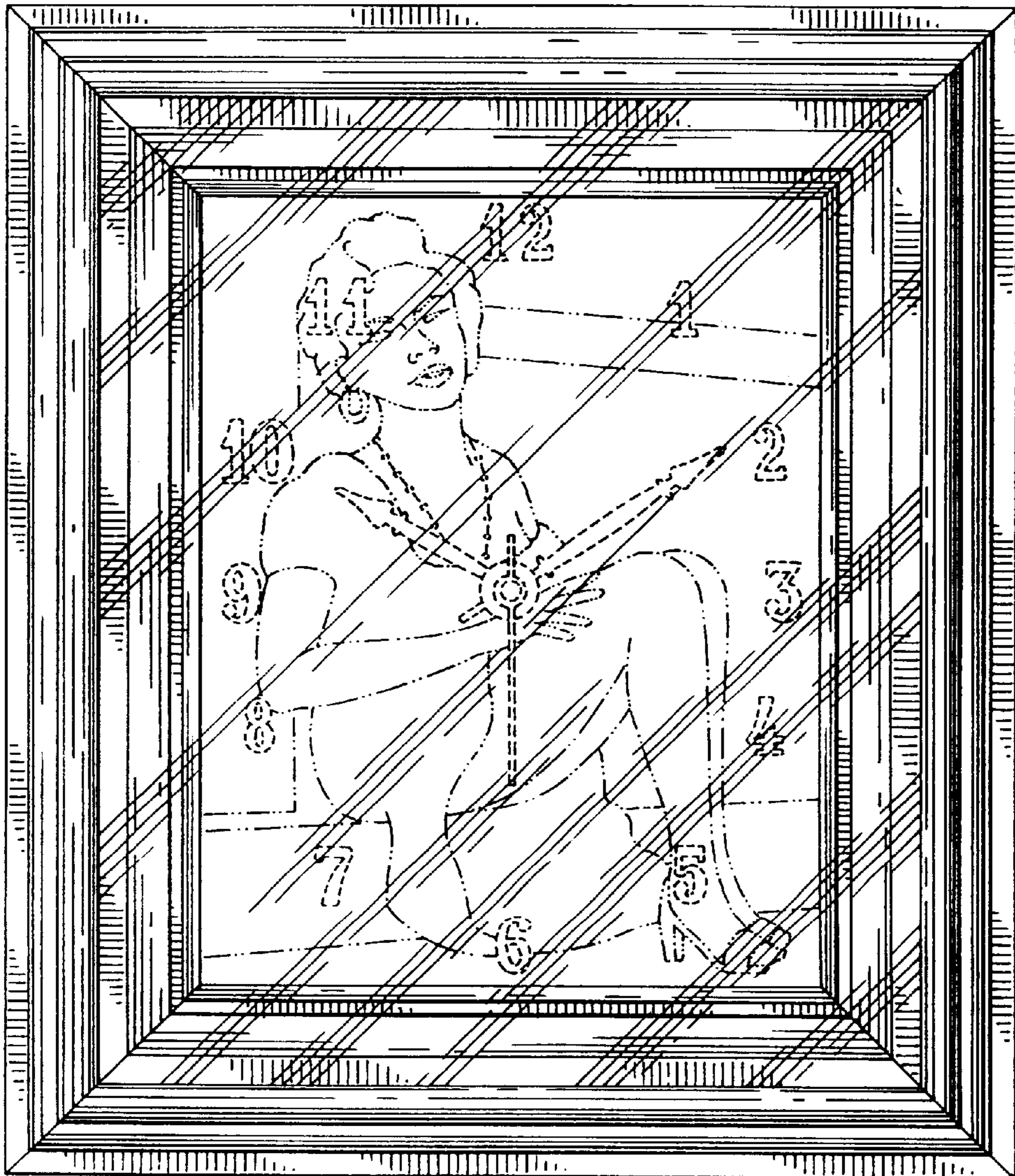
FIG. 2 is a top view of the design;

FIG. 3 is a back view of the design; and,

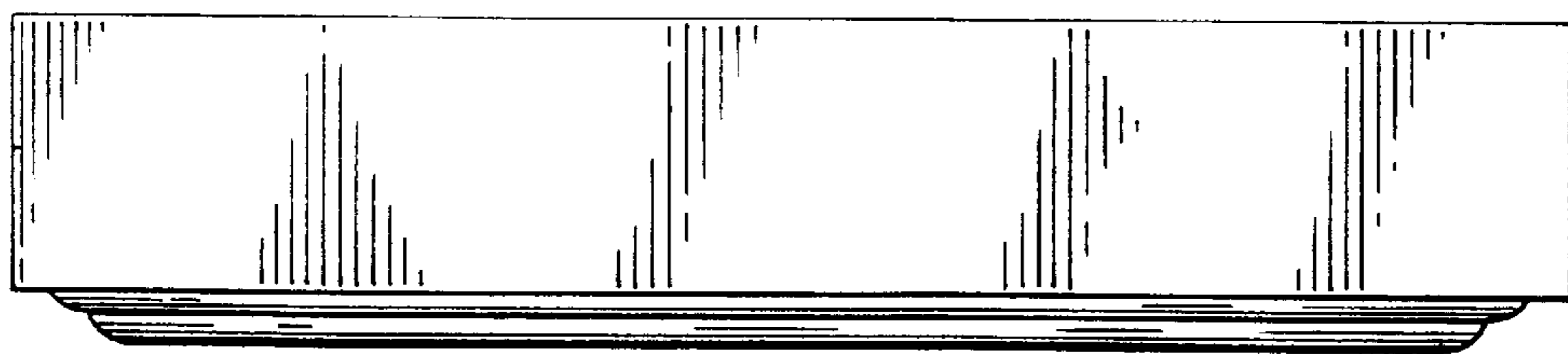
FIG. 4 is a side view of the design.

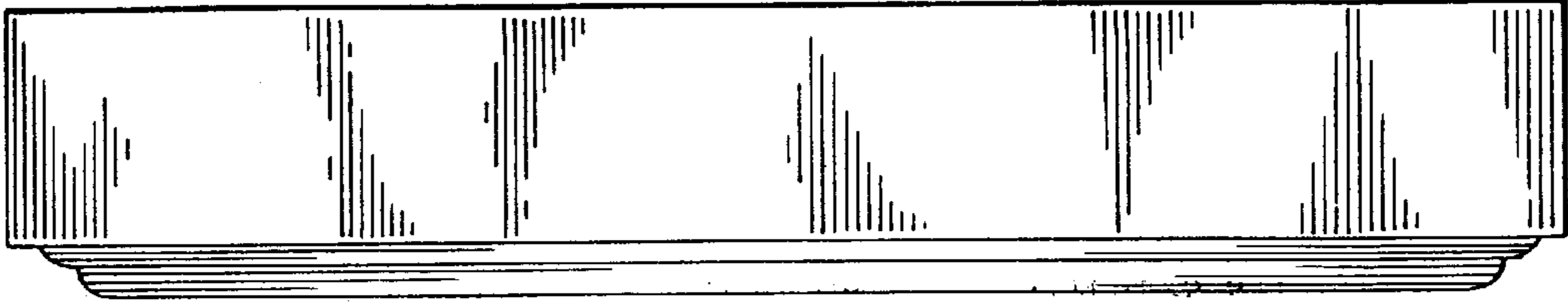




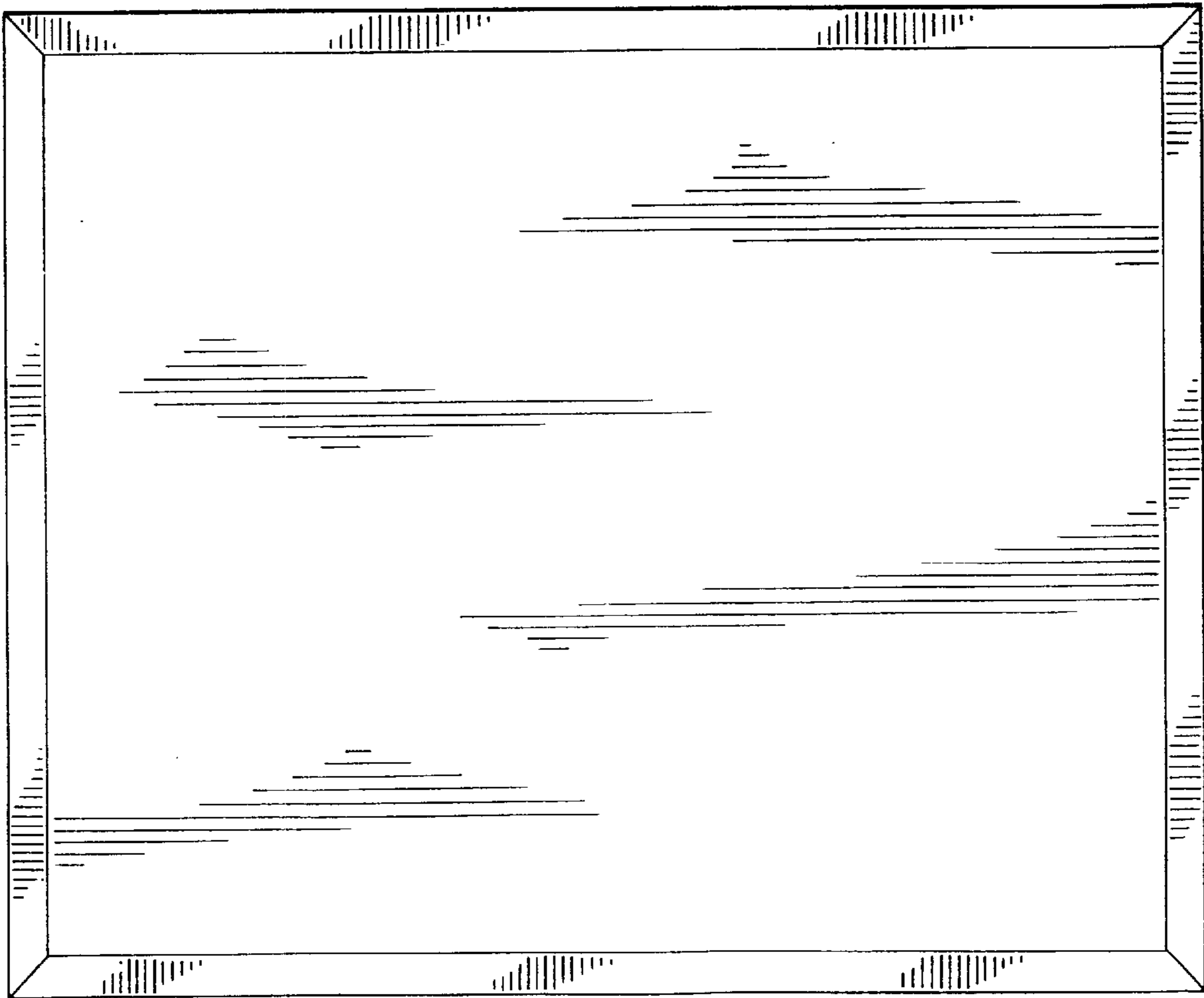
