DESCRIPTION

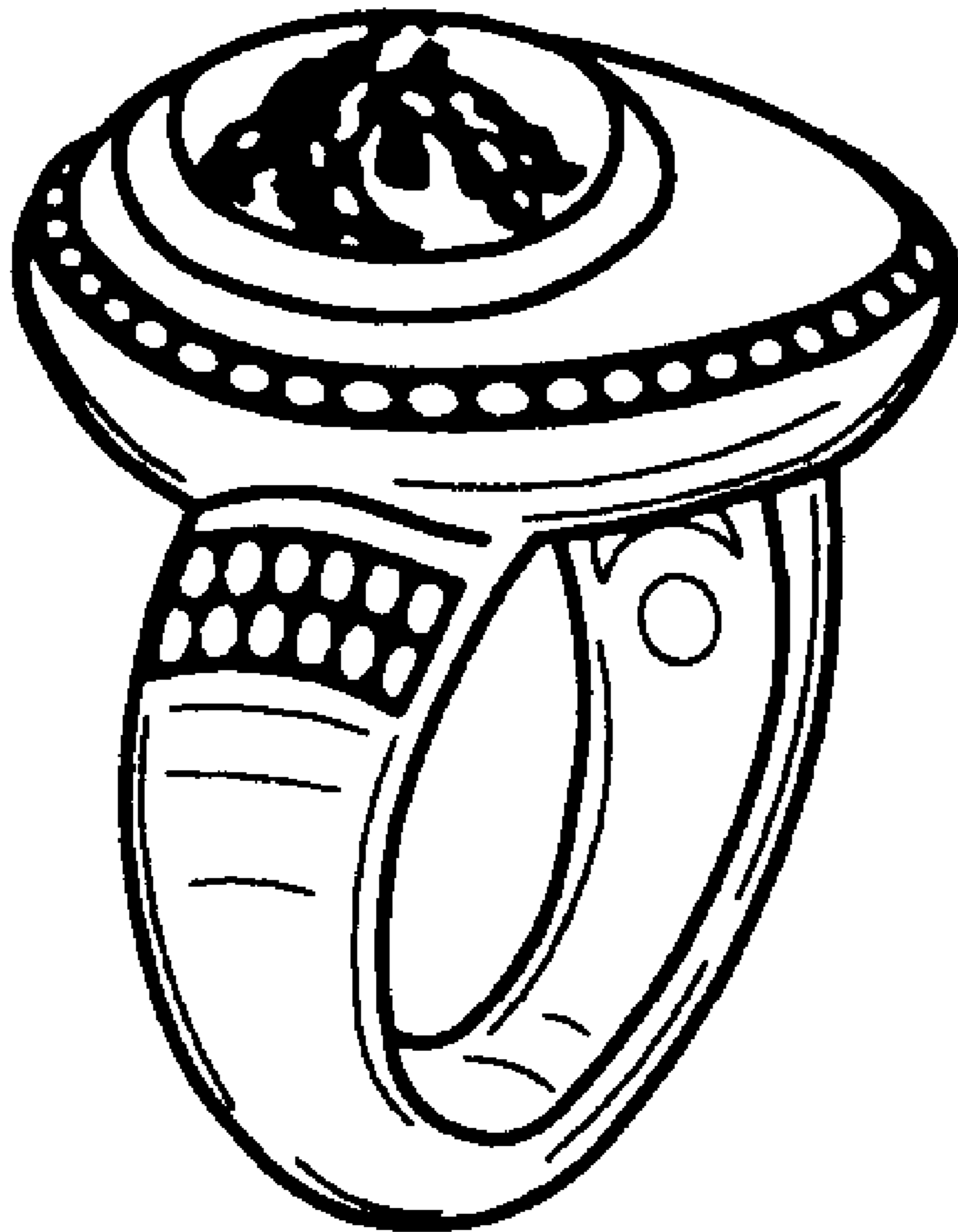
FIG. 1 is a perspective view of a ring showing my new design;

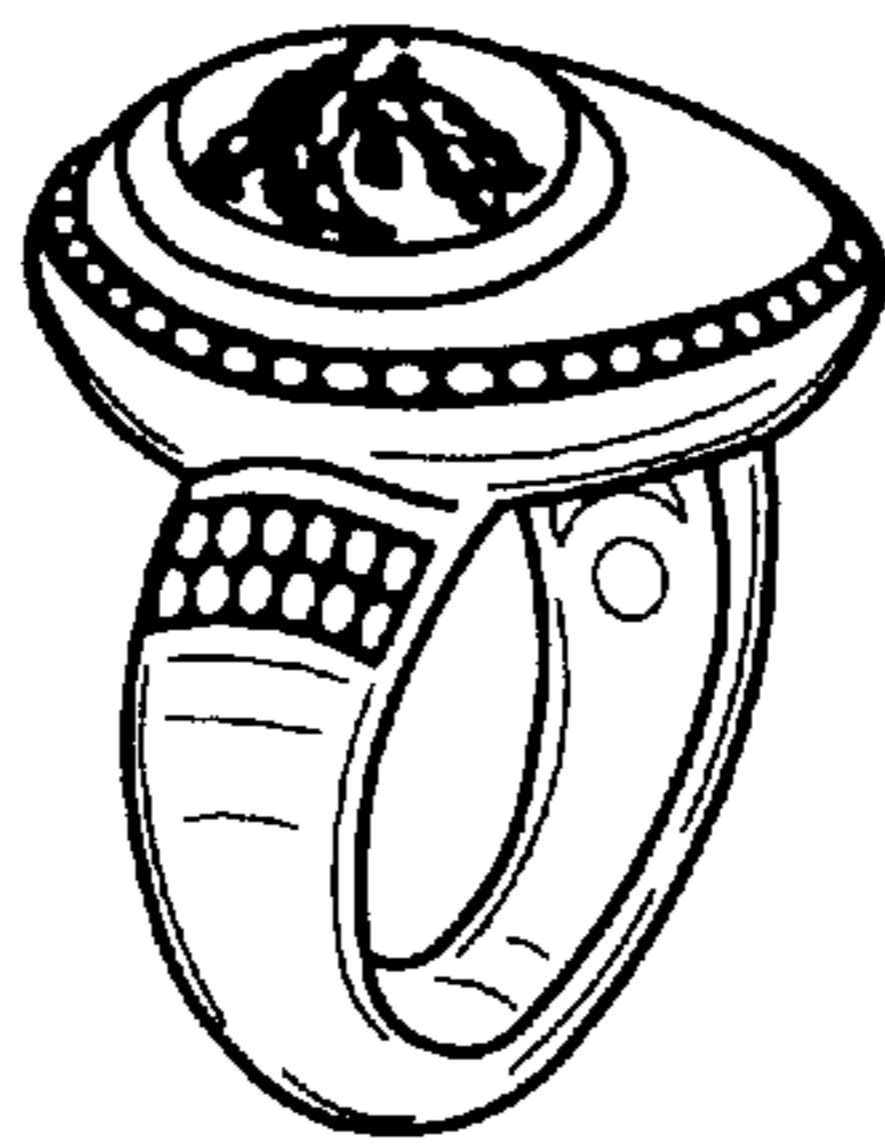

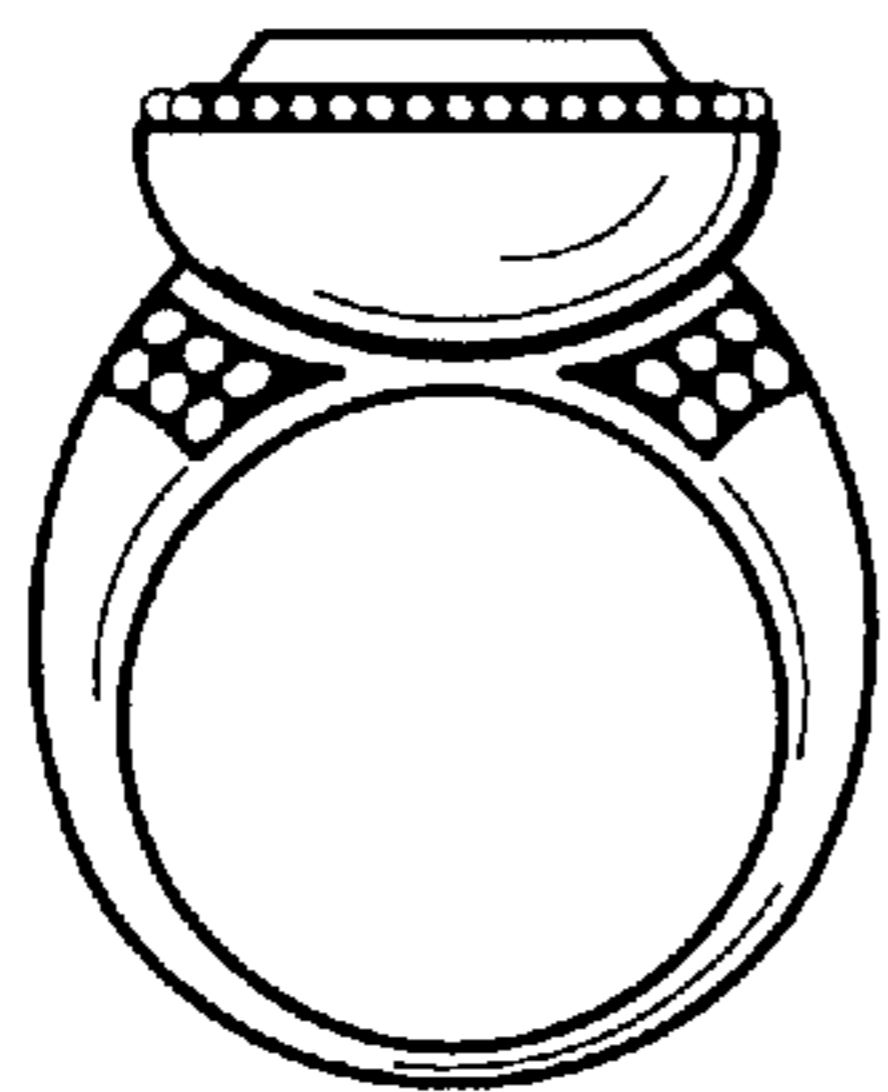

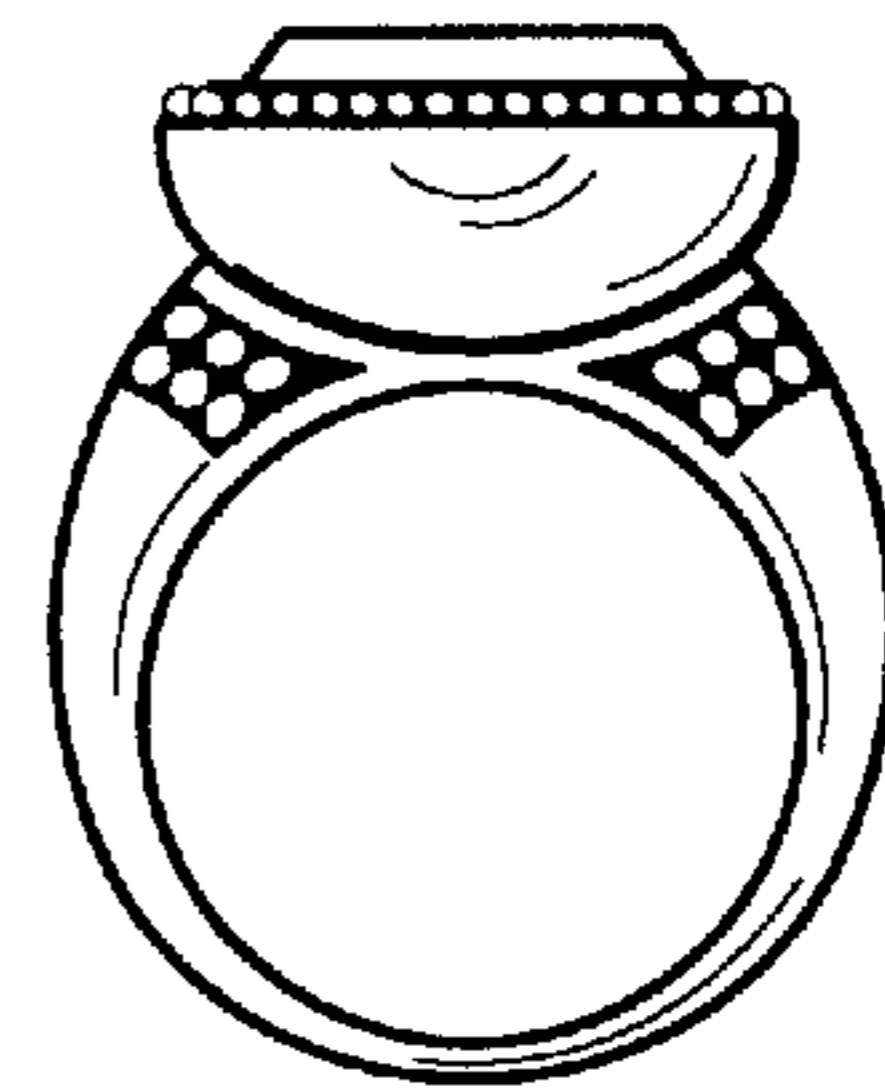

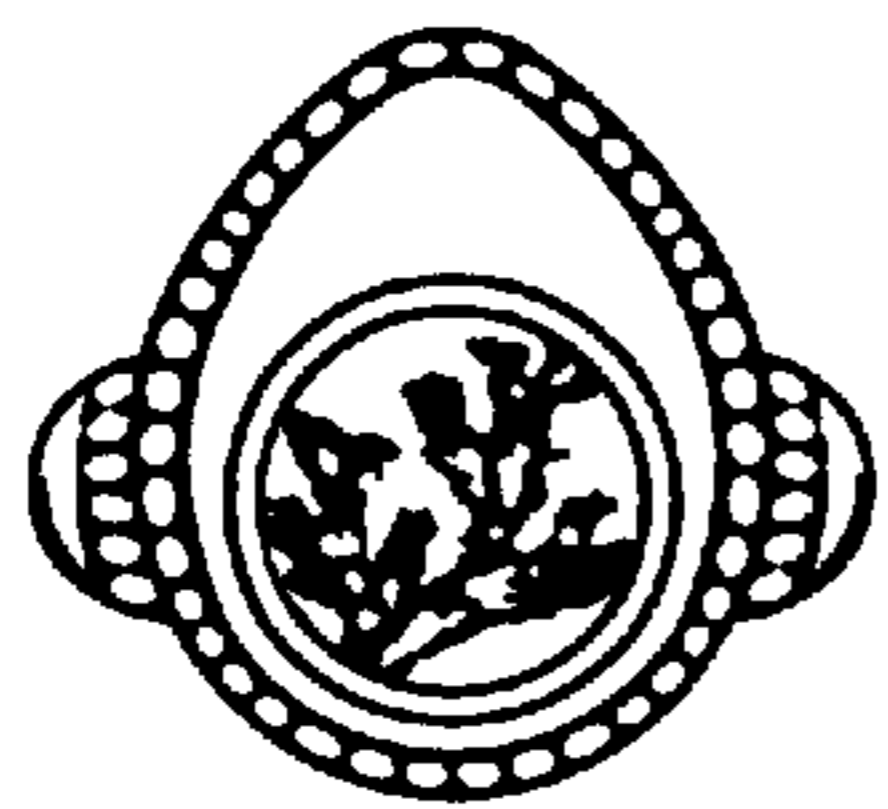

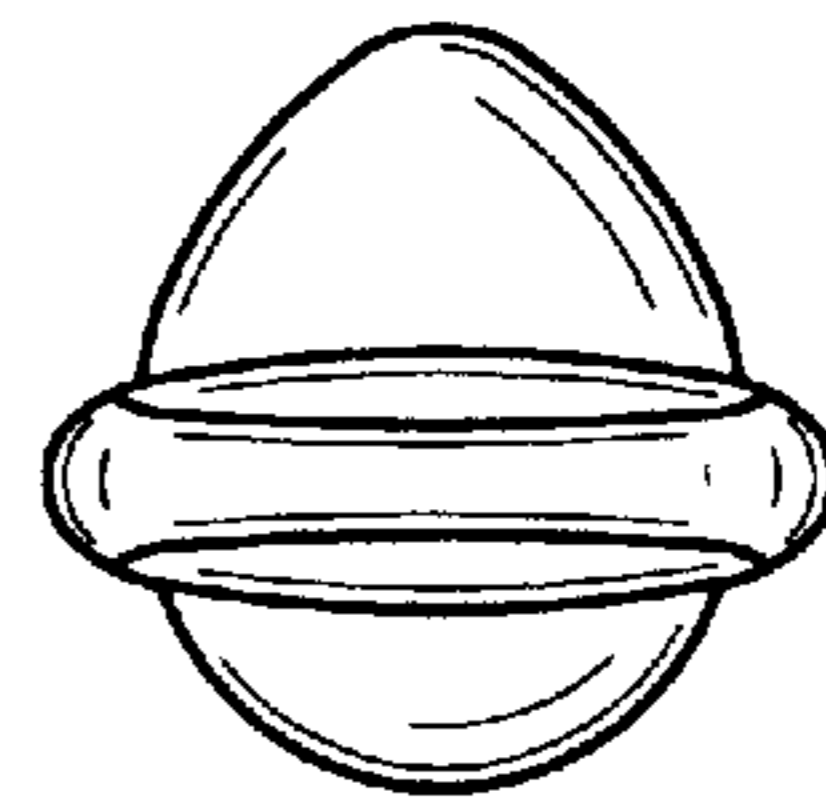

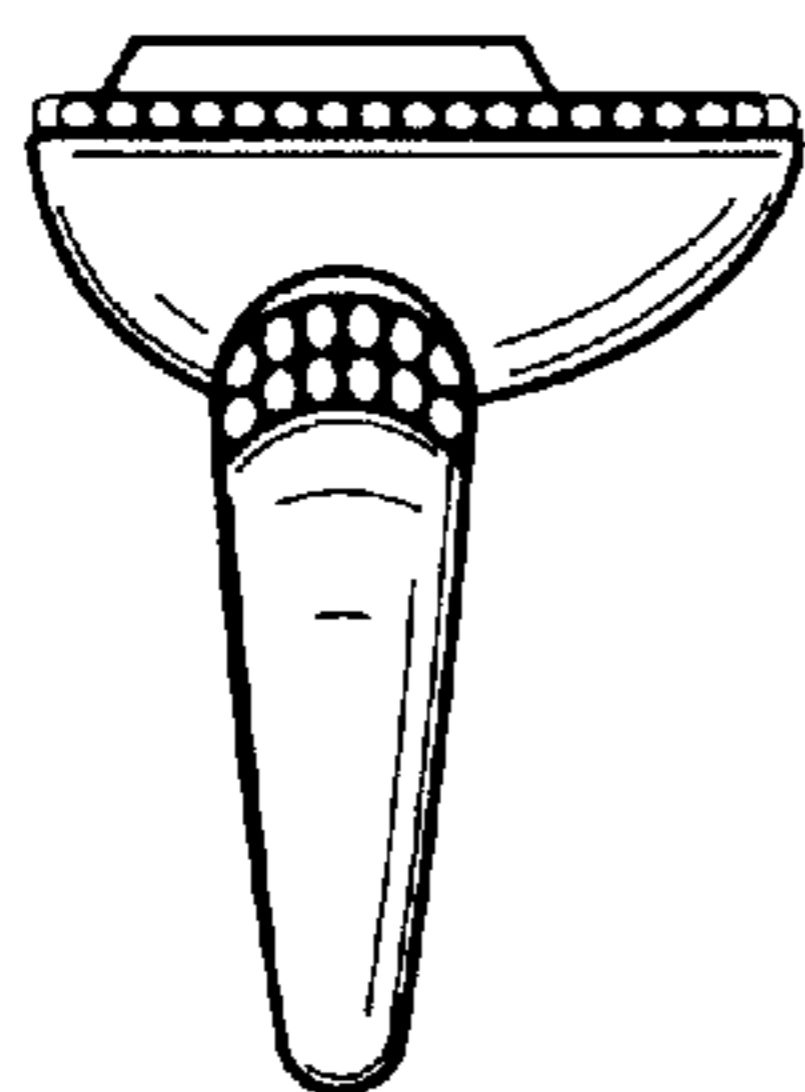

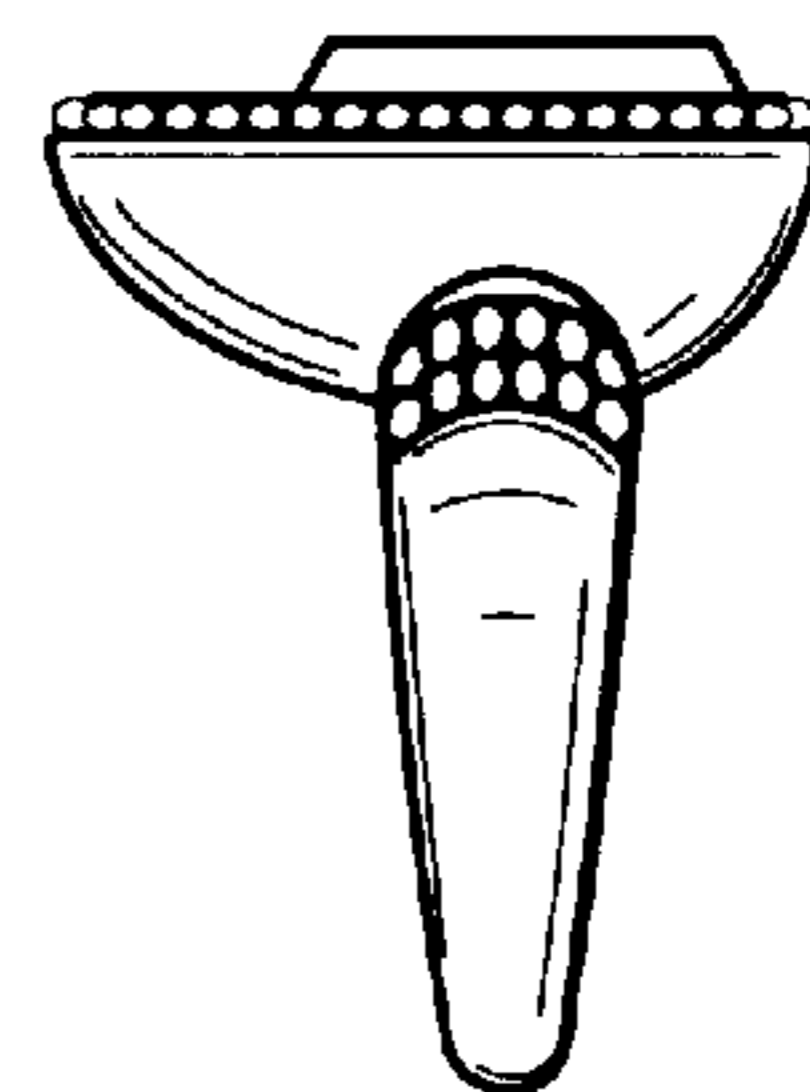
