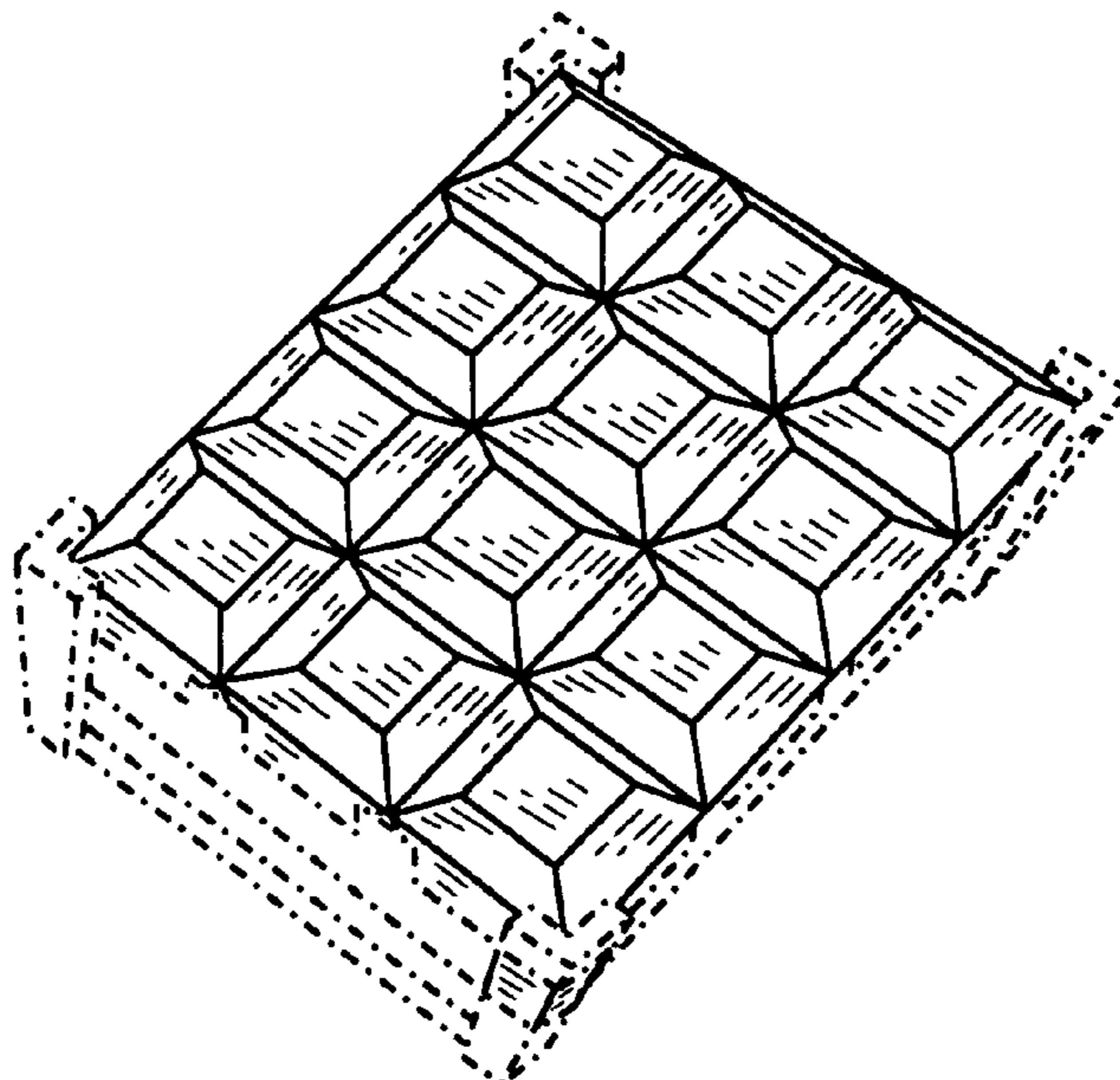
(57) **CLAIM**

The ornamental design for a jewelry setting, as shown and described.

**DESCRIPTION**

FIG. 1 is a top view of a first embodiment of a jewelry setting;  
 FIG. 2 is a perspective view of the jewelry setting of FIG. 1;  
 FIG. 3 is another perspective view of the jewelry setting of FIG. 1;  
 FIG. 4 is a side view of the jewelry setting of FIG. 1;  
 FIG. 5 is a perspective view of the jewelry setting of FIG. 1 in a pendant;  
 FIG. 6 is a top view of the jewelry setting of FIG. 5;  
 FIG. 7 is a perspective view of the jewelry setting of FIG. 1 in an earring;  
 FIG. 8 is a side view of the jewelry setting of FIG. 7;  
 FIG. 9 is a top view of the jewelry setting in an earring;  
 FIG. 10 is a side view of the jewelry setting of FIG. 9;  
 FIG. 11 is a top view of the jewelry setting in a ring; and  
 FIG. 12 is a top view of the jewelry setting in another ring.

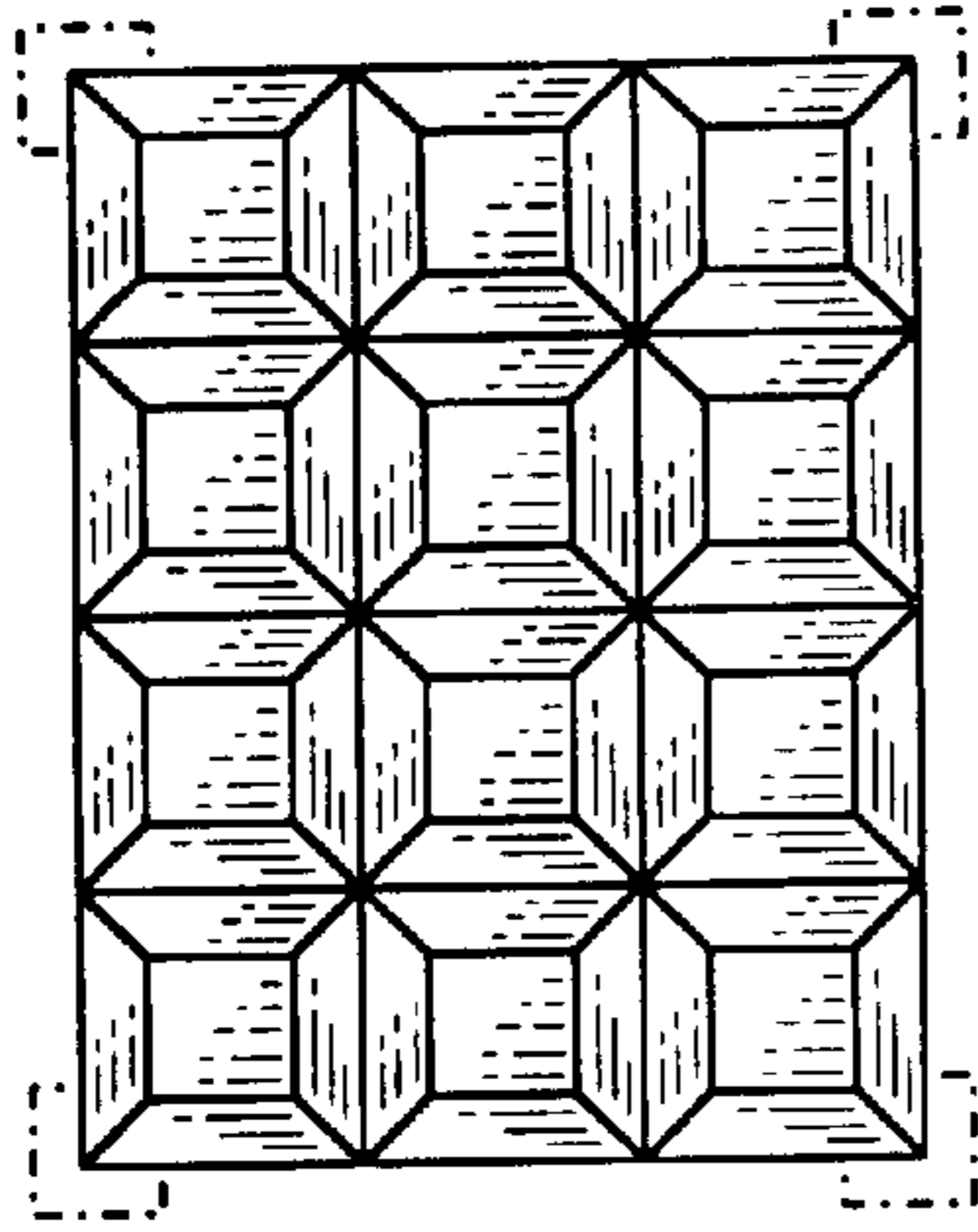

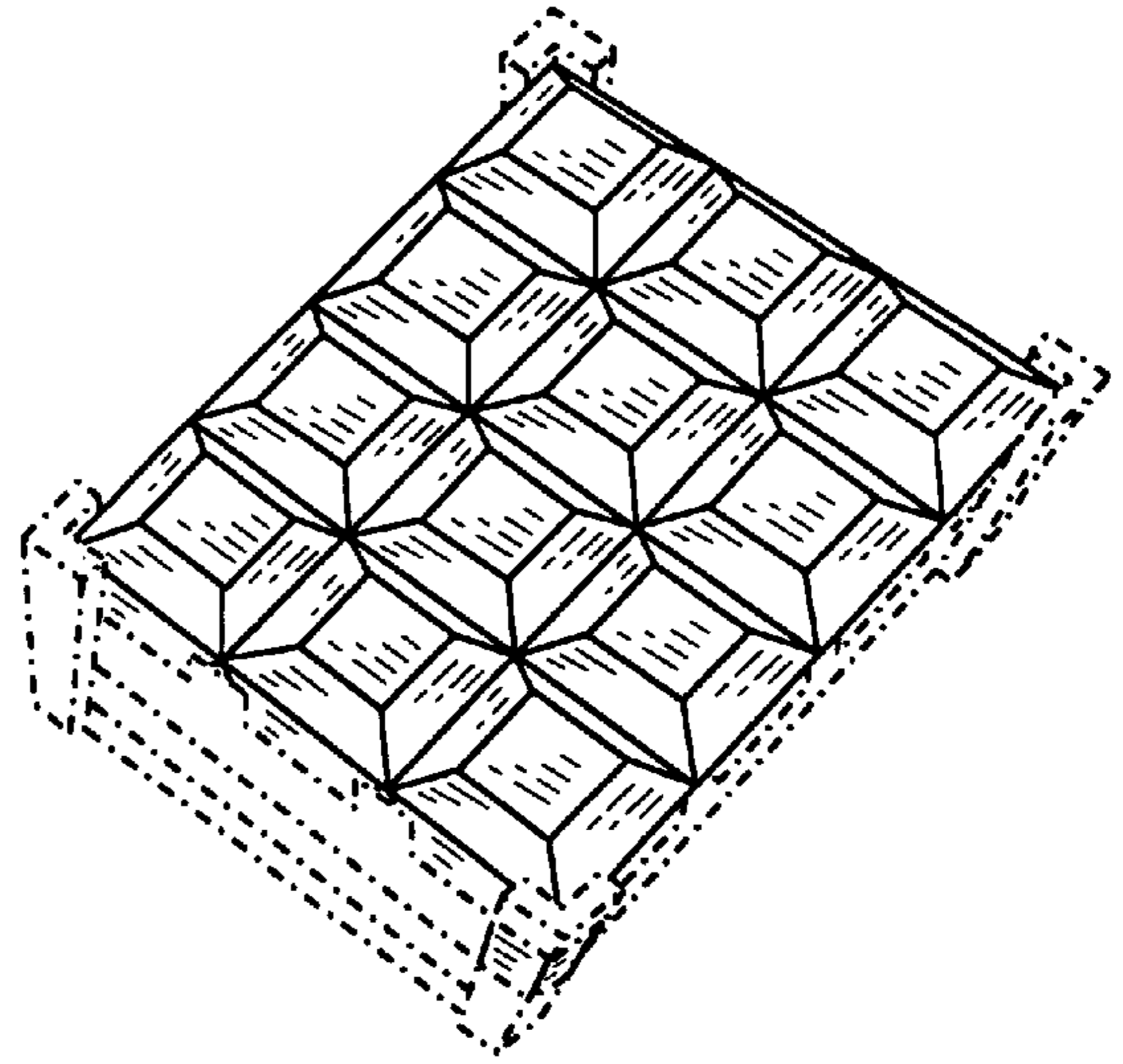

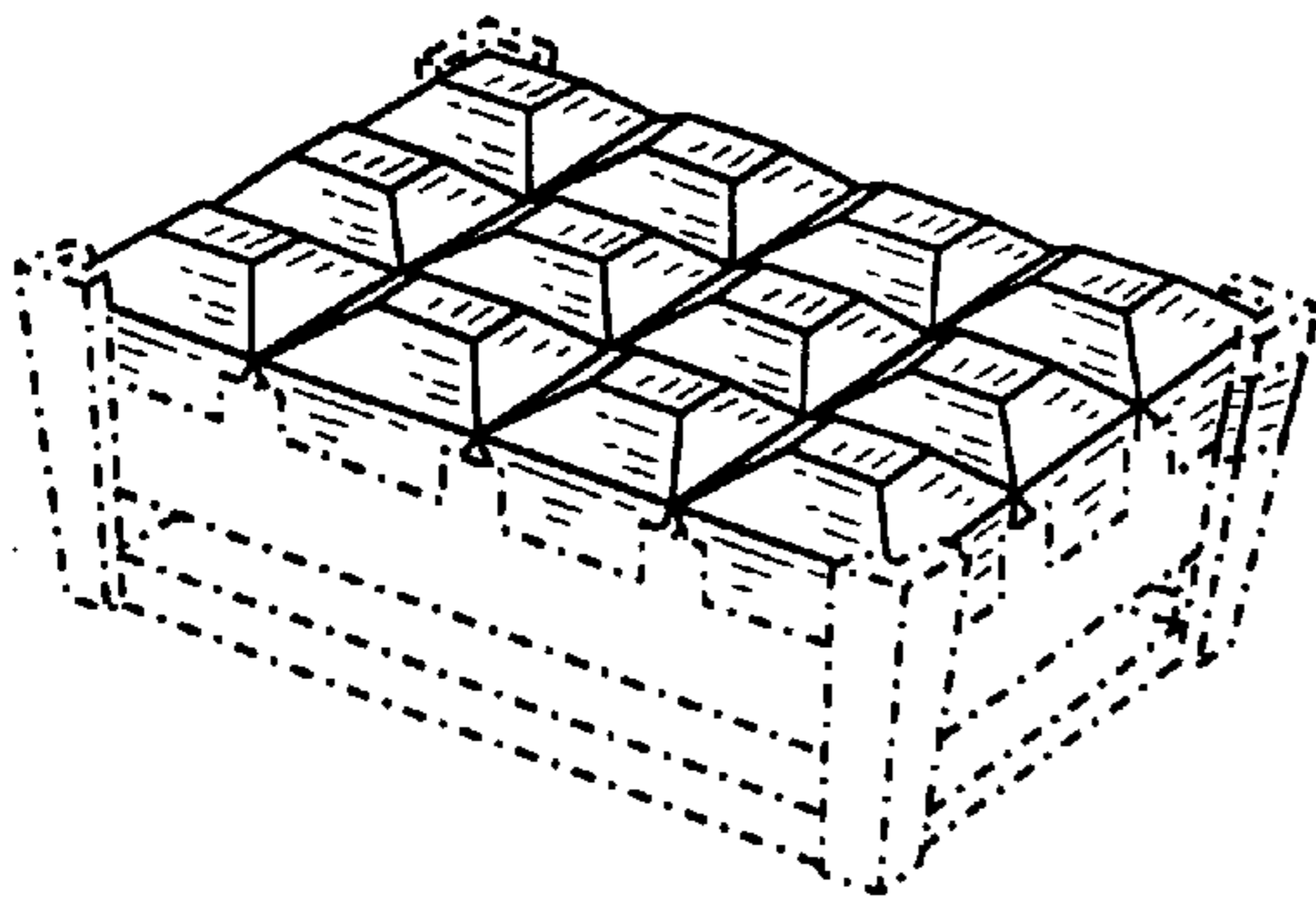

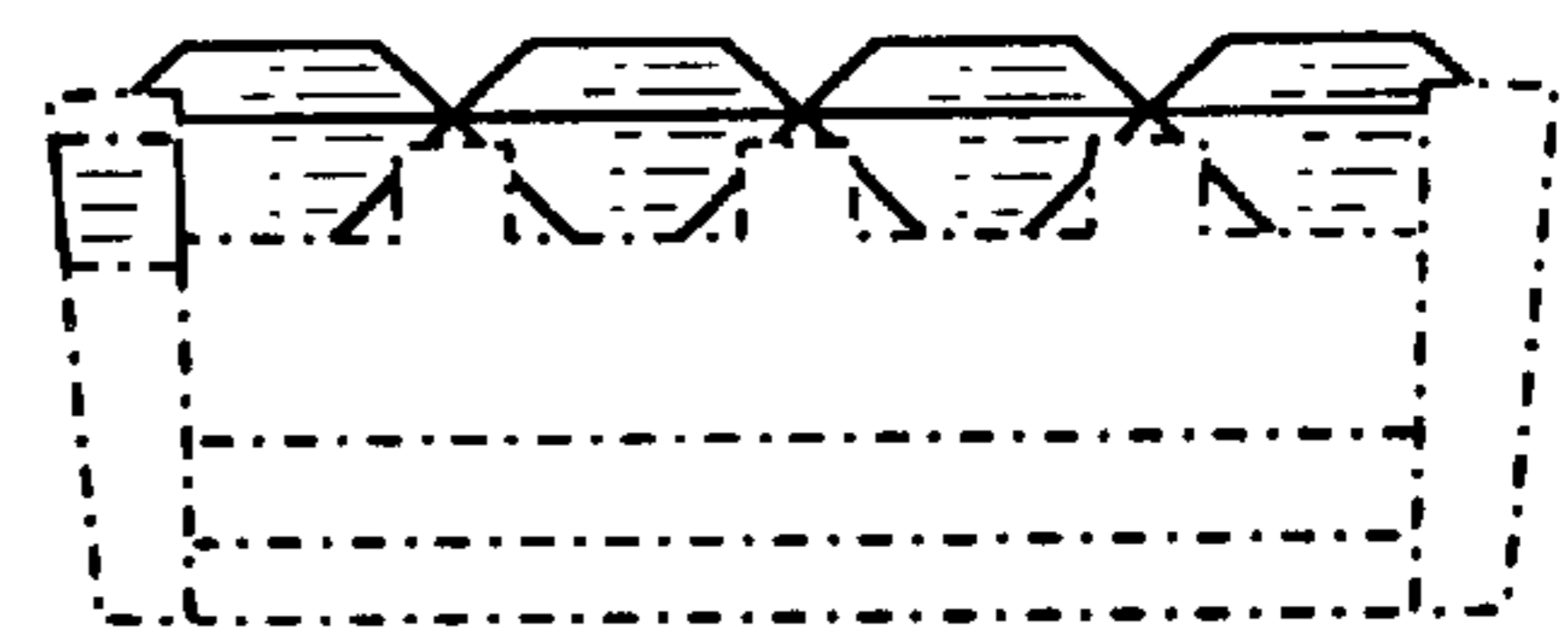

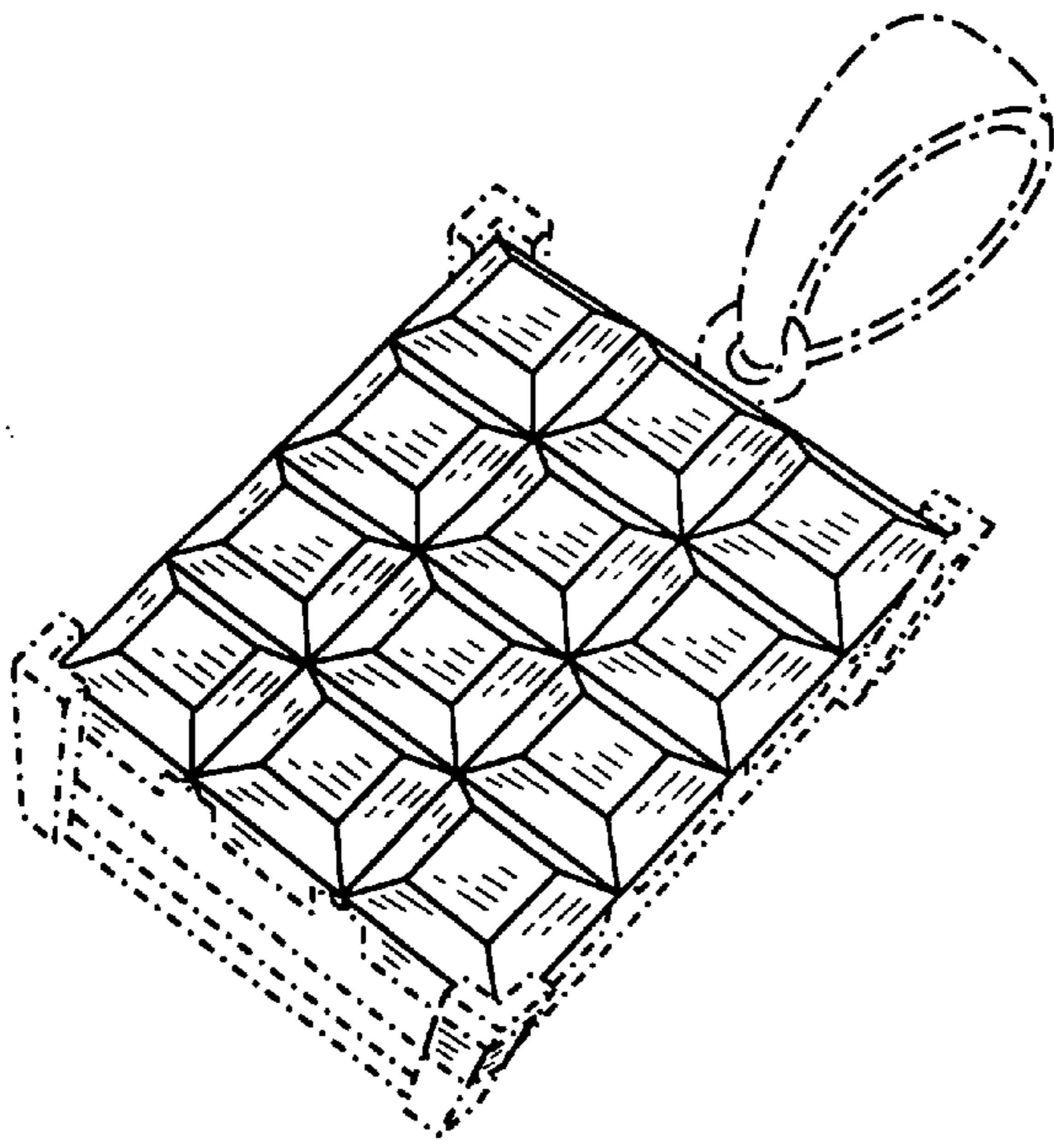

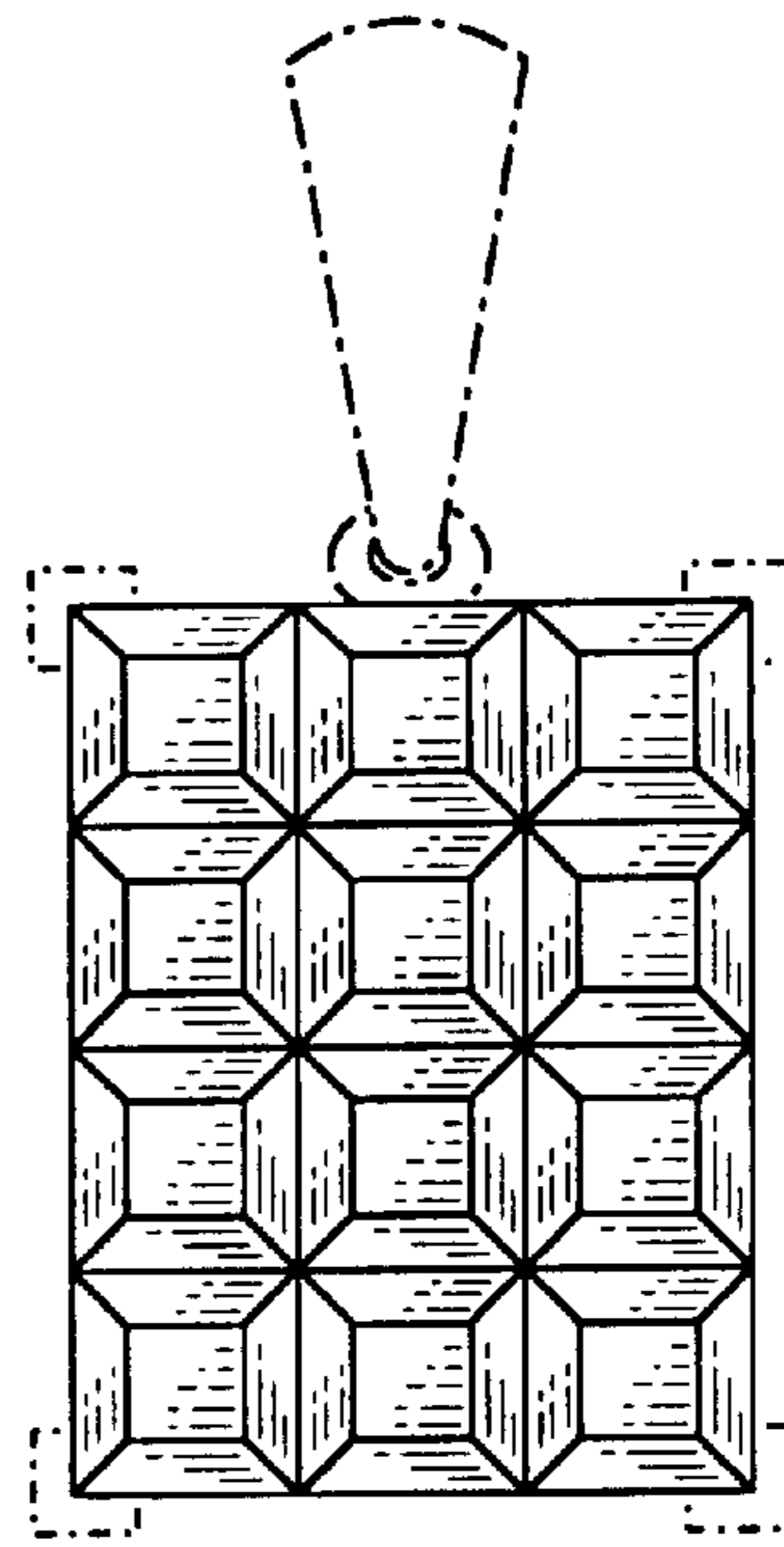

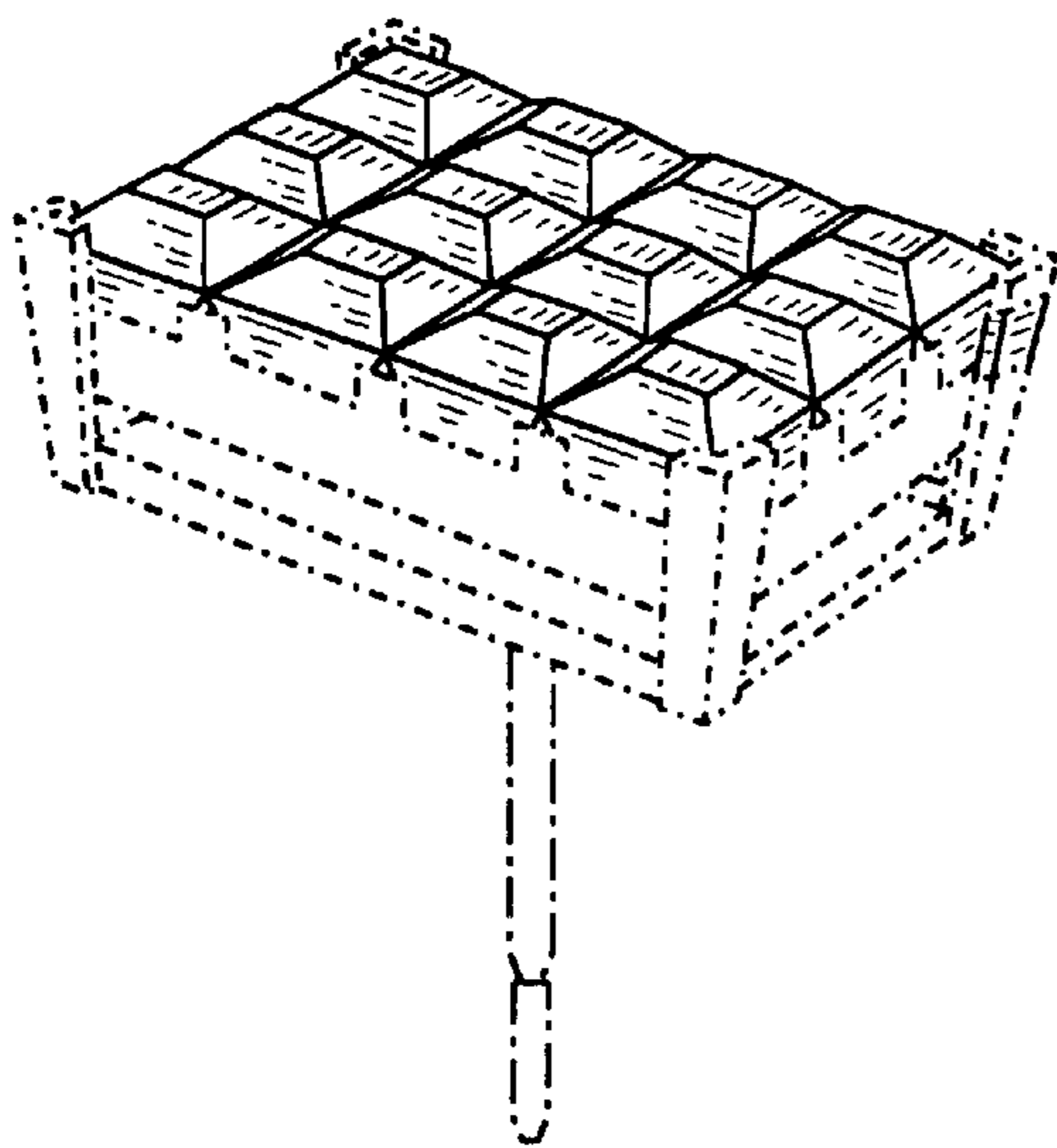

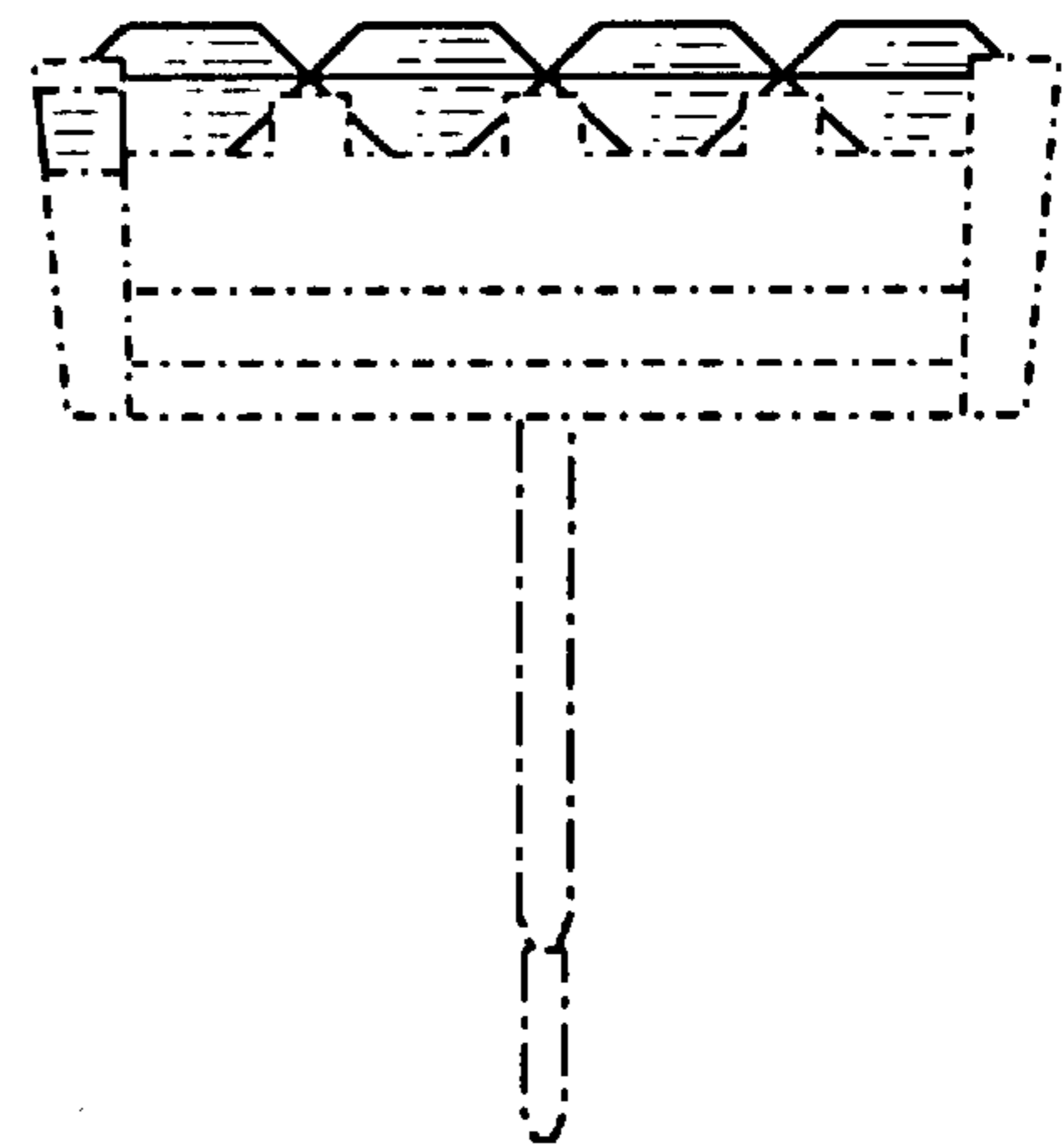

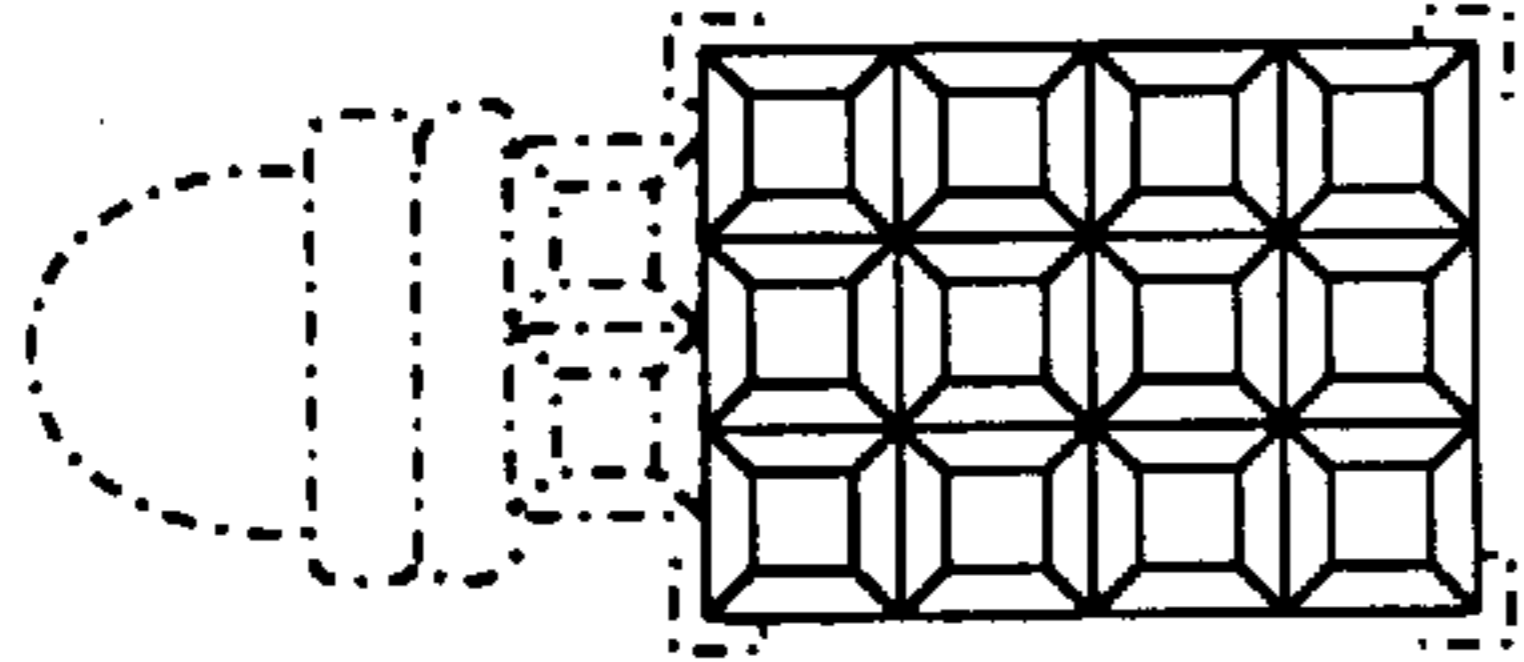

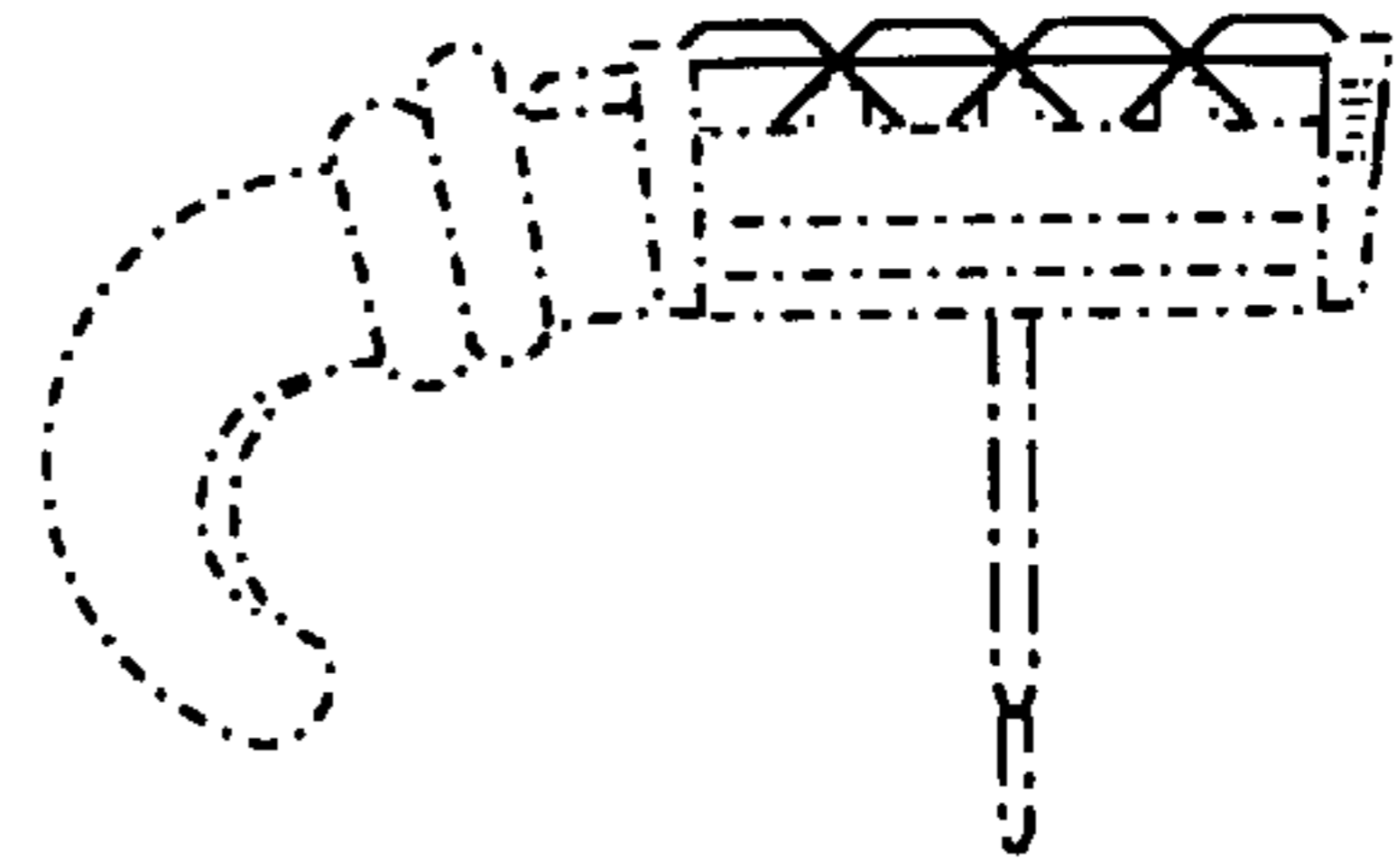

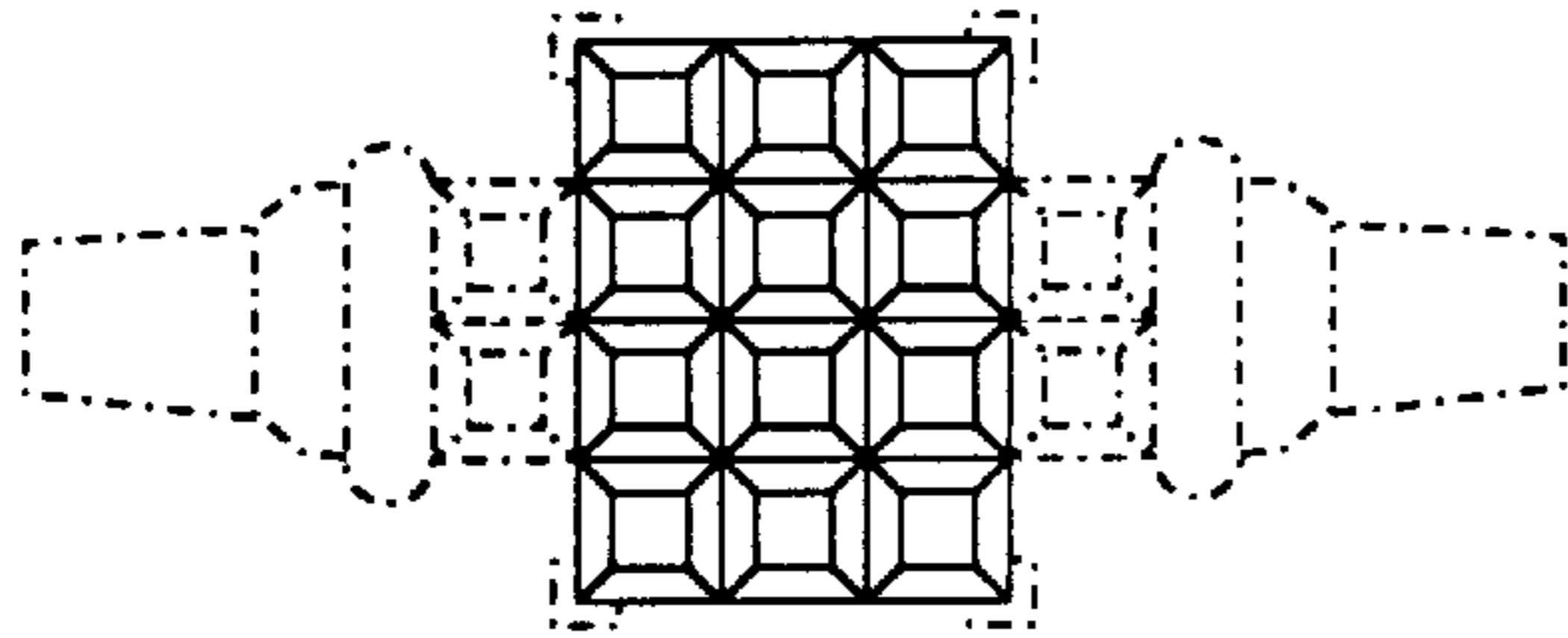

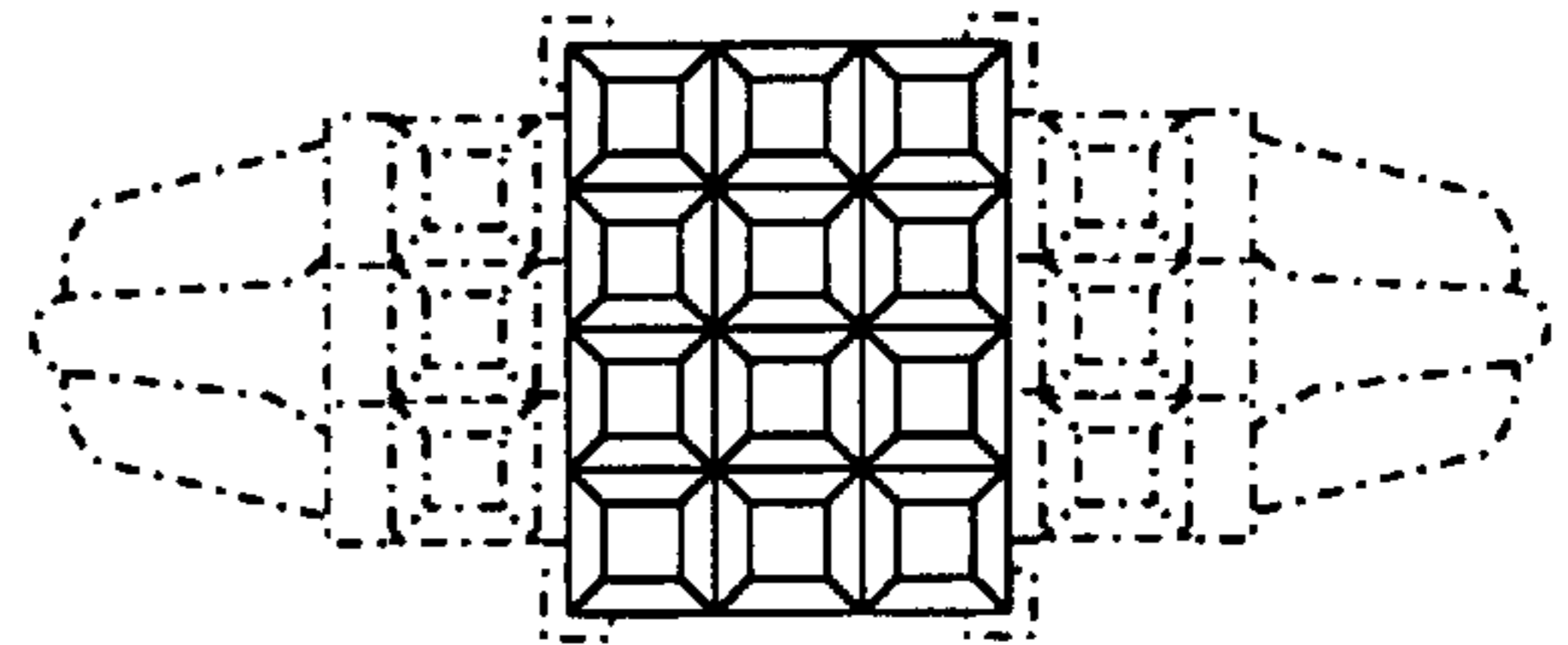
