FIG. 1 is a perspective view of the oval planter from above according to my design.

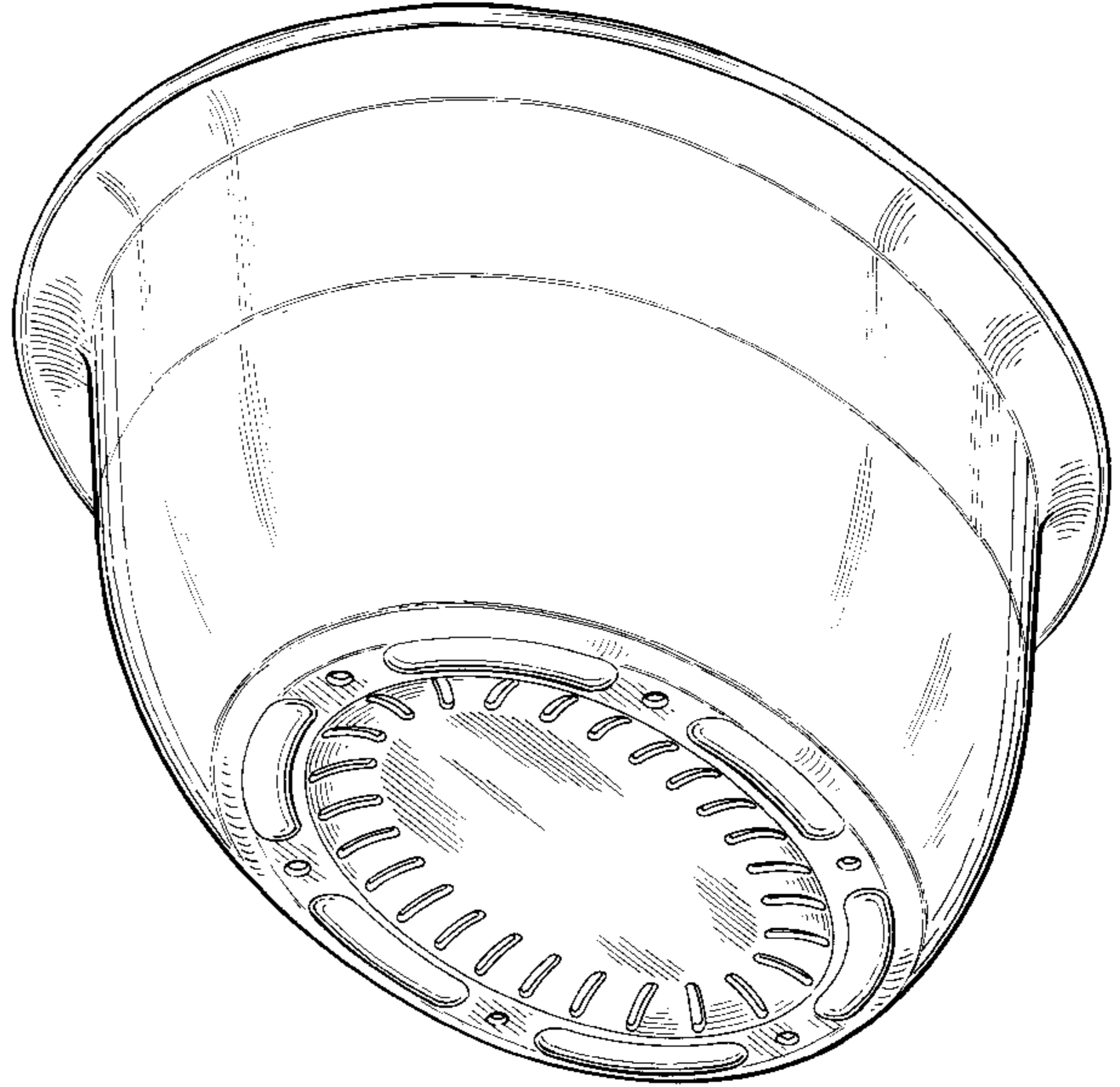
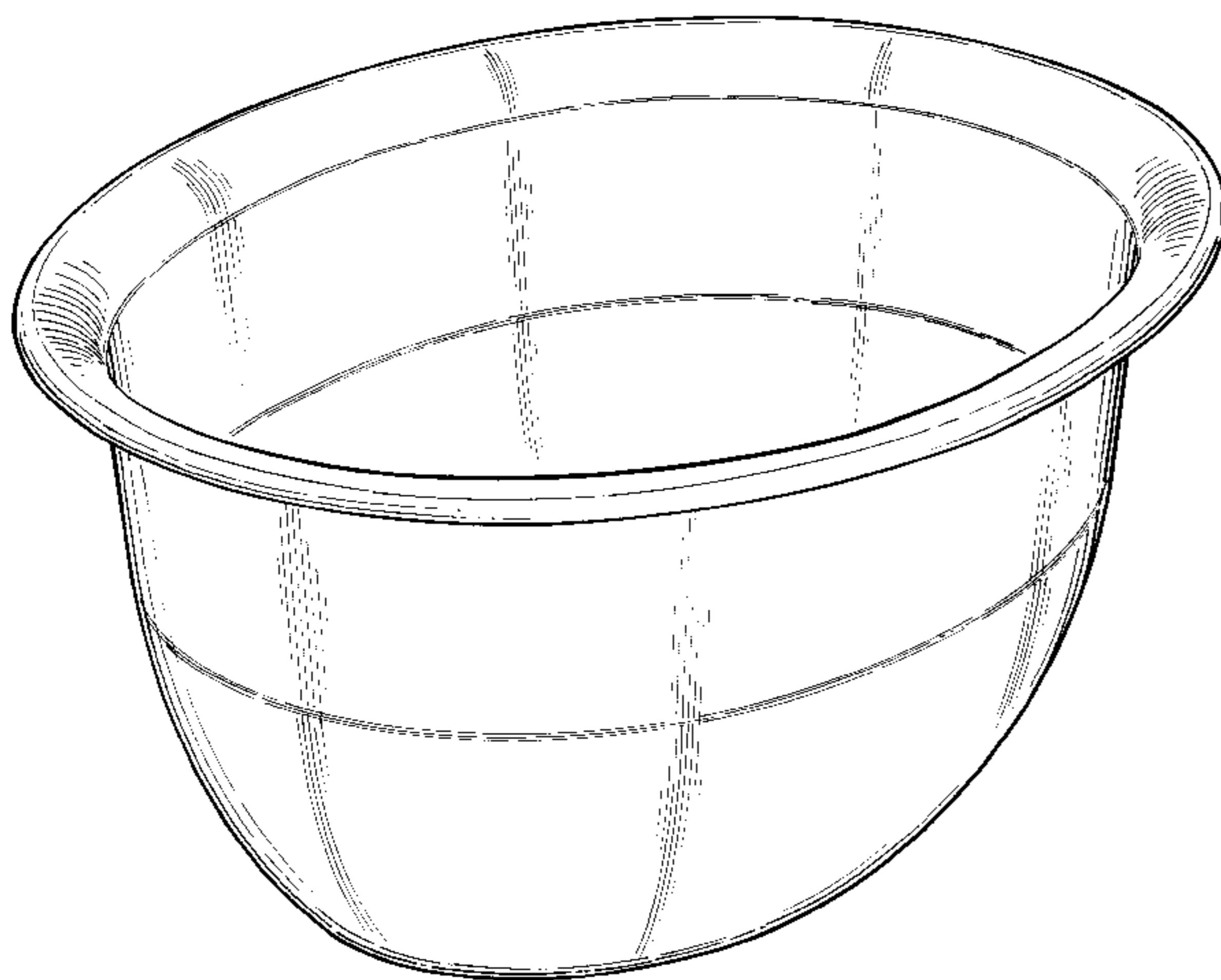
FIG. 2 is a perspective view of the oval planter from below of FIG. 1.

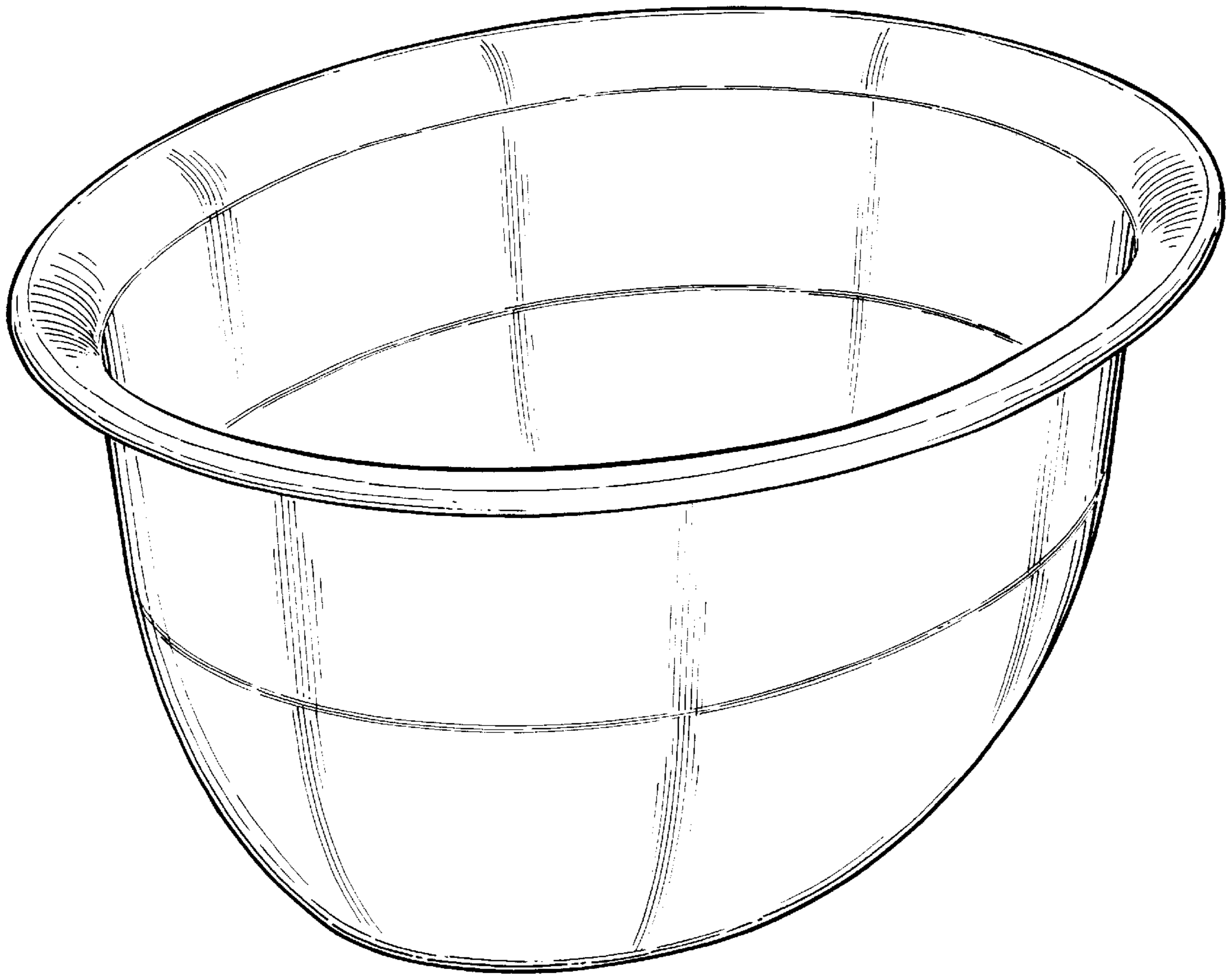
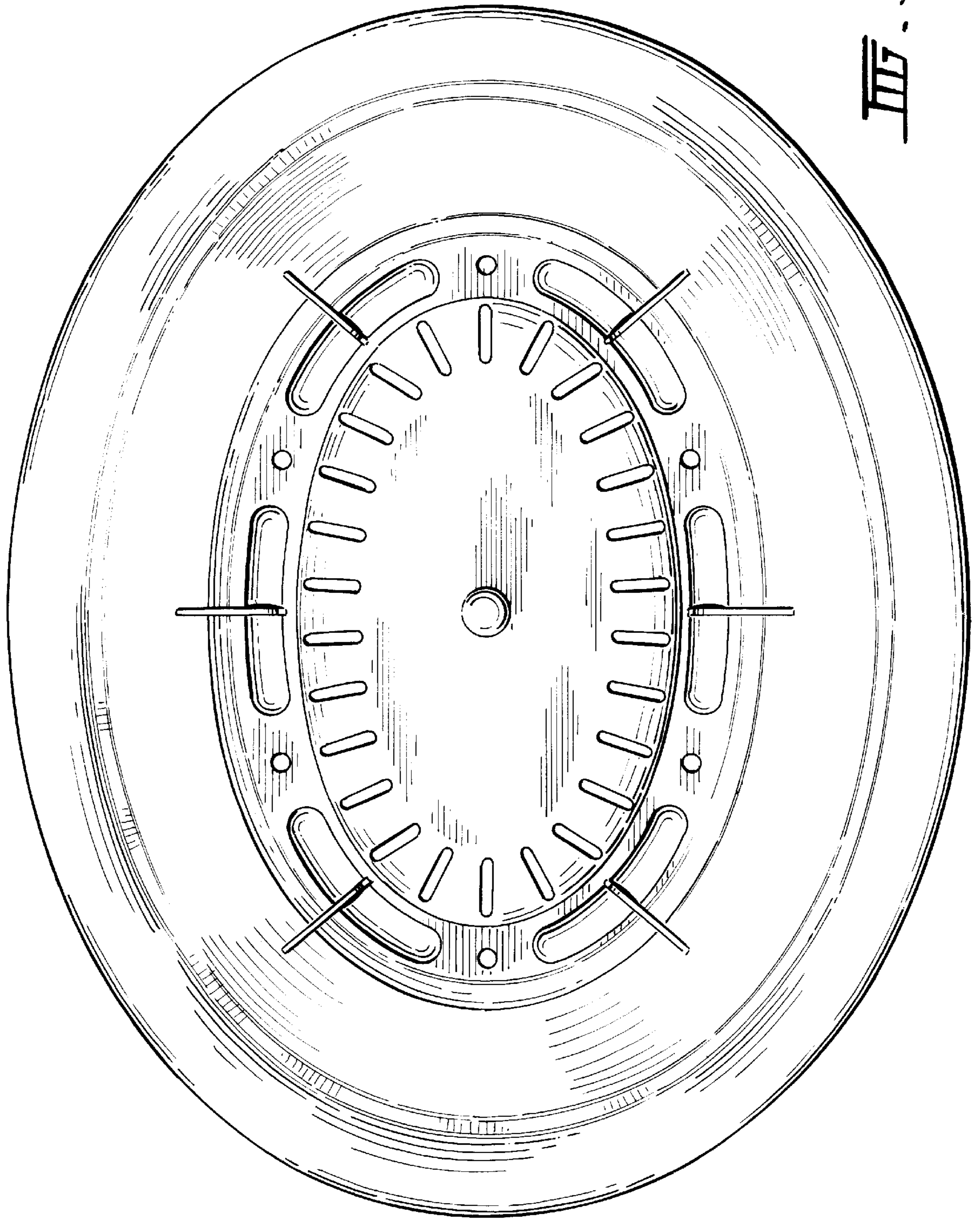

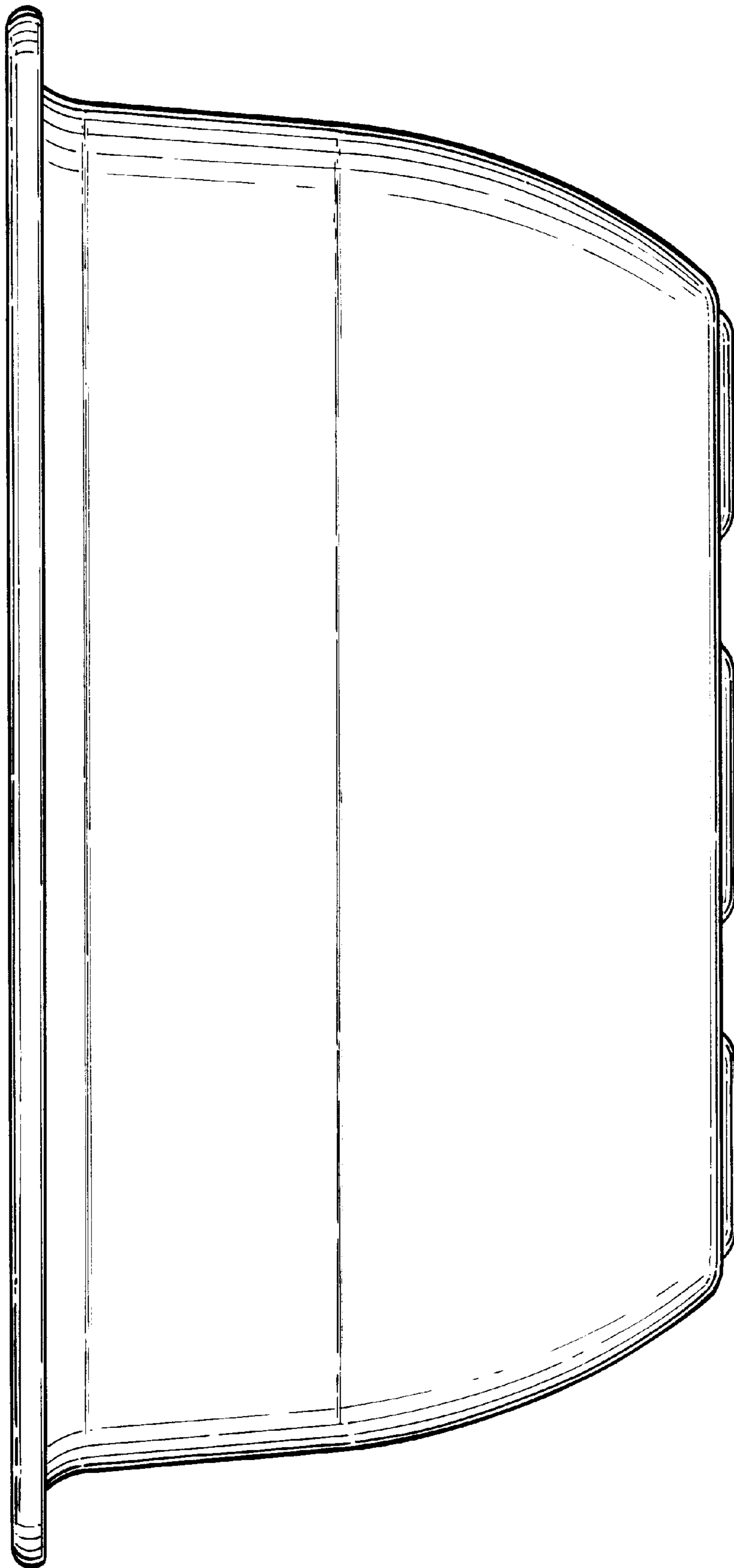

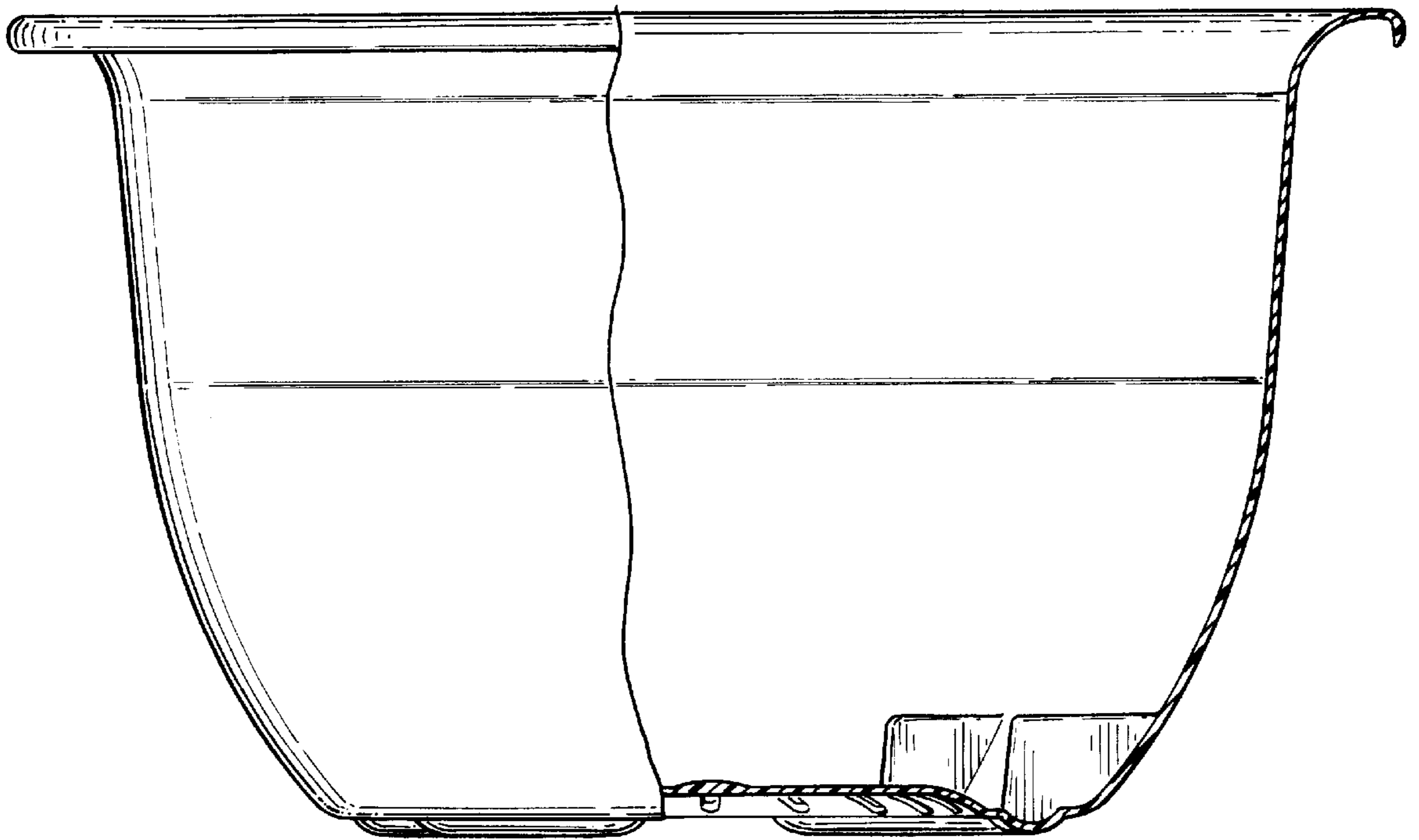
