FIG. 2 is front side elevation view thereof.

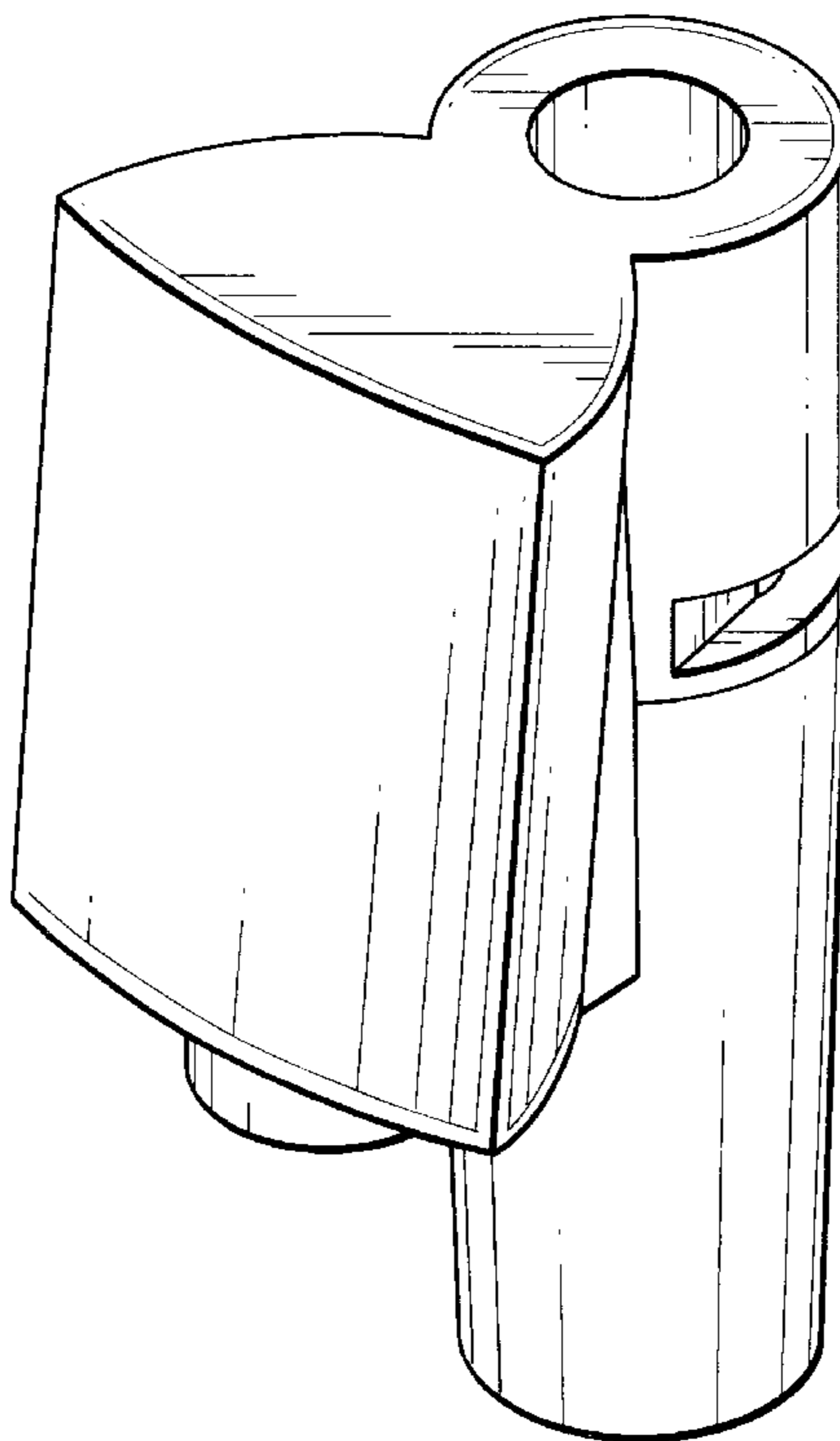
FIG. 3 is a rear side elevation view thereof.

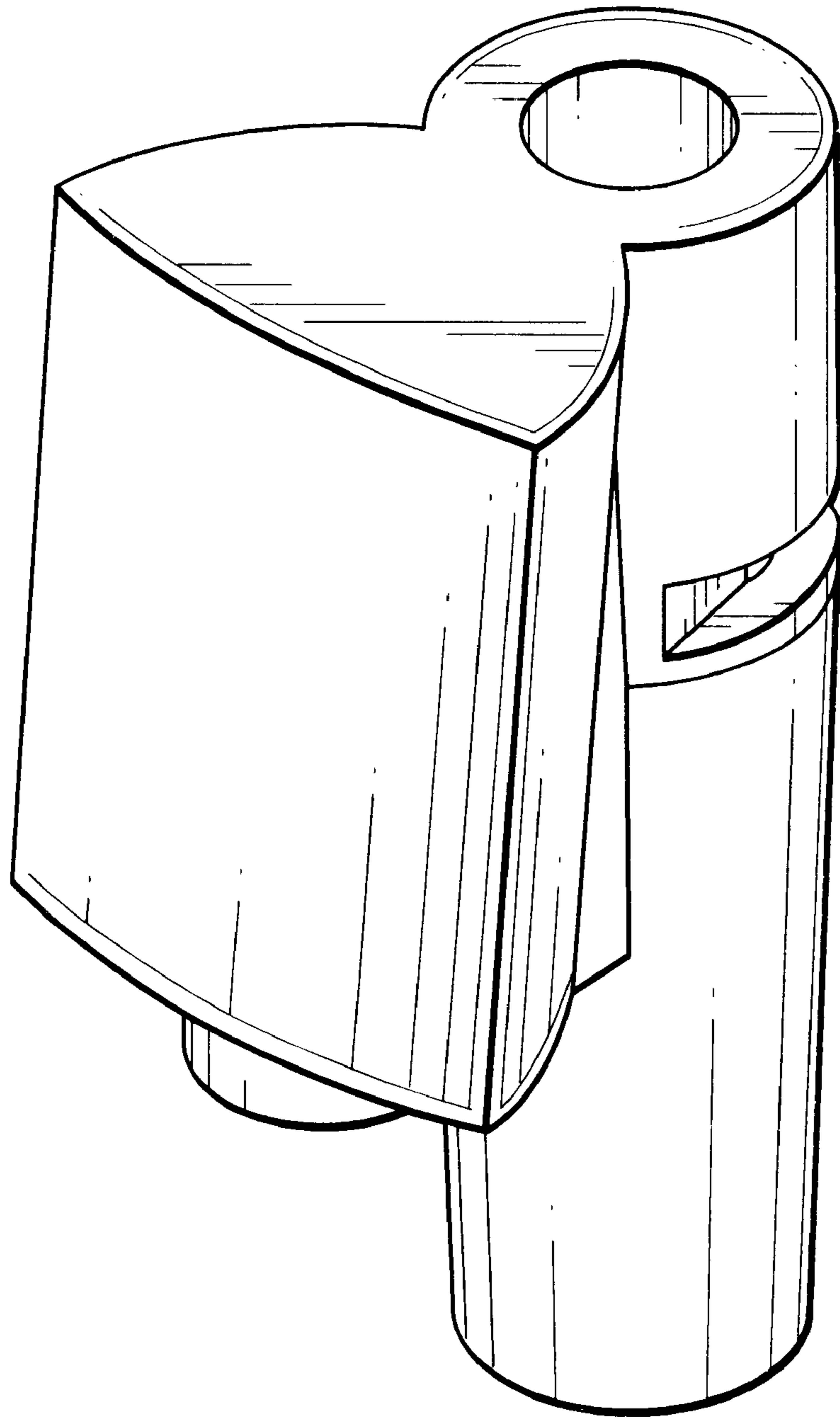

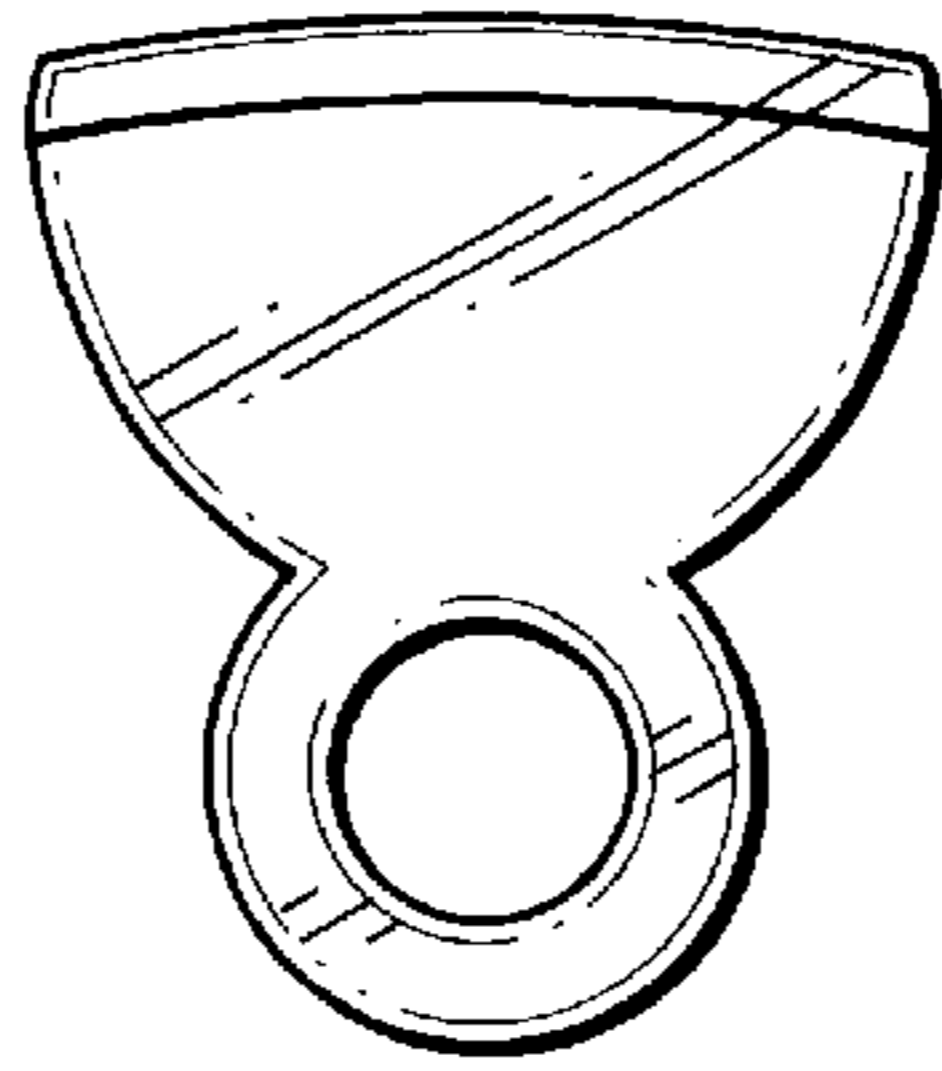

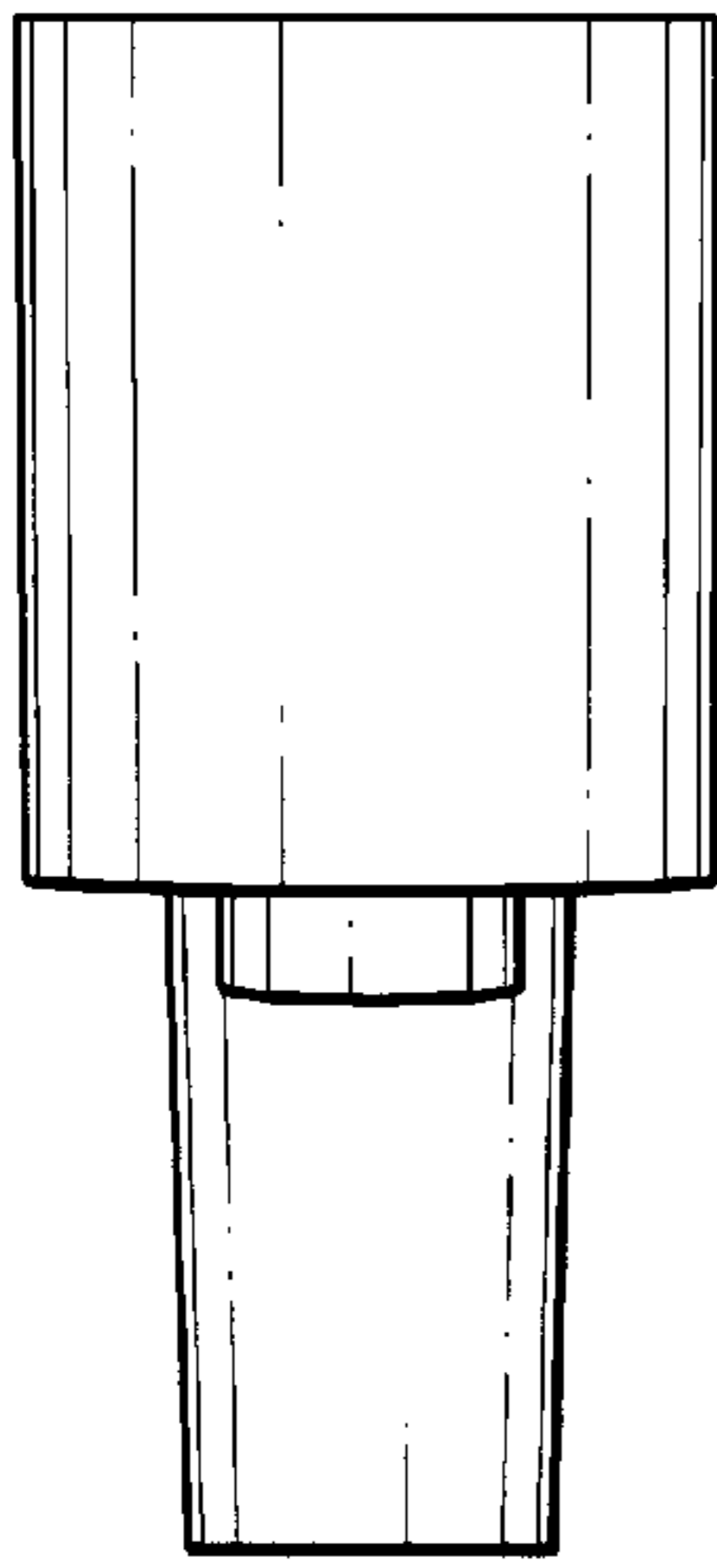

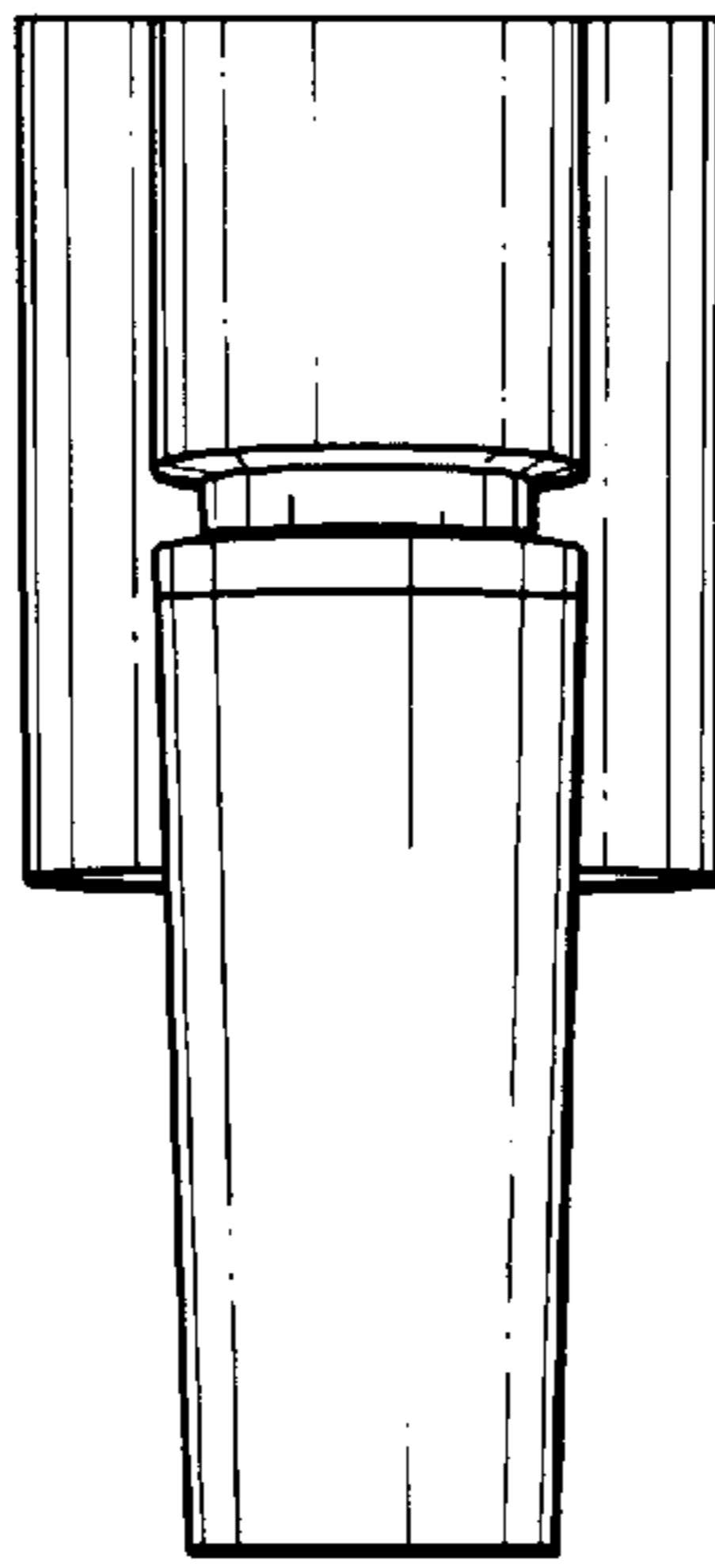

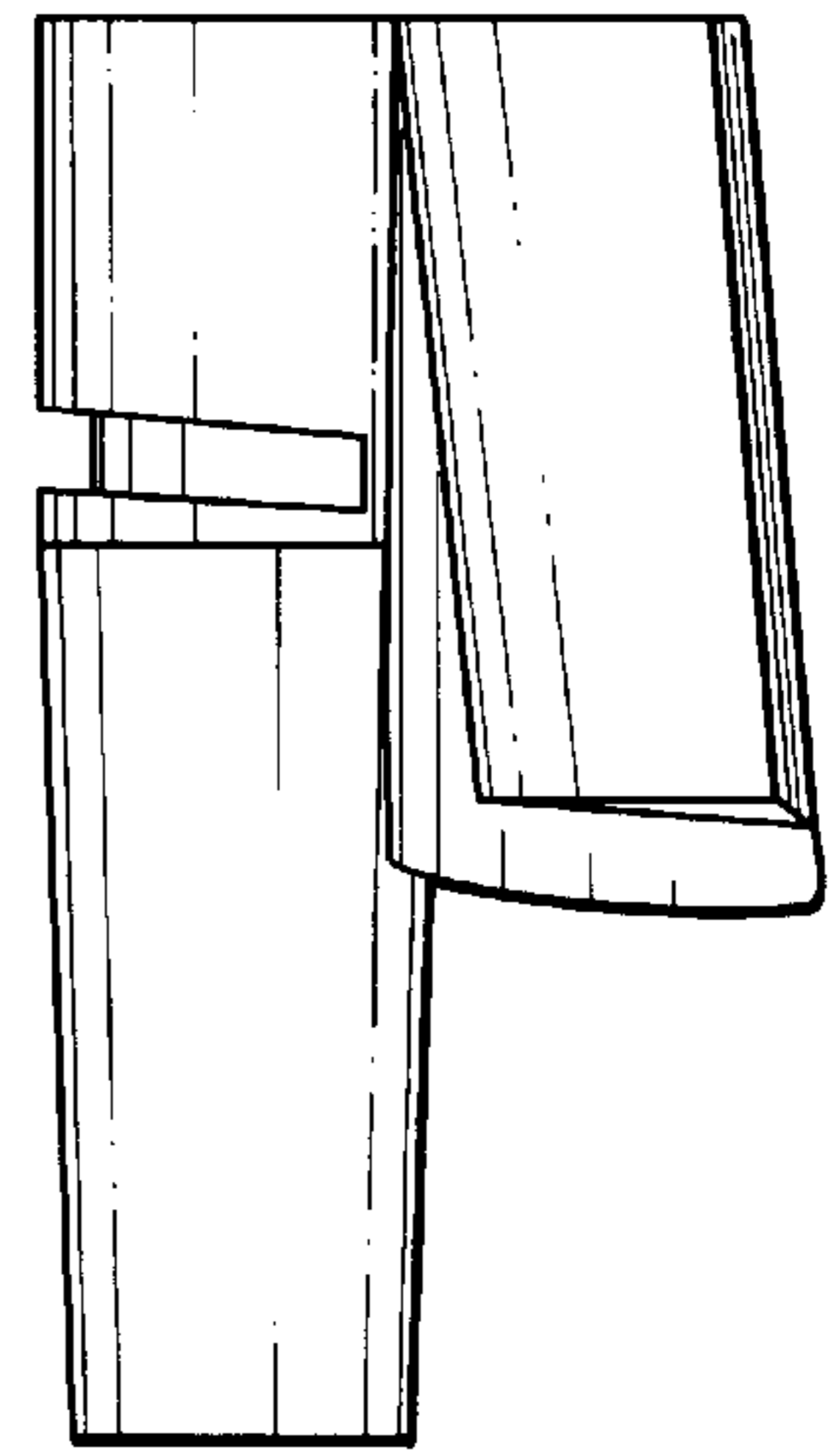

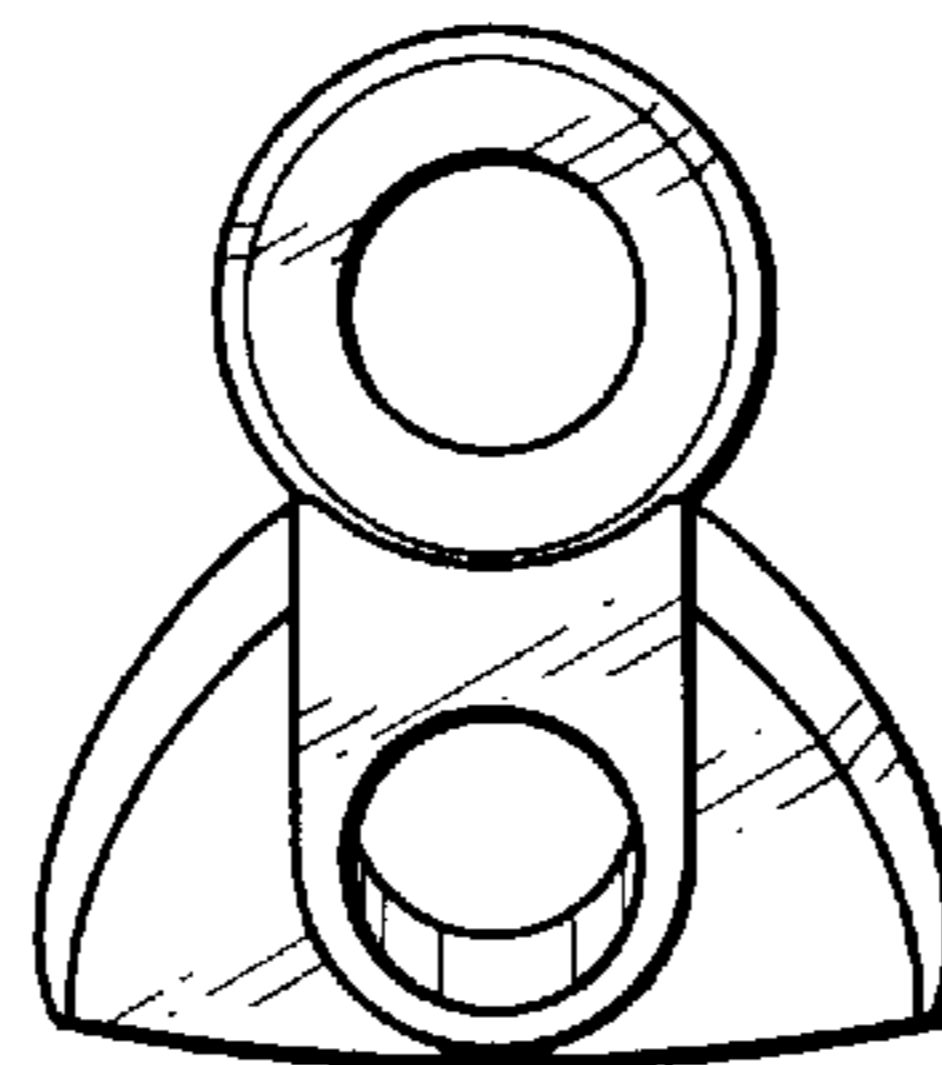
