FIG. 1 is a front view of a user interface for computer display showing our new design;

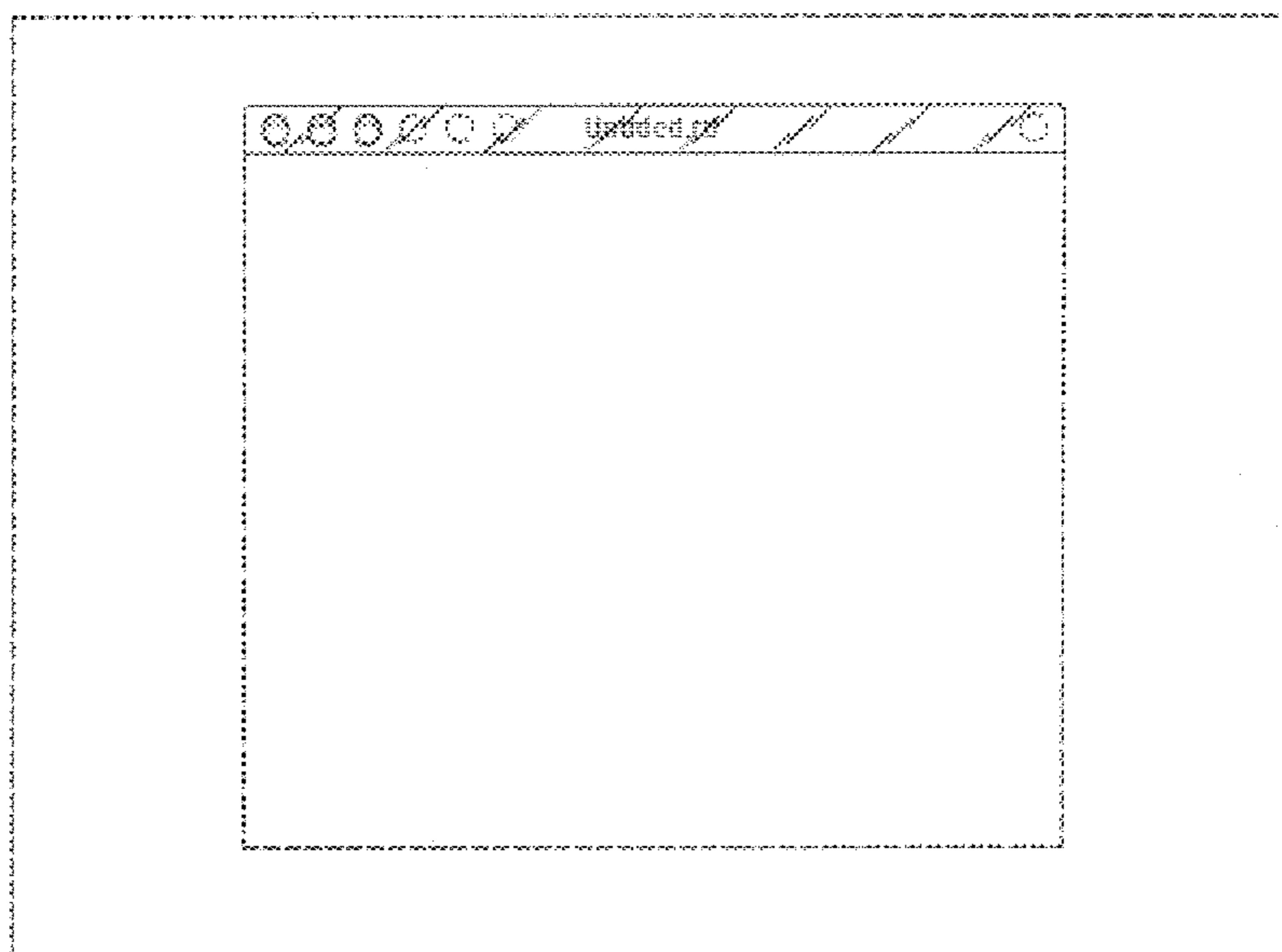
FIG. 2 is a front view of a second embodiment thereof;

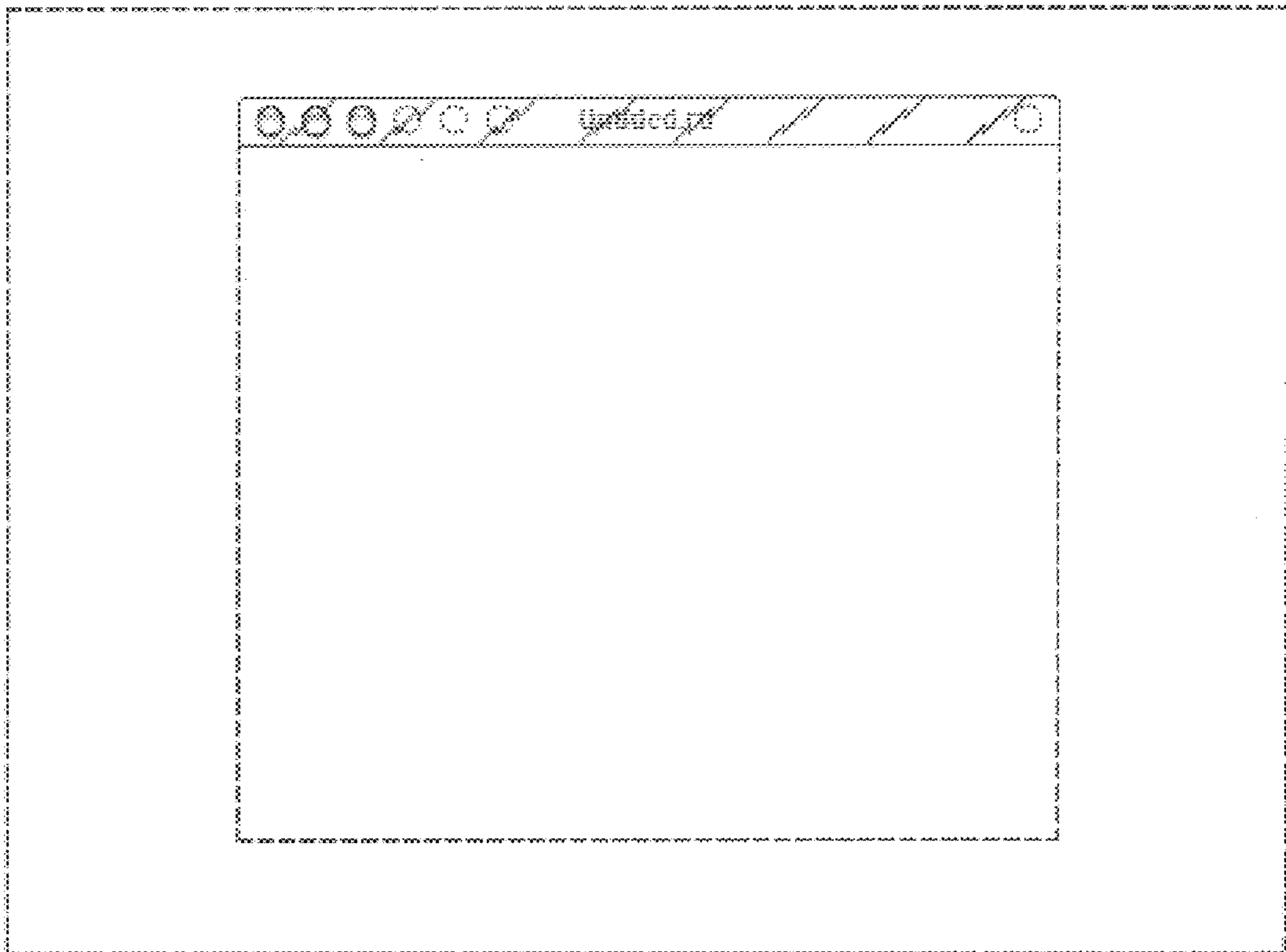

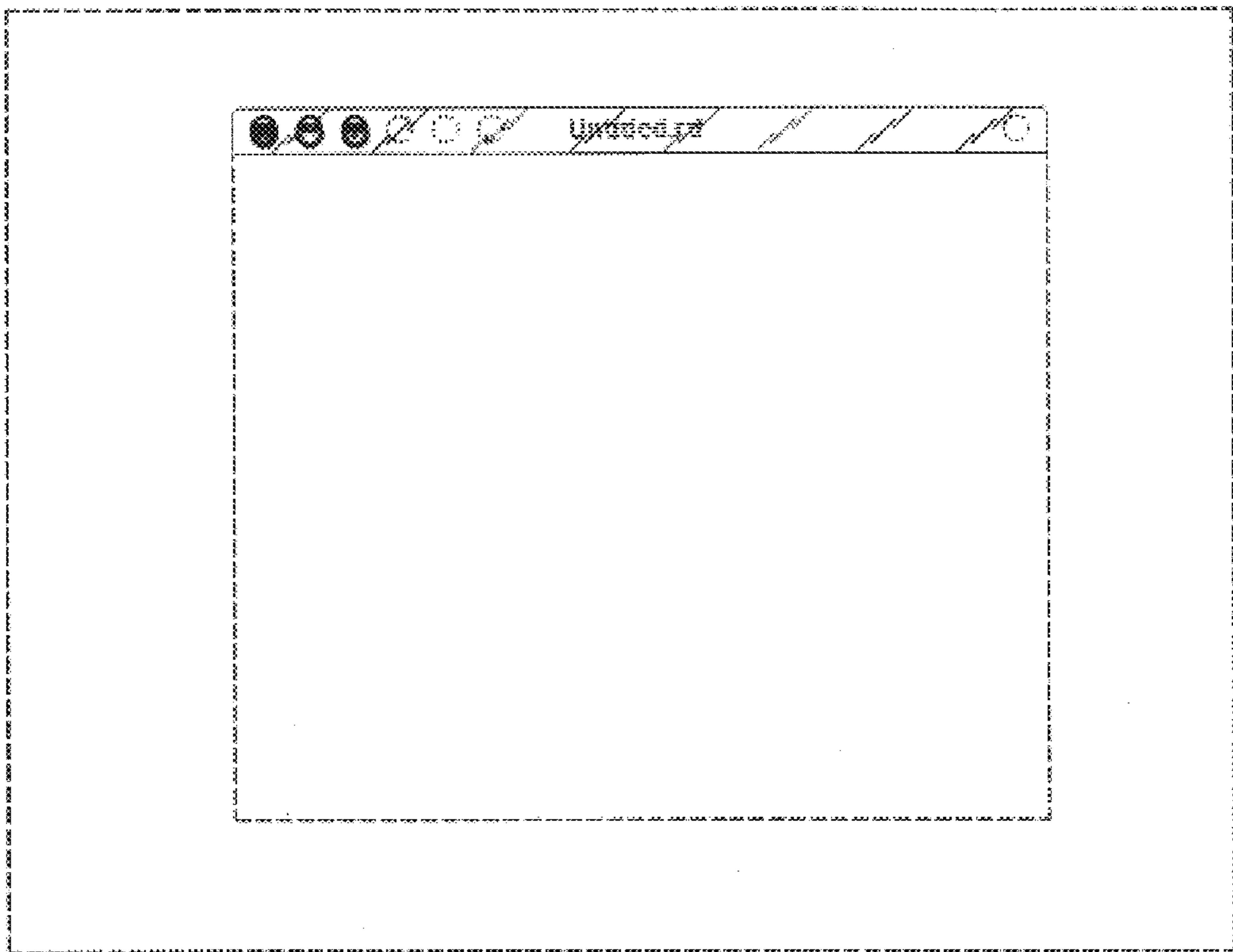

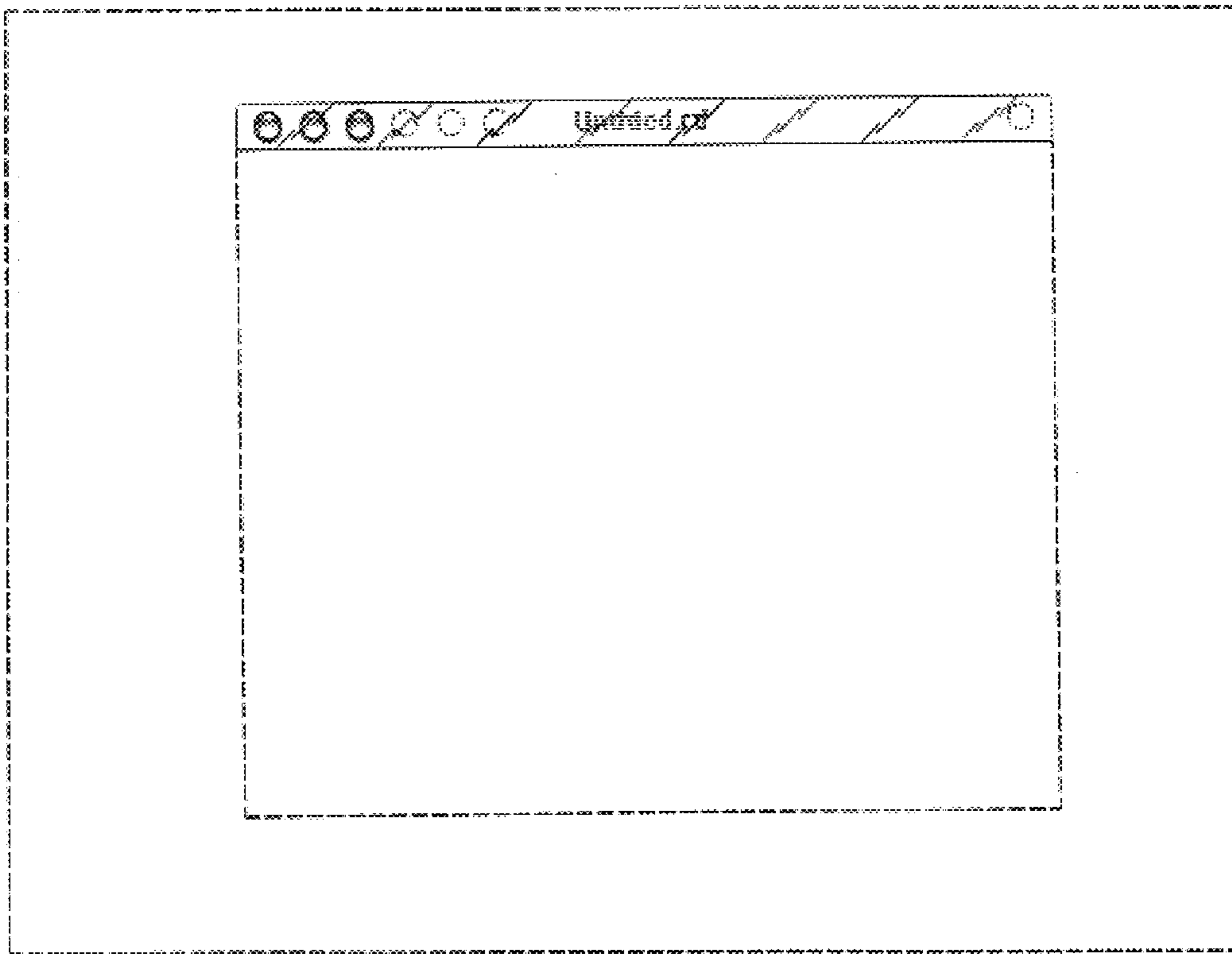

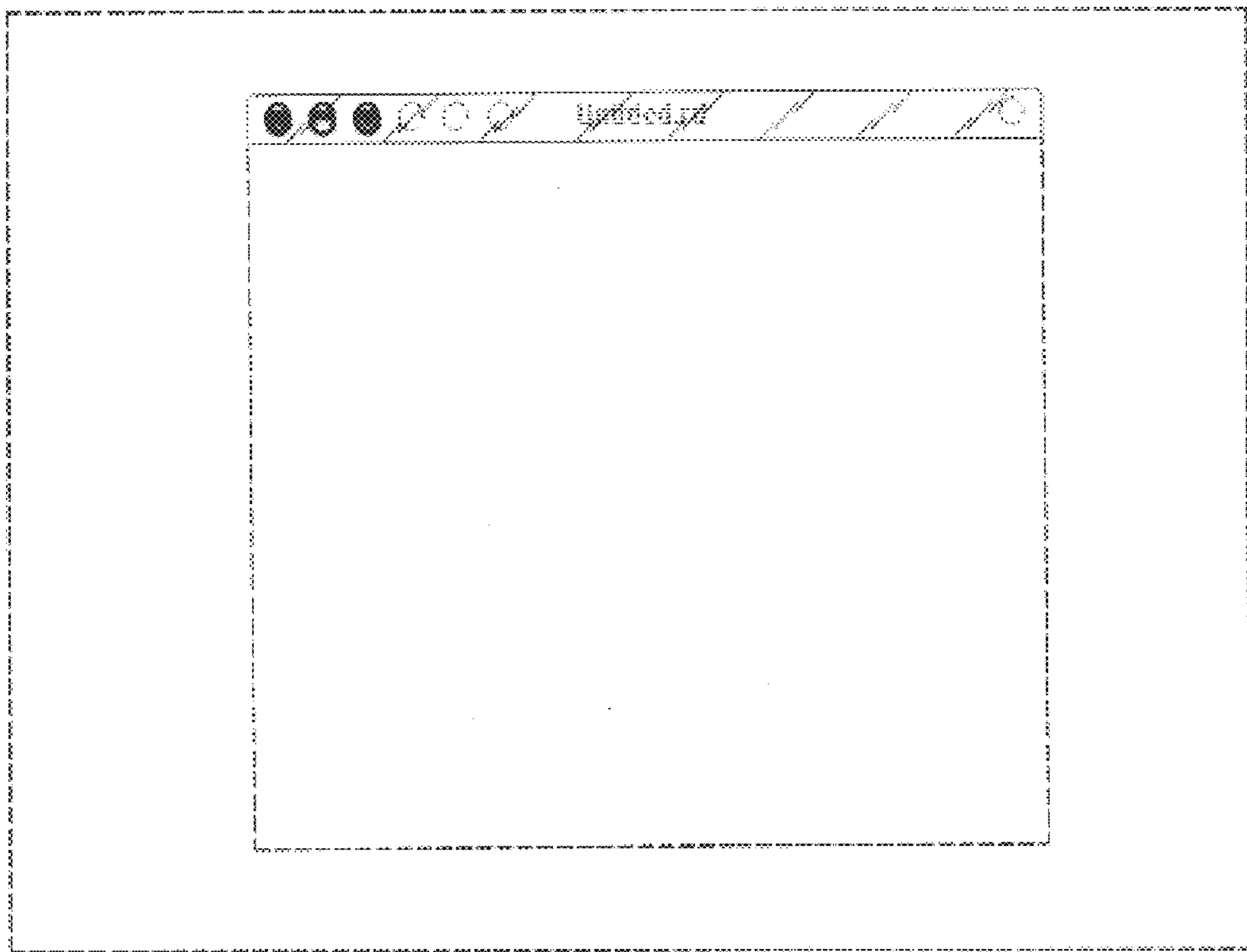
