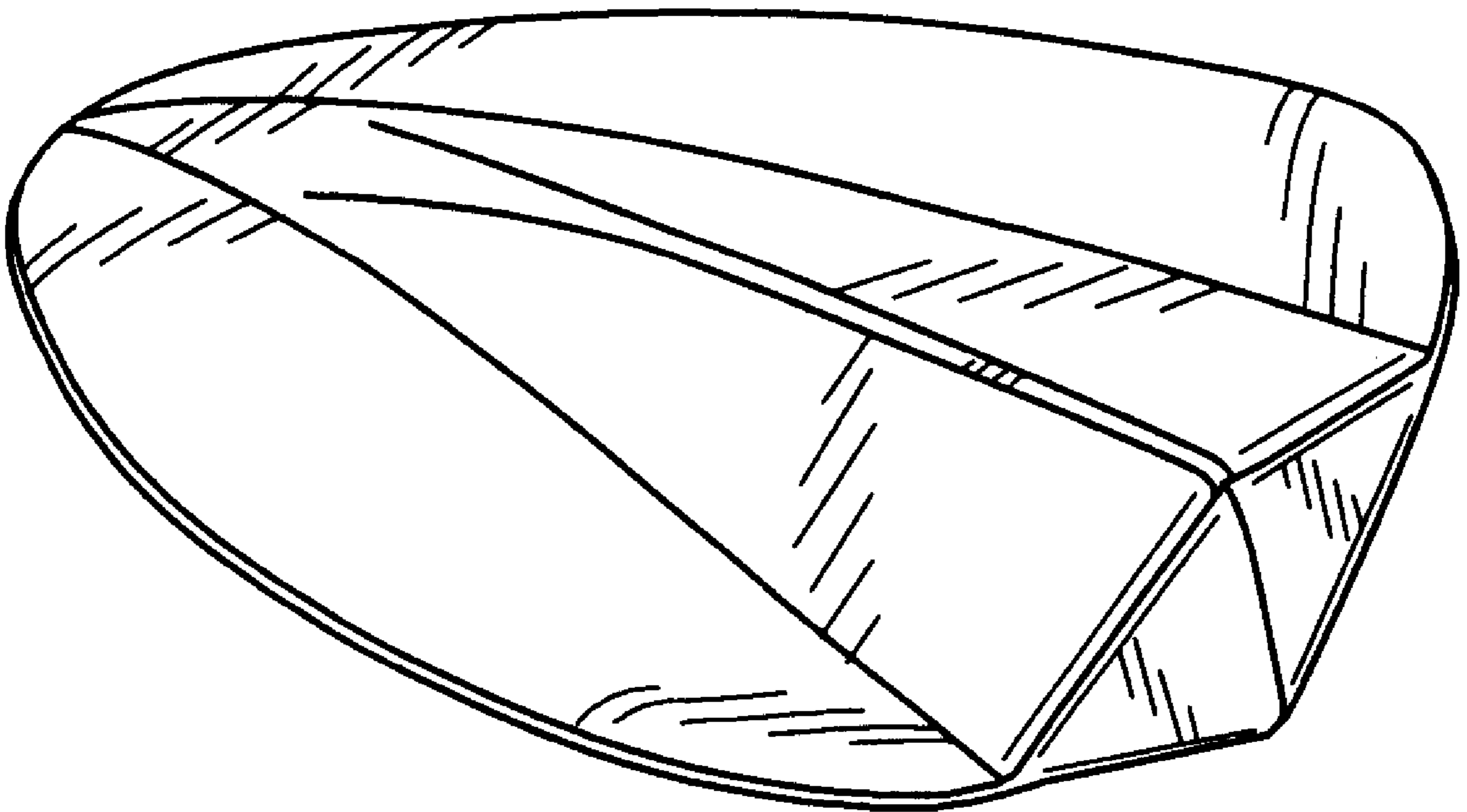

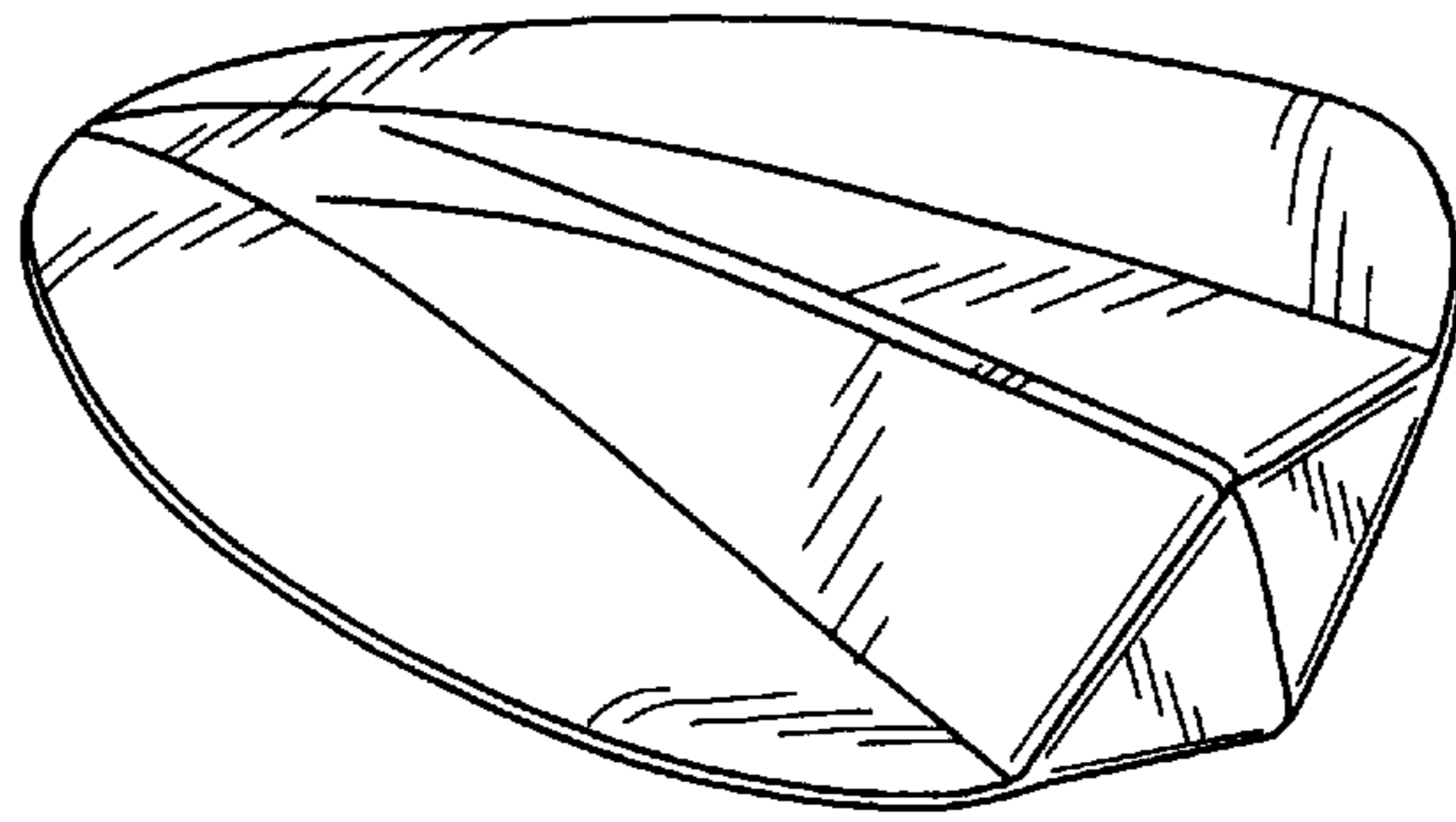
The ornamental design for a guitar pick, as shown and described.

**DESCRIPTION**

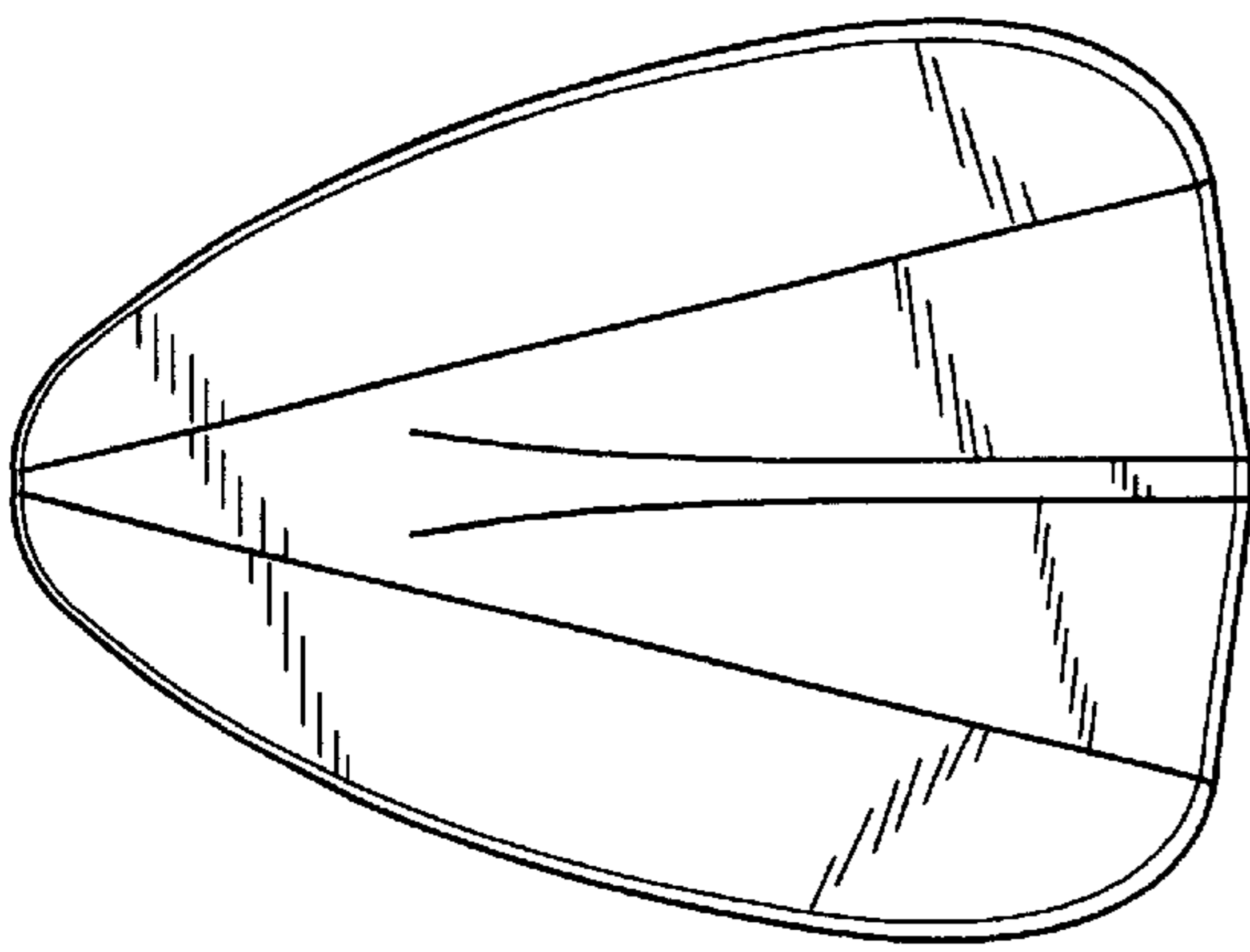
FIG. 1 is a perspective view of a guitar pick showing my new design;

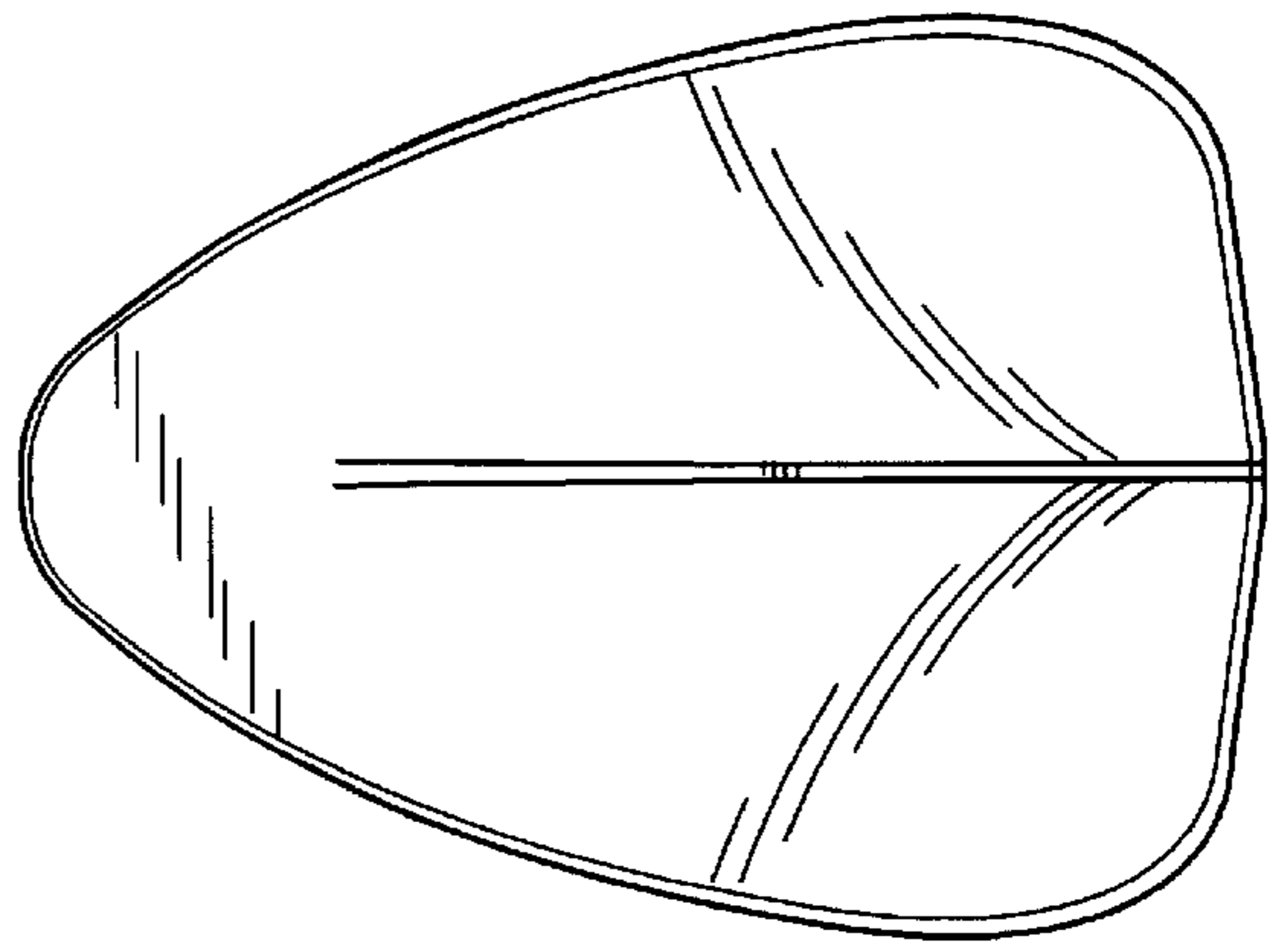




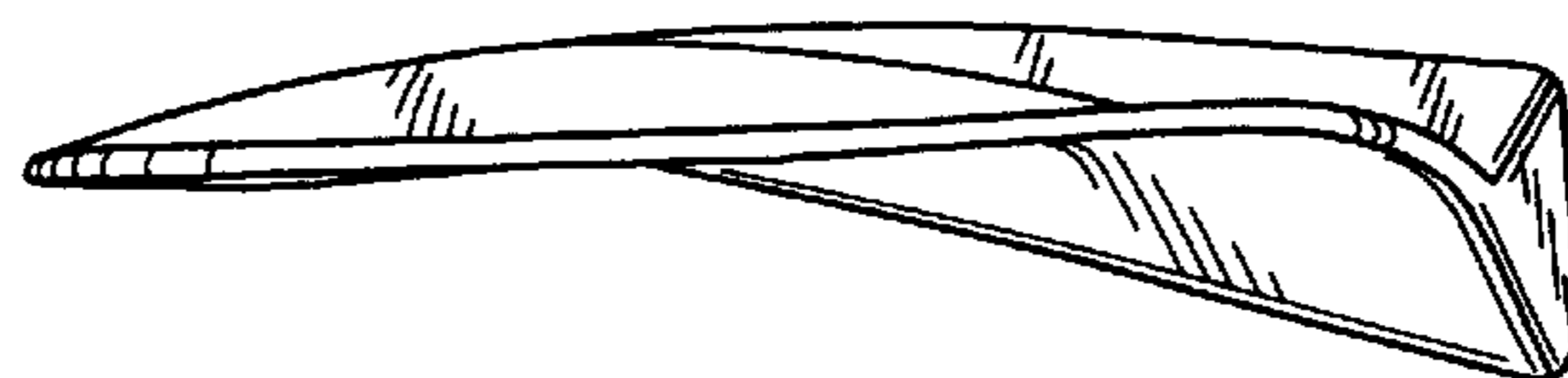

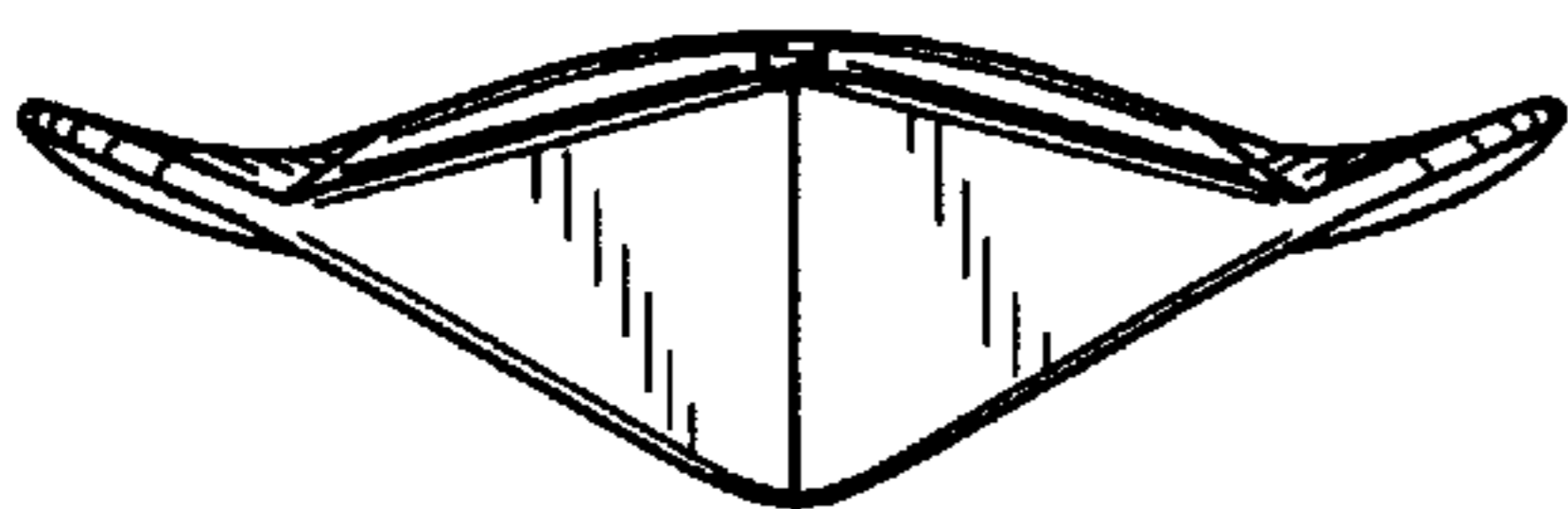

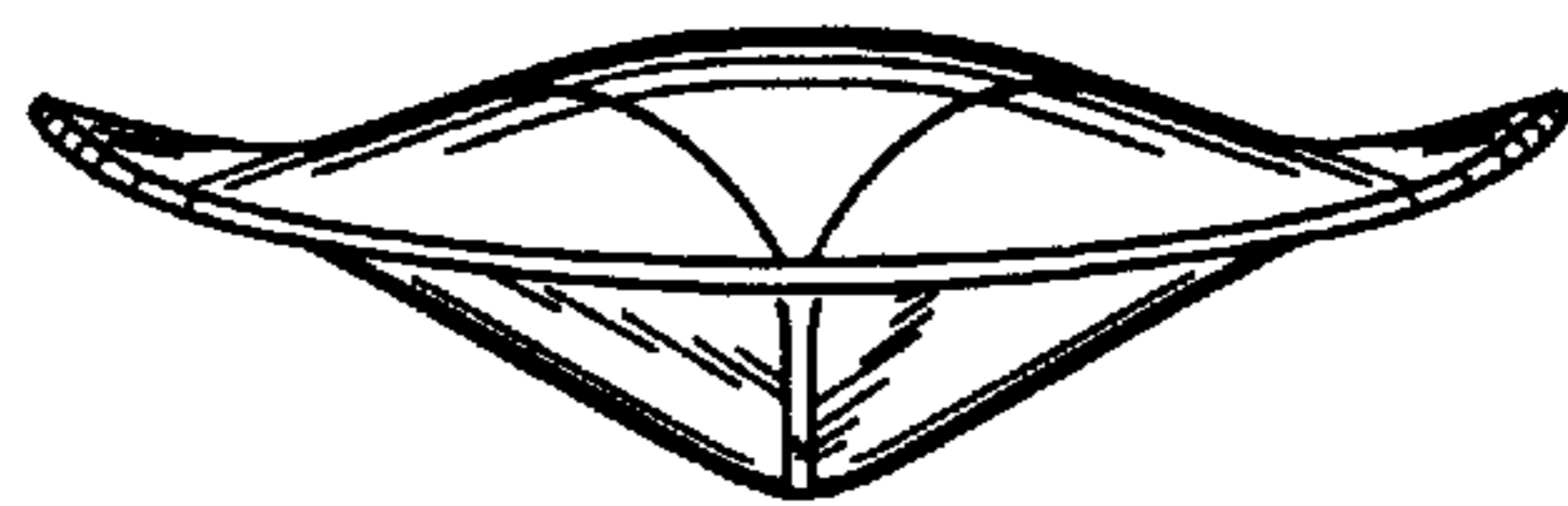
