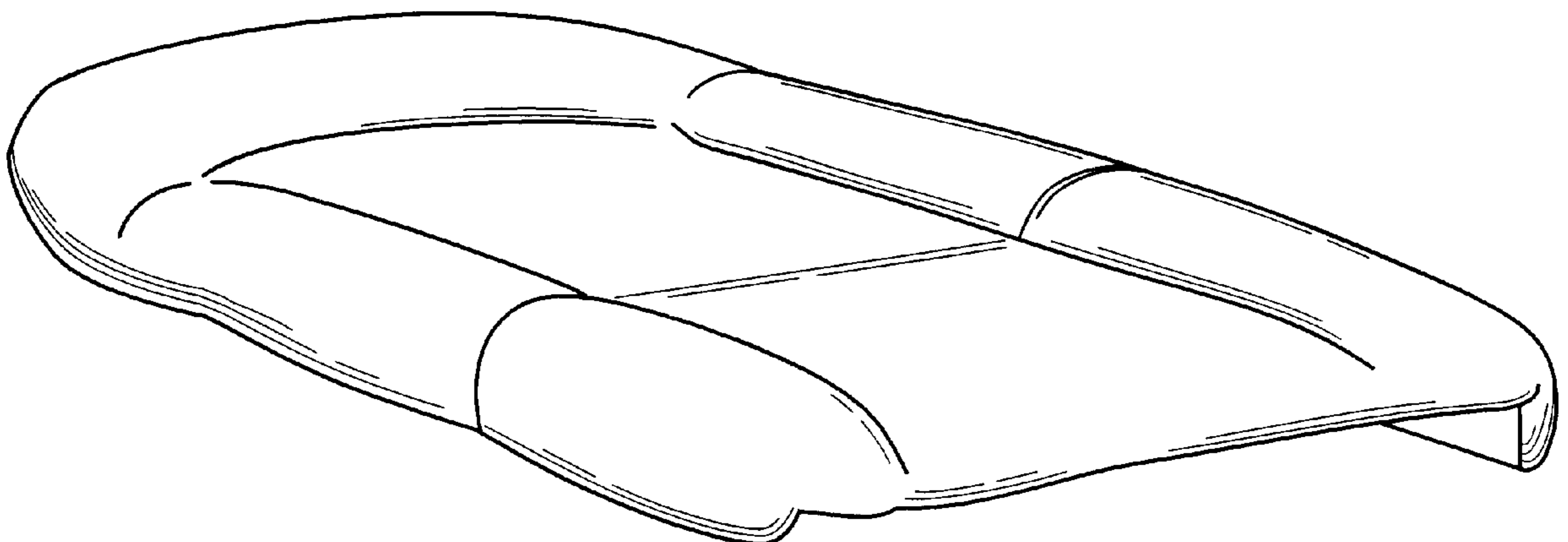
(57) **CLAIM**

The ornamental design for a top for a medical examination table, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a top for a medical examination table, showing our new design;
FIG. 2 is left side elevational view thereof;
FIG. 3 is a right side elevational view thereof;
FIG. 4 is a rear elevational view thereof;
FIG. 5 is a front elevational view thereof; and,
FIG. 6 is a top plan view thereof.

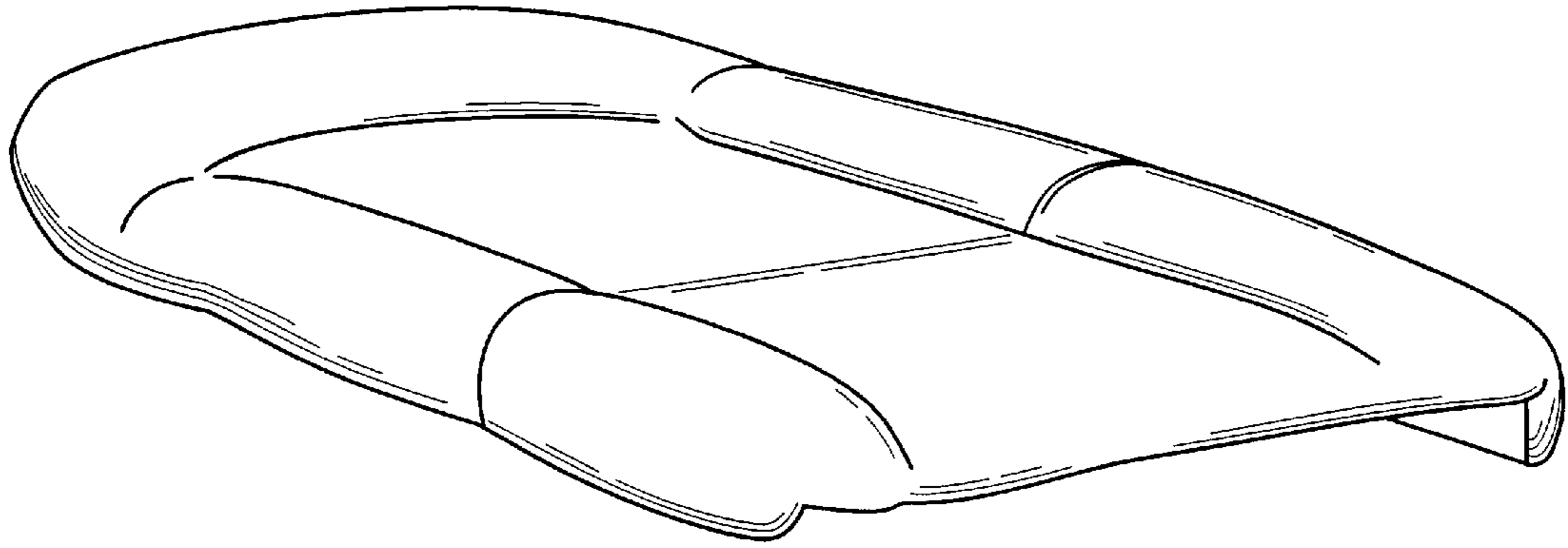

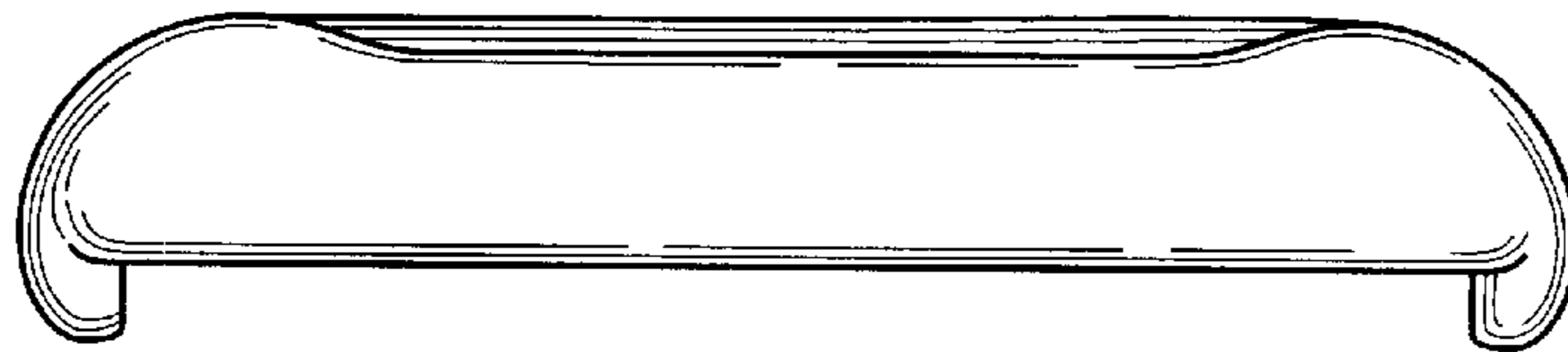

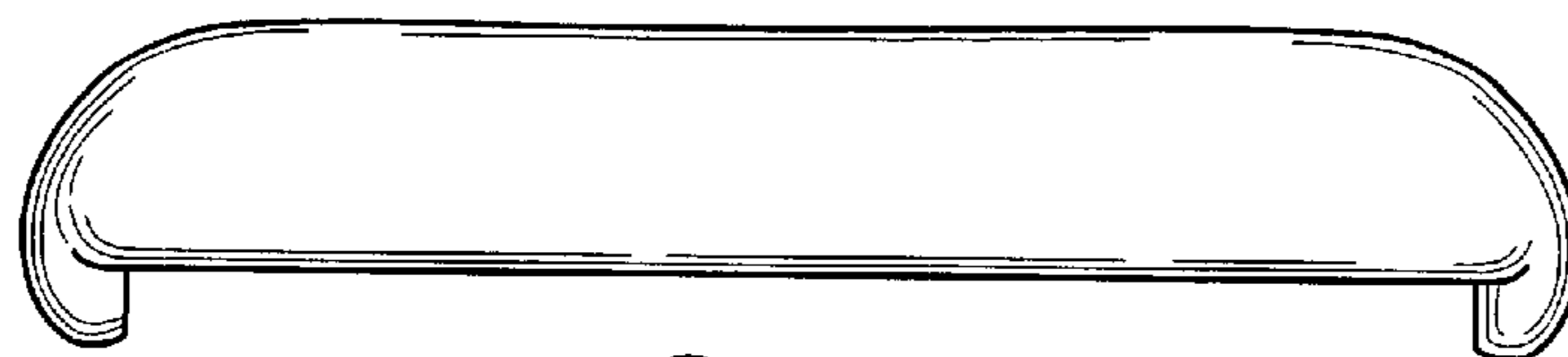

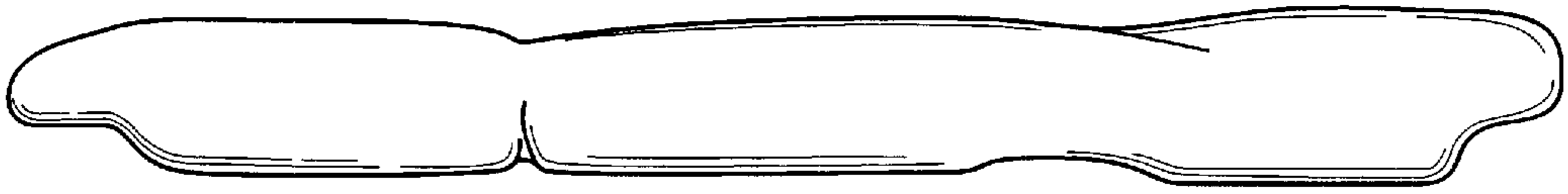

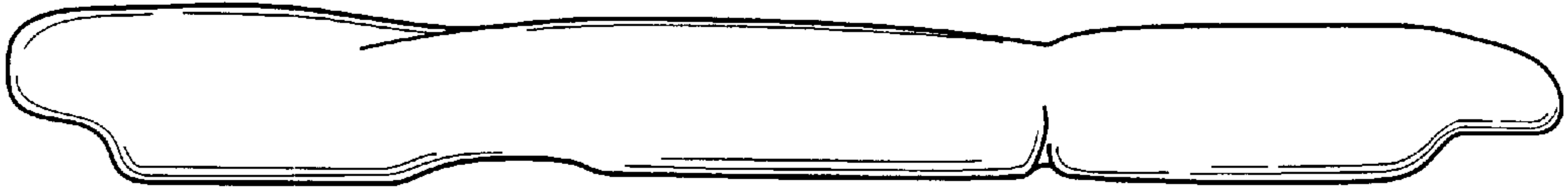

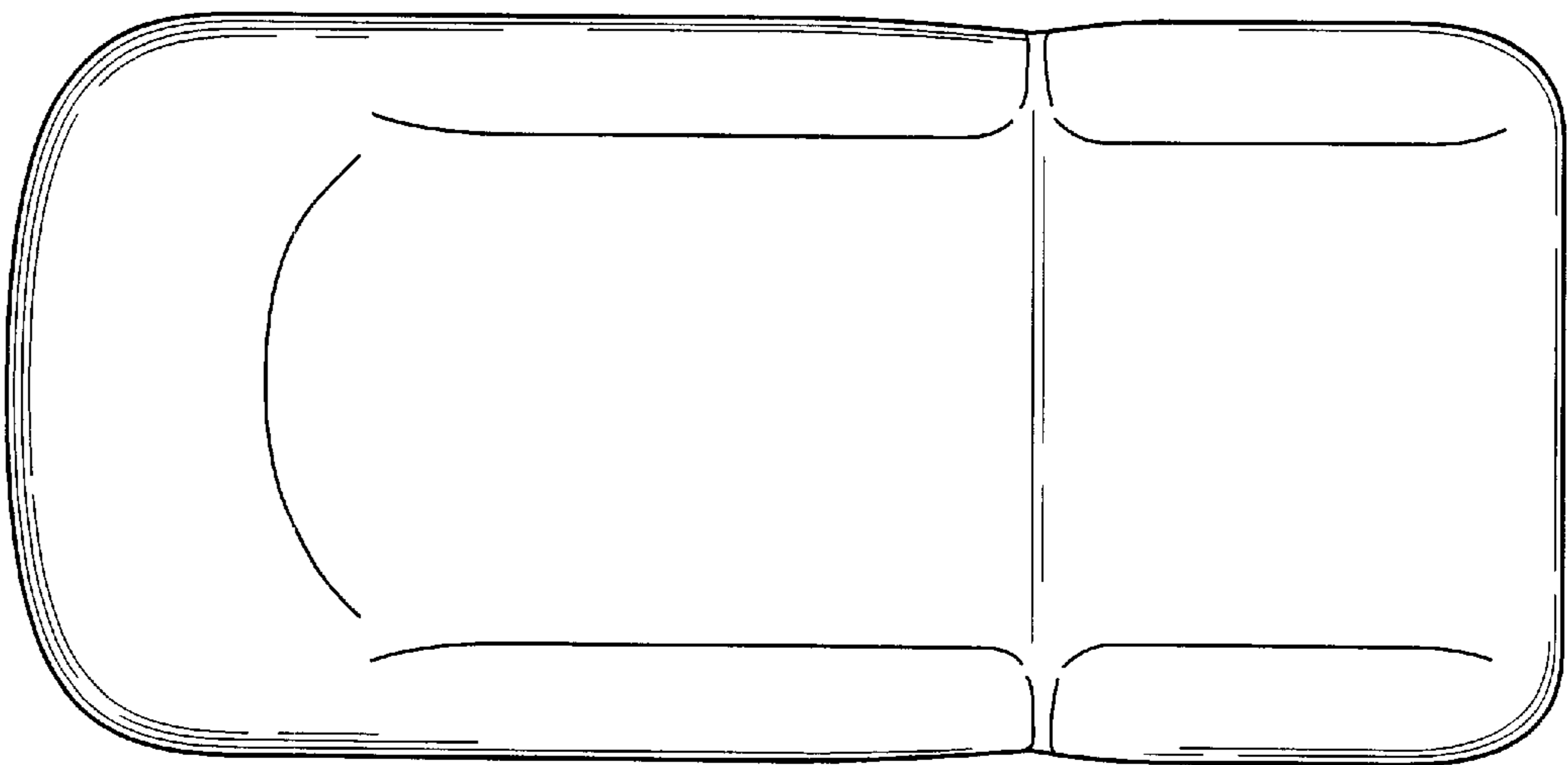
