(57) **CLAIM**

The ornamental design for the lighting fixture backplate, as  
shown and described.

**DESCRIPTION**

FIG. 1 is a side elevation view of the lighting fixture  
backplate in accordance with my design, illustrating a pos-  
sible environment for the backplate;

FIG. 2 is a top plan view of the lighting fixture backplate in  
accordance with my design;

FIG. 3 is a left side elevation view of the lighting fixture  
backplate in accordance with my design;


FIG. 4 is a front elevation view of the lighting fixture  
backplate in accordance with my design;


FIG. 5 is a right side elevation view of the lighting fixture




