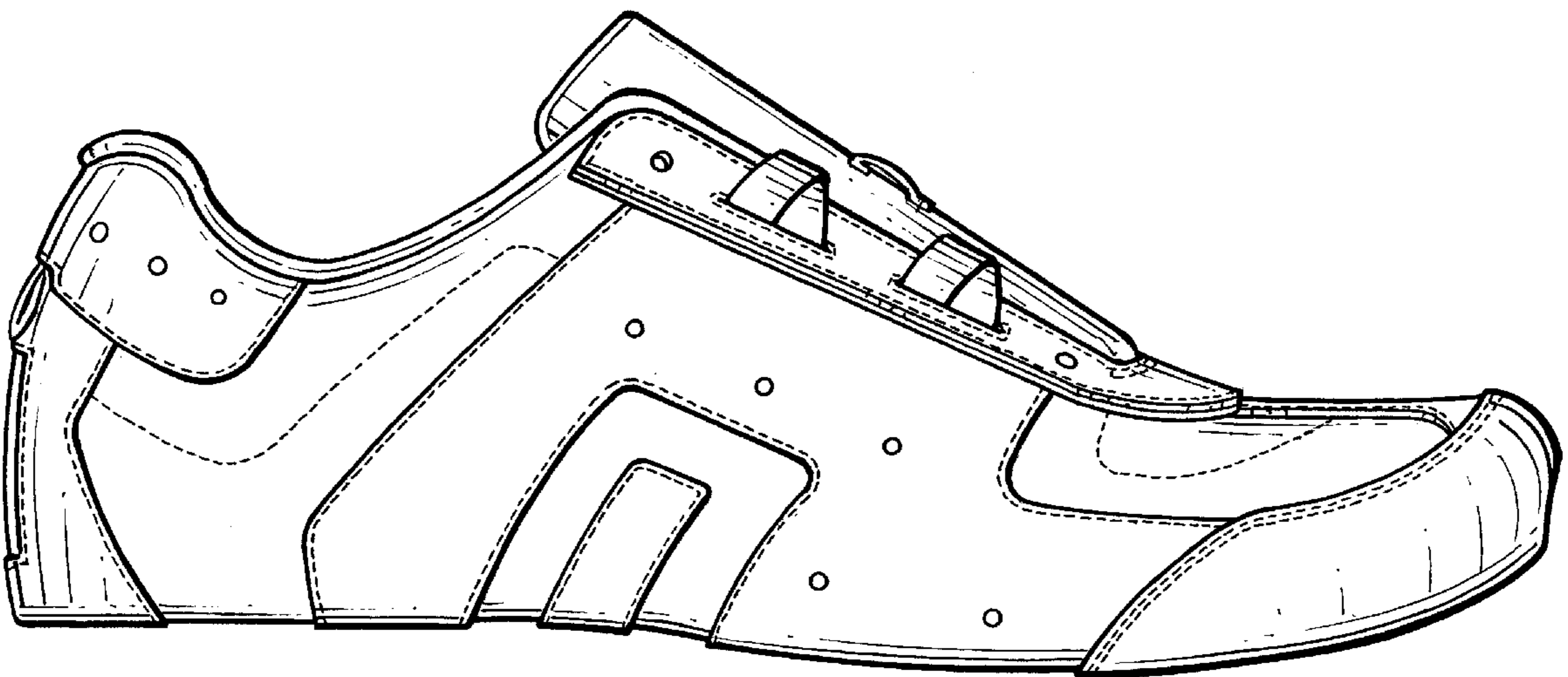
The ornamental design for a shoe upper, as shown and described.

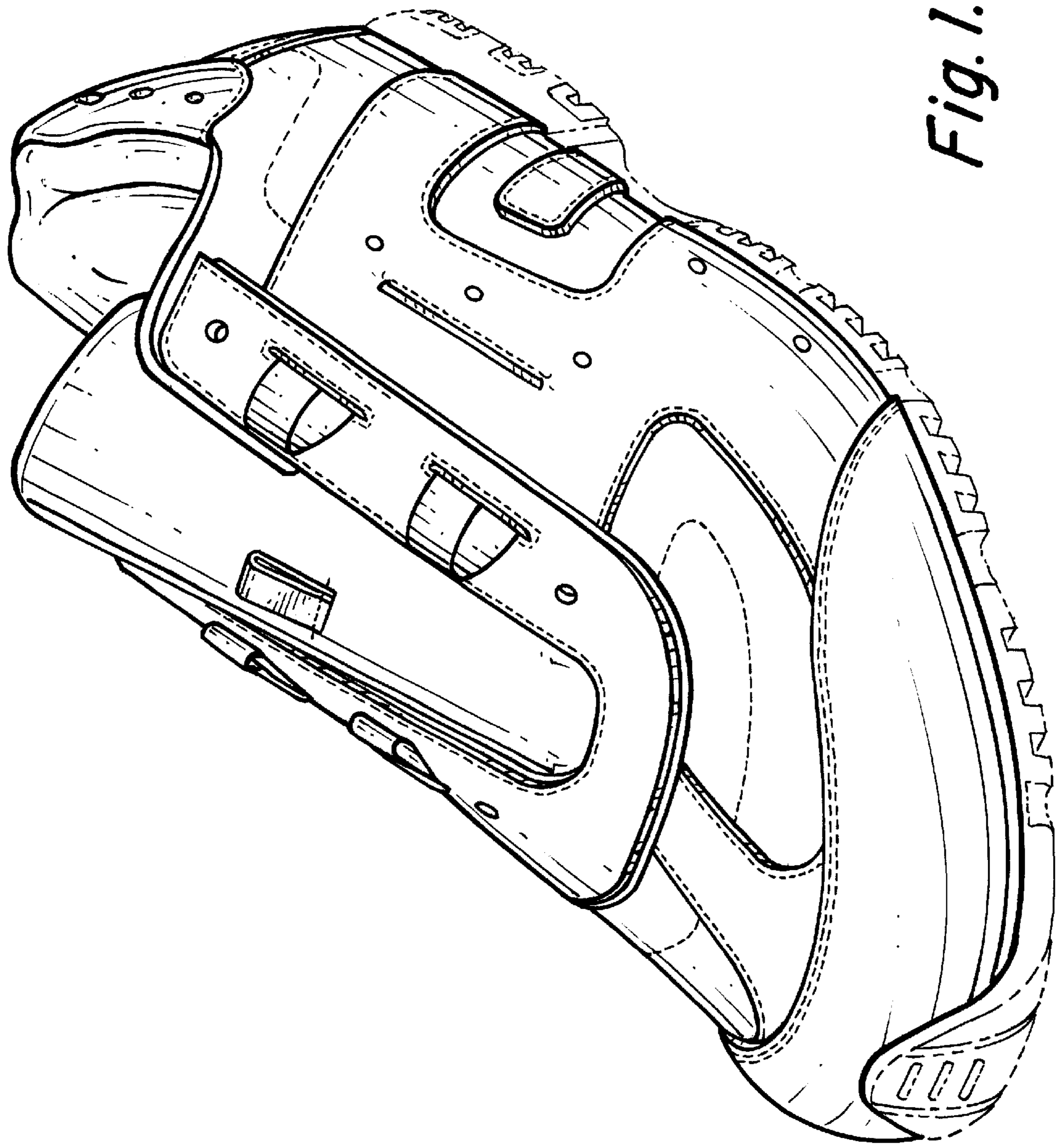
**DESCRIPTION**

 FIG. 6 is a rear elevational view.

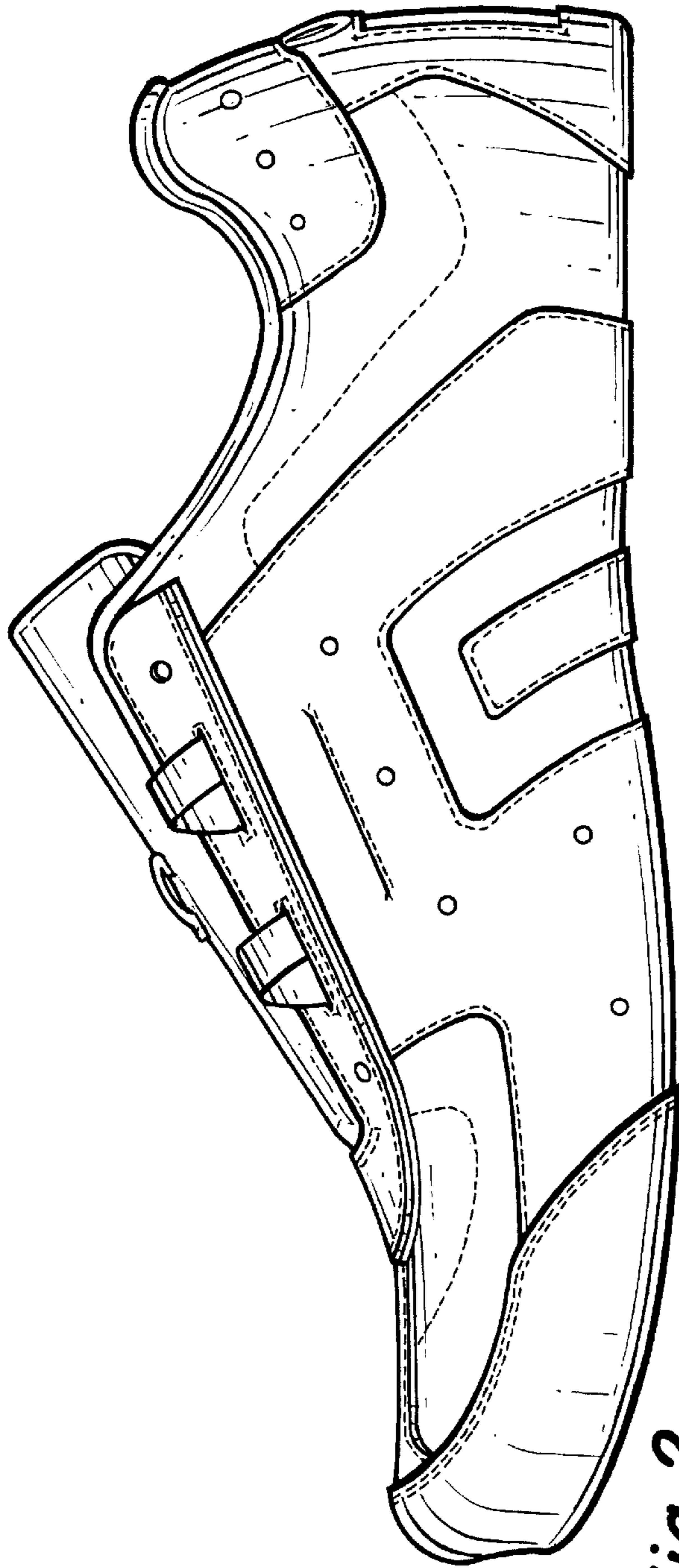
The broken lines showing the bottom in FIG. 1 are for illustrative purposes only and form no part of the claimed design.

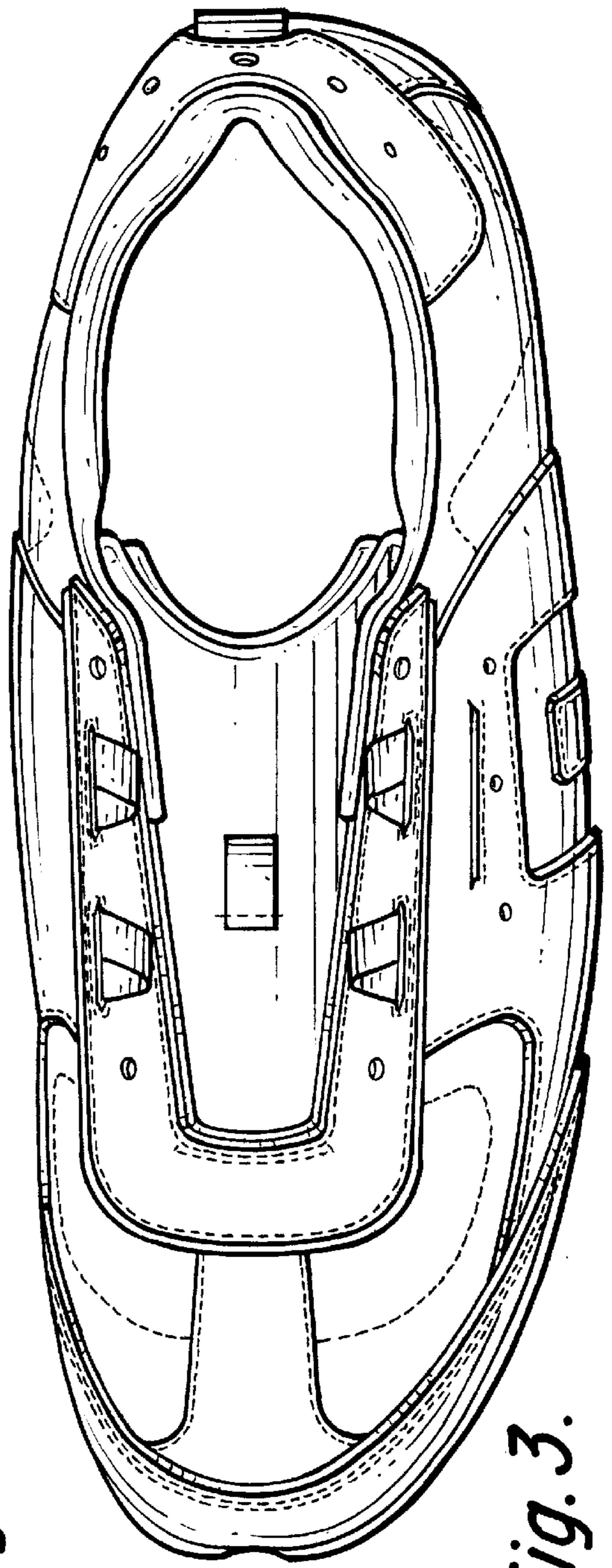




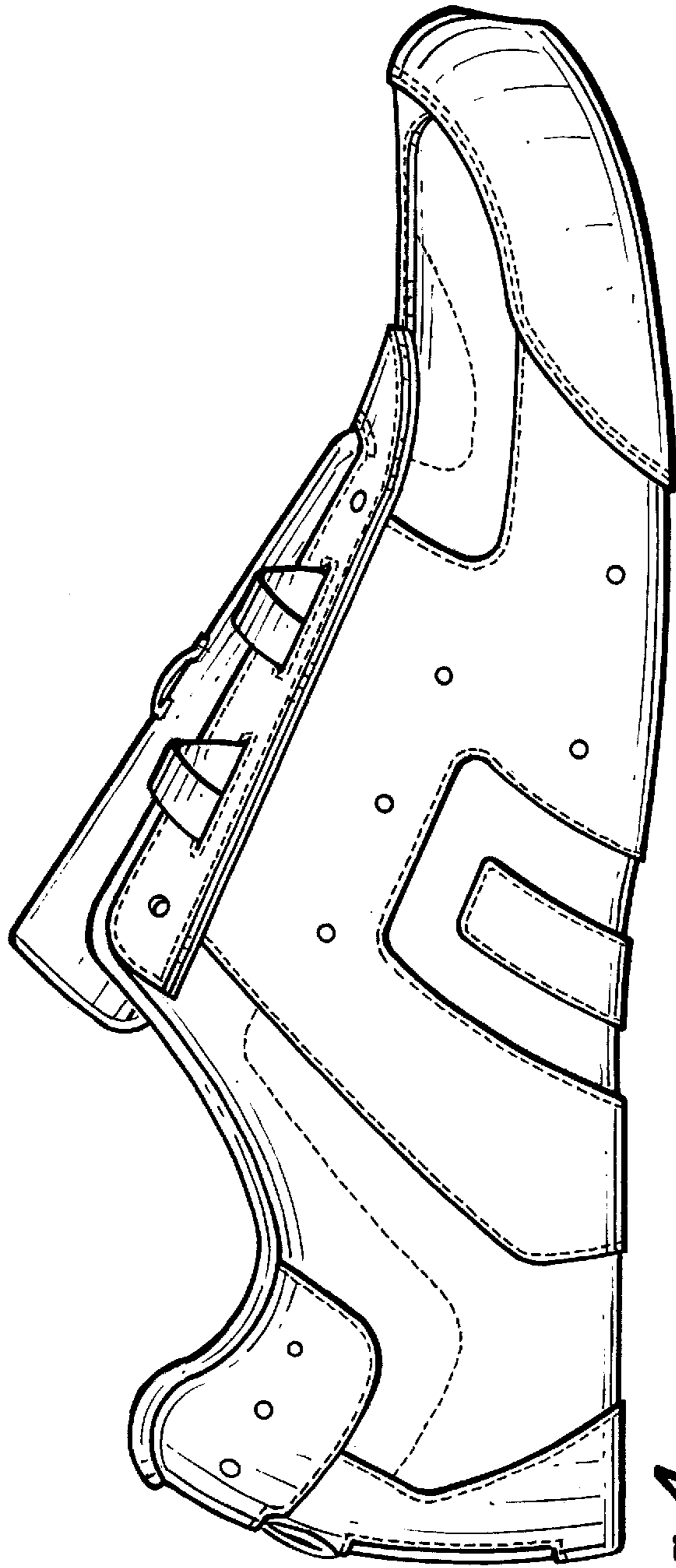

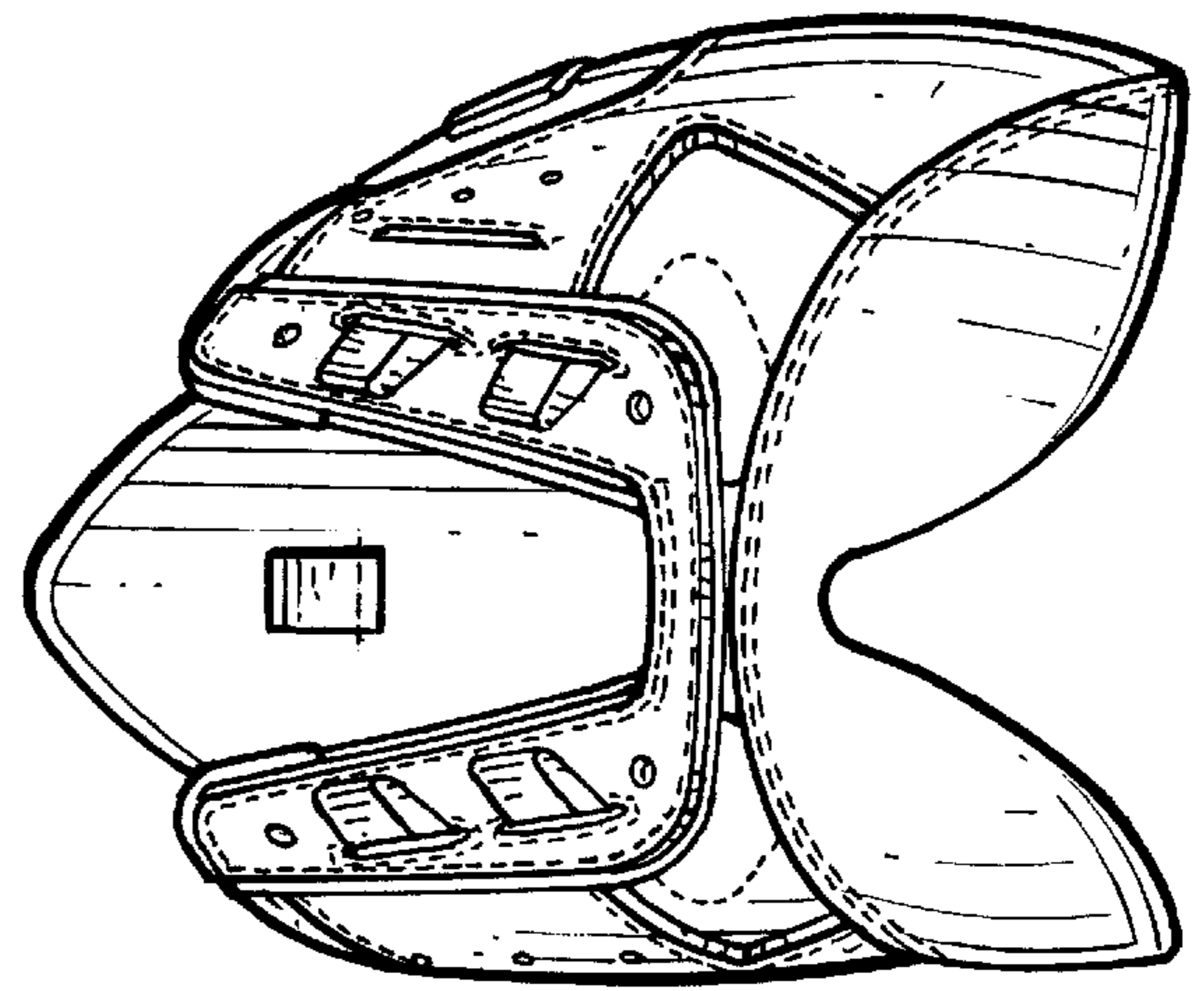

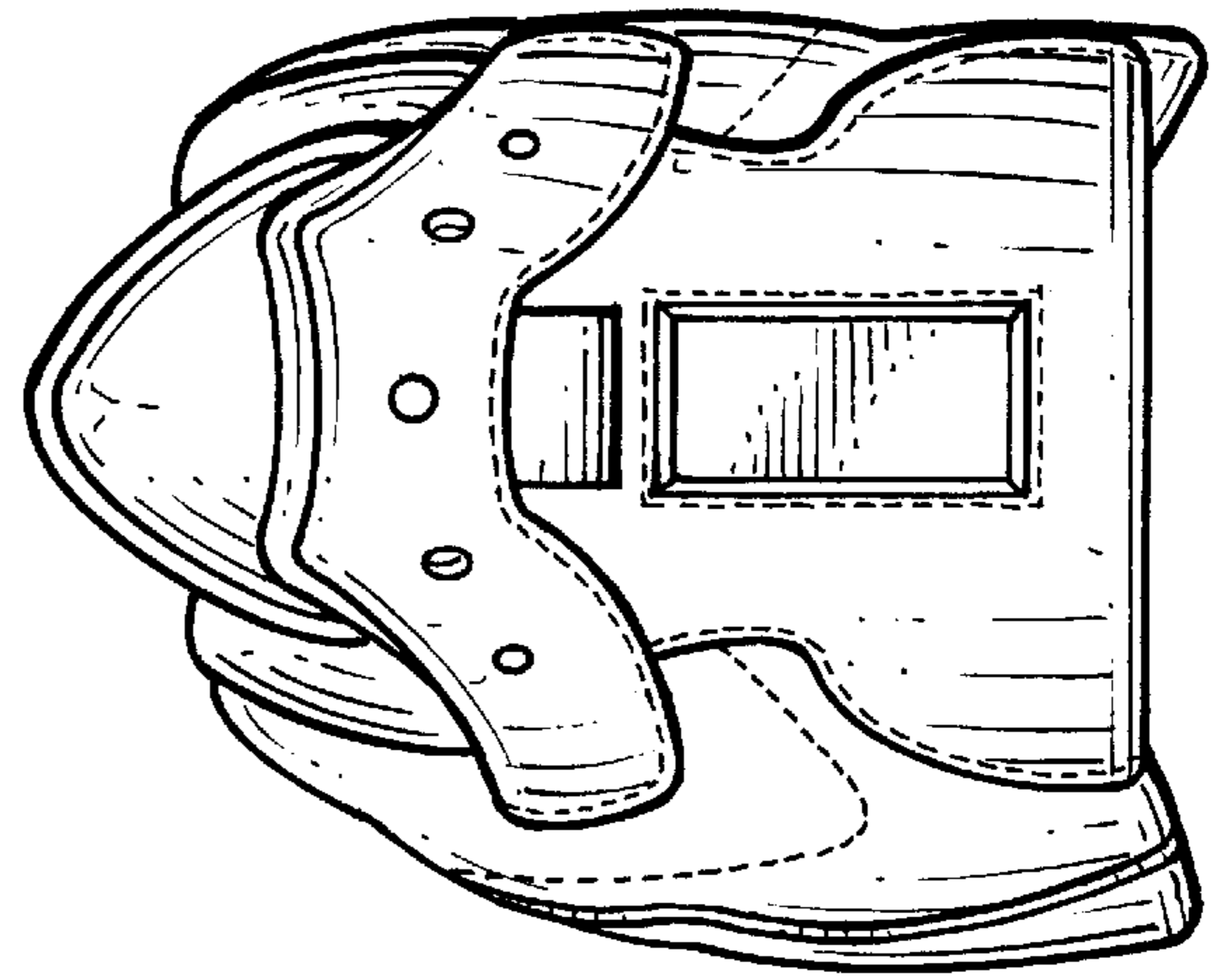
