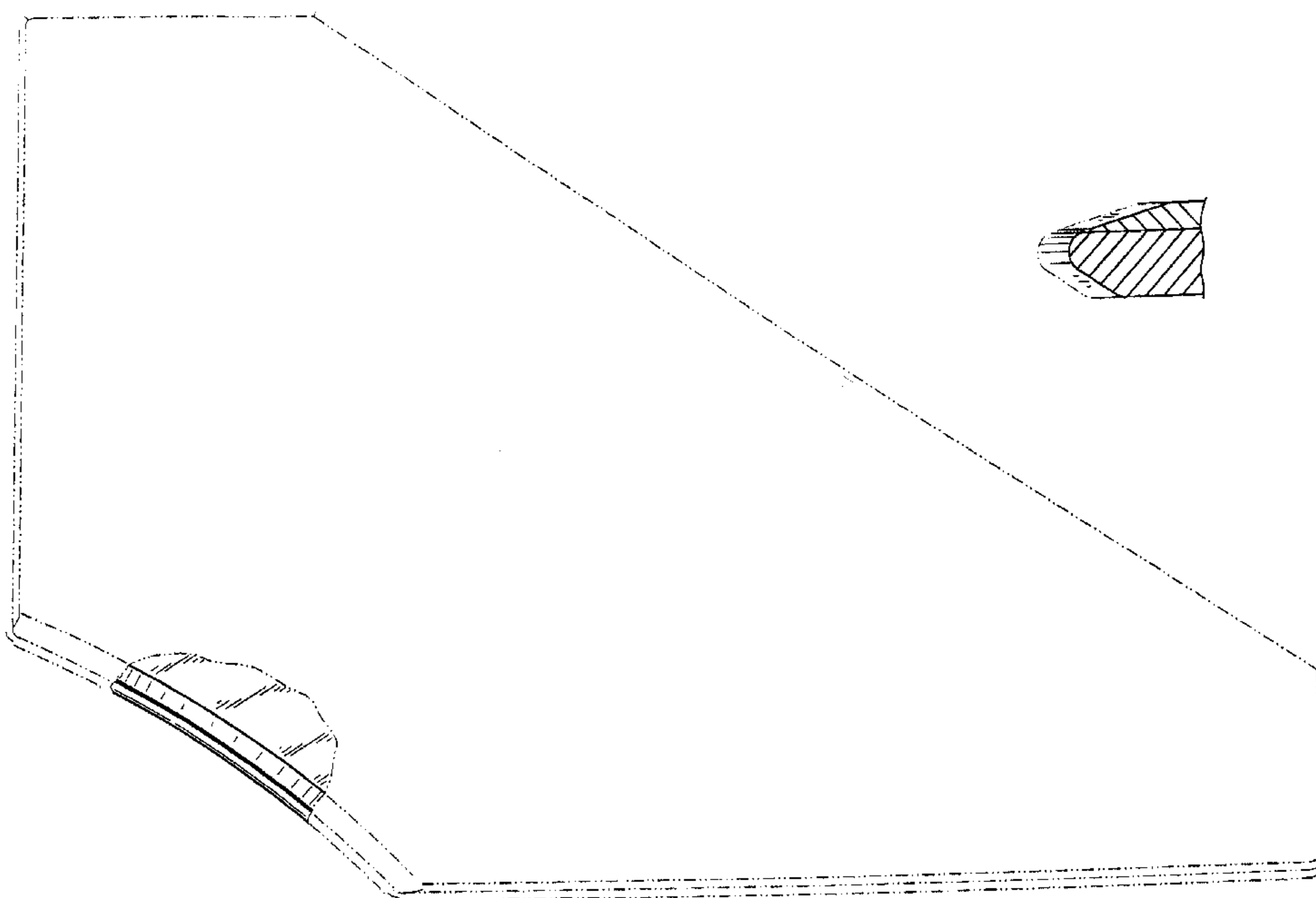
(57) **CLAIM**

The ornamental design for a modular stone-surfaced laminate, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a modular stone-surfaced laminate portion showing my new design, FIG. 2 is a top elevational view thereof; FIG. 3 is a side view thereof; FIG. 4 is a cross-sectional view taken along line 4—4 of FIG. 2; and, FIG. 5 is a bottom plan view thereof. The broken lines shown in all figures are for illustrative environmental purposes only and form no part of the claimed design.

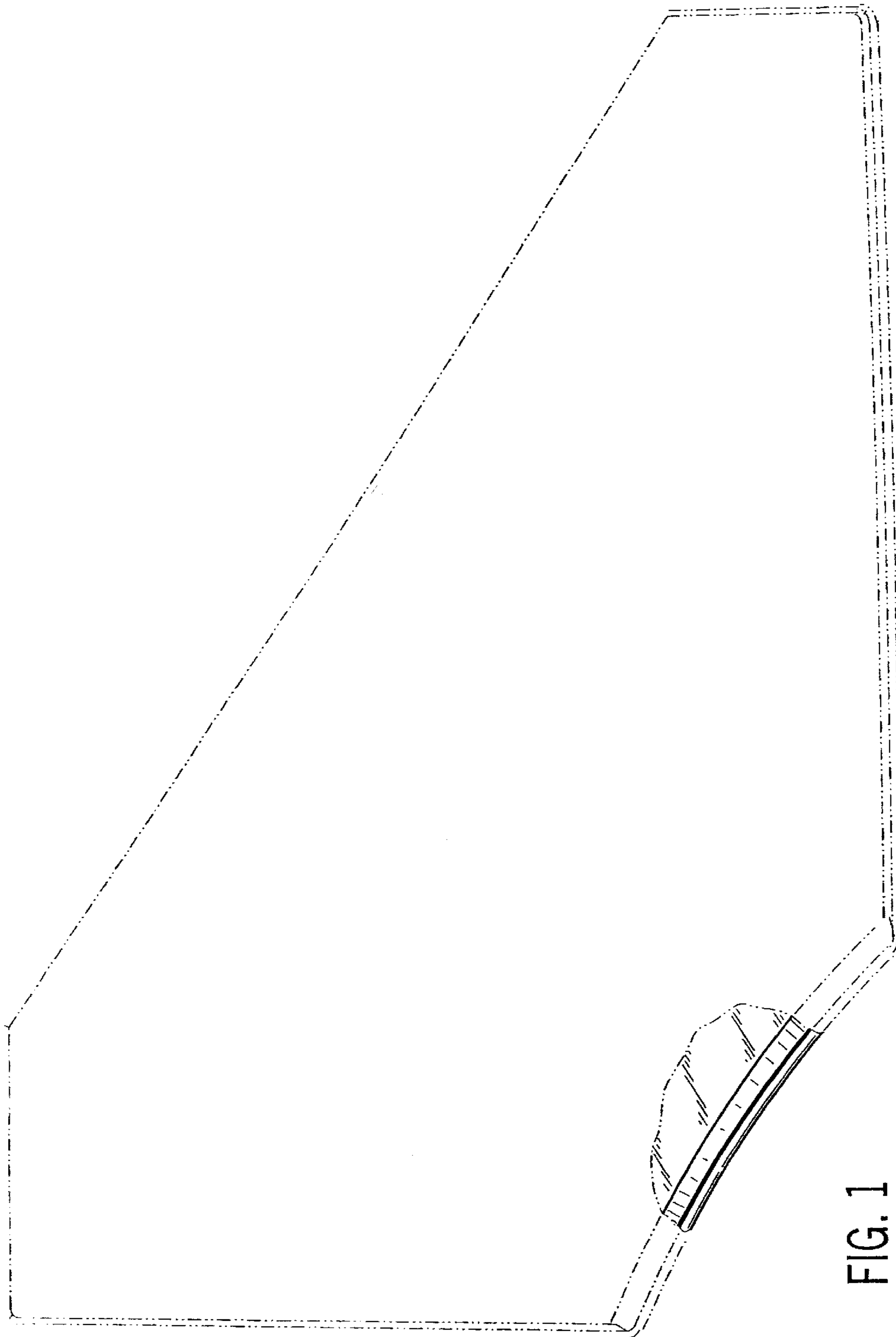

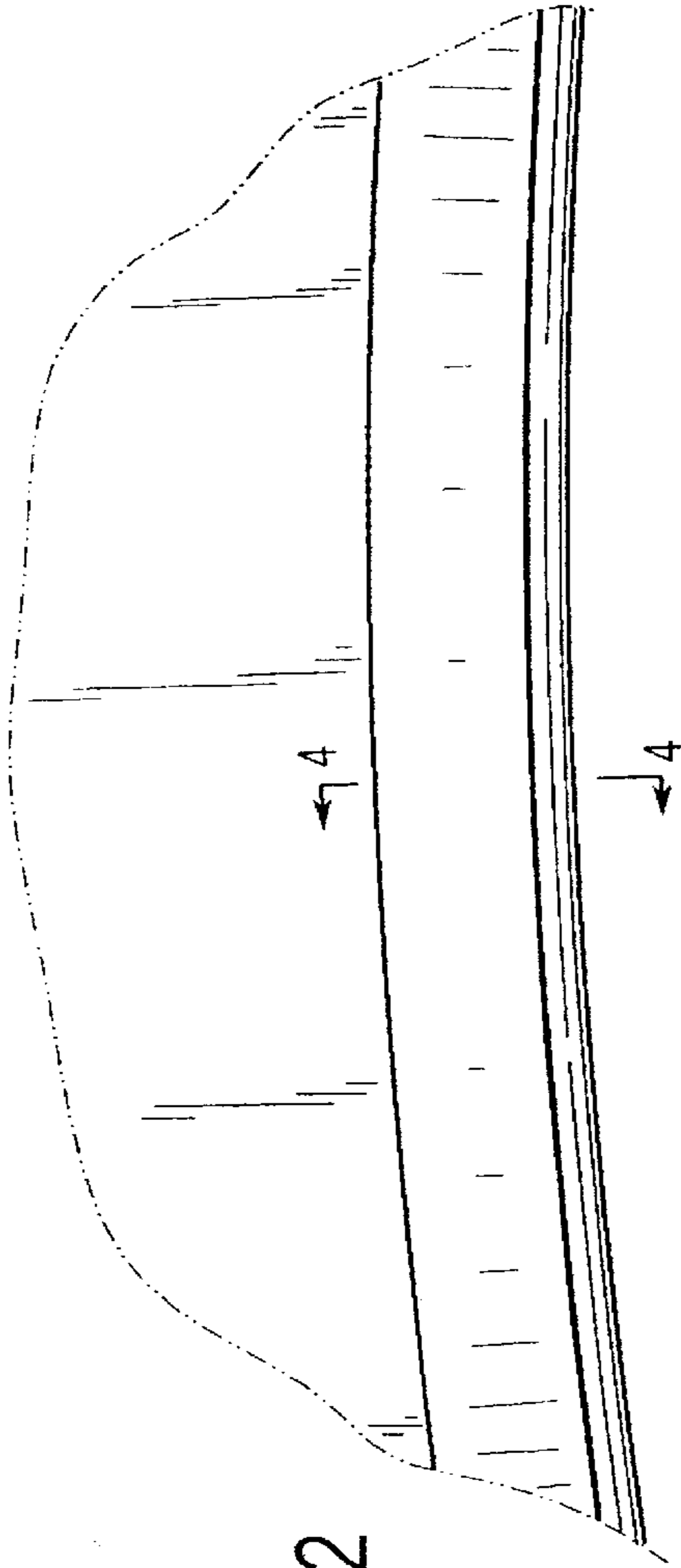

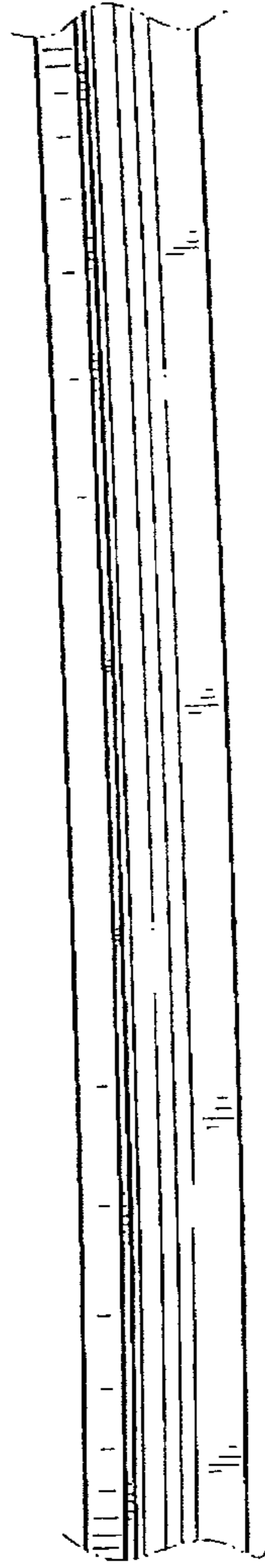

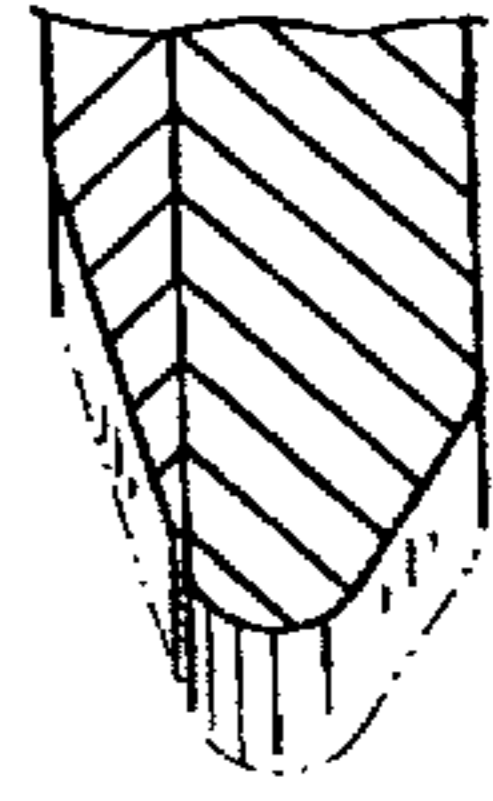

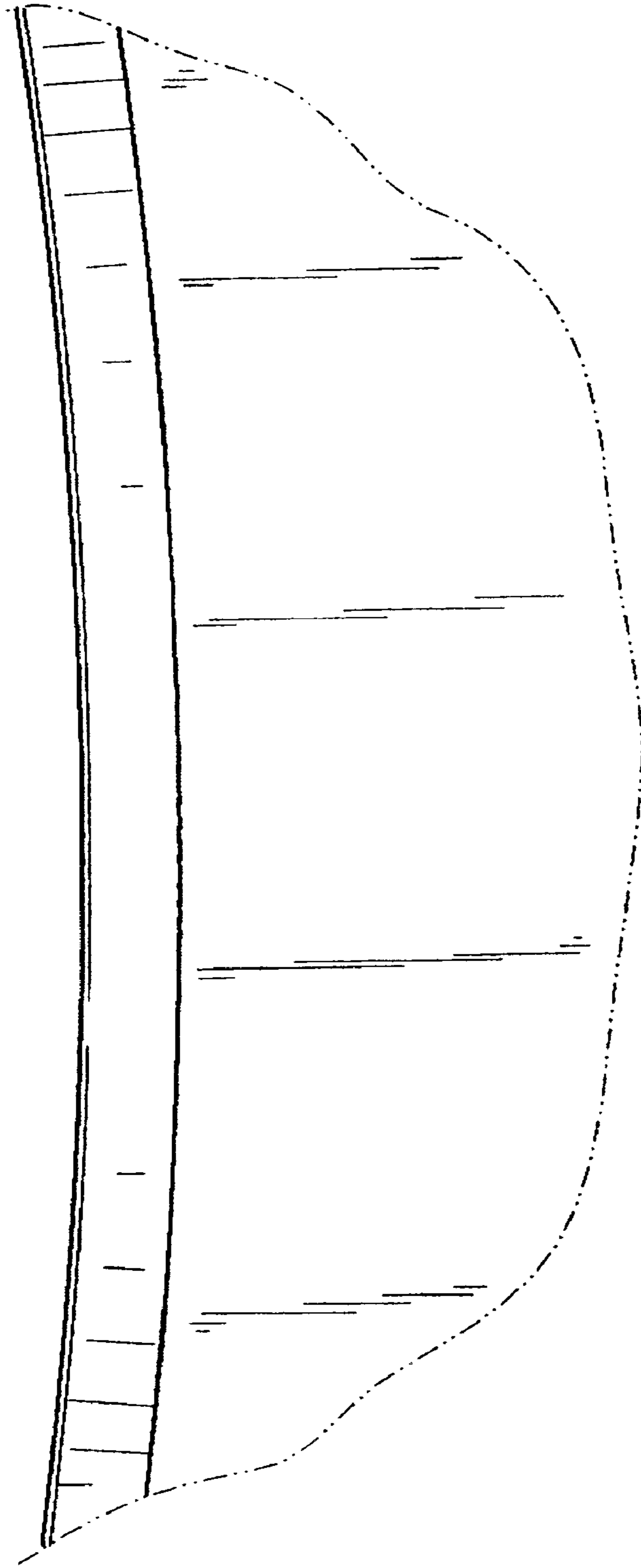
