(57) **CLAIM**

I claim the ornamental design for a three dimensional folding Christmas tree, as shown and described.

DESCRIPTION

FIG. 1 is a front elevational view of a three dimensional folding Christmas tree showing my new design;

FIG. 2 is a front perspective view thereof;

FIG. 3 is a top plan view thereof;

FIG. 4 is a bottom plan view thereof;

FIG. 5 is a front elevational view of a leaf element of FIG. 1, shown separately for clarity of illustration, the slits shown in broken lines for illustrative purpose only and form no part of the claimed design;

FIG. 6 is a front elevational view thereof, on a reduced scale;

FIG. 7 is a front elevational view of the small tree element of FIG. 1, on a reduced scale, shown separately for clarity of illustration;

FIG. 8 is a front perspective view of FIG. 7;

FIG. 9 is a top plan view of FIG. 7, on an enlarged scale;

FIG. 10 is a bottom plan view of FIG. 9;

FIG. 11 is a front elevational view of a leaf element of FIG. 7, shown separately for clarity of illustration, the slits shown in broken lines for illustrative purpose only and form no part of the claimed design;

FIG. 12 is a front elevational view of FIG. 7;

FIG. 13 is a front elevational view of the base element of FIG. 1 in an unassembled condition, shown separately for clarity of illustration;

FIG. 14 is a top perspective view of FIG. 13 in a partially assembled condition;

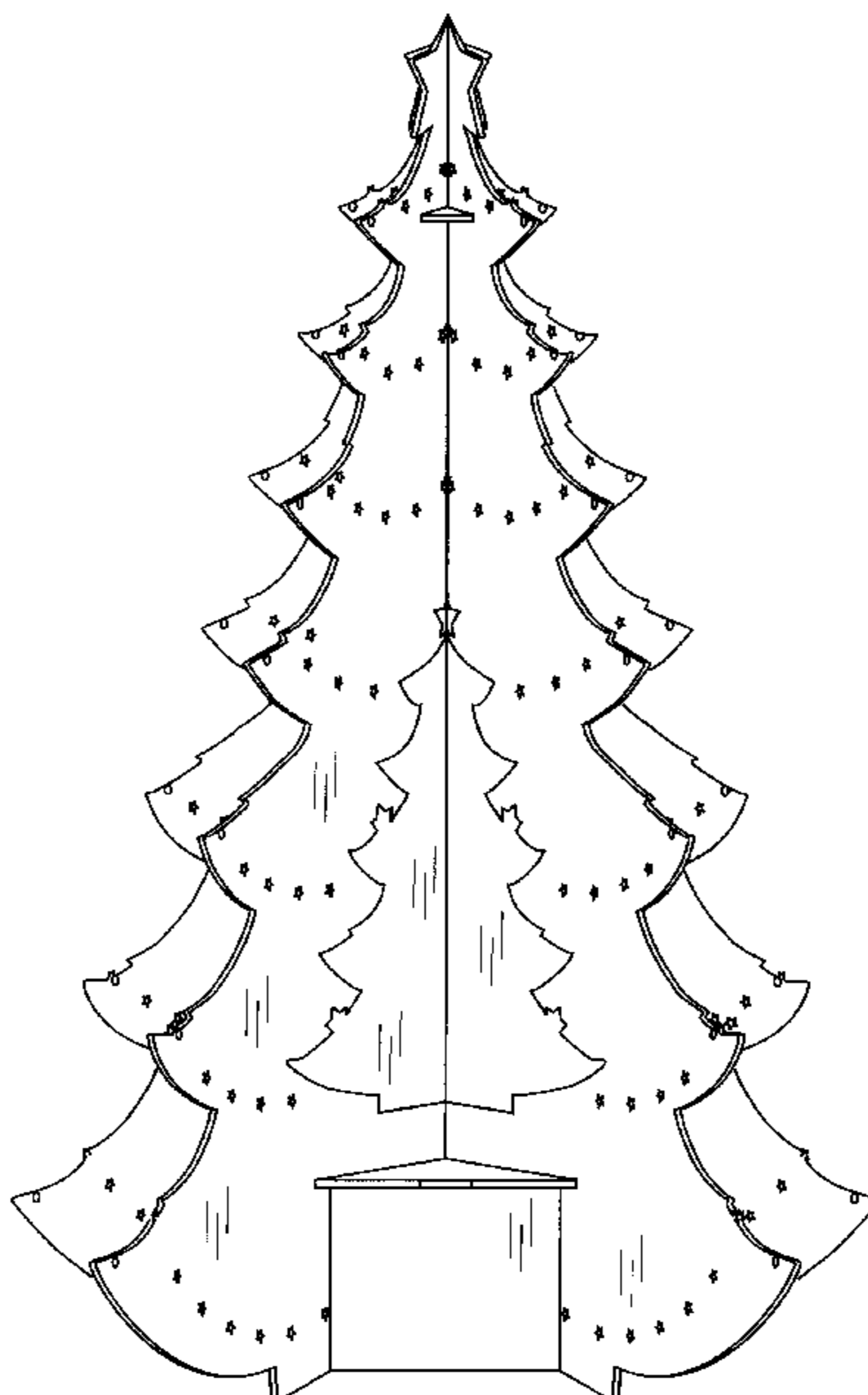
FIG. 15 is a top plan view of the top element of the base support of FIG. 1, shown separately for clarity of illustration;

FIG. 16 is a top plan view of the upper structural support of FIG. 1, shown separately for clarity of illustration;

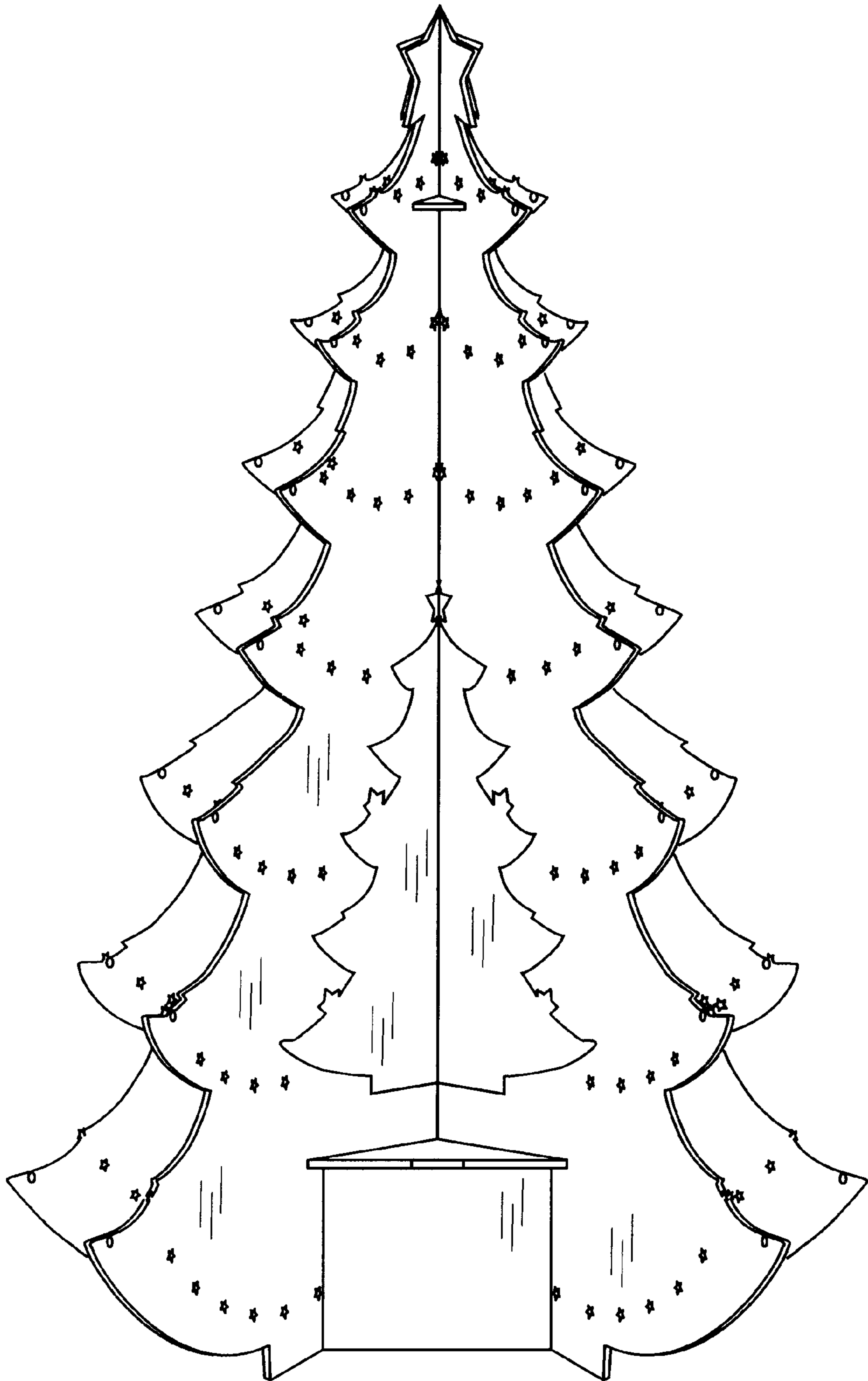

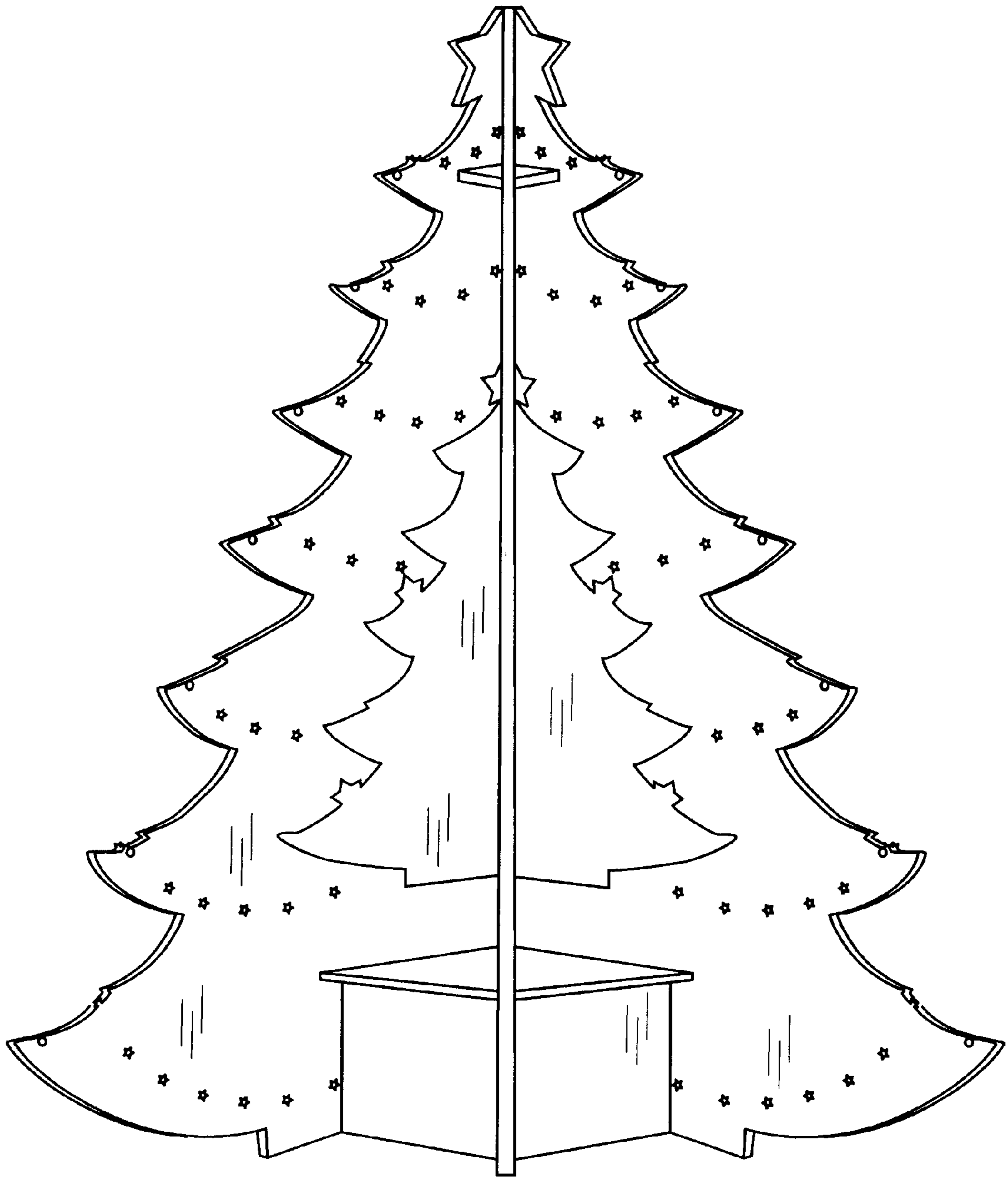

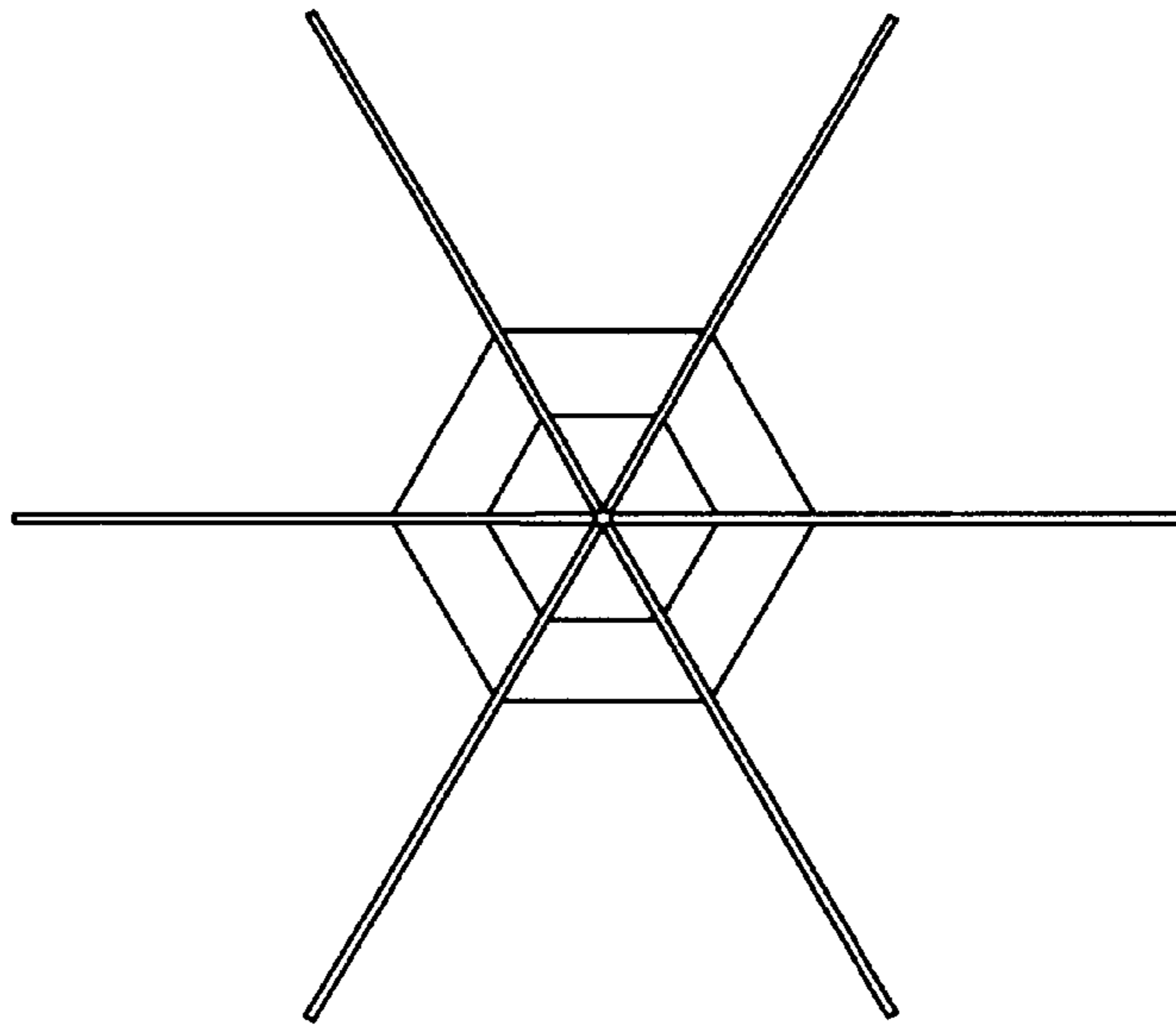

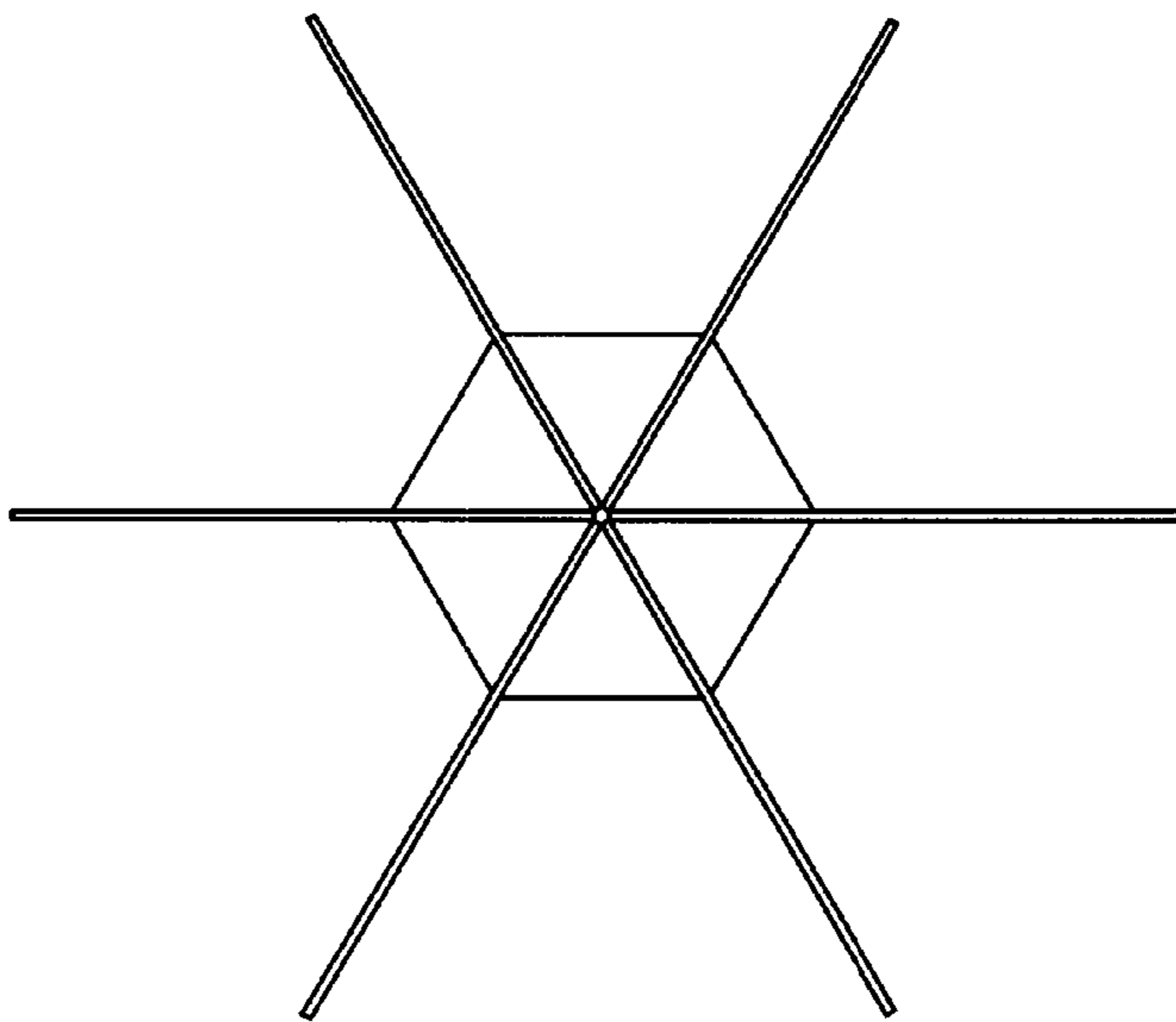

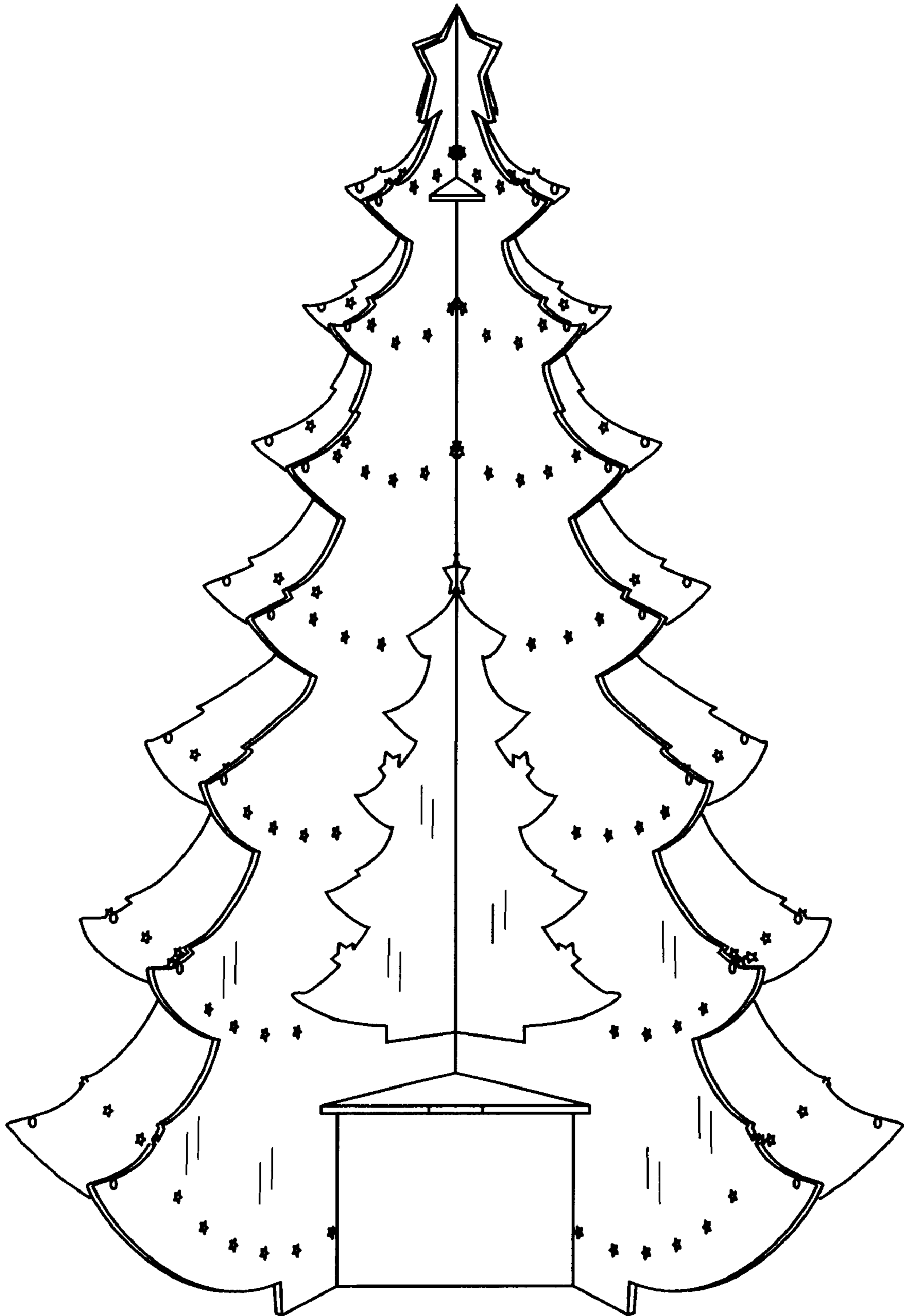

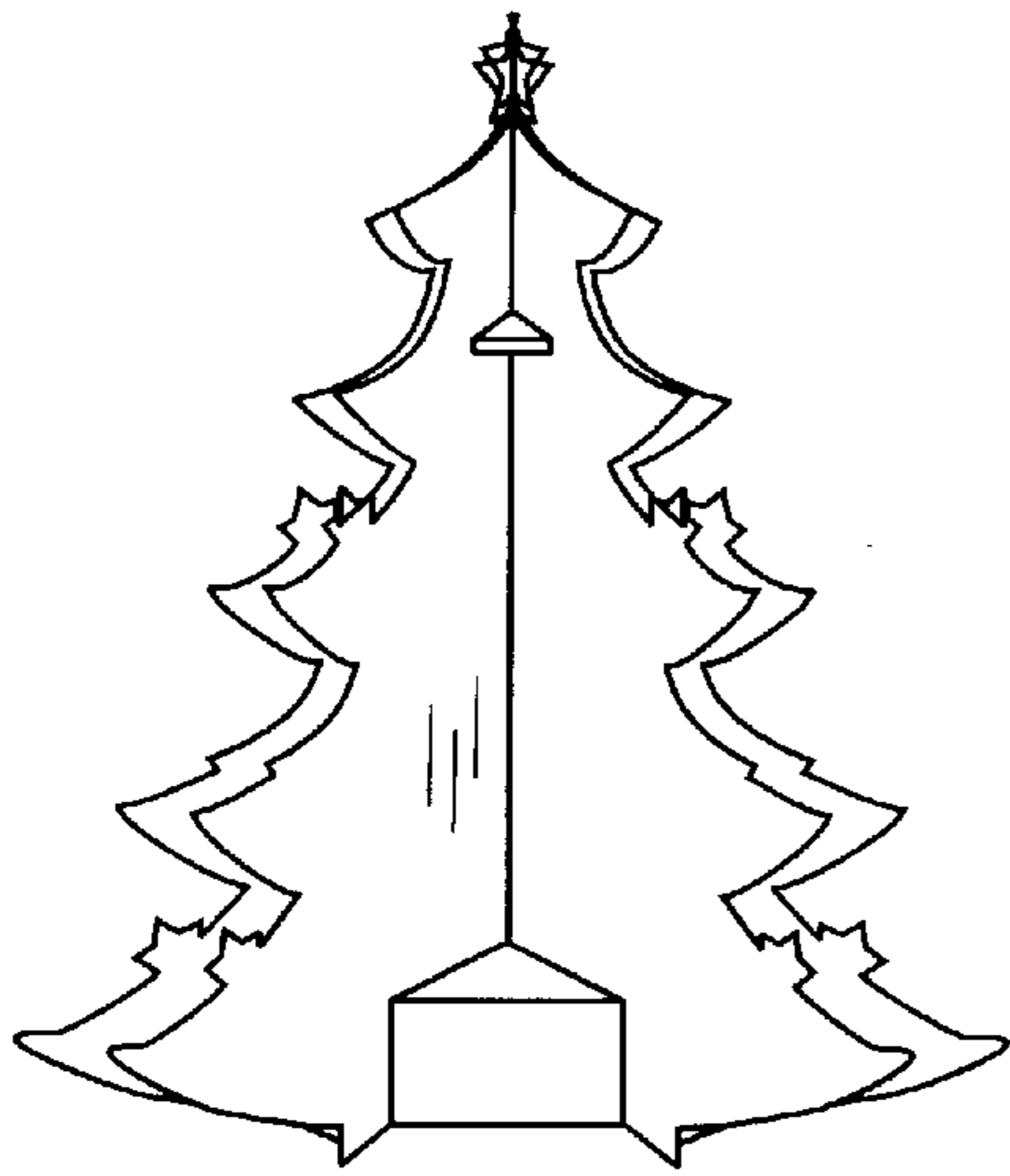

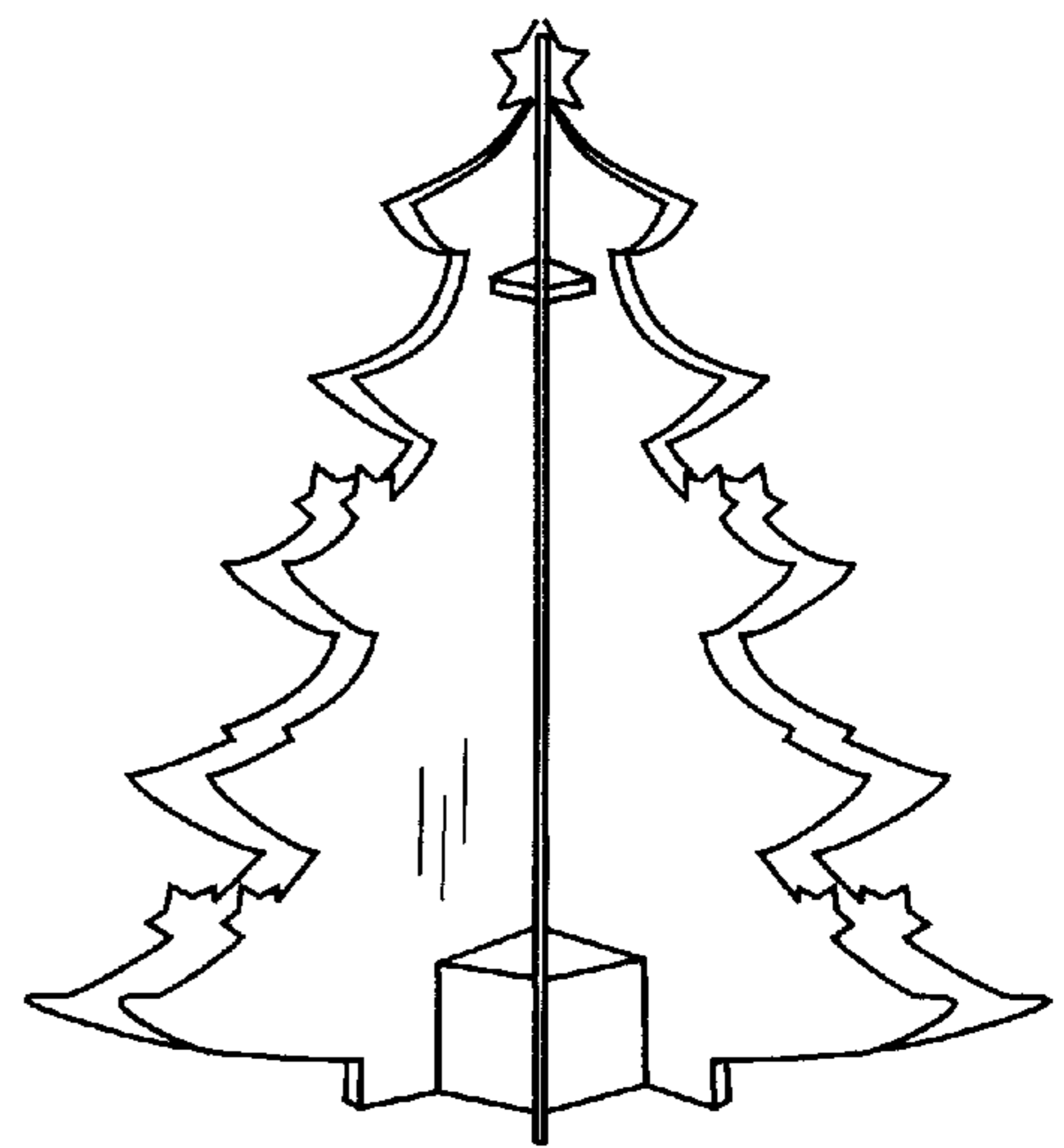

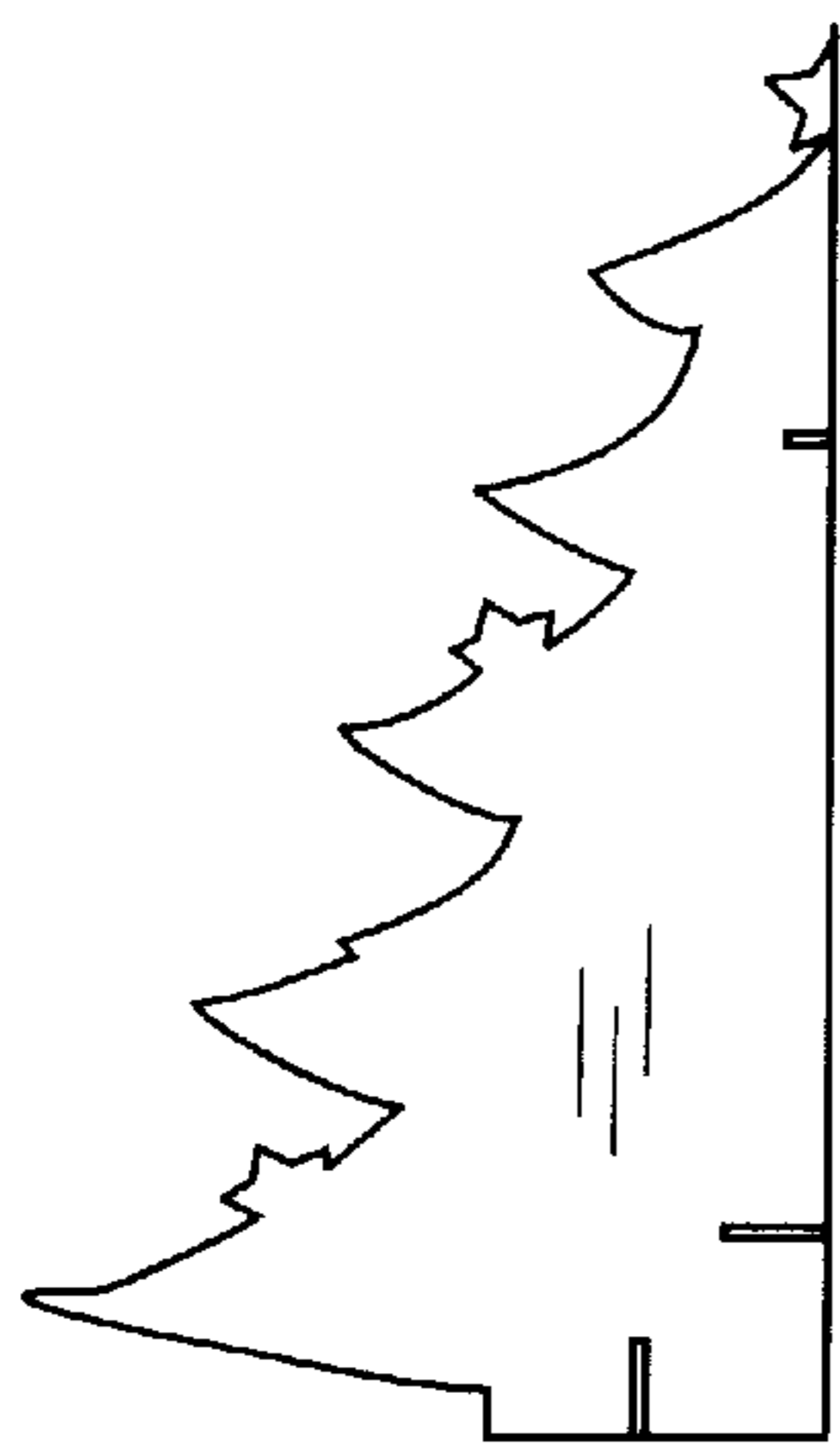

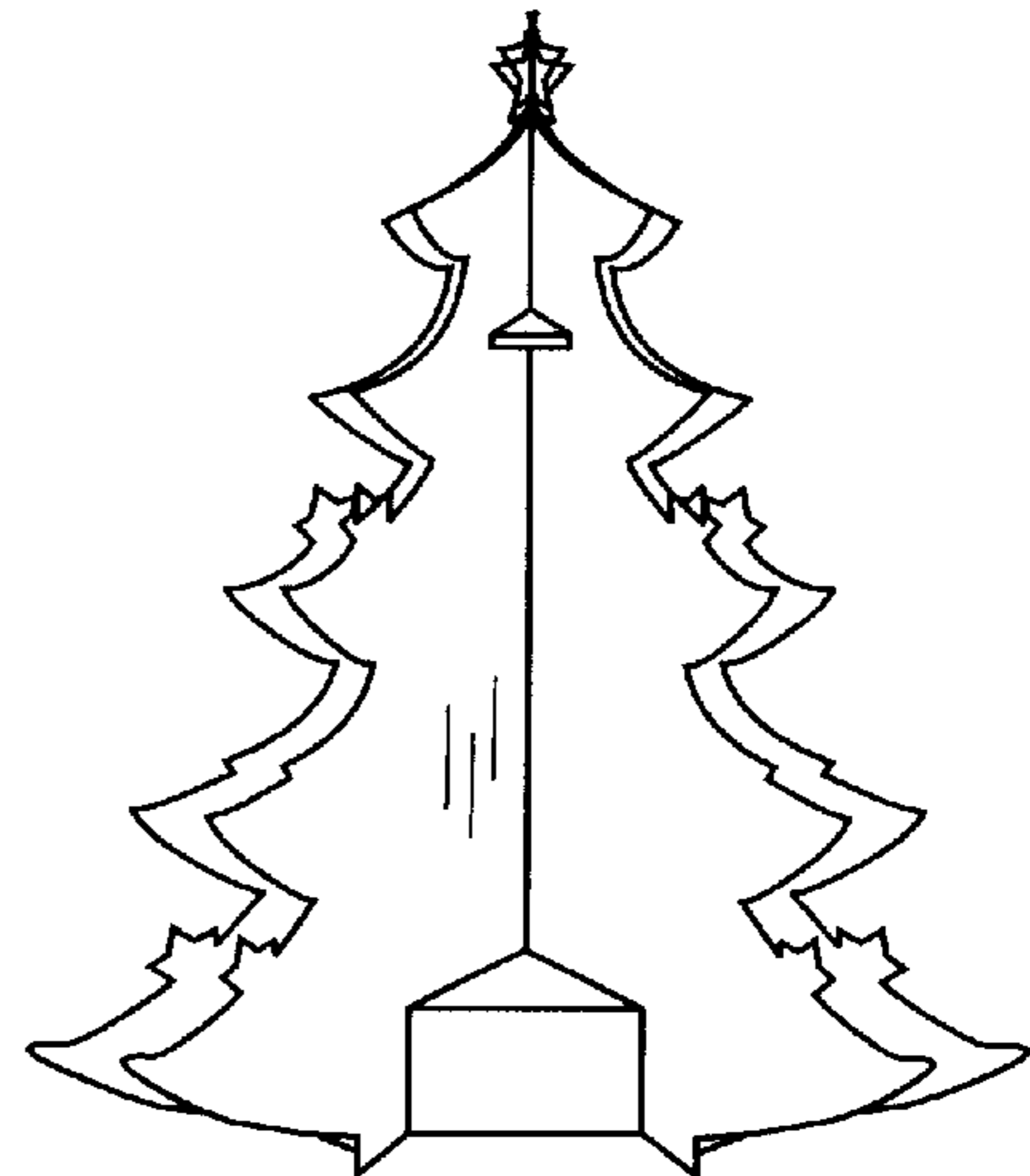

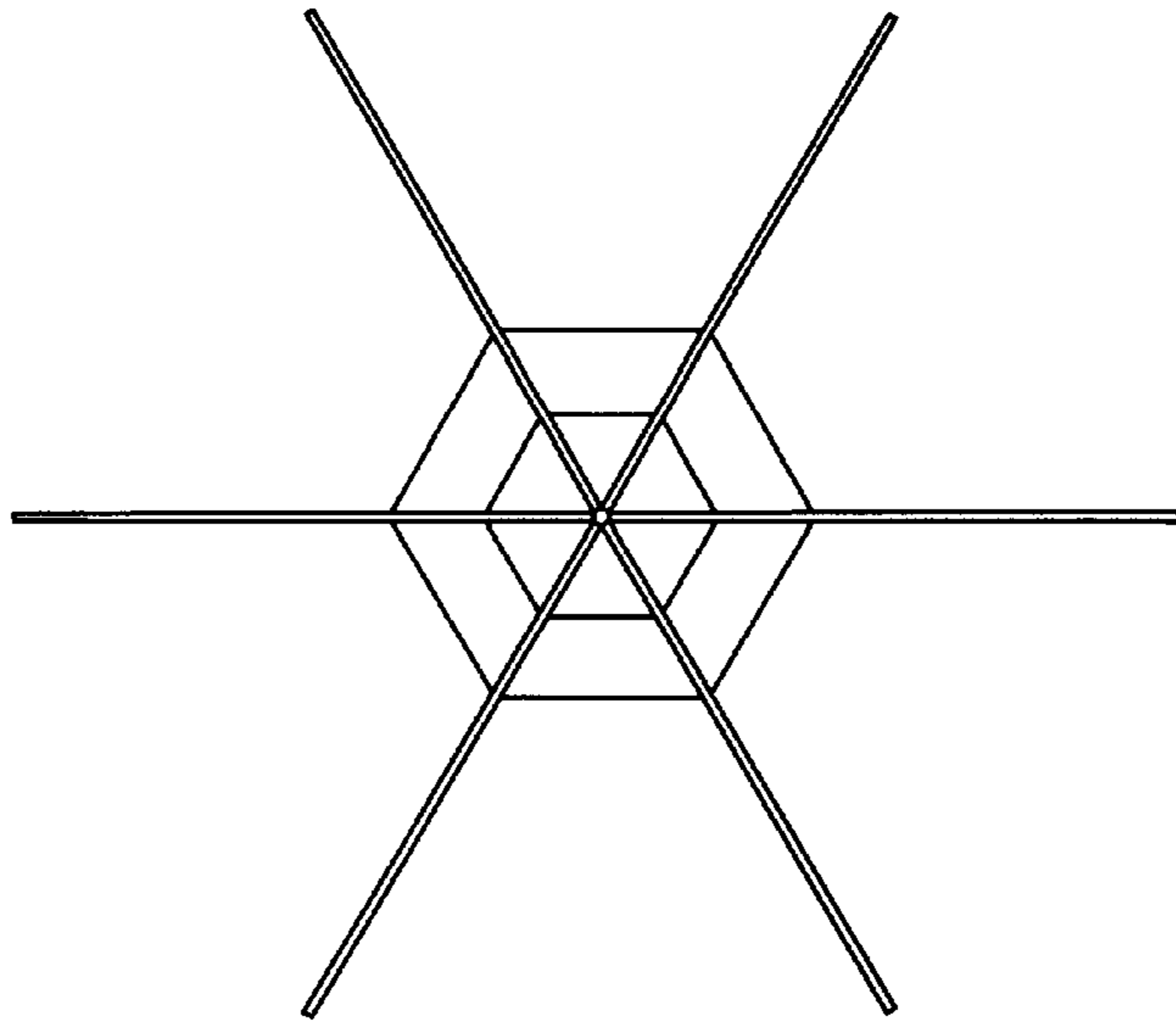

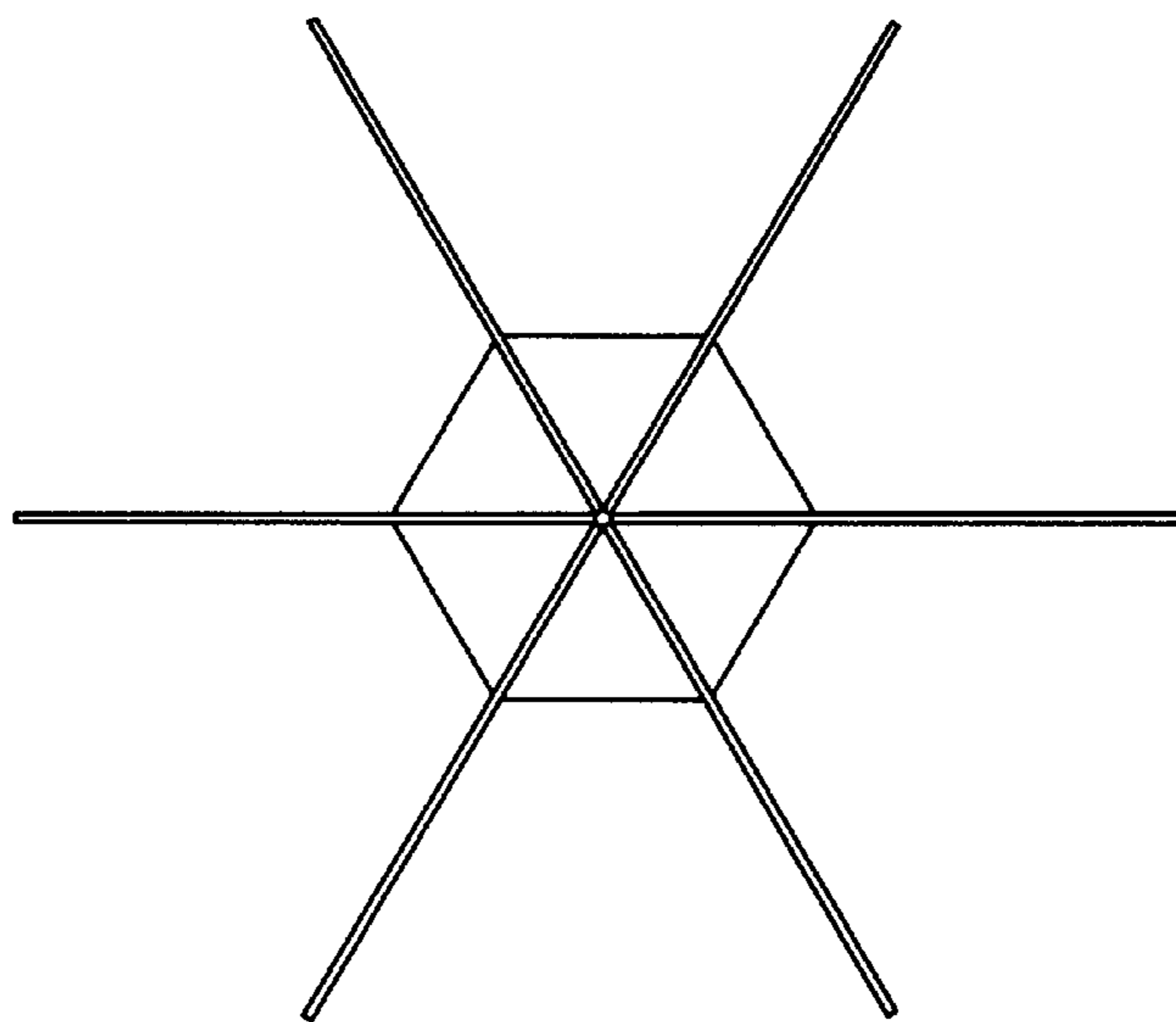

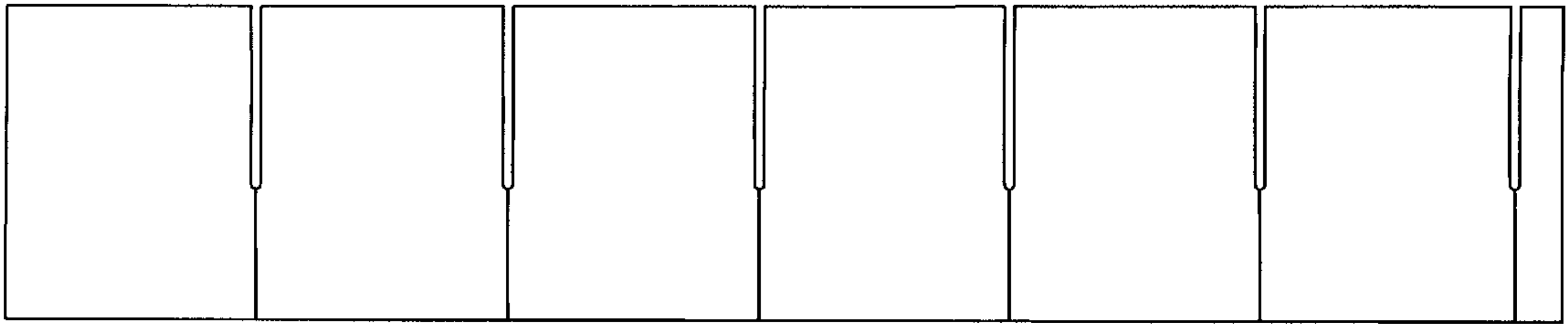

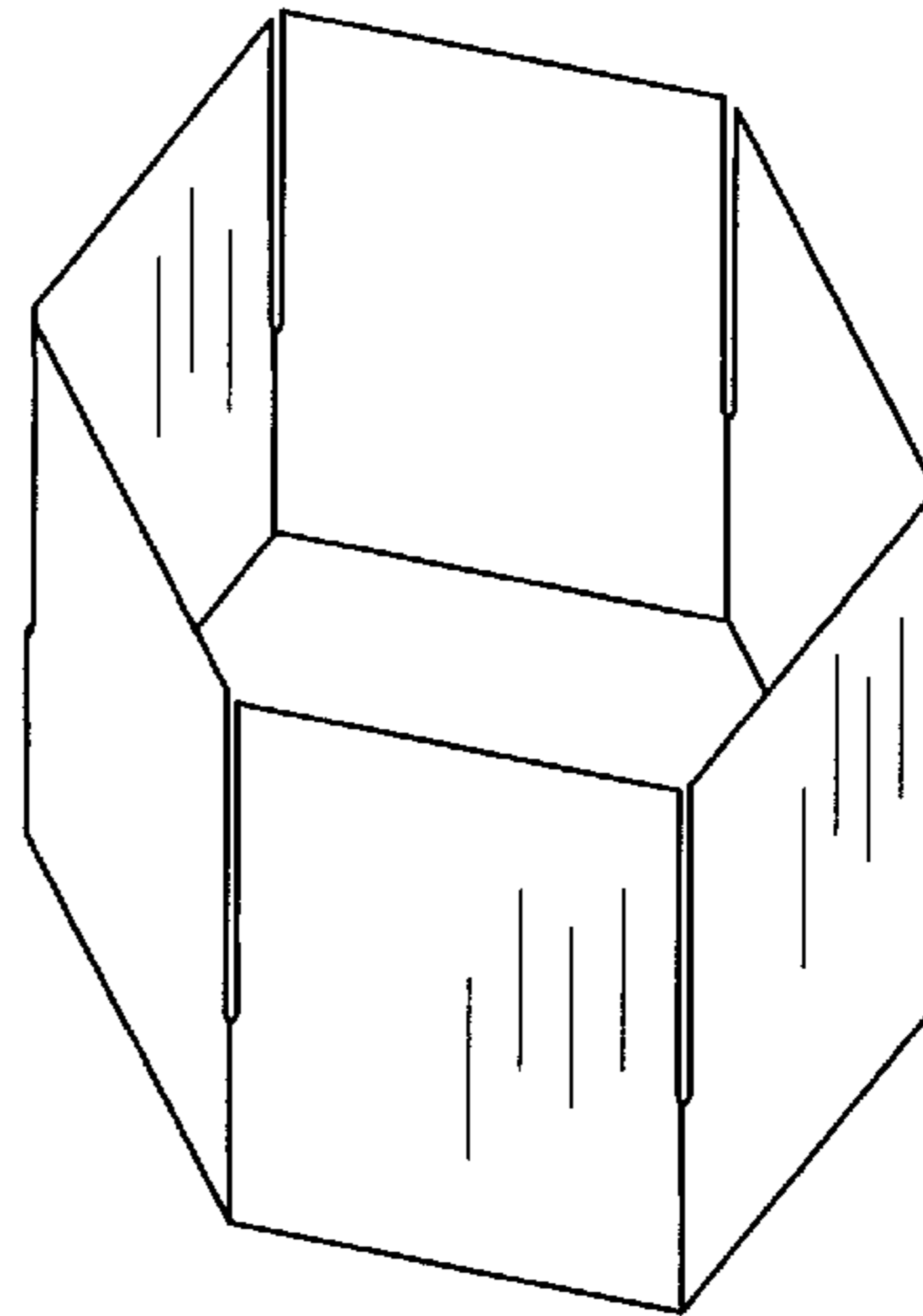

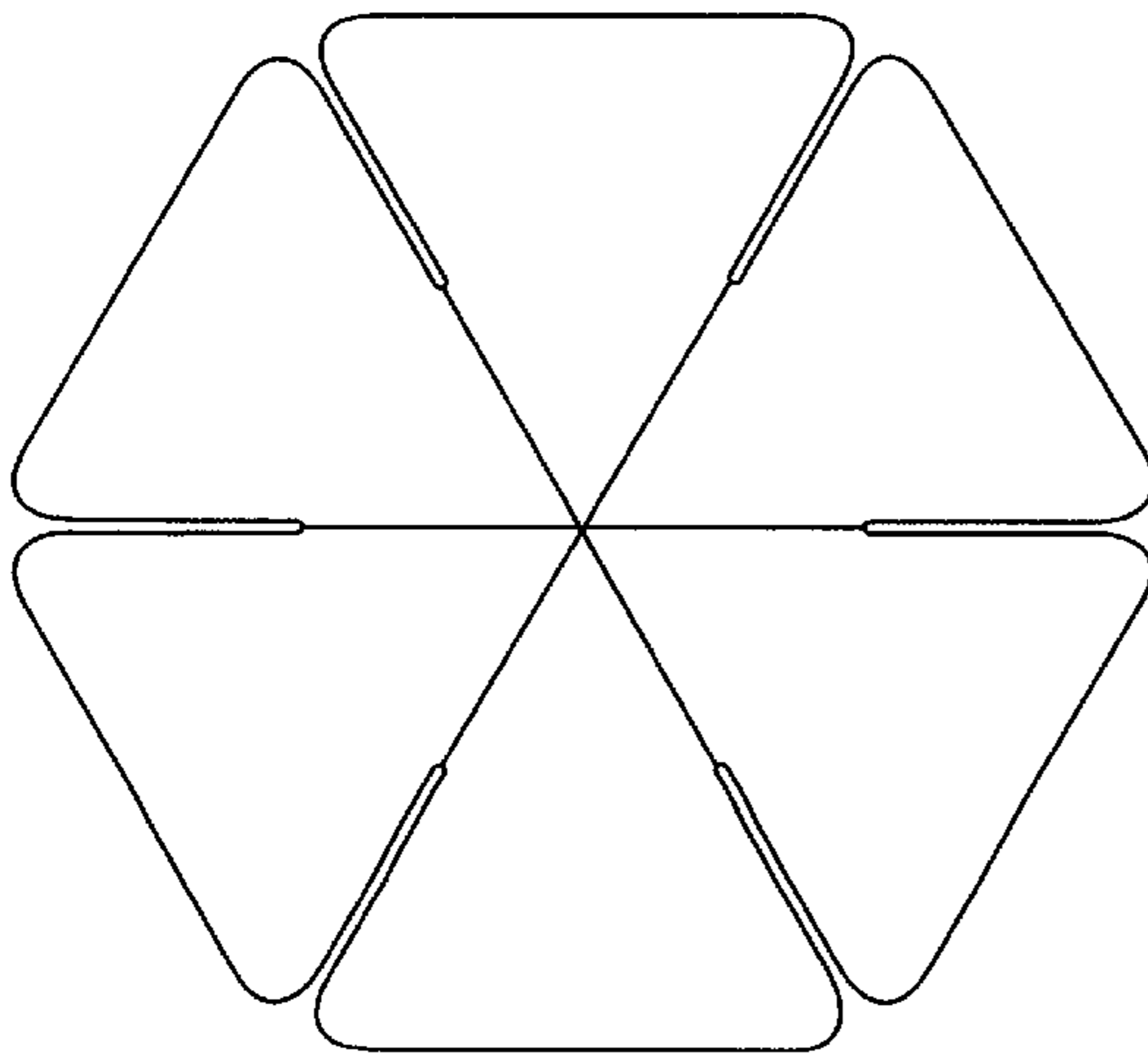
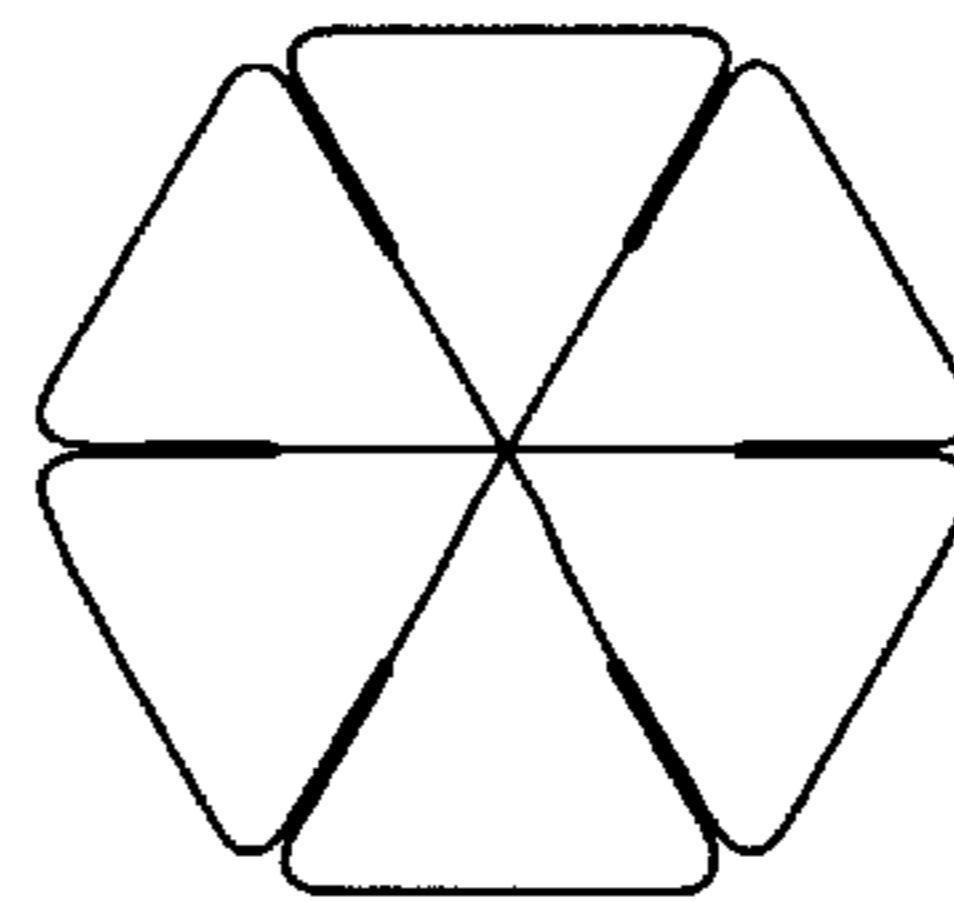

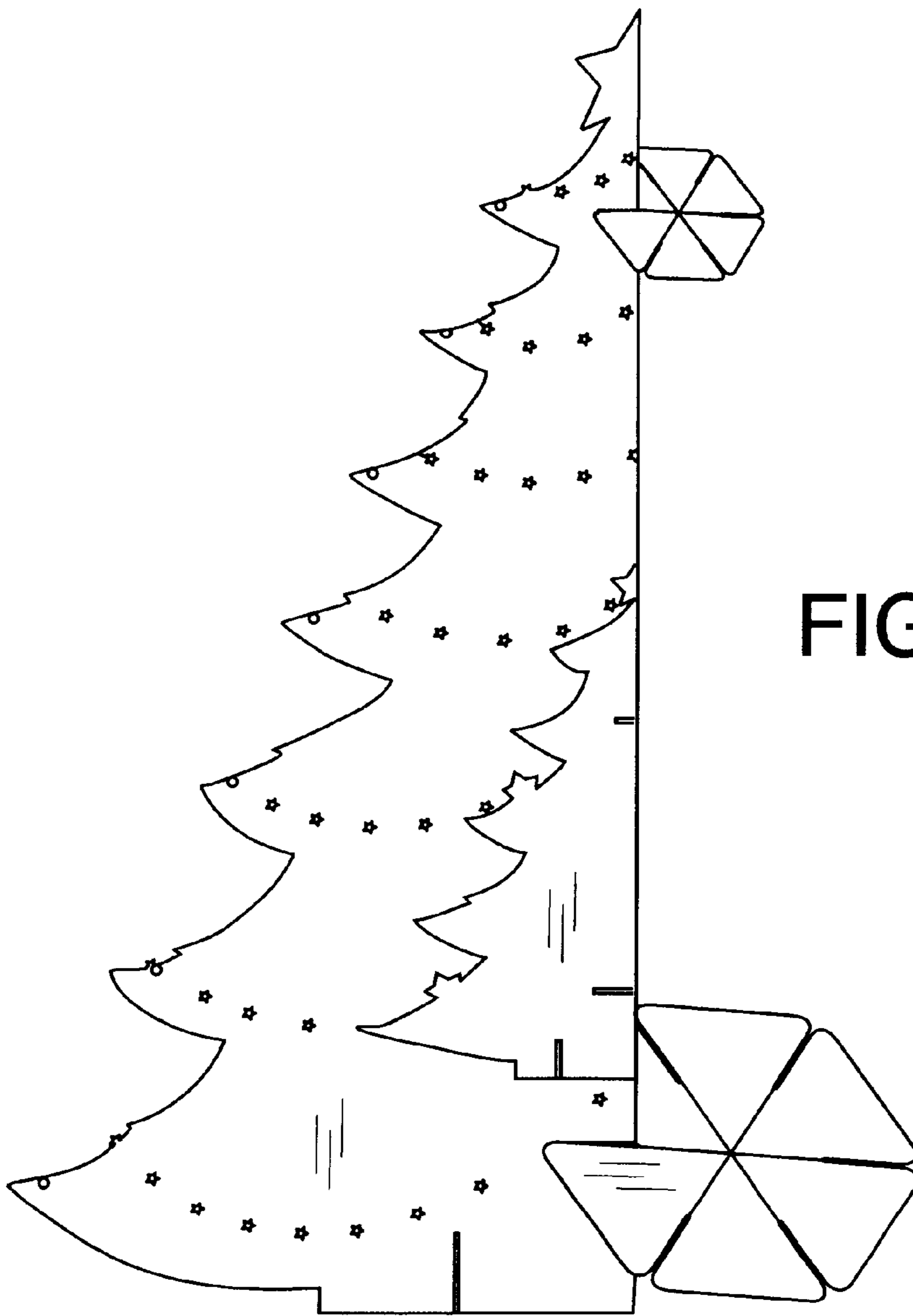
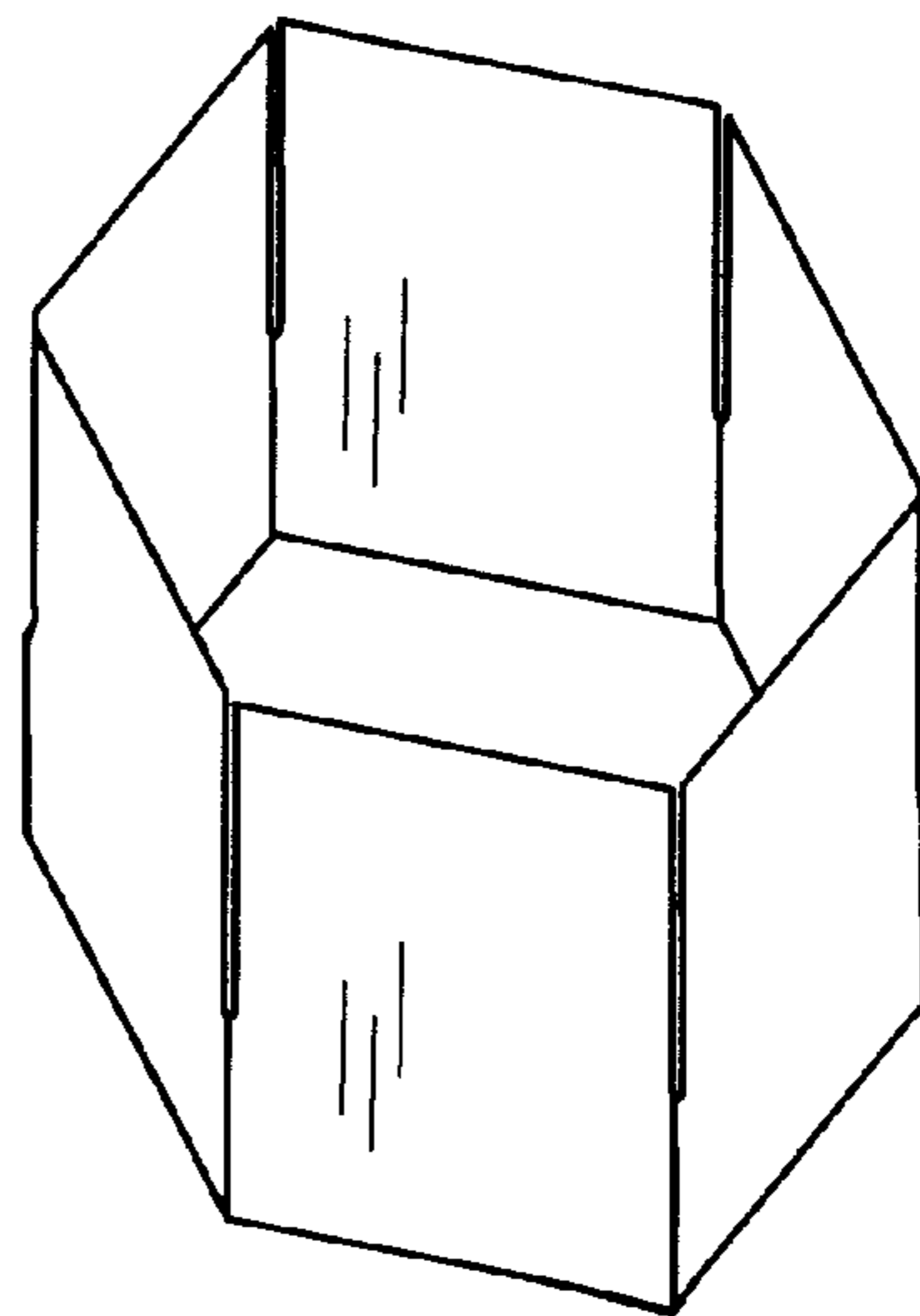

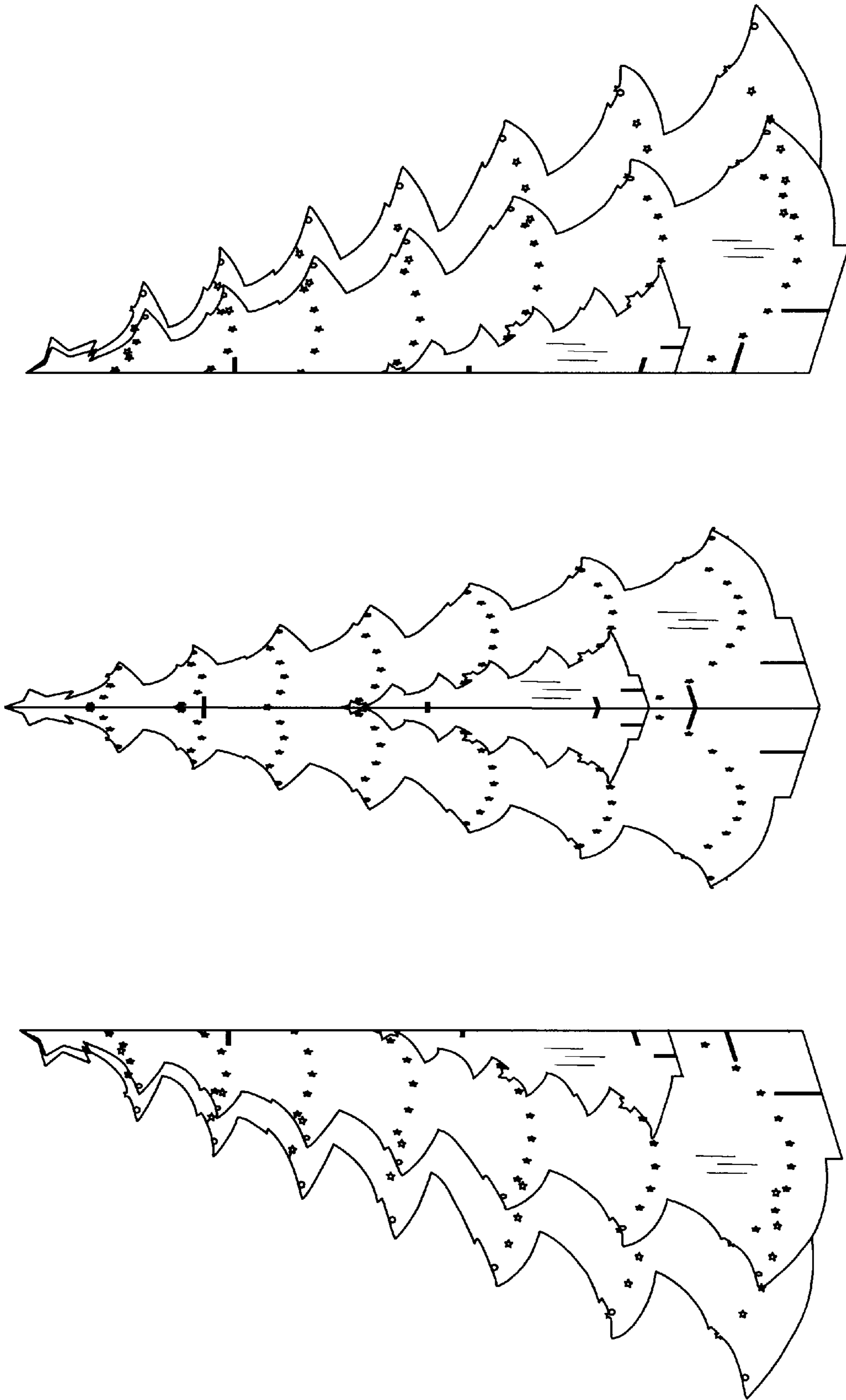
