DESCRIPTION

FIG. 9 is a top plan view showing a third embodiment, in color, of our new design, the other views of the third embodiment being substantially the same as those of the first embodiment;

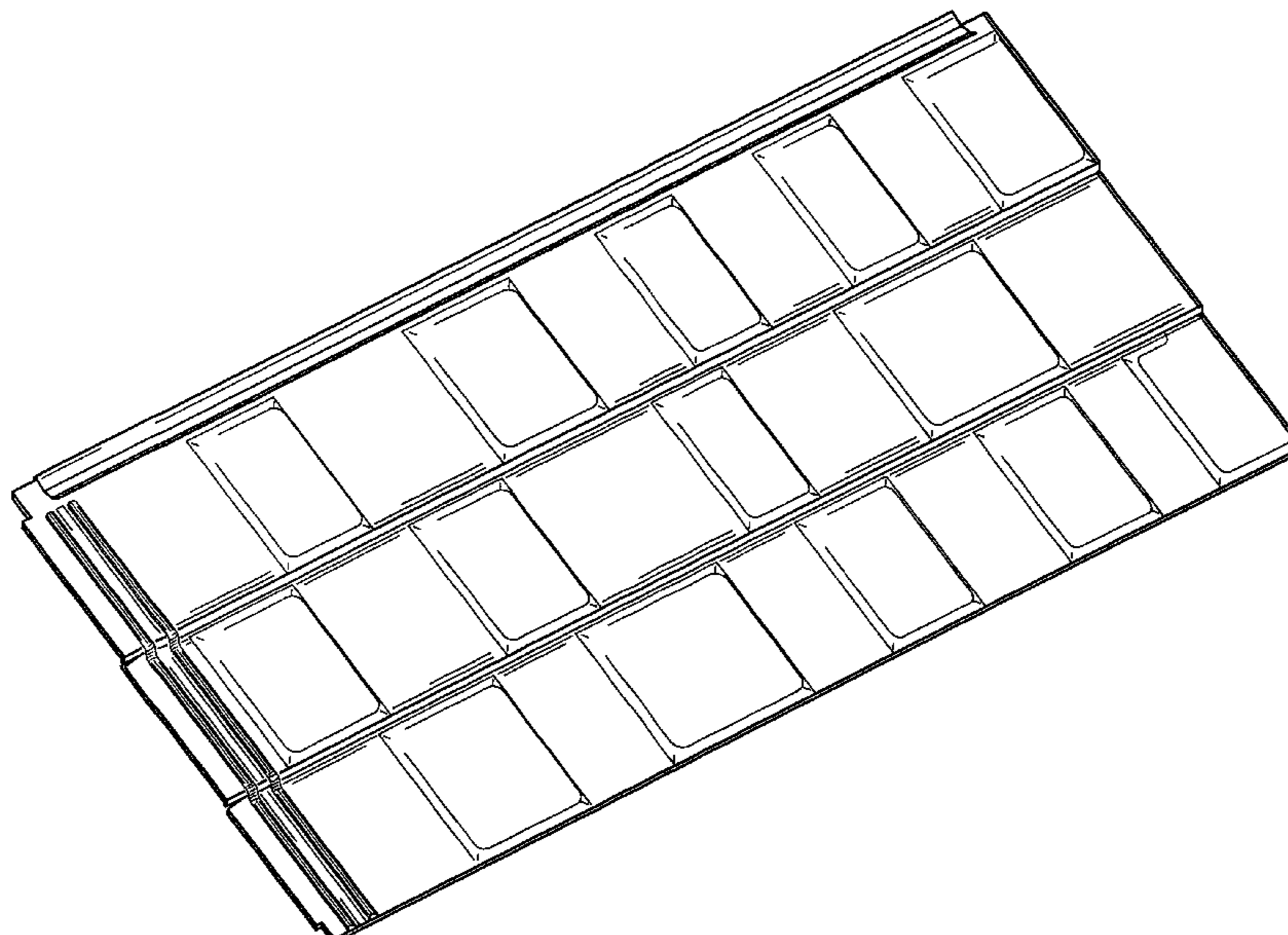

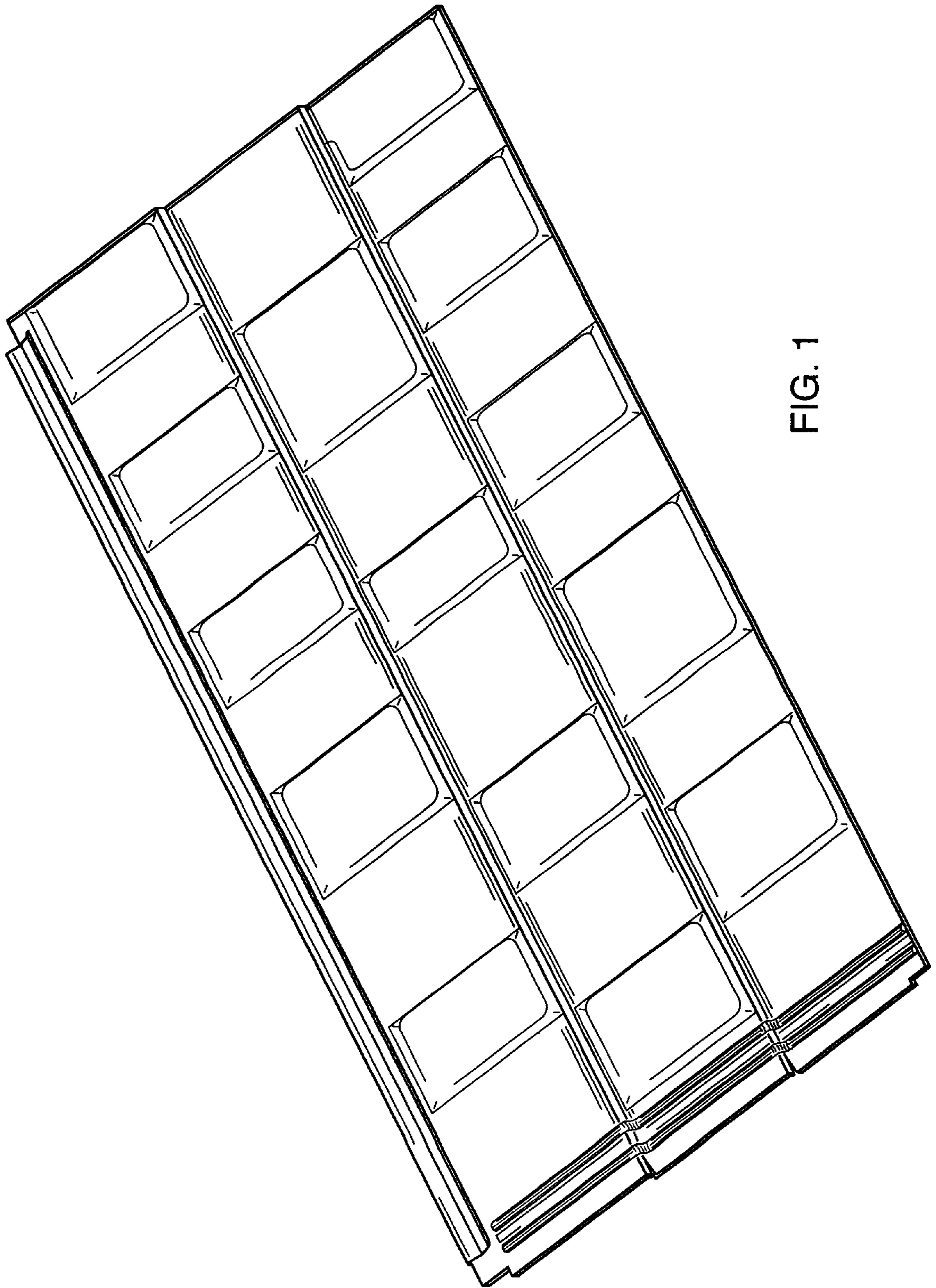

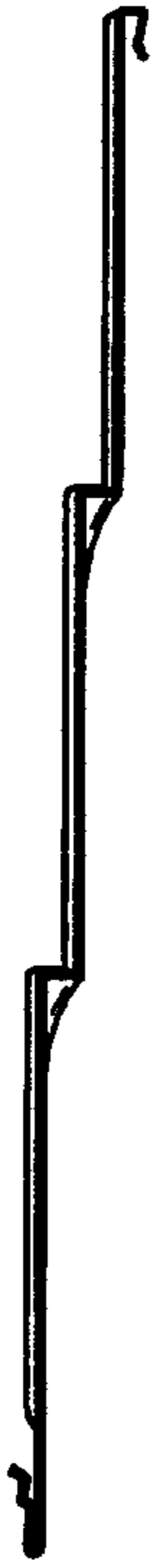

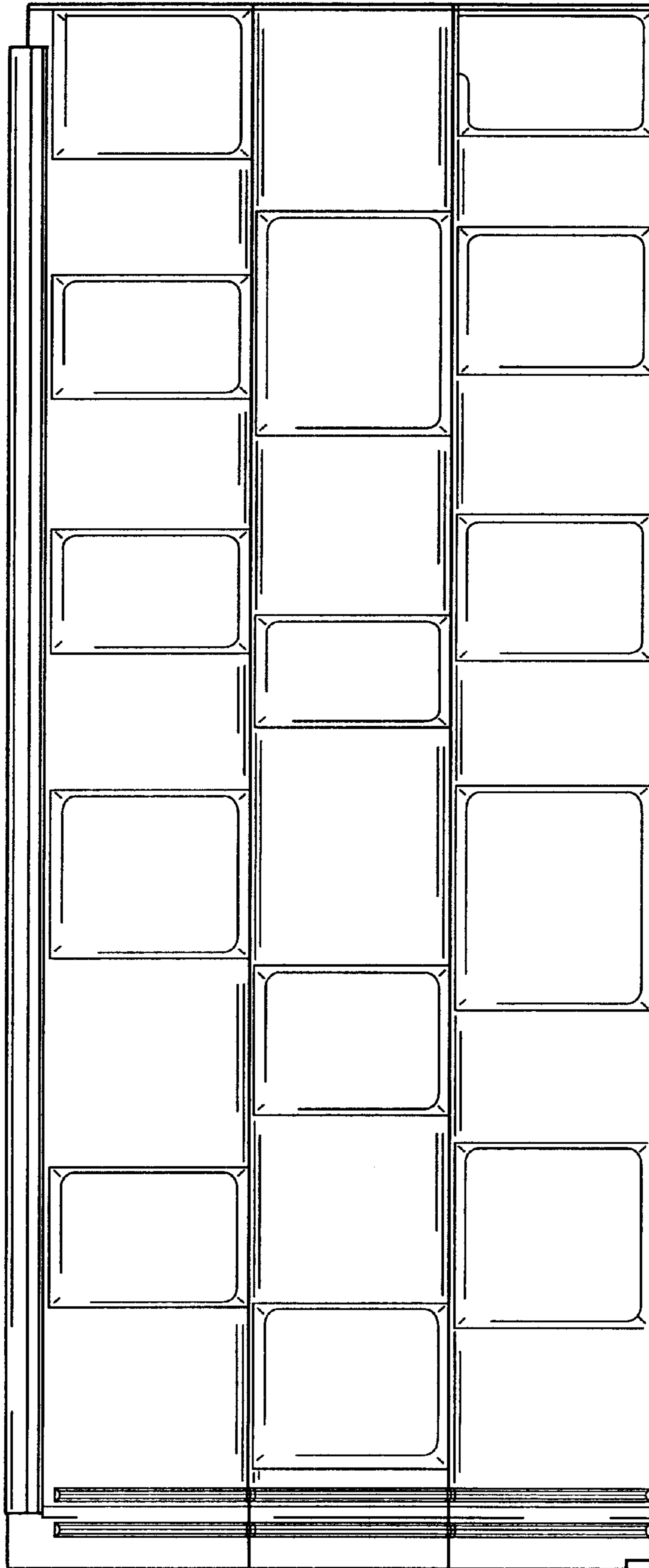

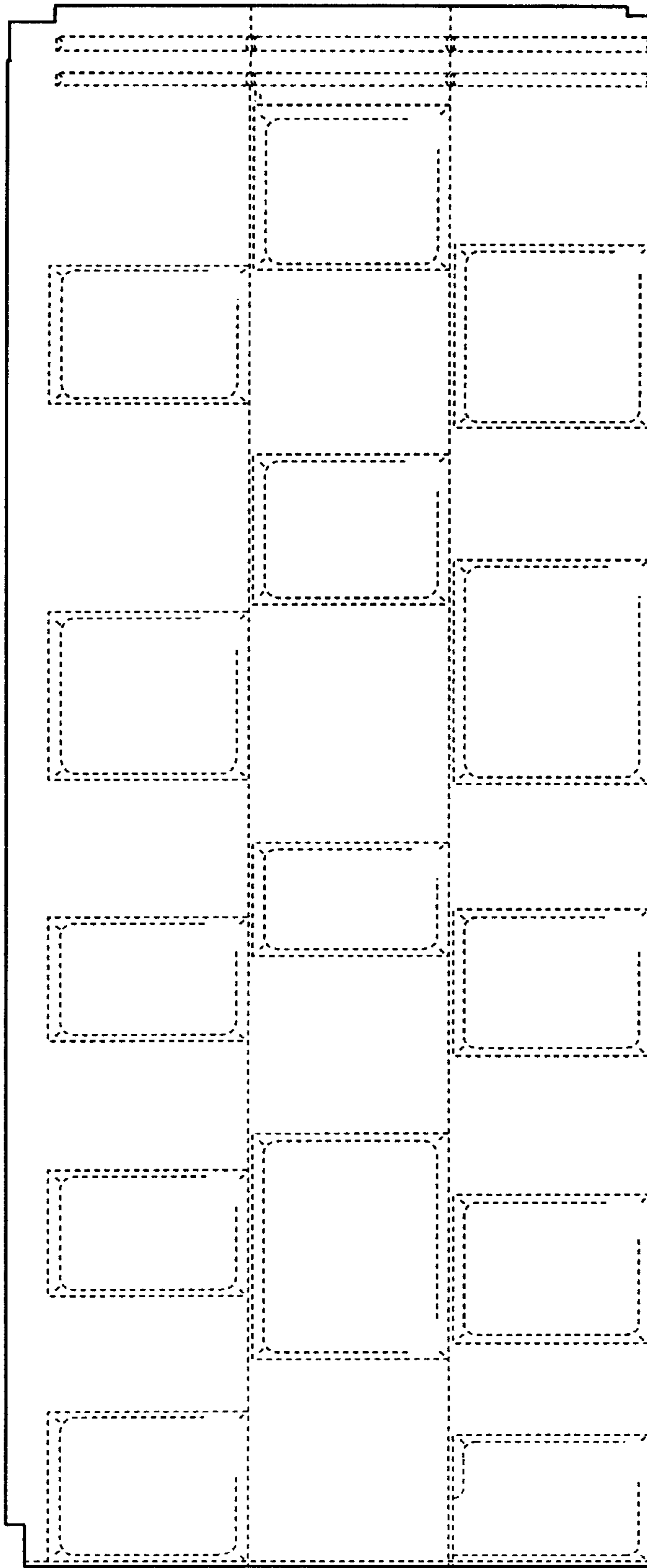

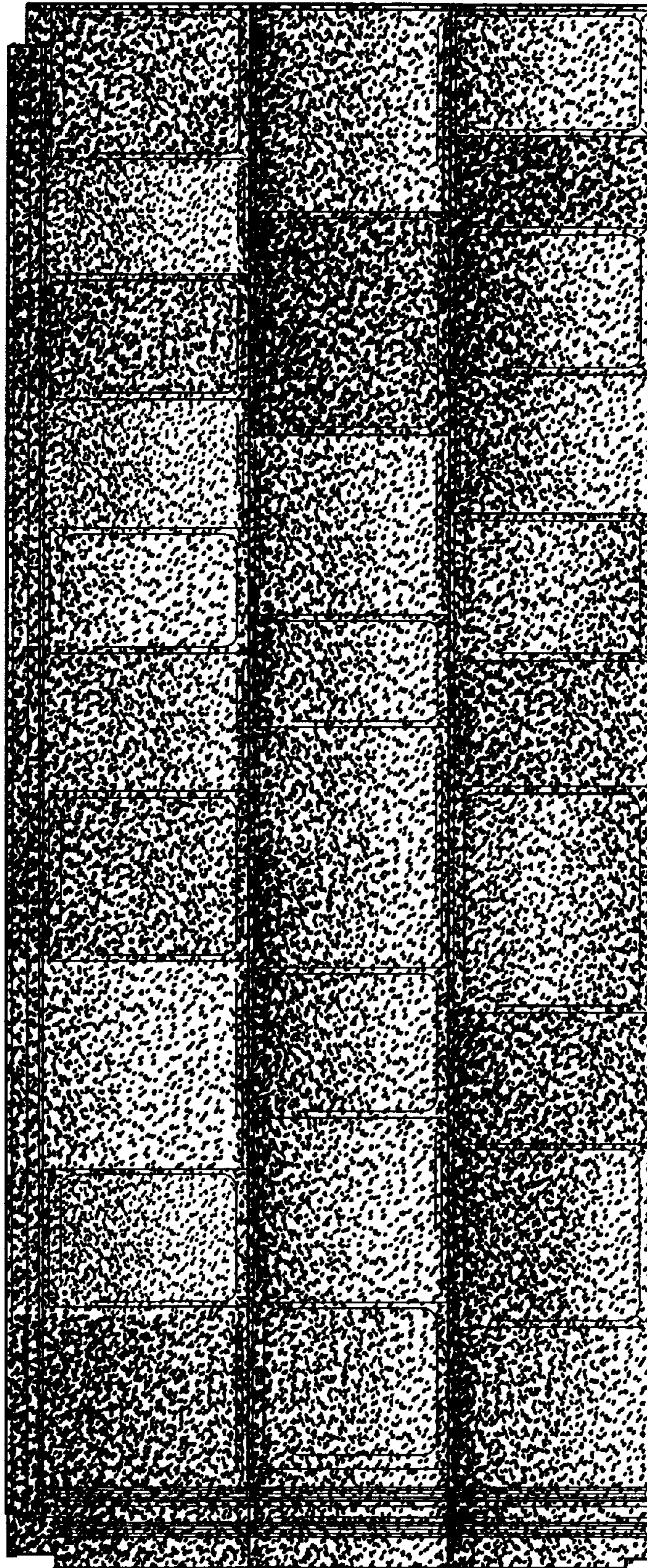

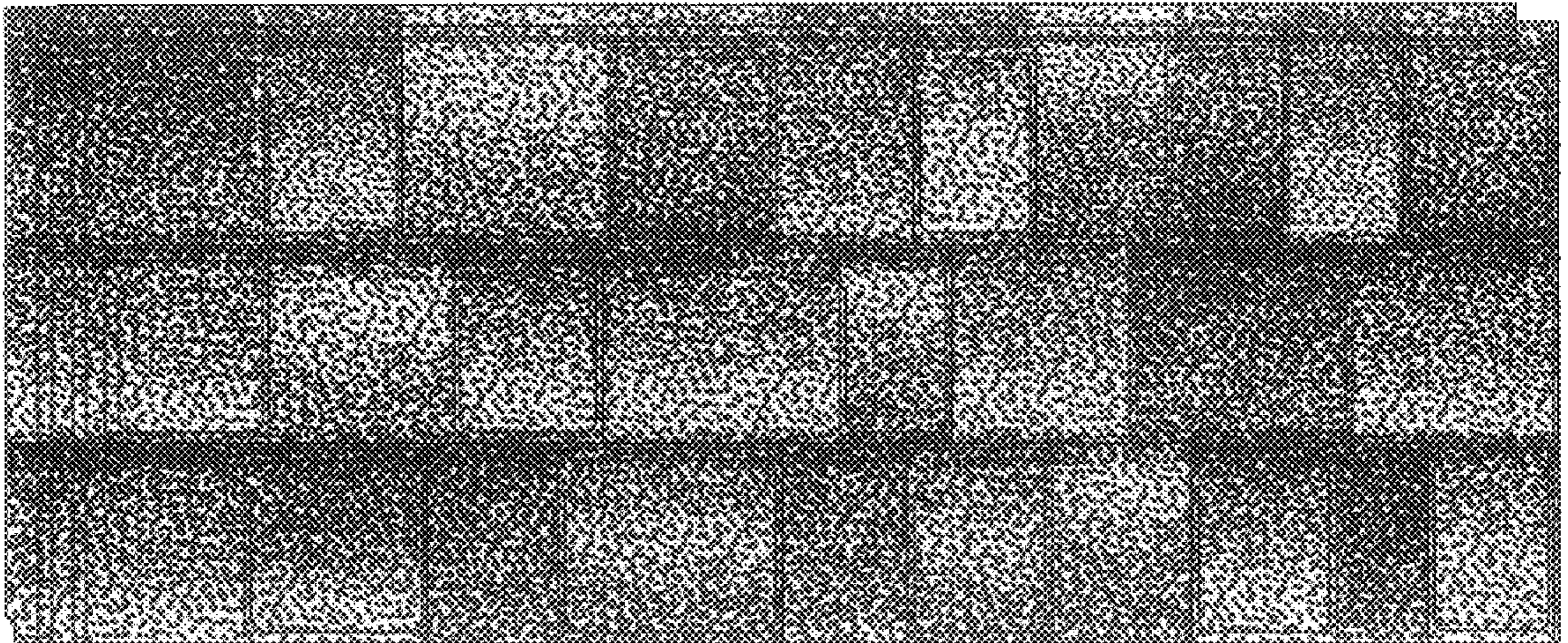

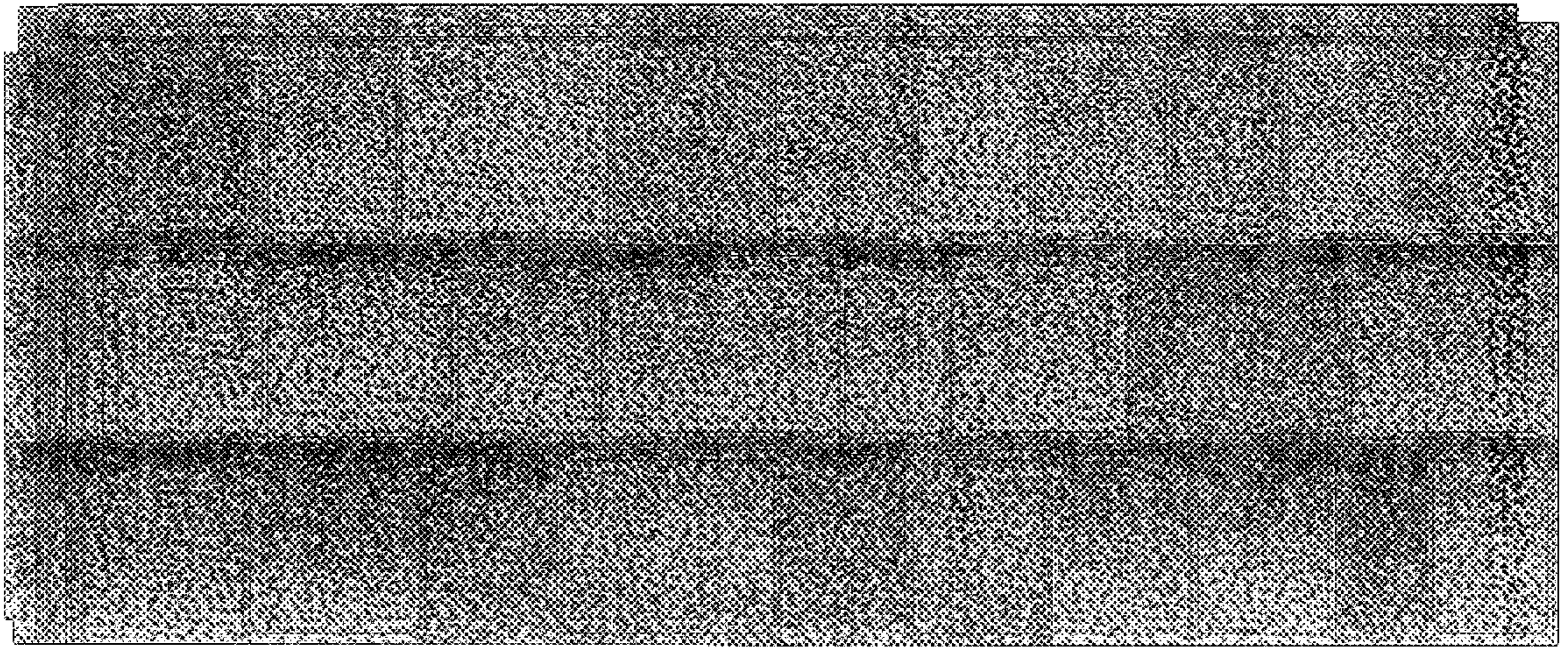

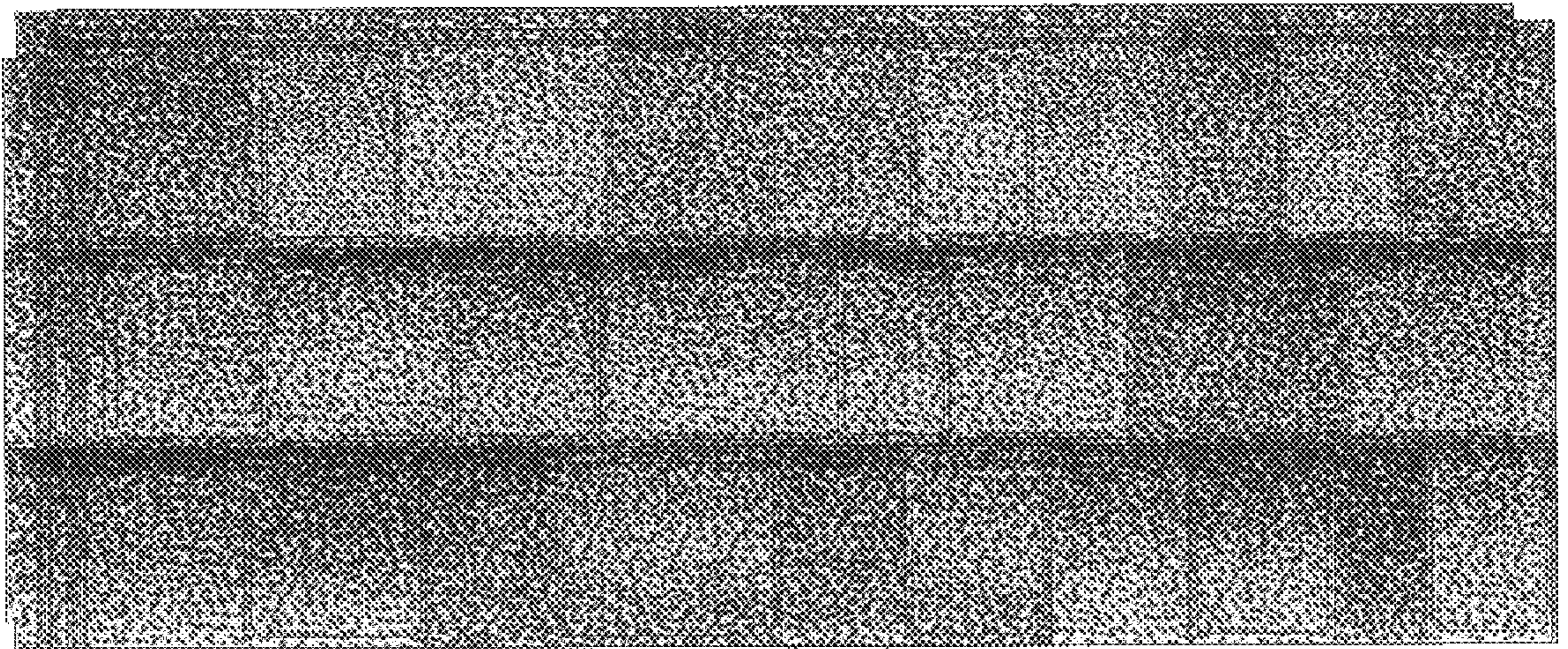
