(57) **CLAIM**

The ornamental design for a container for a cosmetic product, as shown and described.

DESCRIPTION

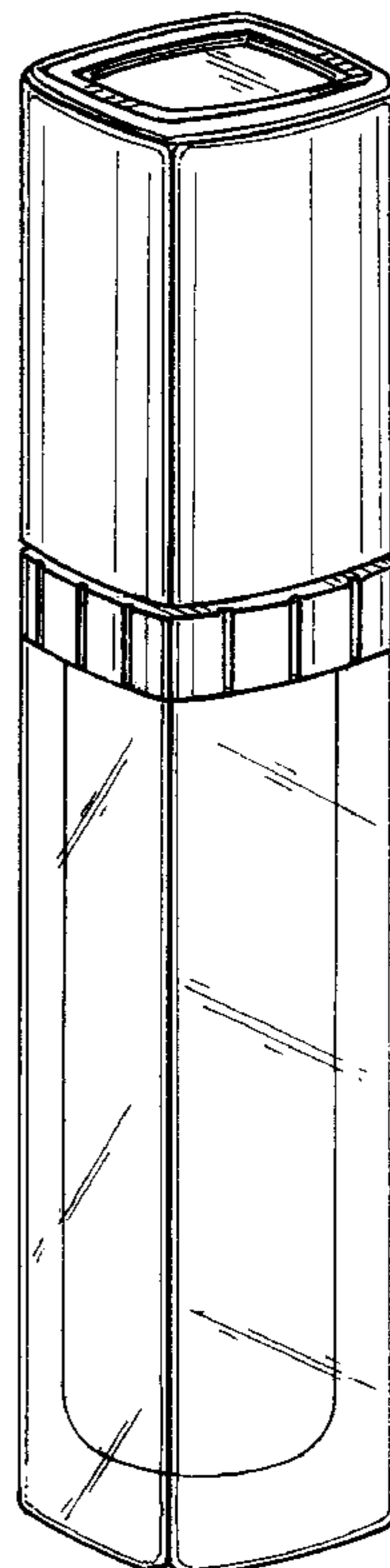

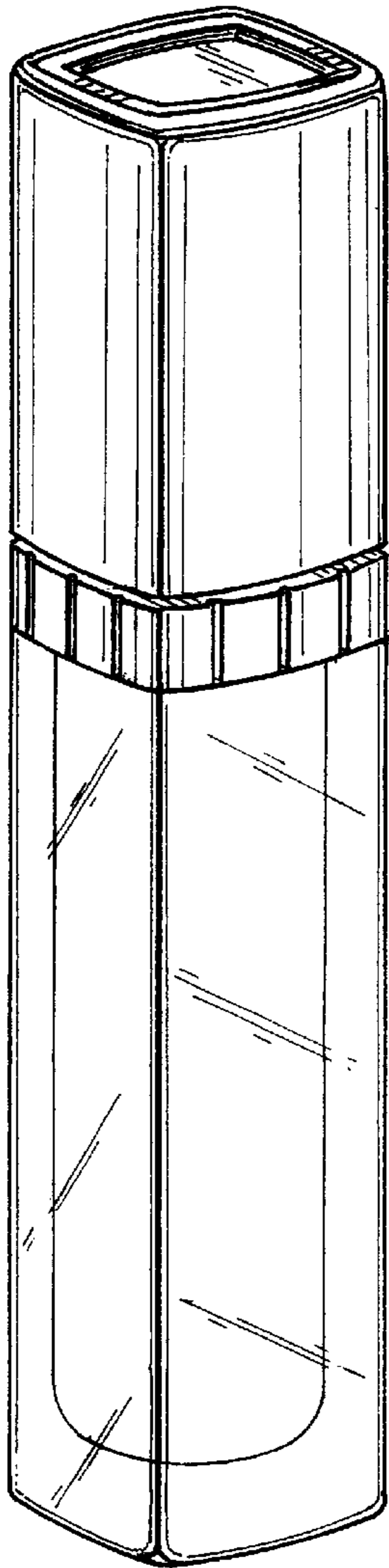

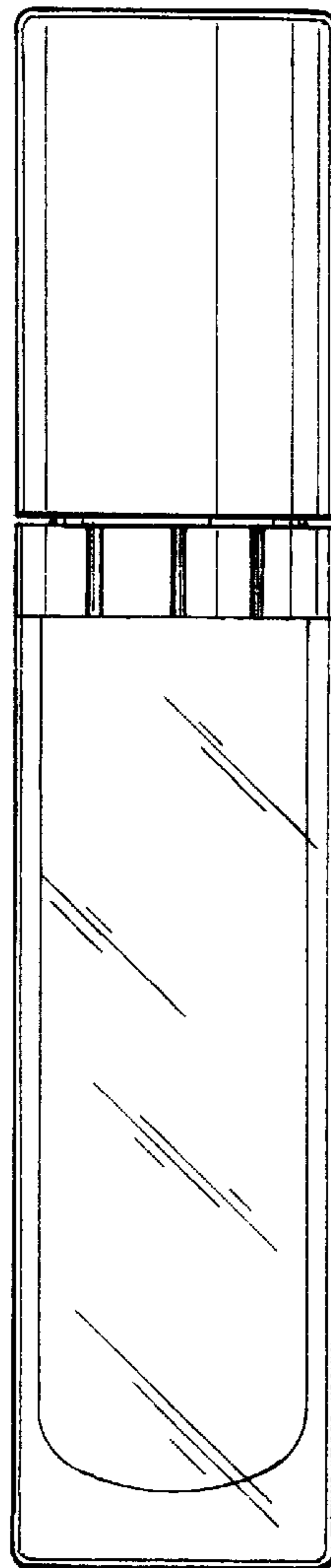

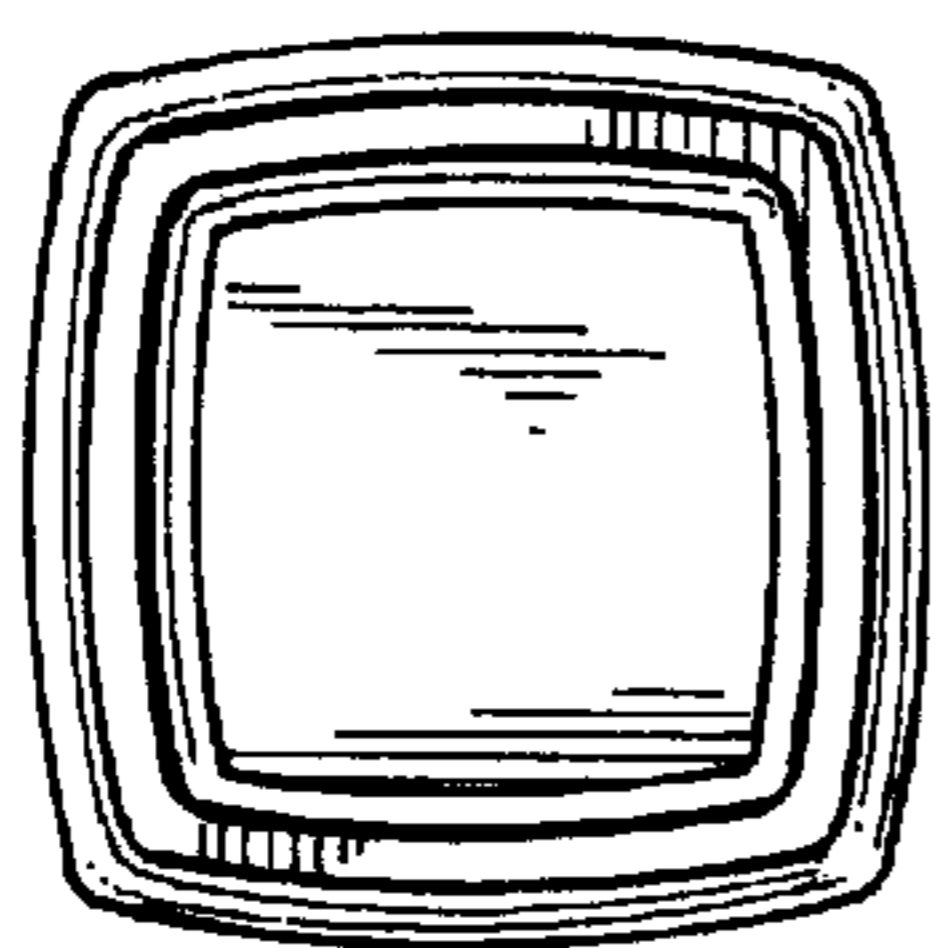
