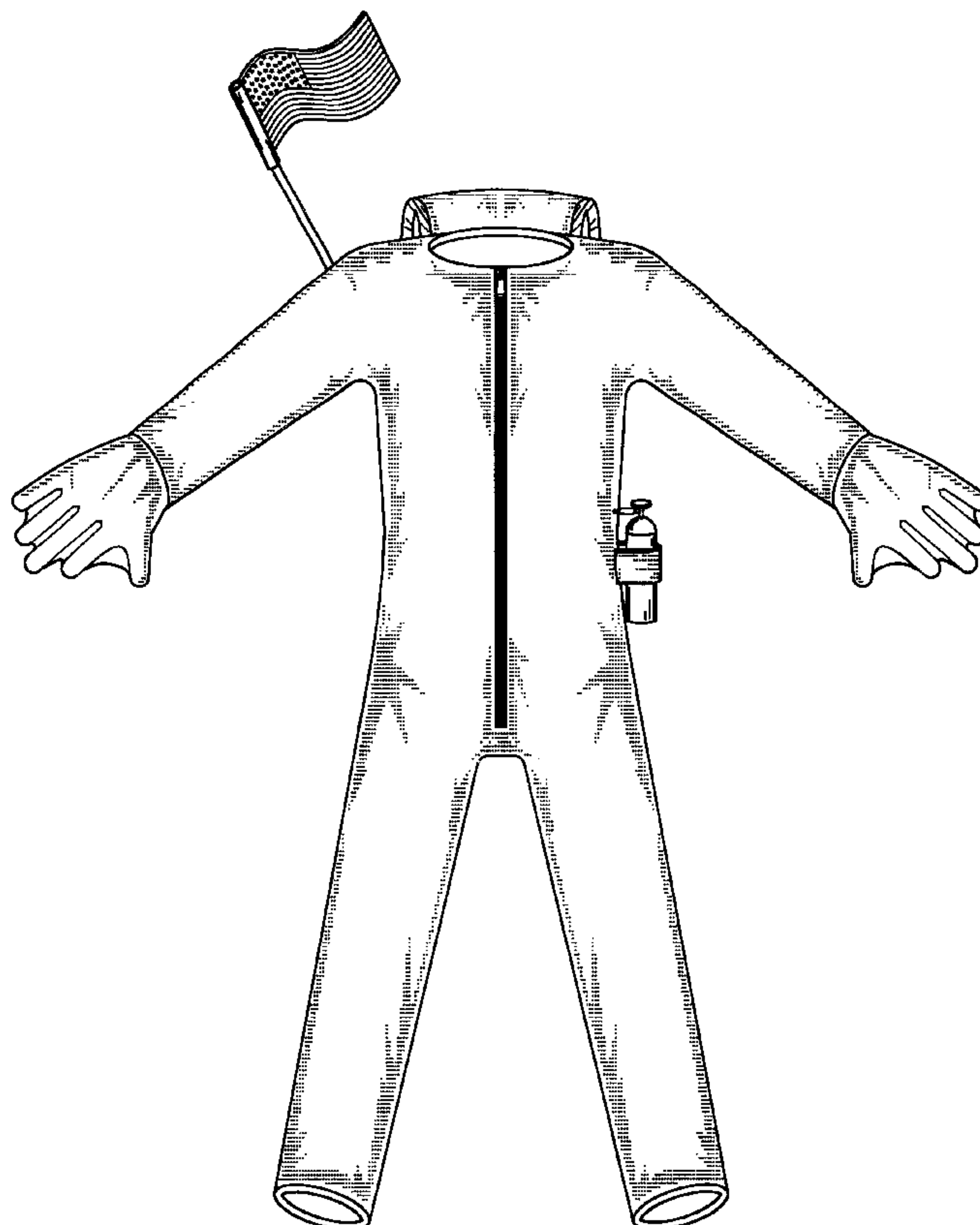
(57) **CLAIM**

The ornamental design for a inflatable suit with attached life-saving devices, as shown and described.

DESCRIPTION

FIG. 1 is a front view of an inflatable suit with attached life-saving devices showing my new design;
 FIG. 2 is a front view with the leg coverings in a different position;
 FIG. 3 is a rear view of FIG. 2;
 FIG. 4 is a top view of FIG. 2;
 FIG. 5 is a bottom view of FIG. 2;
 FIG. 6 is a side view as seen from the right of FIG. 2; and,
 FIG. 7 is a side view as seen from the left of FIG. 2.
 The hand coverings are shown in an alternate position in FIGS. 4, 5, 6 and 7. The flag is shown in alternate positions in FIGS. 4, 5, 6 and 7. FIGS. 2 and 3 in the drawings are shown on a reduced scale.

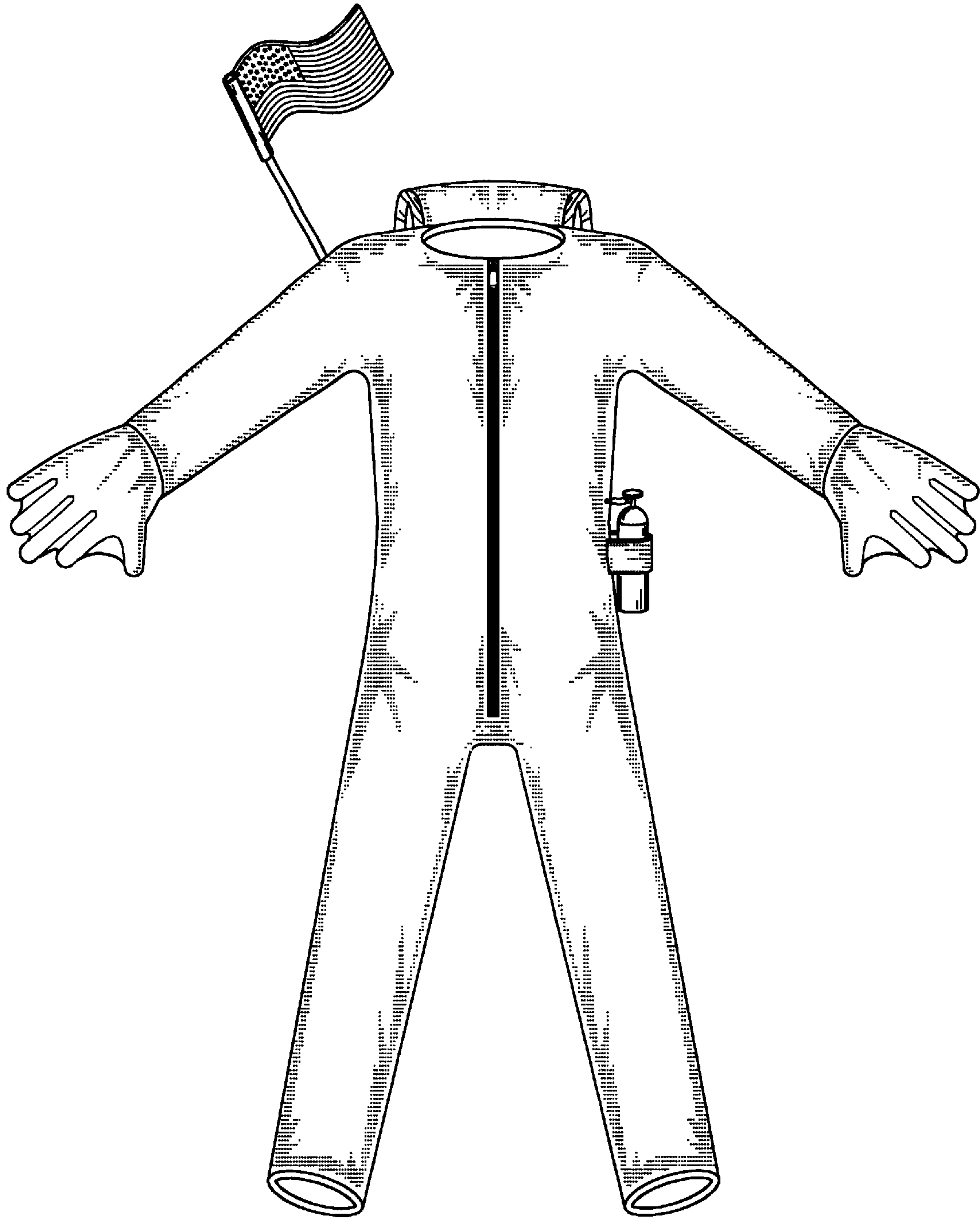

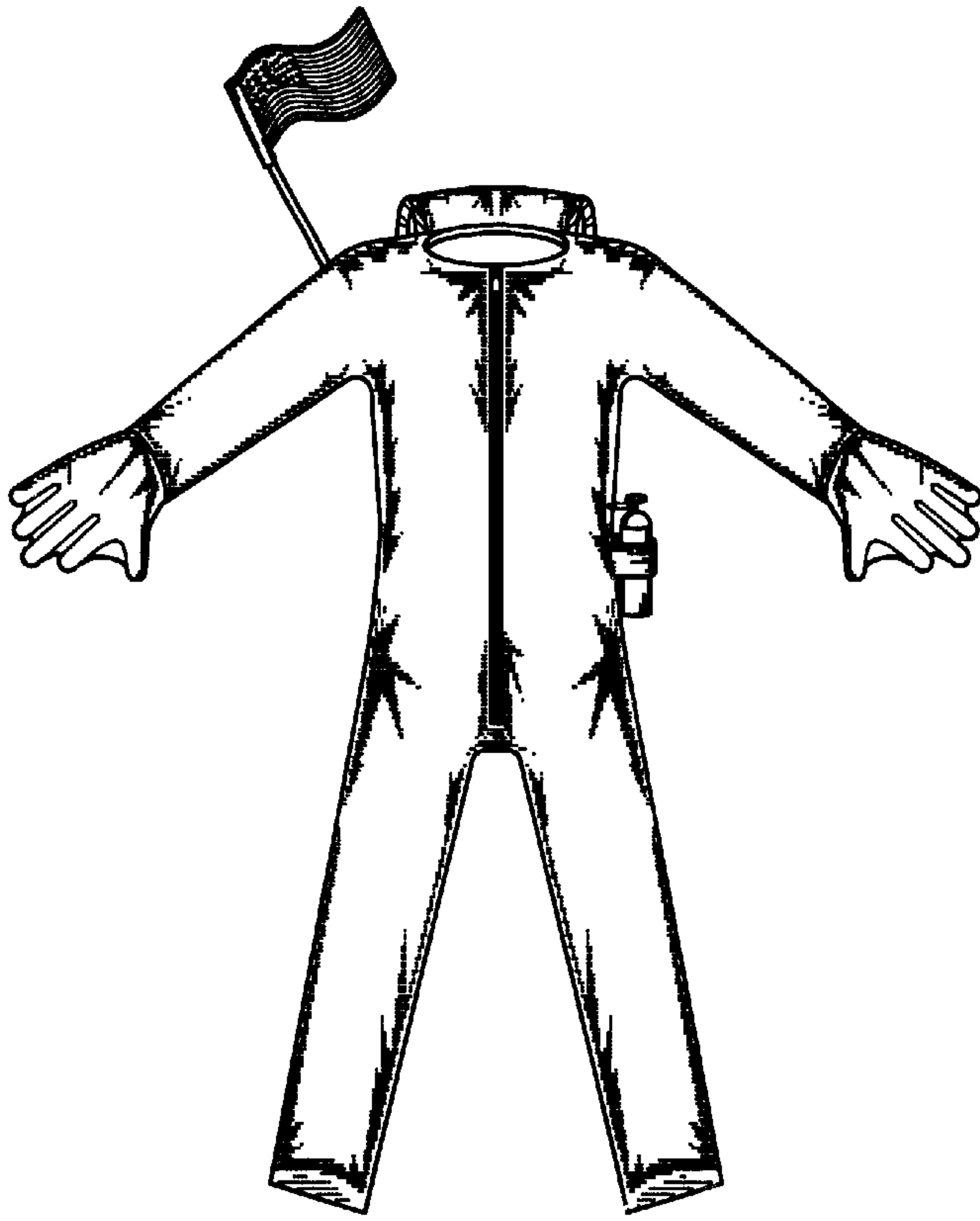

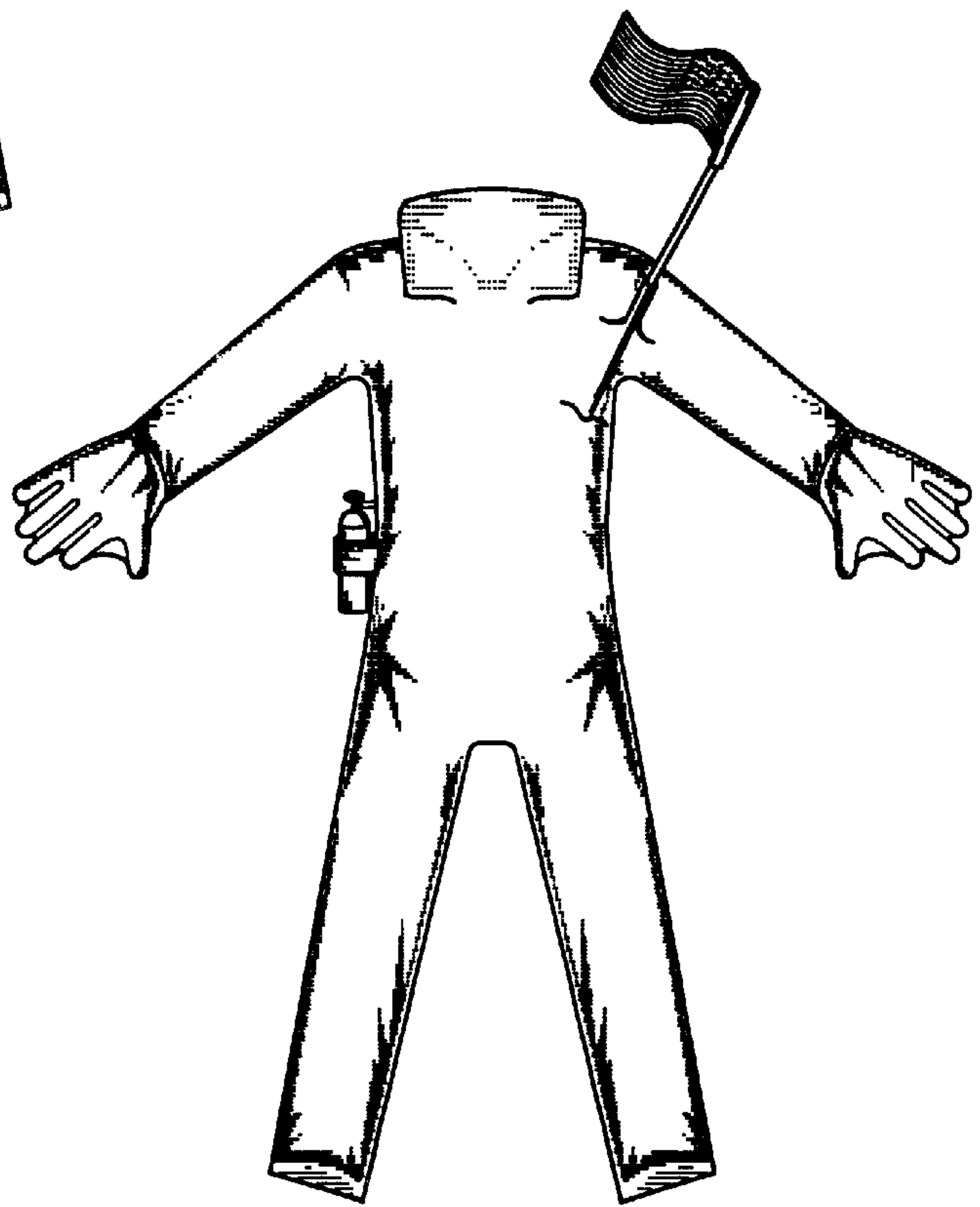

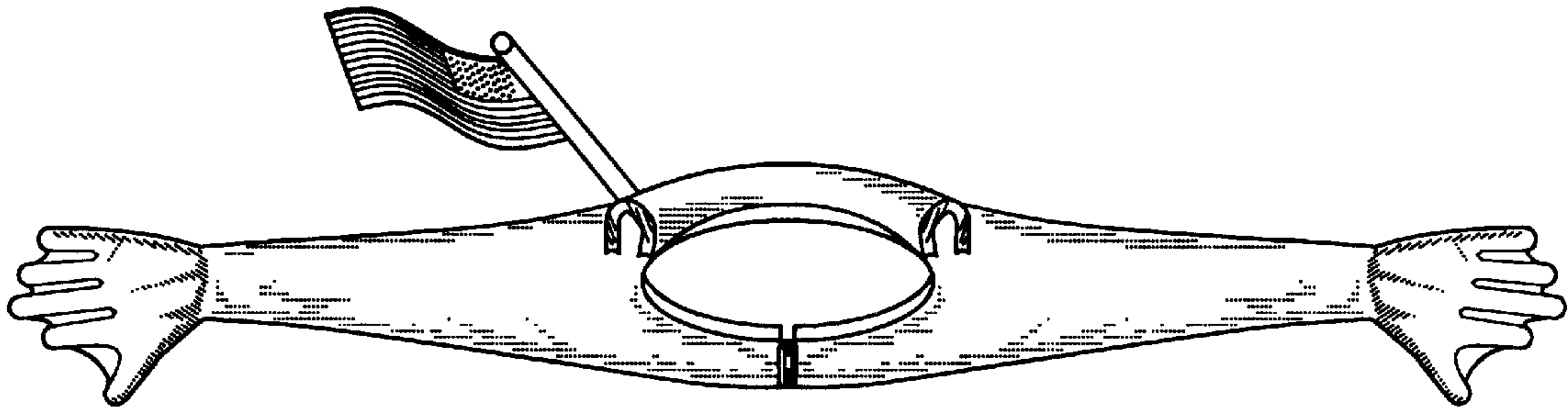

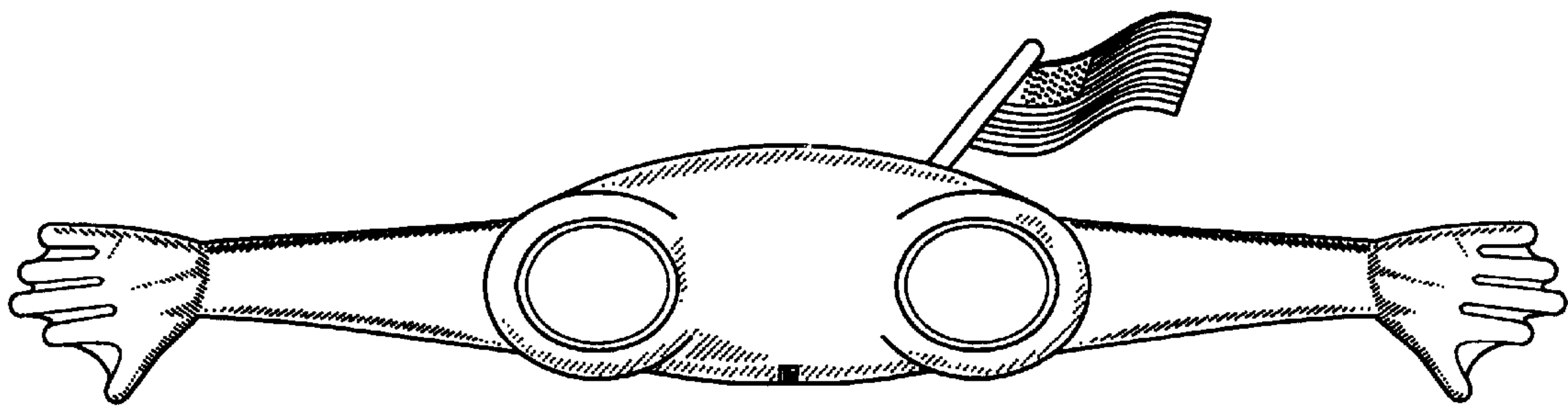

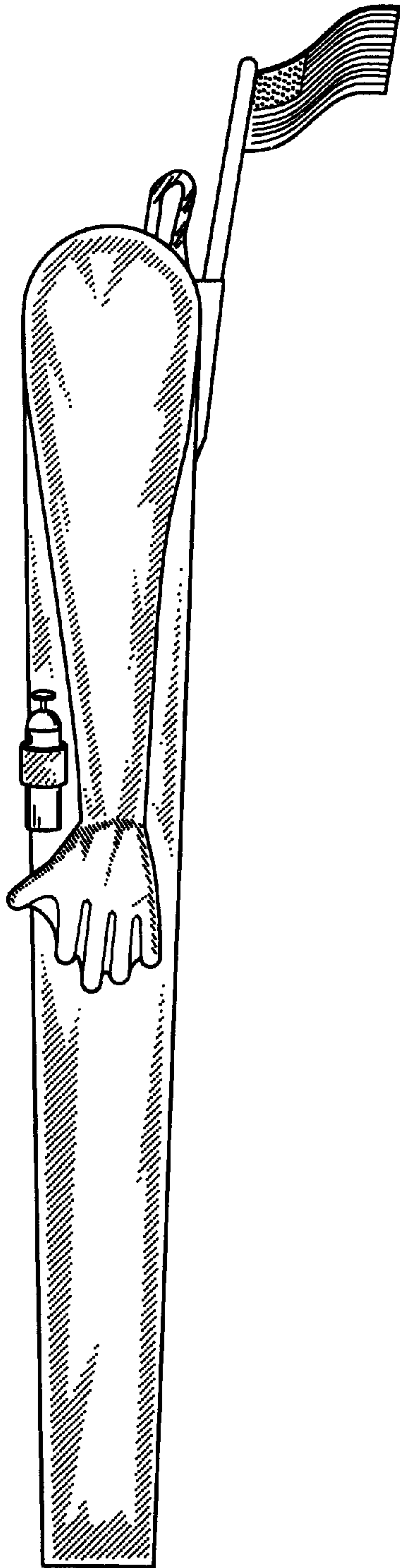

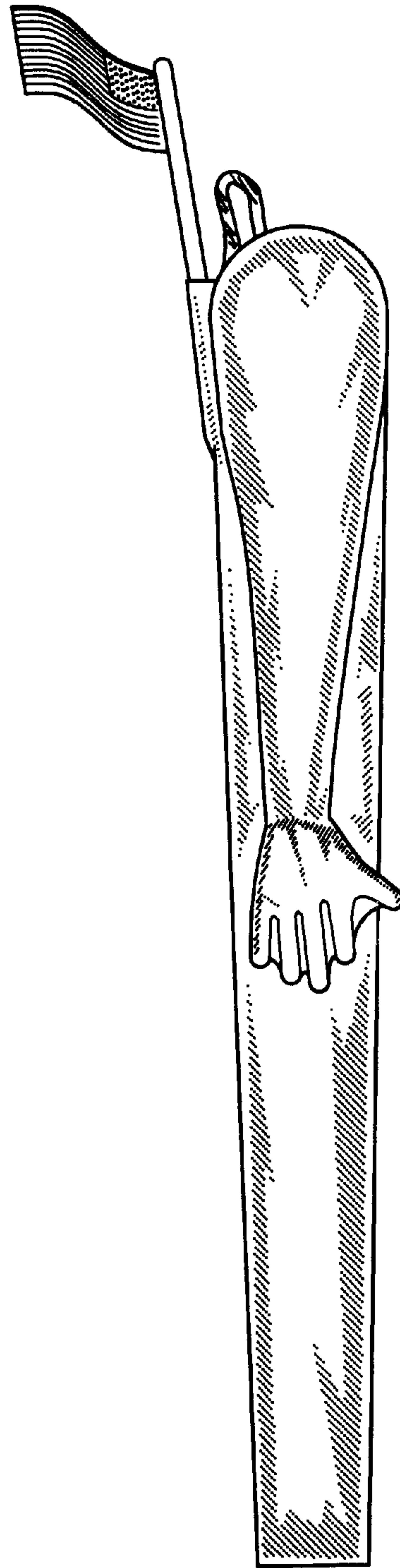
