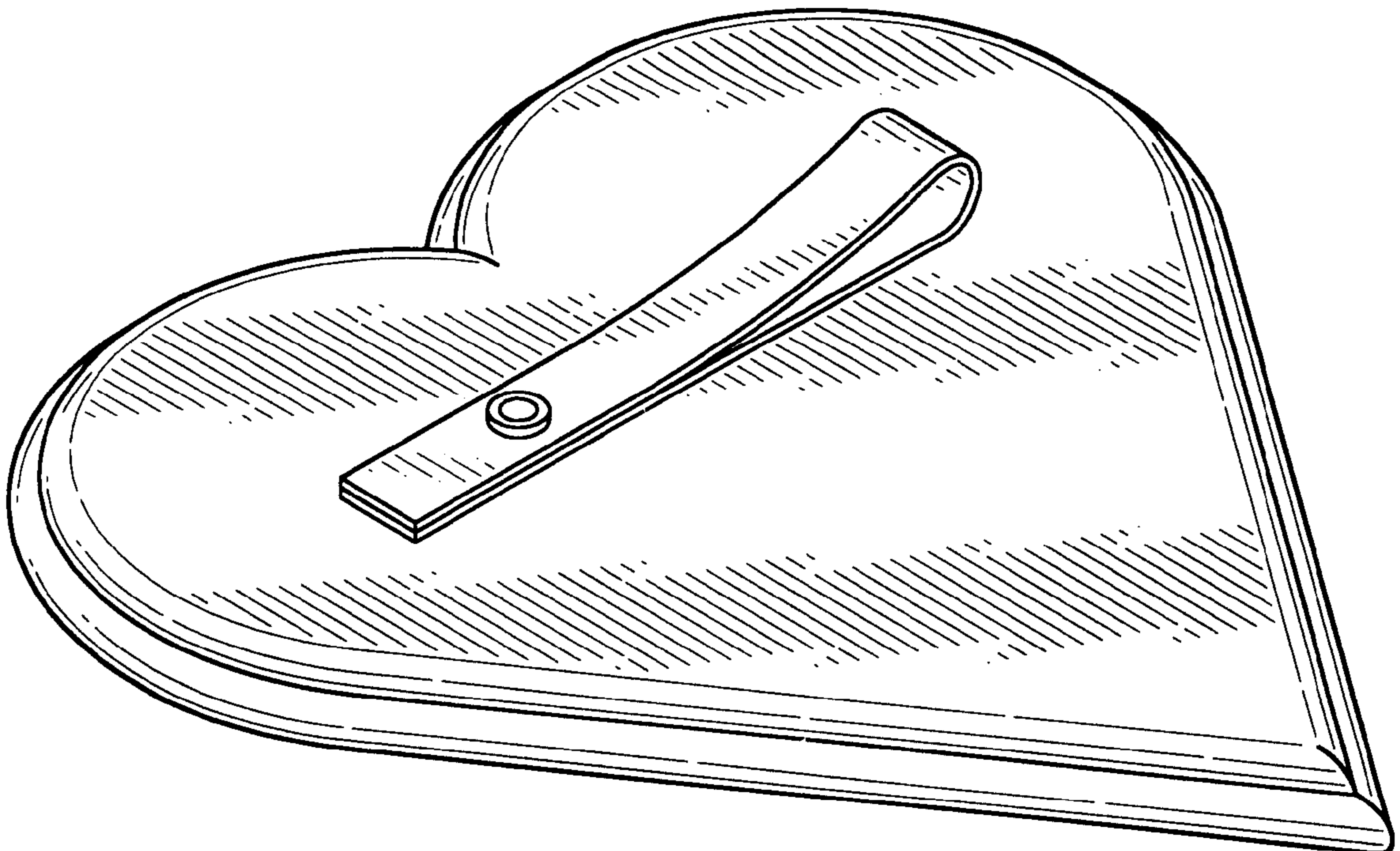
(57) **CLAIM**

The ornamental design for a protective pad for use with shoulder straps, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a protective pad for use with shoulder straps of the present invention; FIG. 2 is a front elevational view of the protective pad for use with shoulder straps of the present invention; FIG. 3 is a right side elevational view of the protective pad for use with shoulder straps of the present invention; FIG. 4 is a top plan view of the protective pad for use with shoulder straps of the present invention; FIG. 5 is a bottom plan view of the protective pad for use with shoulder straps of the present invention; and, FIG. 6 is a left side elevational view of the protective pad for use with shoulder straps of the present invention.

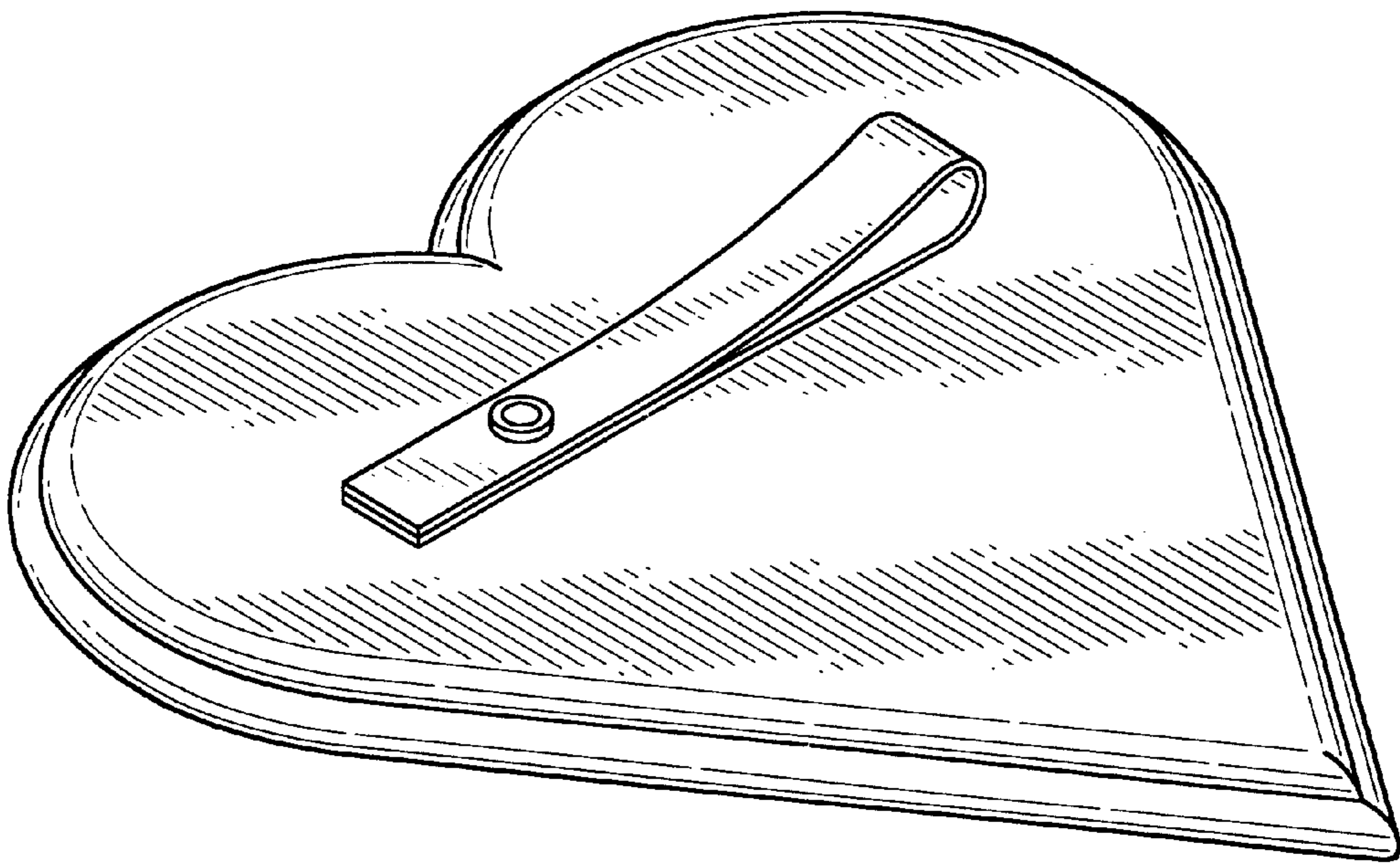

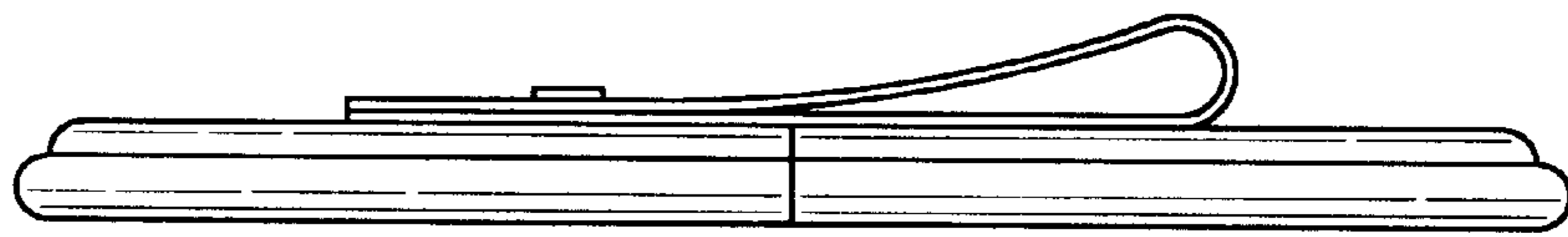

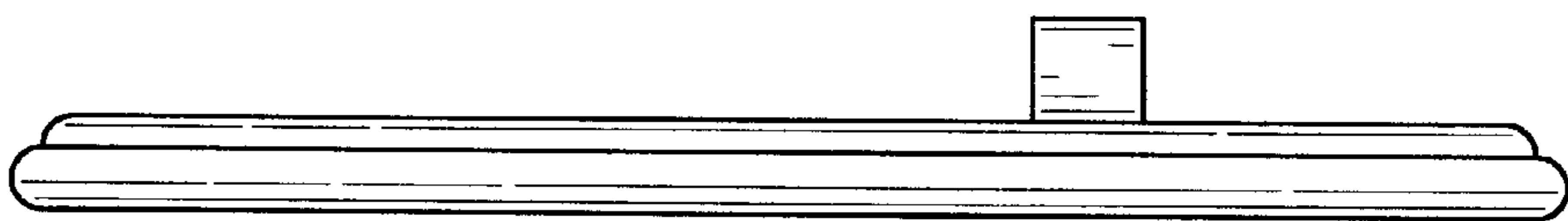

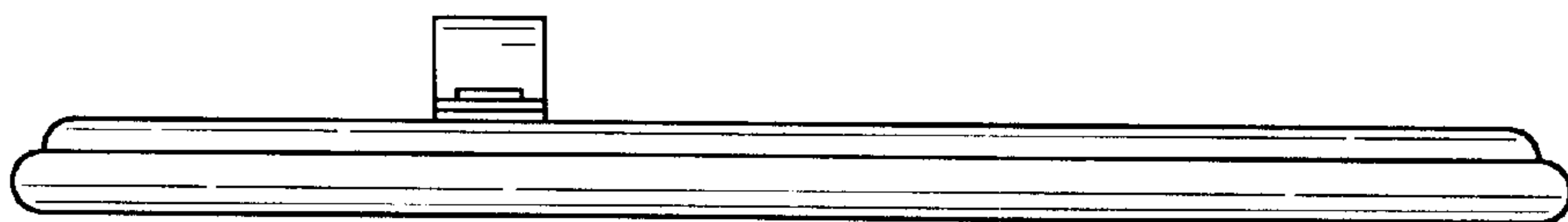

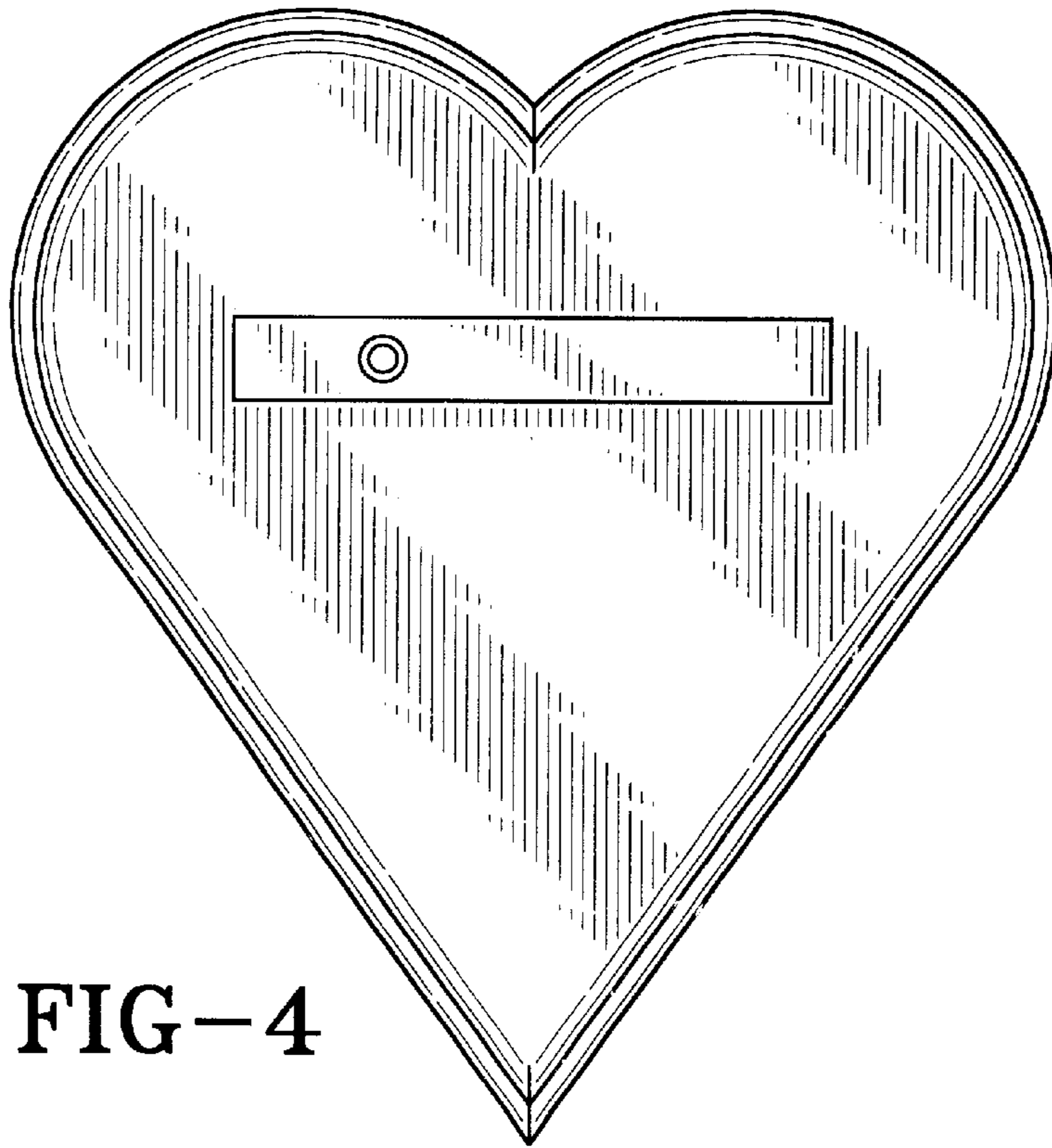

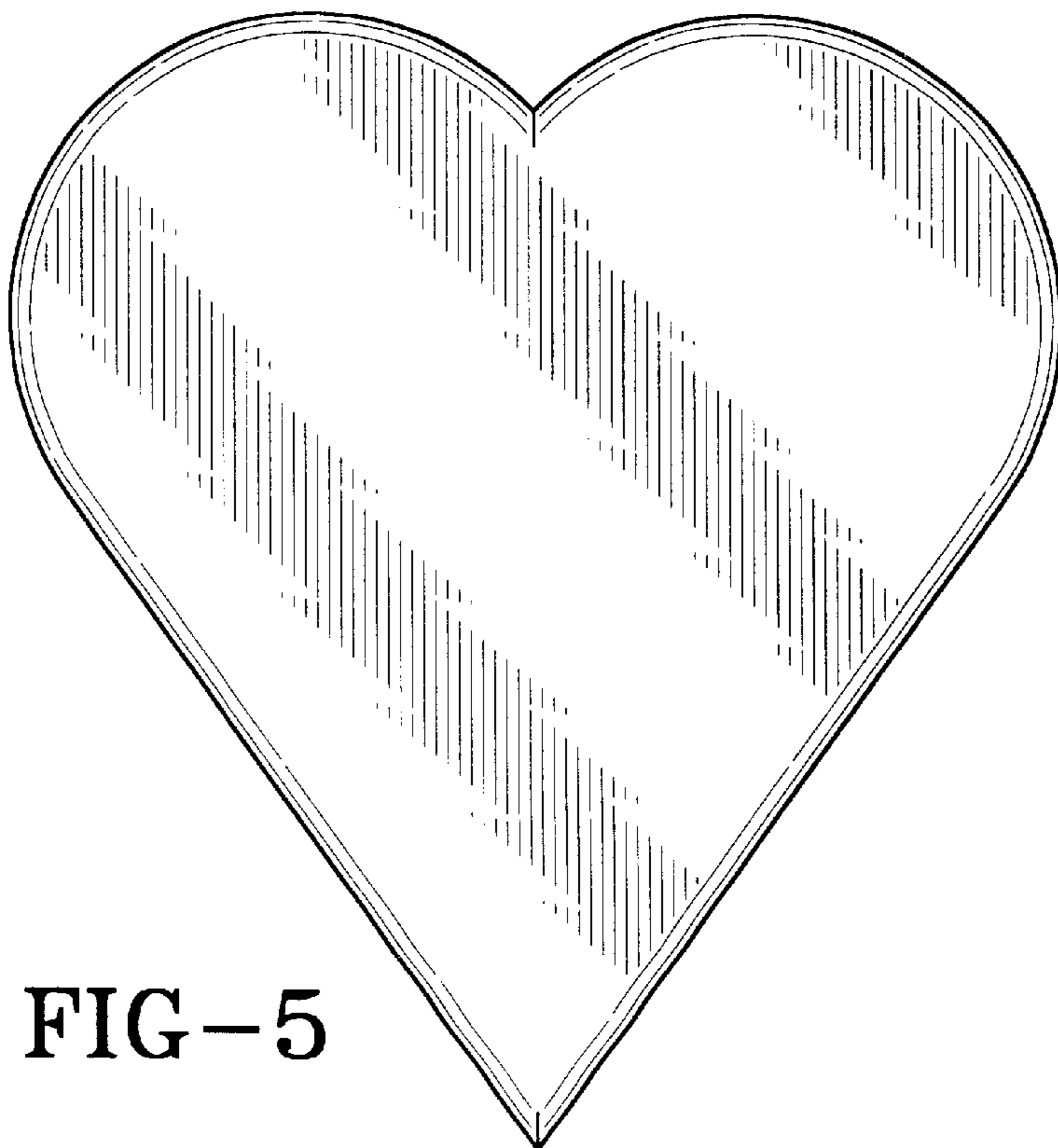
