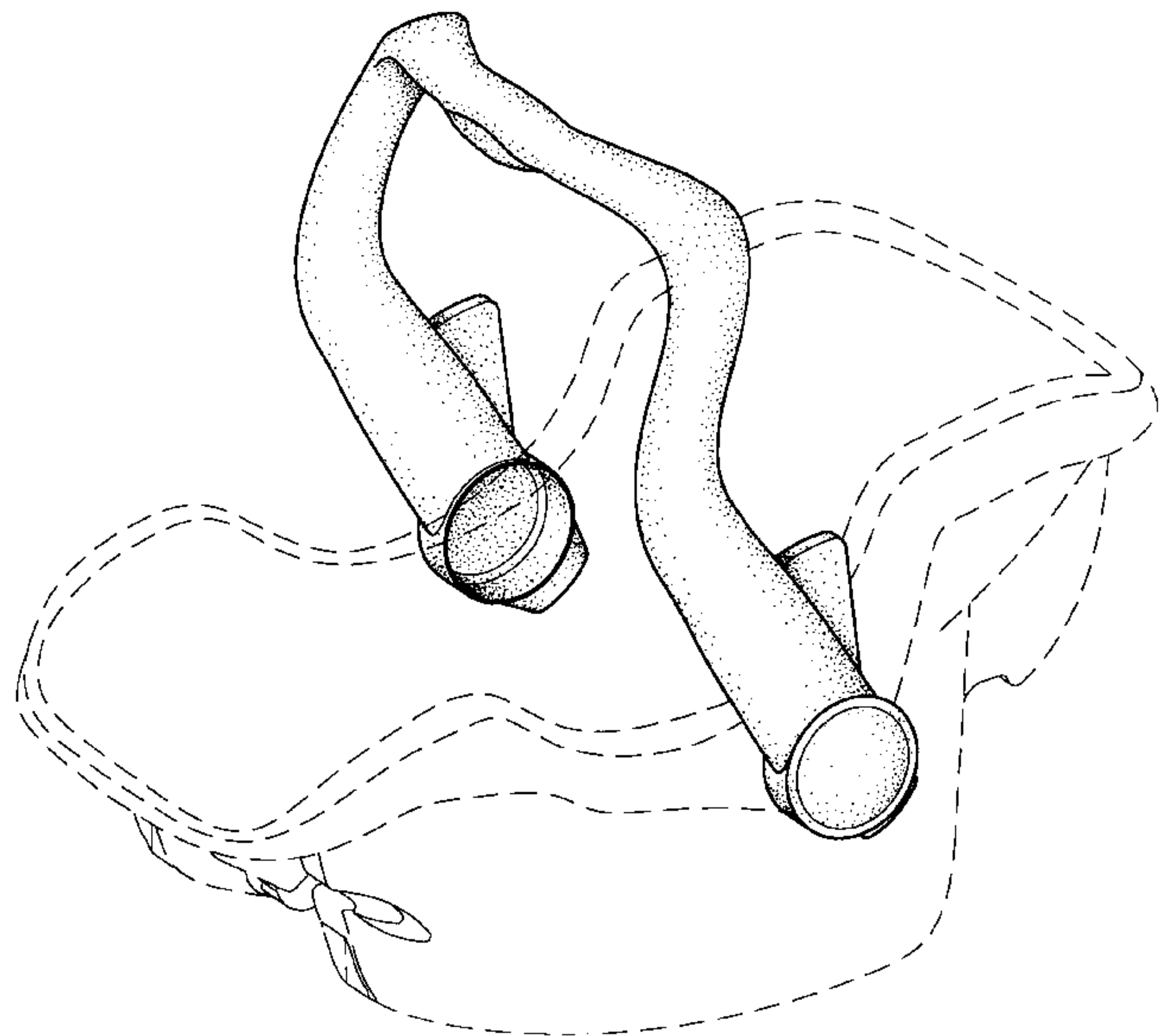
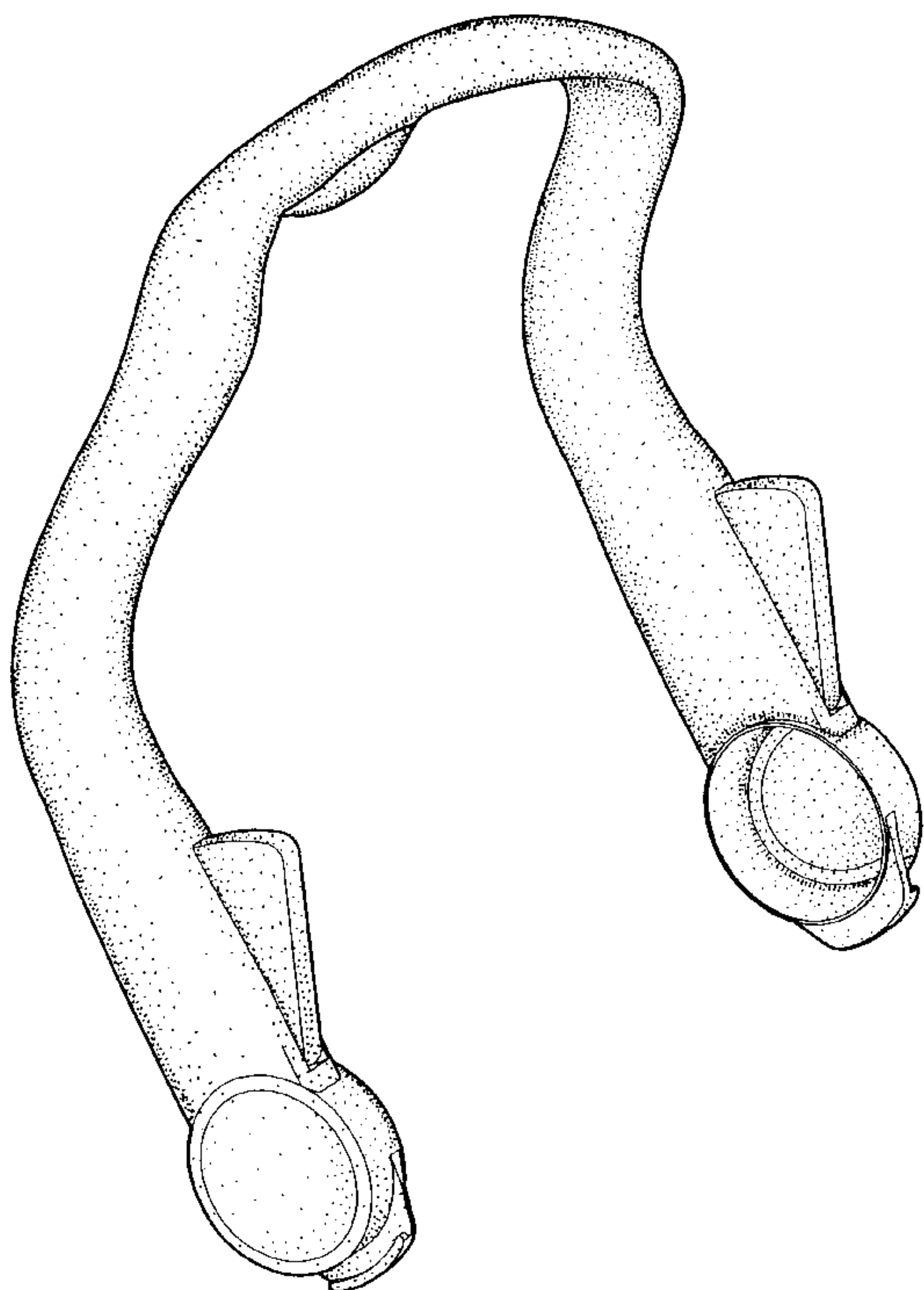
(57) **CLAIM**

DESCRIPTION

FIG. 1 is a perspective view of a handle for car safety seat showing our new design;

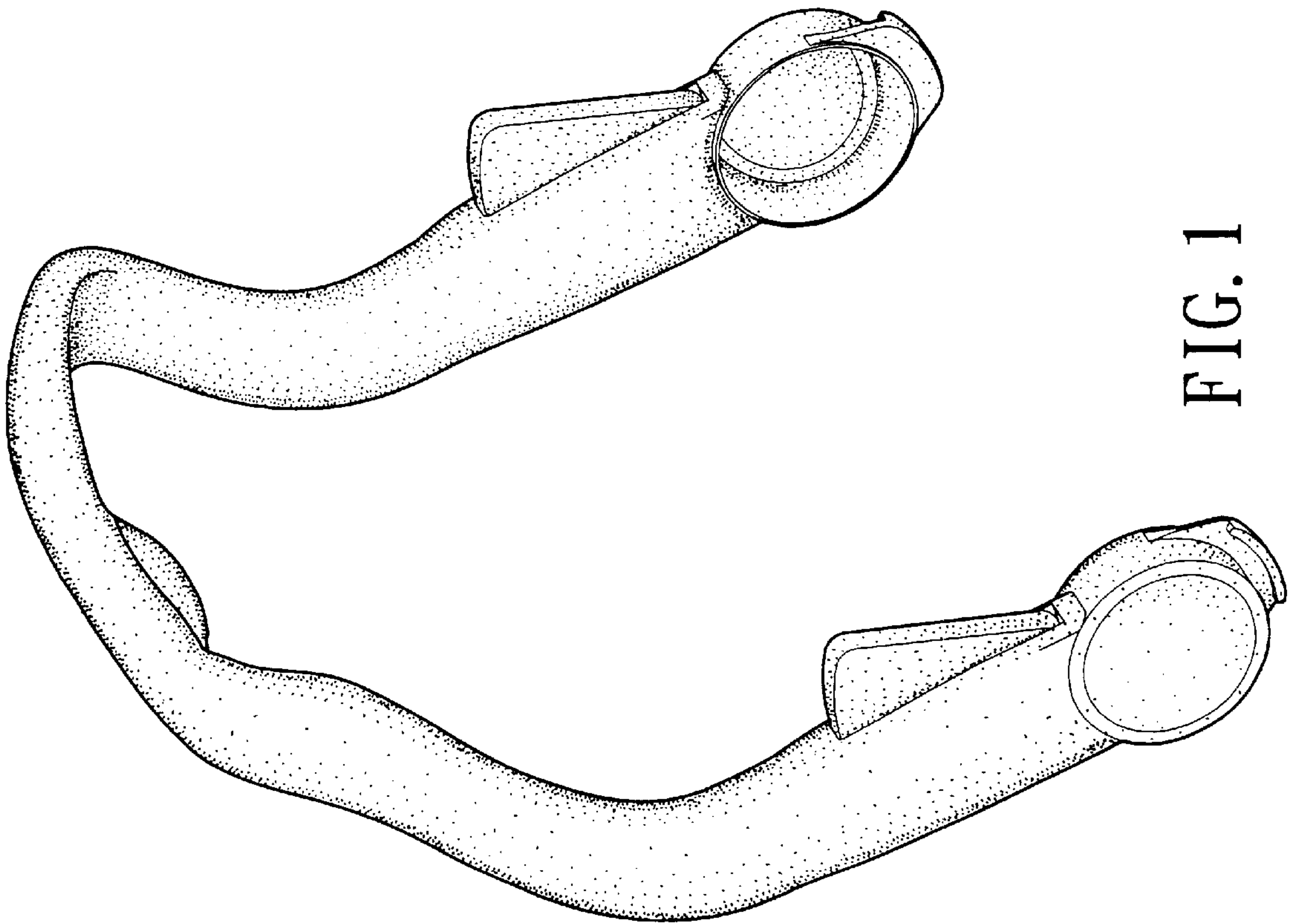

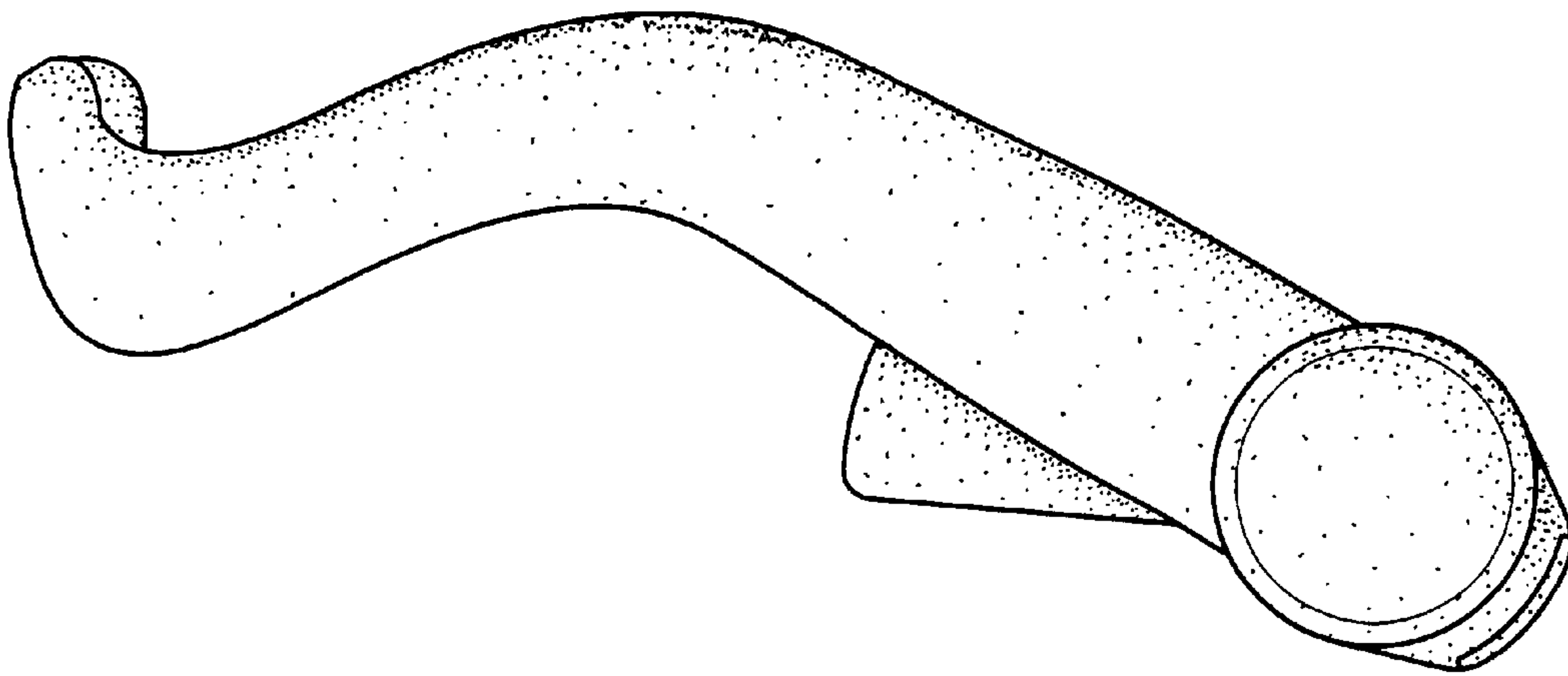

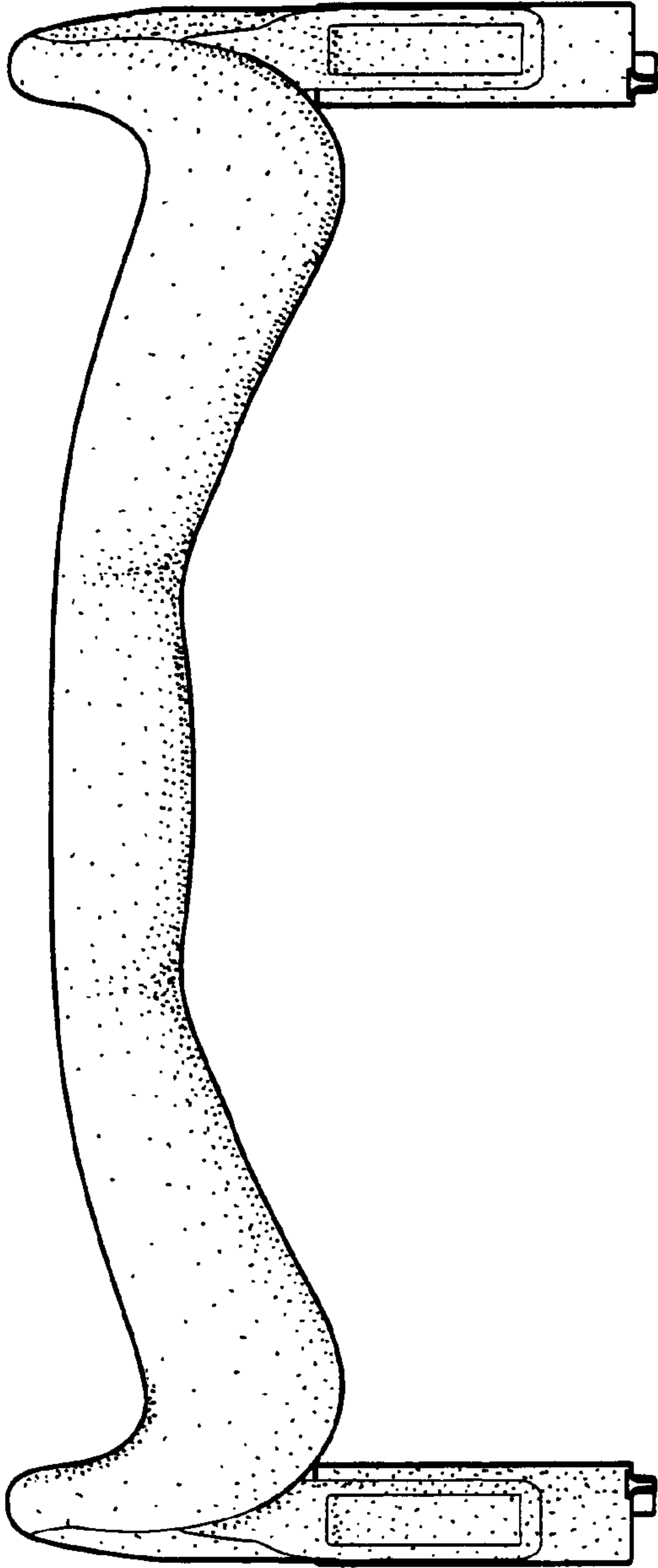

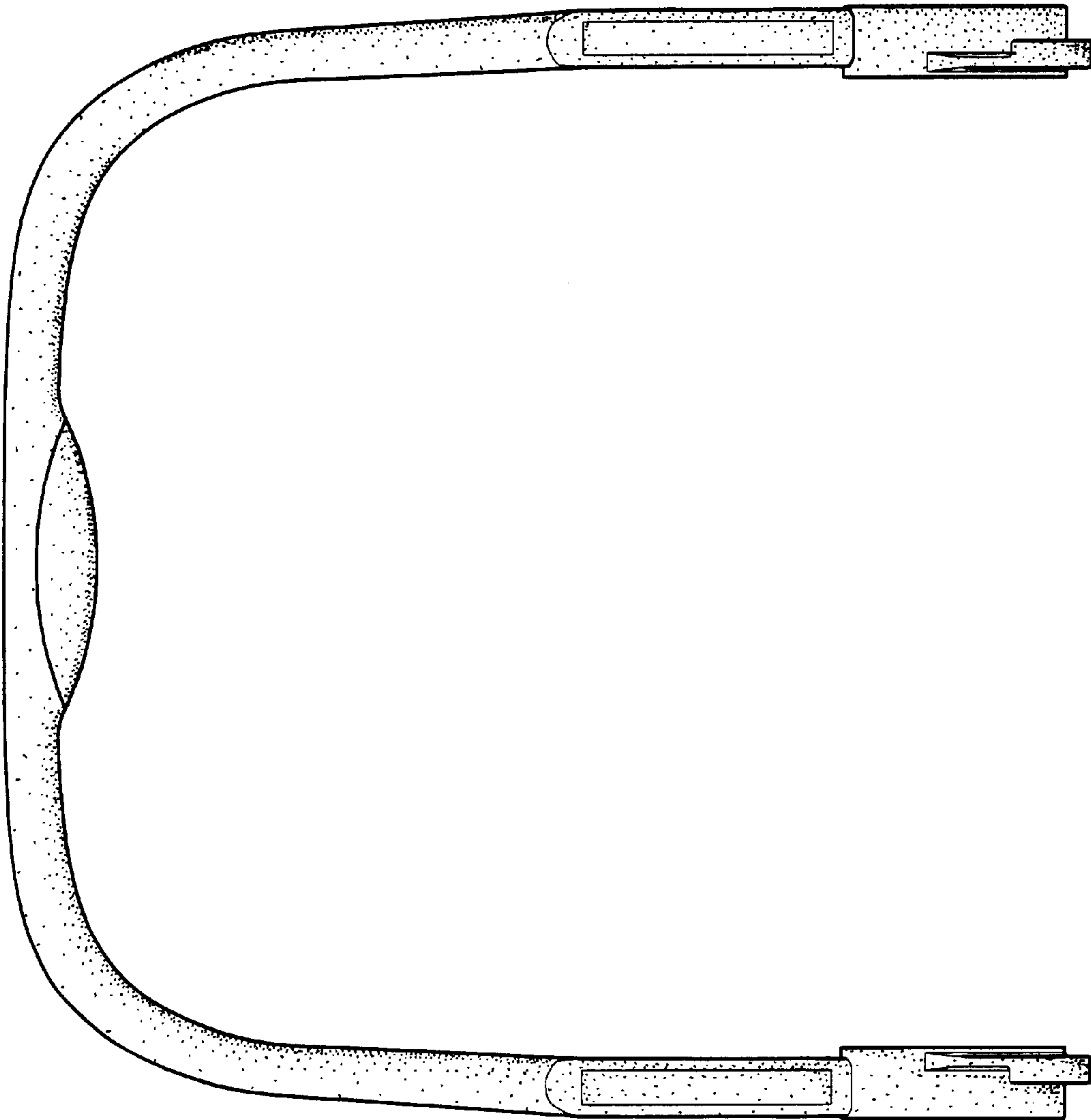

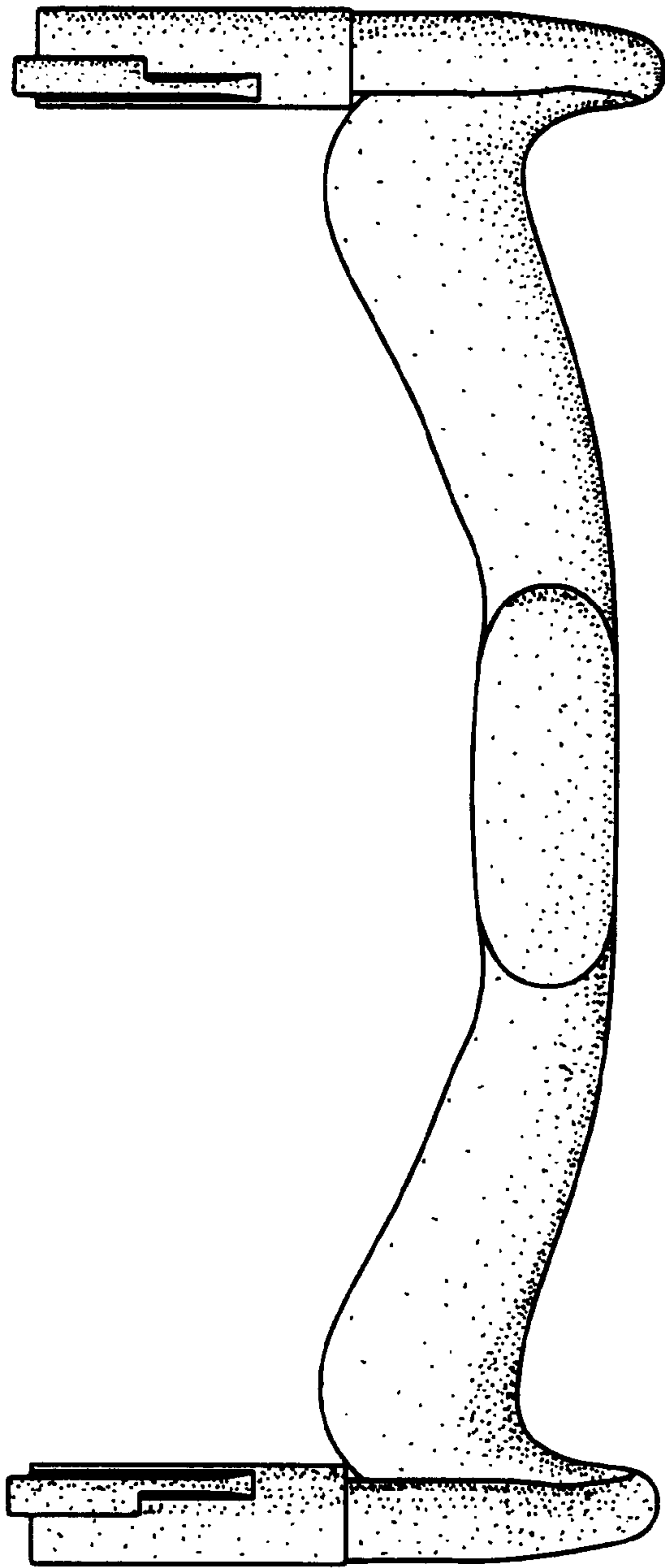

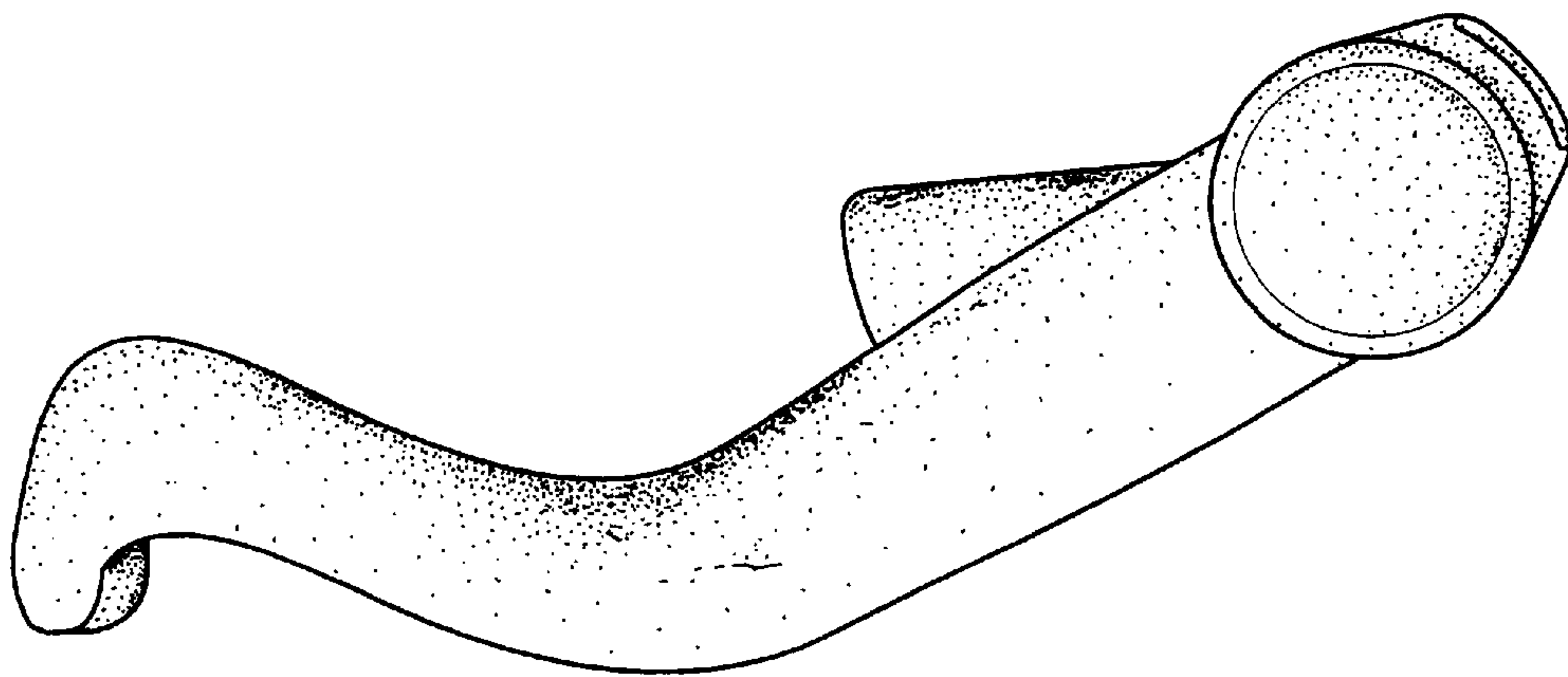

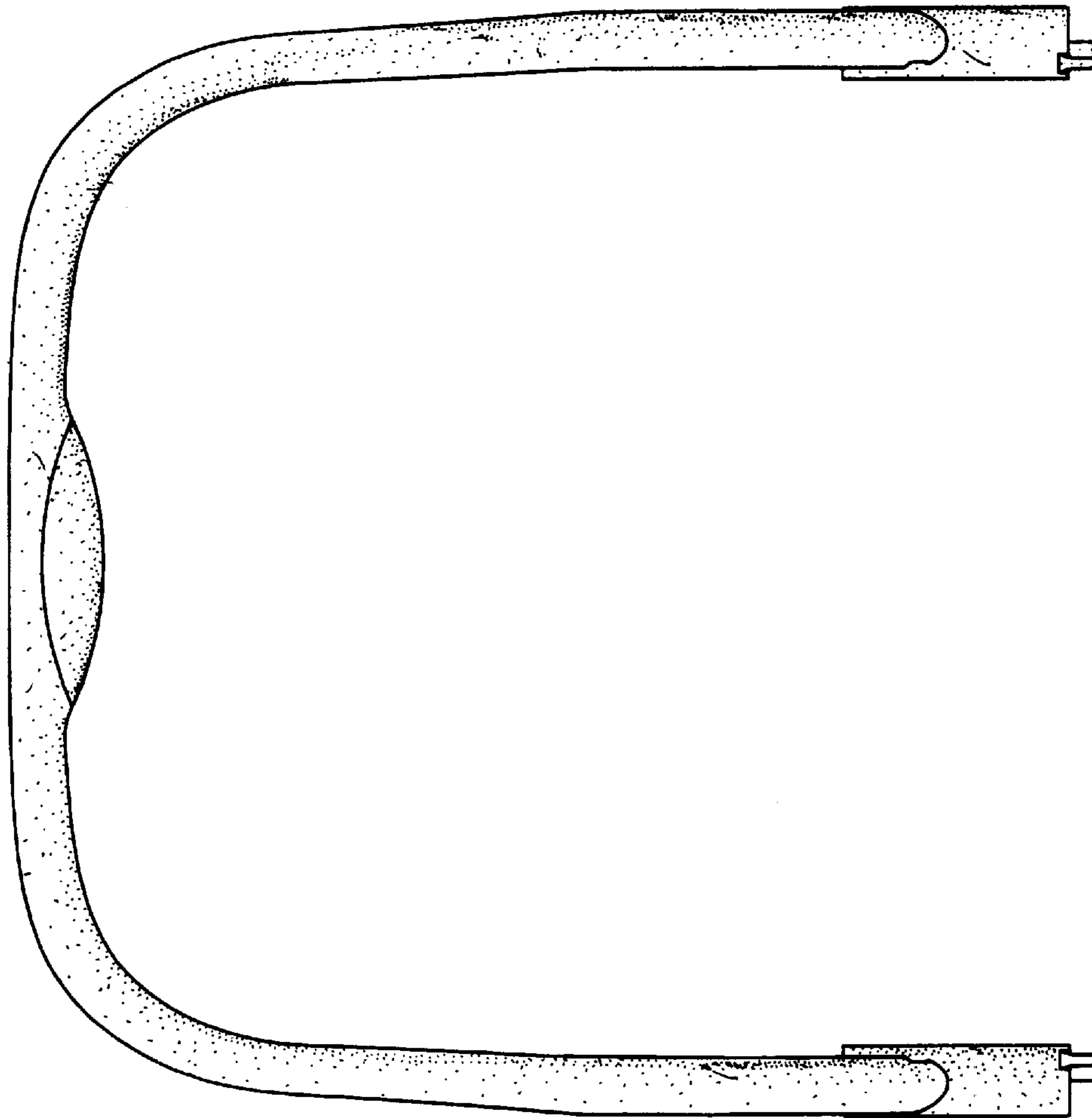

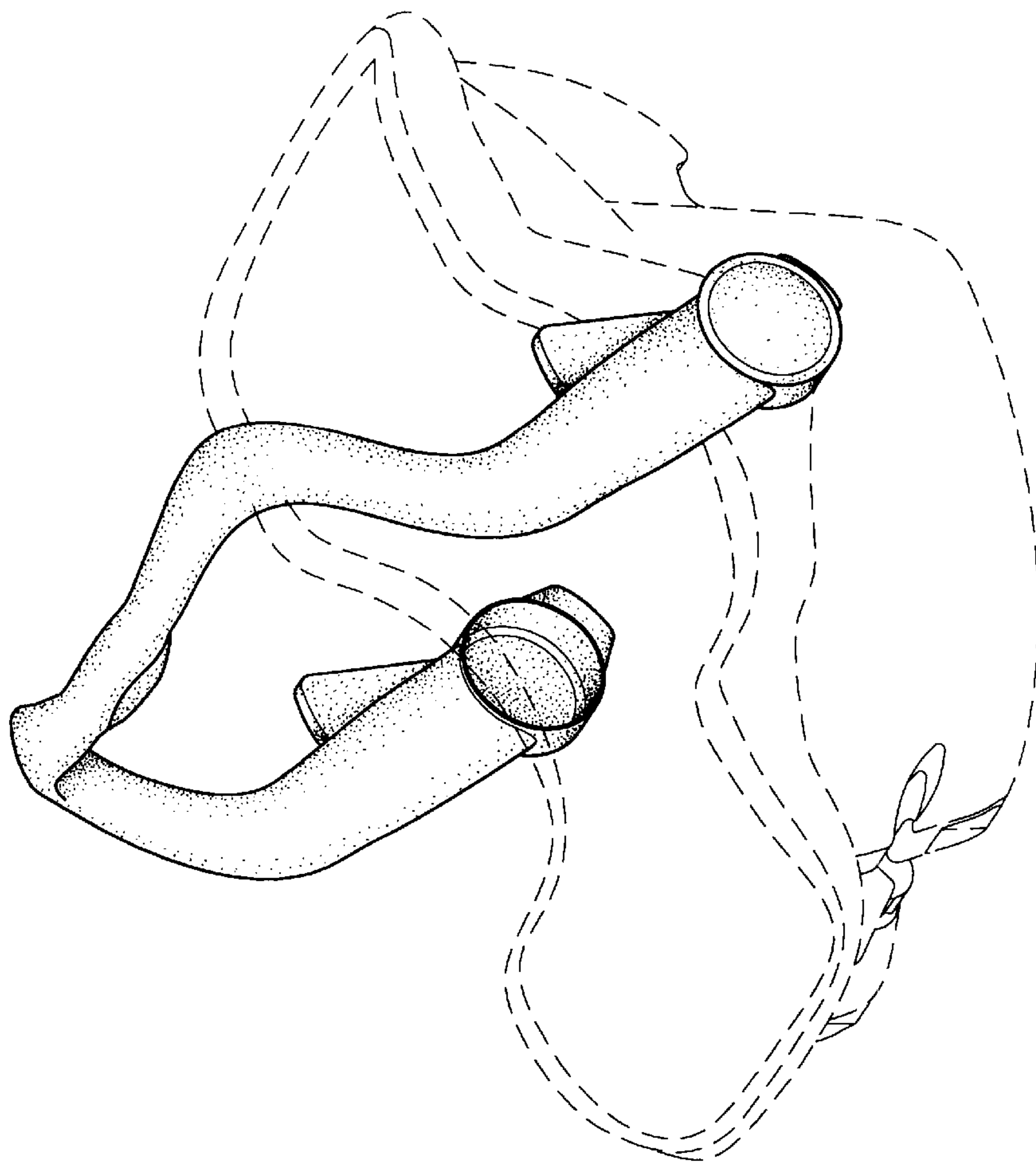
