The ornamental design for a wire media storage rack, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of one embodiment of the wire media storage rack of the present invention;

FIG. 2 is a front view of the wire media storage rack of FIG. 1;

FIG. 3 is a rear view of the wire media storage rack of FIG. 1;

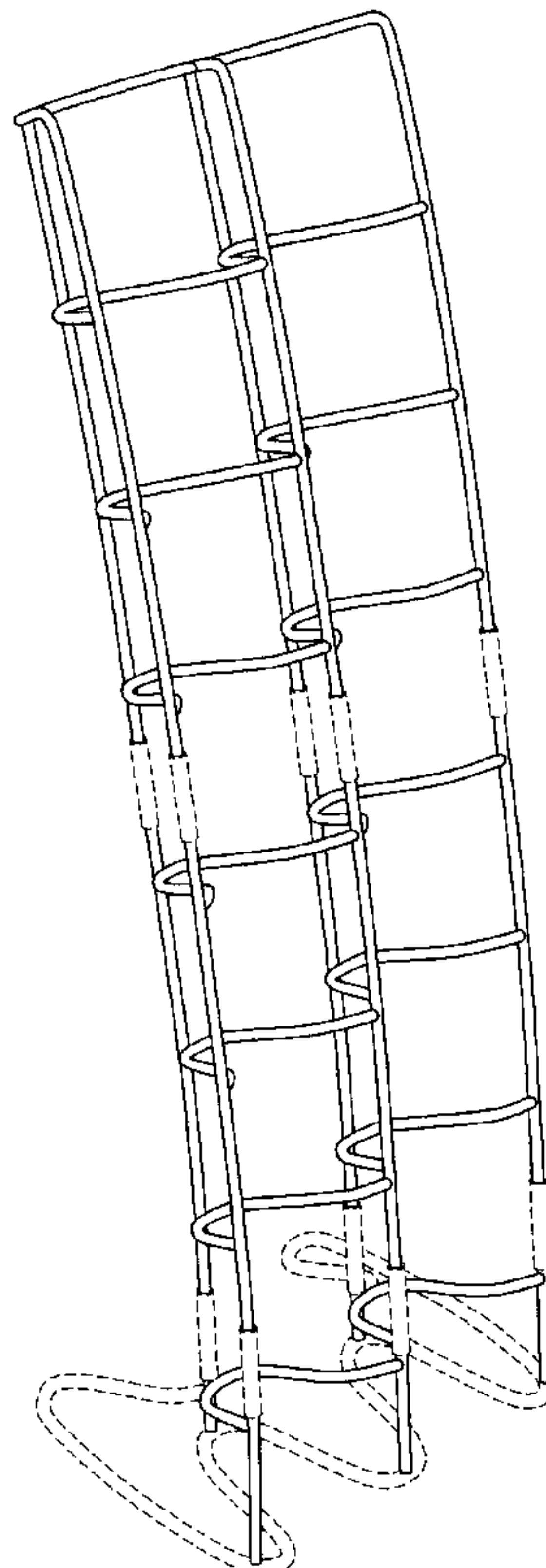
FIG. 4 is a left side view of the wire media storage rack of FIG. 1, the right side view being a mirror image thereof;

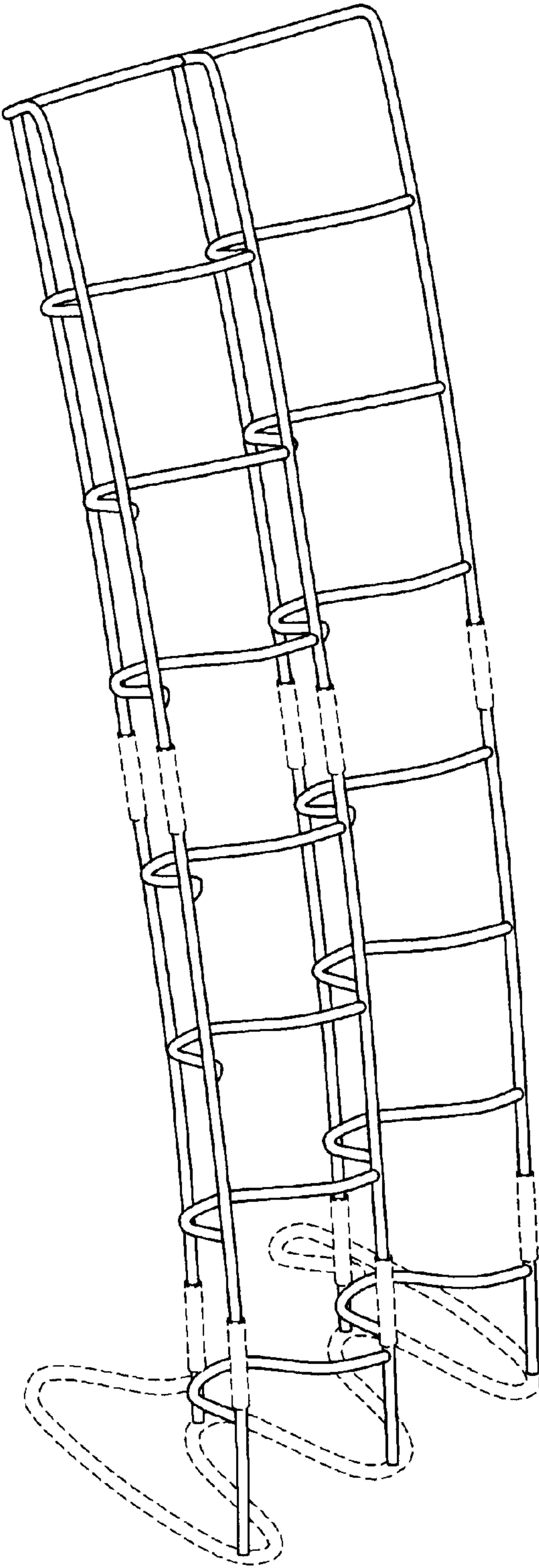

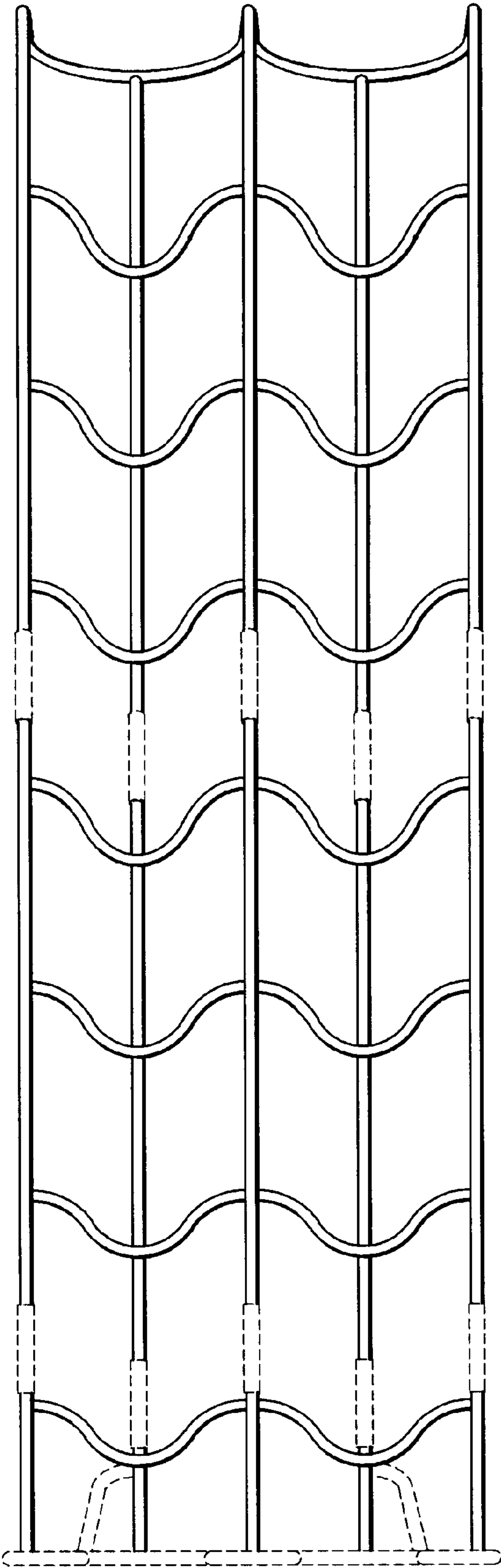

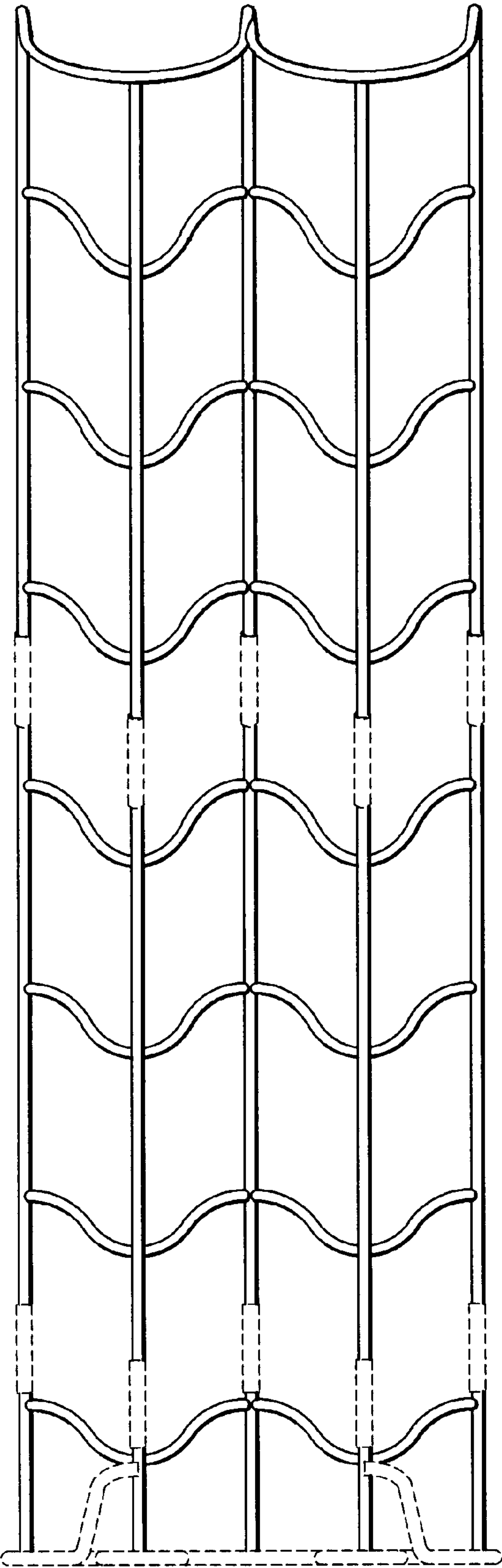

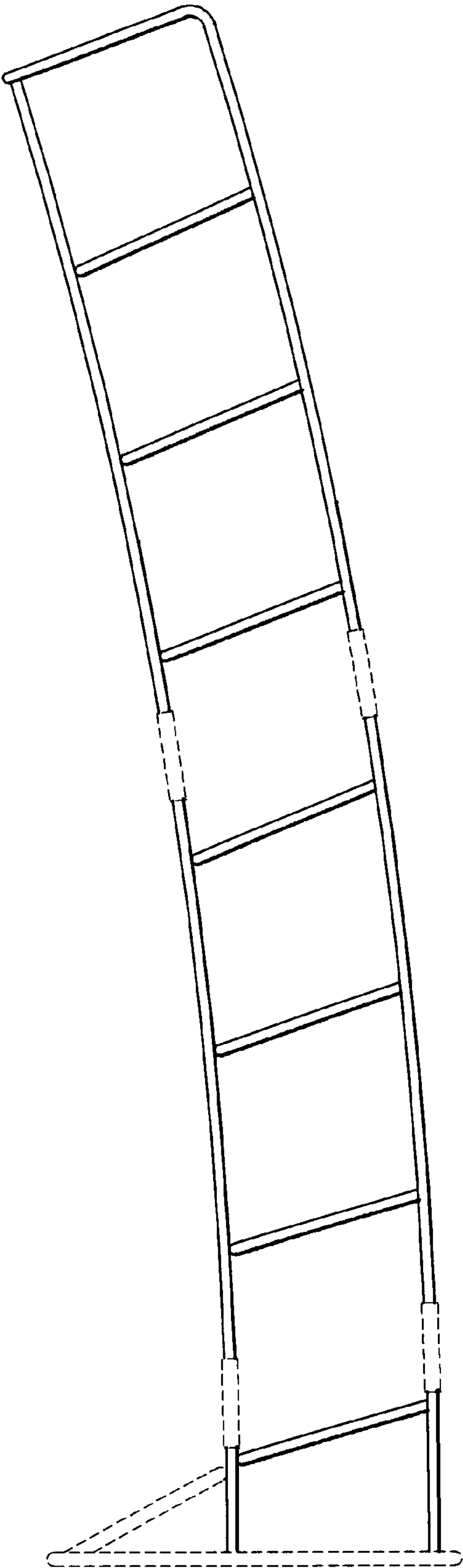

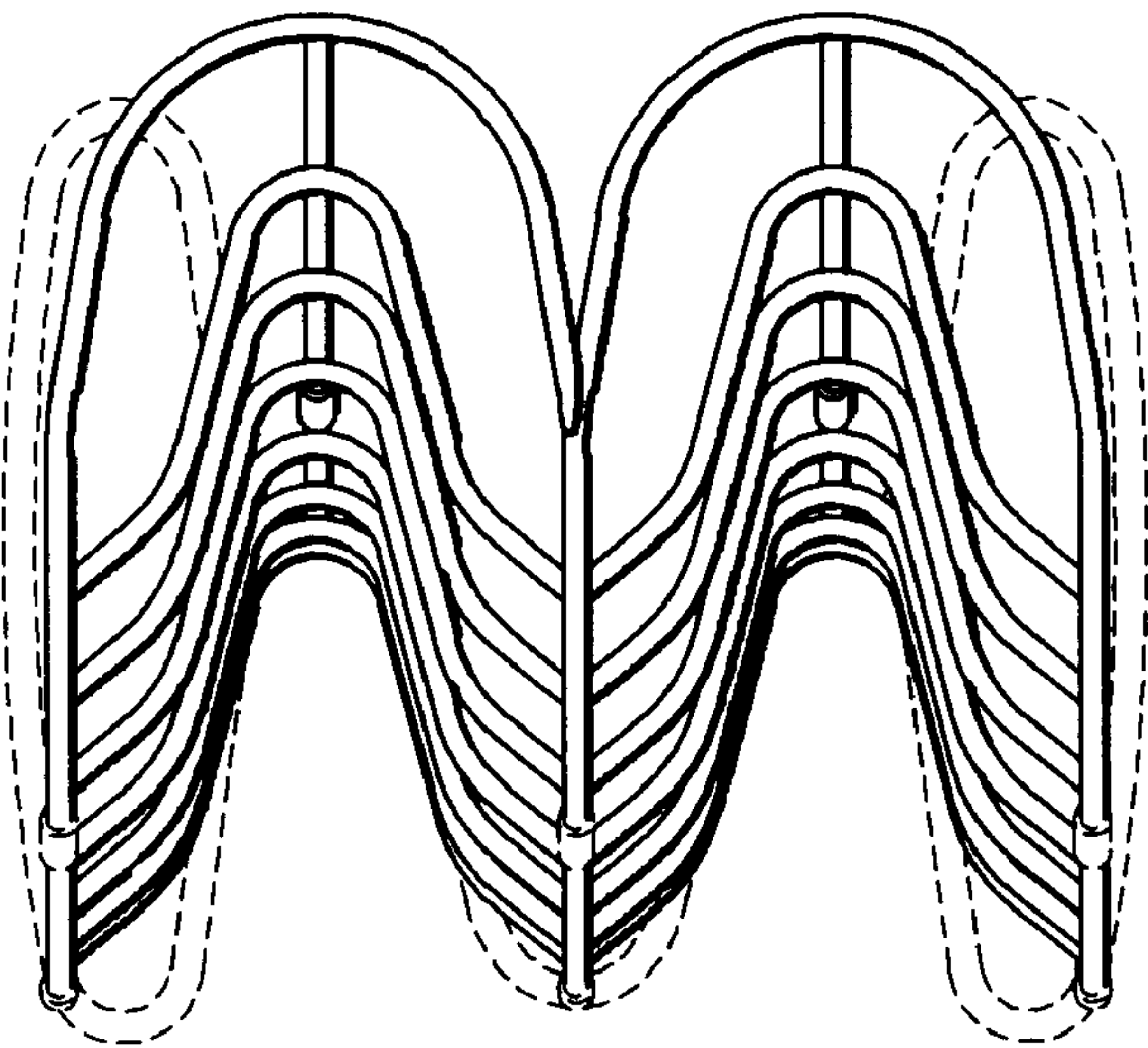

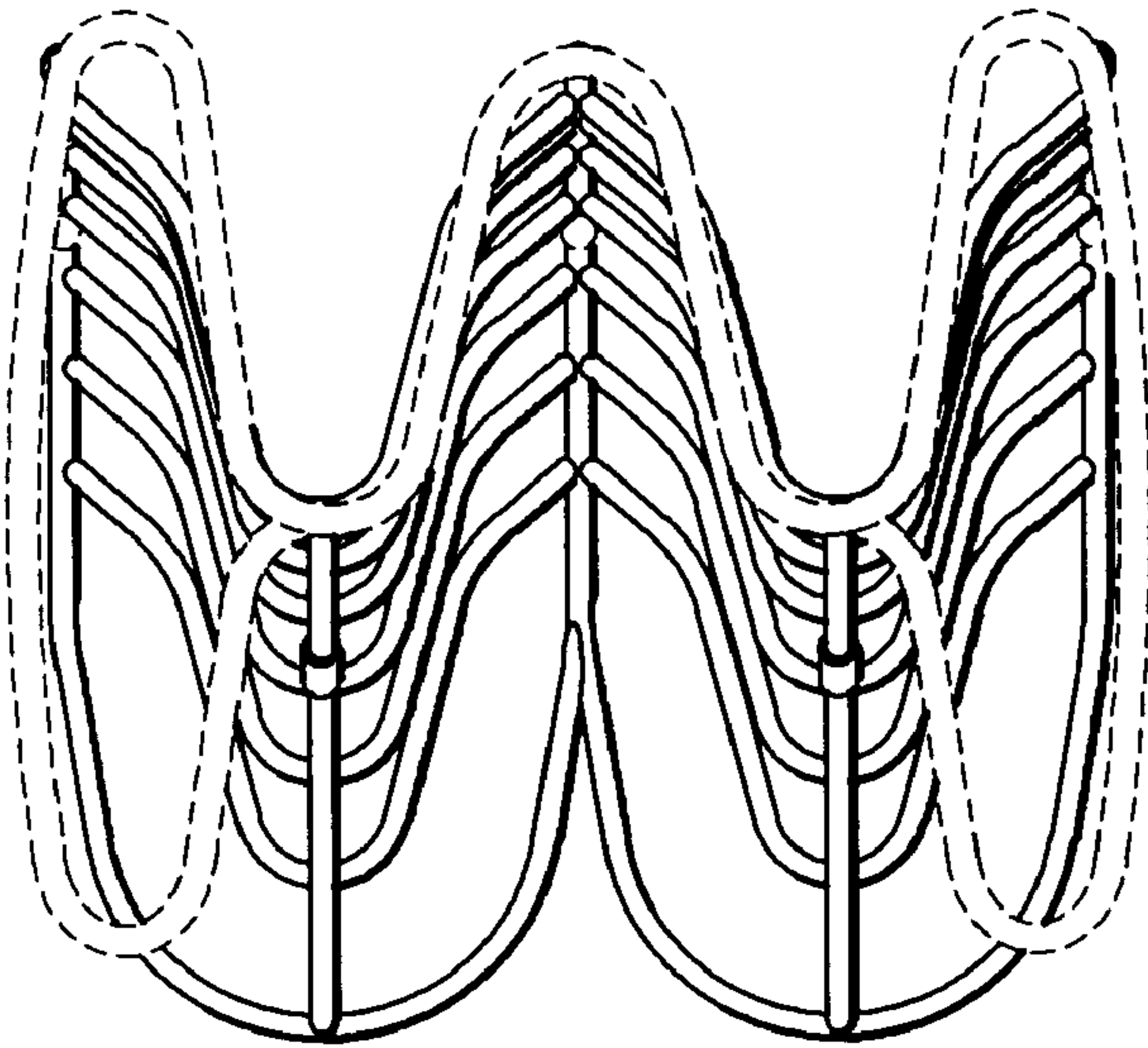
