The ornamental design for coffee maker, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view as seen from the top, front and left side of a coffee maker showing a preferred embodiment of the new design;

FIG. 20 is a left side elevational view of the coffee maker shown in FIG. 19;

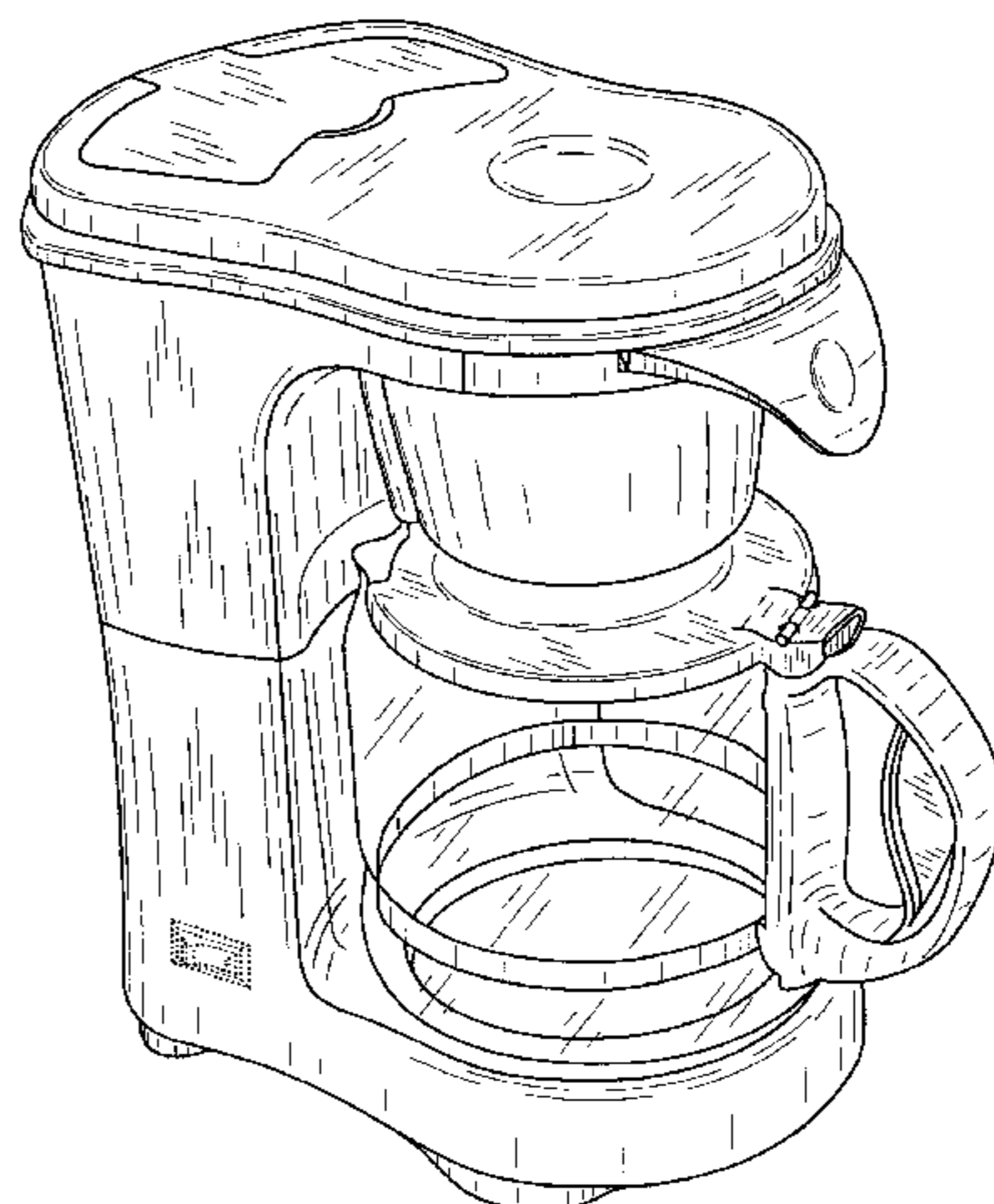
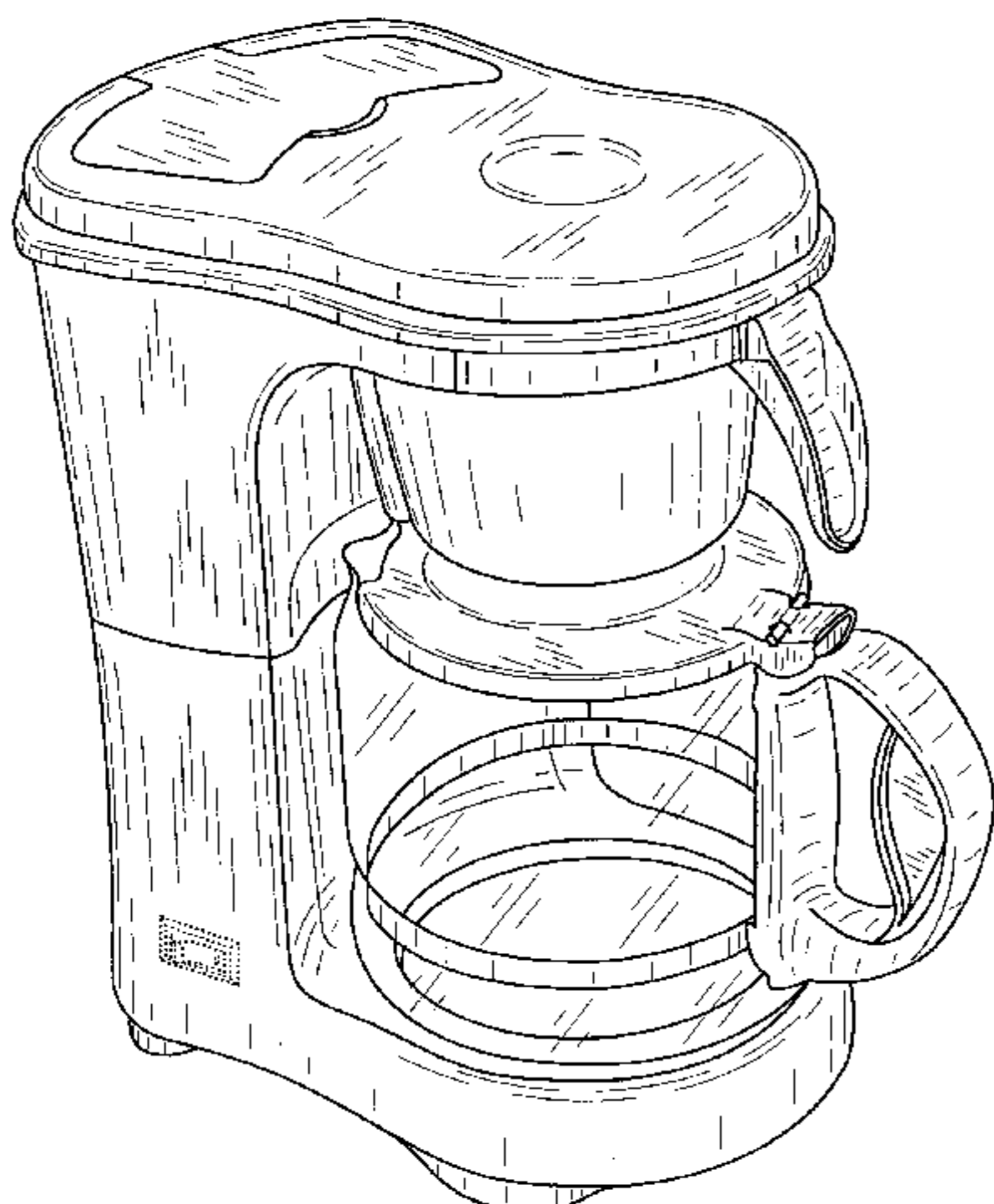
FIG. 21 is a front elevational view of the coffee maker shown in FIG. 19;

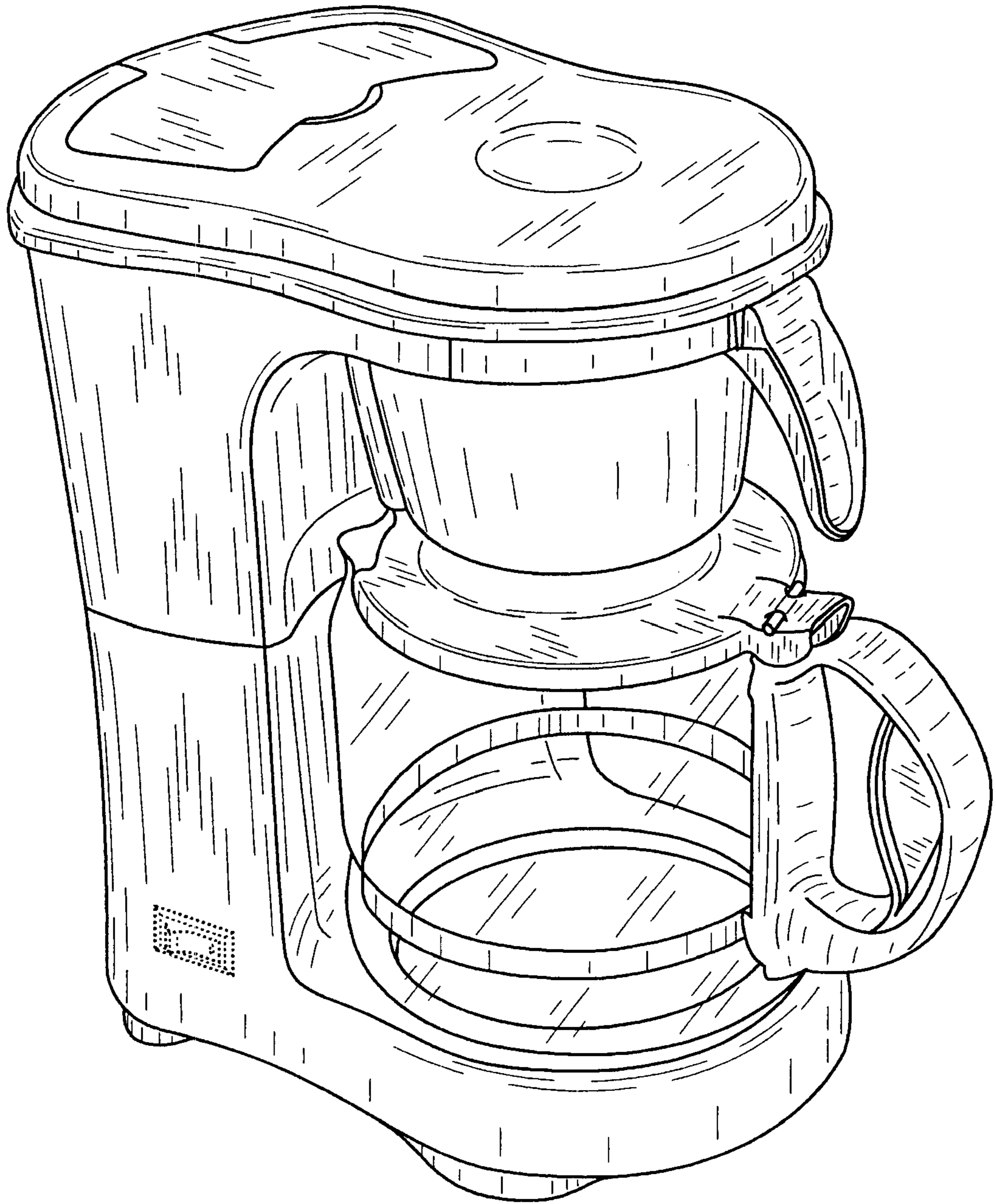

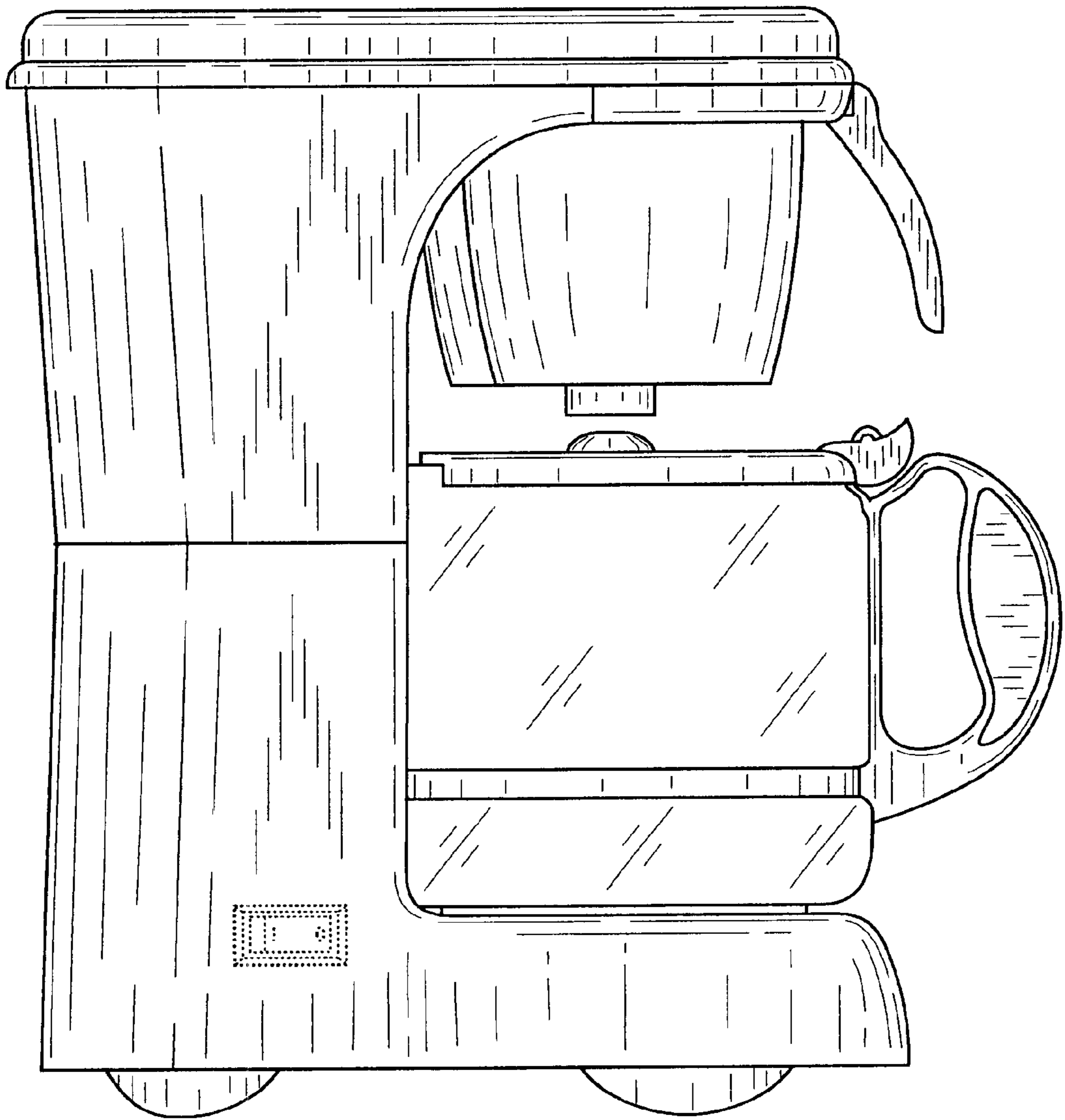

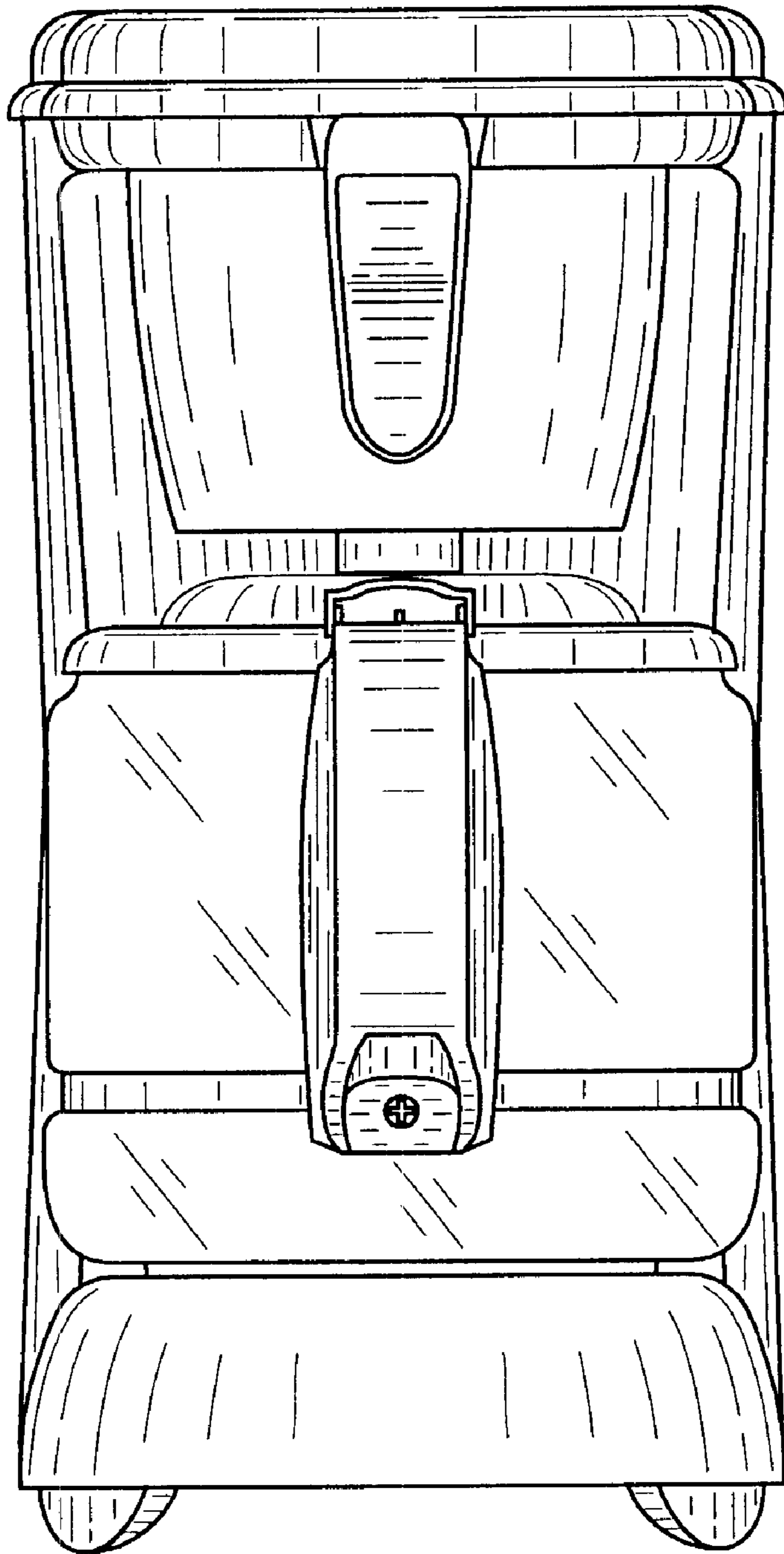

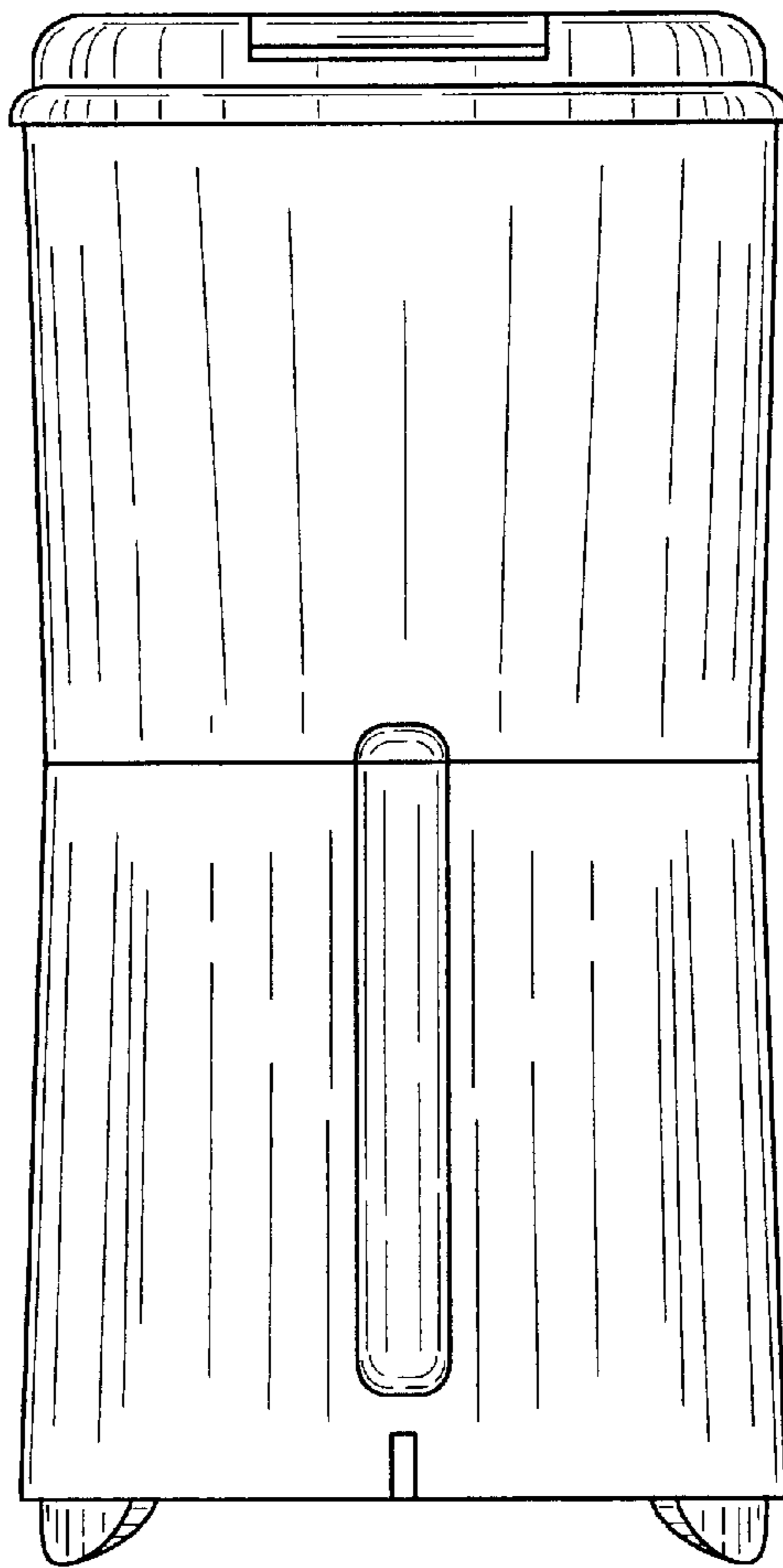

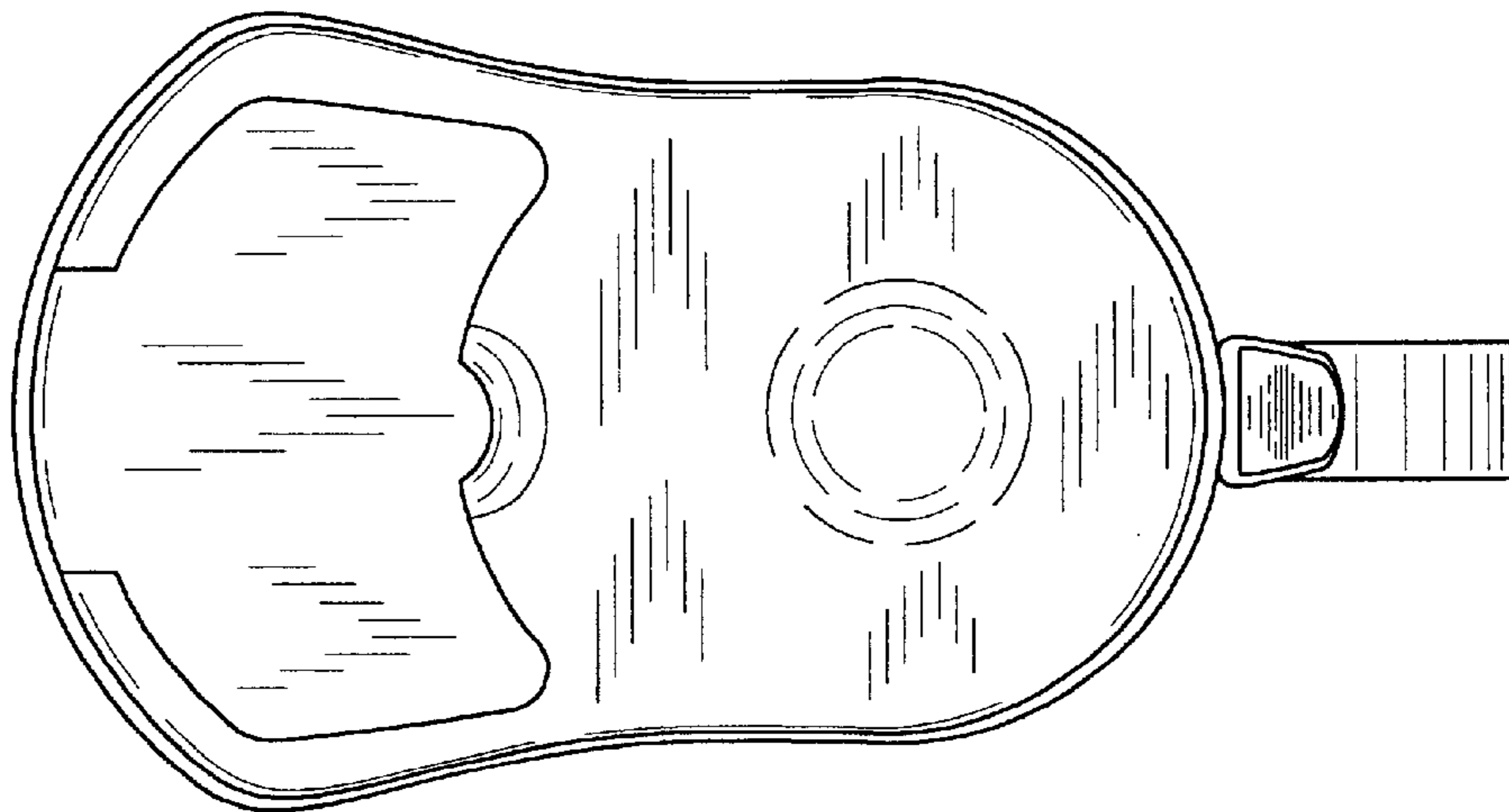

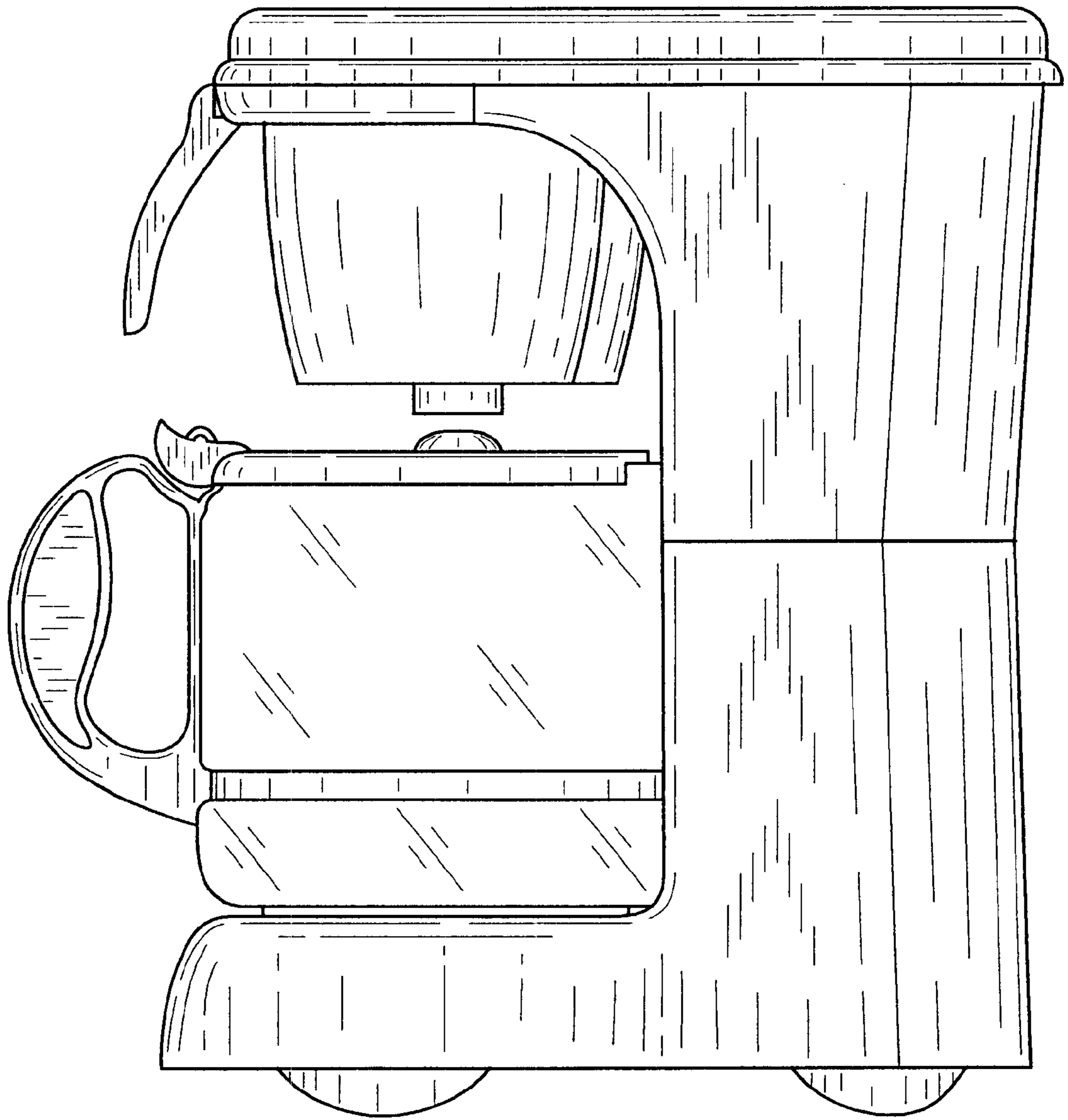

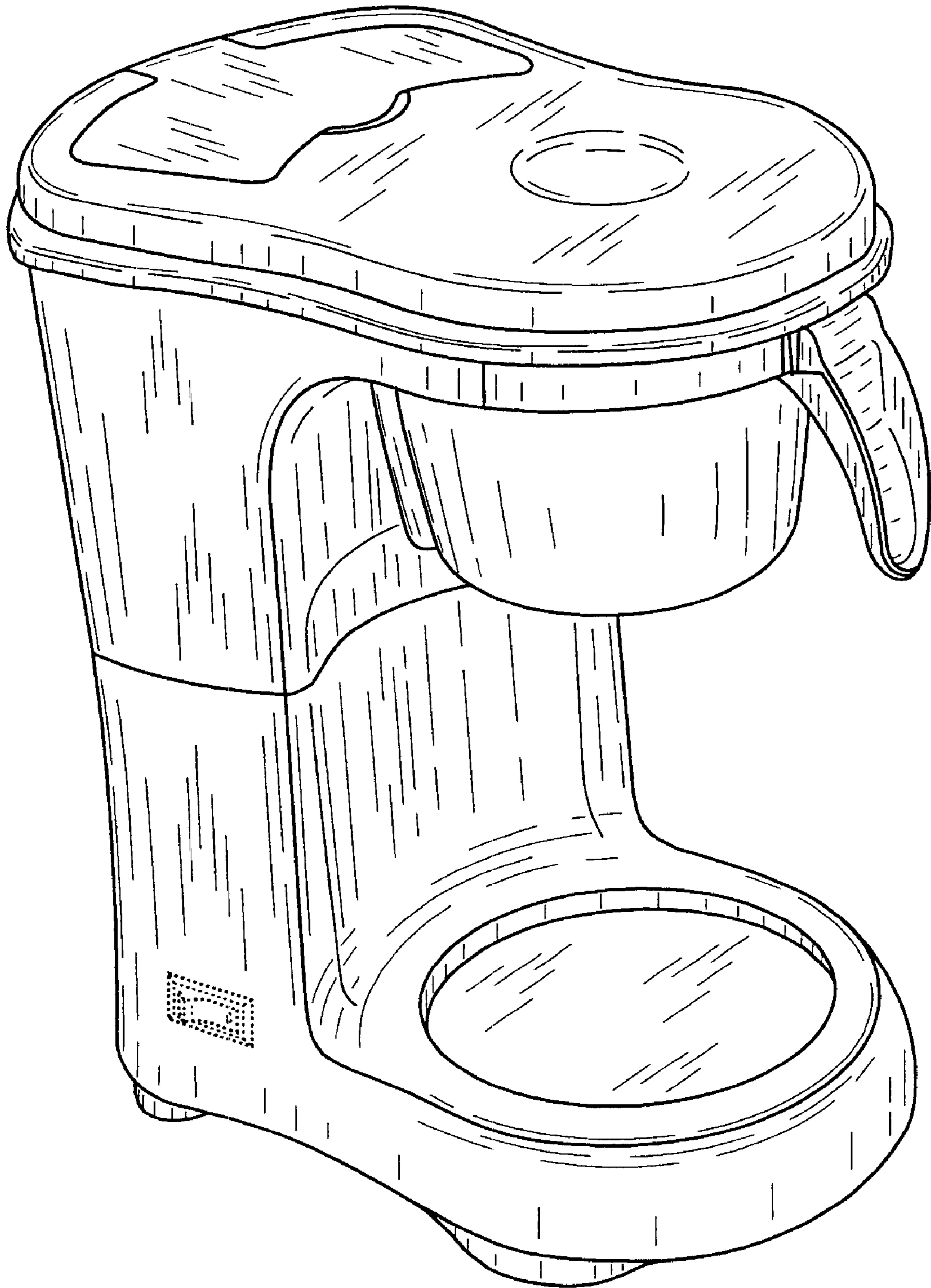

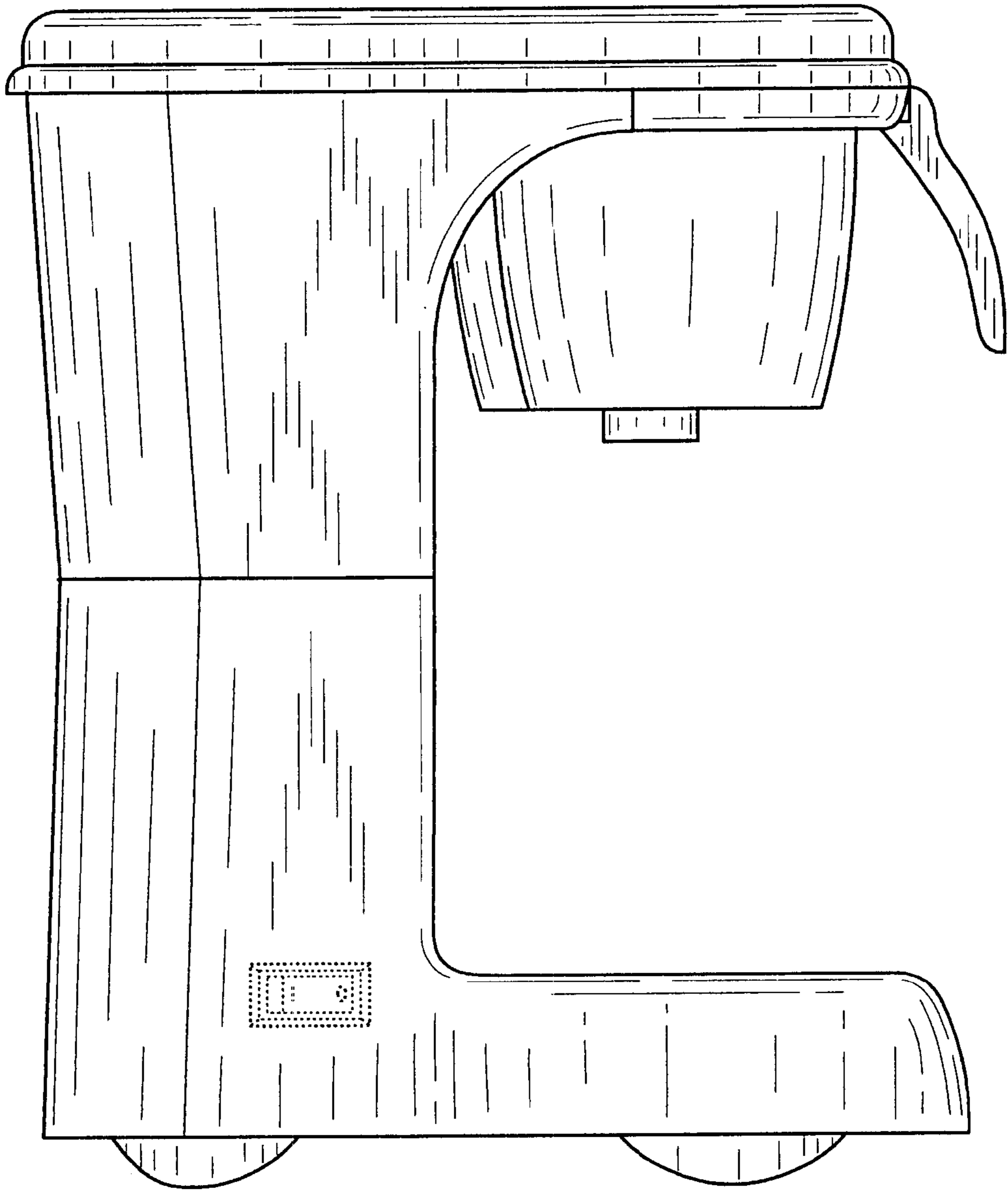

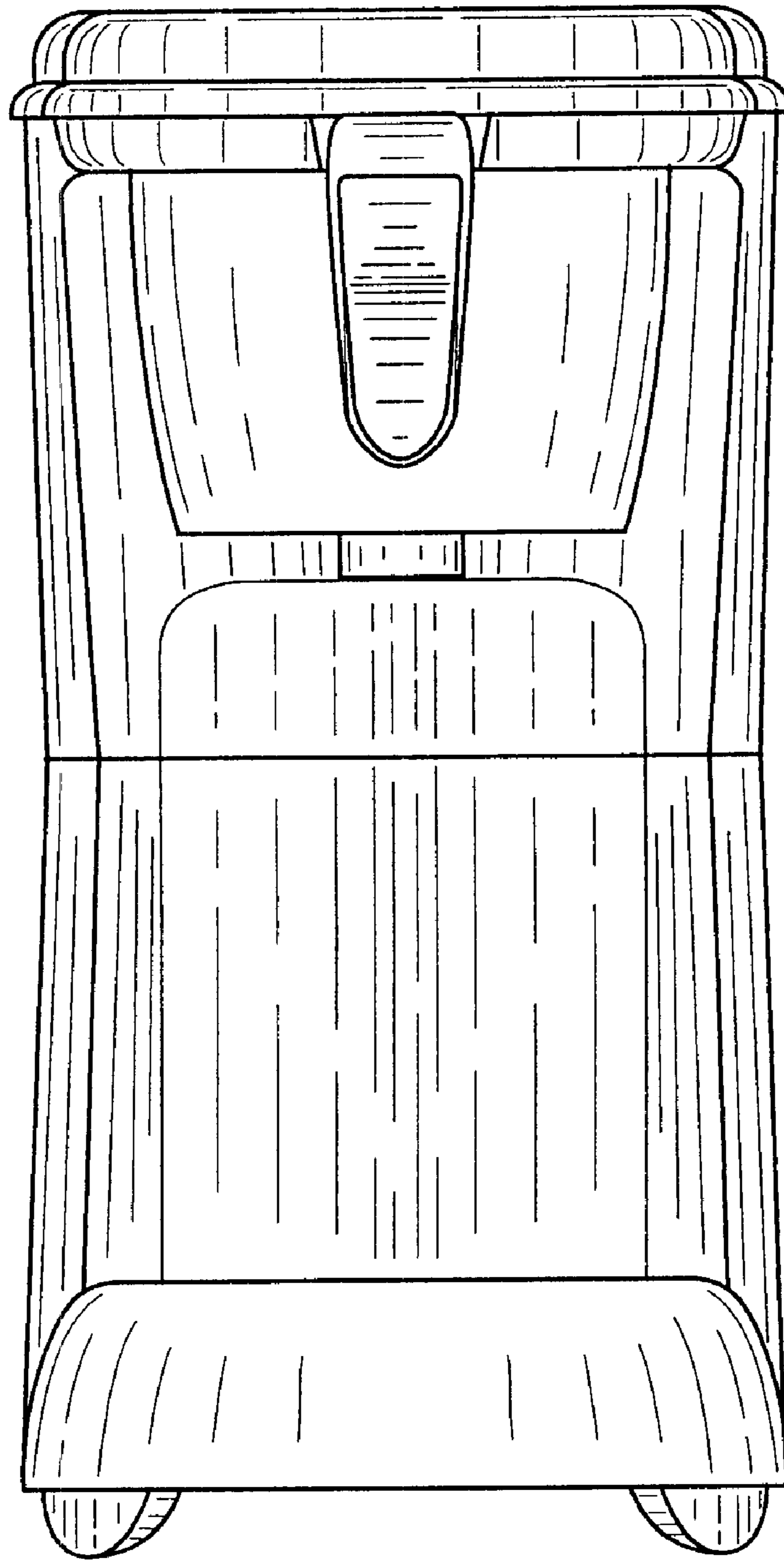

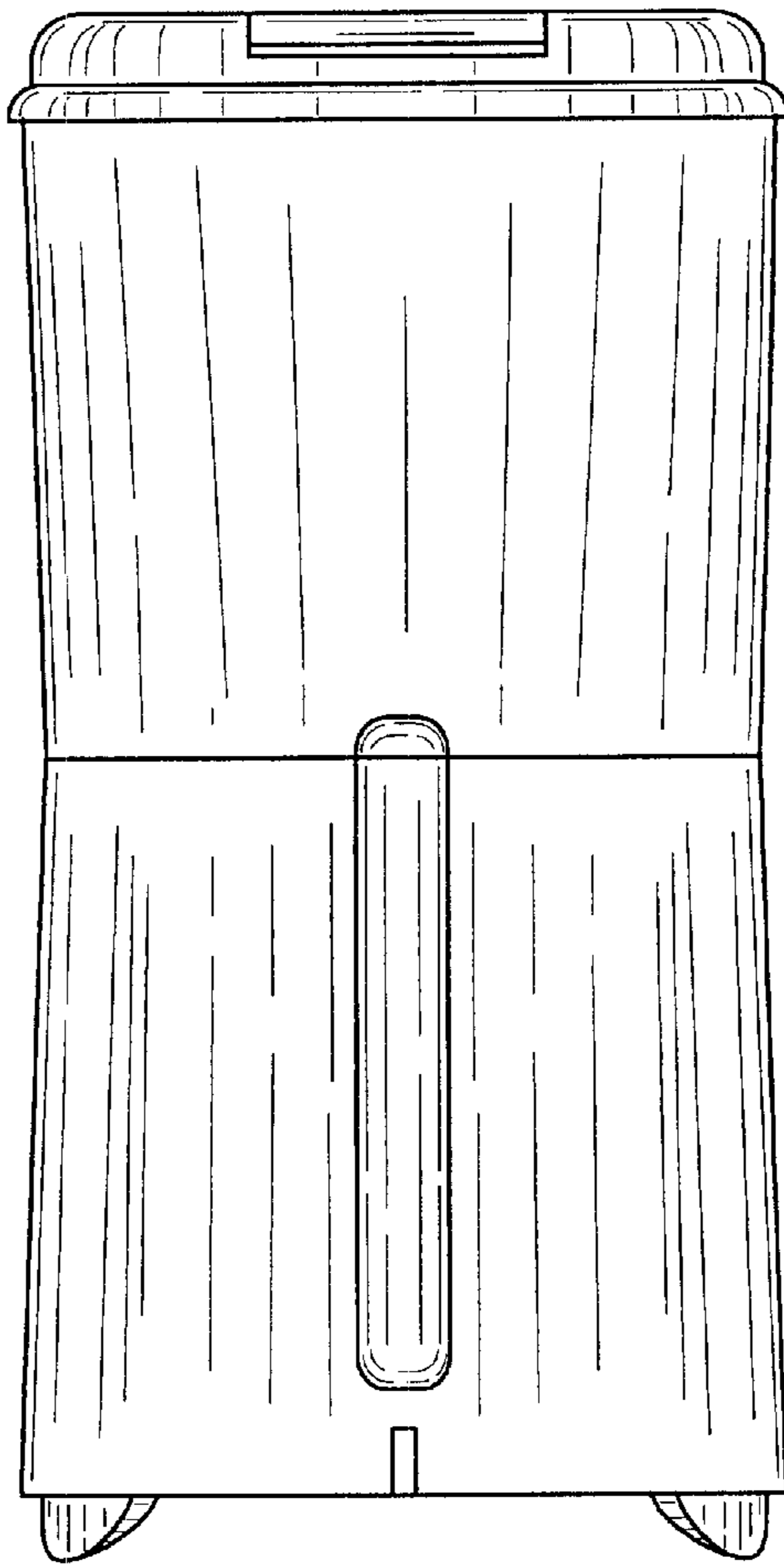

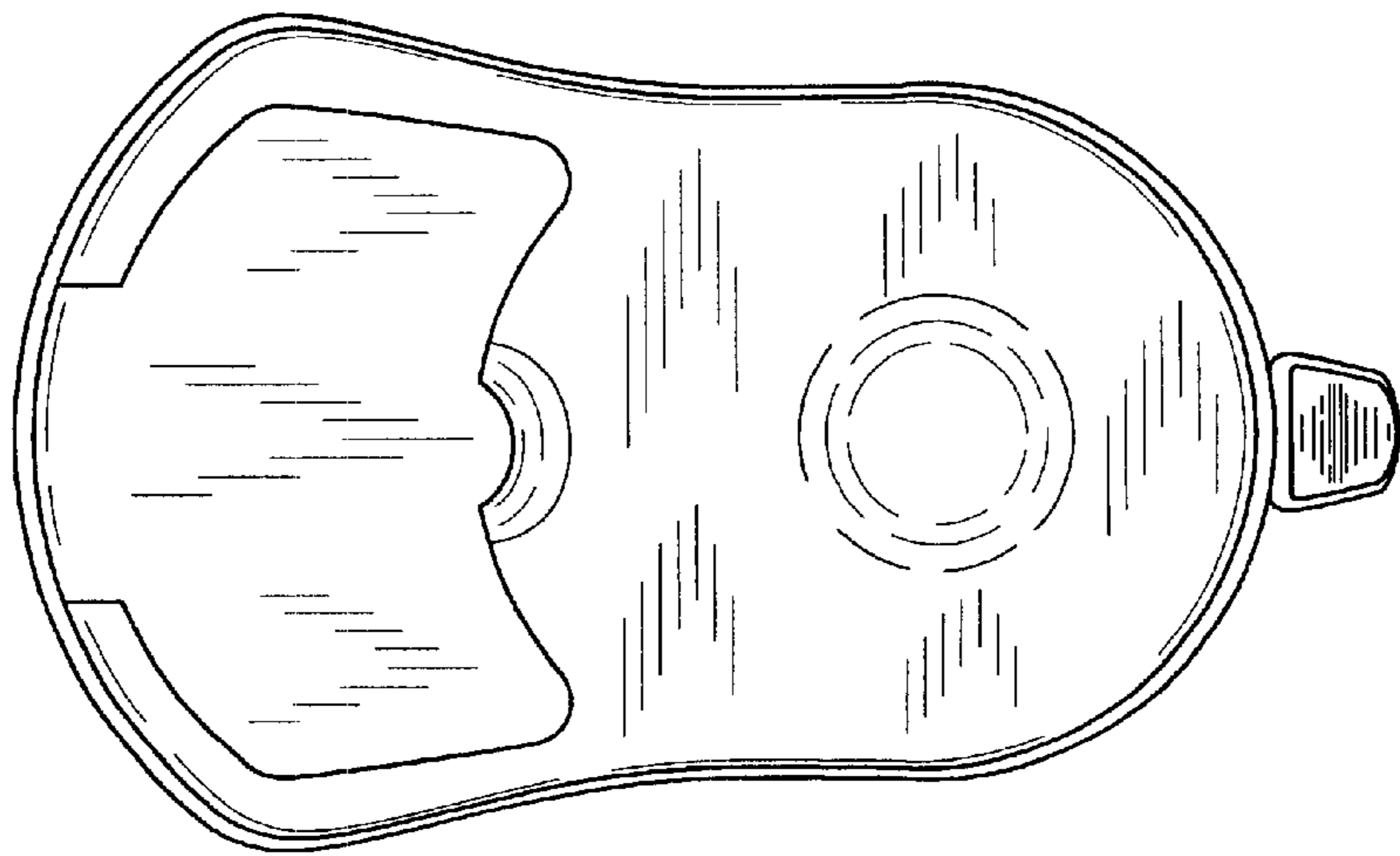

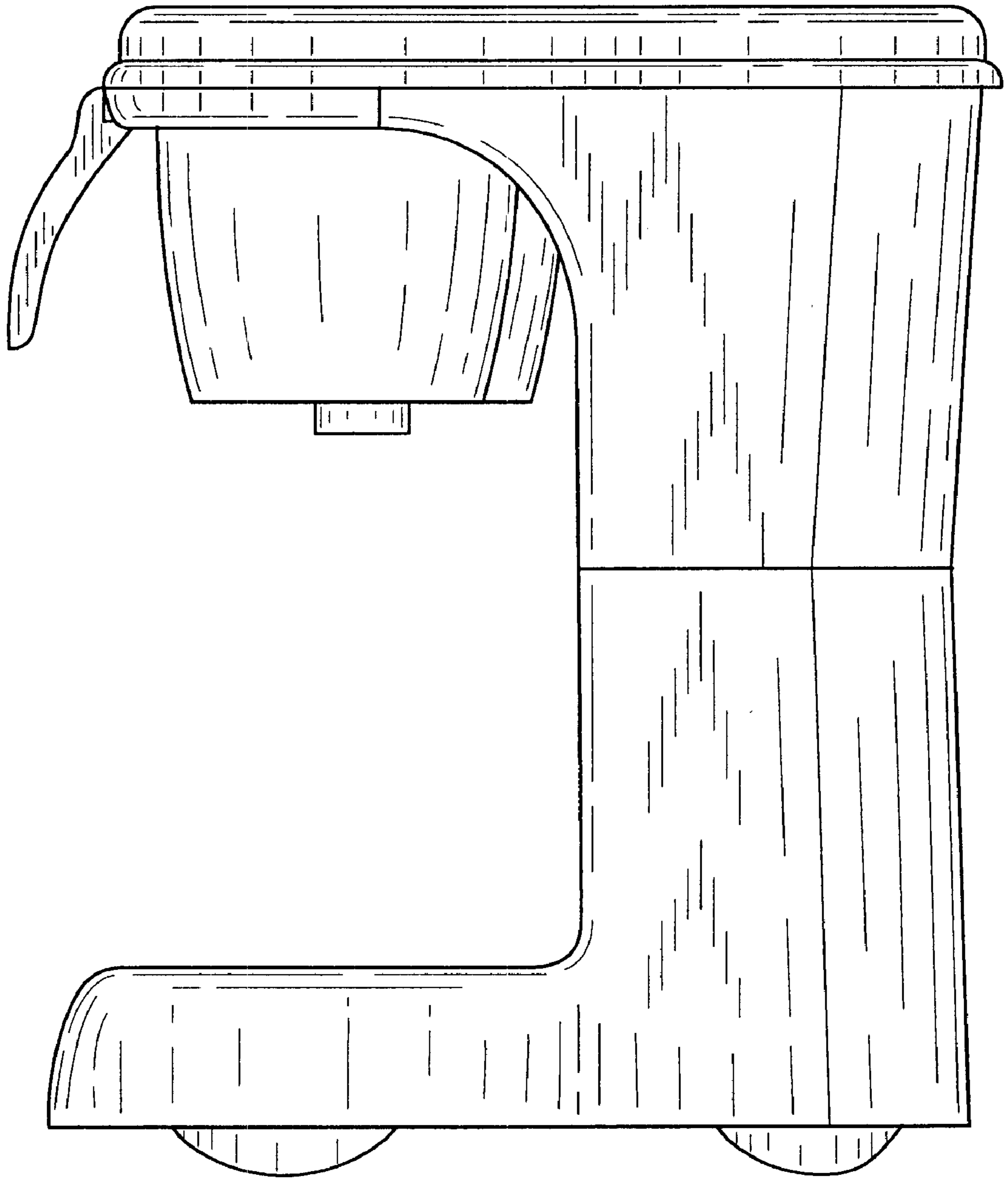

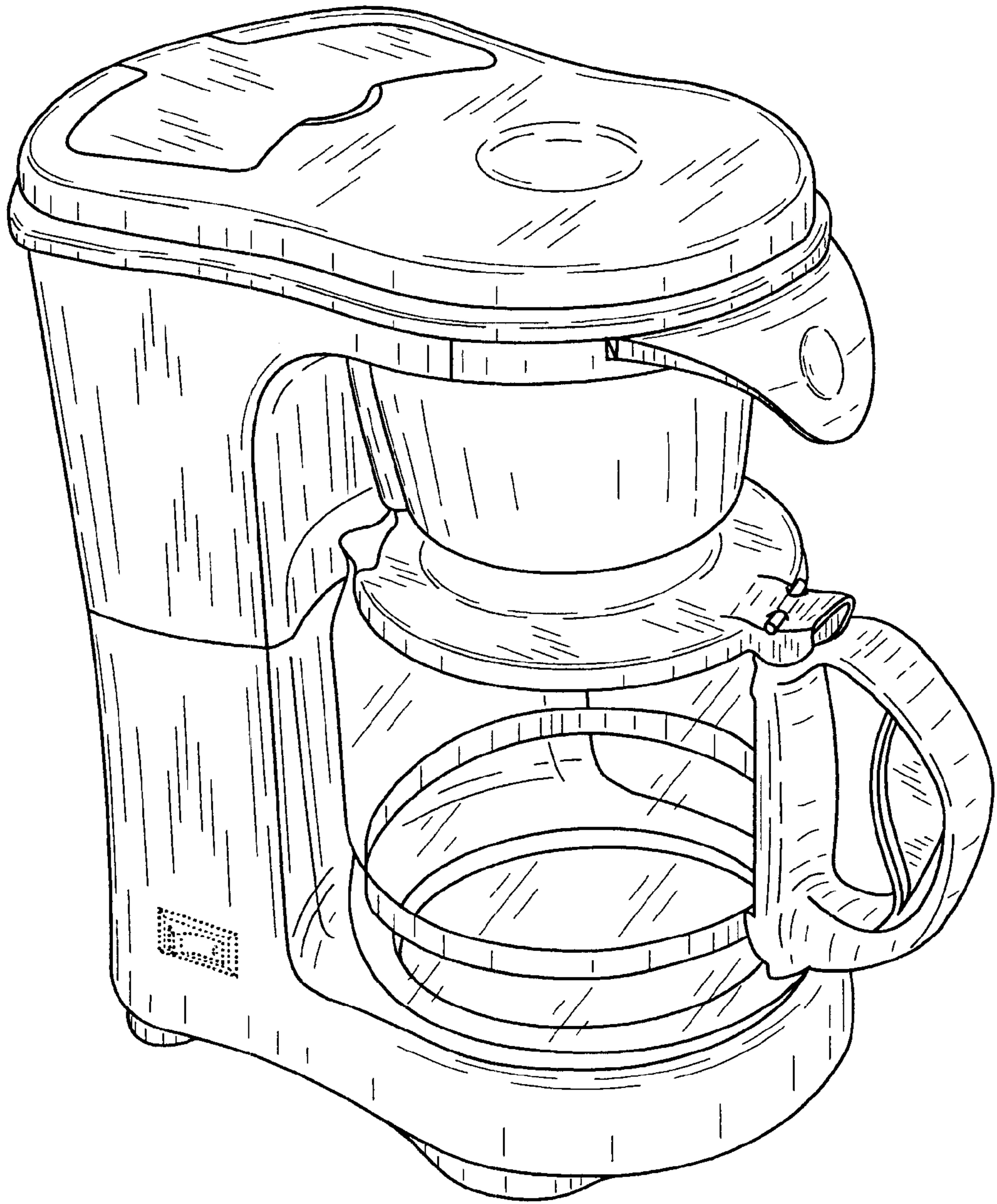

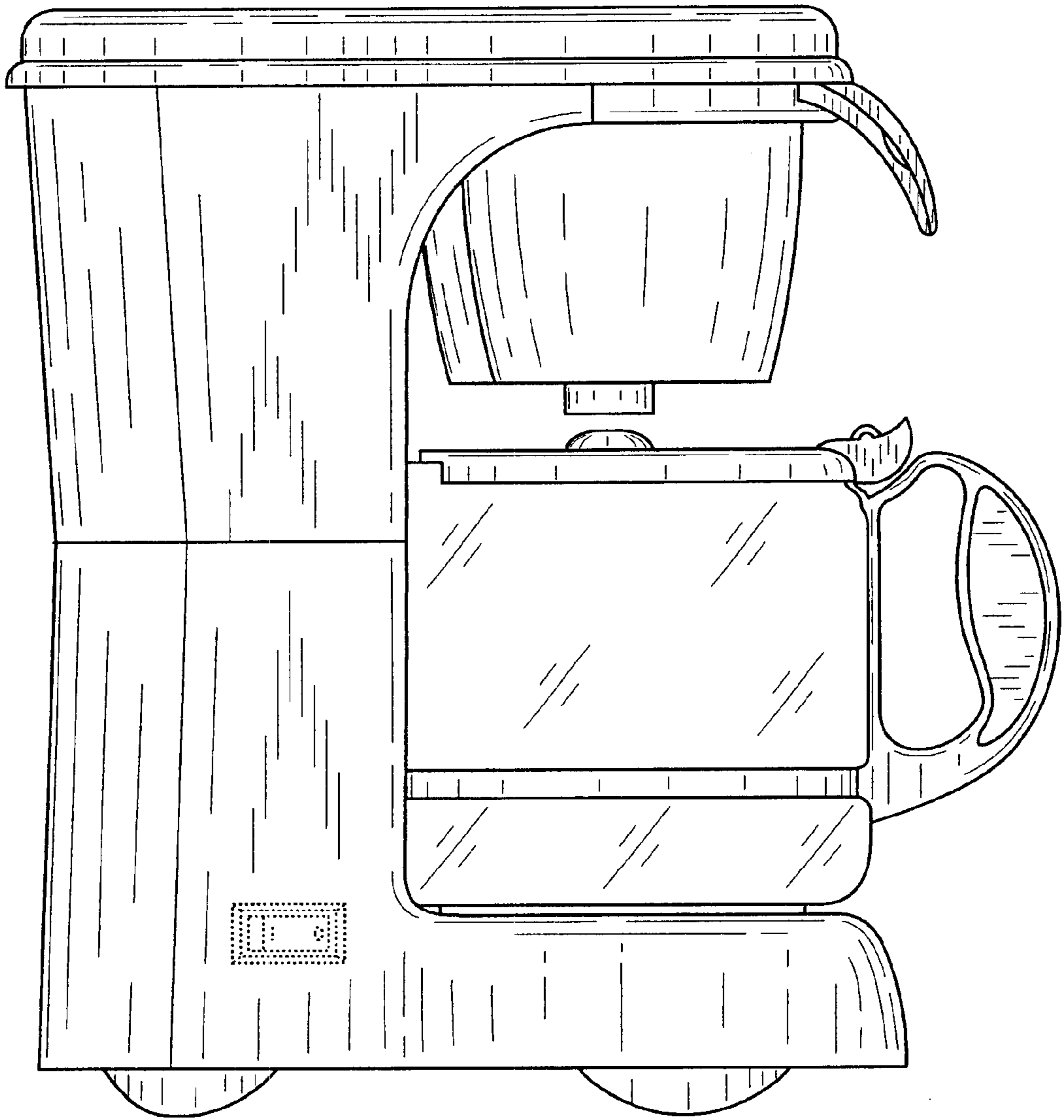

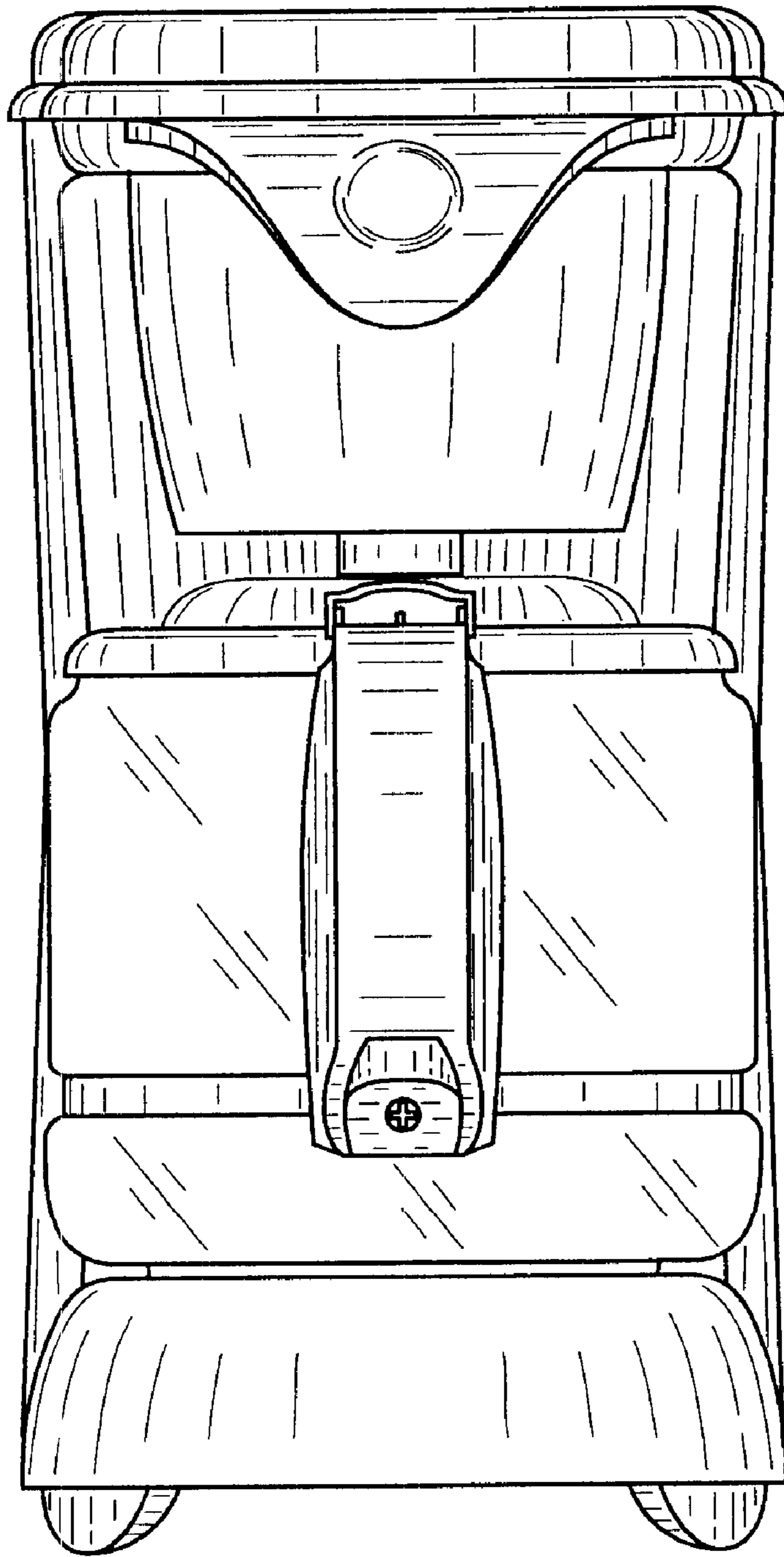

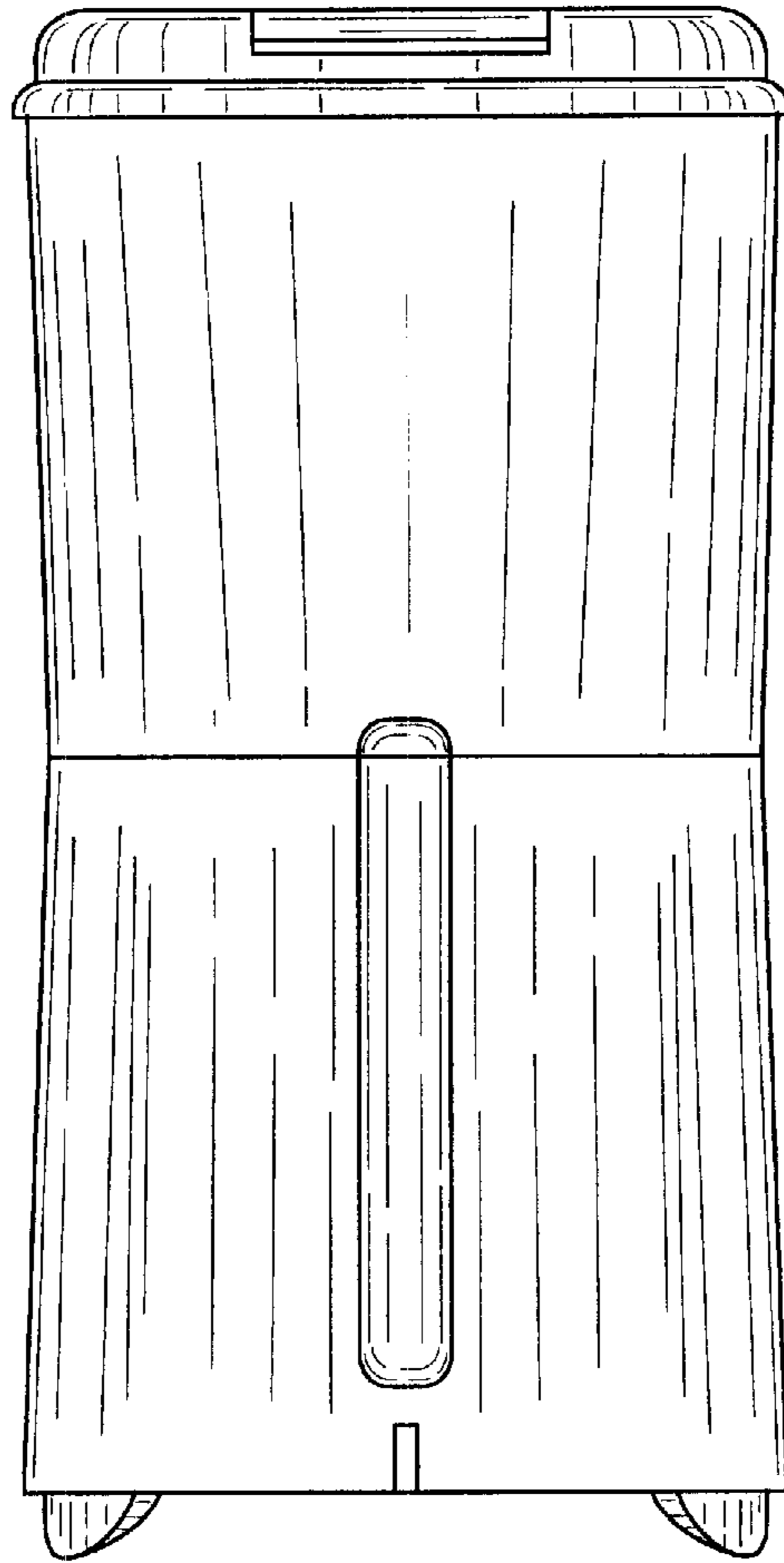

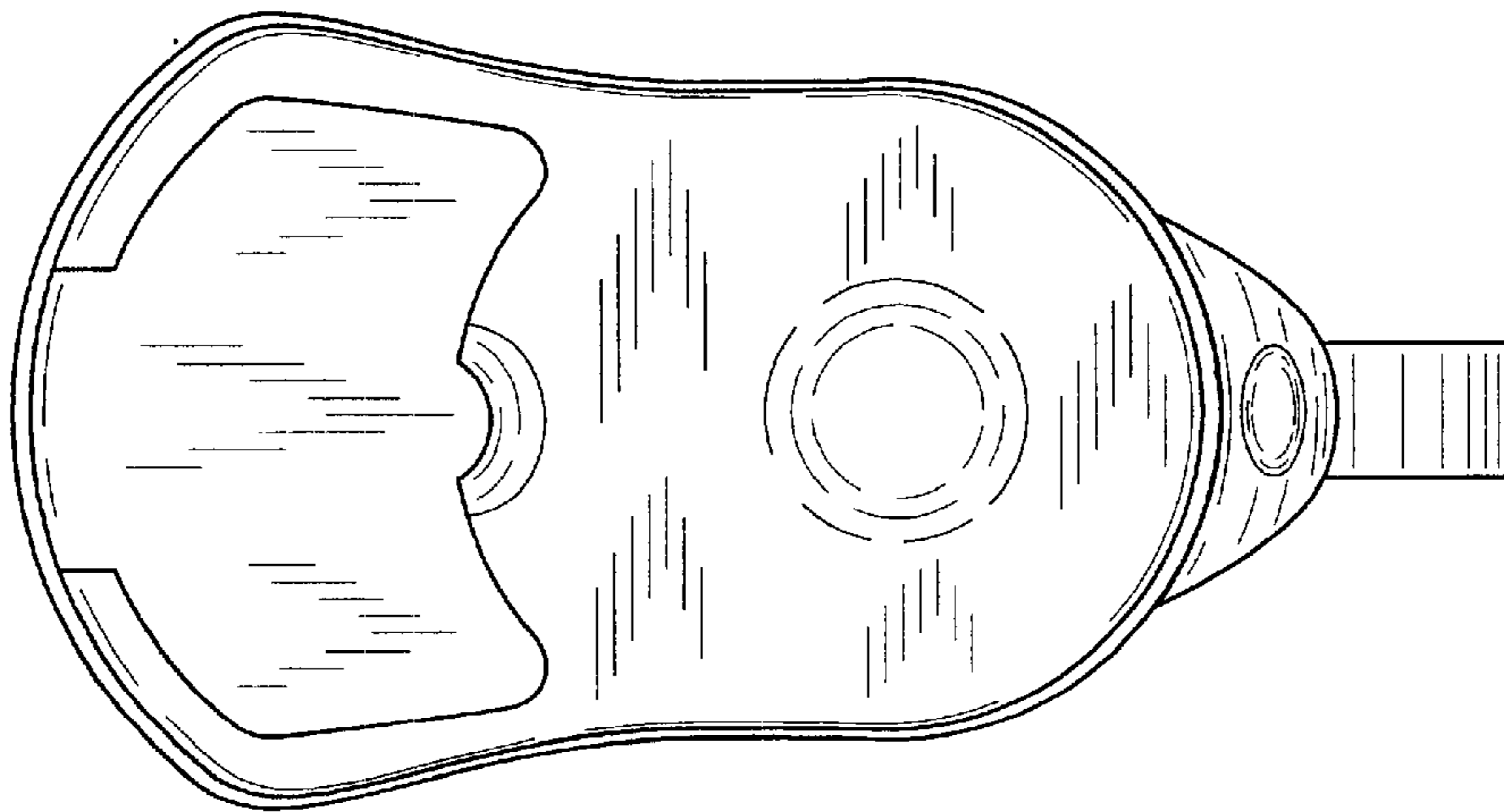

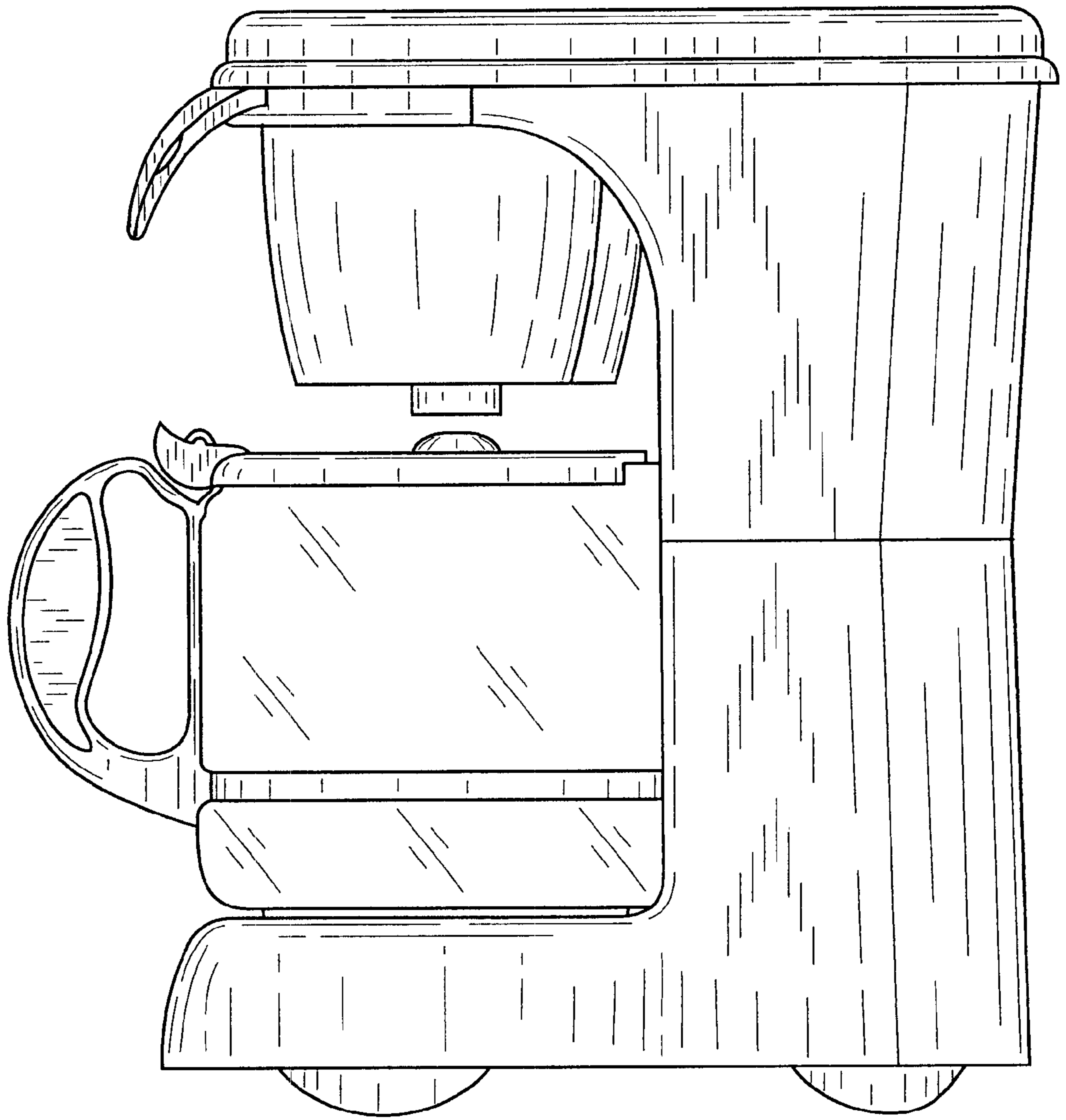

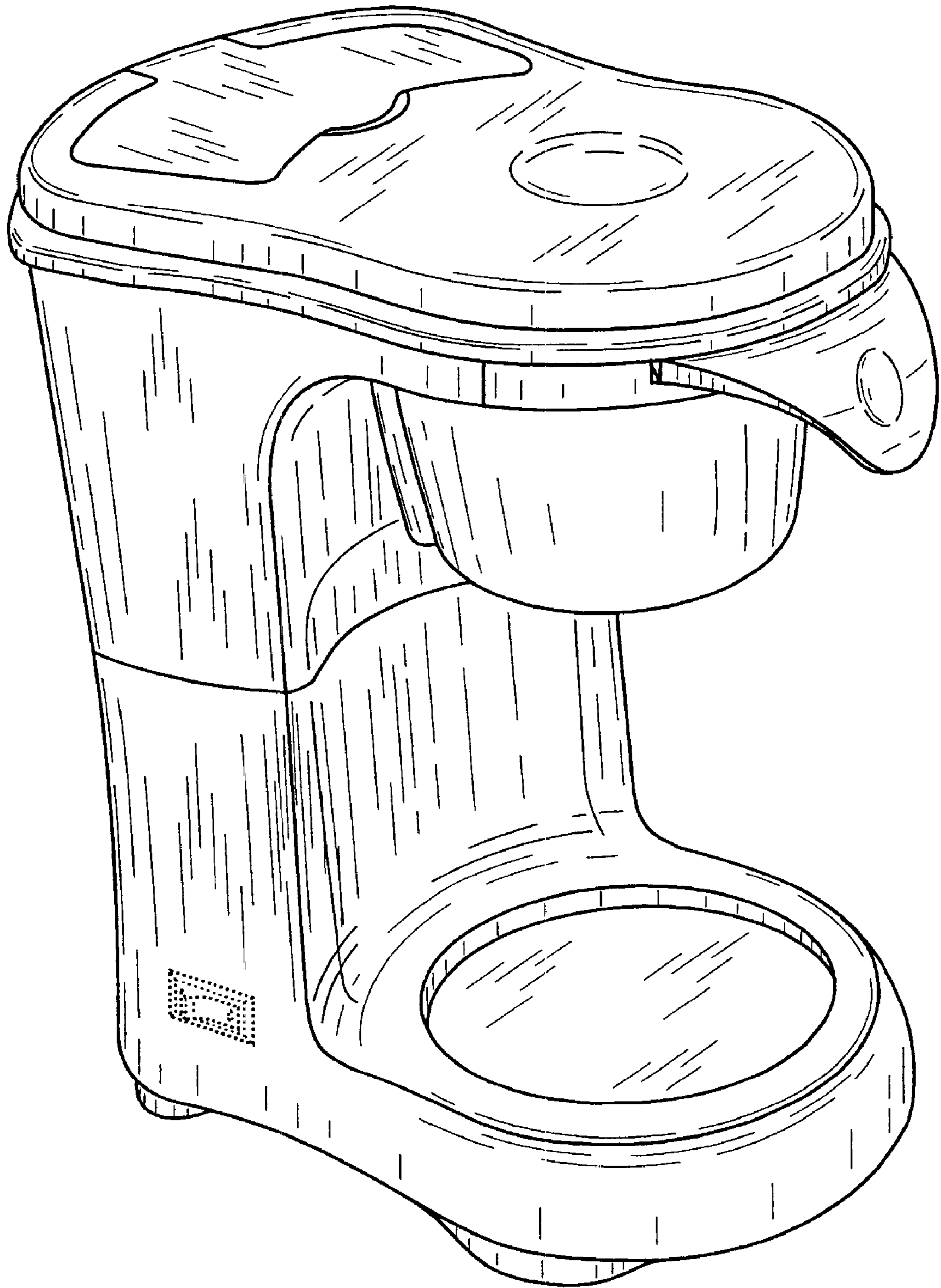

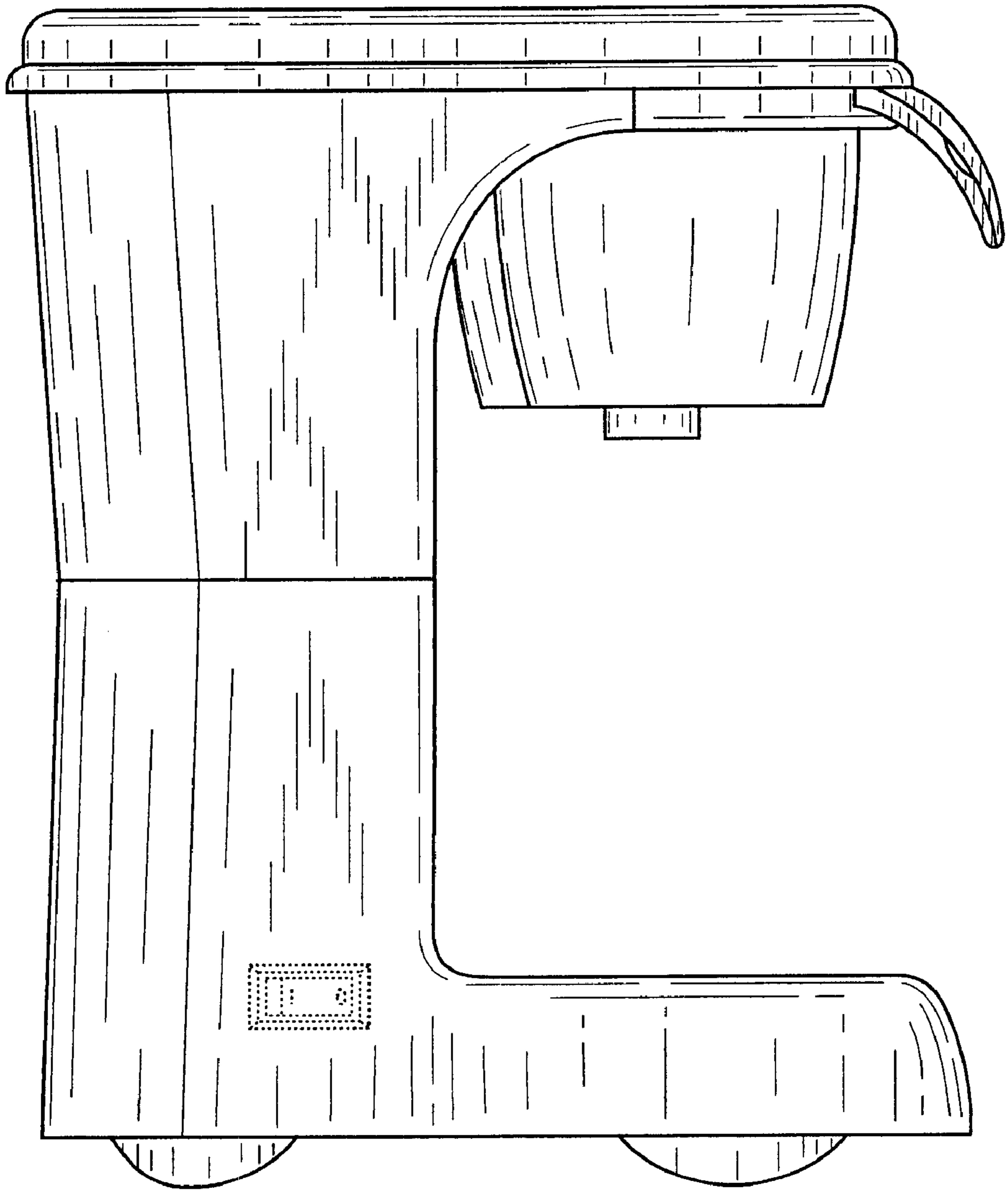

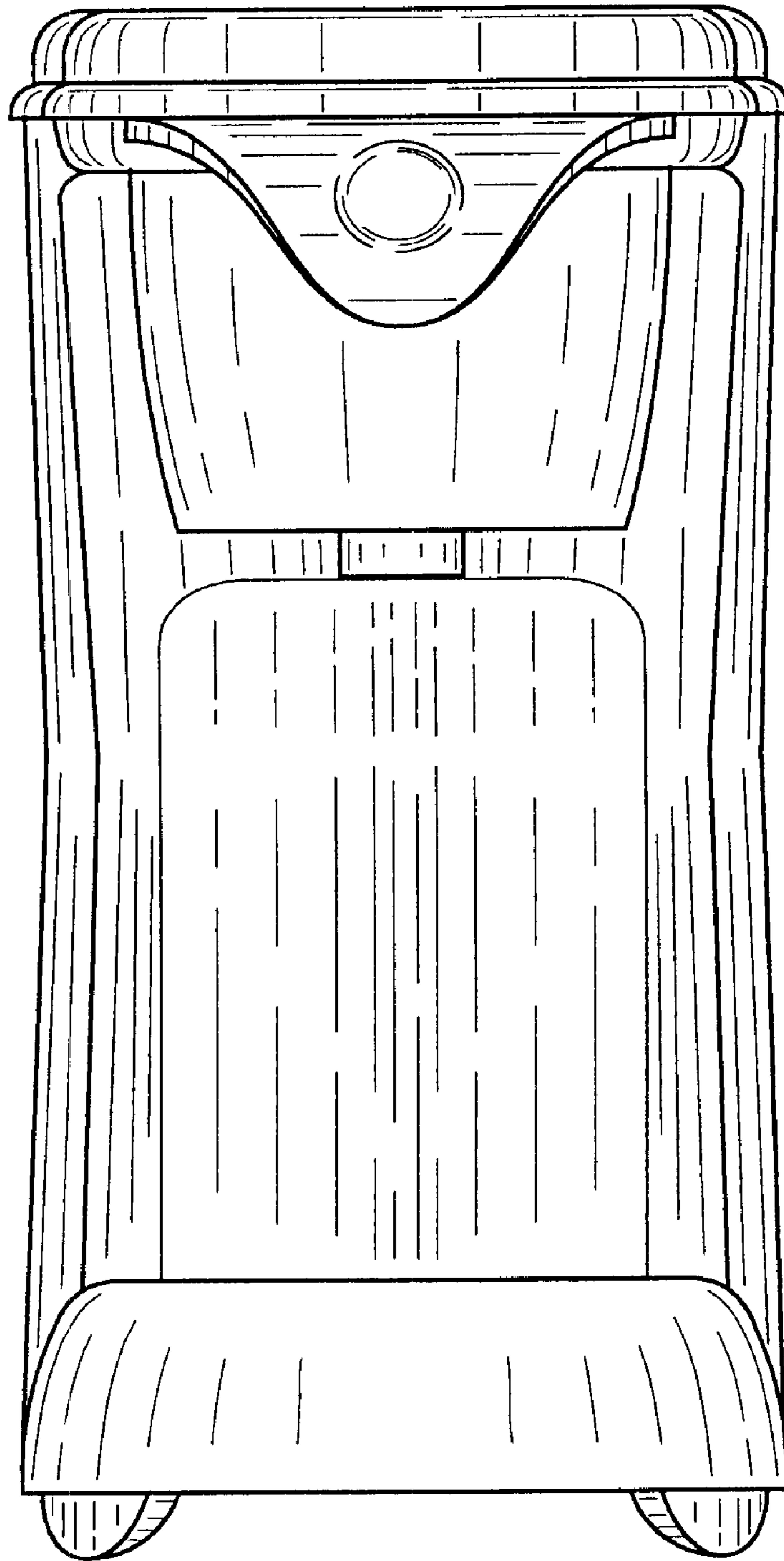

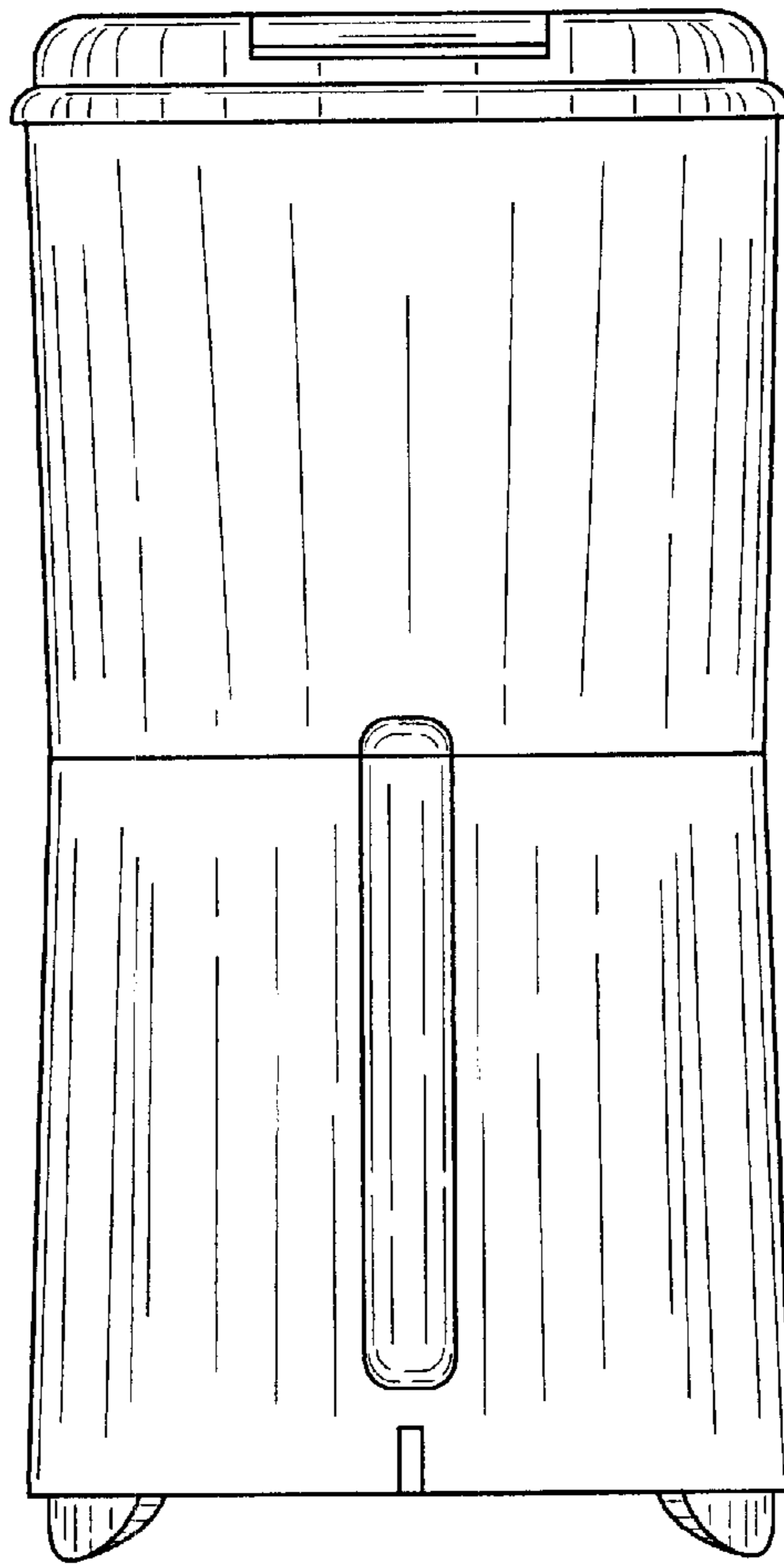

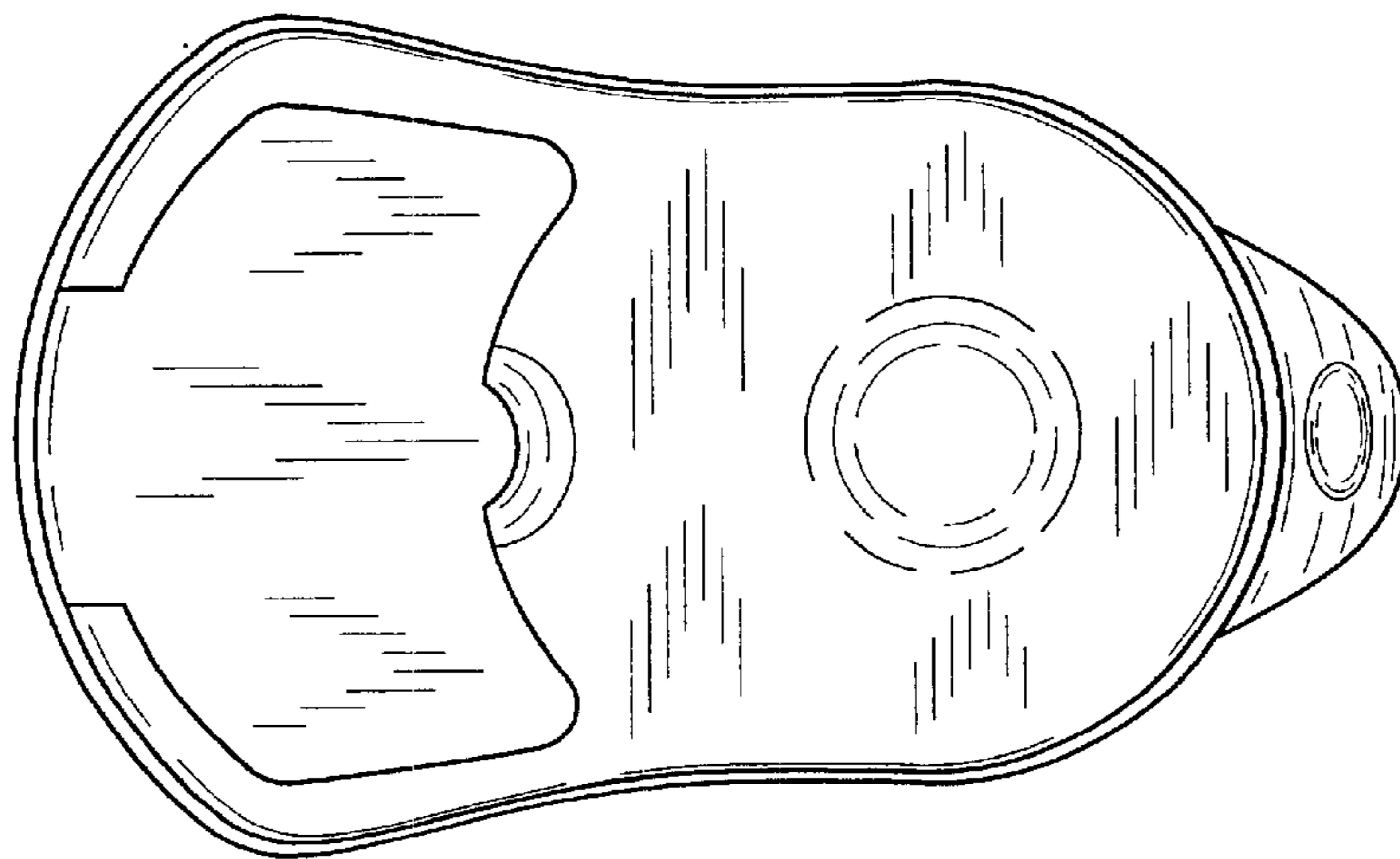

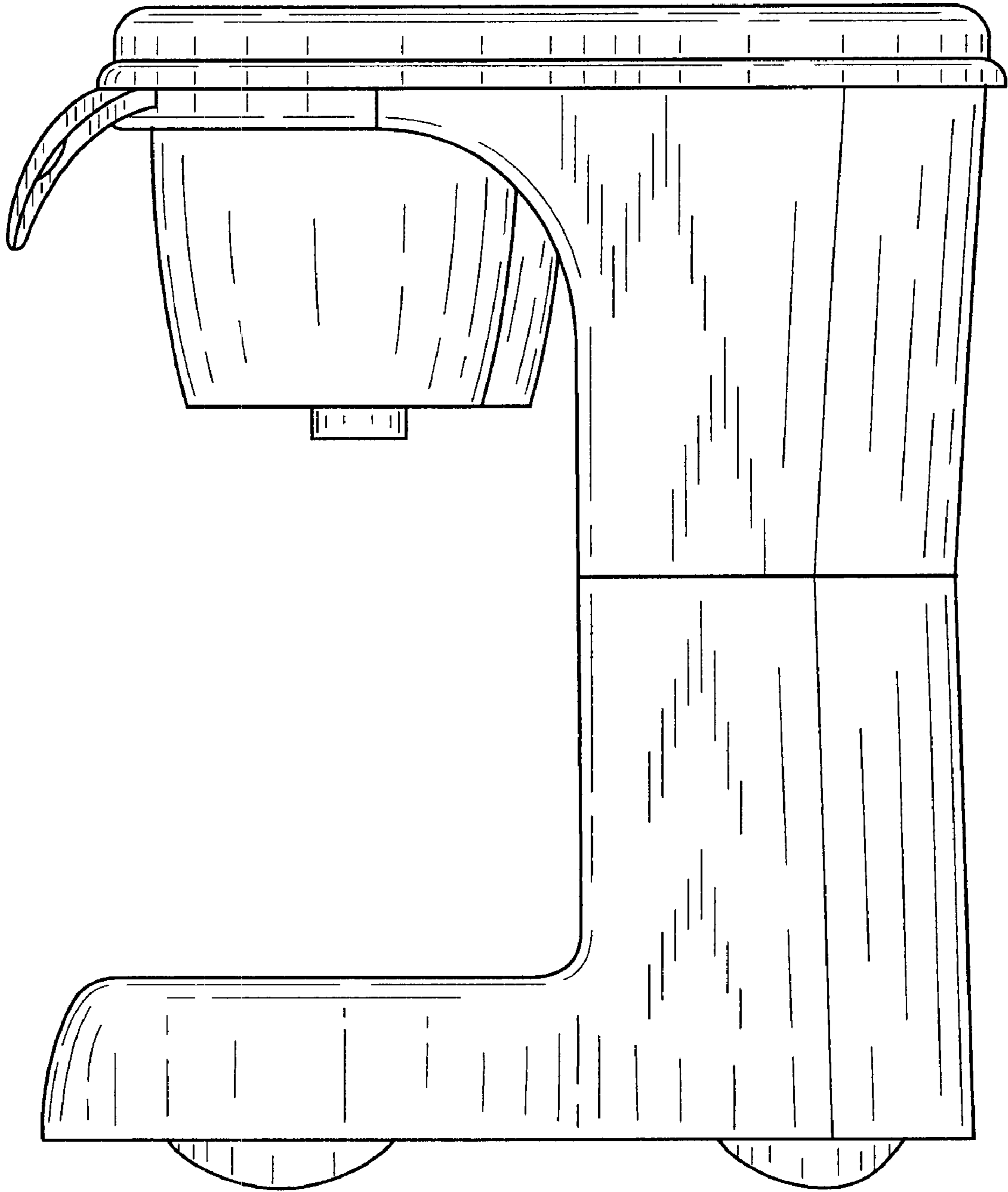
