(57) **CLAIM**

The ornamental design for carton for food products having tapered sides, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a carton illustrating our design;

FIG. 2 is a top plan view thereof;

FIG. 3 is an elevational view from the left side thereof;

FIG. 4 is an elevational view from the front;

FIG. 5 is a bottom plan view;

FIG. 6 is an elevational view from the right side thereof; and,

FIG. 7 is an elevational view from the rear.

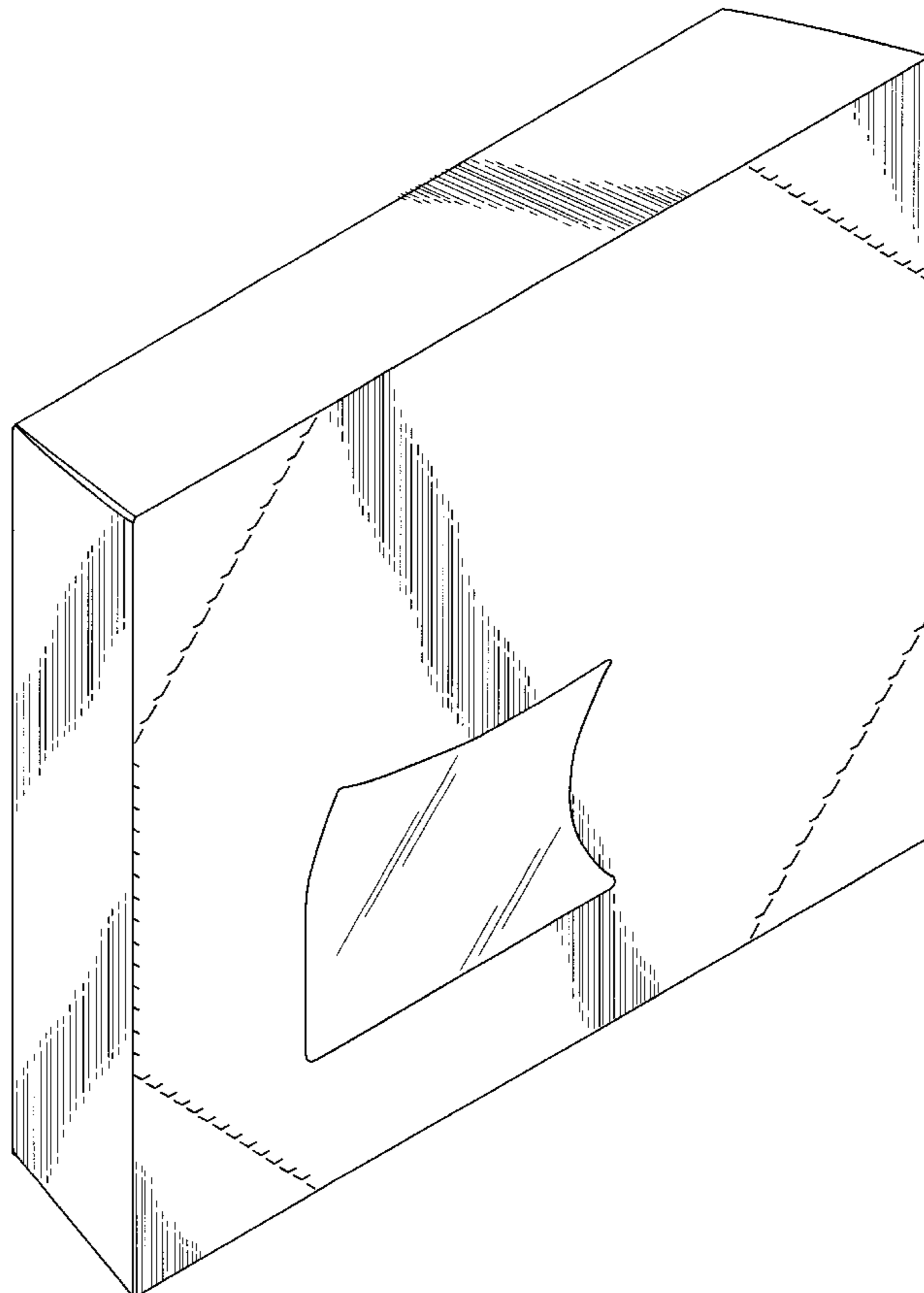

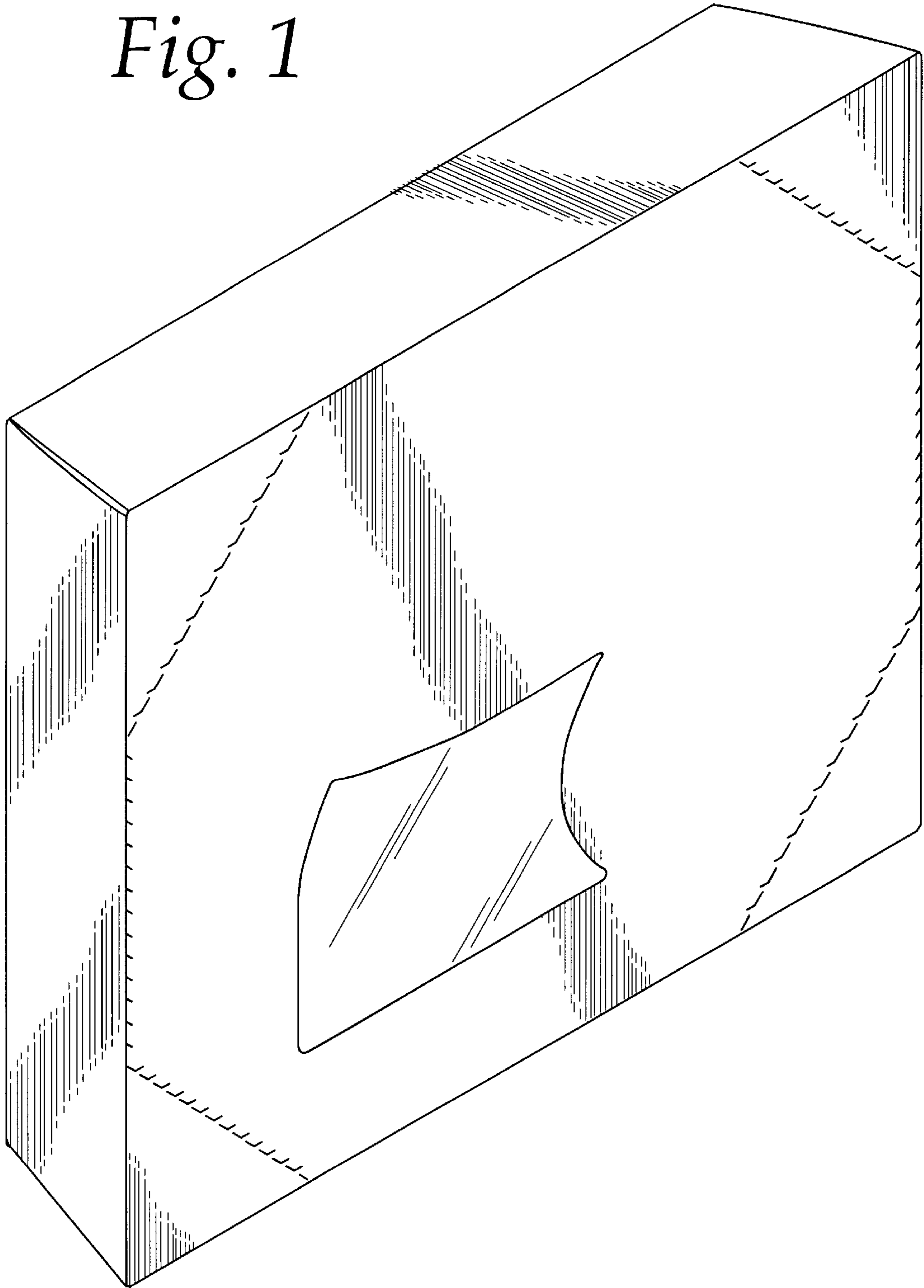

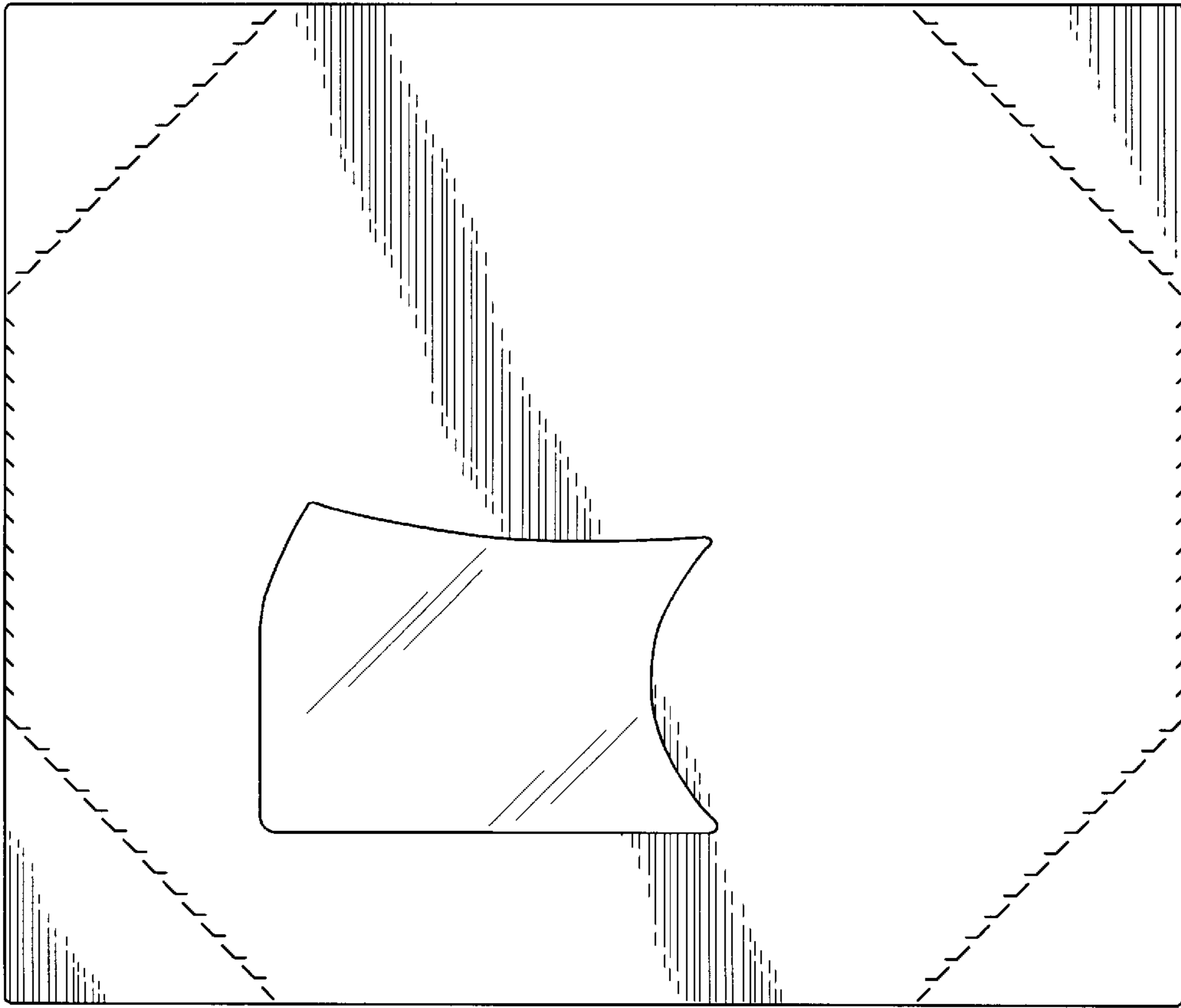

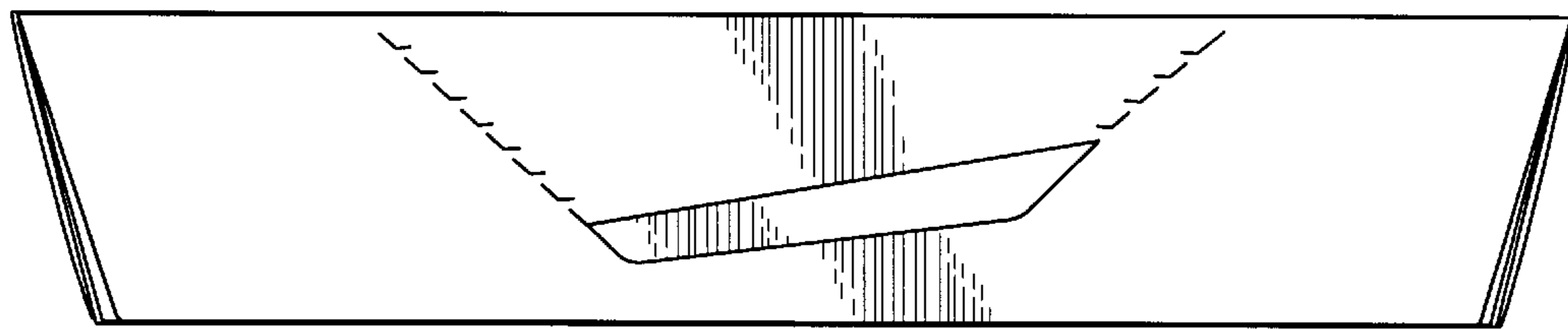

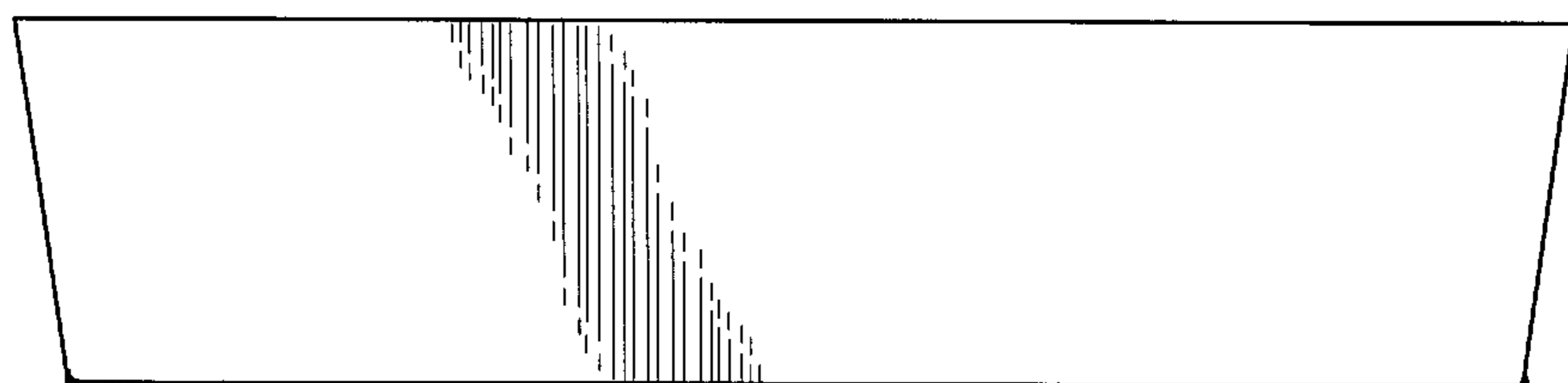

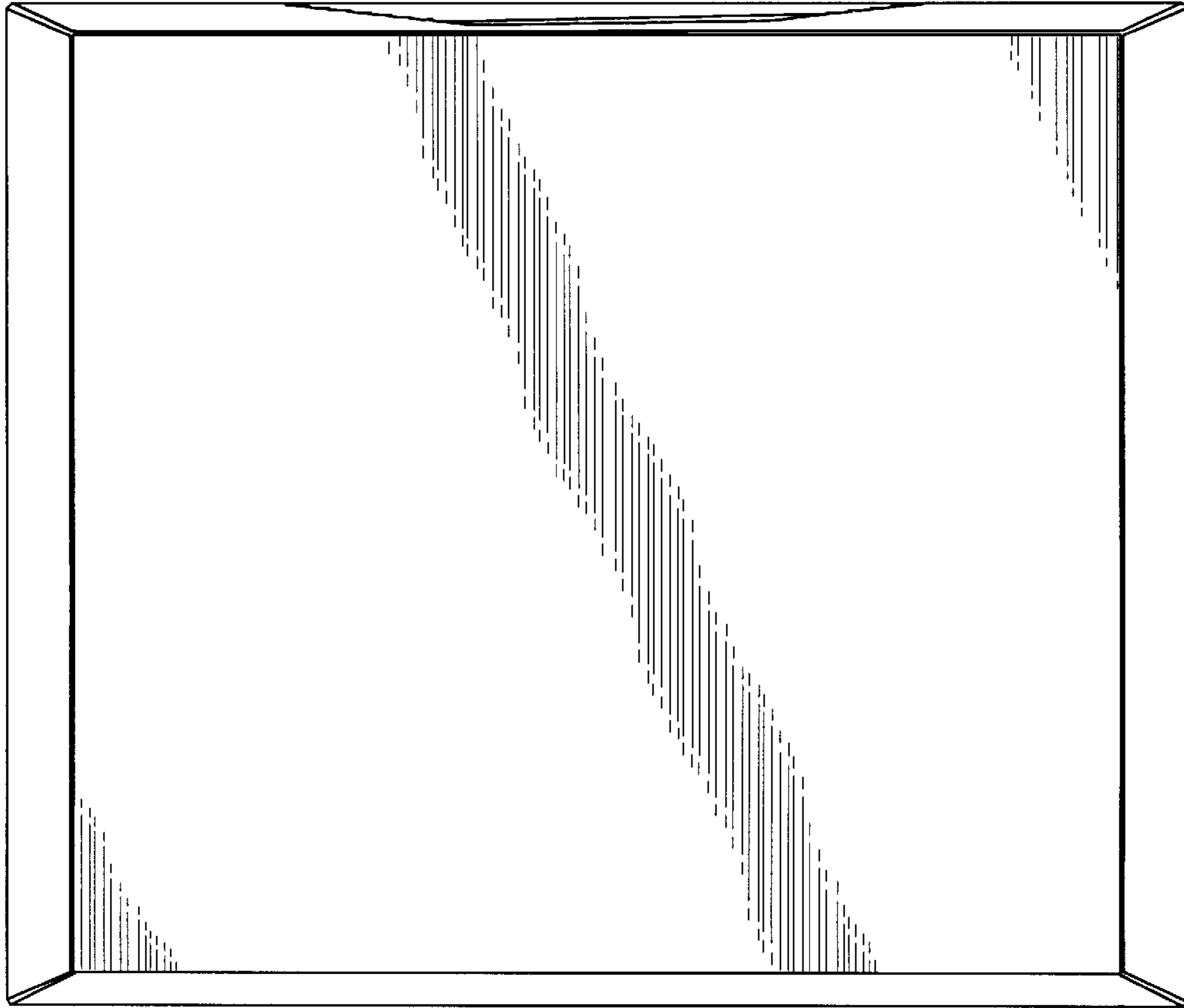

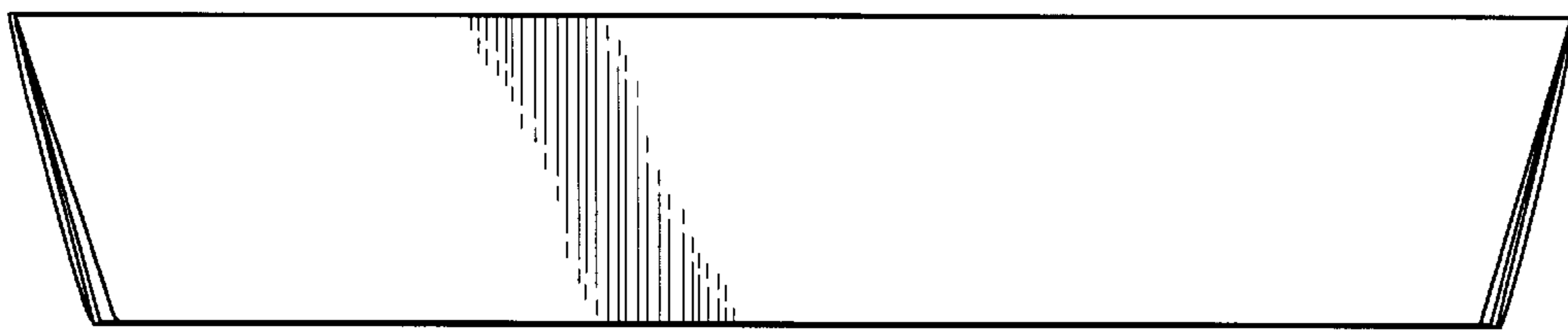
