FIG. 1 is a front view of the container of the present invention;

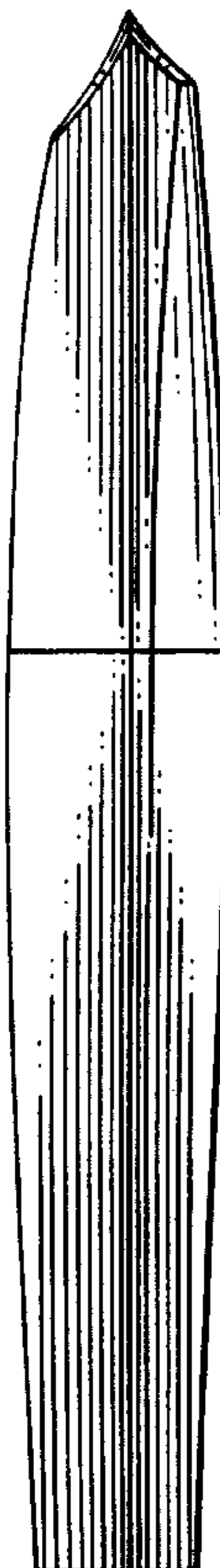
FIG. 2 is a side view of the container of the present invention;

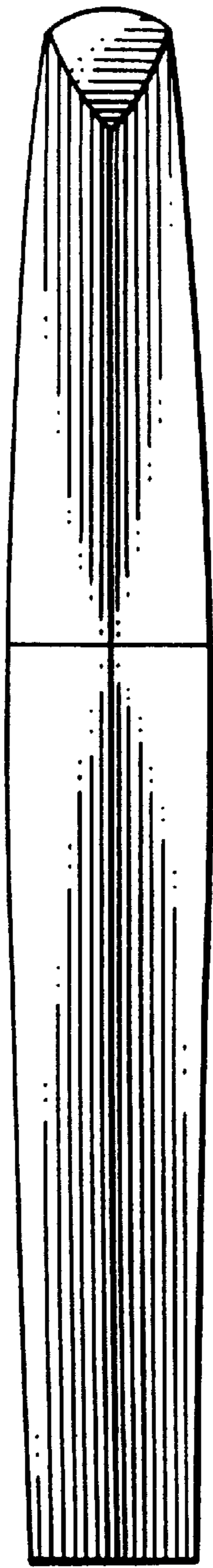

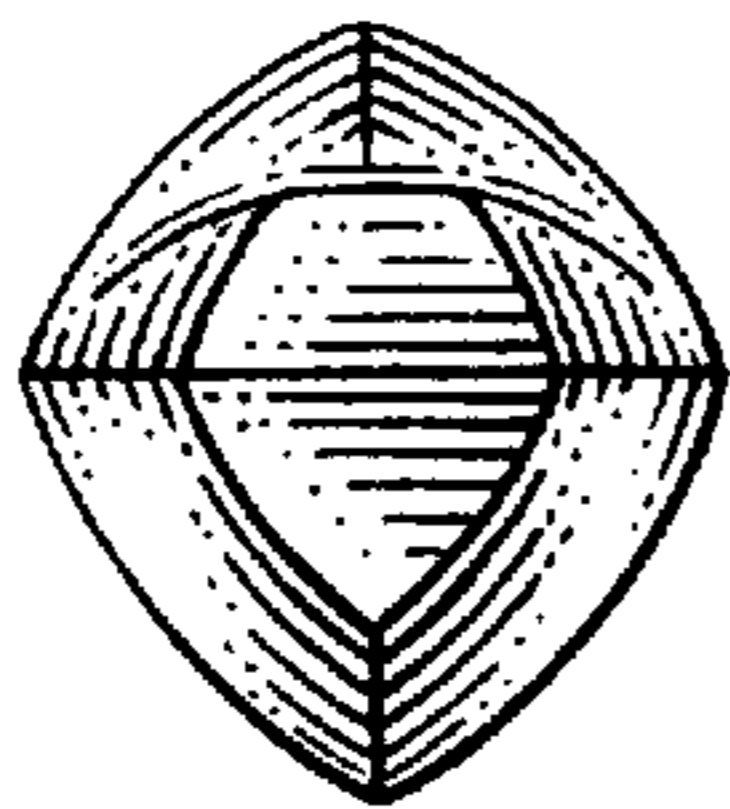

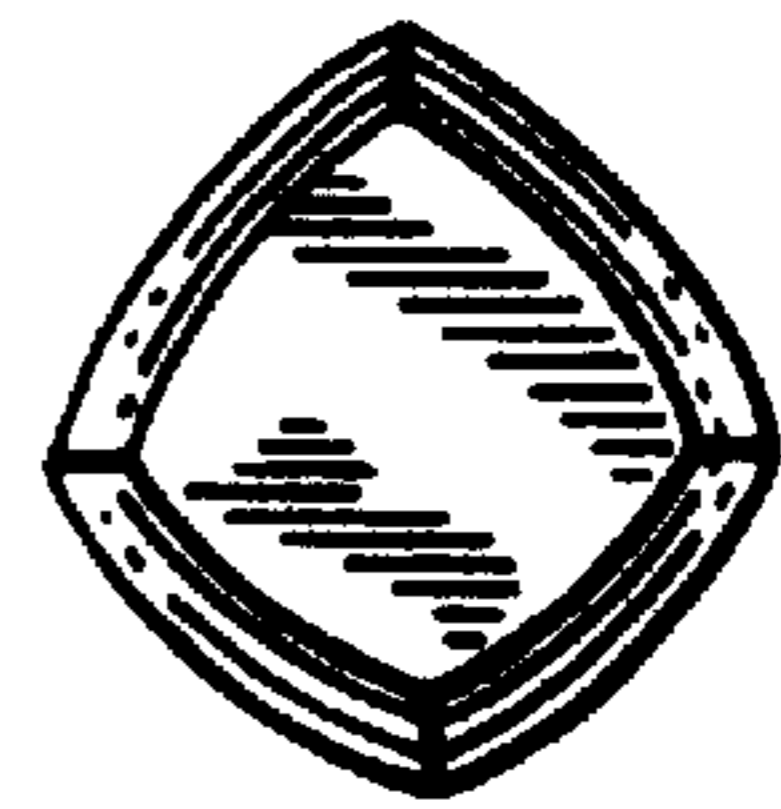
