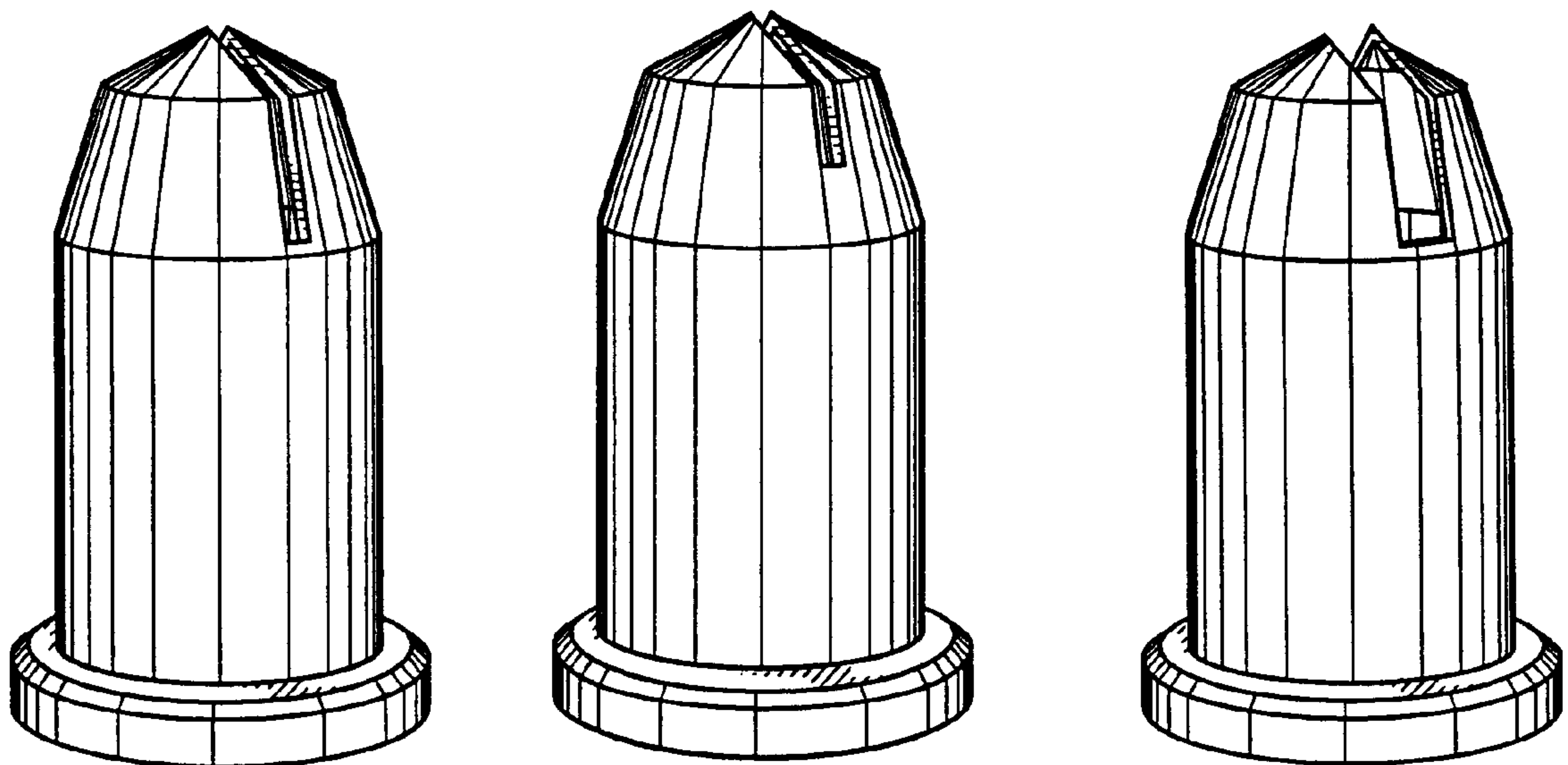
(57) **CLAIM**

The ornamental design for a spray nozzle, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a spray nozzle showing the new design;
 FIG. 2 is a side view of the spray nozzle of FIG. 1;
 FIG. 3 is another side view of the spray nozzle of FIG. 1, rotated 90 degrees from FIG. 2;
 FIG. 4 is a top view of the spray nozzle of FIG. 1;
 FIG. 5 is a bottom view of the spray nozzle of FIG. 1;
 FIG. 6 is a perspective view of a second embodiment showing a spray nozzle of the new design;
 FIG. 7 is a side view of the spray nozzle of FIG. 6;
 FIG. 8 is another side view of the spray nozzle of FIG. 6, rotated 90 degrees from FIG. 7;
 FIG. 9 is a top view of the spray nozzle of FIG. 6;
 FIG. 10 is a bottom view of the spray nozzle of FIG. 6;

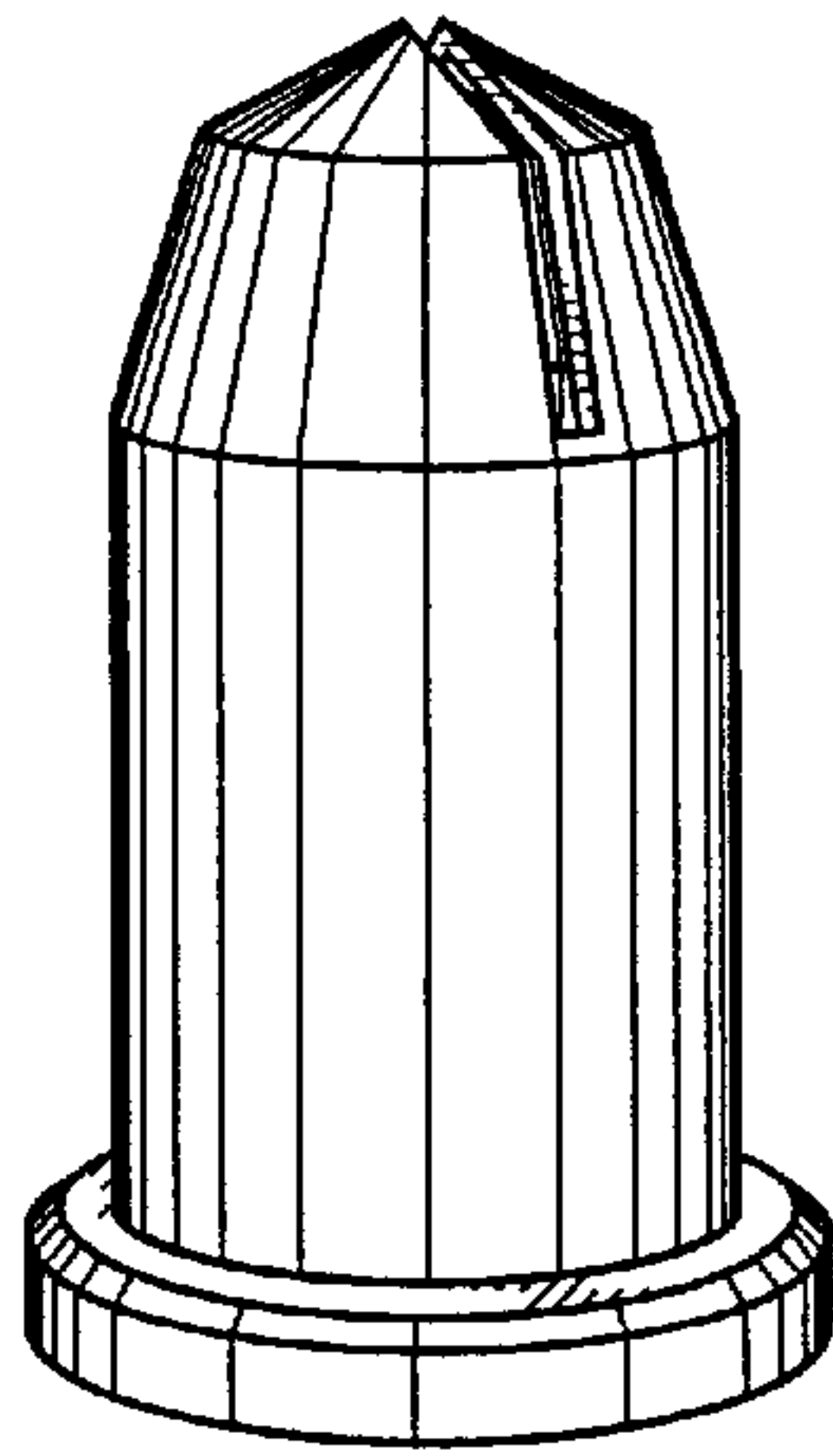

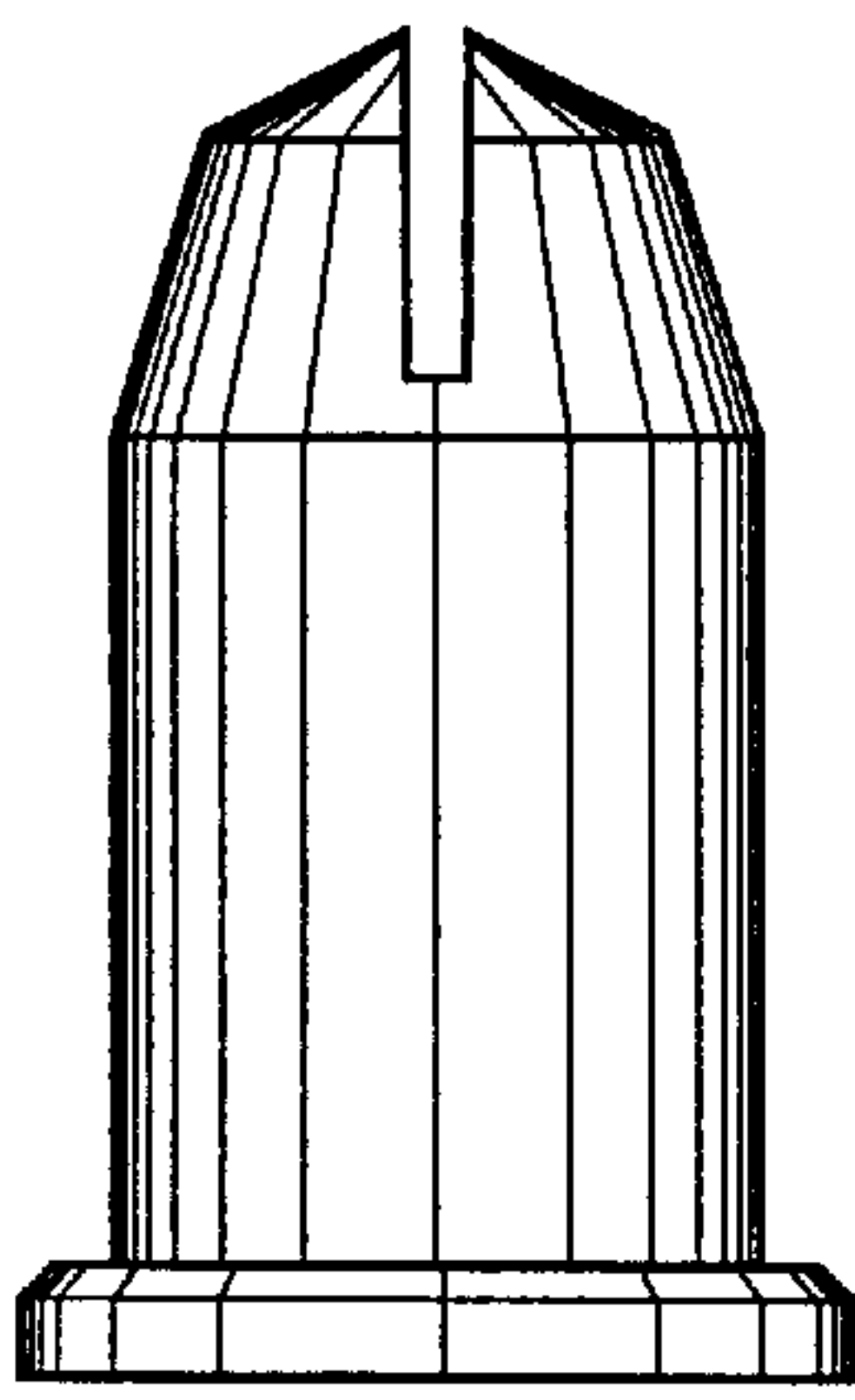

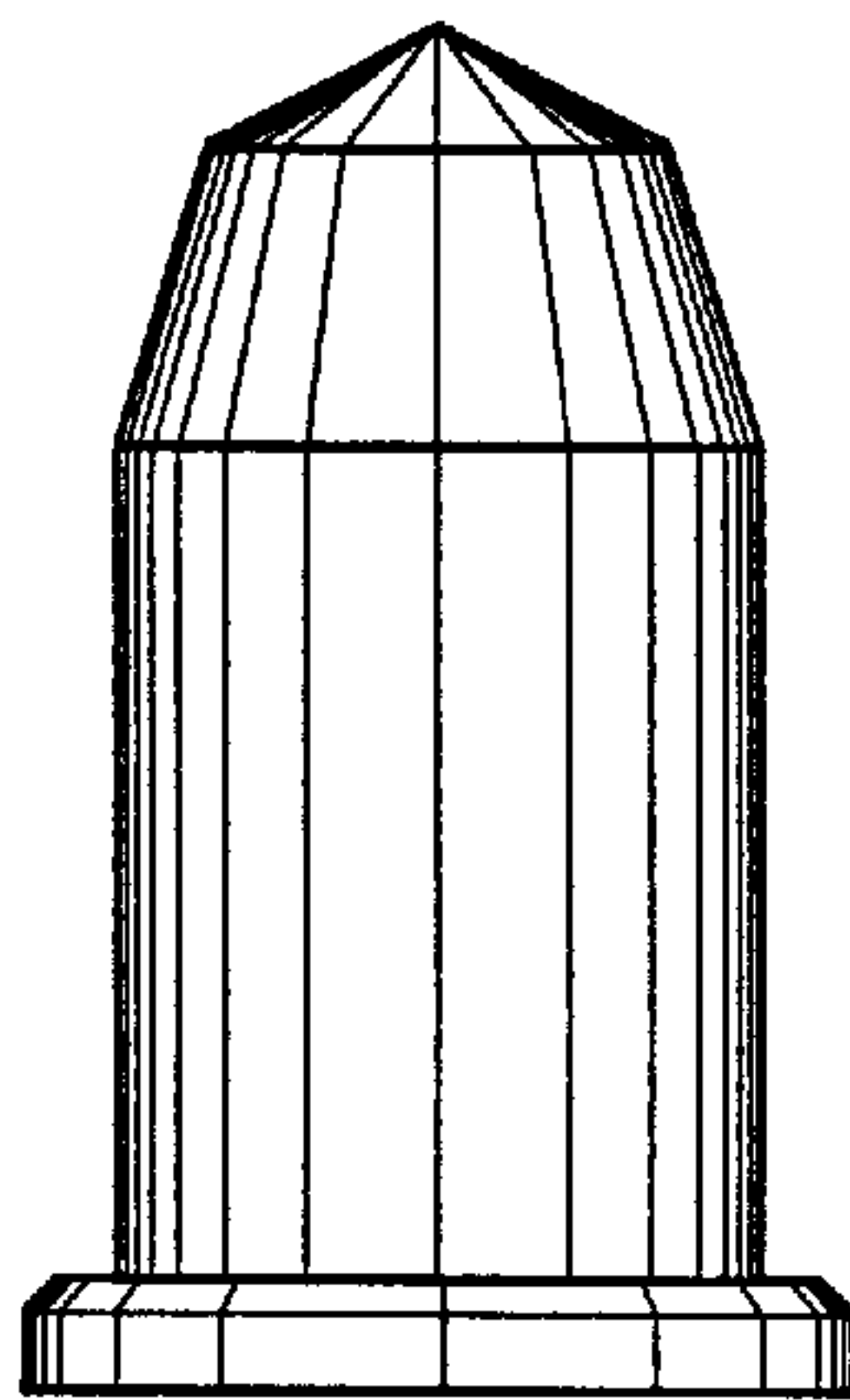

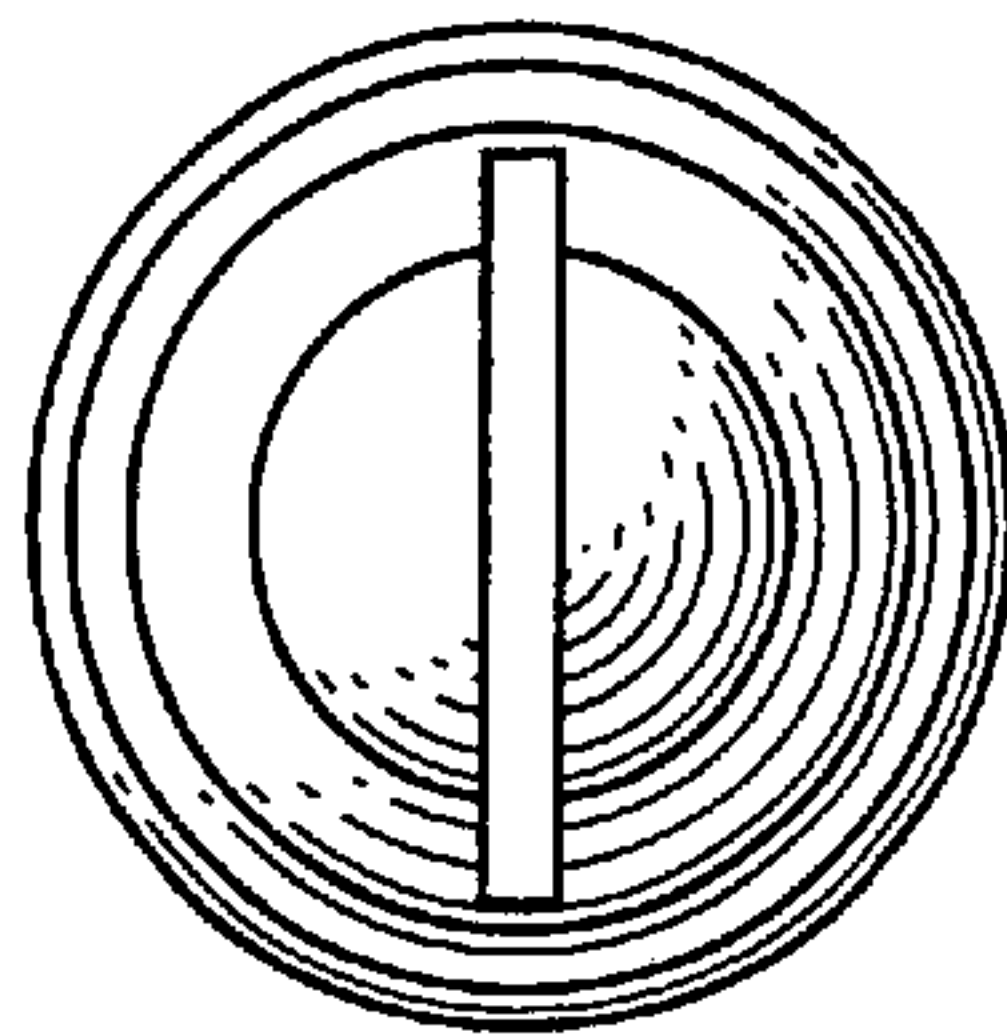

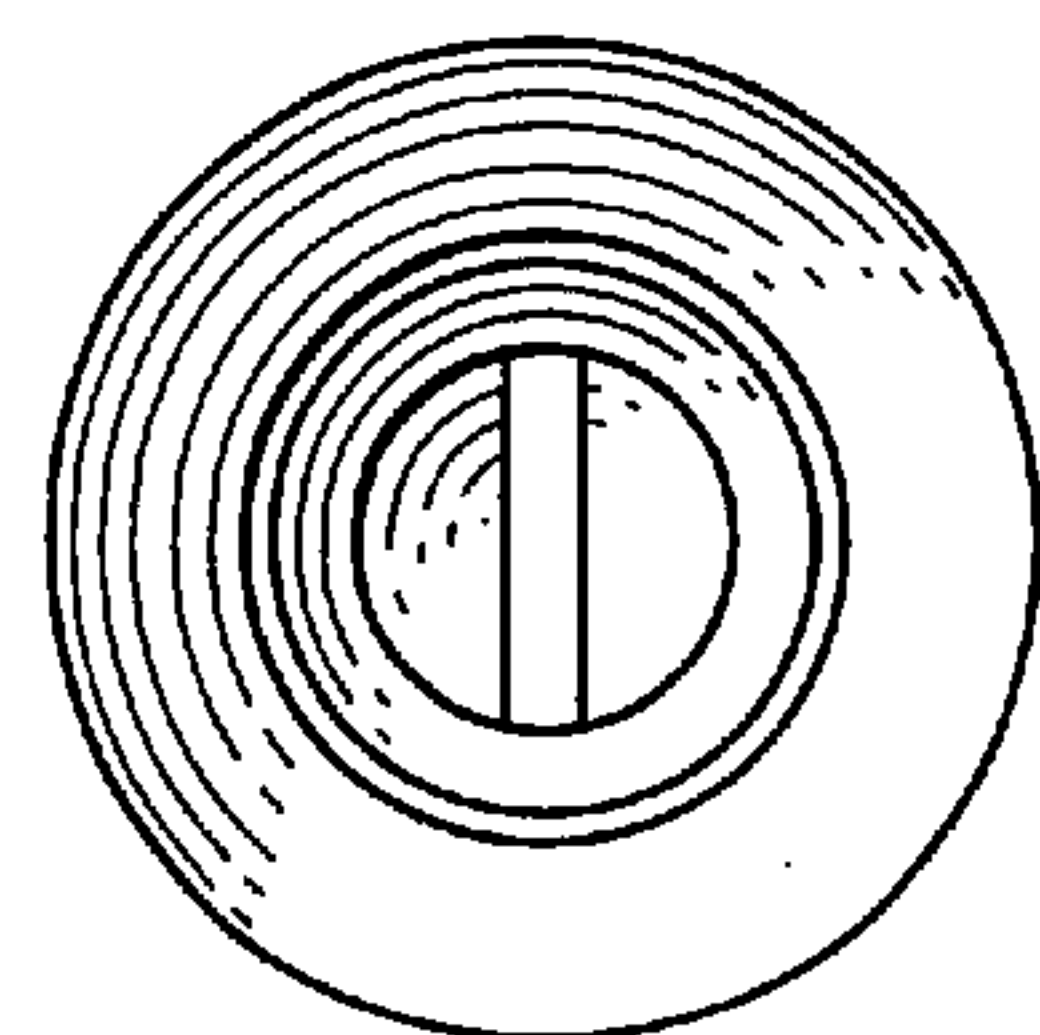

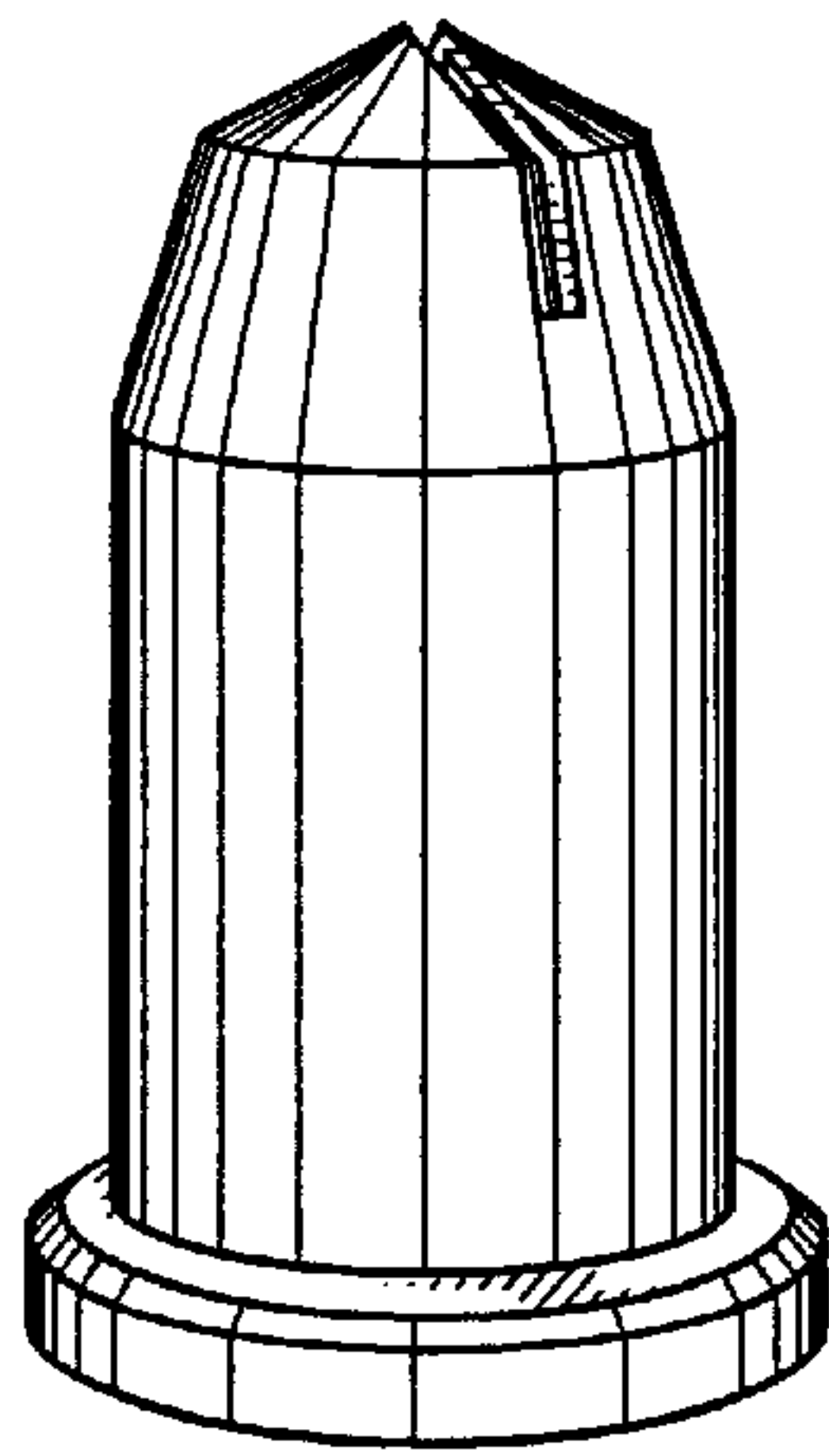

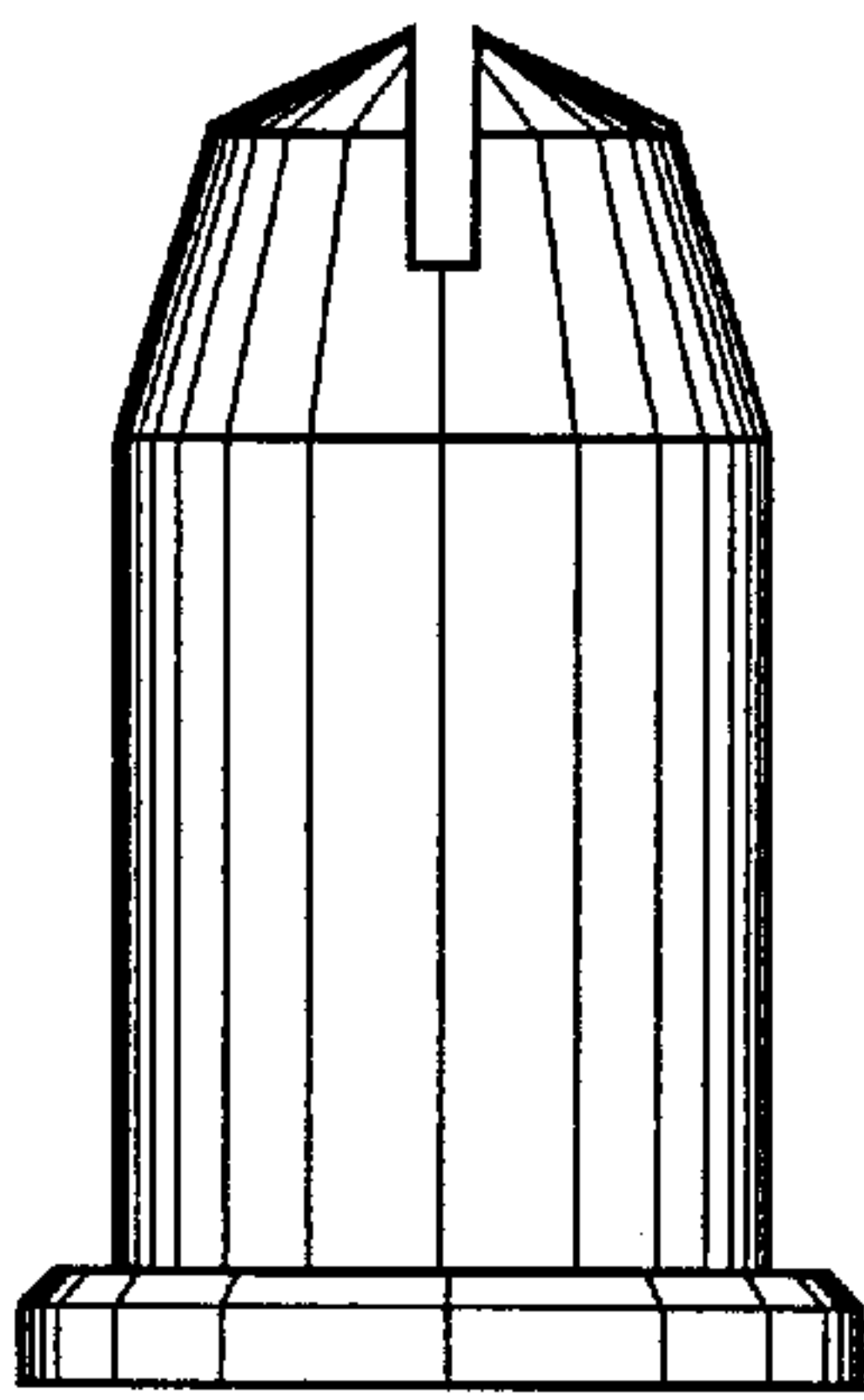

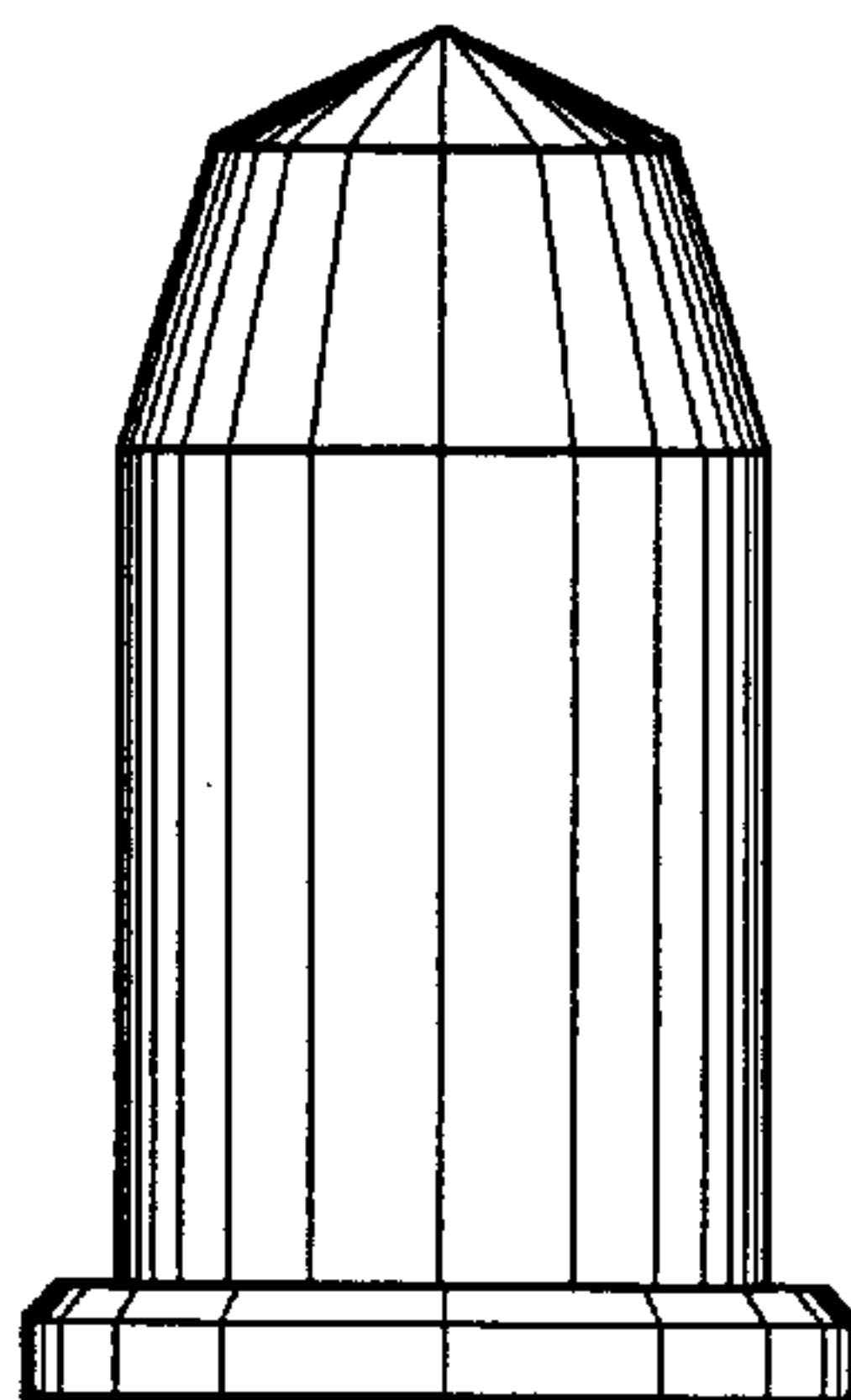

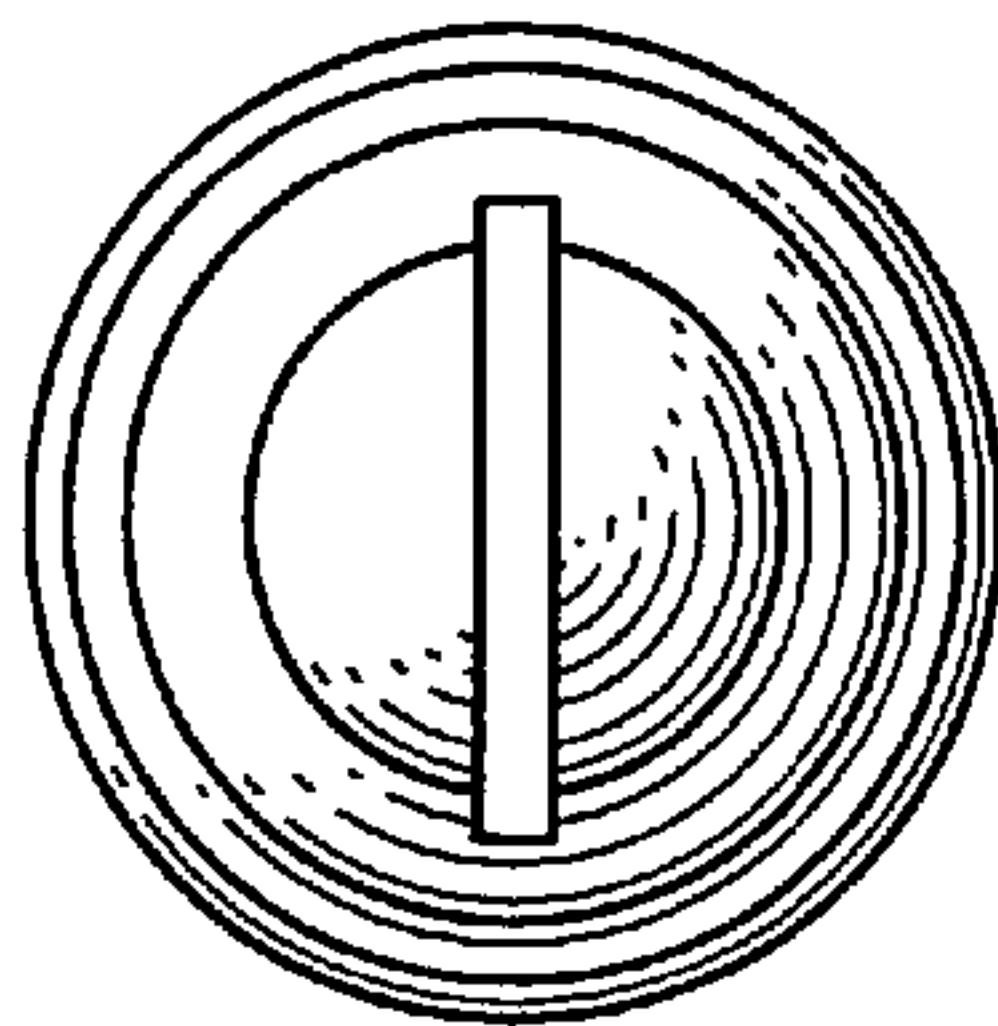

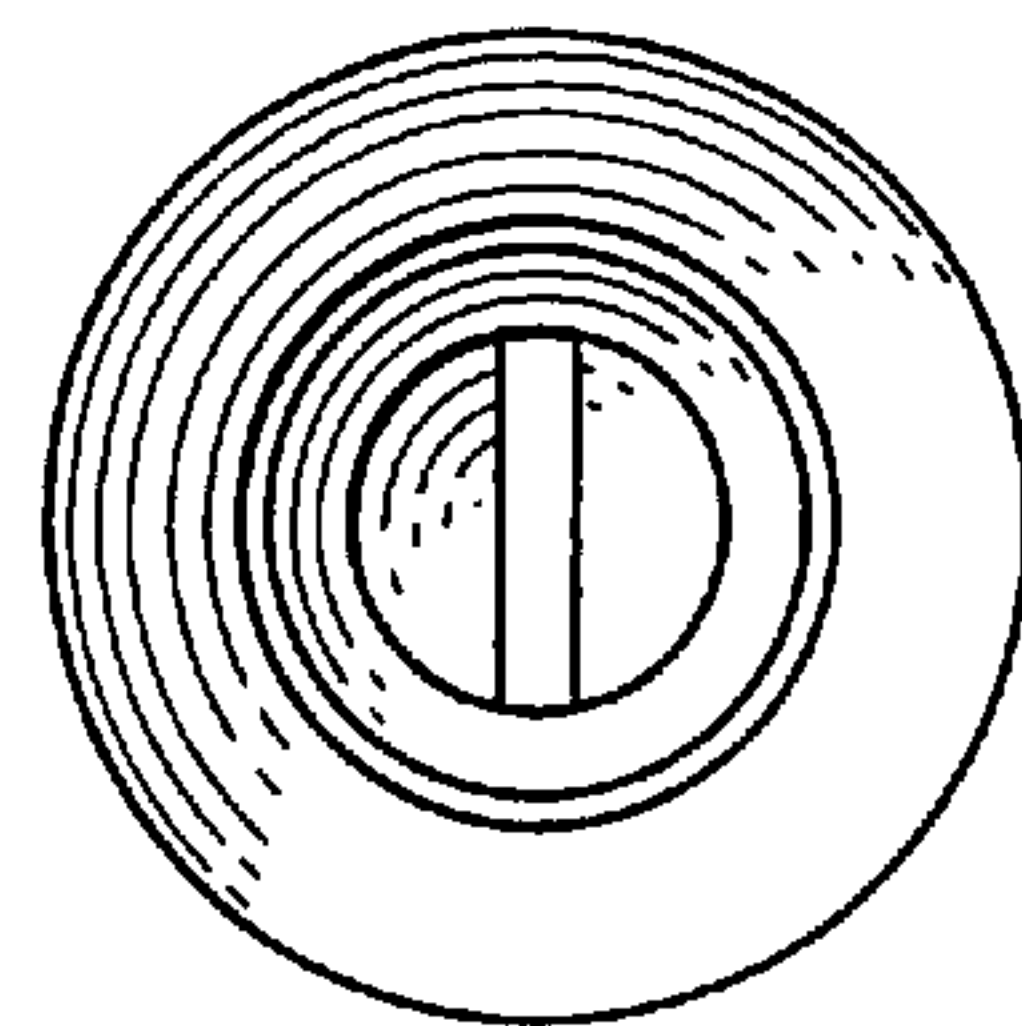

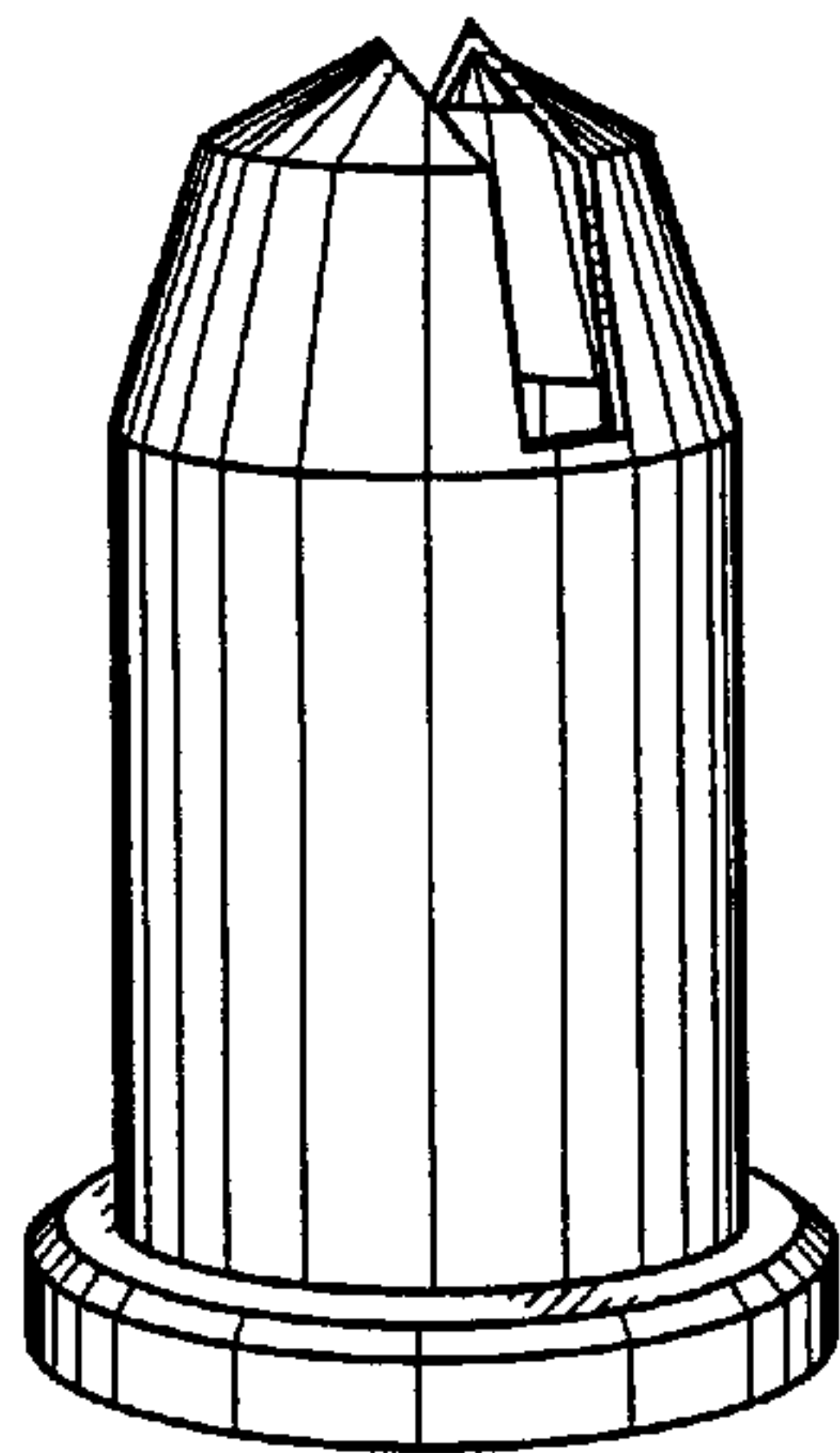

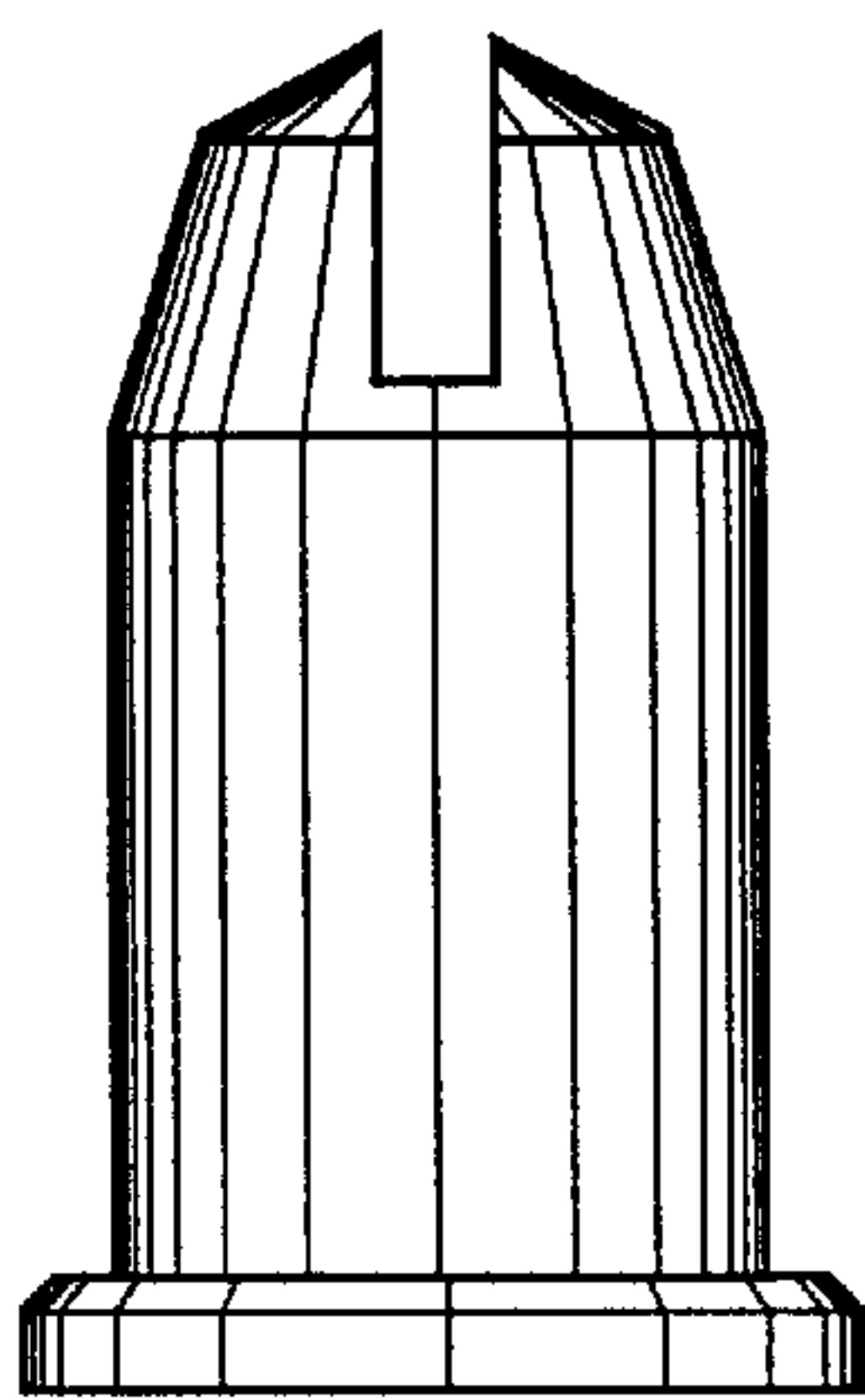

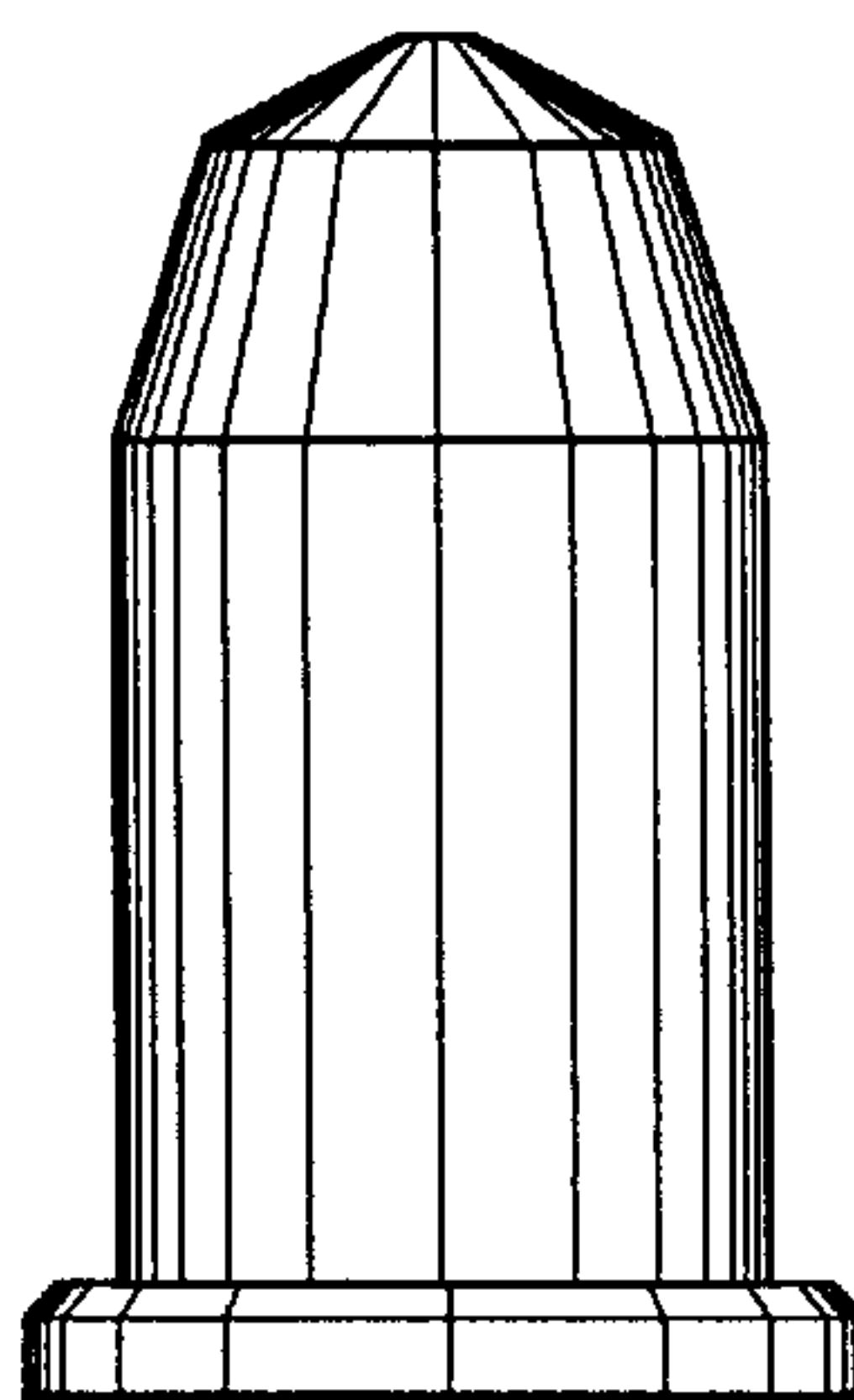

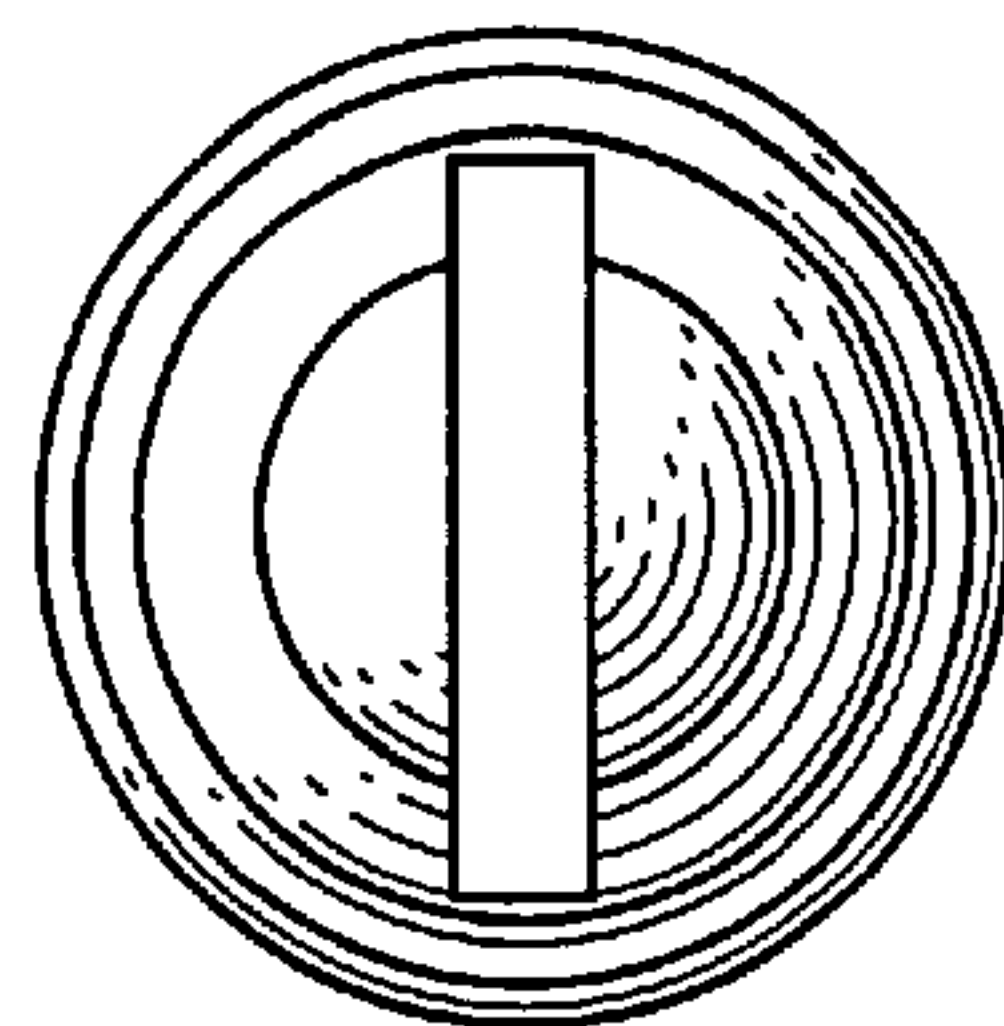

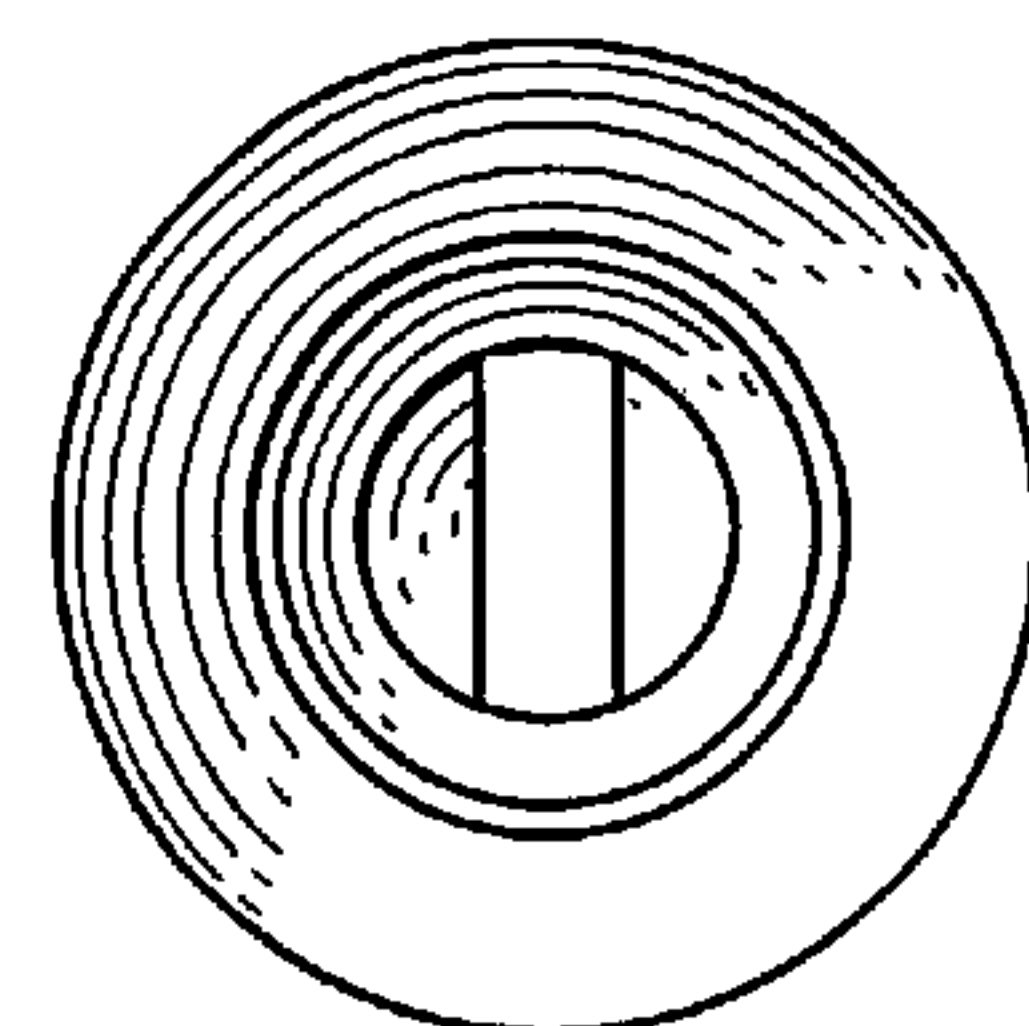

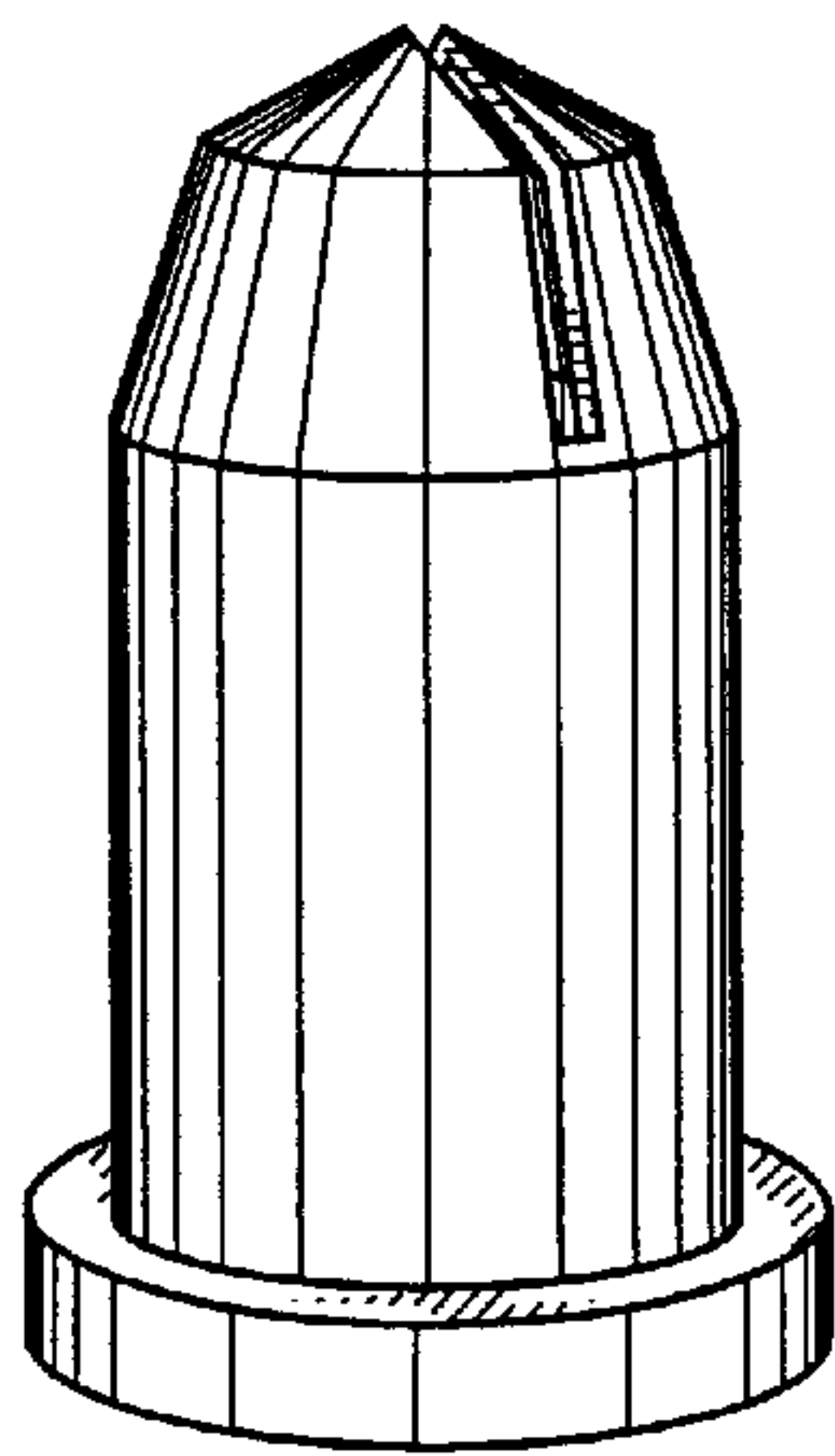

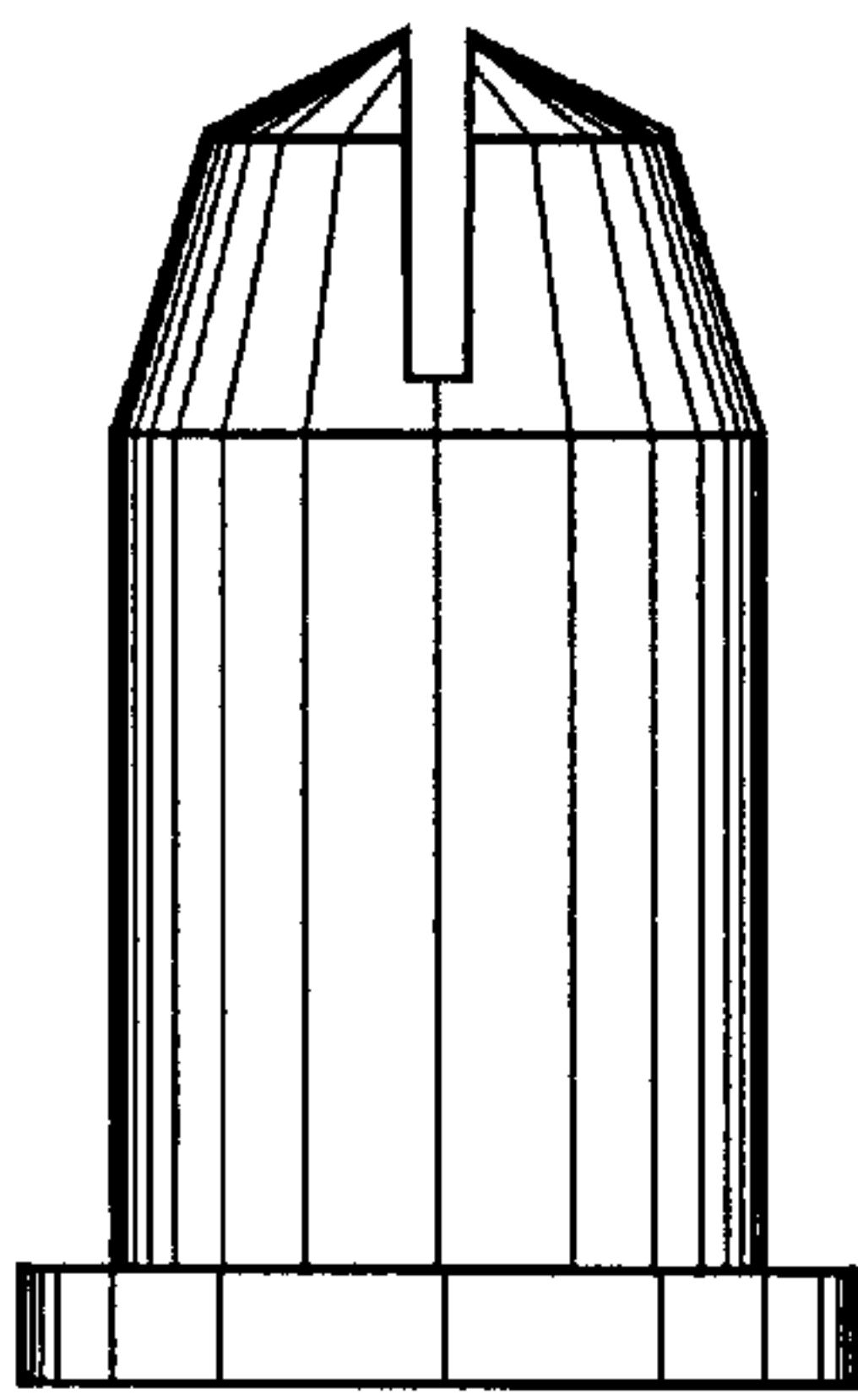

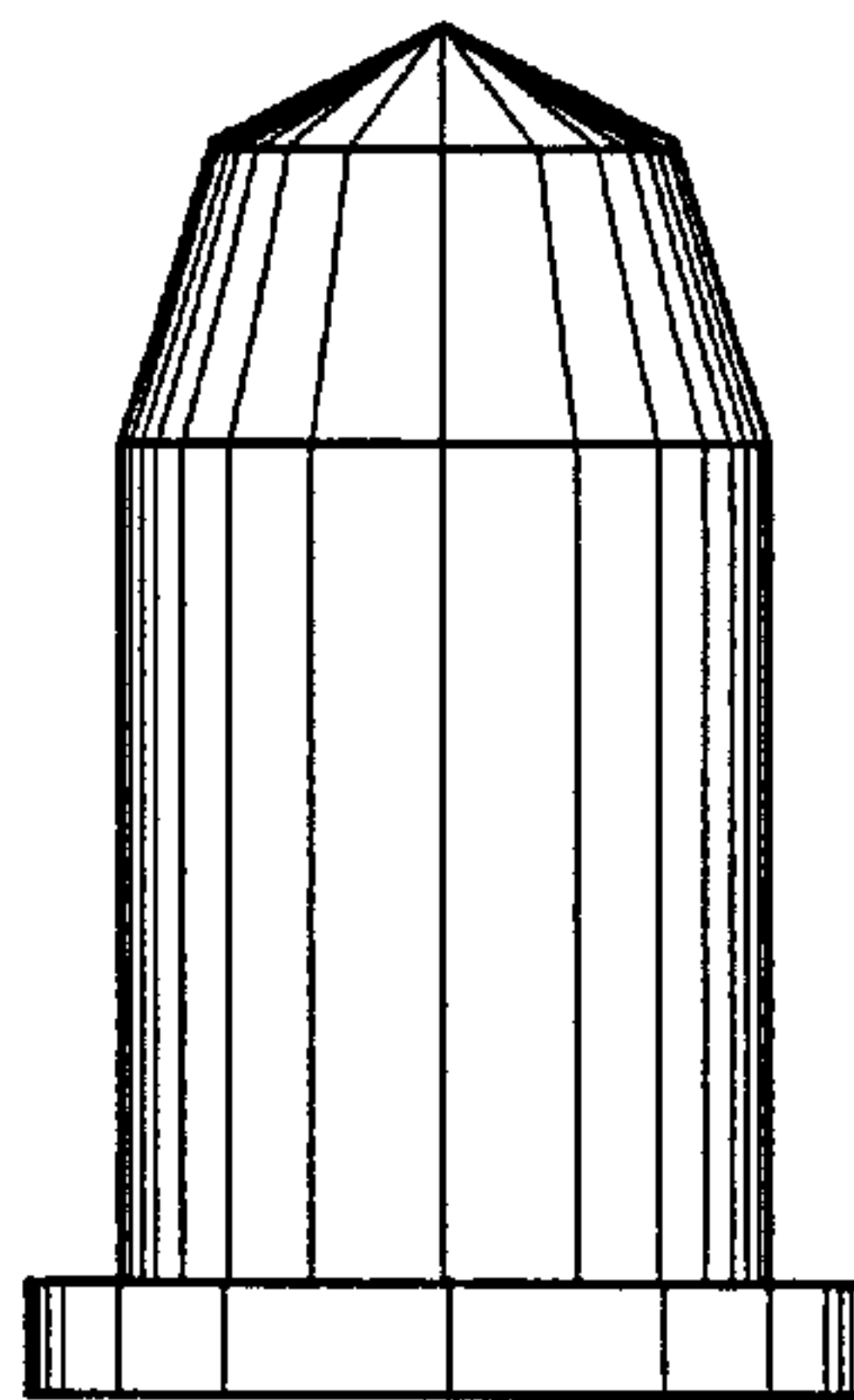

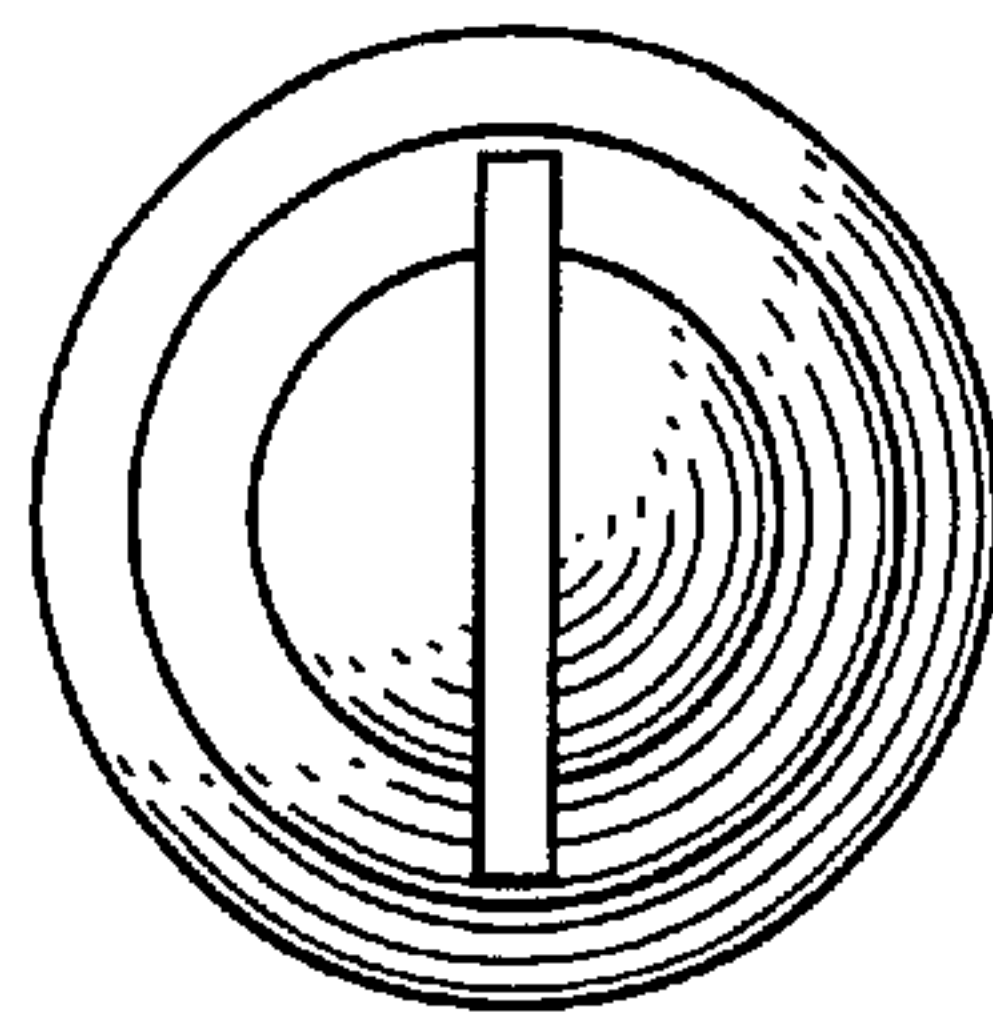

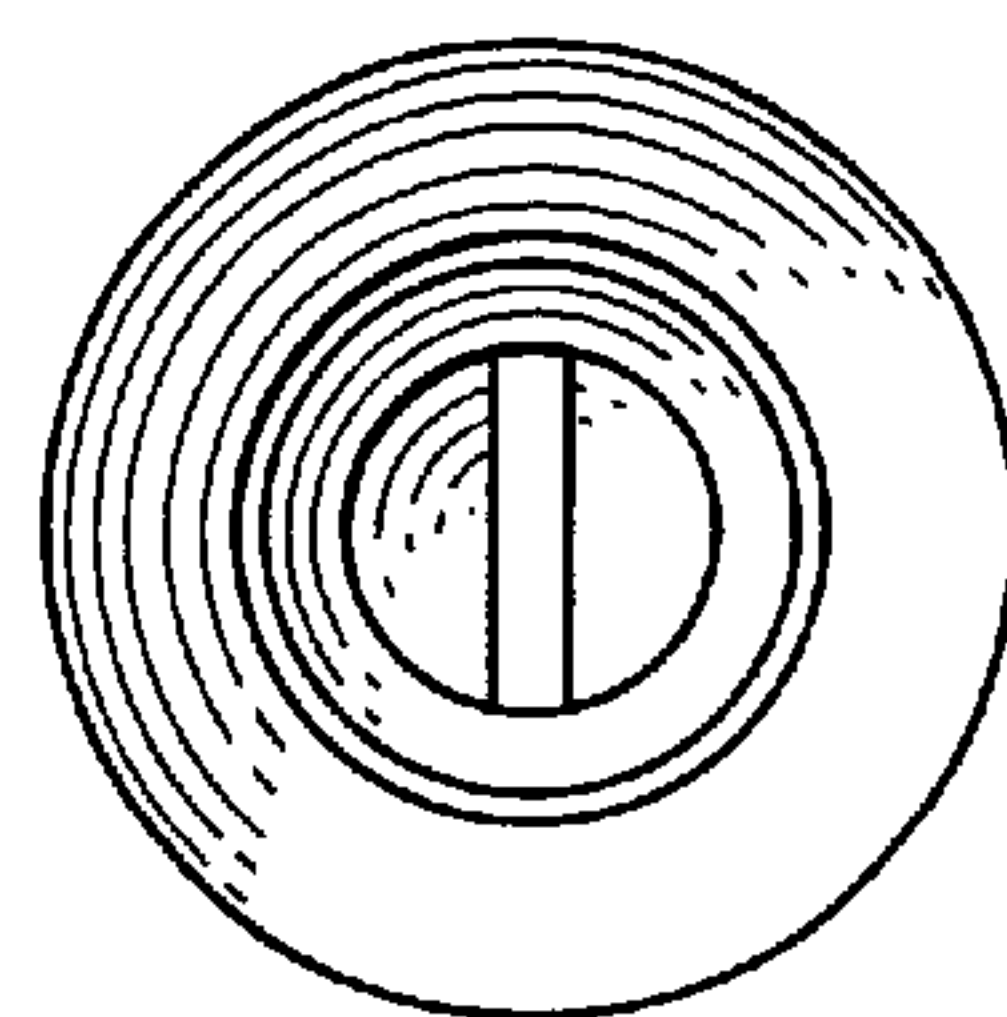
