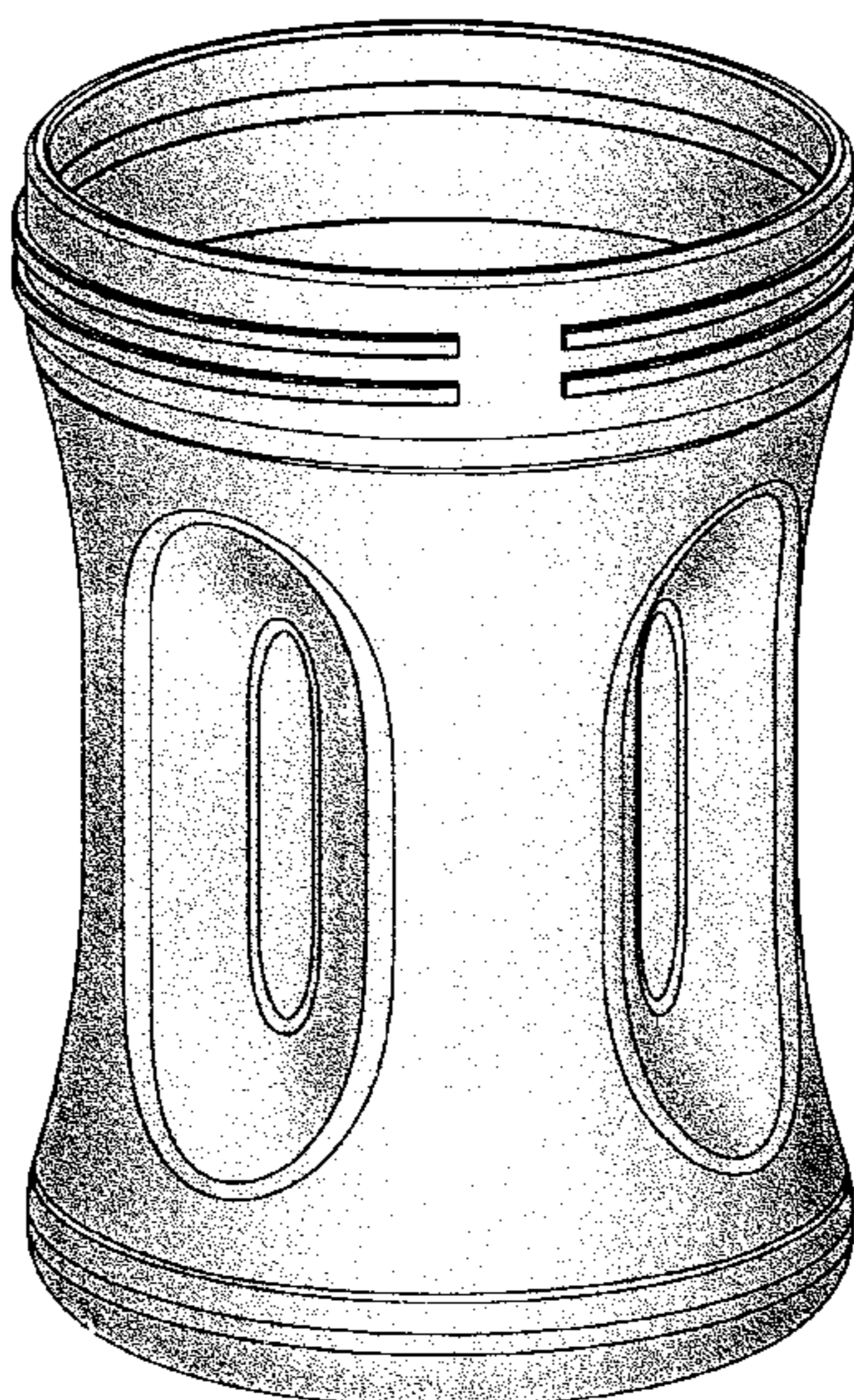
(57) **CLAIM**

The ornamental design for the container, as shown and described in the accompanying figures.

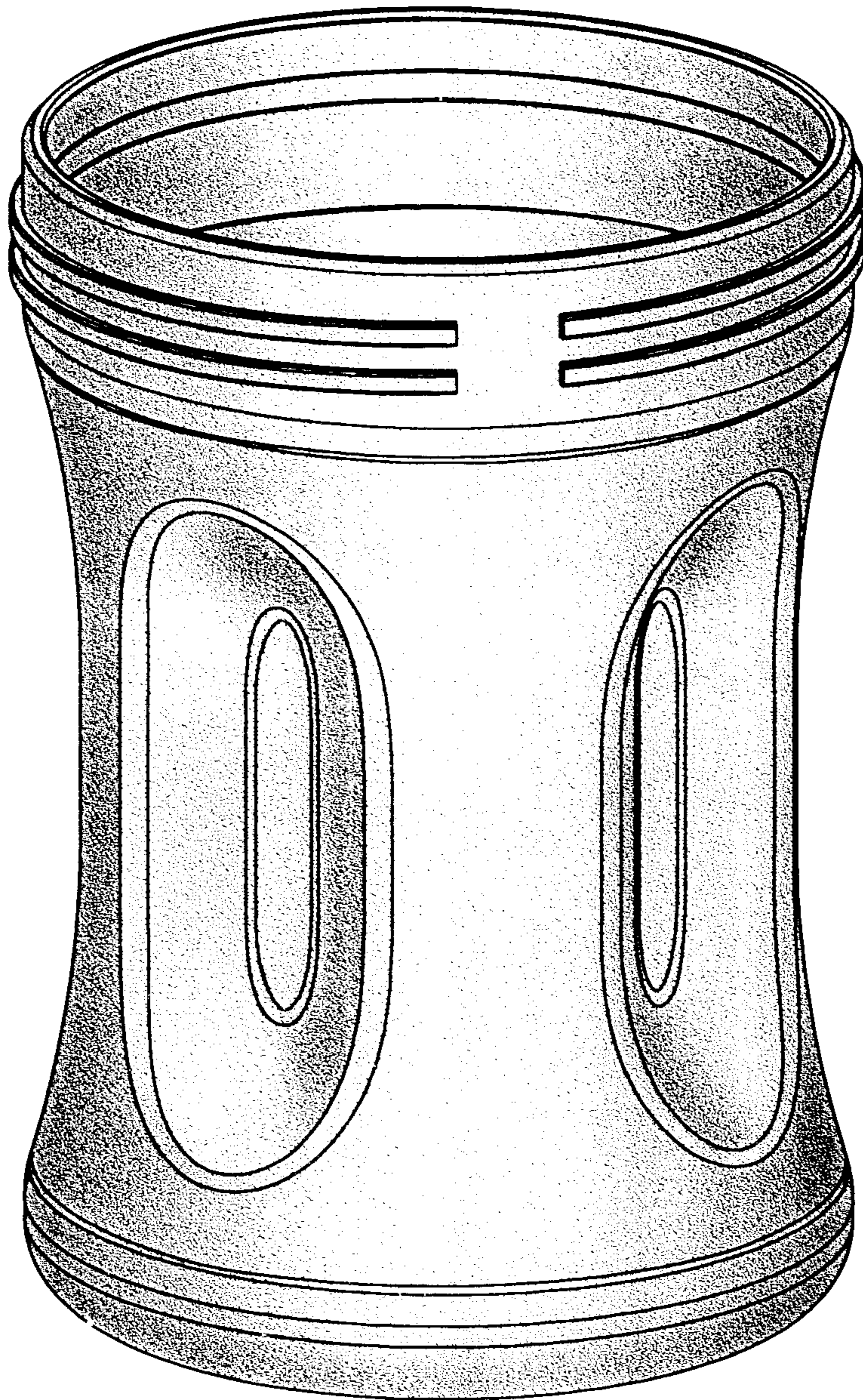
**DESCRIPTION**

FIG. 1 is a top front perspective view of the container;  
 FIG. 2 is a bottom rear perspective view of the container of FIG. 1;  
 FIG. 3 is a left side view of the container of FIG. 1;  
 FIG. 4 is a further left side view showing one grip of the container of FIG. 1;  
 FIG. 5 is a bottom view of the container of FIG. 1;  
 FIG. 6 is a top view of the container of FIG. 1;  
 FIG. 7 is a side view, of the container of FIG. 1 with a lid thereon, the lid forming no part of the design; and,  
 FIG. 8 is a top side perspective view, of the container of FIG. 1 with a lid thereon, the lid forming no part of the design.  
 The broken lines are for illustrative purpose only and form no part of the design.

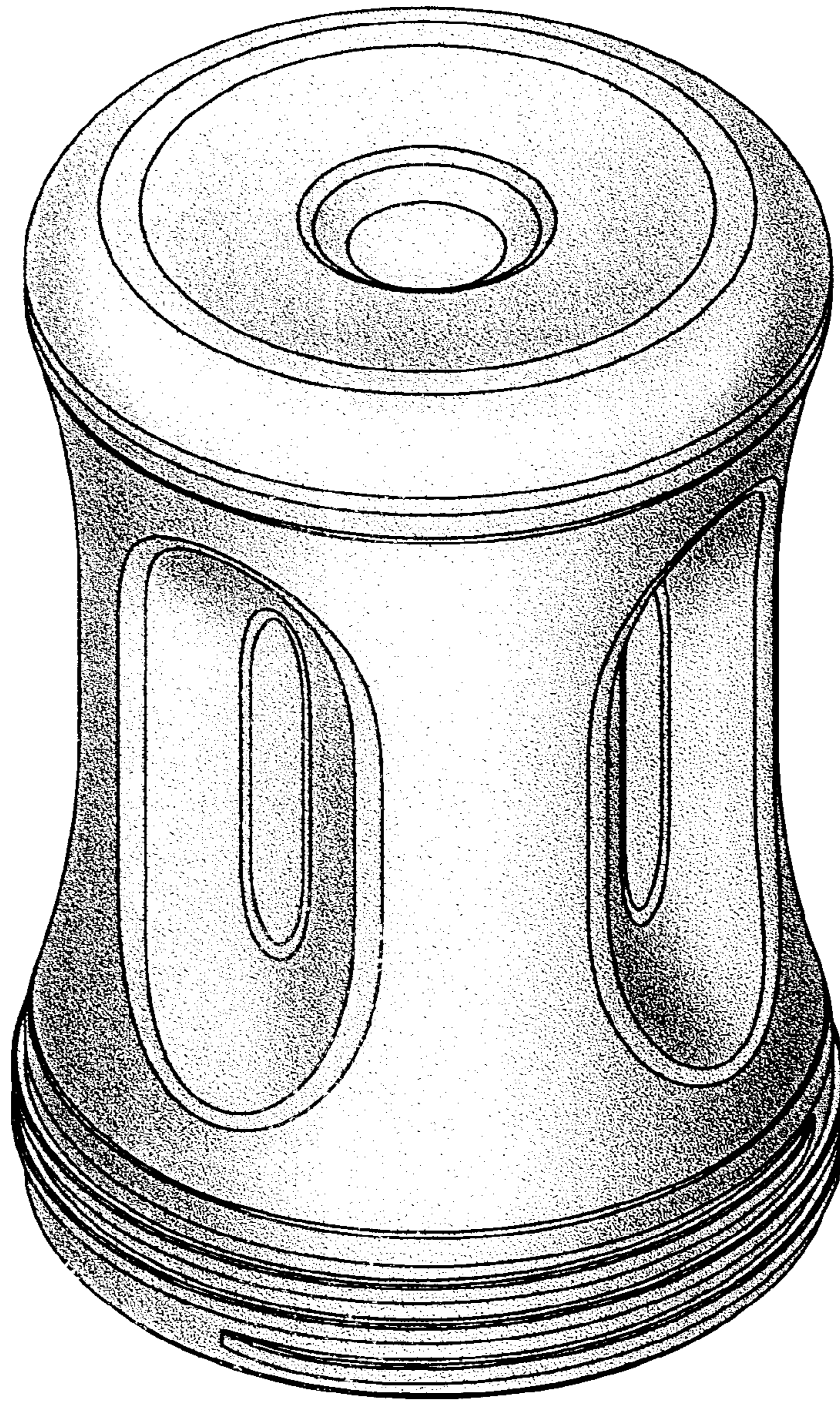






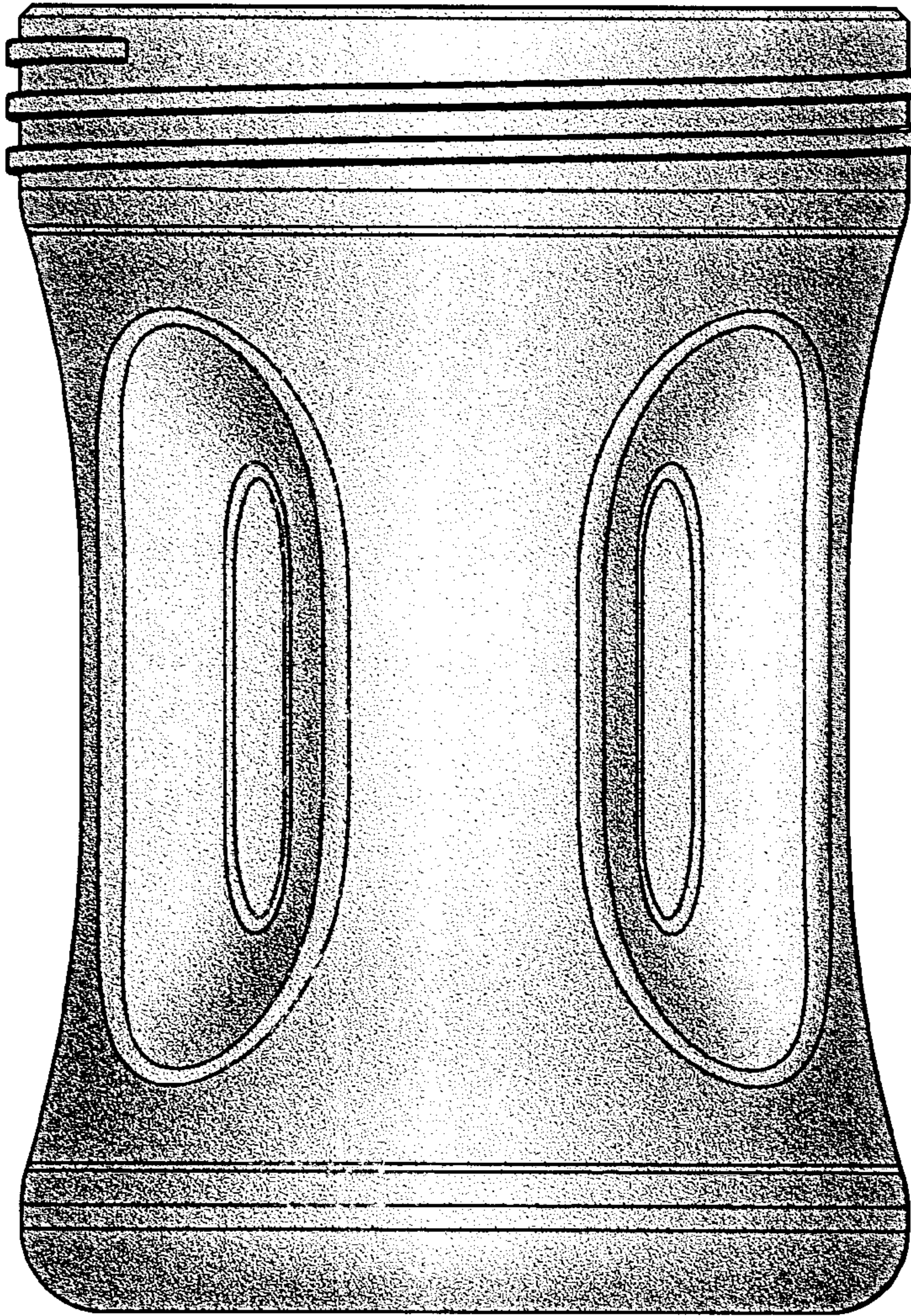

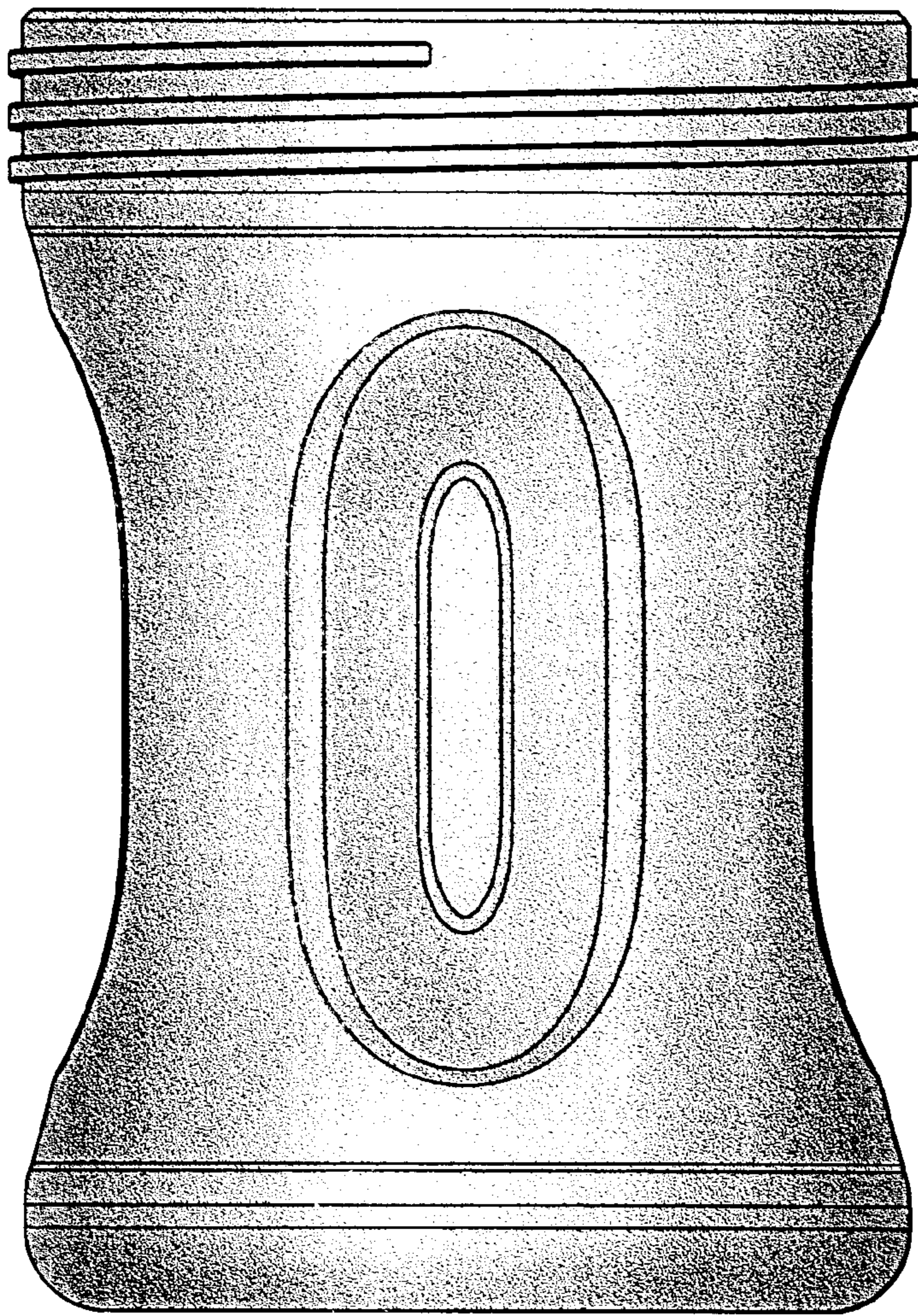

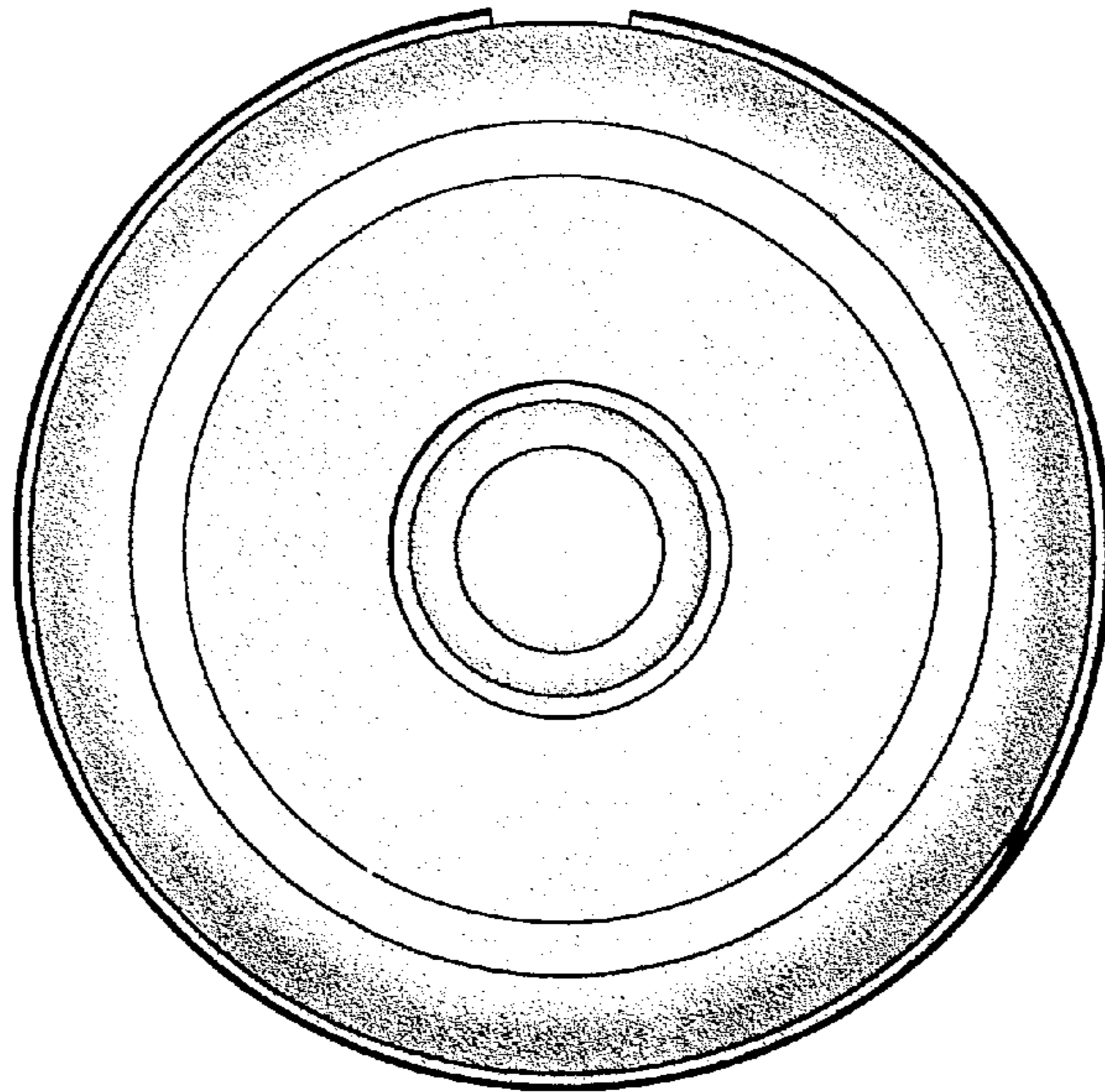

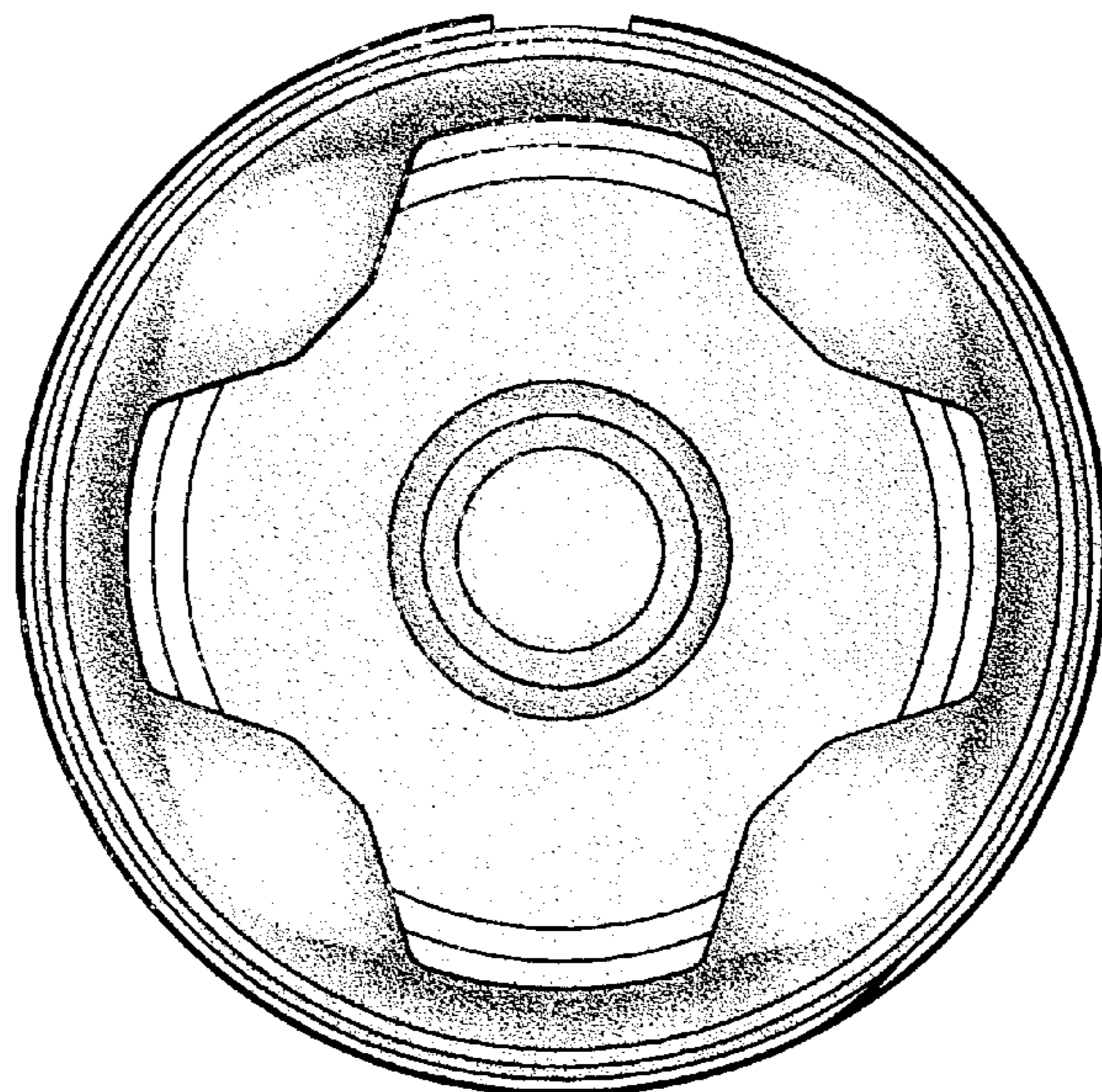

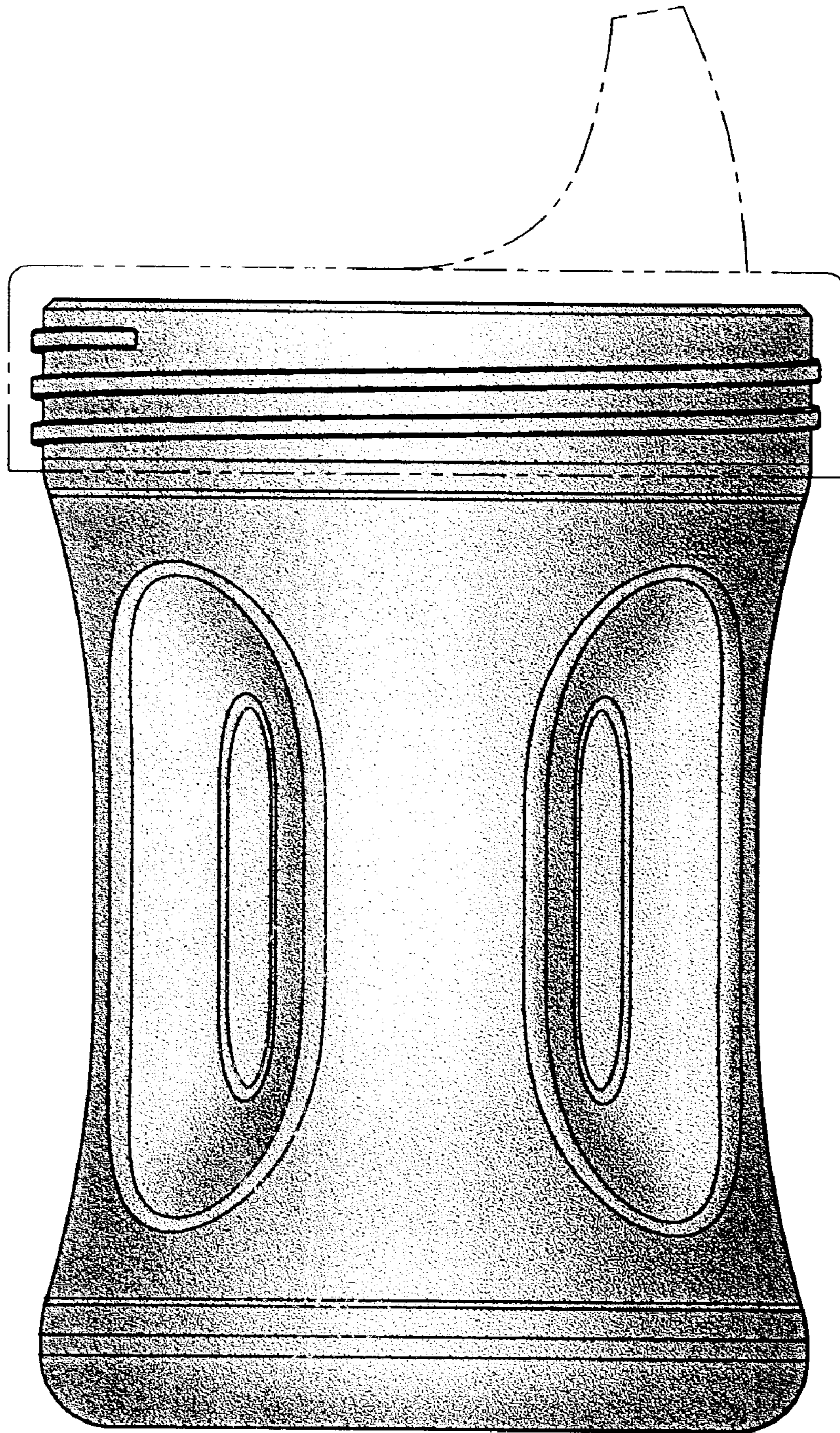

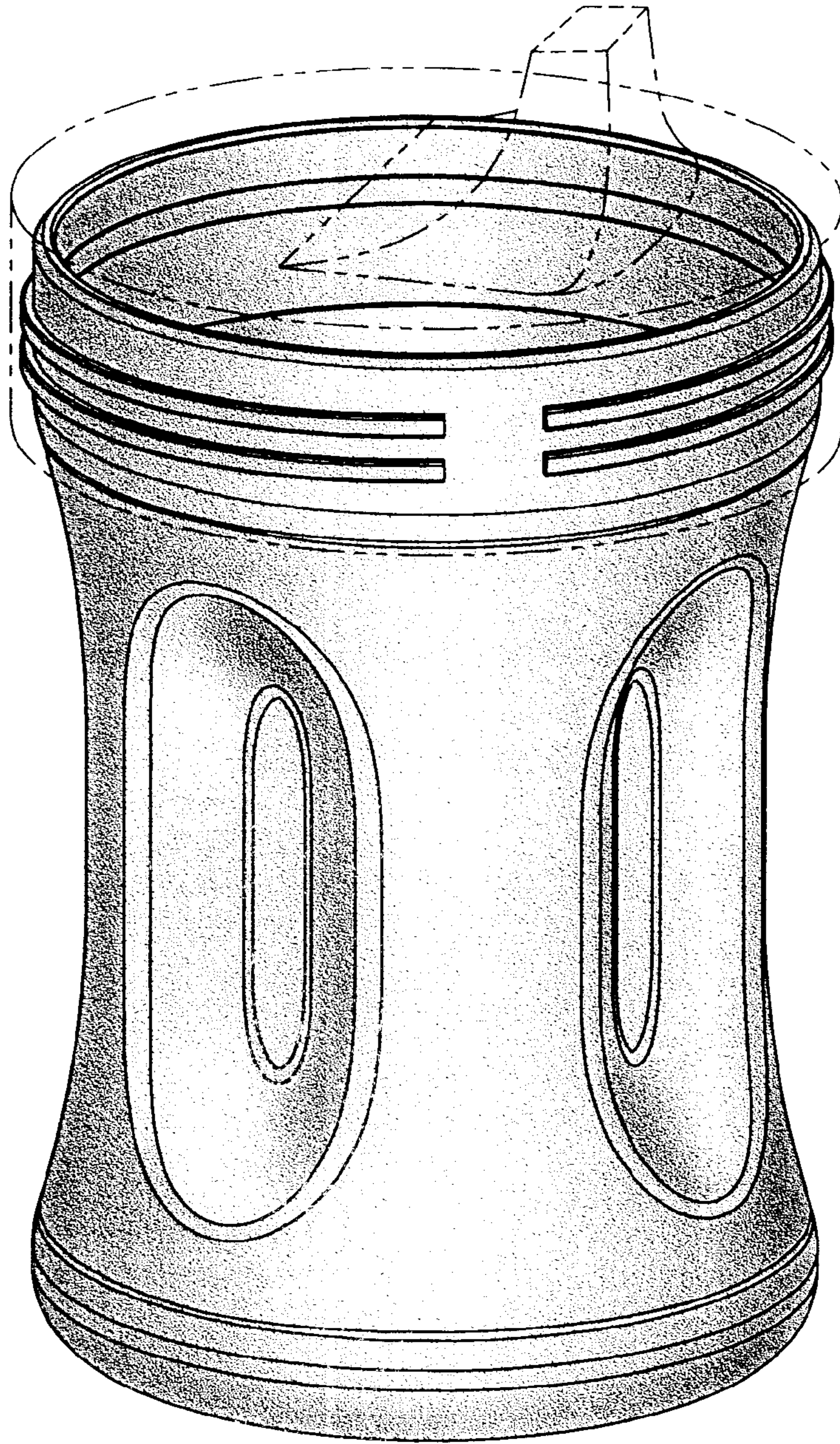
