(57) **CLAIM**

The ornamental design for a bottle, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of the bottle; FIG. 2 is a front elevational view thereof; FIG. 3 is a side elevational view thereof, the two sides being mirror images; and, FIG. 4 is a top plan view thereof. The broken lines showing in FIGS. 1, 2, 3, and 5 are for illustrative purposes only and form no part of the claimed design.

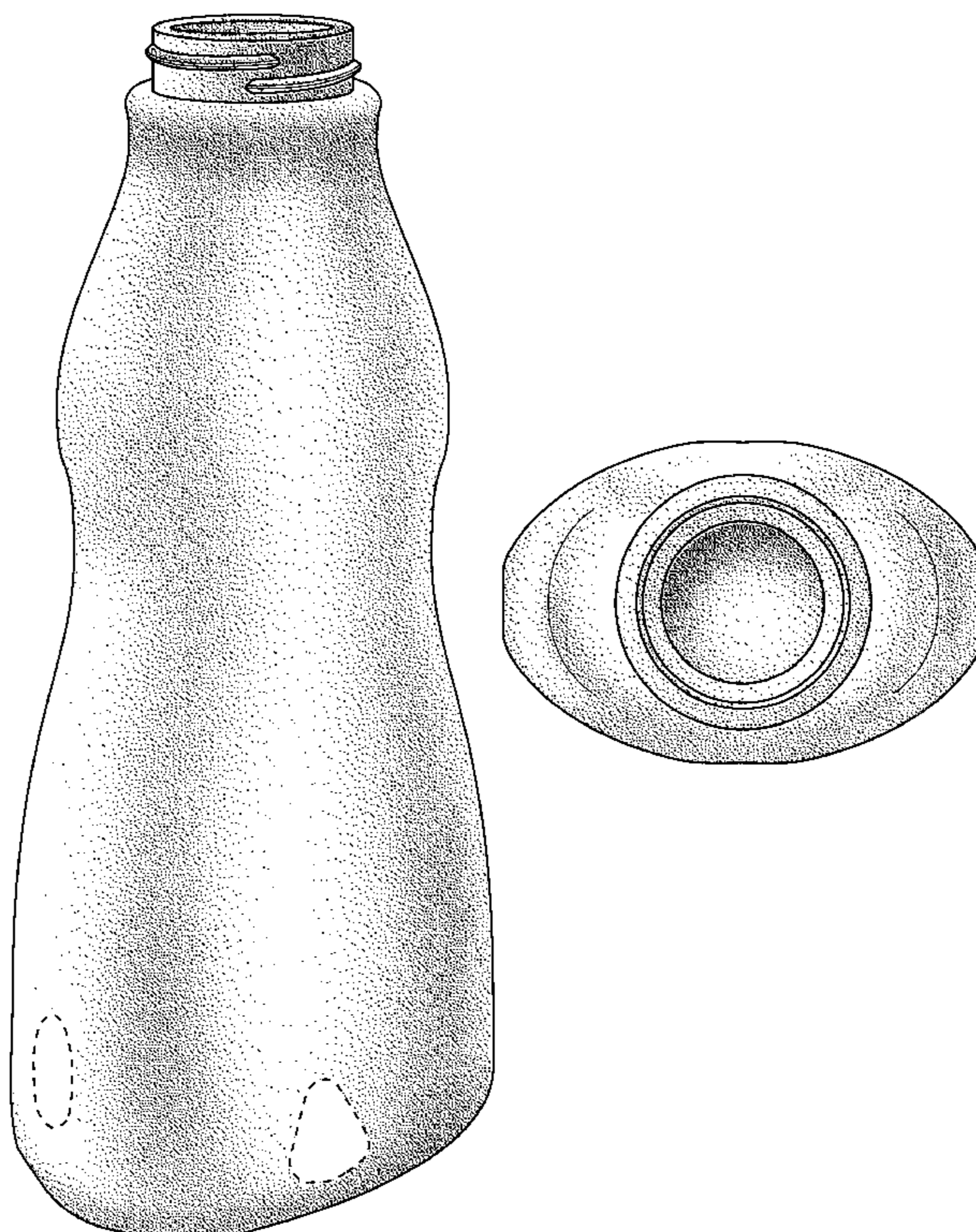

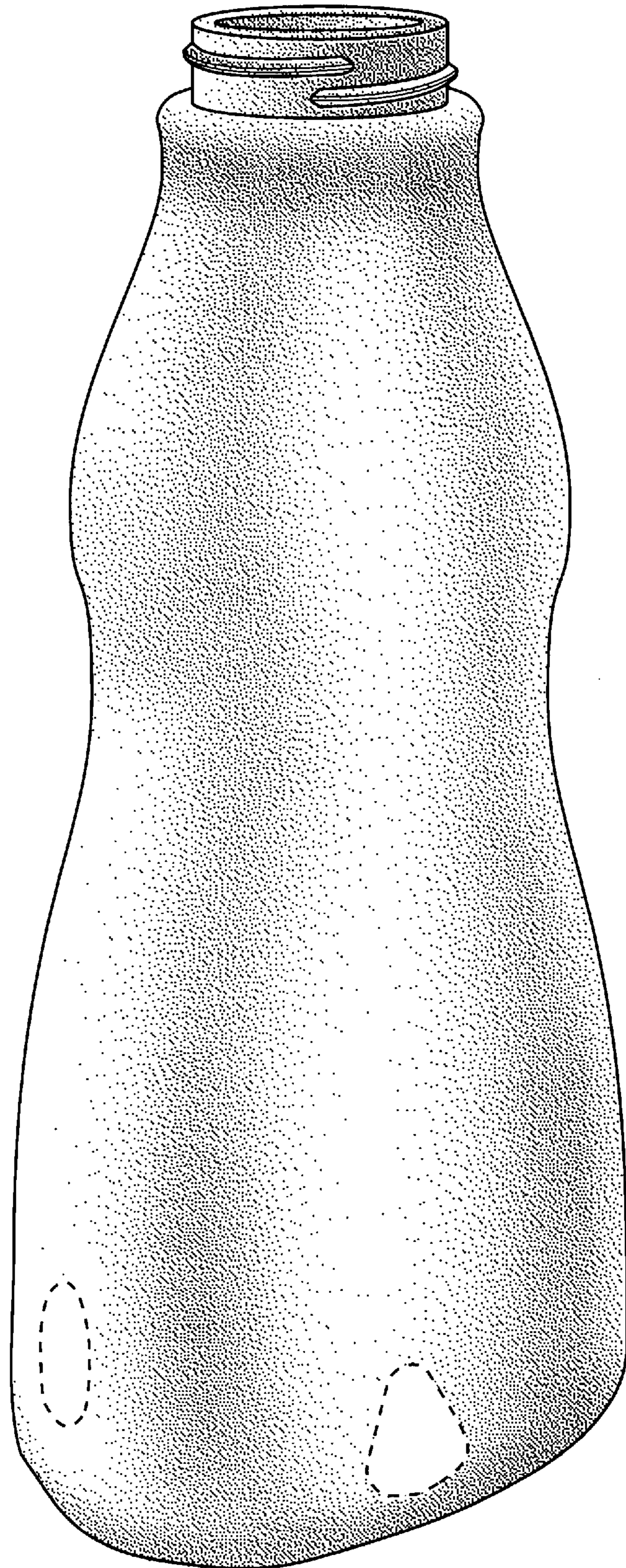

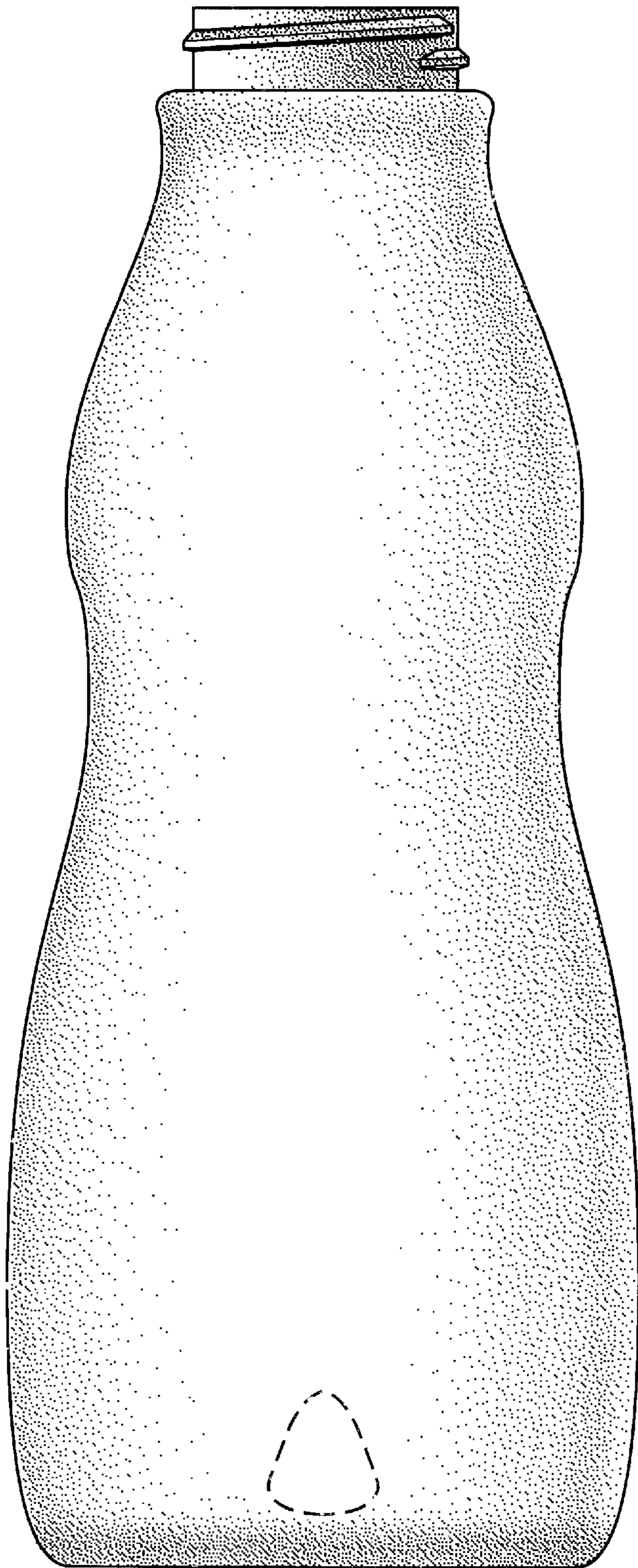
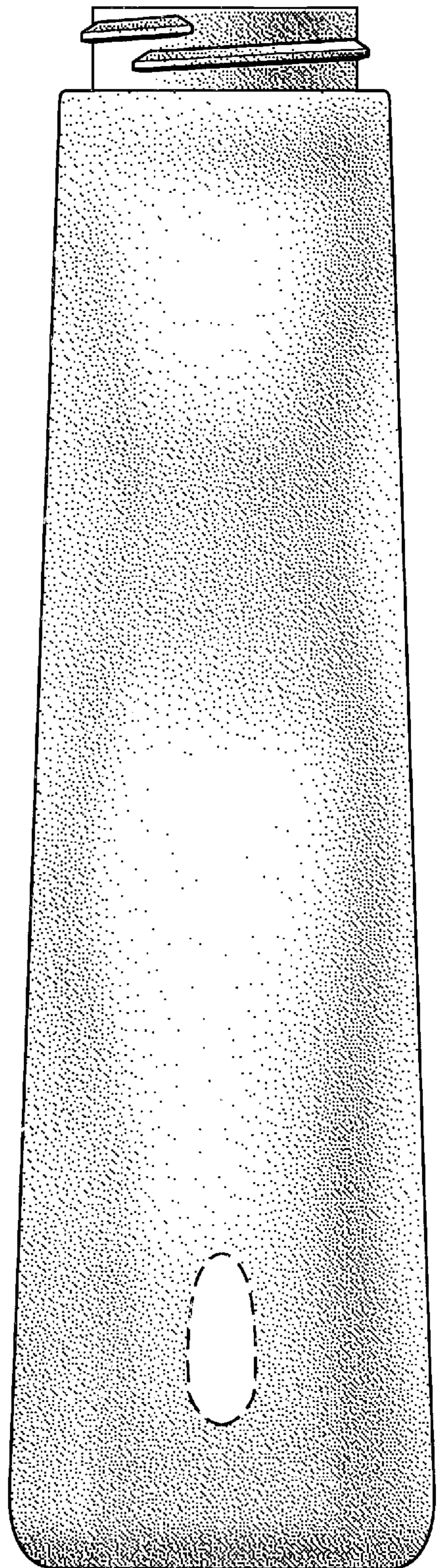

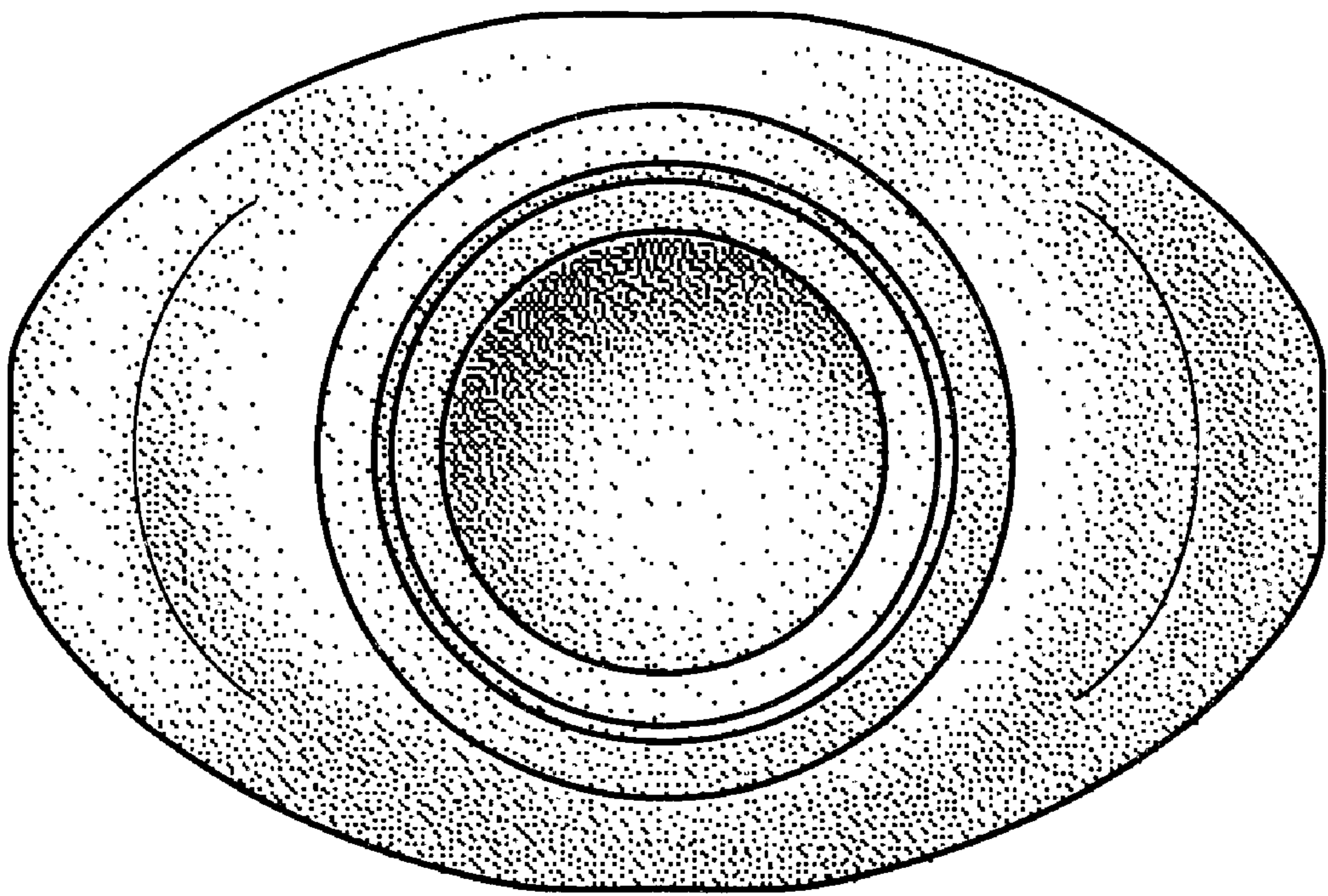
