**DESCRIPTION**

FIG. 1 is a front perspective view of the trailer hitch cover of this invention;

FIG. 2 is a top plan view of the trailer hitch cover of FIG. 1;

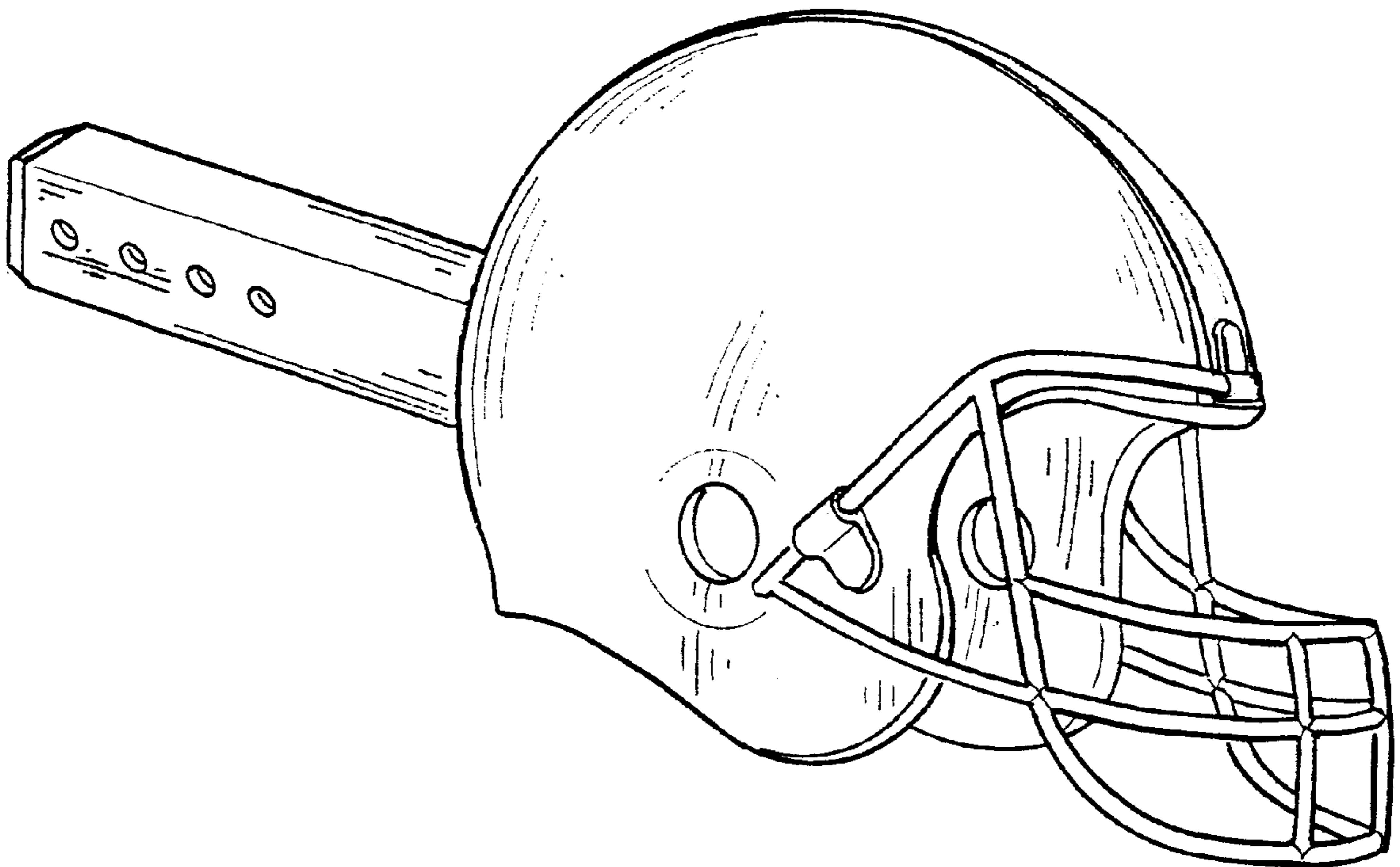
FIG. 3 is a side elevation view of the trailer hitch cover of FIG. 1;

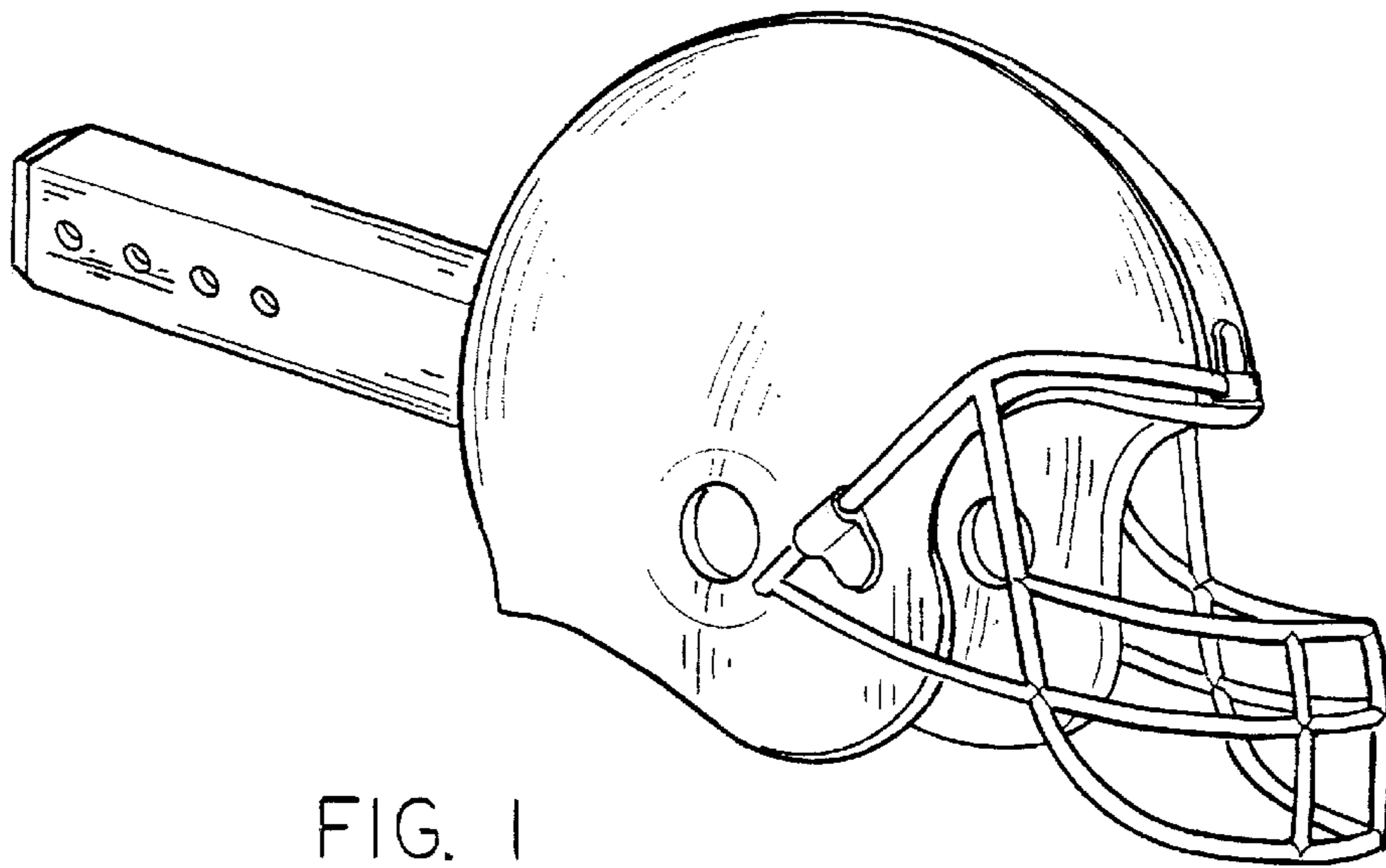

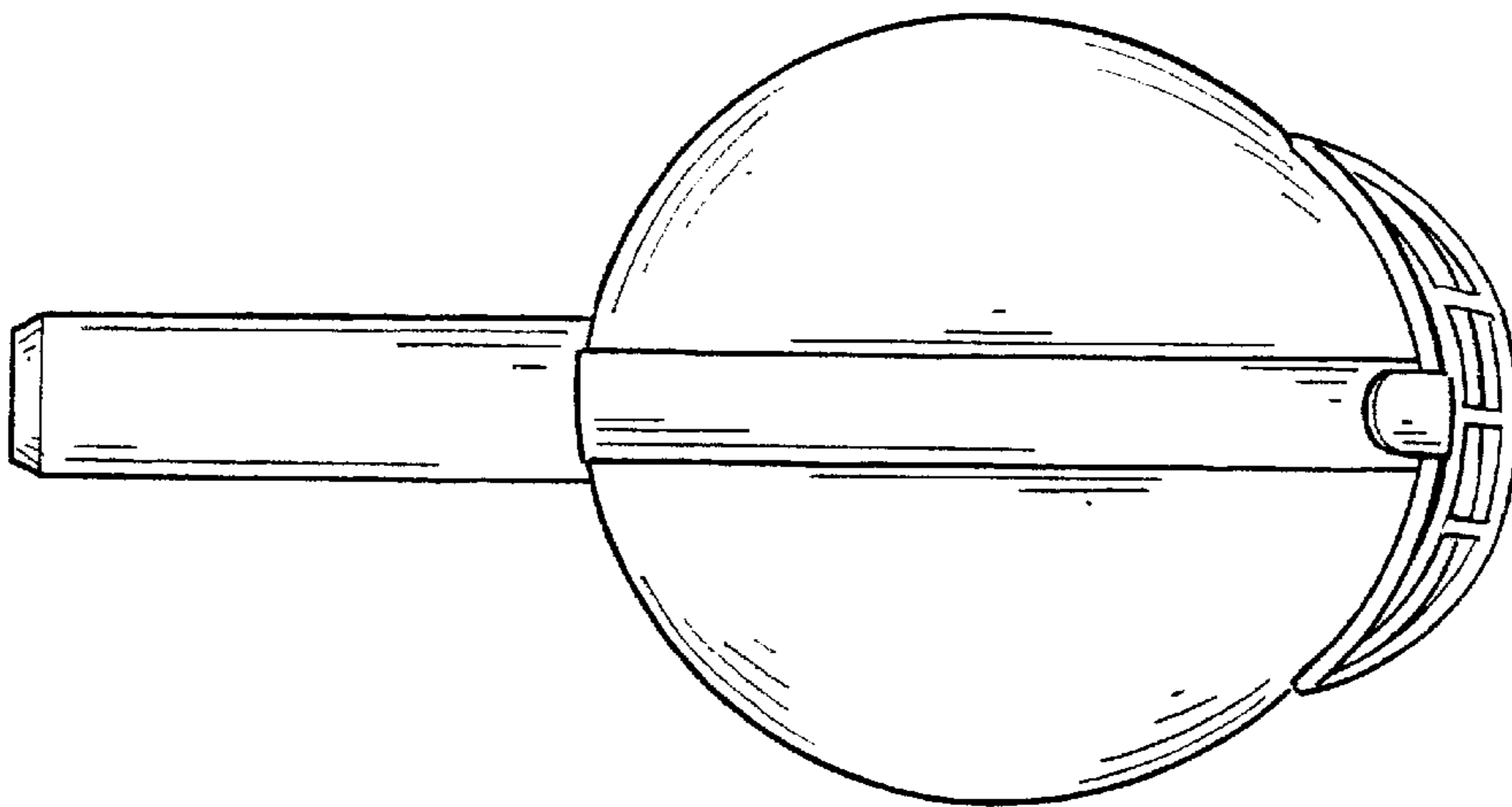

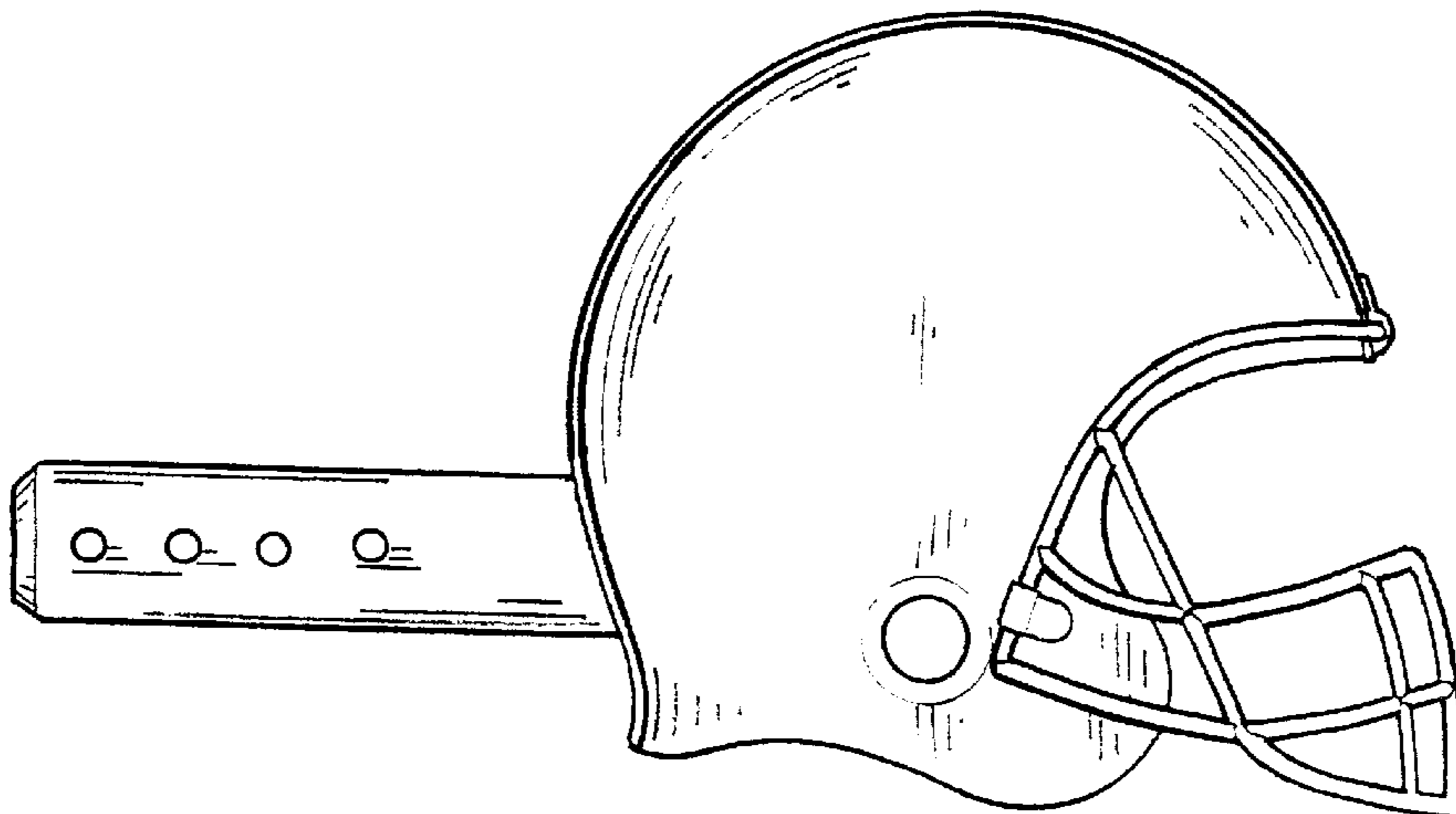

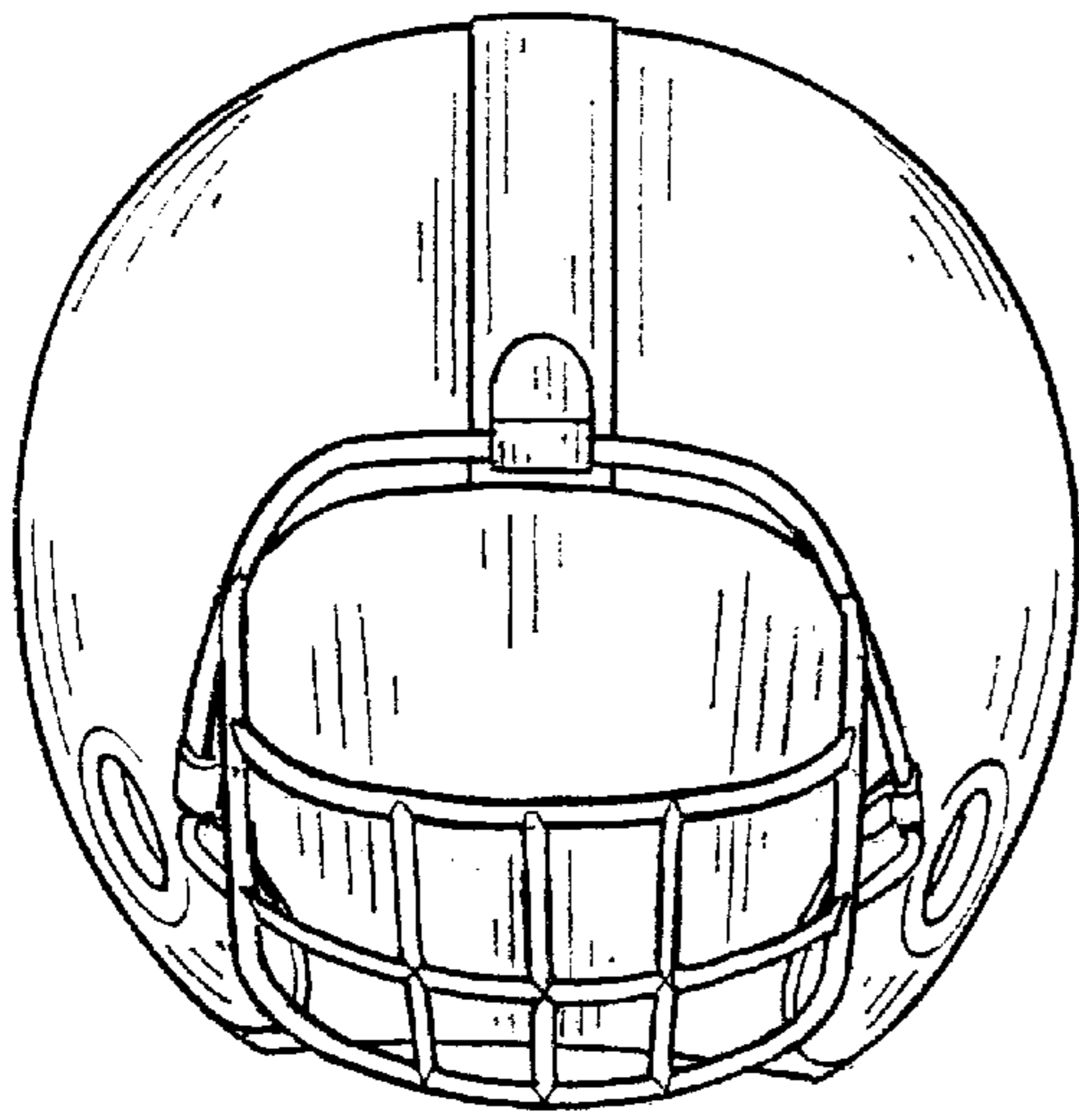

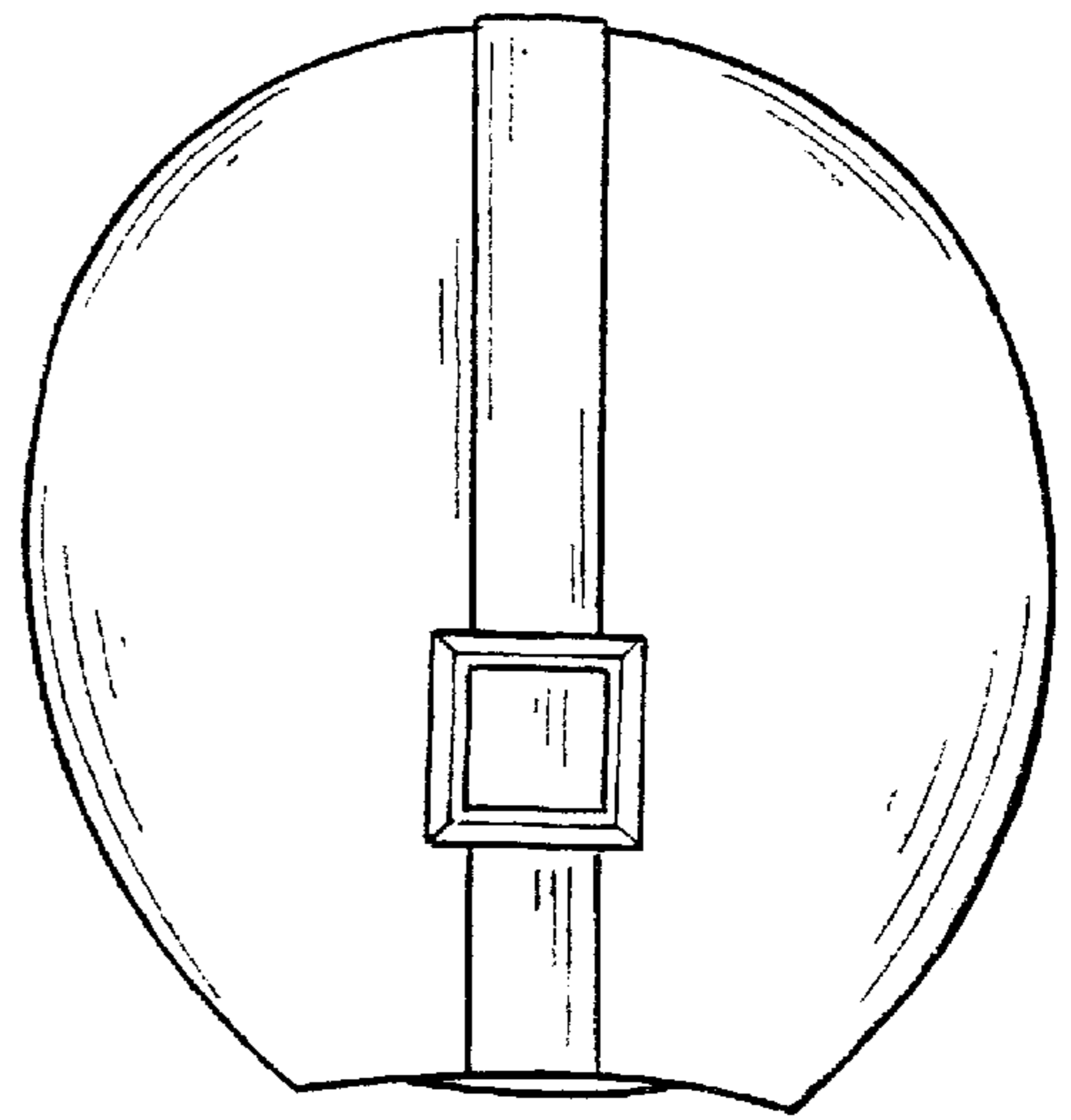

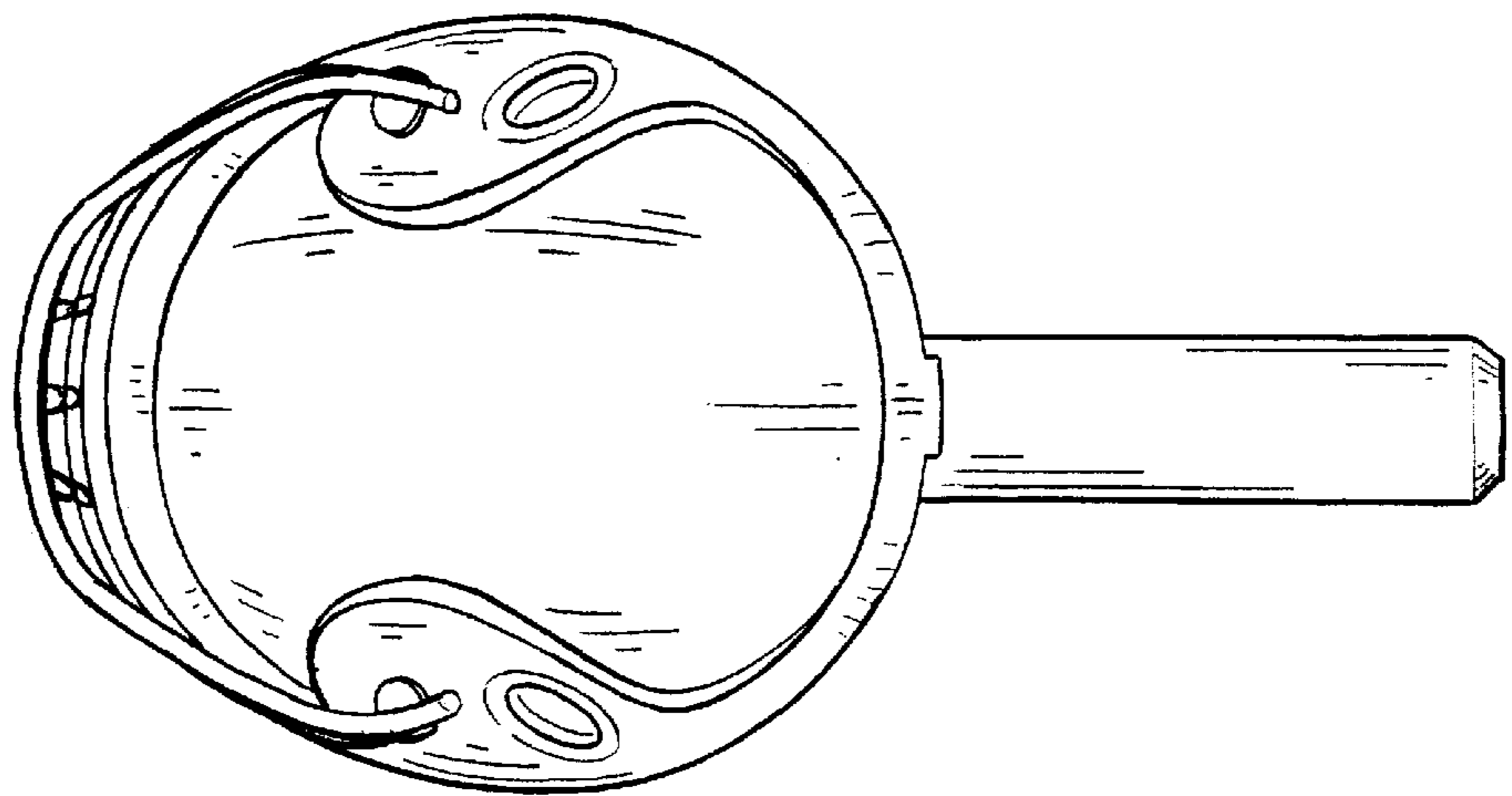
