(57) **CLAIM**

The ornamental design for a wireless radiotelephone front cover, as shown and described.

DESCRIPTION

FIG. 1 is a front, bottom and right side perspective view showing our new design for a wireless radiotelephone front cover;

FIG. 2 is a left side elevation view of the wireless radiotelephone front cover of FIG. 1;

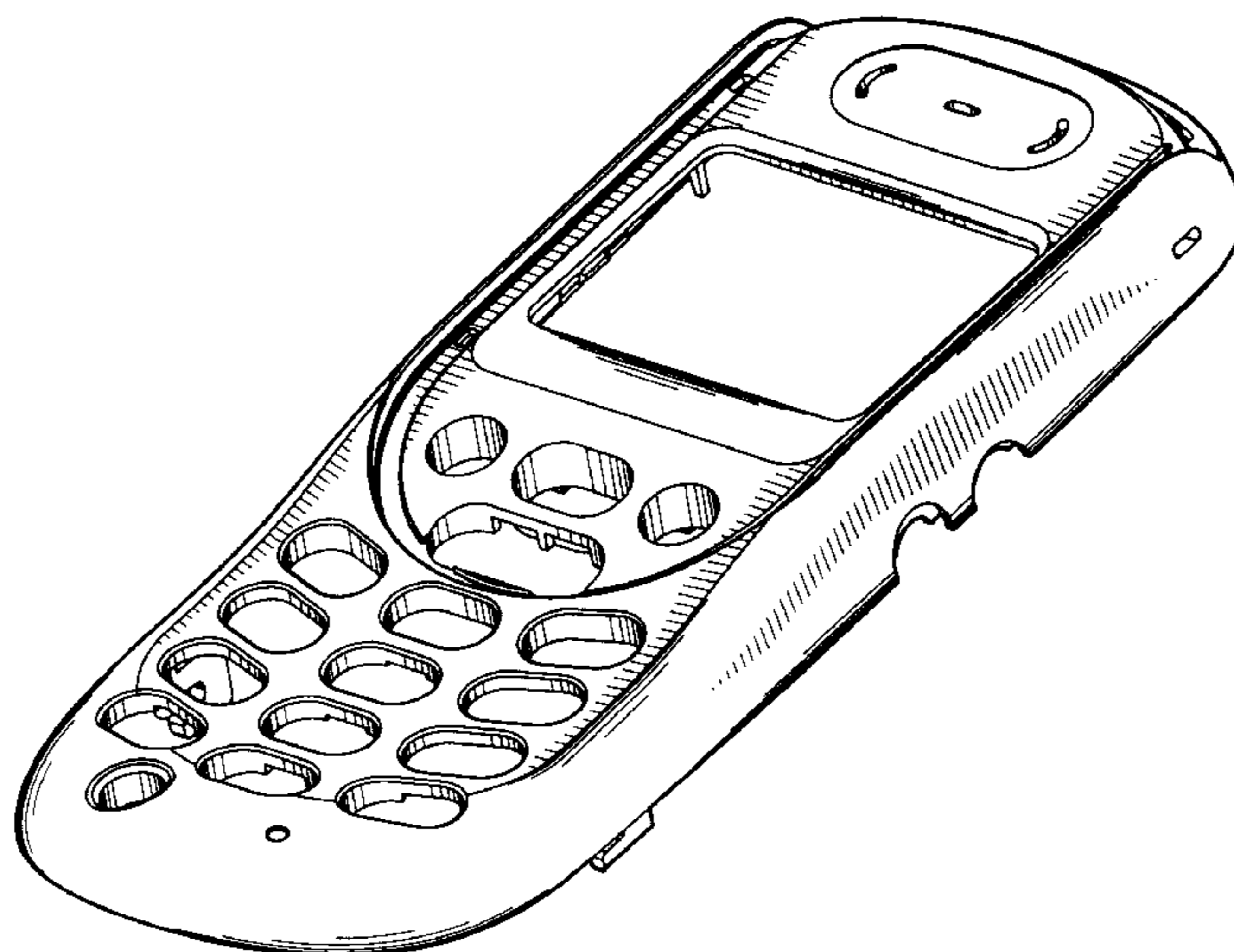
FIG. 3 is a front plan view of the wireless radiotelephone front cover of FIG. 1;

FIG. 4 is a bottom elevation view of the wireless radiotelephone front cover of FIG. 1;

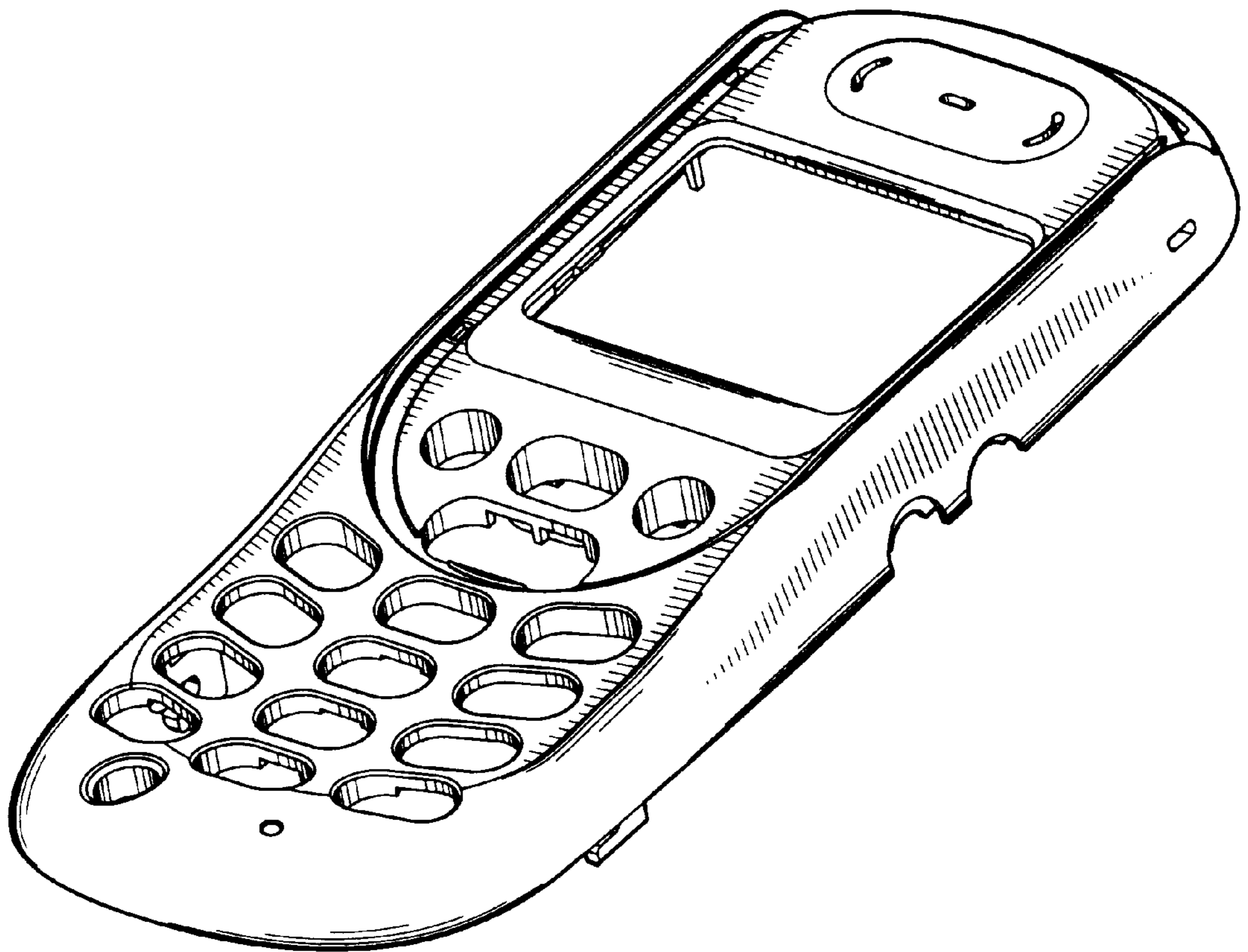

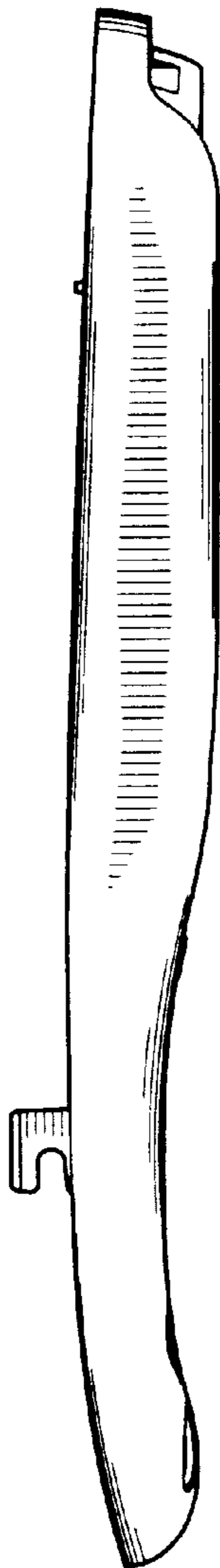

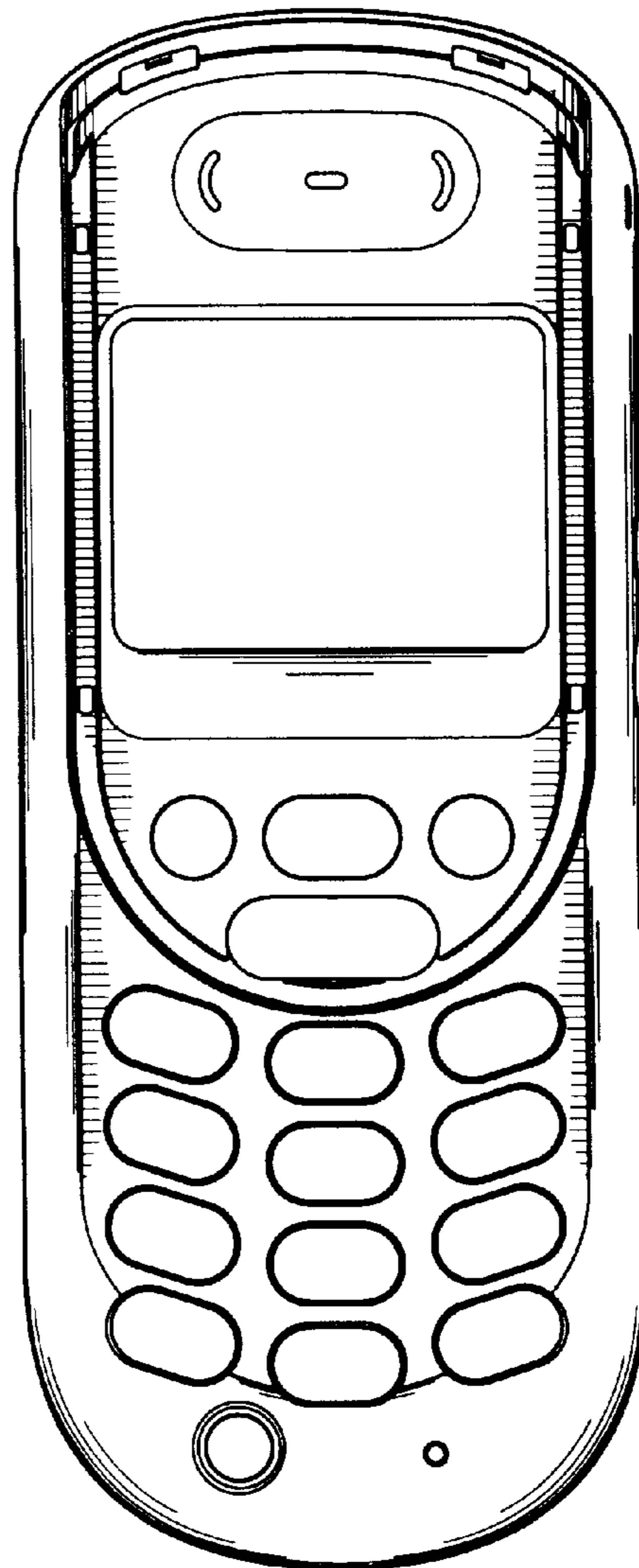

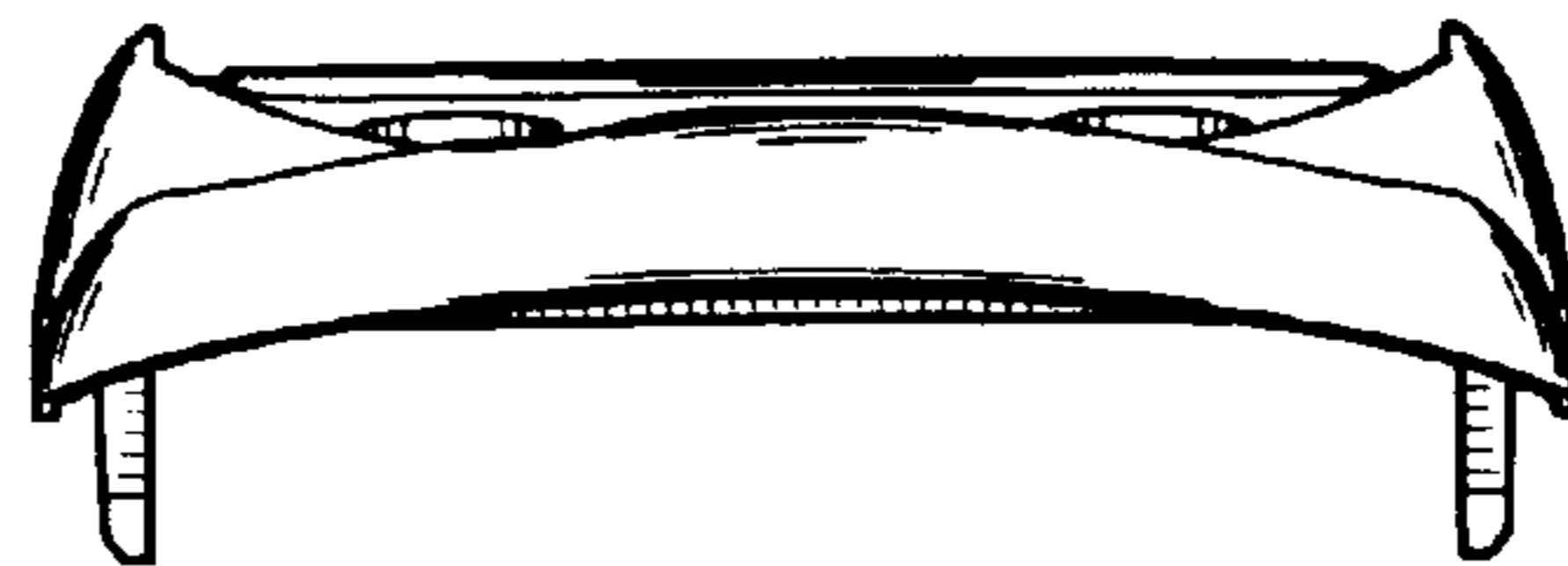

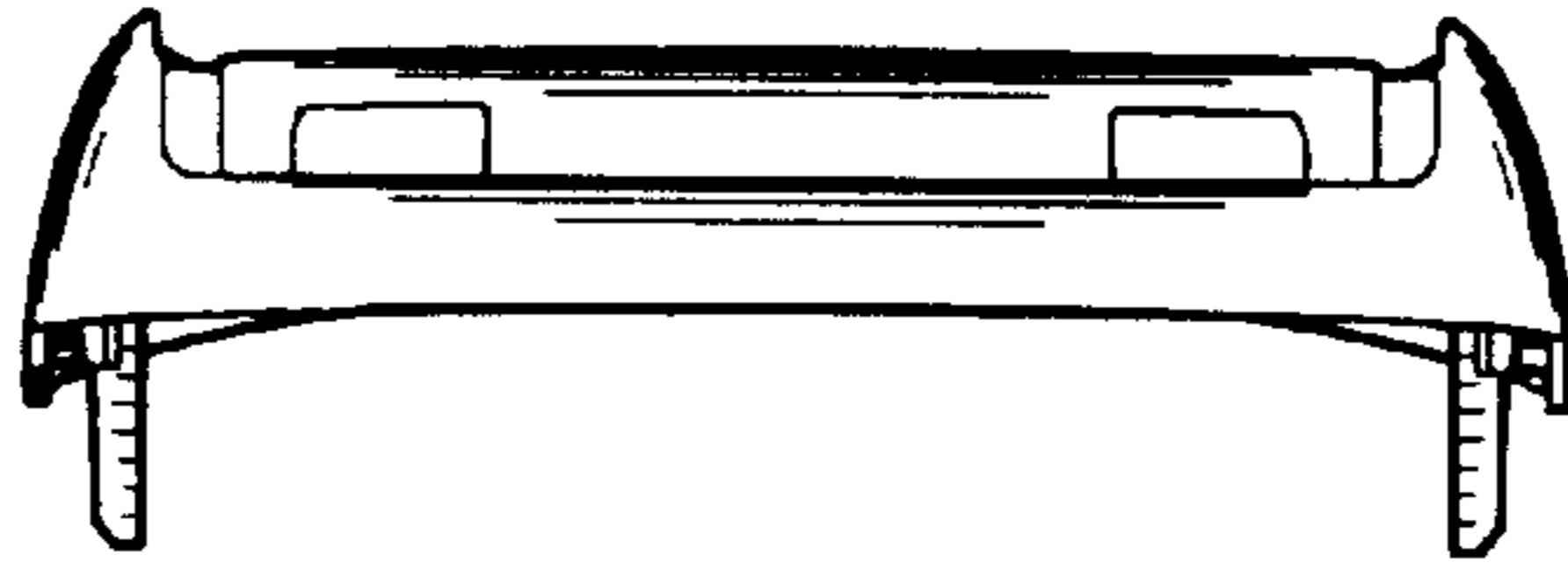

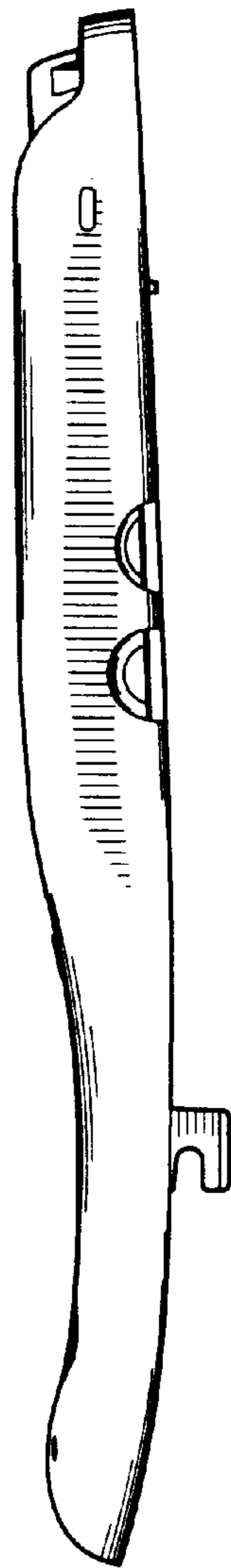
