(57) **CLAIM**

The ornamental design for a compressor for air conditioners of vehicles, as shown and described.

DESCRIPTION

FIG. 1 is a front view of a compressor for air conditioner of vehicles, according to the design.

FIG. 2 is a rear view of the compressor, as shown in FIG. 1.

FIG. 3 is a right side view of the compressor, as shown in FIG. 1.

FIG. 4 is a left side view of the compressor, as shown in FIG. 1.

FIG. 5 is a top view of the compressor, as shown in FIG. 1.

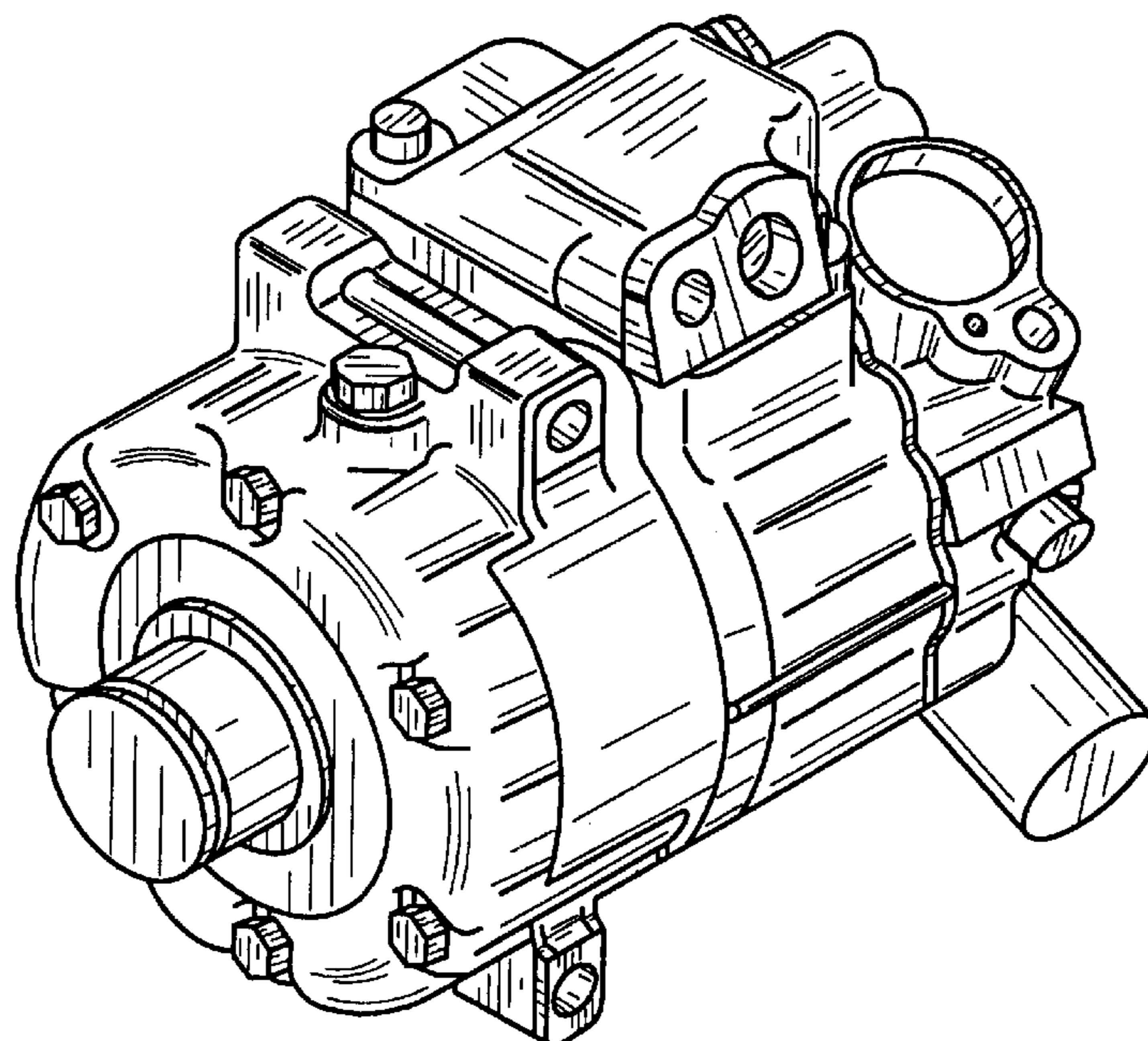
FIG. 6 is a bottom view of the compressor, as shown in FIG. 1.

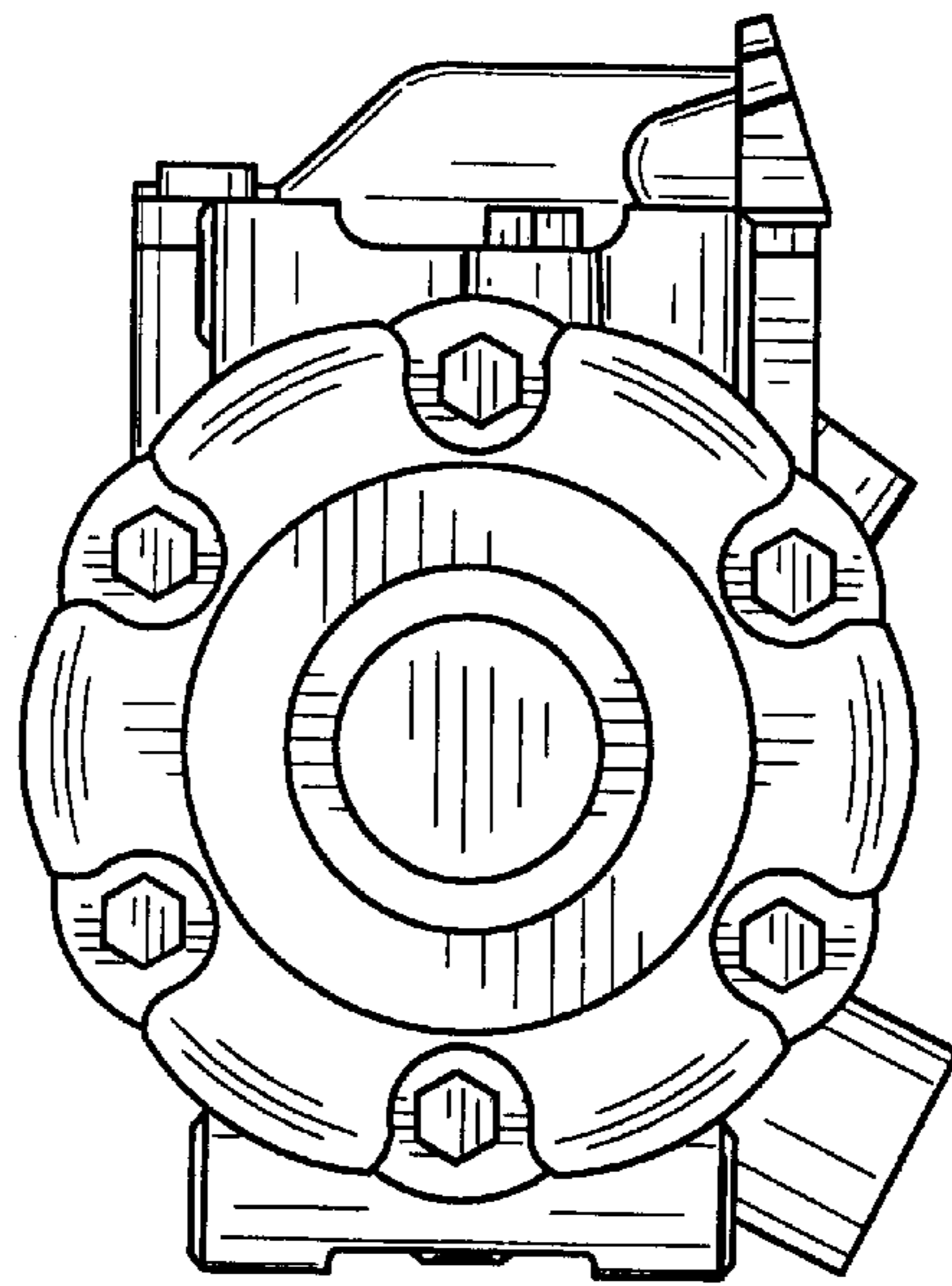

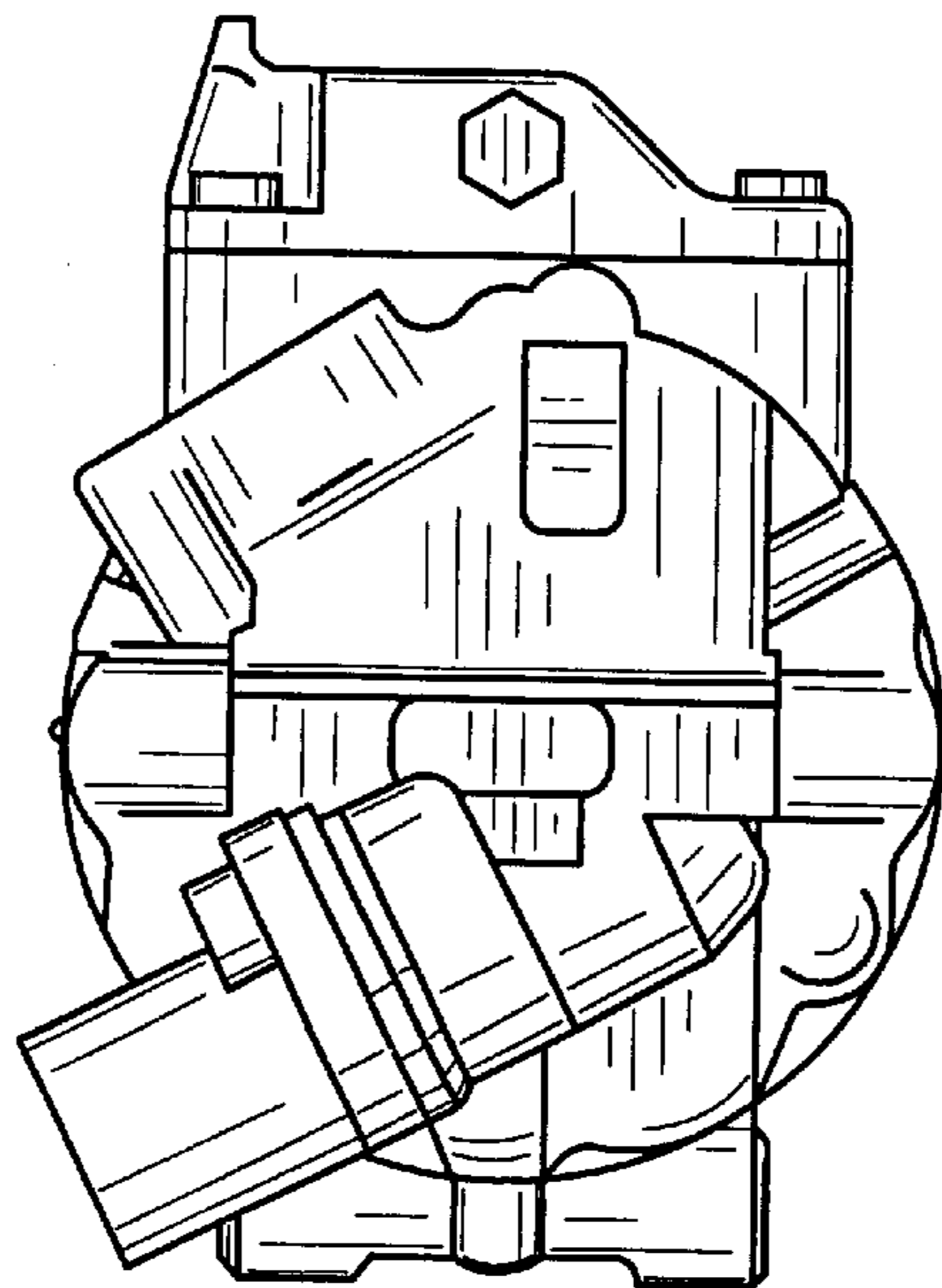

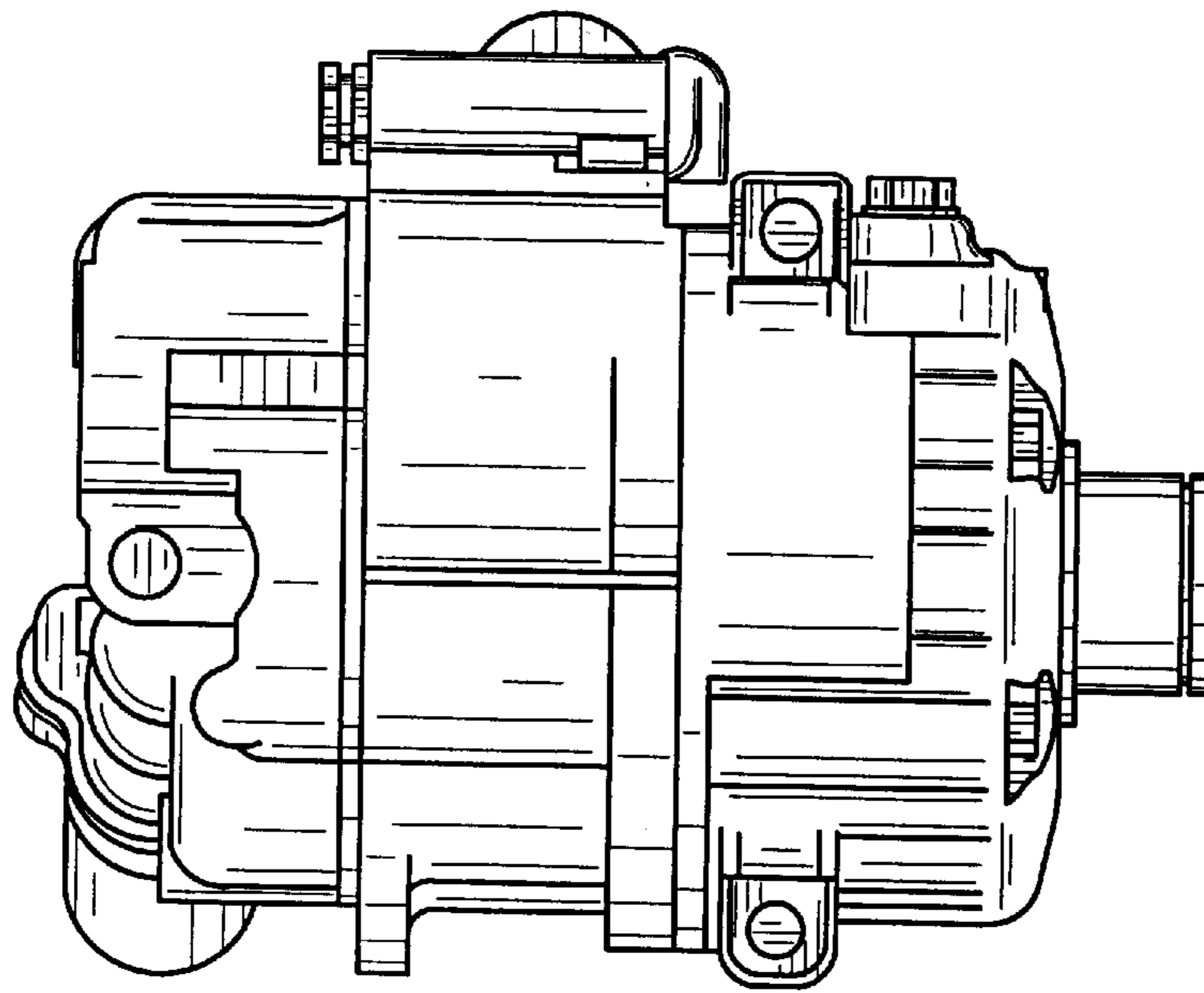

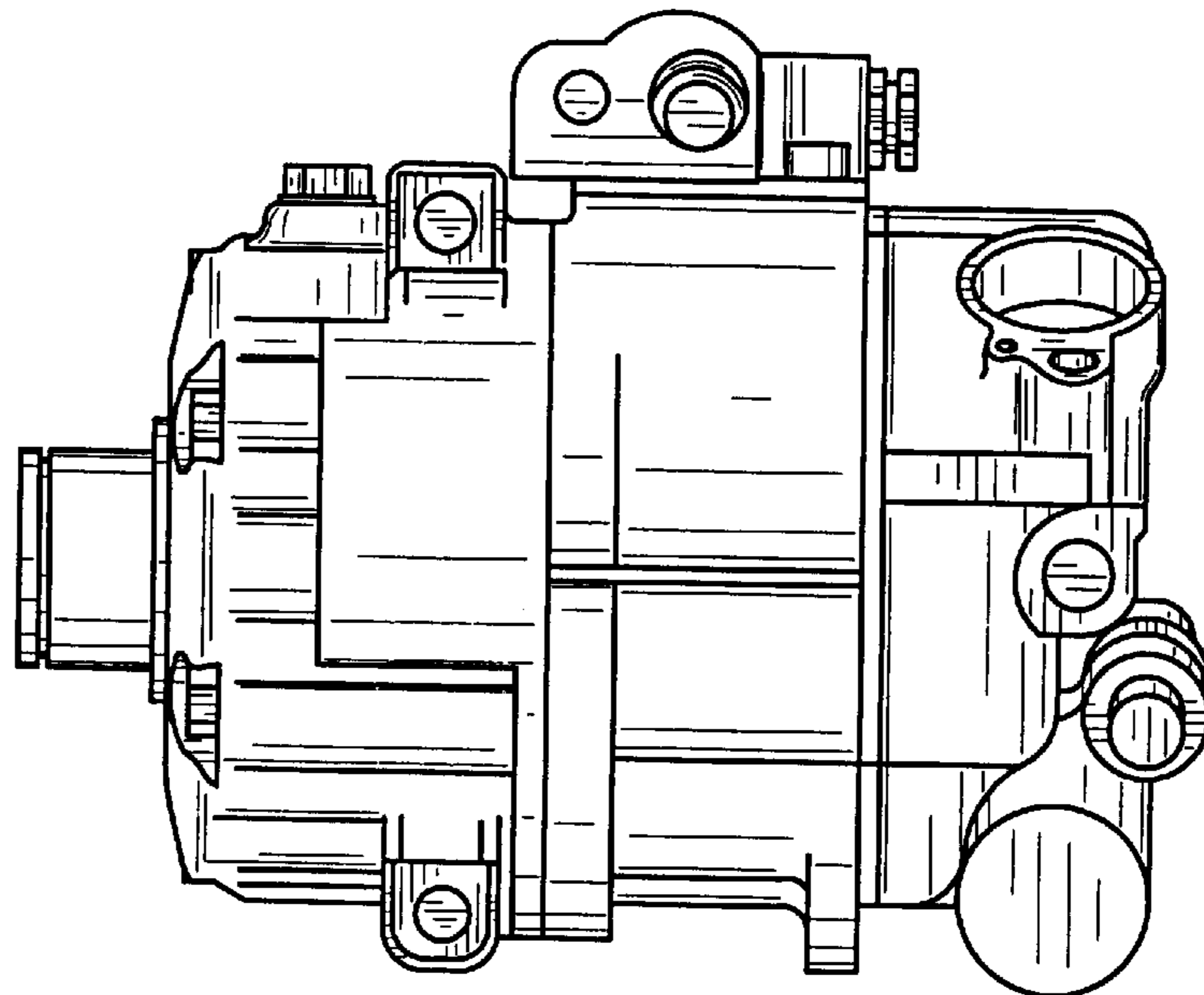

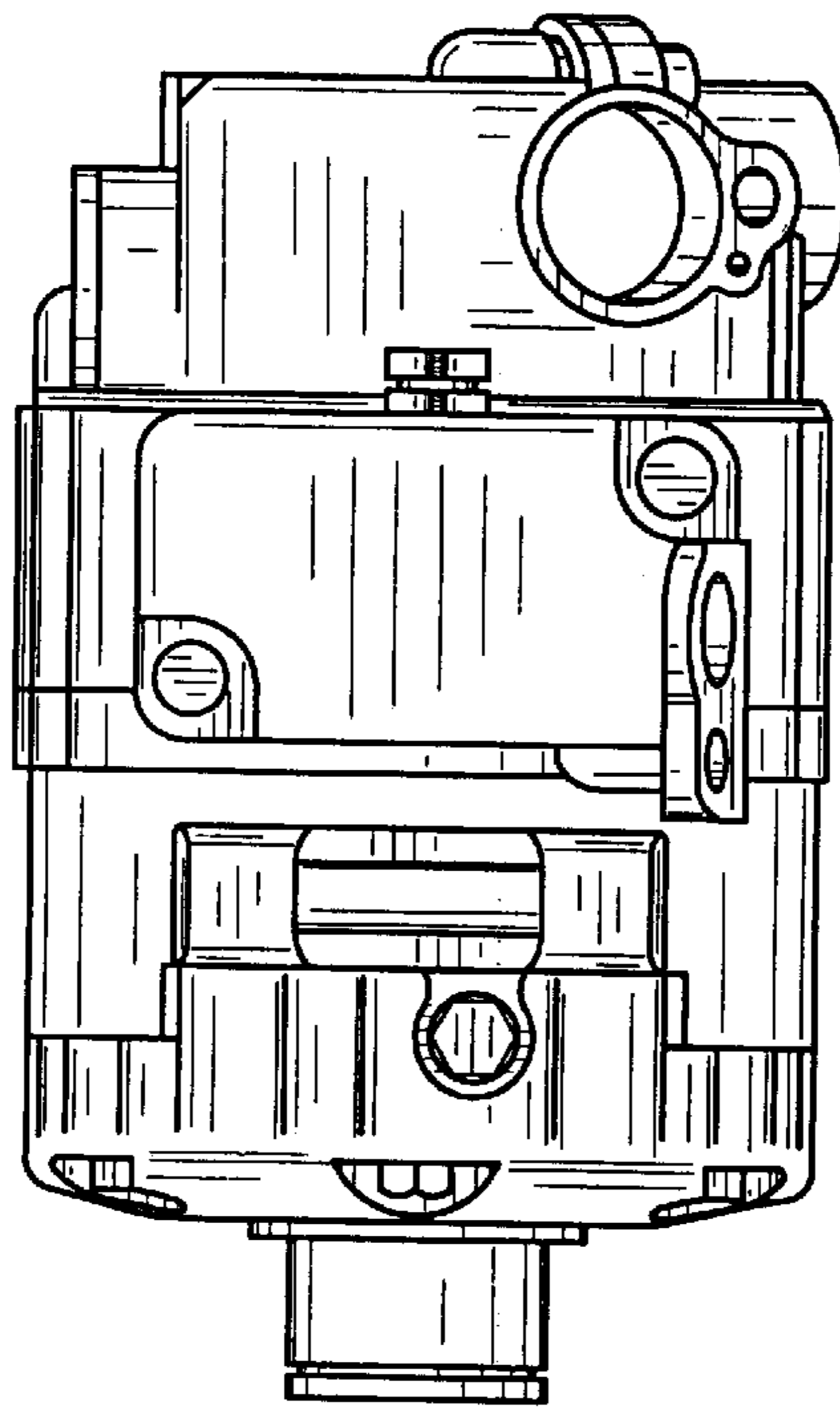

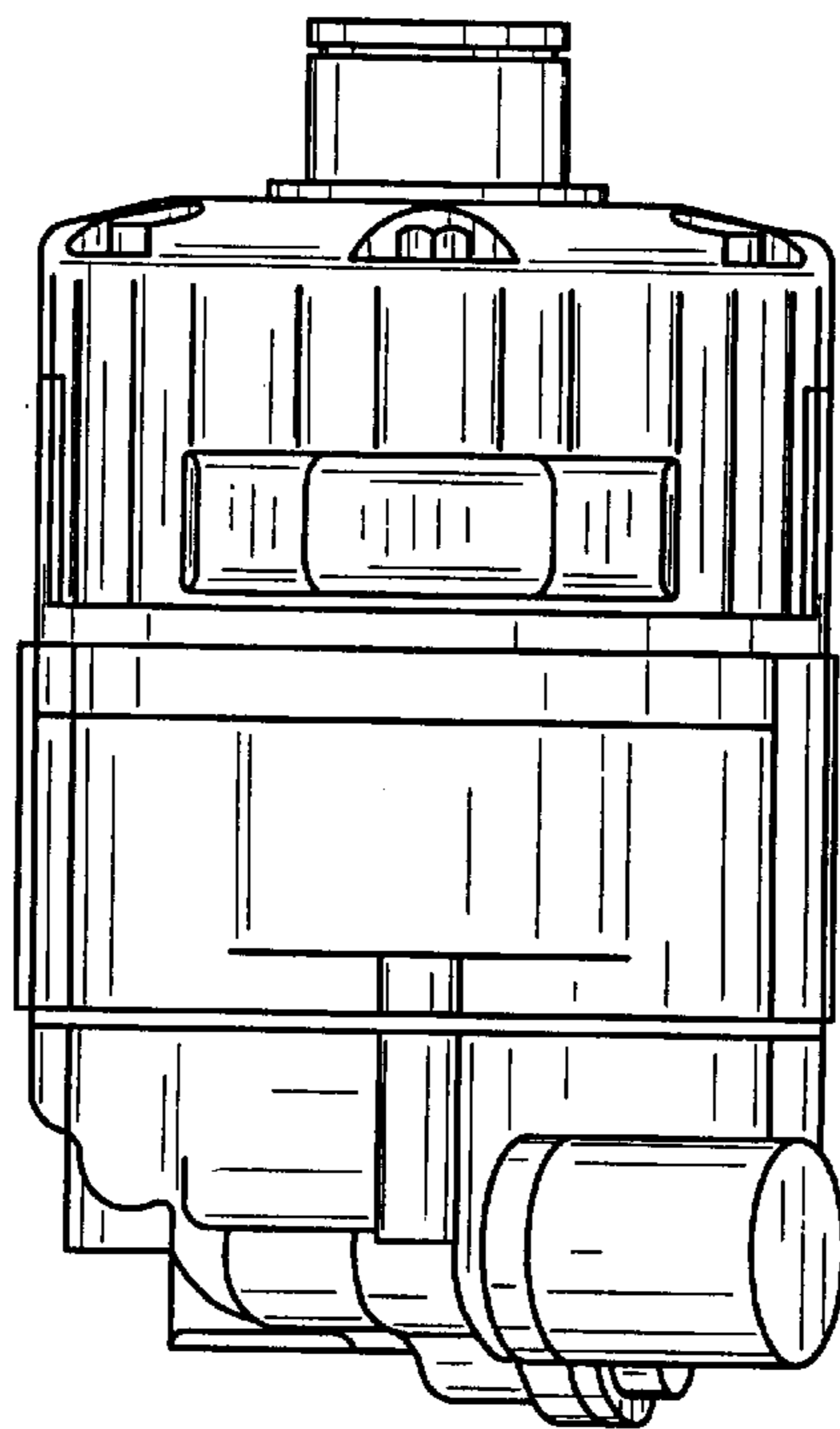

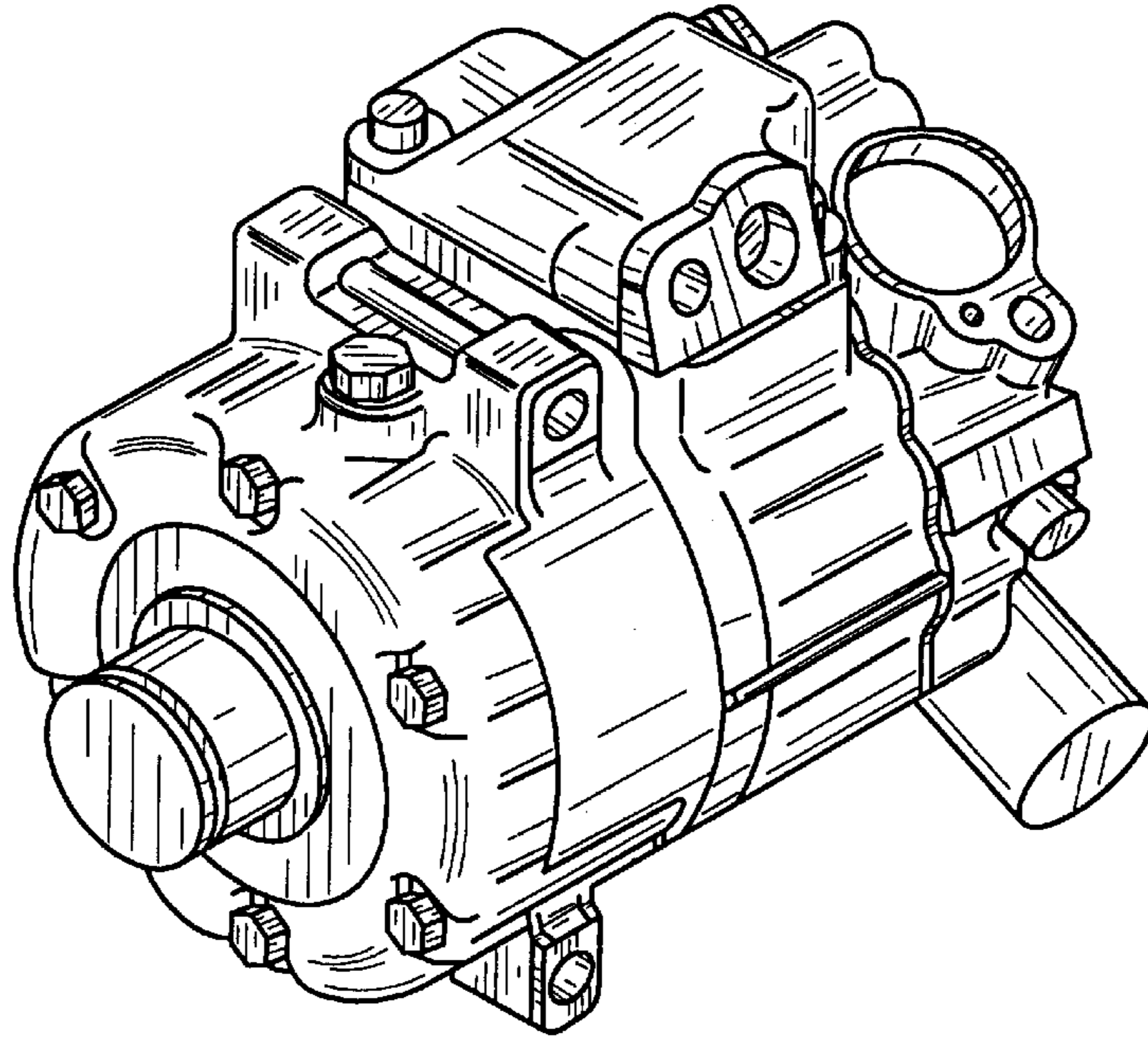

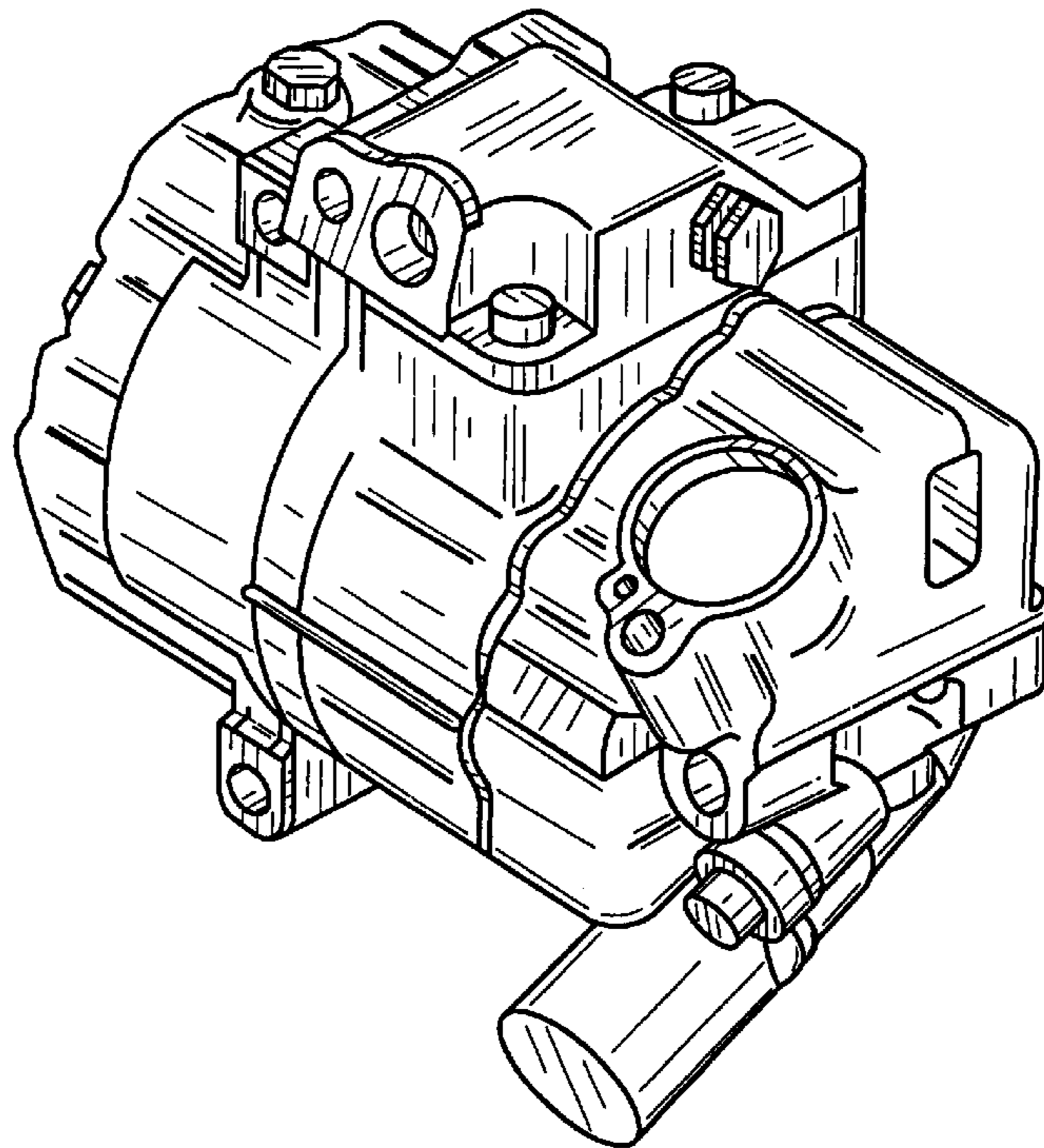
