I claim an ornamental design for a duck figure, as shown and  
described.

**DESCRIPTION**

FIG. 1 is a perspective view of a duck figure showing my  
new design;

FIG. 2 is a front elevational view thereof;

FIG. 3 is a right side elevational view thereof, the left side  
being a mirror image;

FIG. 4 is a top plan view thereof;

FIG. 5 is a rear view thereof;

FIG. 6 is a perspective view of a second embodiment of FIG.  
1;

FIG. 7 is a front elevational view of FIG. 6;

FIG. 8 is a right side elevational view of FIG. 6, the left side  
being a mirror image;;

FIG. 9 is a top plan view of FIG. 6; and,

FIG. 10 a rear view of FIG. 6.

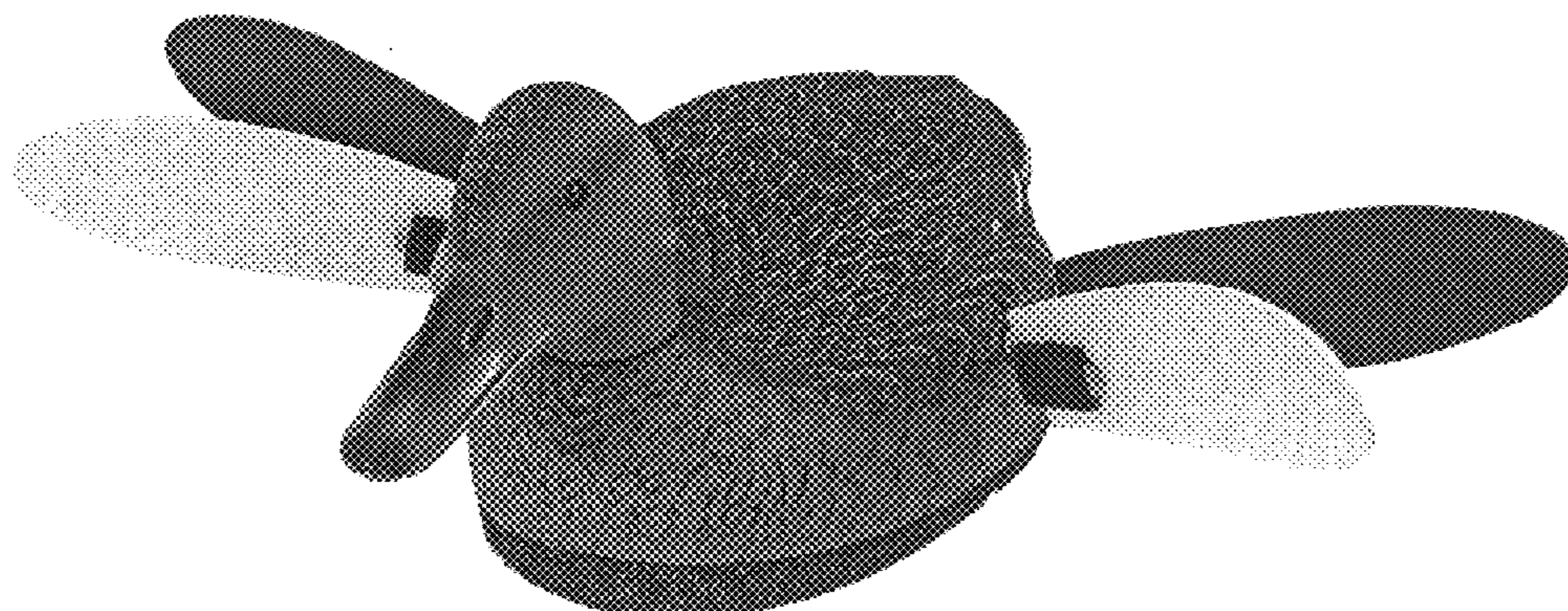
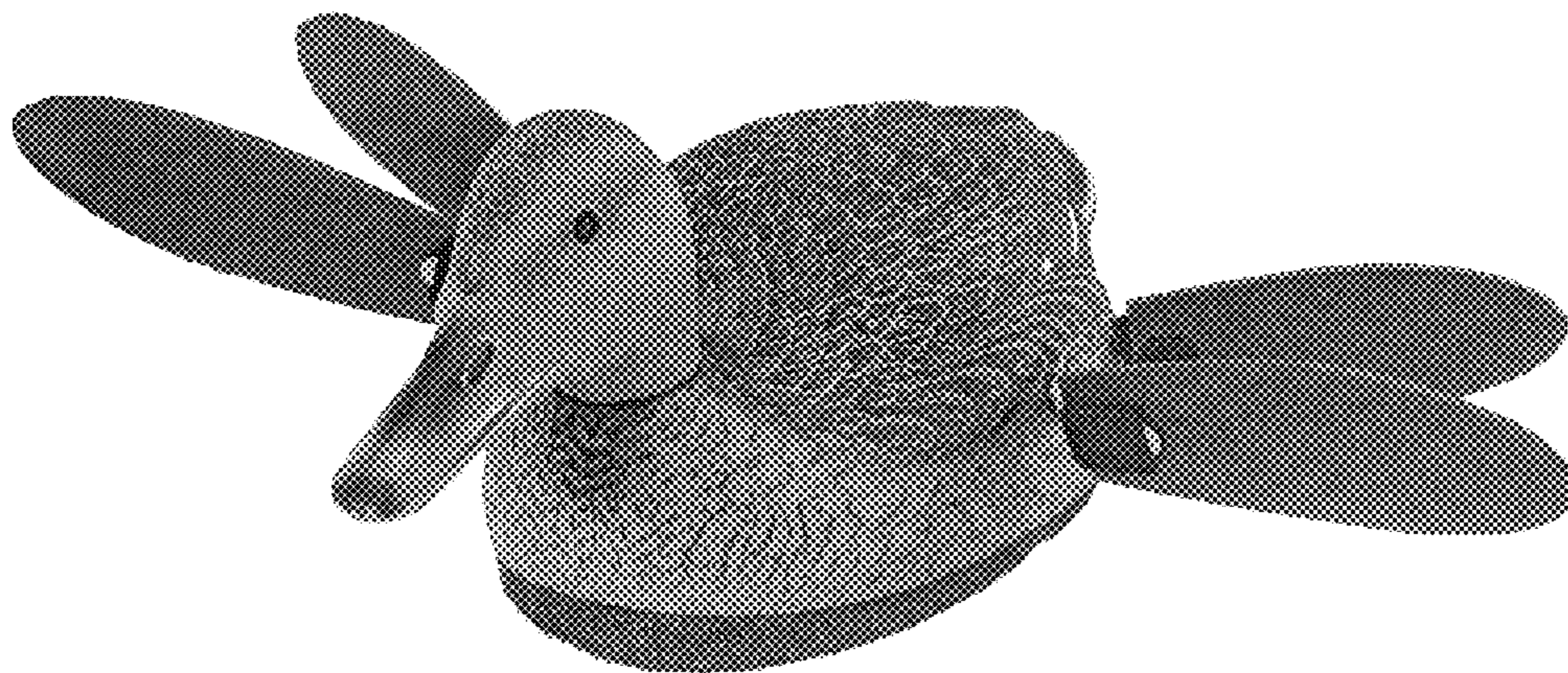

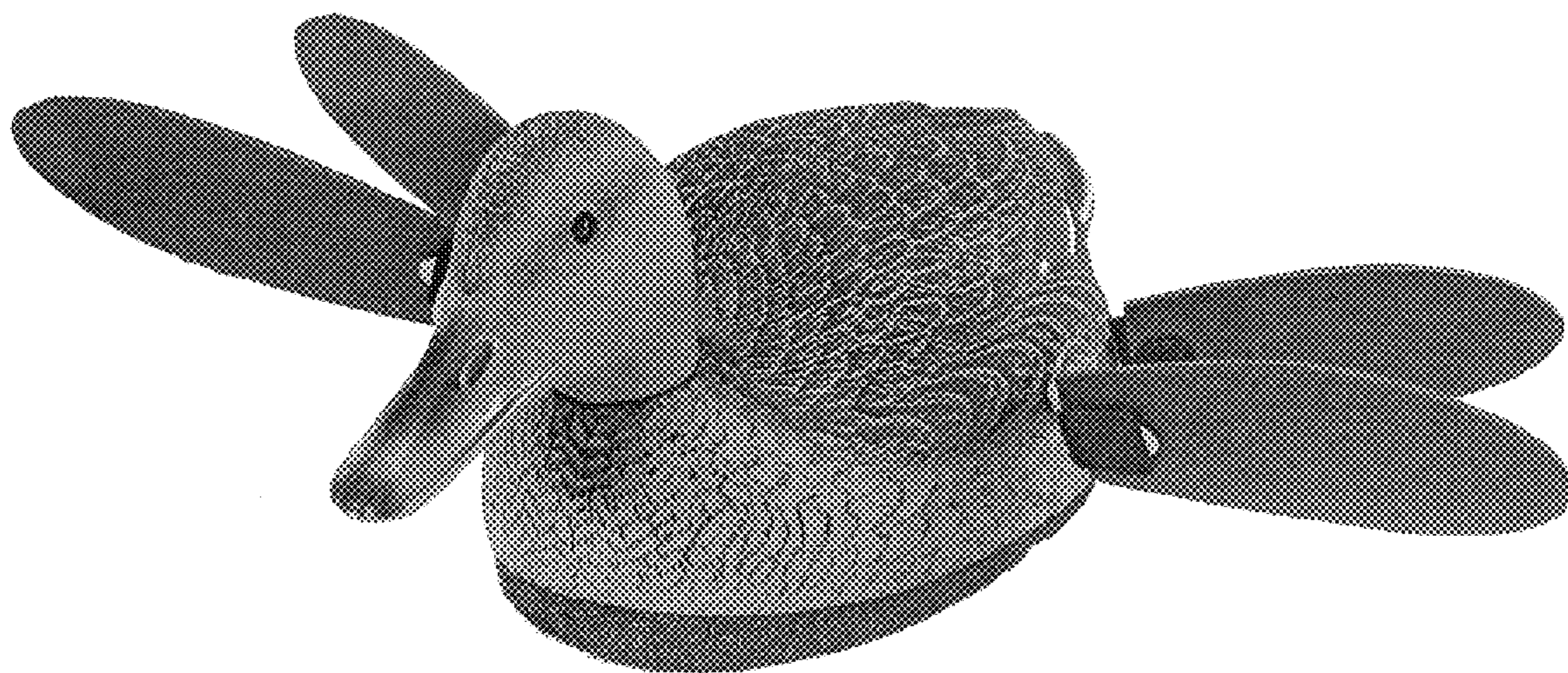

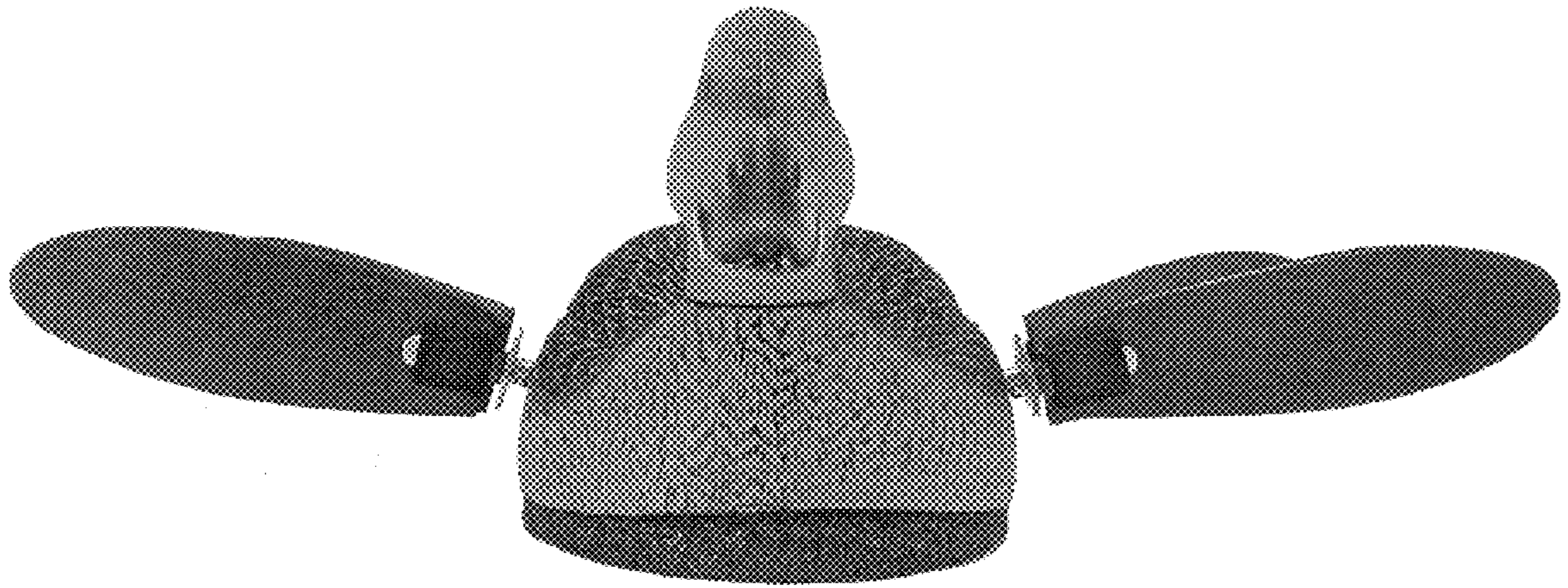

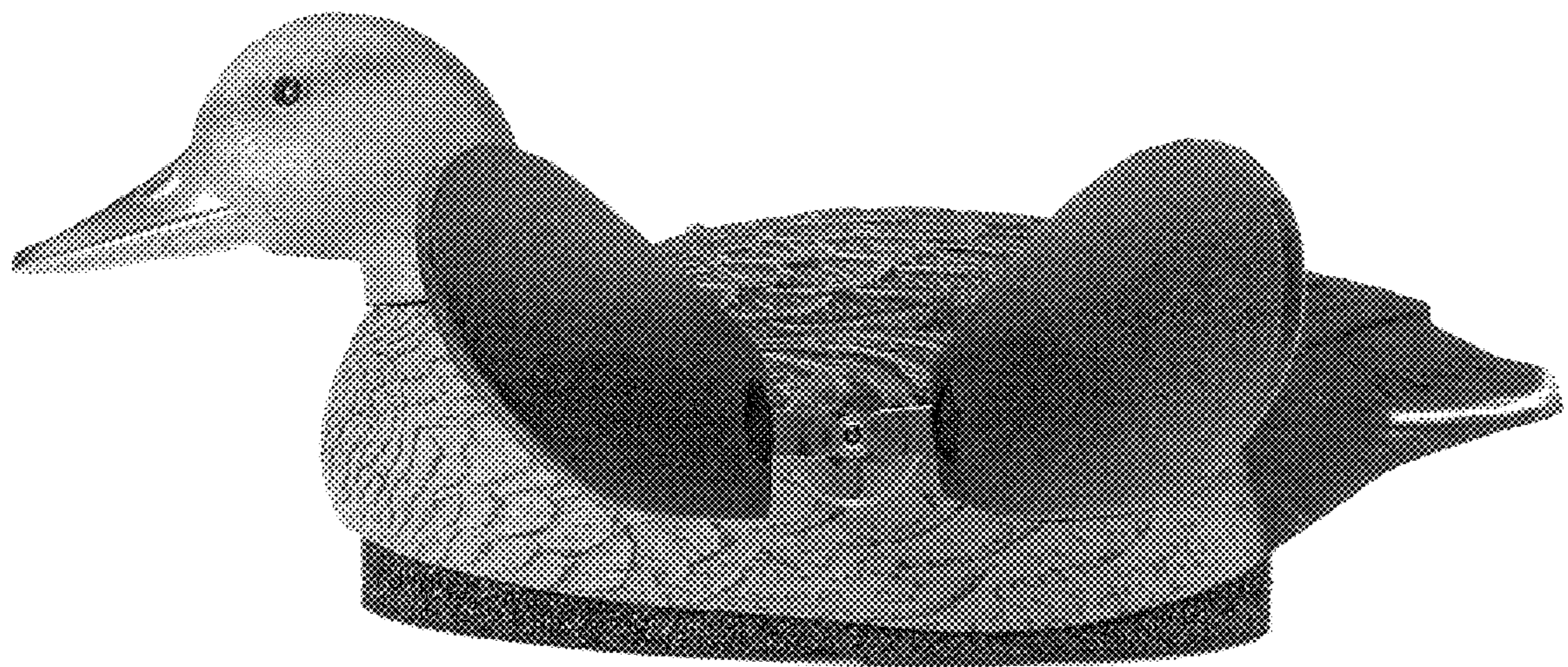

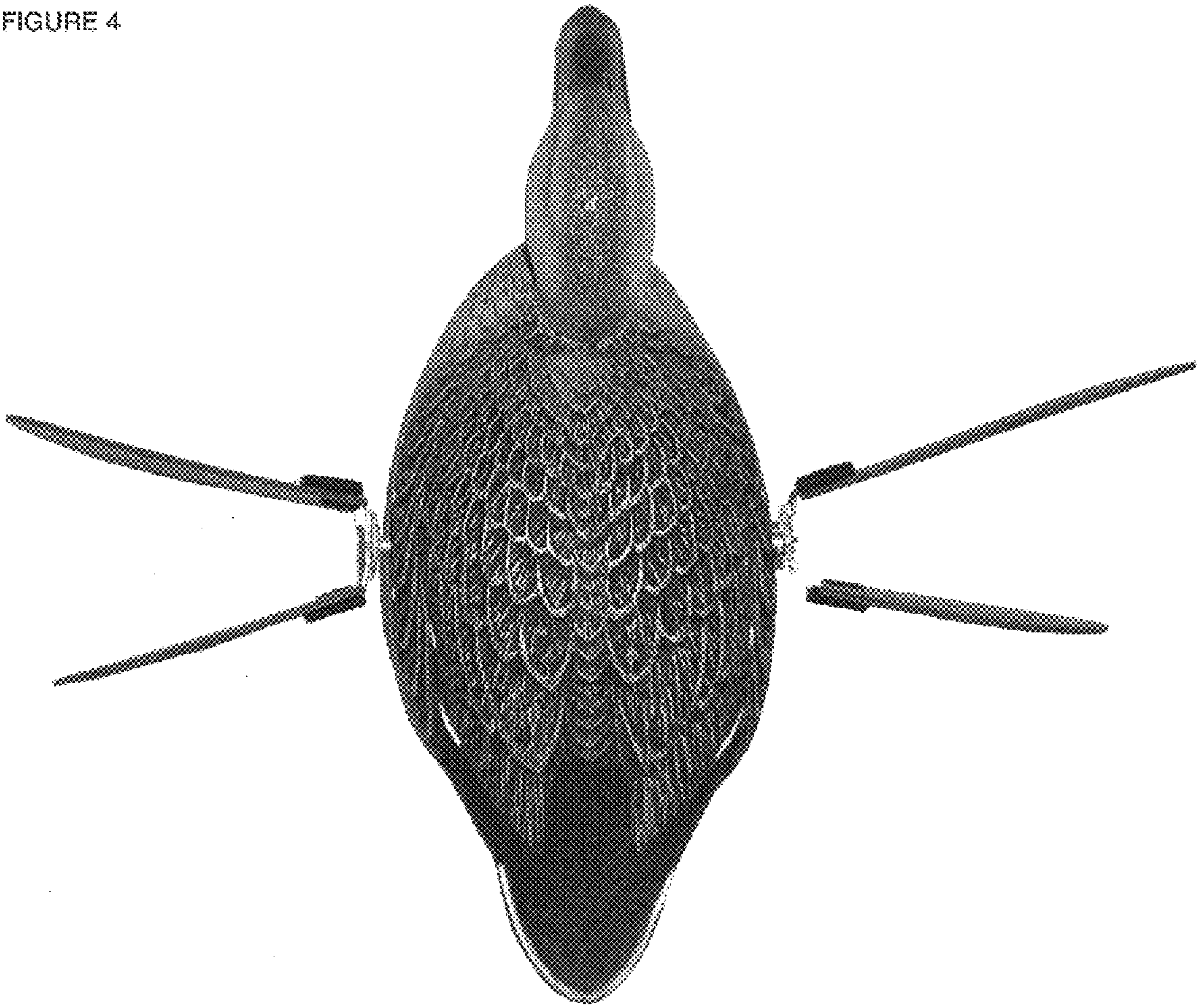

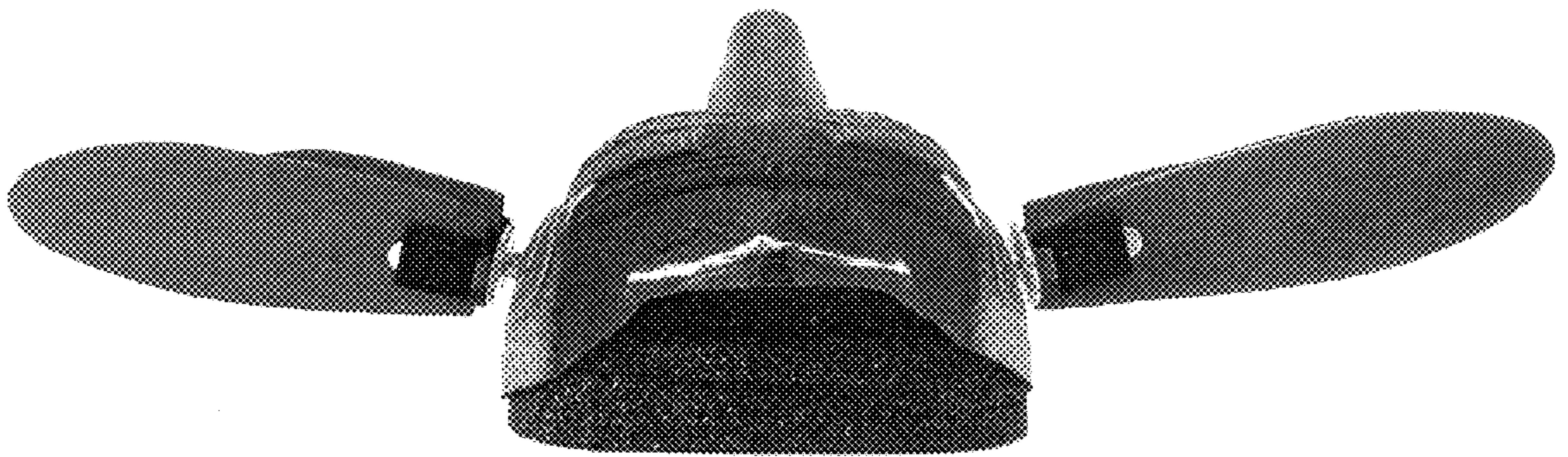

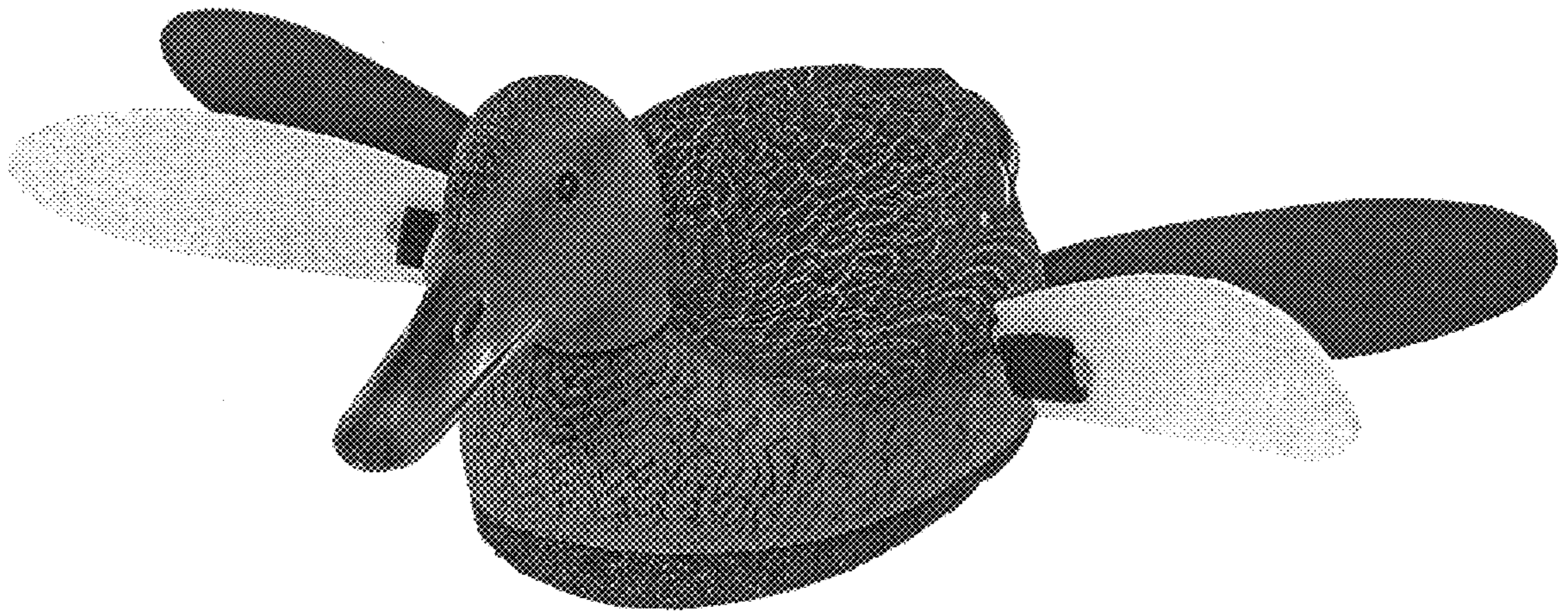

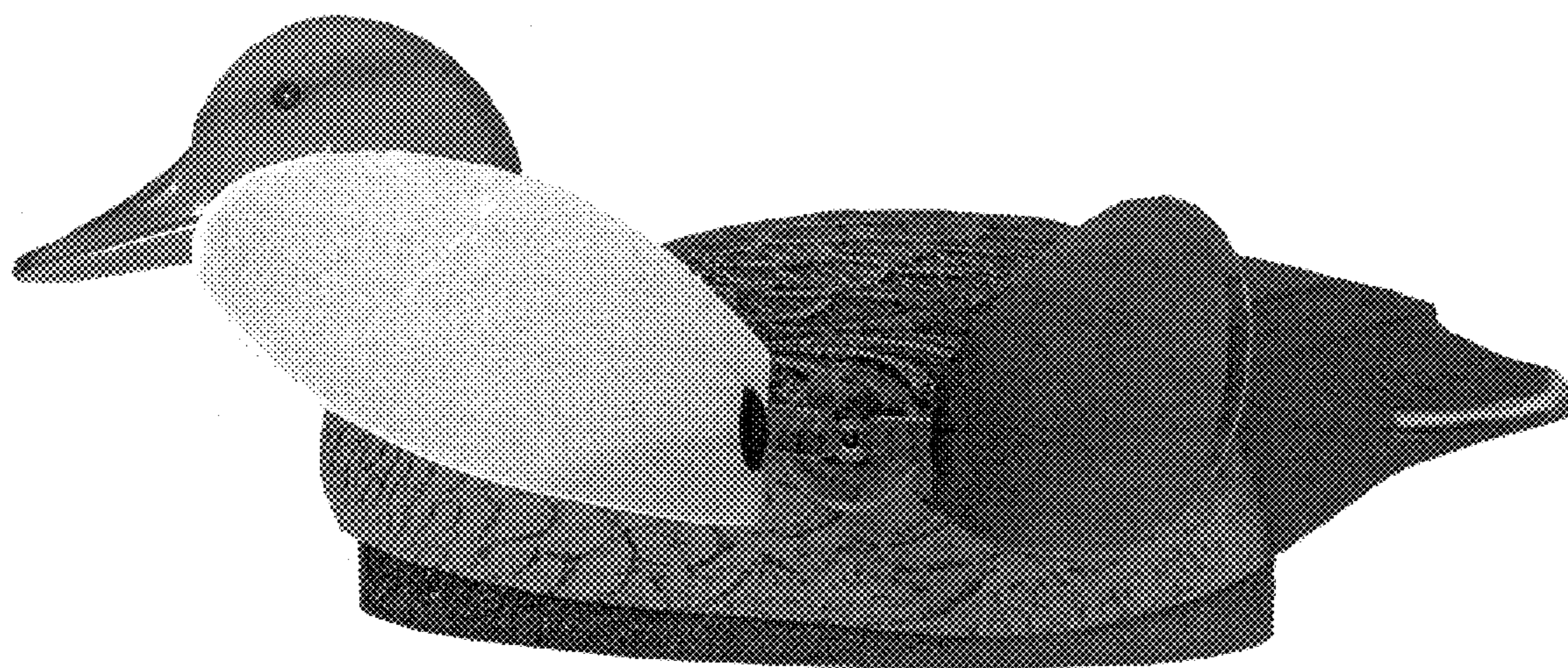
