**DESCRIPTION**

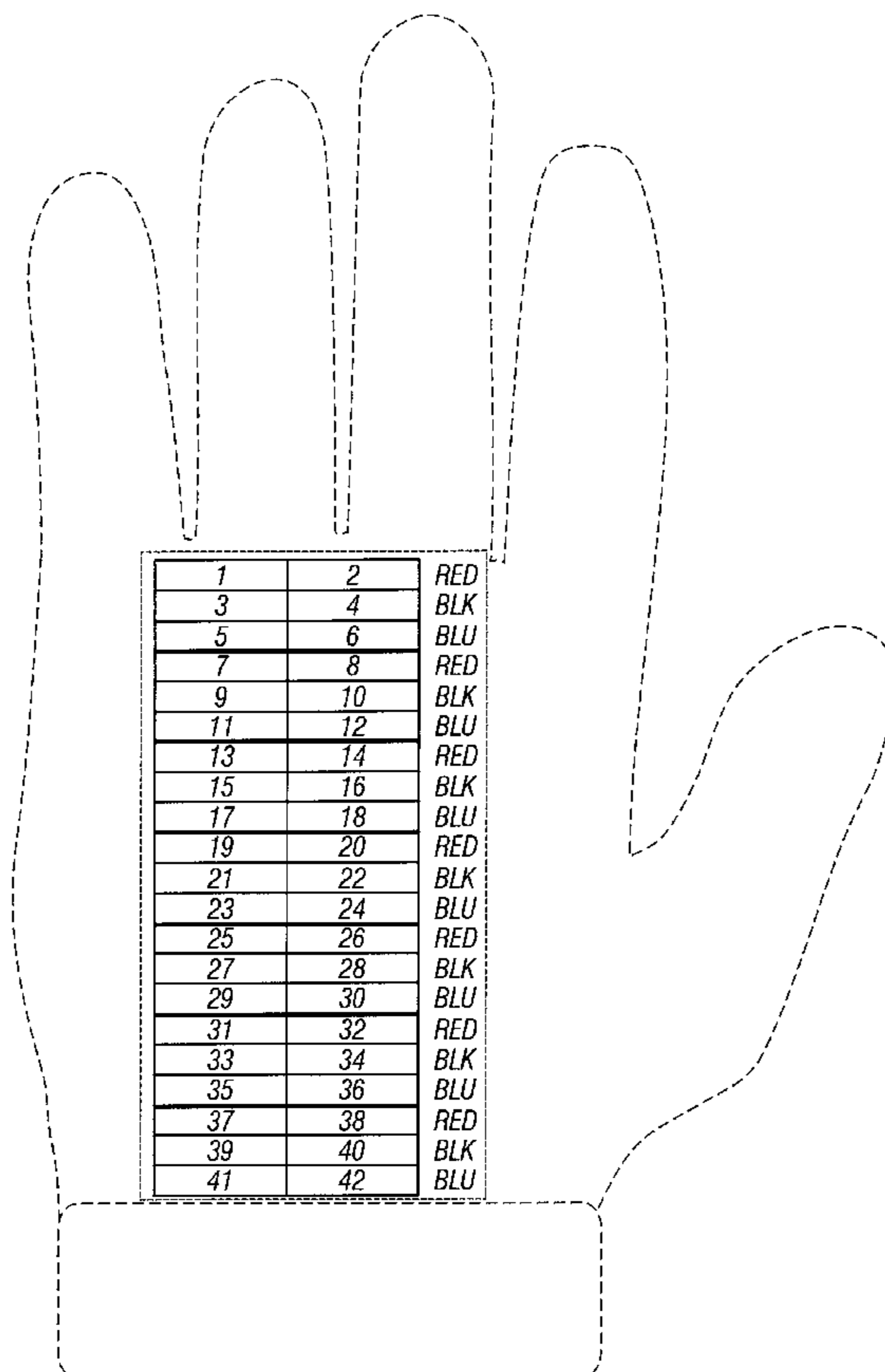
FIG. 1 is a top view of the left pair of electrician's glove of the present invention; and,

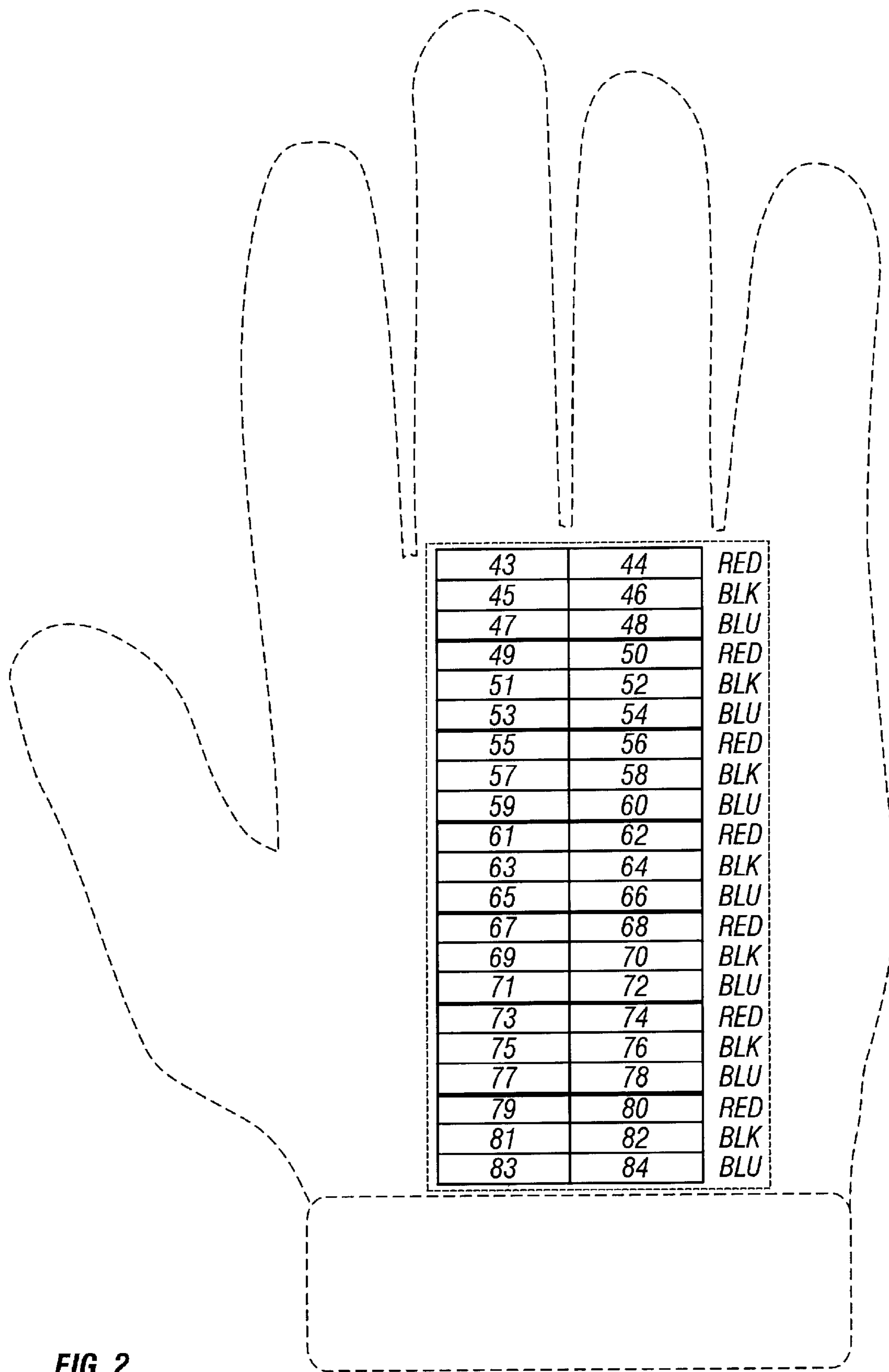
