(57) **CLAIM**

The ornamental design for a display rack, as shown and described.

**DESCRIPTION**

FIG. 1 is a side elevational view of a display rack showing my new design;

FIG. 2 is a perspective view of the display rack of FIG. 1; and,

FIG. 3 is an enlarged exploded perspective view of a portion of the display rack of FIG. 1, shown separately for the convenience of illustration.

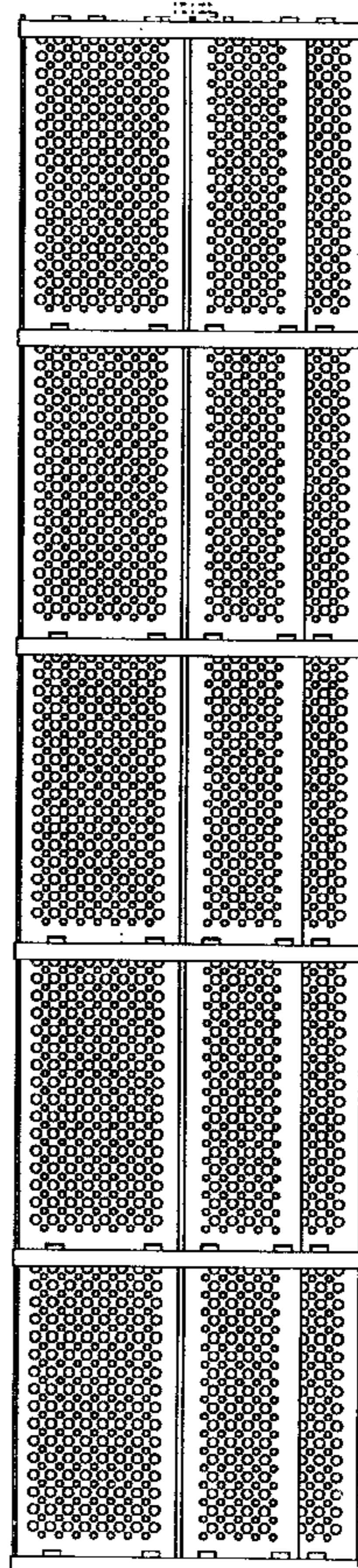

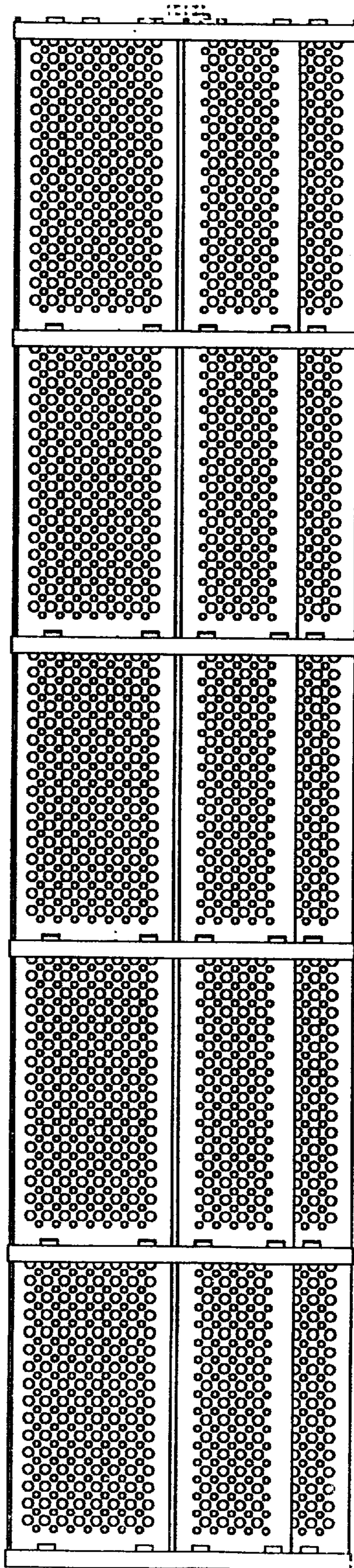

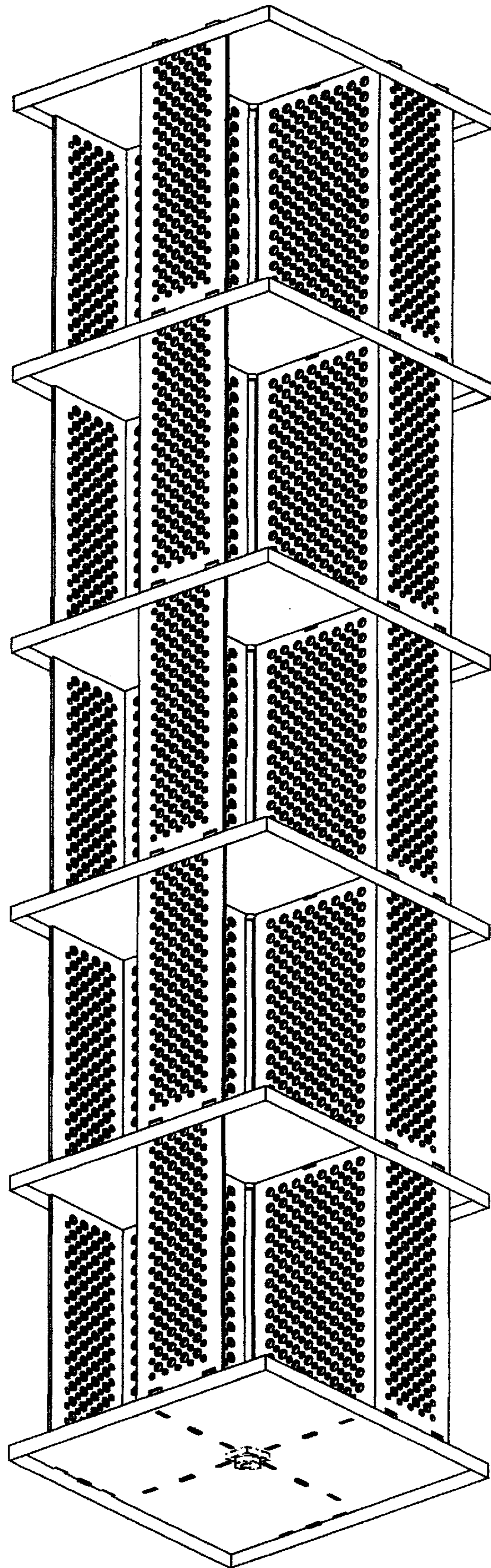
