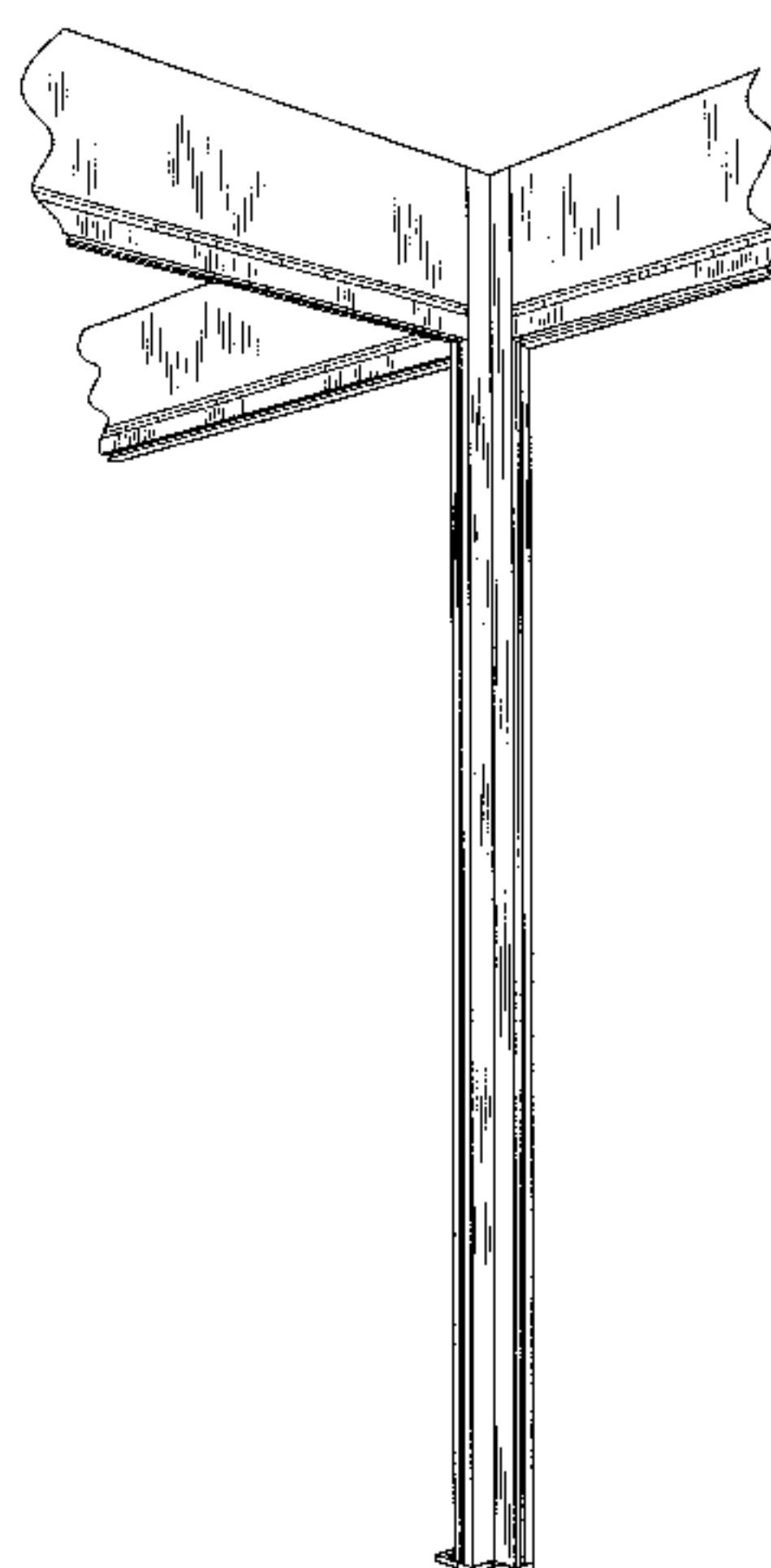
(57) **CLAIM**

The ornamental design for a furniture post and beam, as shown and described.

**DESCRIPTION**

FIG. 1 is perspective view of a furniture post and beam, showing our new design;  
 FIG. 2 is a front elevational view;  
 FIG. 3 is a right-hand side elevational view;  
 FIG. 4 is a rear elevational view;  
 FIG. 5 is a top plan view; and  
 FIG. 6 is a bottom plan view thereof.  
 FIG. 7 is a perspective view of another embodiment of our design;  
 FIG. 8 is a front elevational view of the embodiment shown in FIG. 7;  
 FIG. 9 is a top plan view of the embodiment shown in FIG. 7; and  
 FIG. 10 is a bottom plan view of the embodiment shown in FIG. 7.  
 FIG. 11 is a perspective view of yet another embodiment of our design;  
 FIG. 12 is a left-hand side elevational view of the embodiment shown in FIG. 11;  
 FIG. 13 is a rear elevational view of the embodiment shown in FIG. 11;  
 FIG. 14 is a top plan view of embodiment shown in FIG. 11; and  
 FIG. 15 is a bottom plan view of the embodiment shown in FIG. 11.  
 FIG. 16 is a perspective view of yet another embodiment of the present design;  
 FIG. 17 is a front elevational view of the embodiment shown in FIG. 16;  
 FIG. 18 is a rear elevational view of the embodiment shown in FIG. 16;  
 FIG. 19 is a top plan view of the embodiment shown in FIG. 16; and,  
 FIG. 20 is a bottom plan view of the embodiment shown in FIG. 16.  
 The beams are shown cut away in the views to indicate indeterminate length.

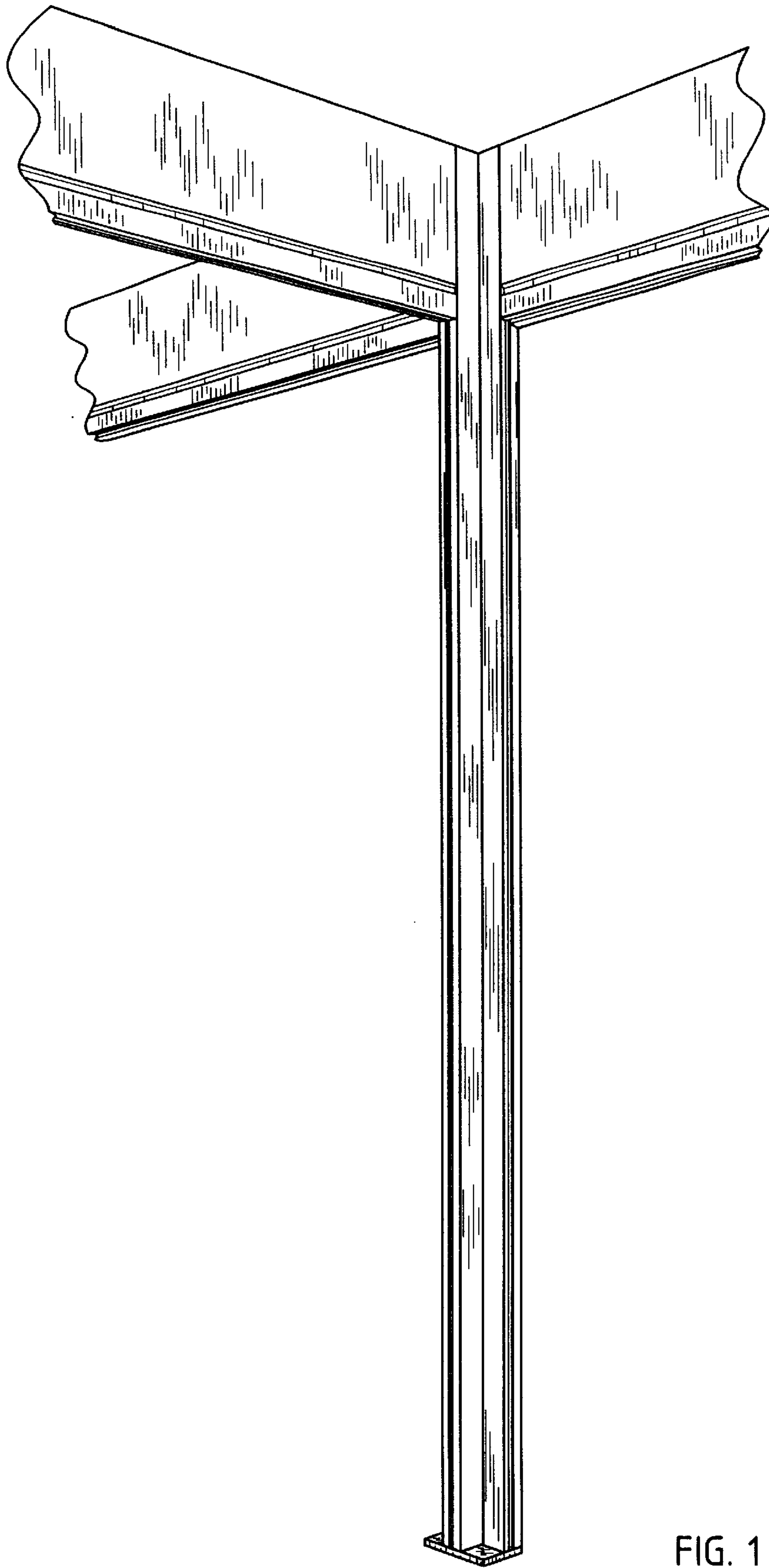

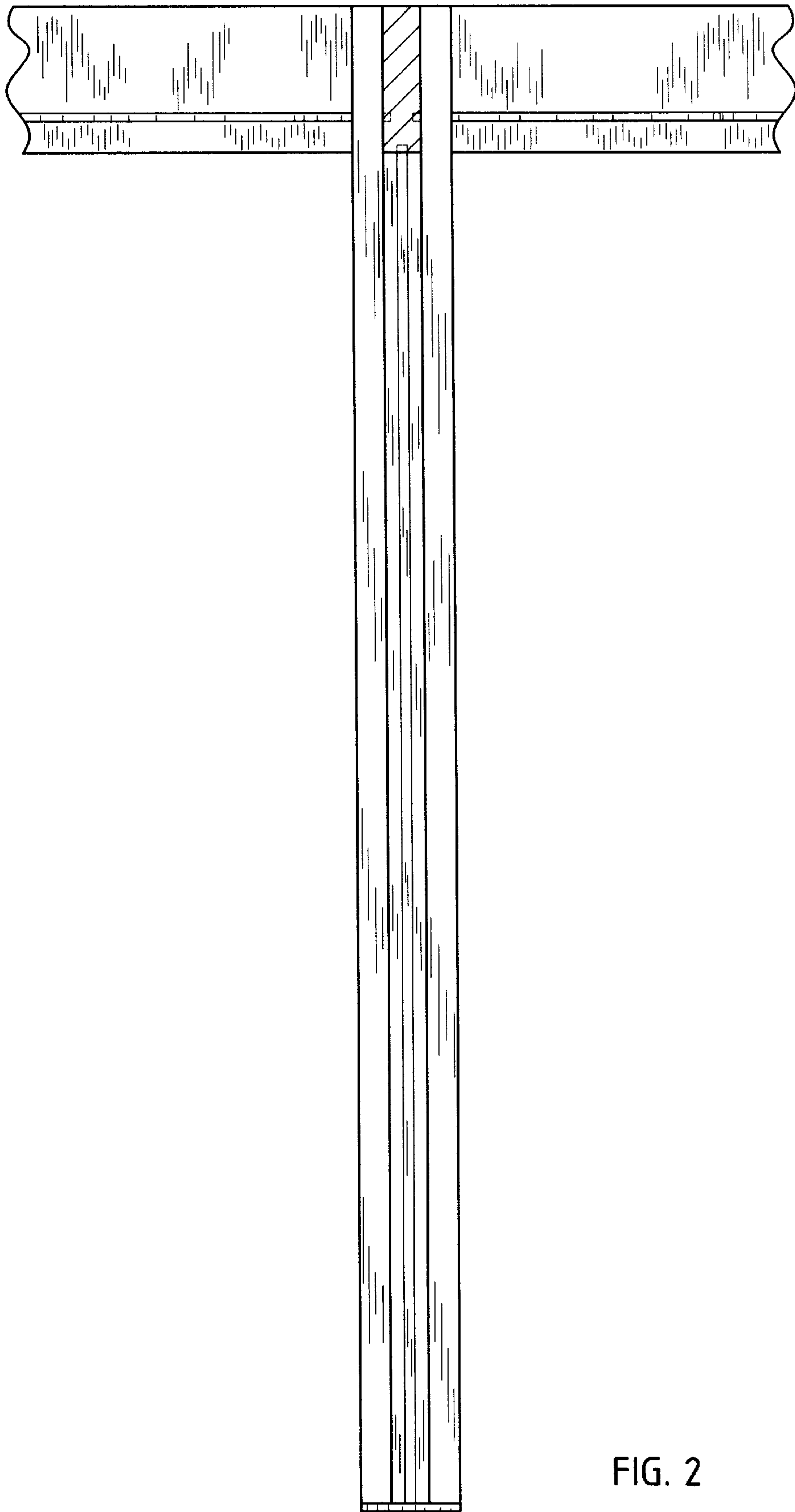

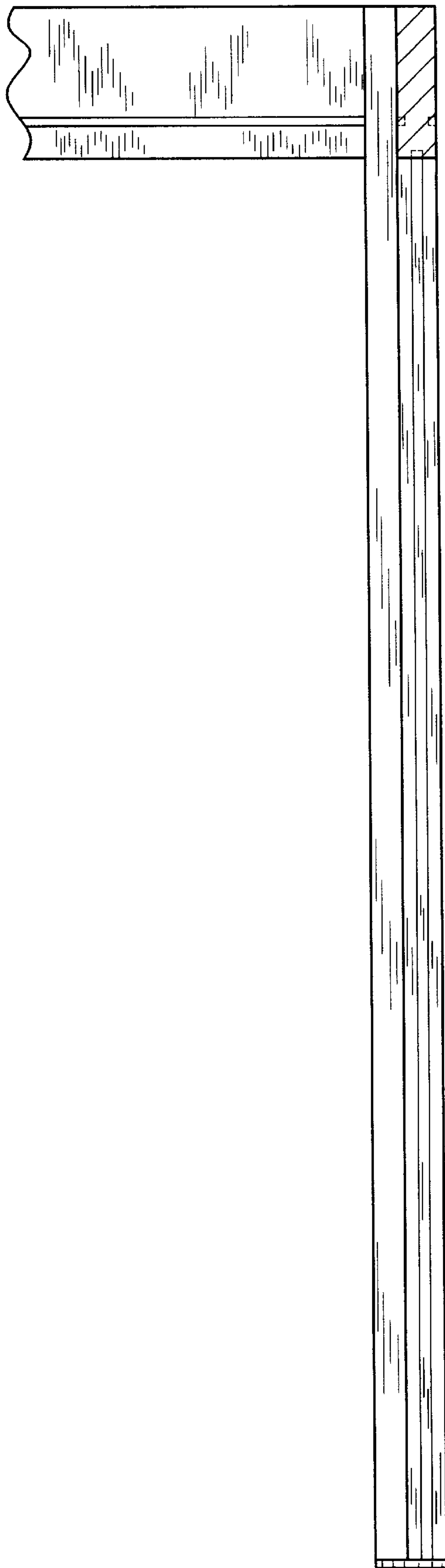

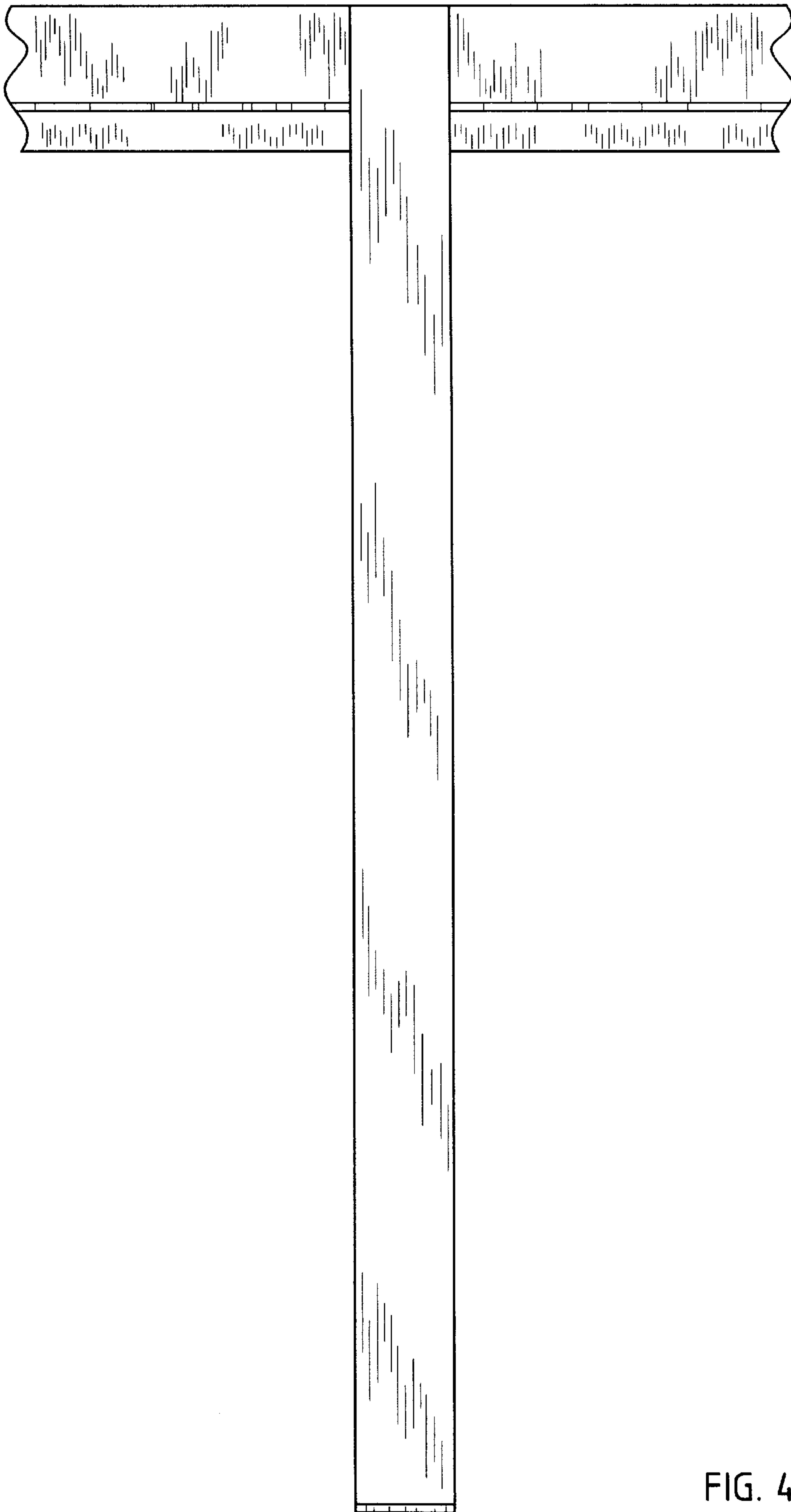

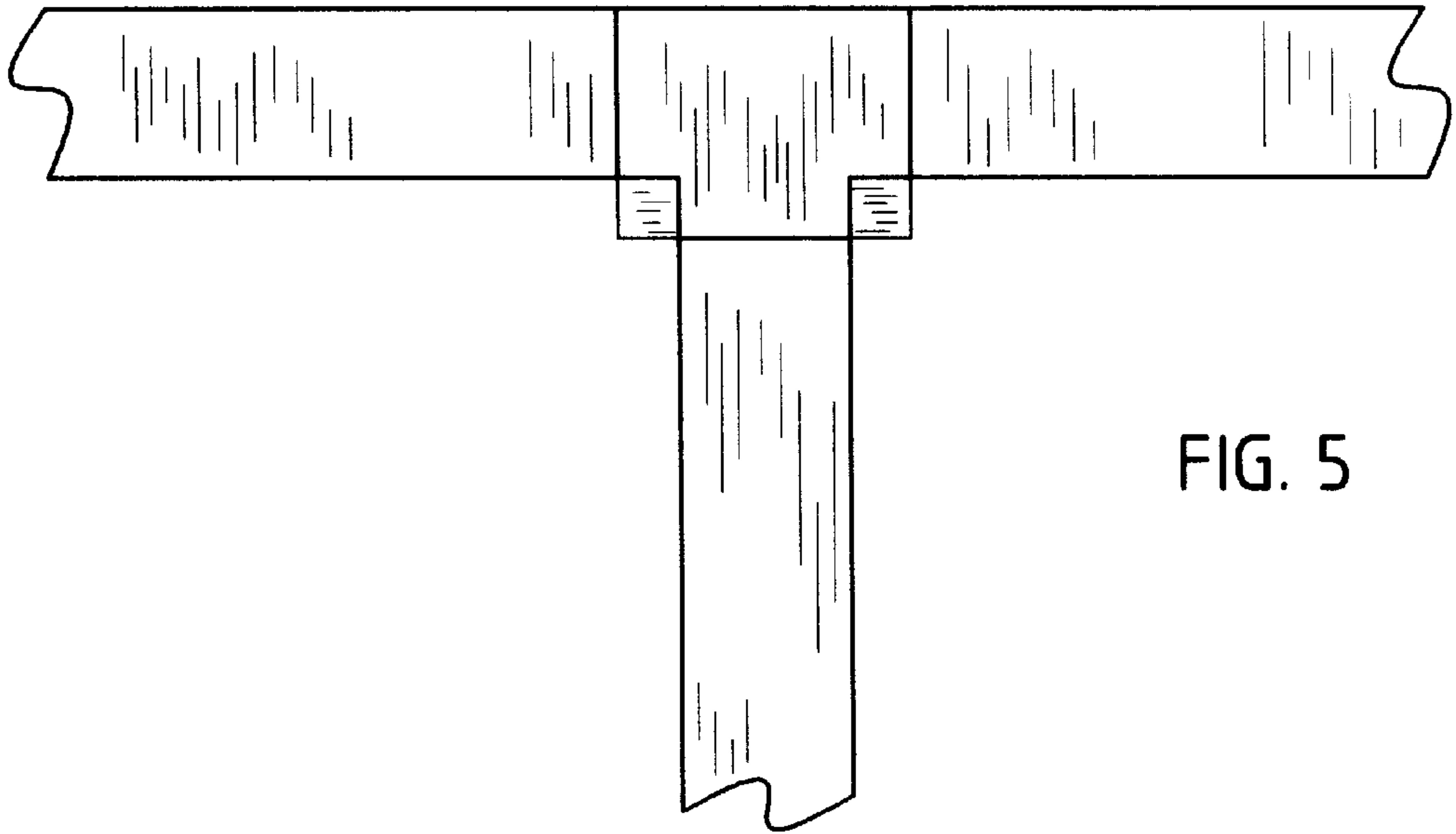

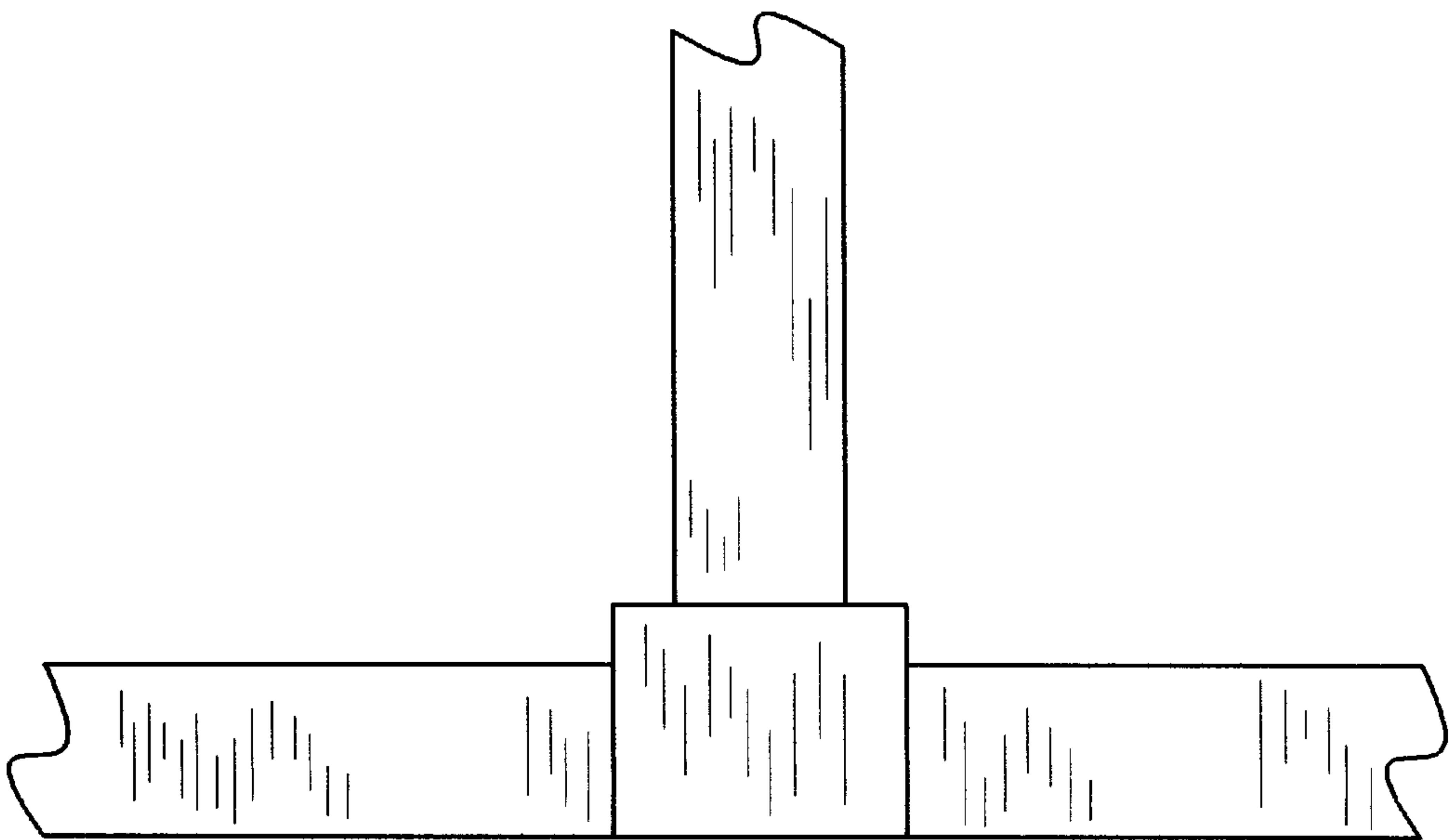

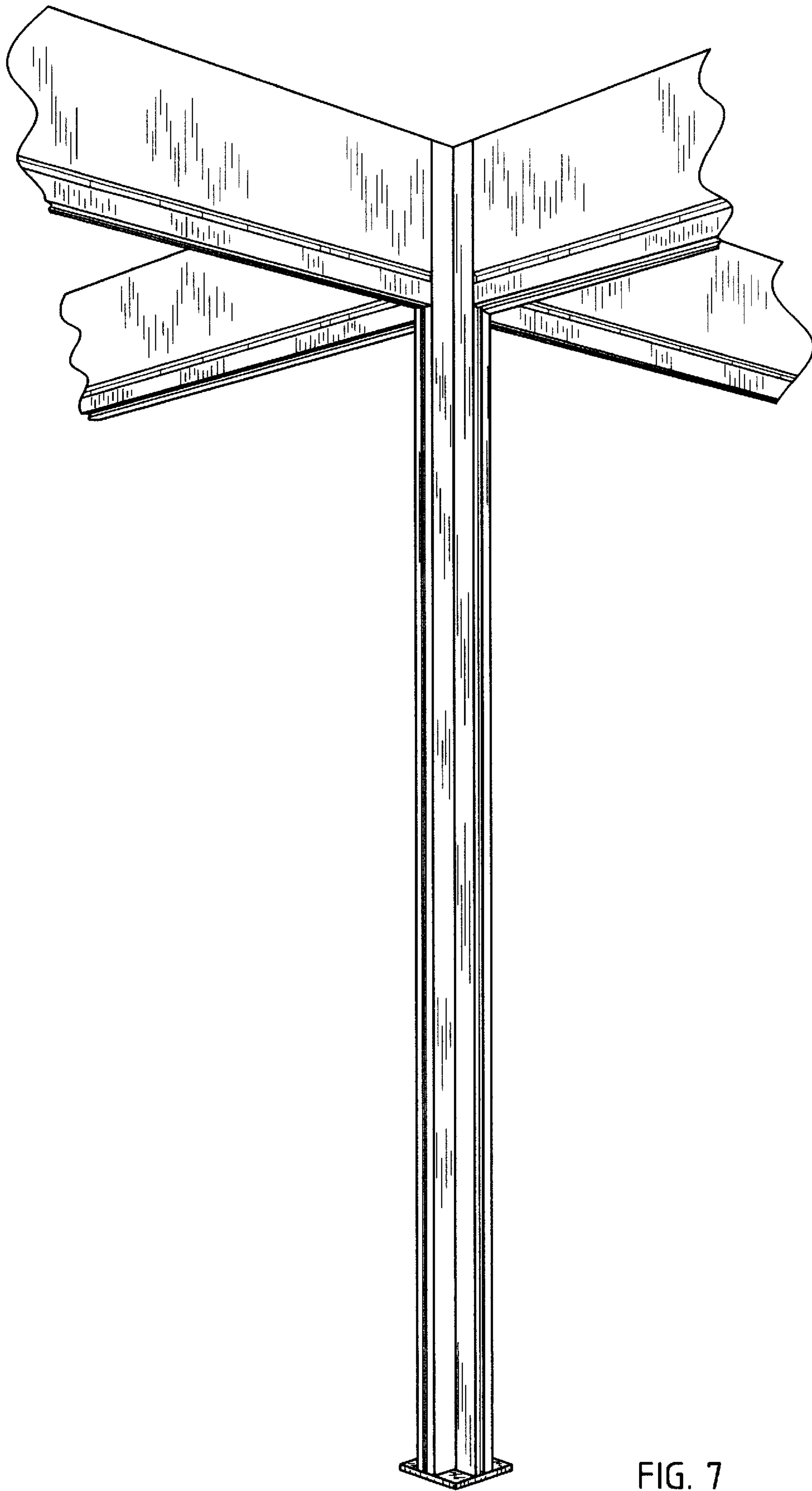

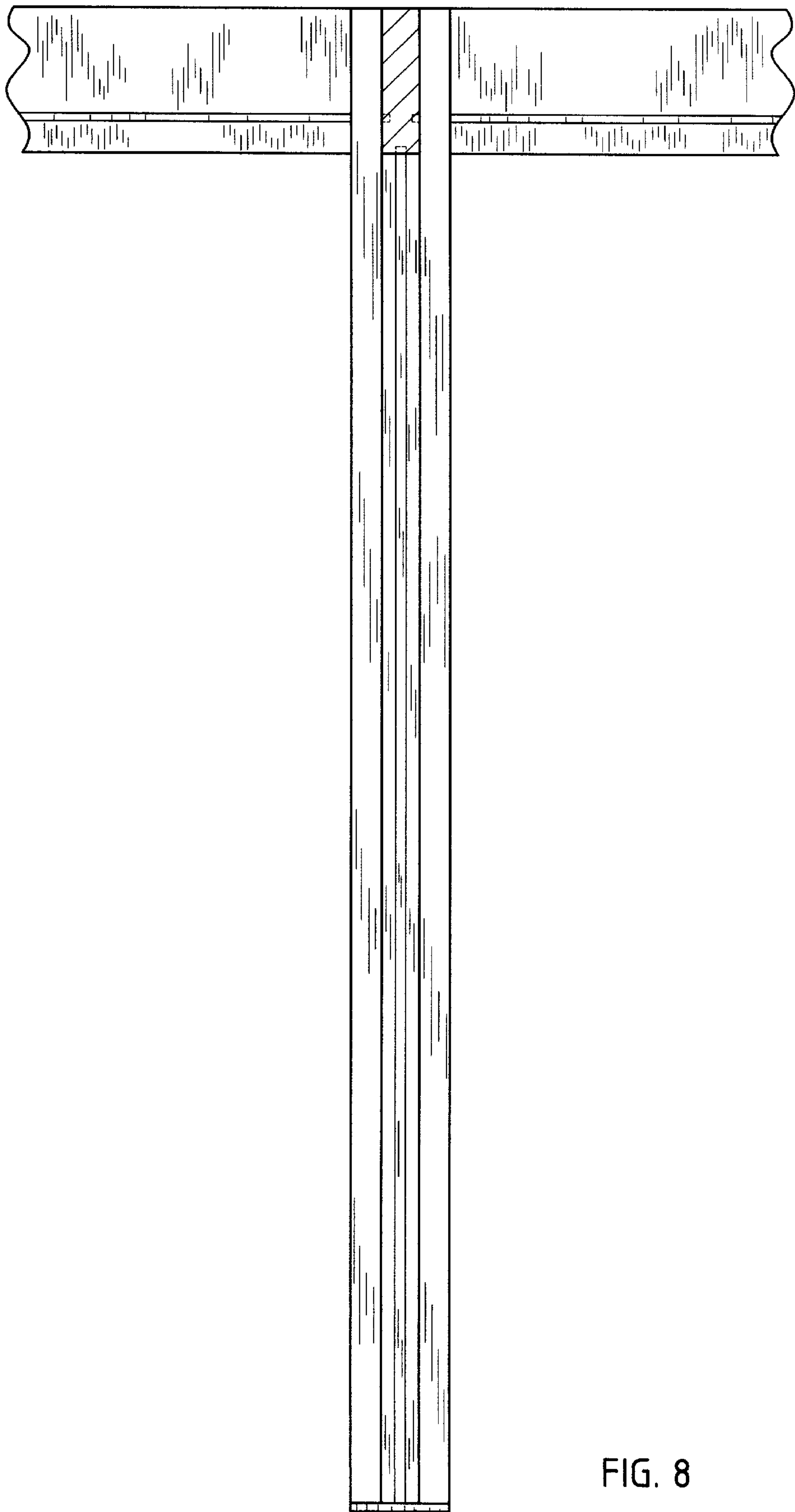
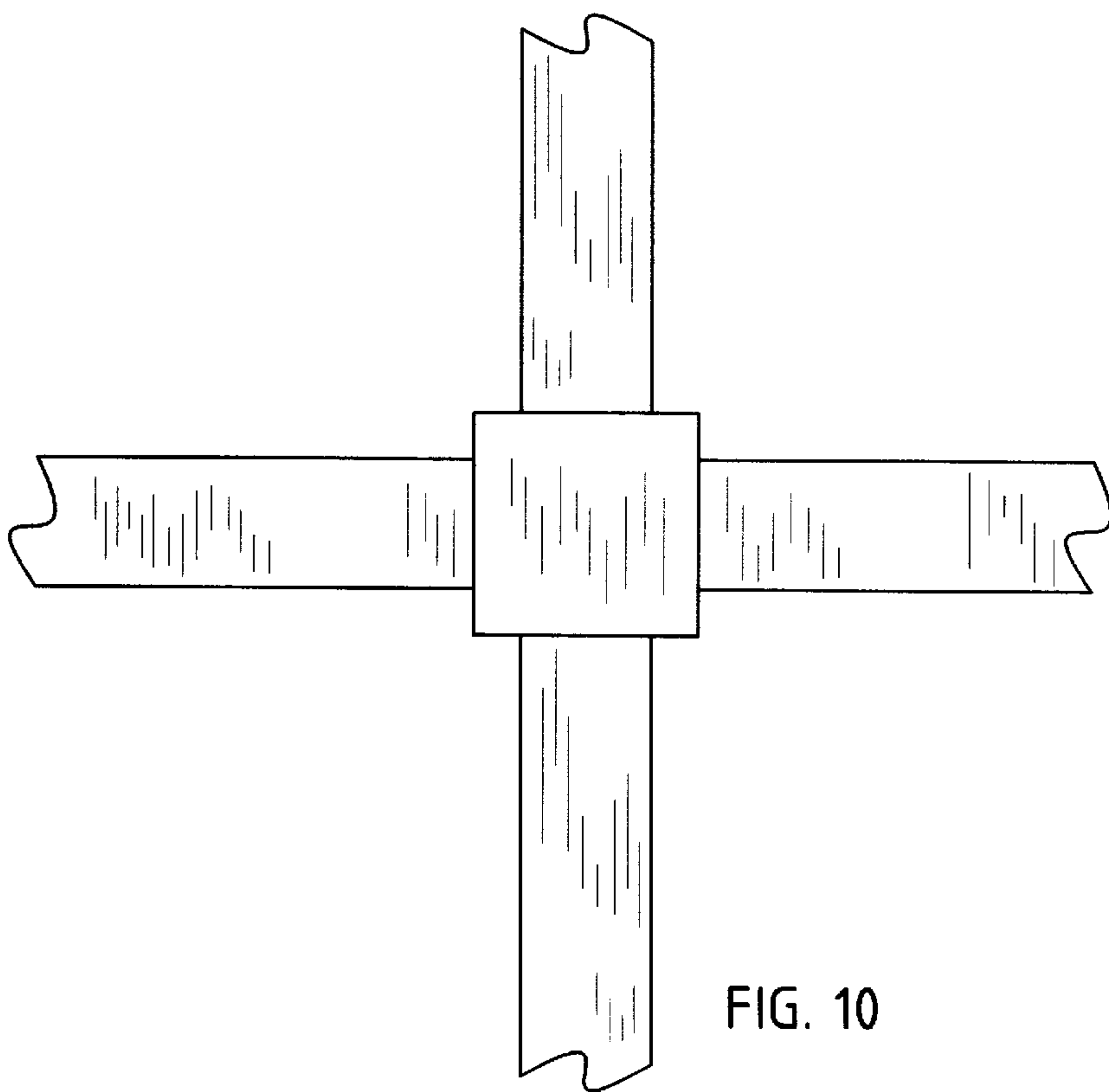
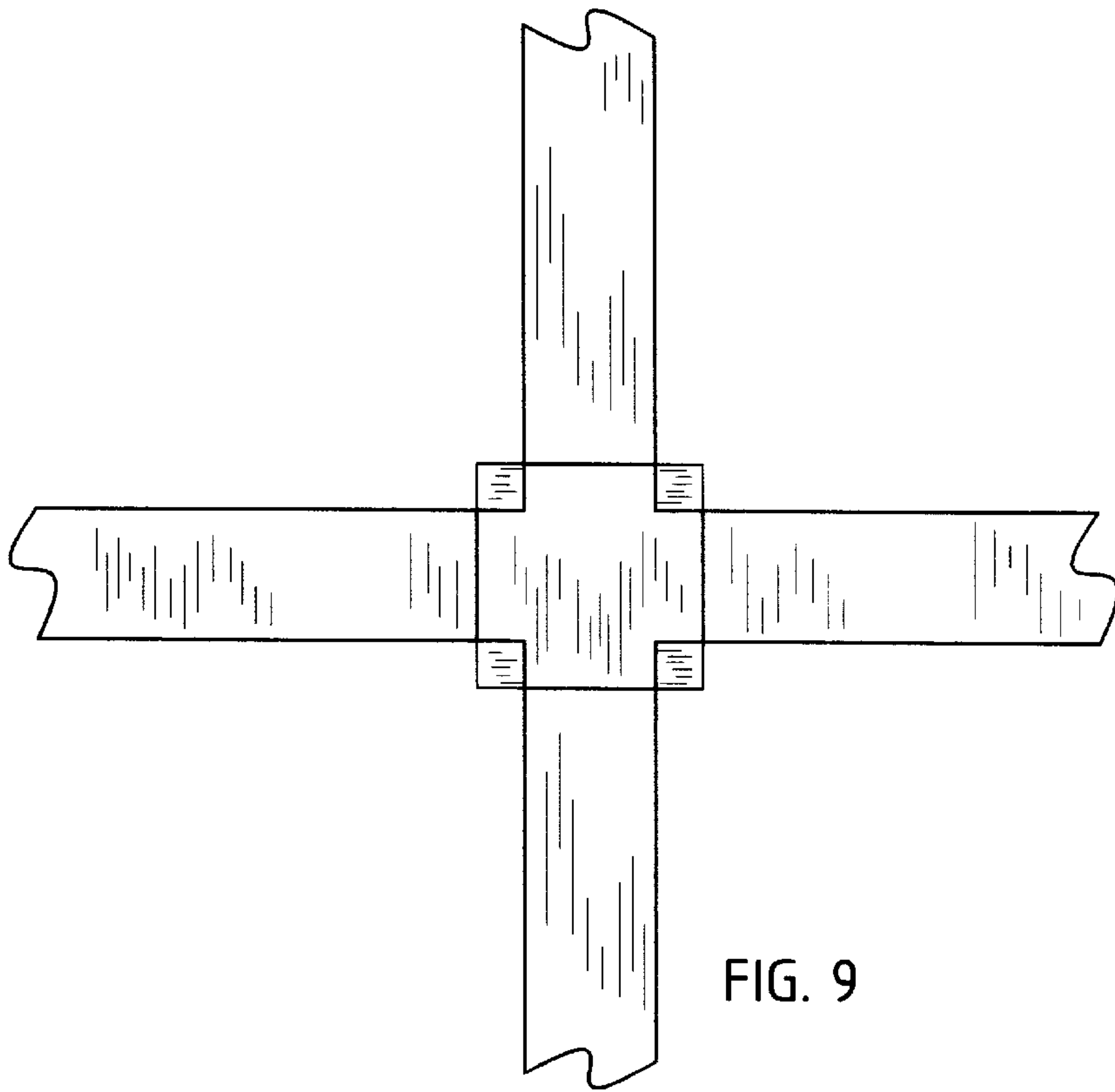

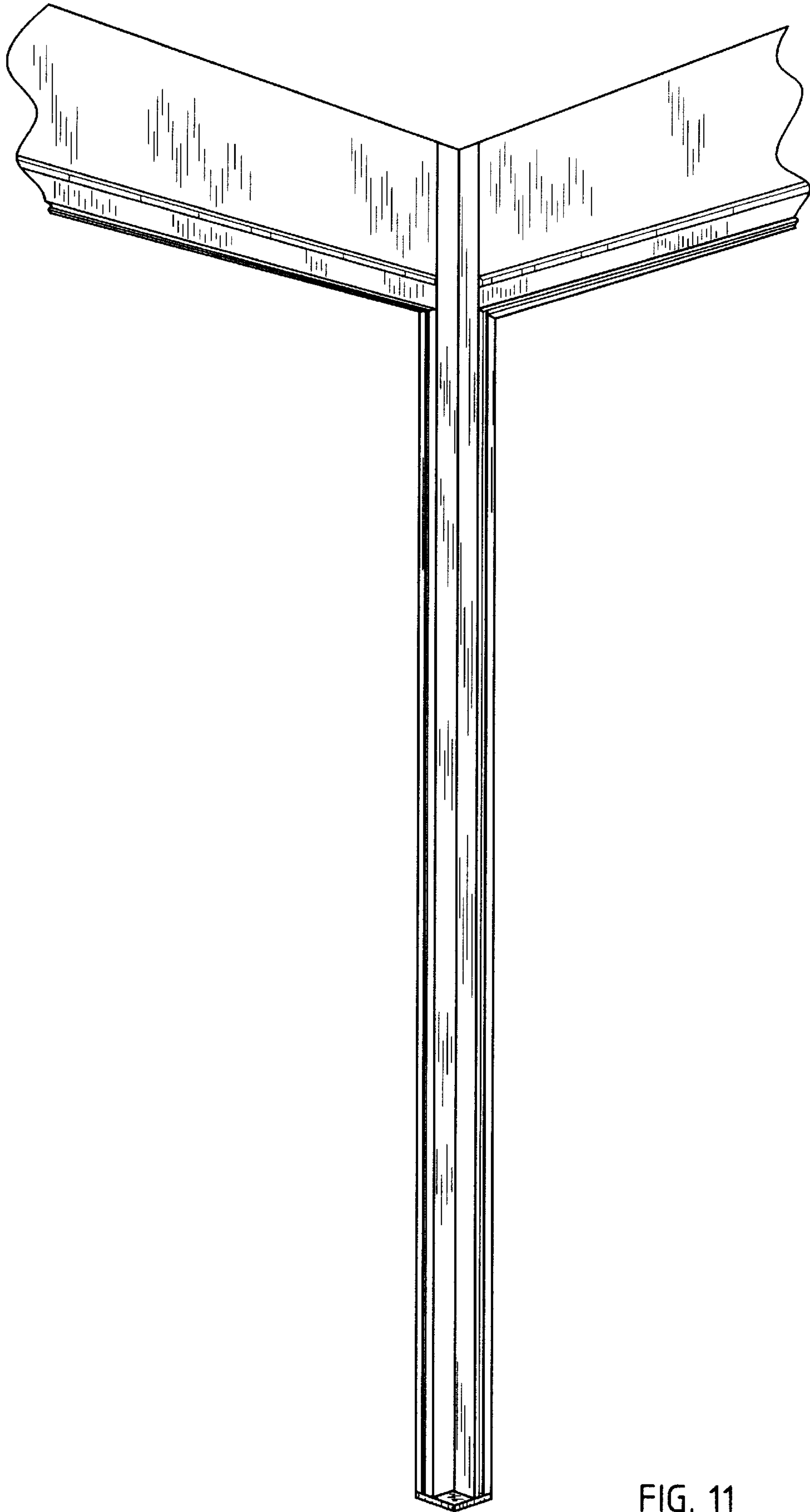

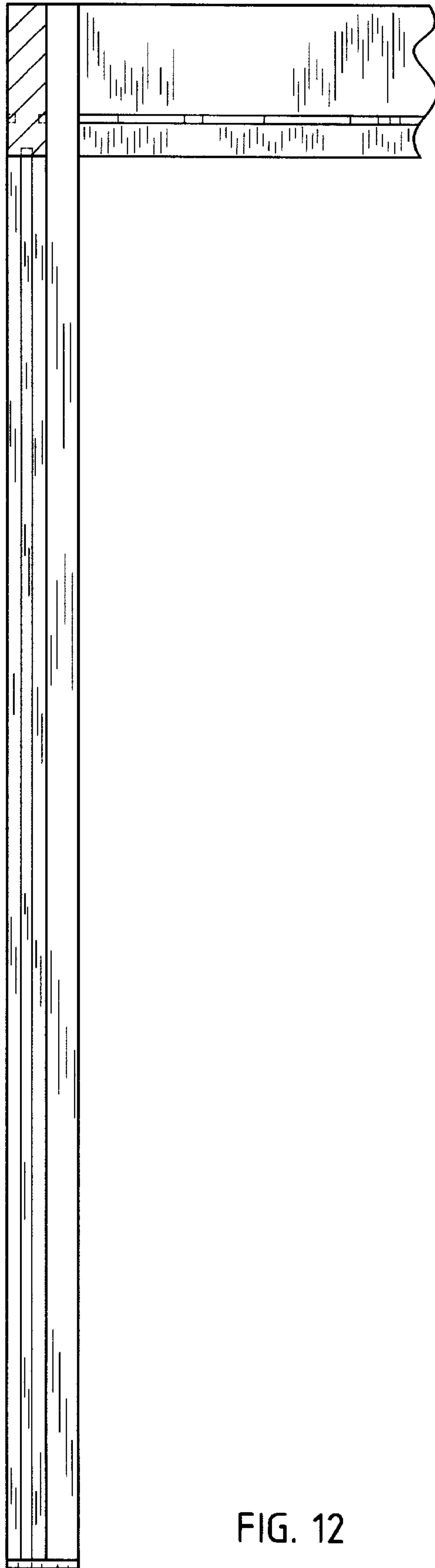

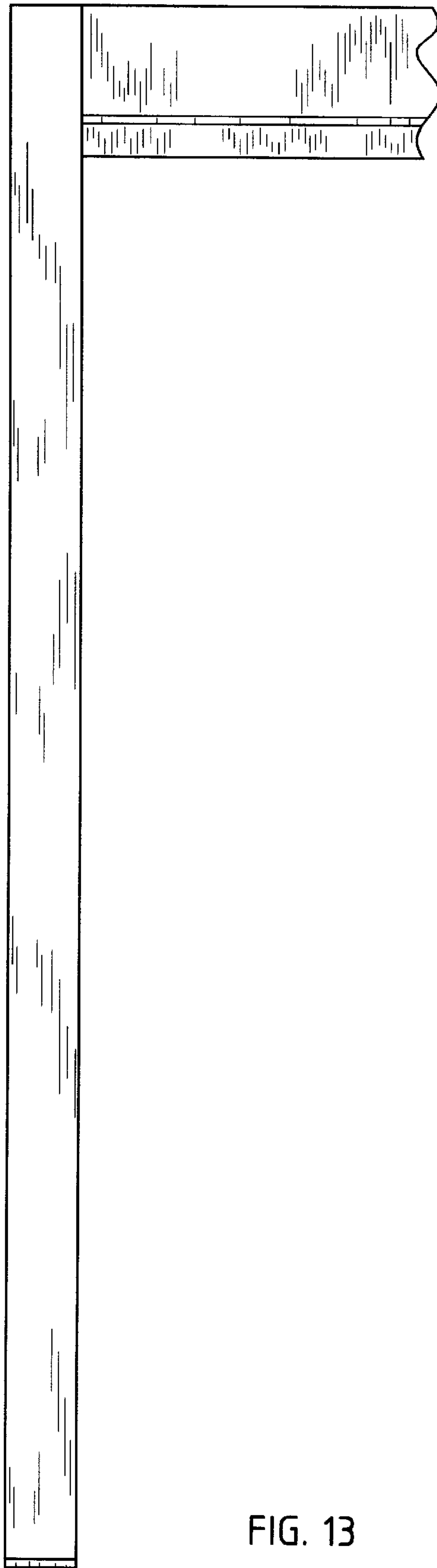

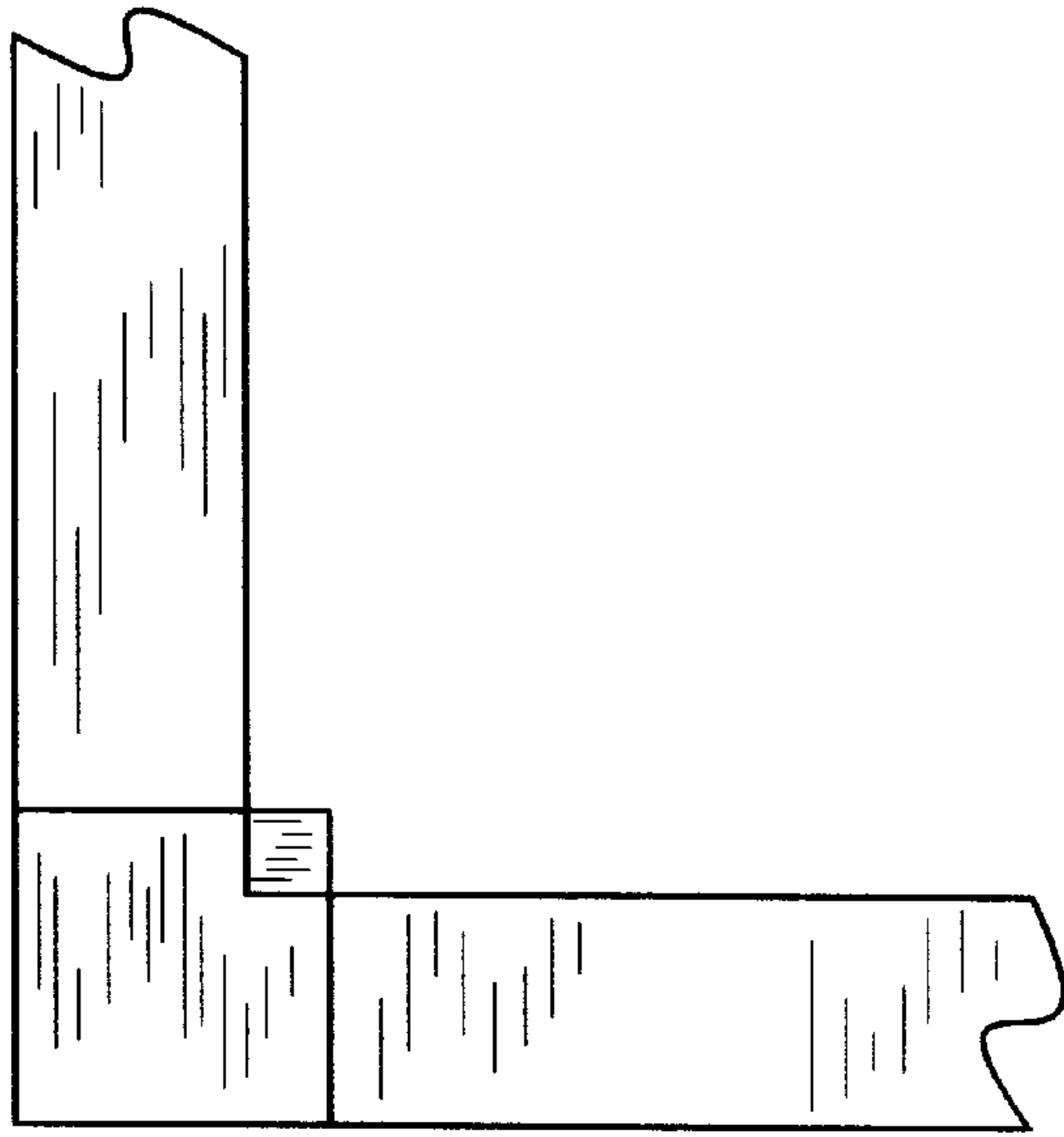

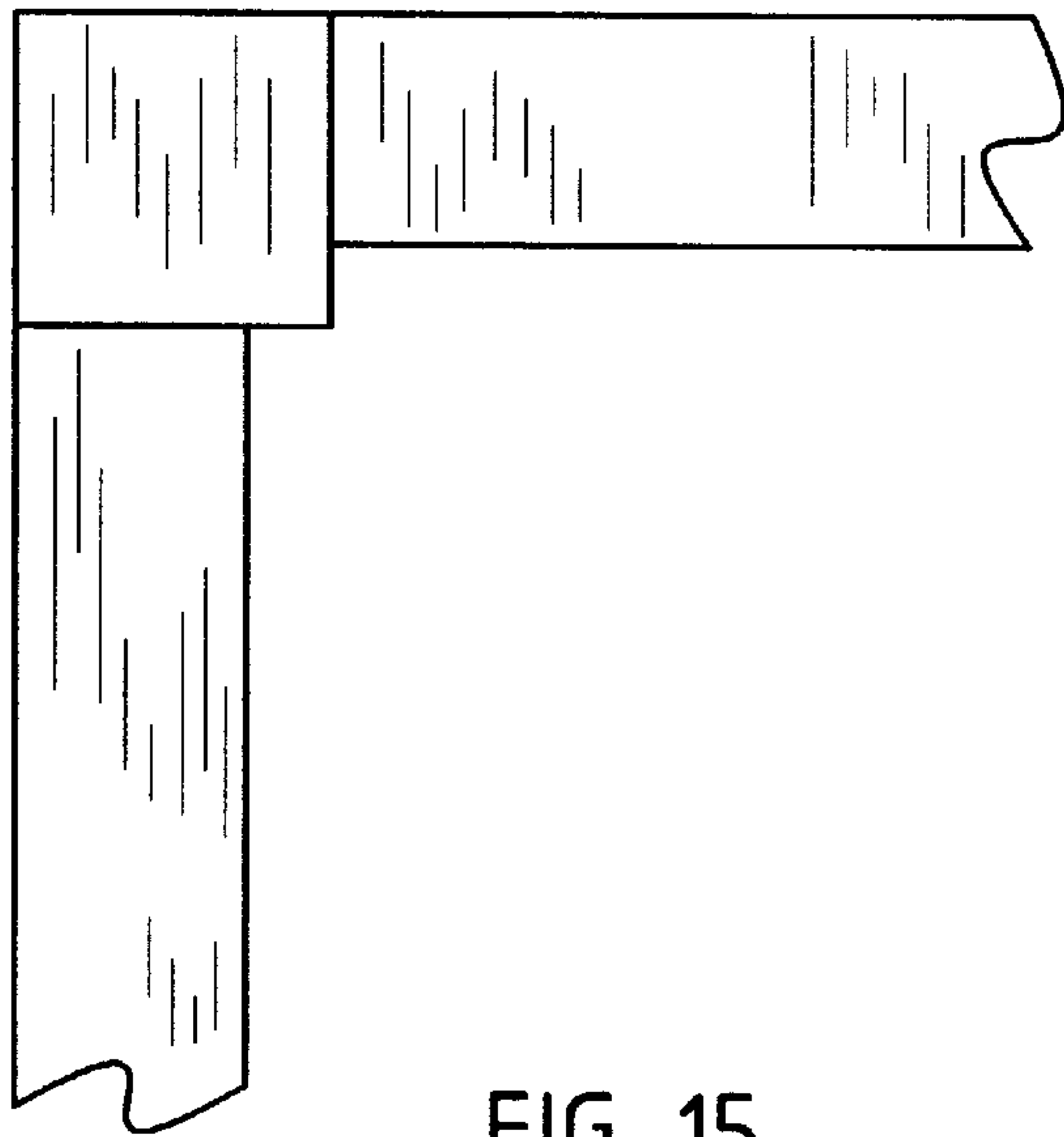

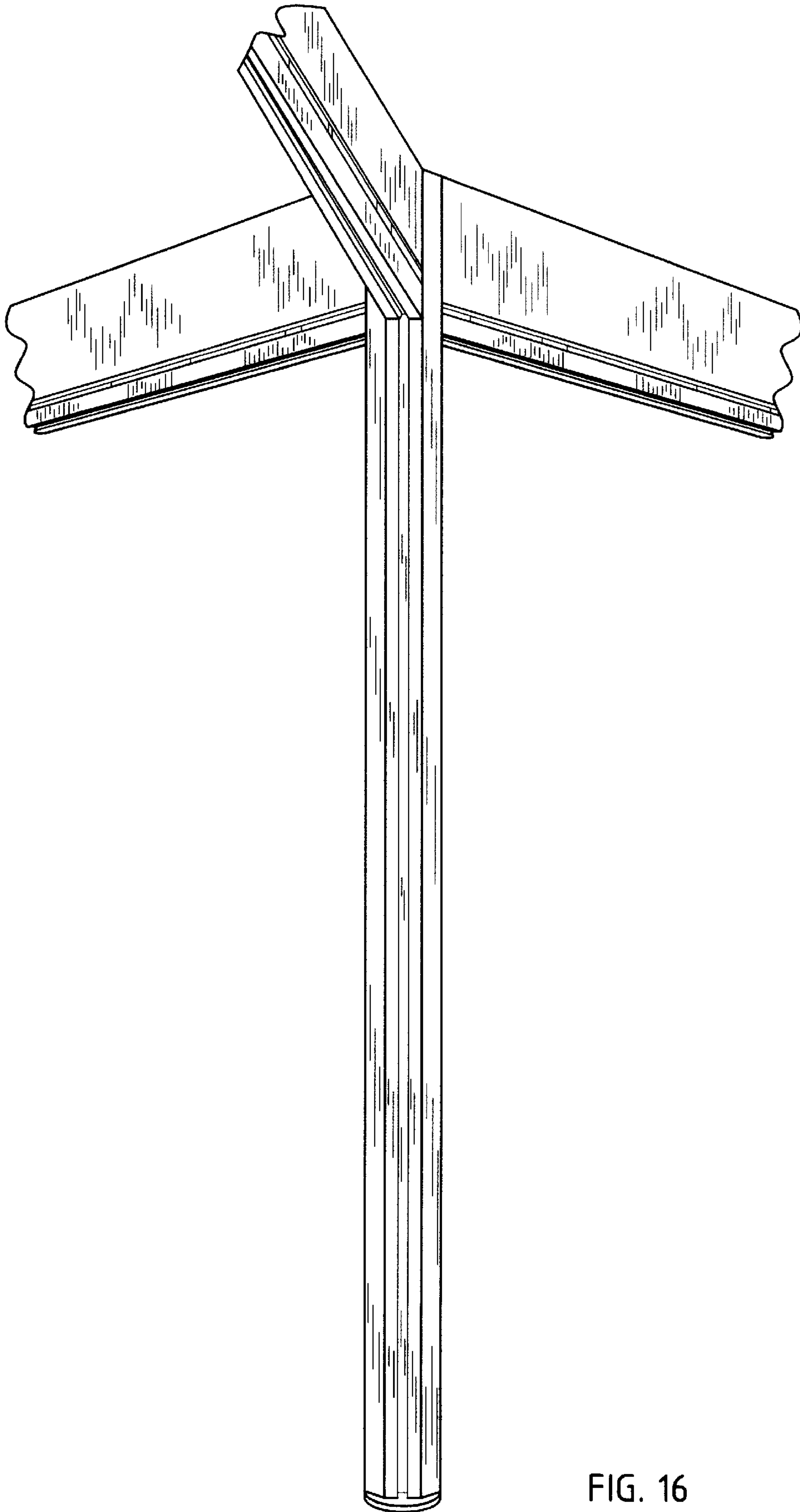

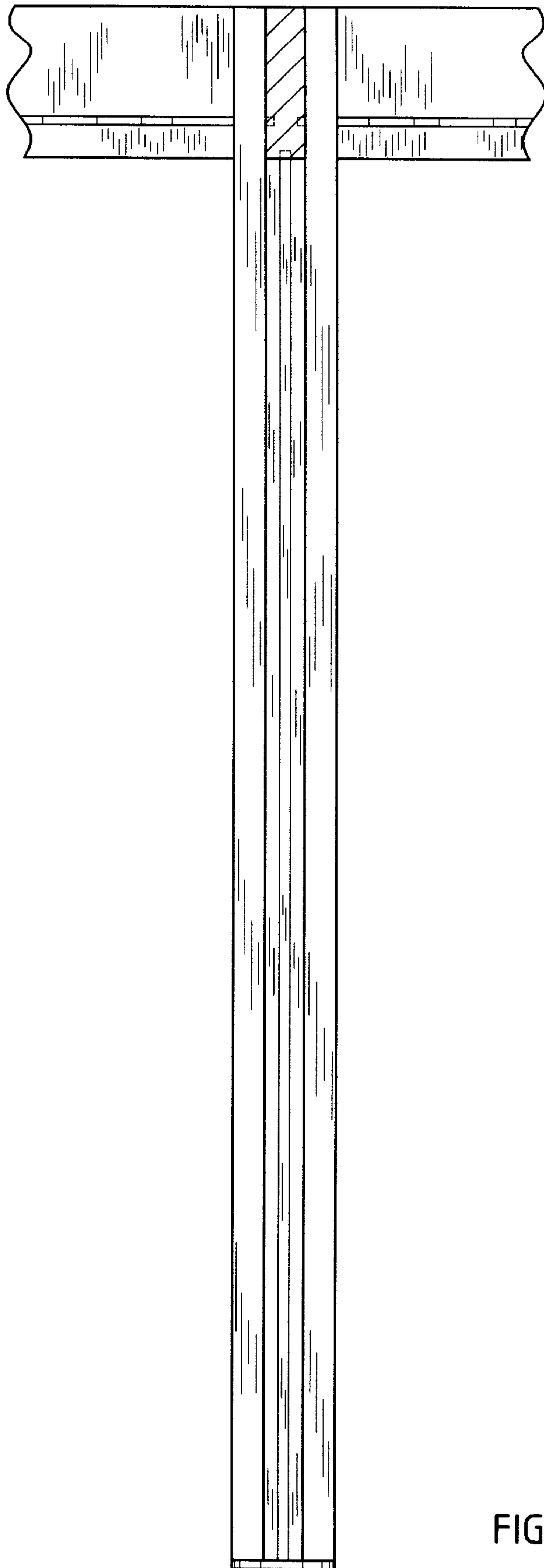

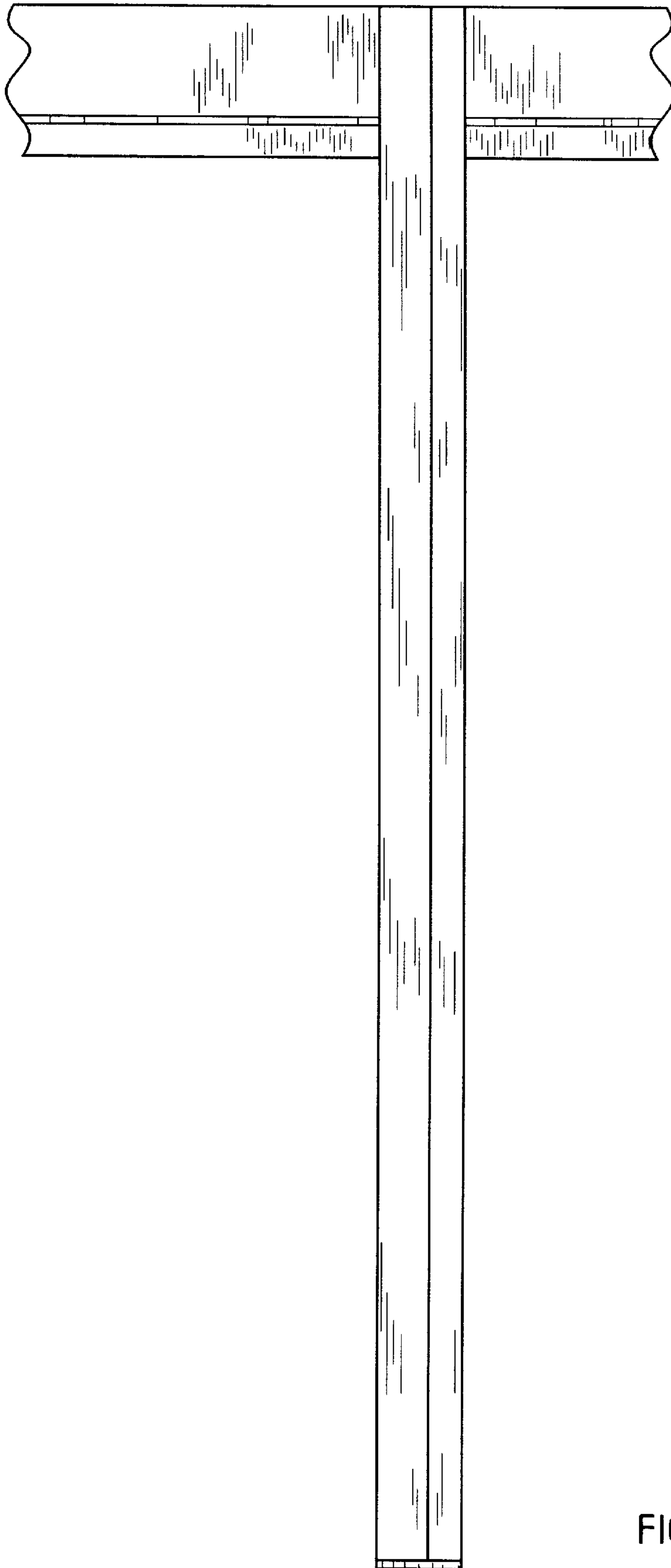

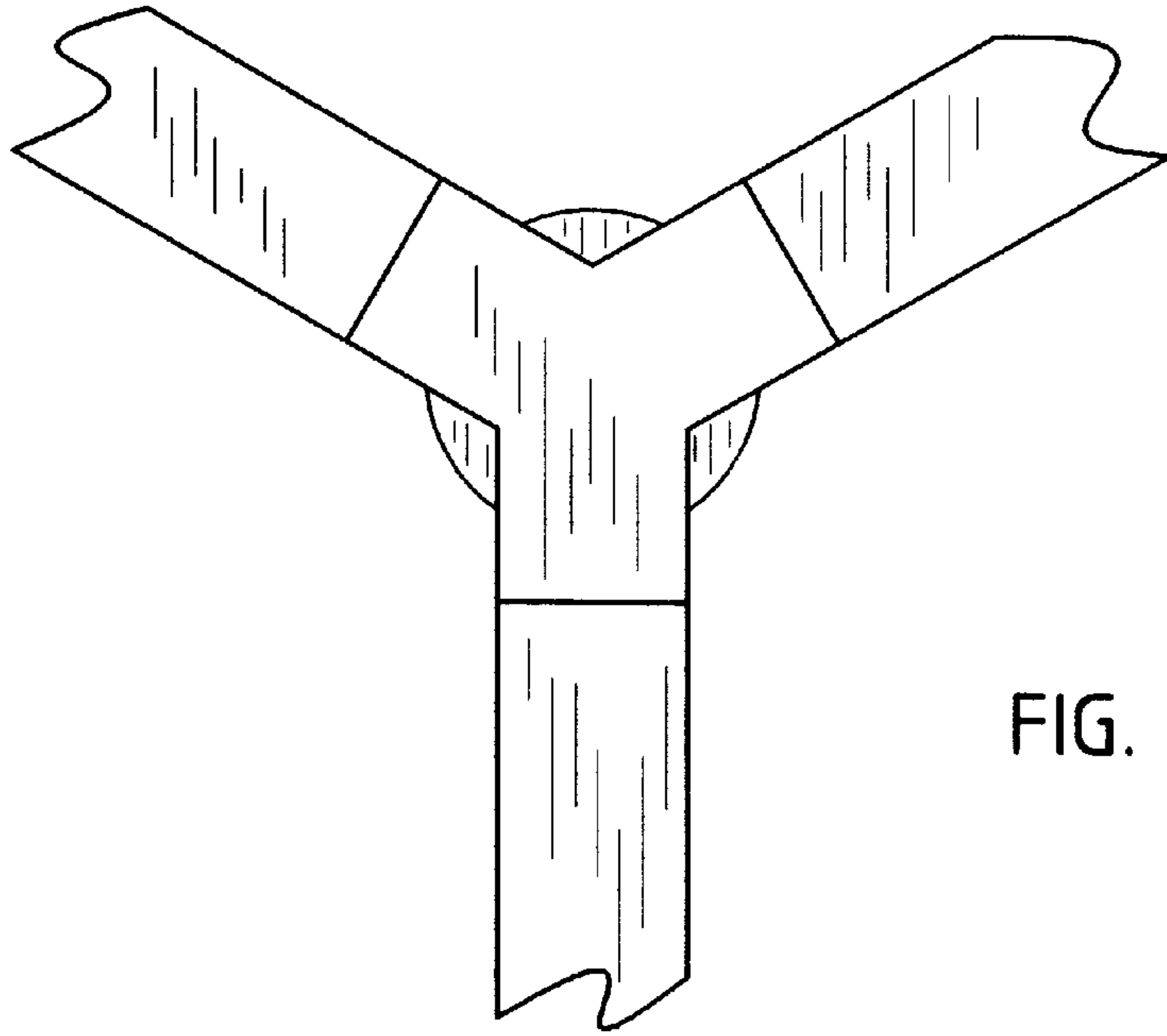

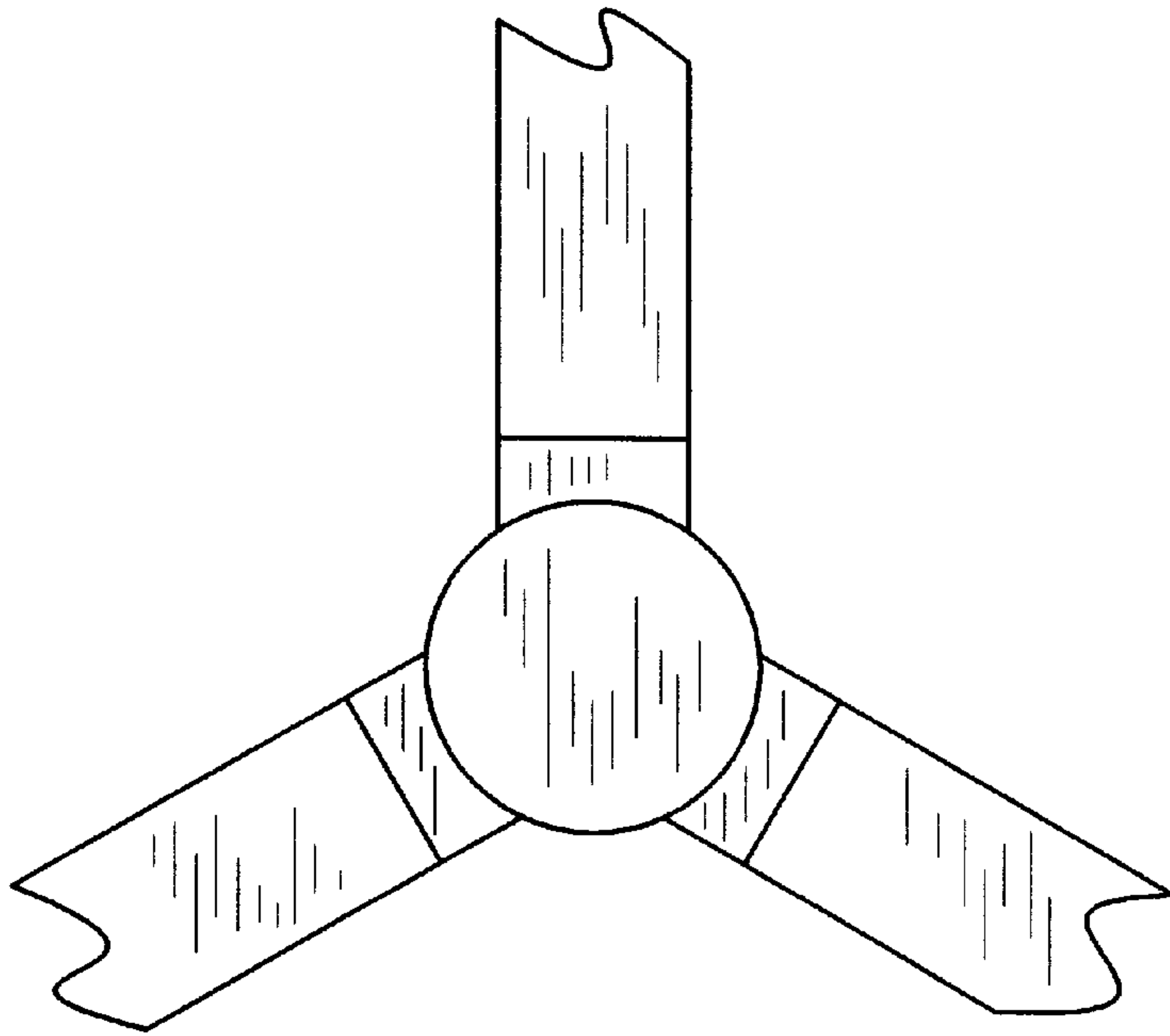
