(57) **CLAIM**

The ornamental design for an automatic basket lifting fryer, as shown.

**DESCRIPTION**

FIG. 1 is a front view of an automatic basket lifting fryer according to the present design.

FIG. 2 is a rear view of the automatic basket lifting fryer depicted in FIG. 1.

FIG. 3 is a left side view of the automatic basket lifting fryer depicted in FIG. 1.

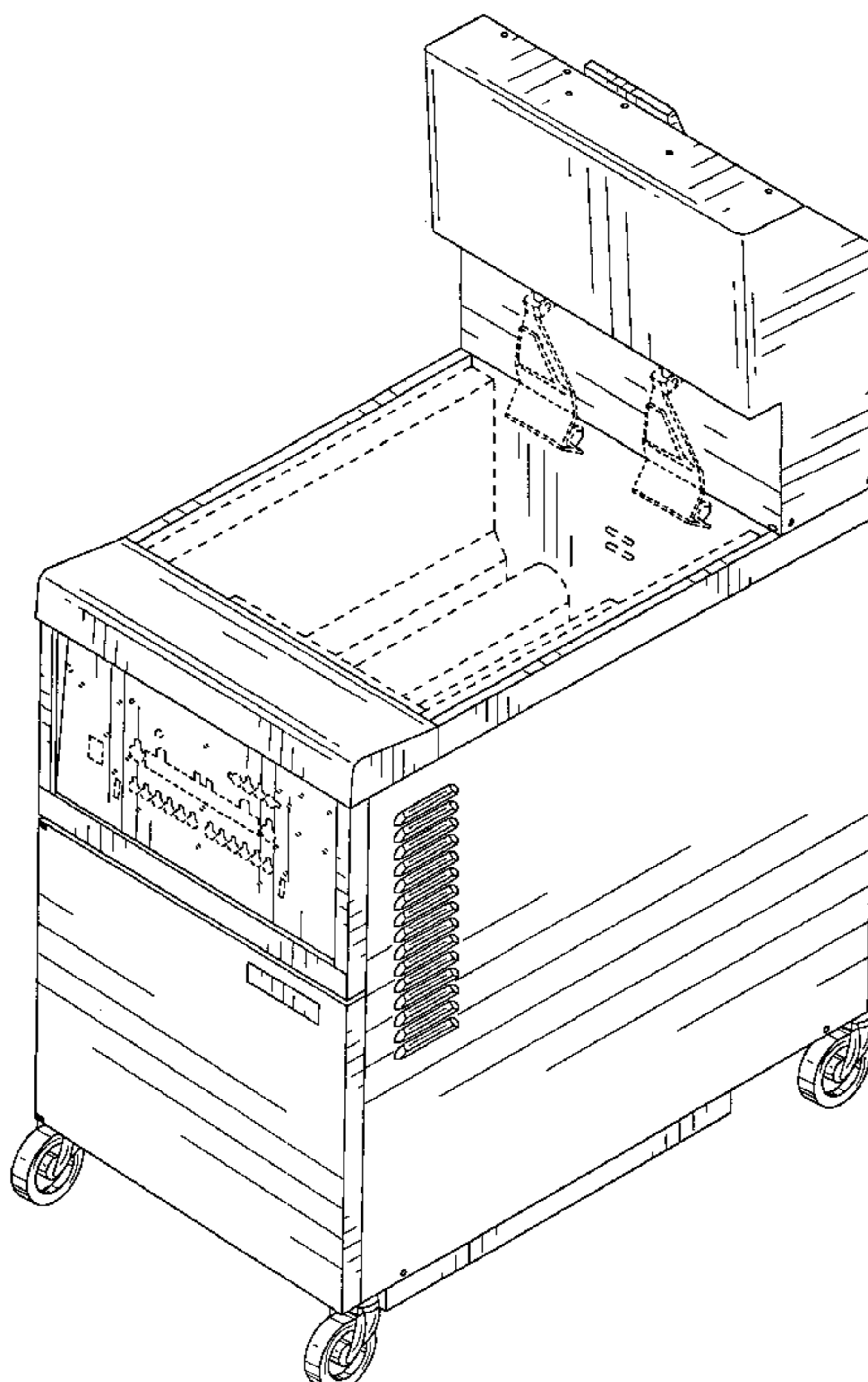
FIG. 4 is a right side view of the automatic basket lifting fryer depicted in FIG. 1.

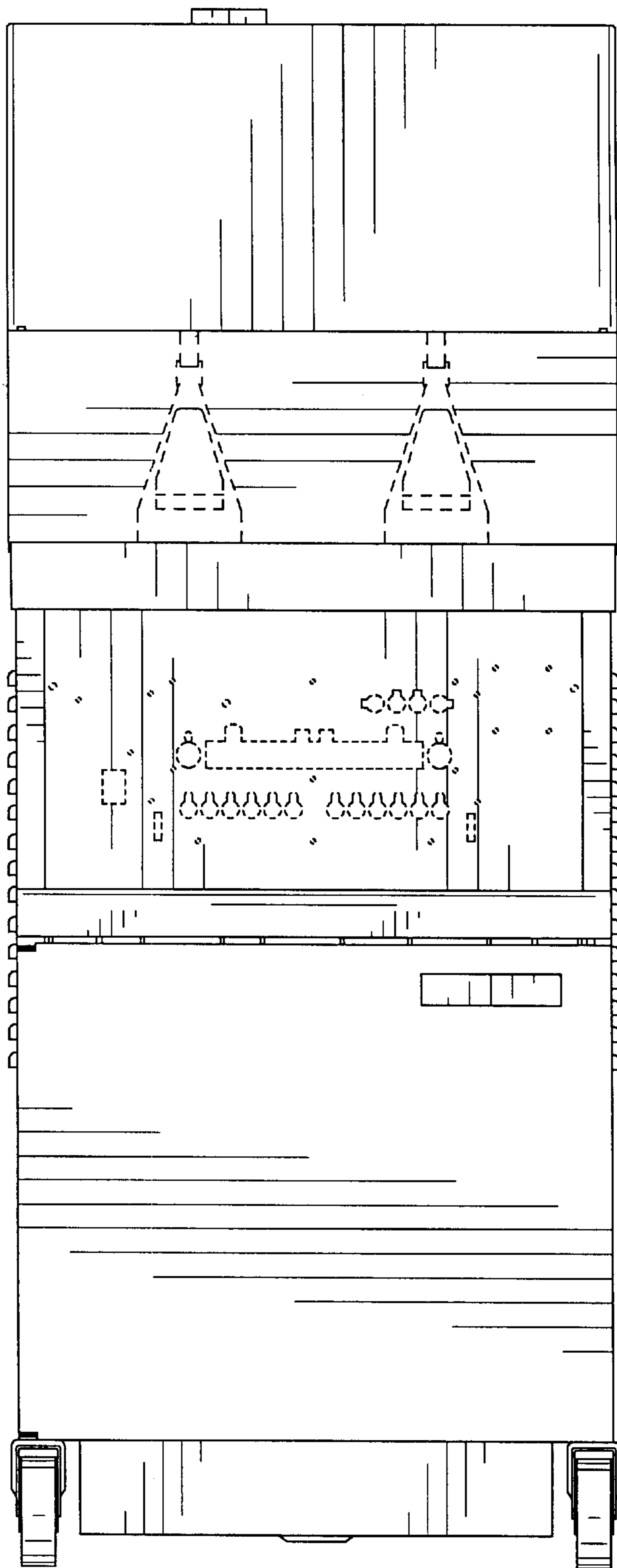

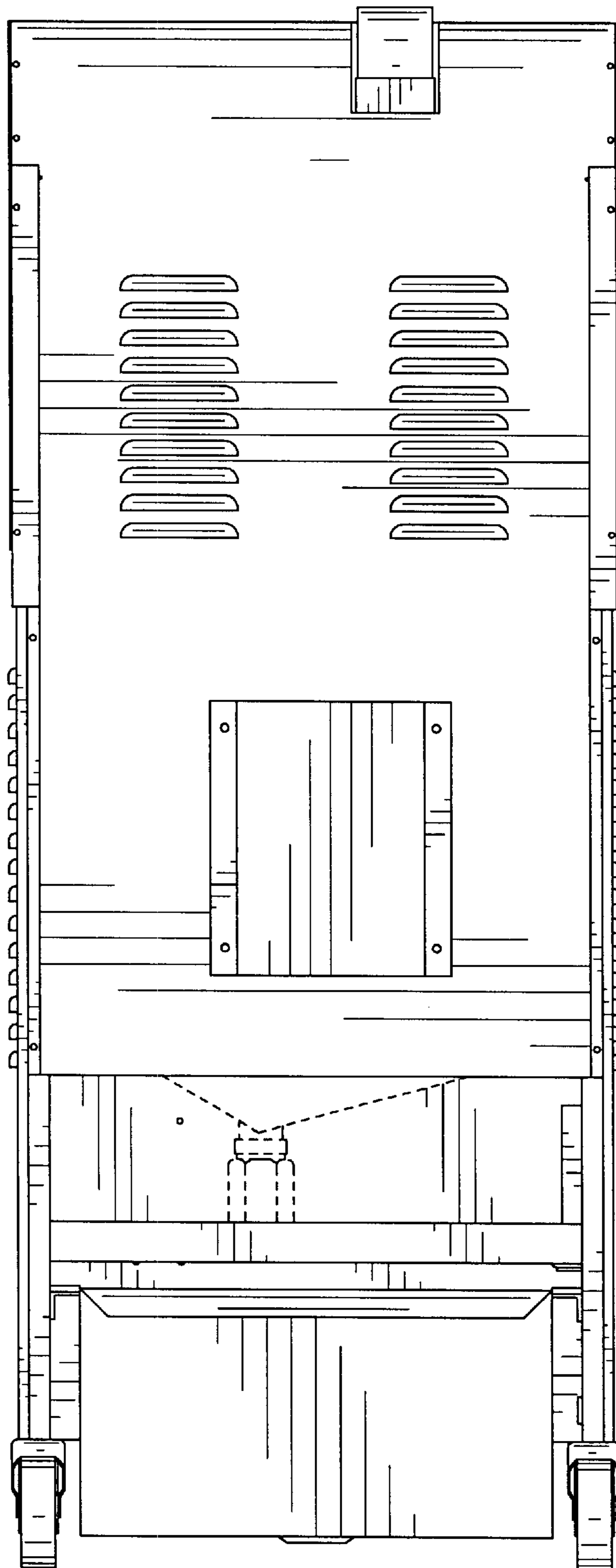

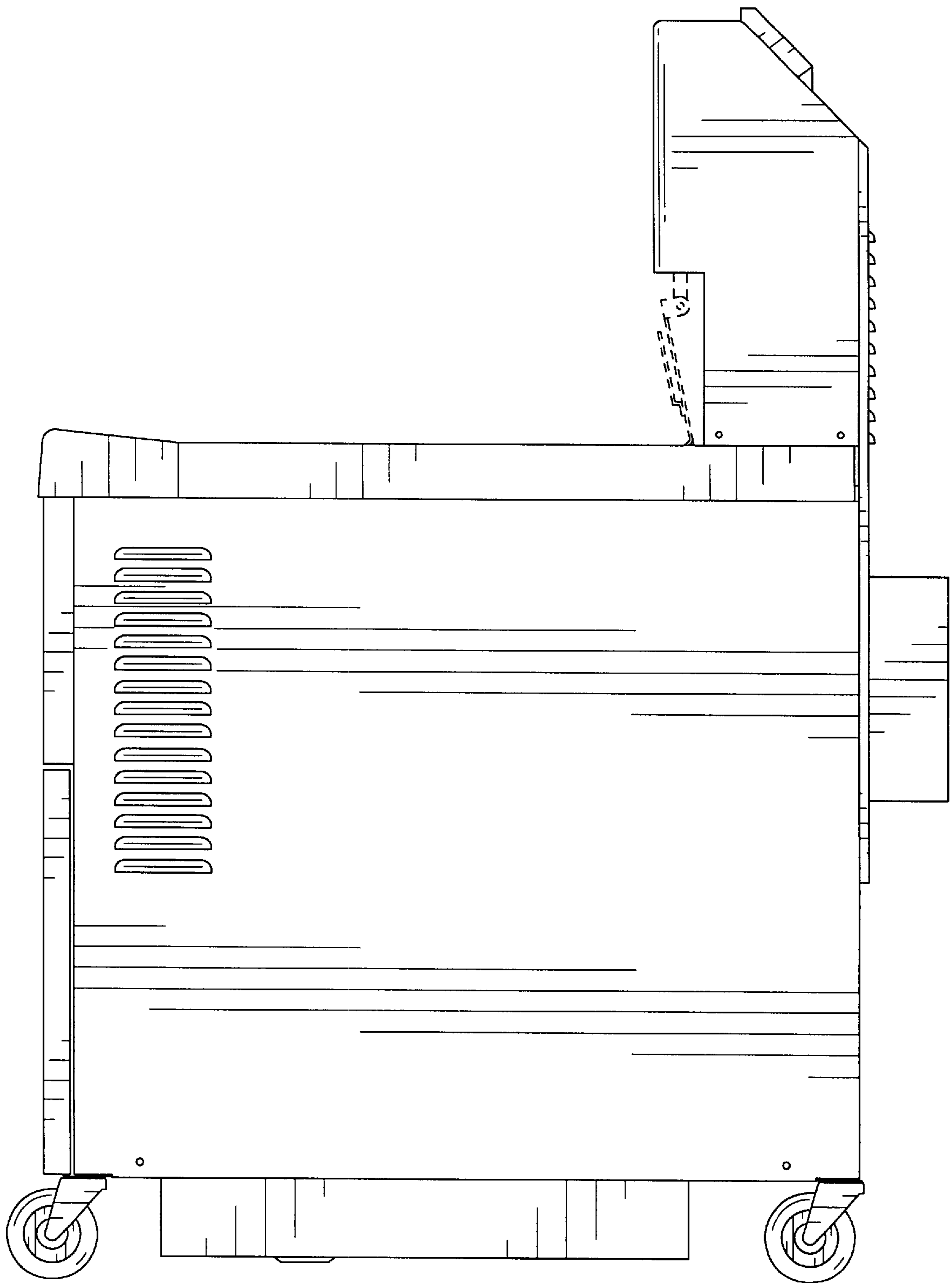

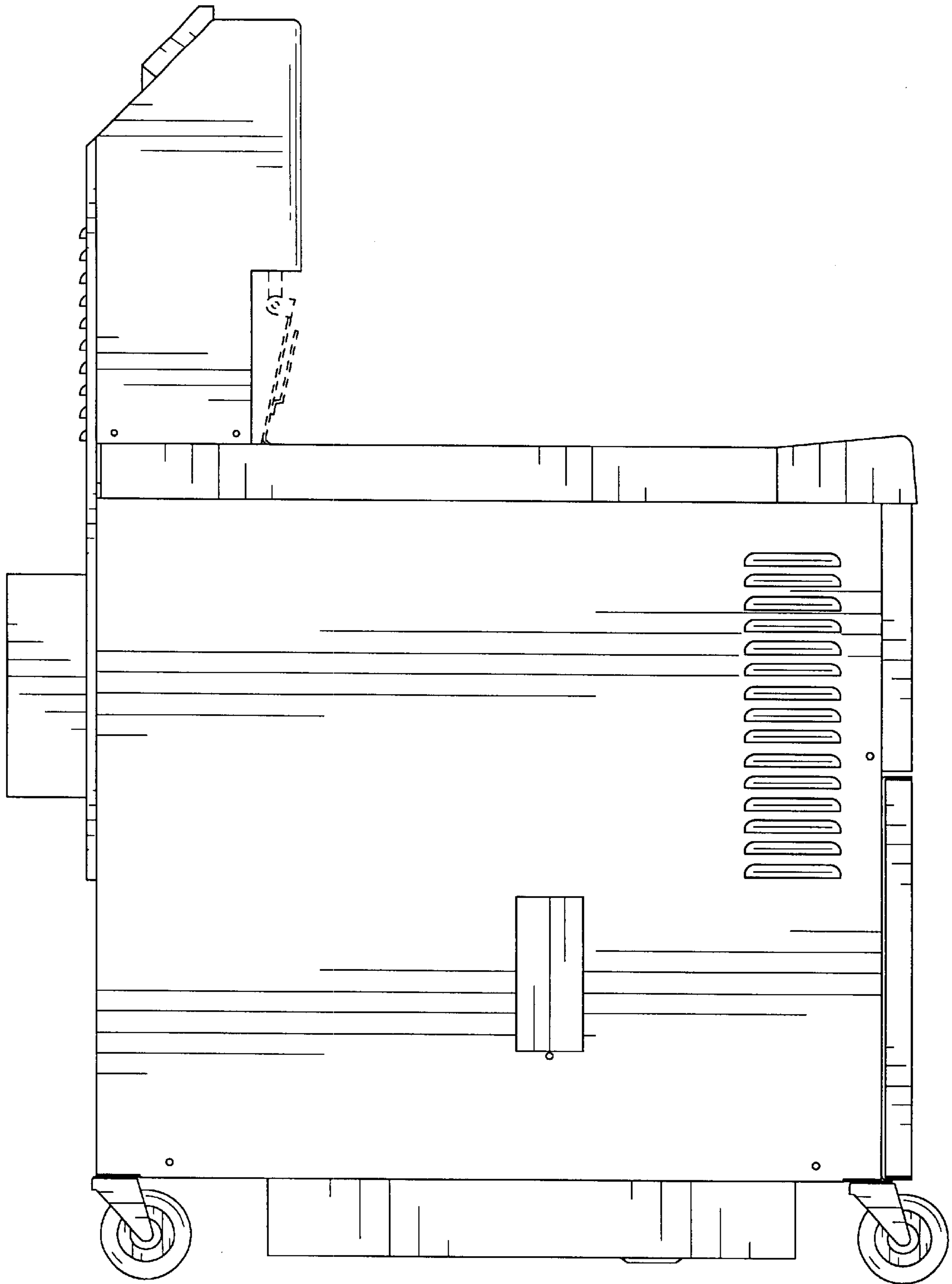

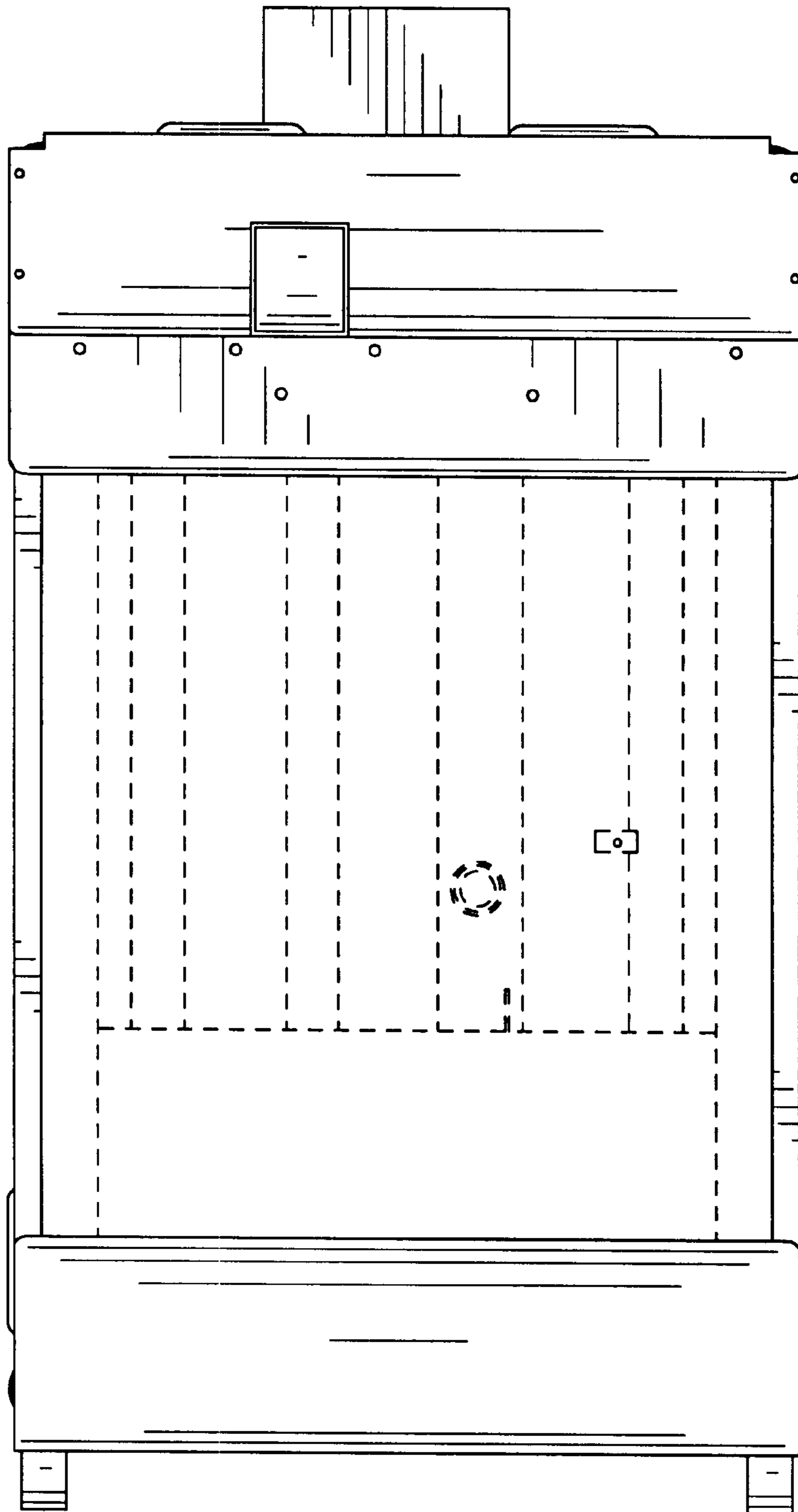

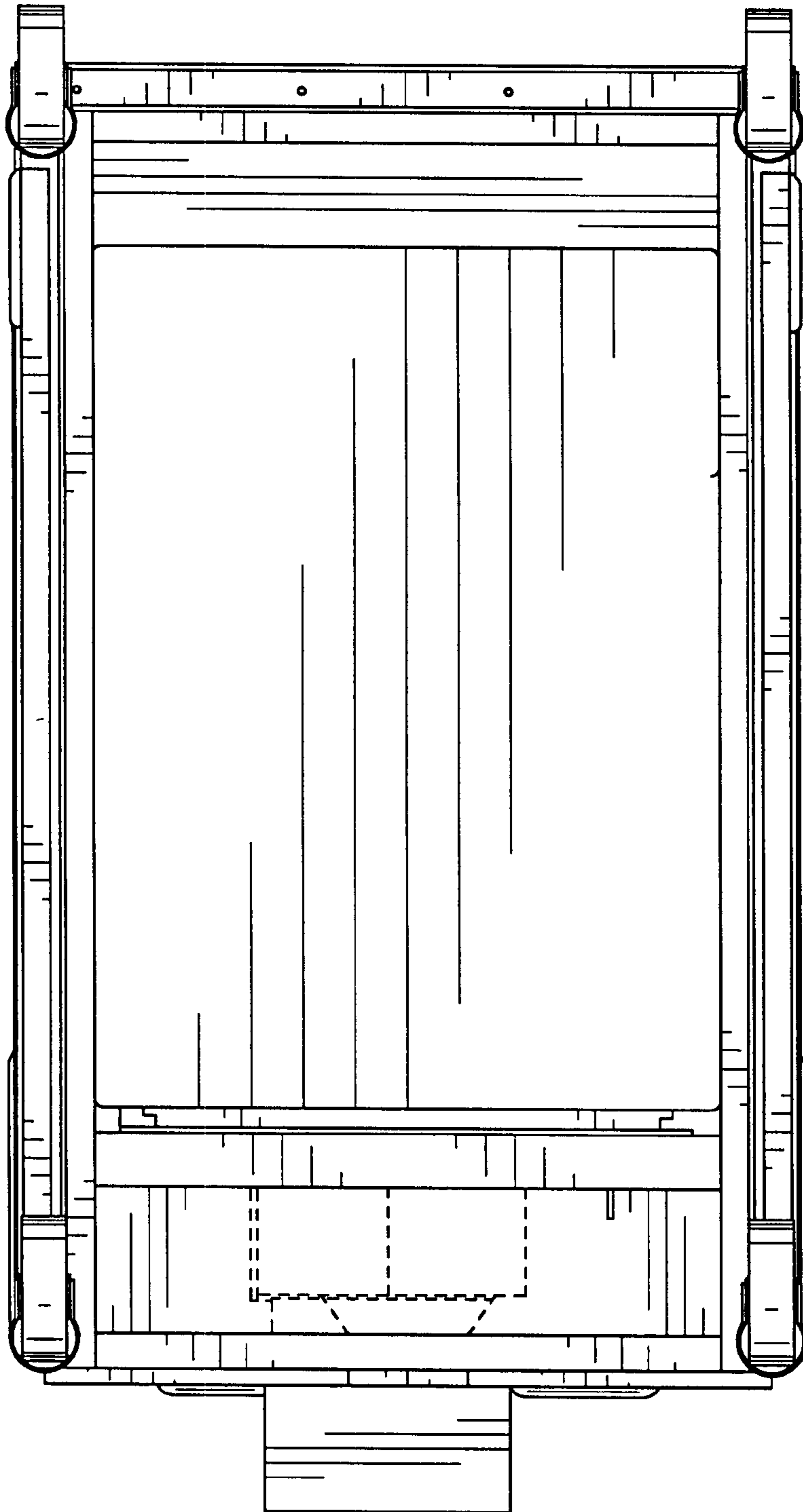

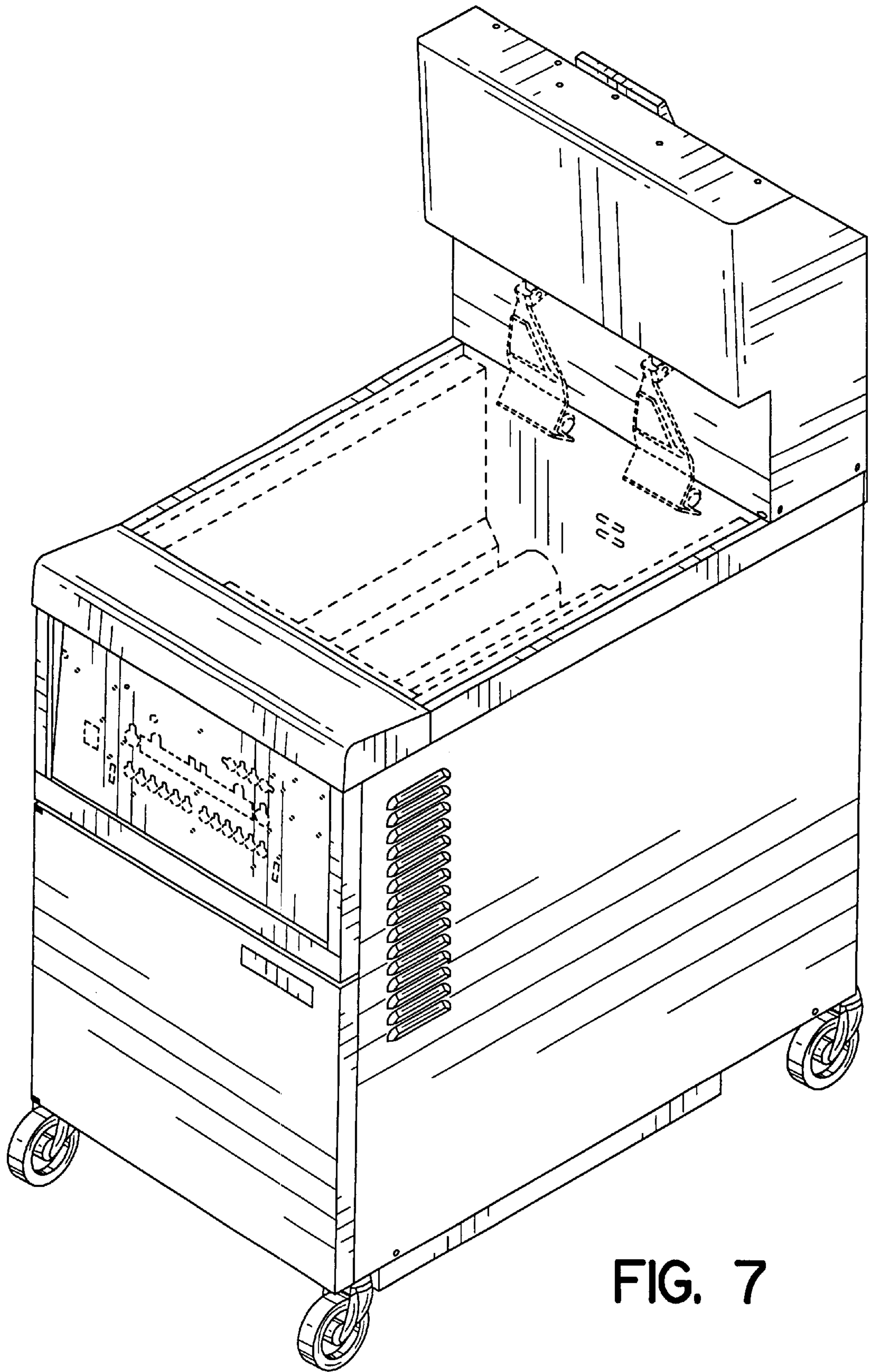
