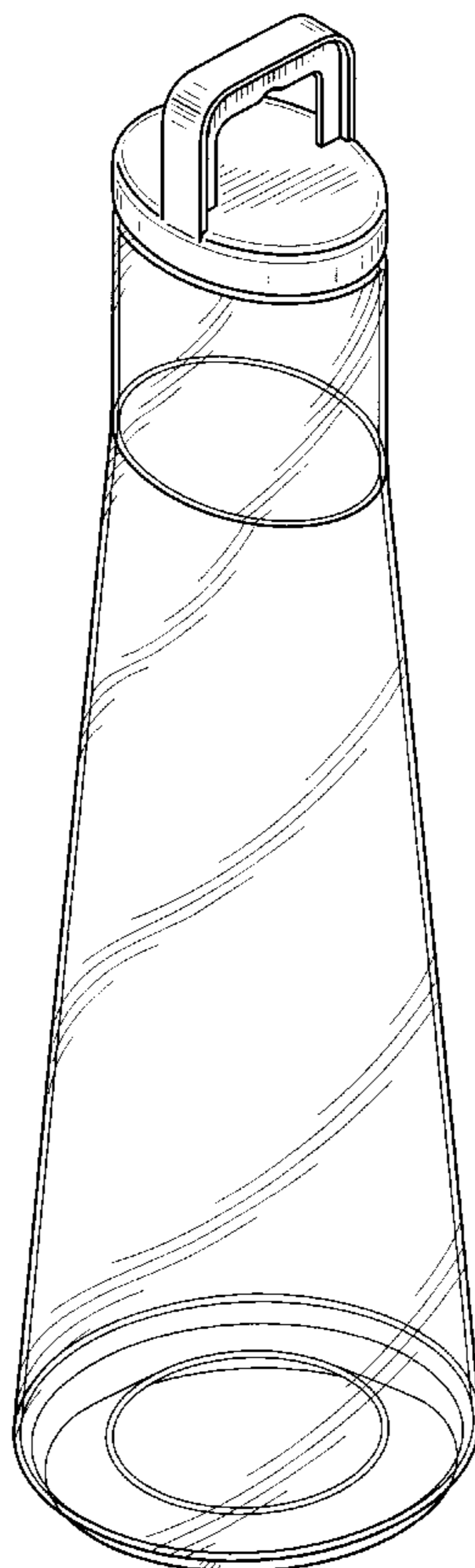
The ornamental design for a package for flashlight, as shown and described.

**DESCRIPTION**

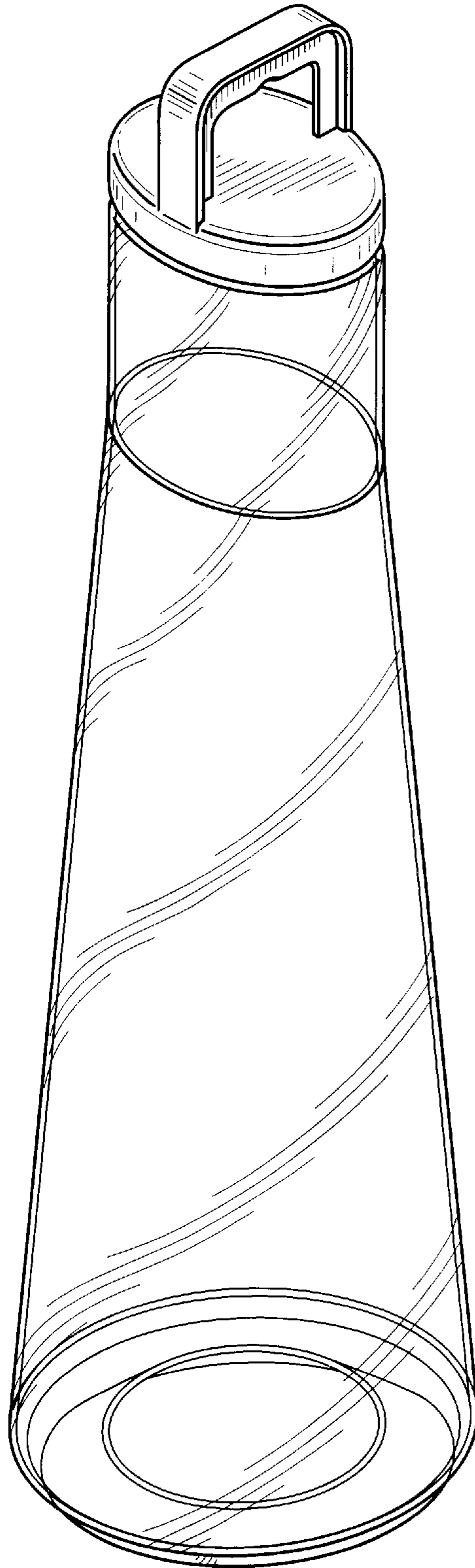
FIG. 1 is a perspective view of the package for flashlight of the invention;

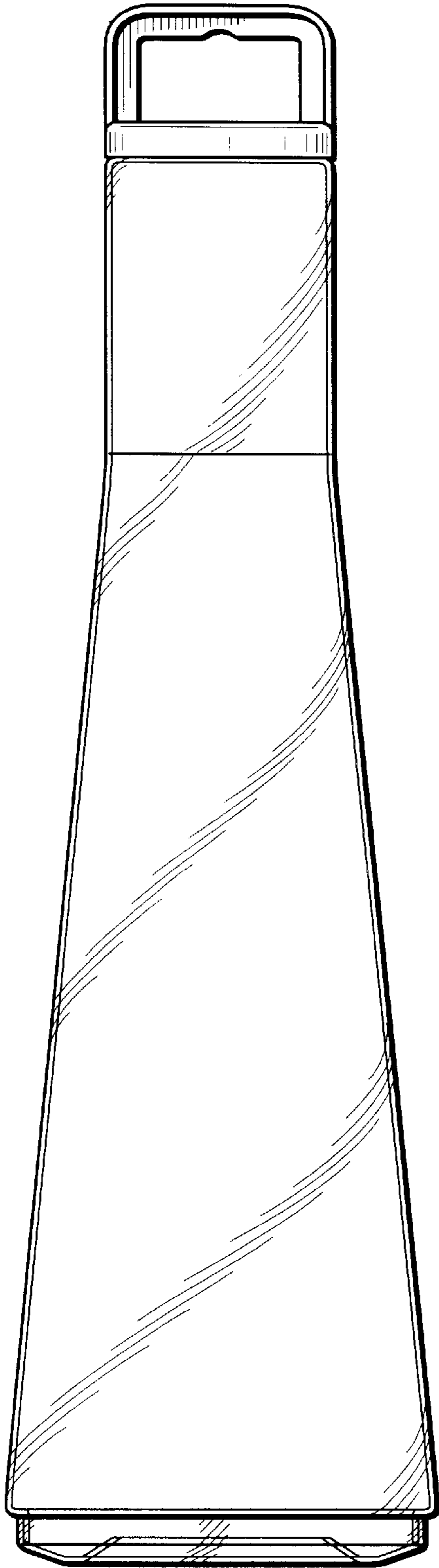

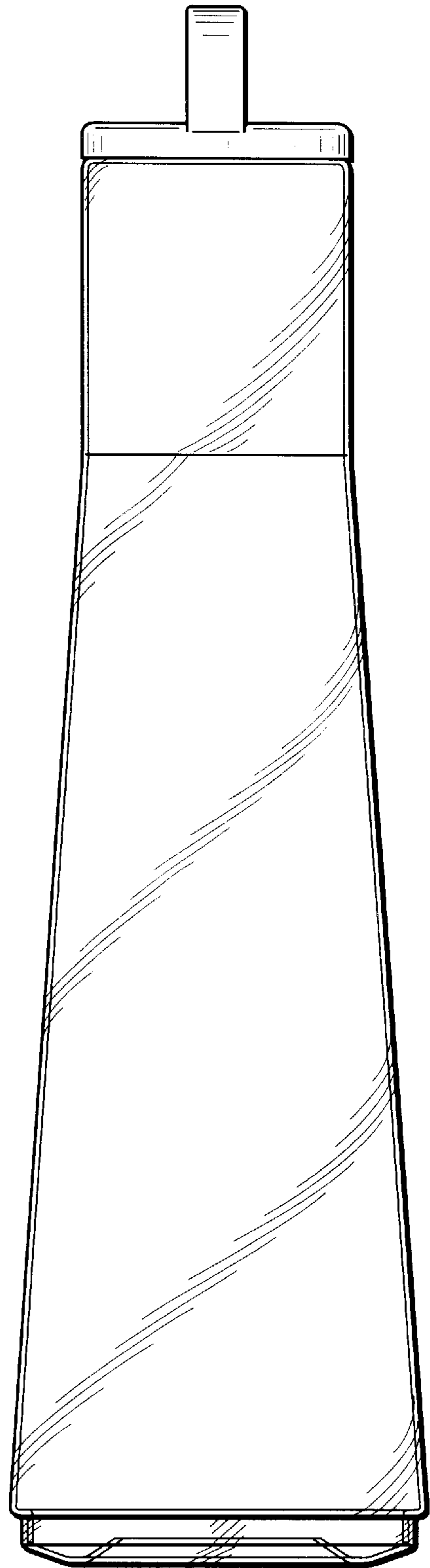

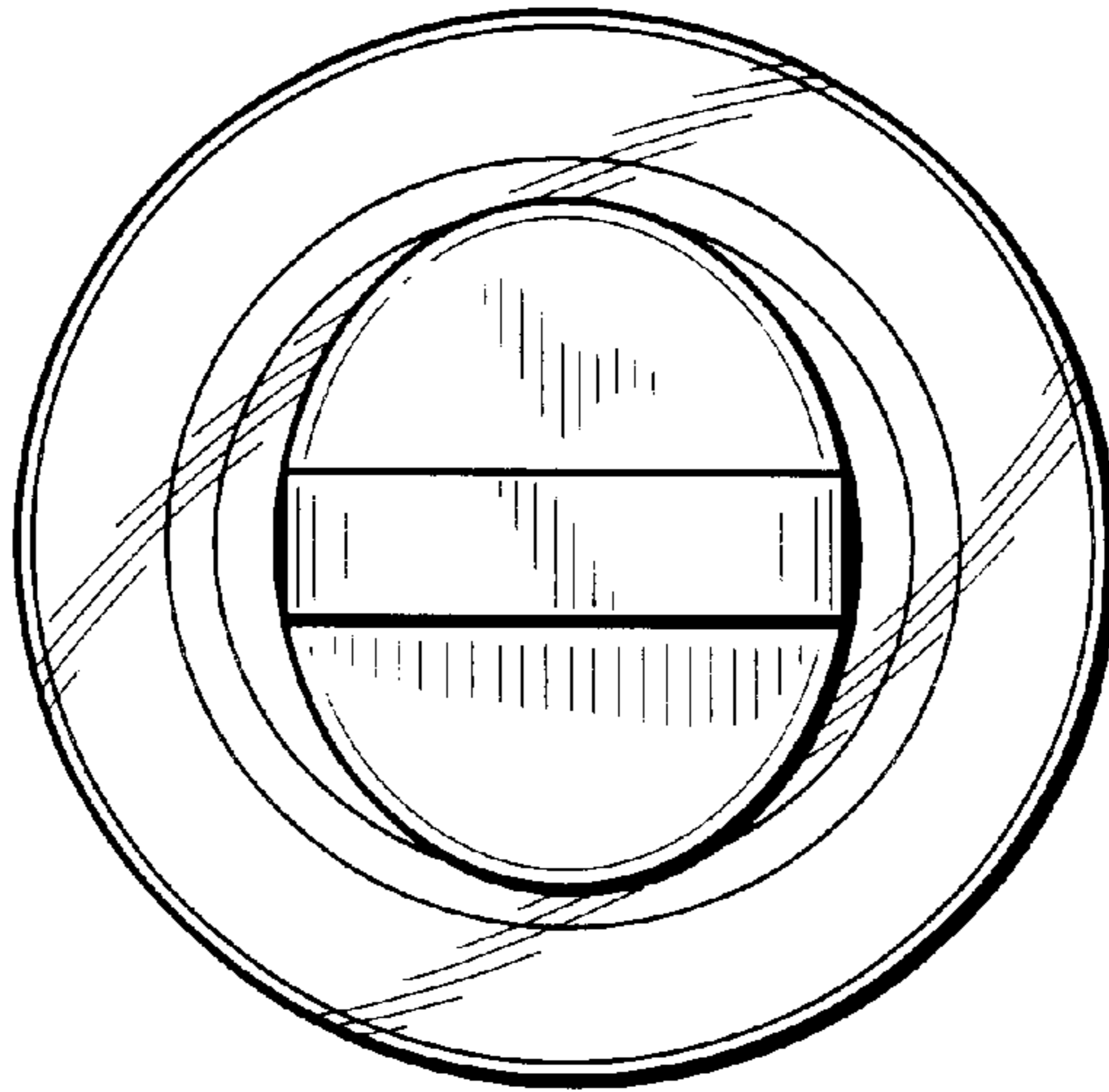
