- FIG. 4 is a front elevational view thereof;
- FIG. 5 is a top plan view thereof;
- FIG. 6 is a bottom plan view thereof;
- FIG. 7 is a rear elevational view thereof;
- FIG. 8 is a top, front, right side perspective view of a second embodiment of a hair color applicator showing our new design;
- FIG. 9 is a top, front, right side perspective view thereof at a different angle;
- FIG. 10 is a left side view thereof; the right side view being a mirror image thereof;
- FIG. 11 is a front elevational view thereof;
- FIG. 12 is a top plan view thereof;
- FIG. 13 is a bottom plan view thereof;
- FIG. 14 is a rear elevational view thereof;

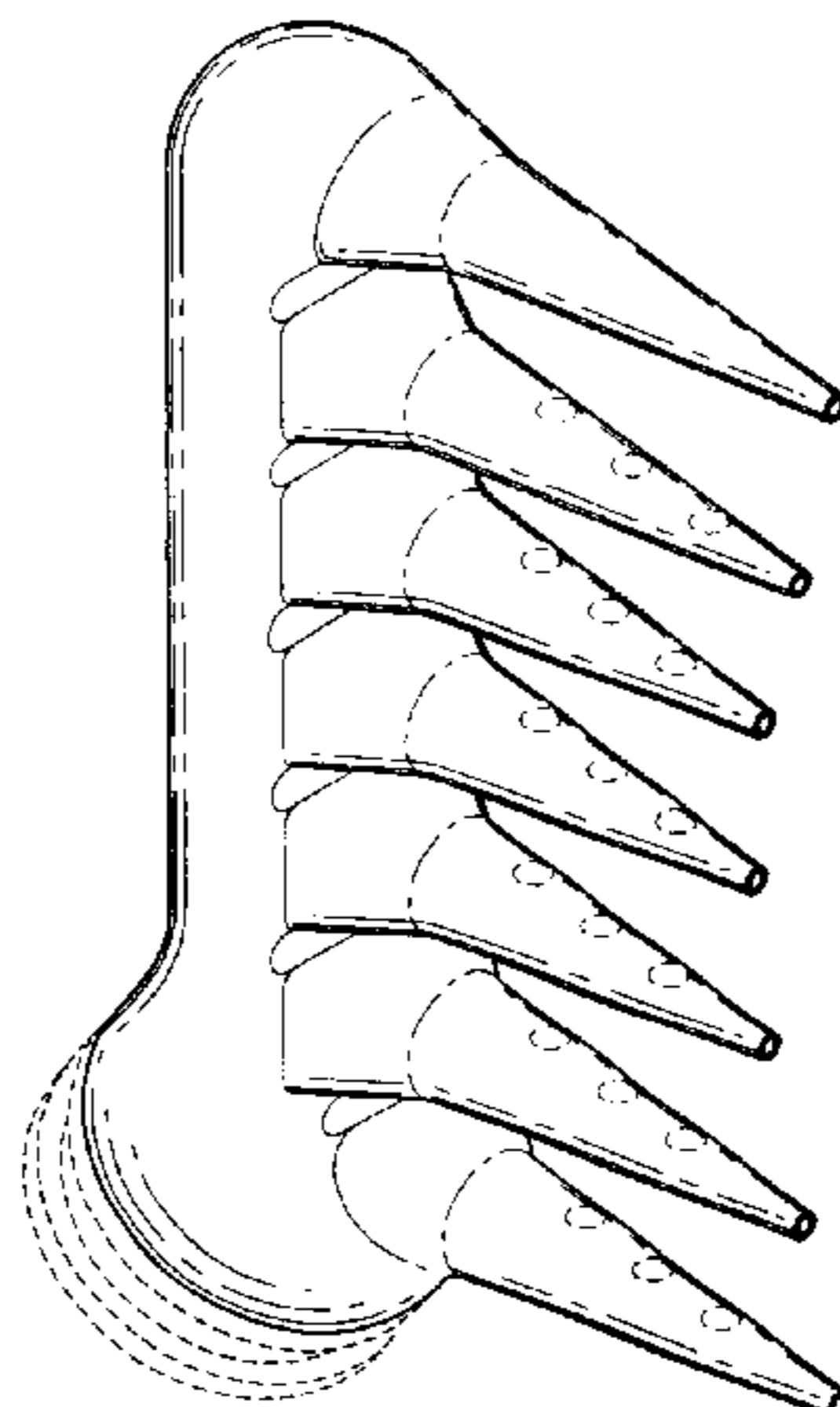


FIG. 15 is a top, front, right side perspective view of a third embodiment of a hair color applicator showing our new design;

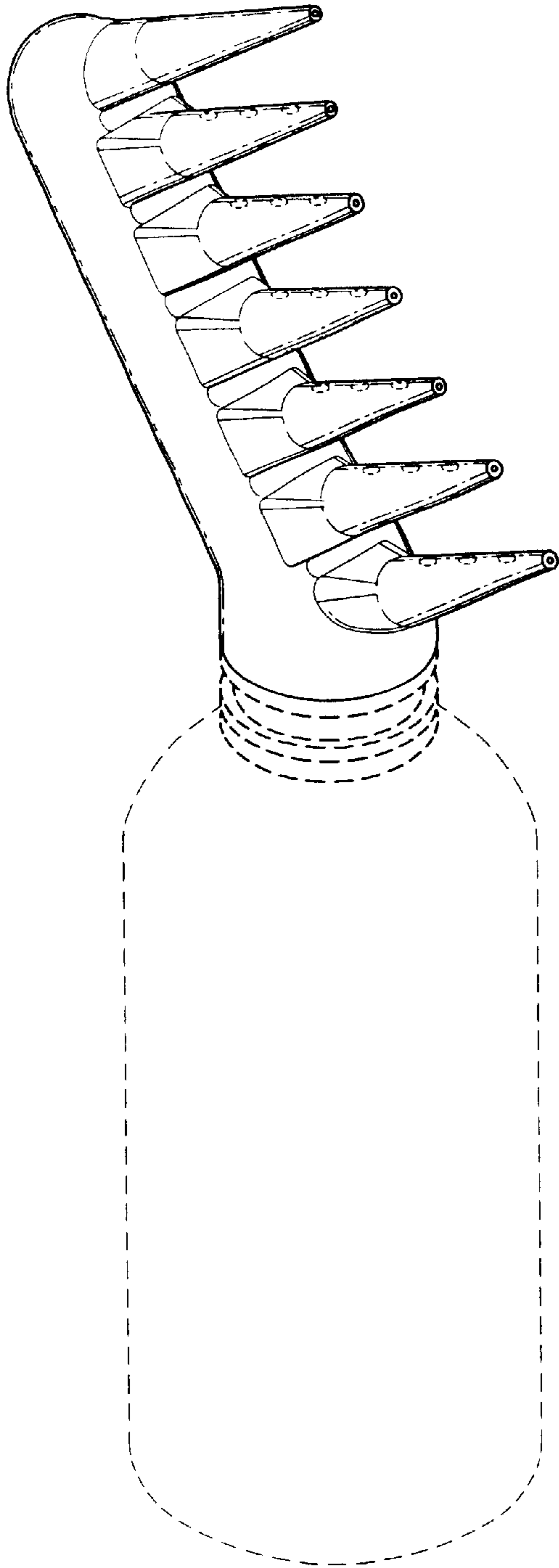

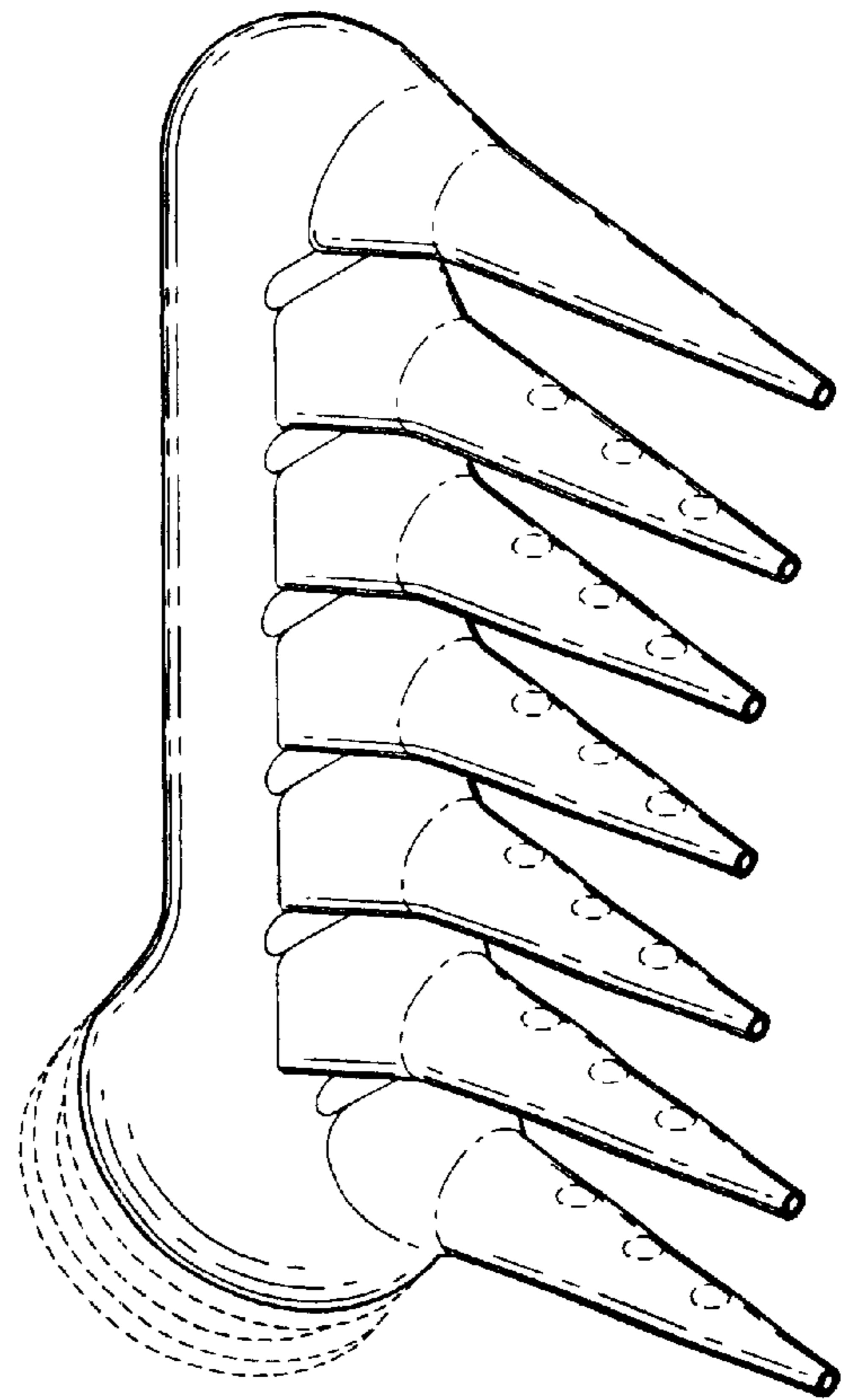

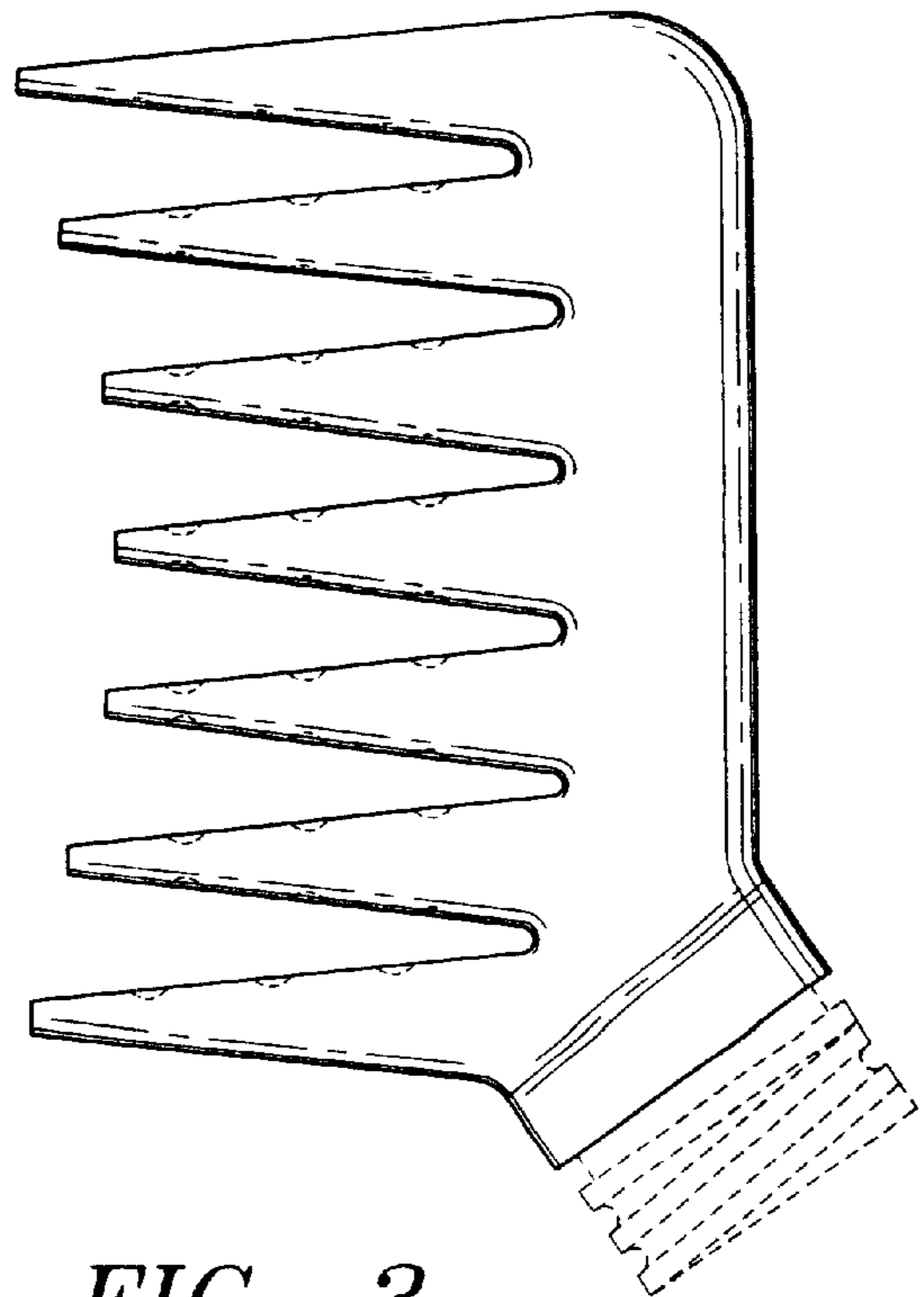

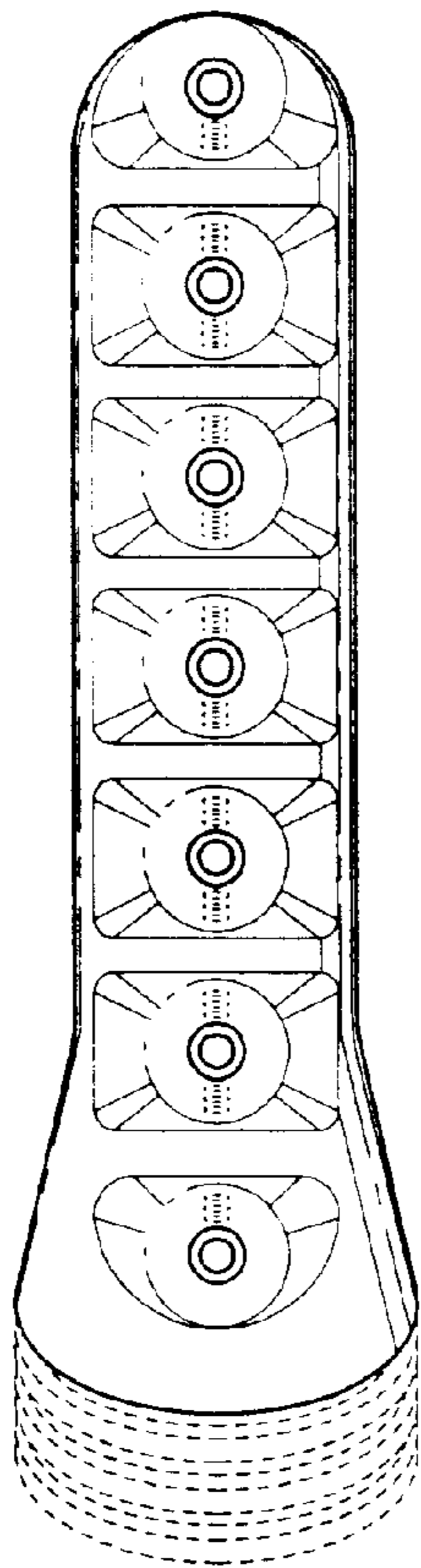

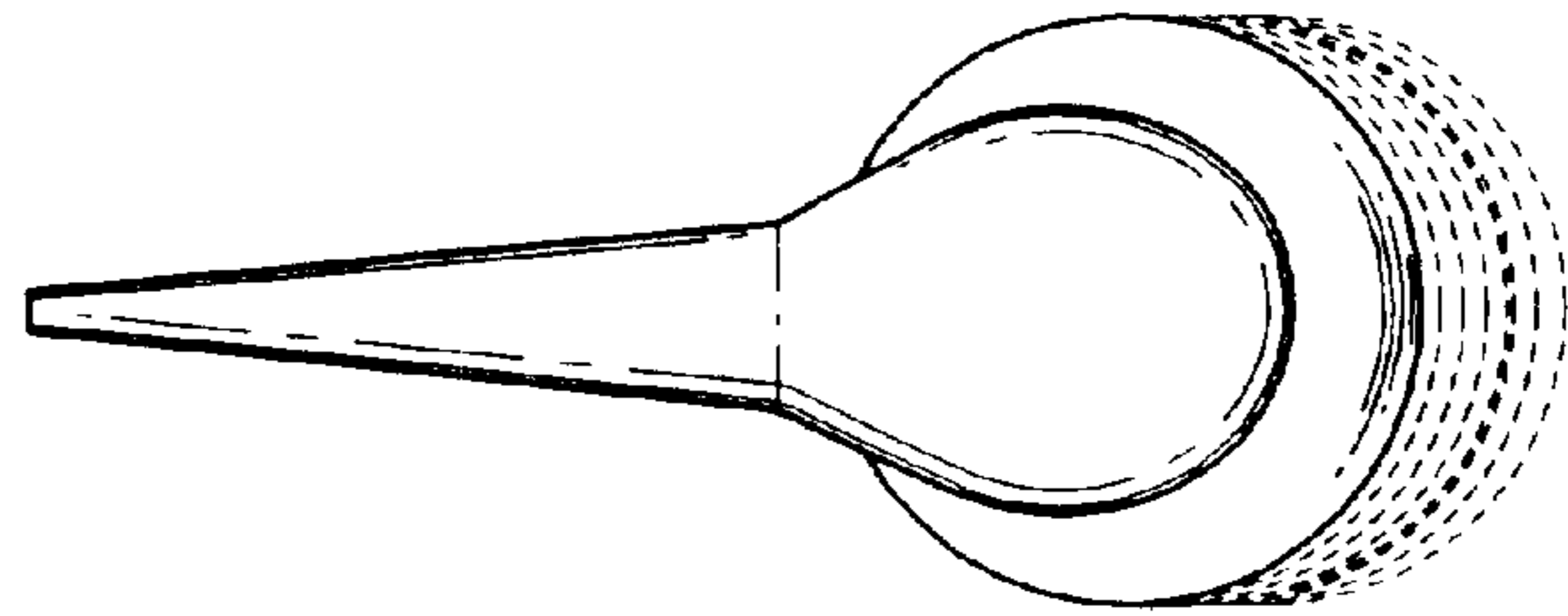

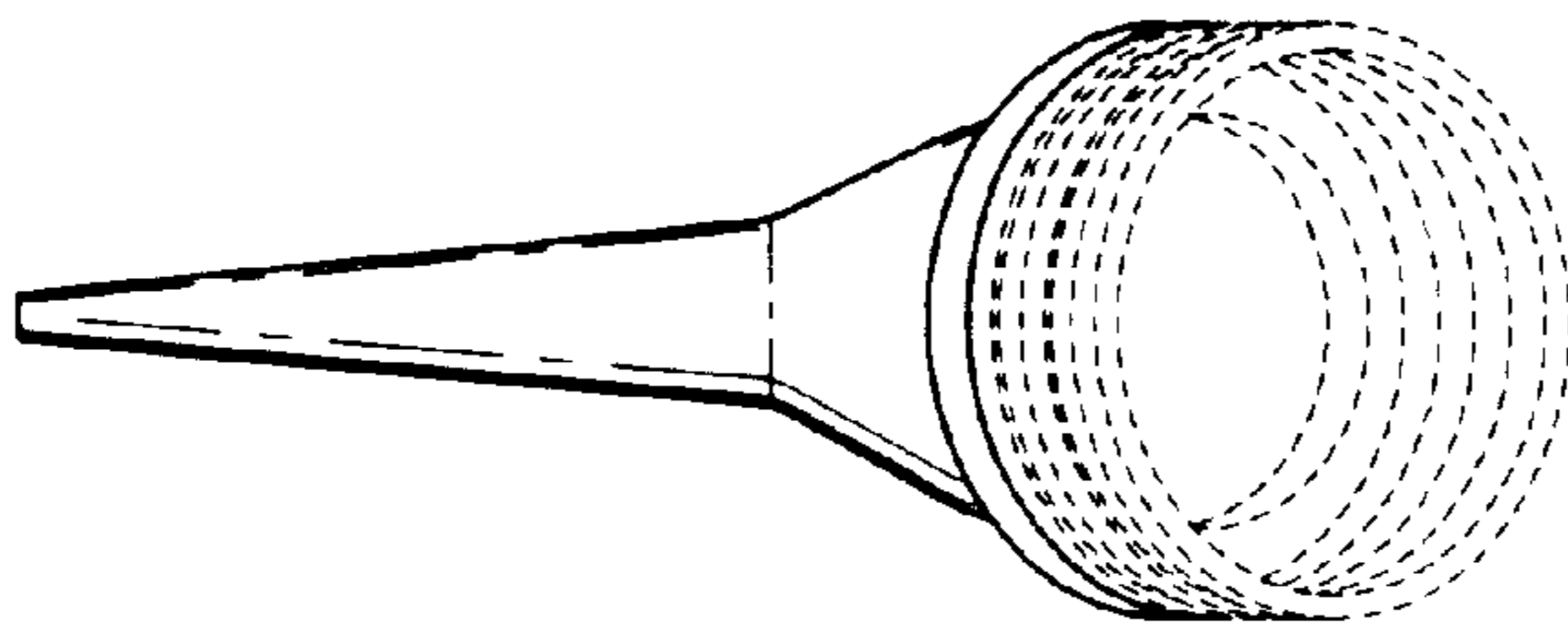

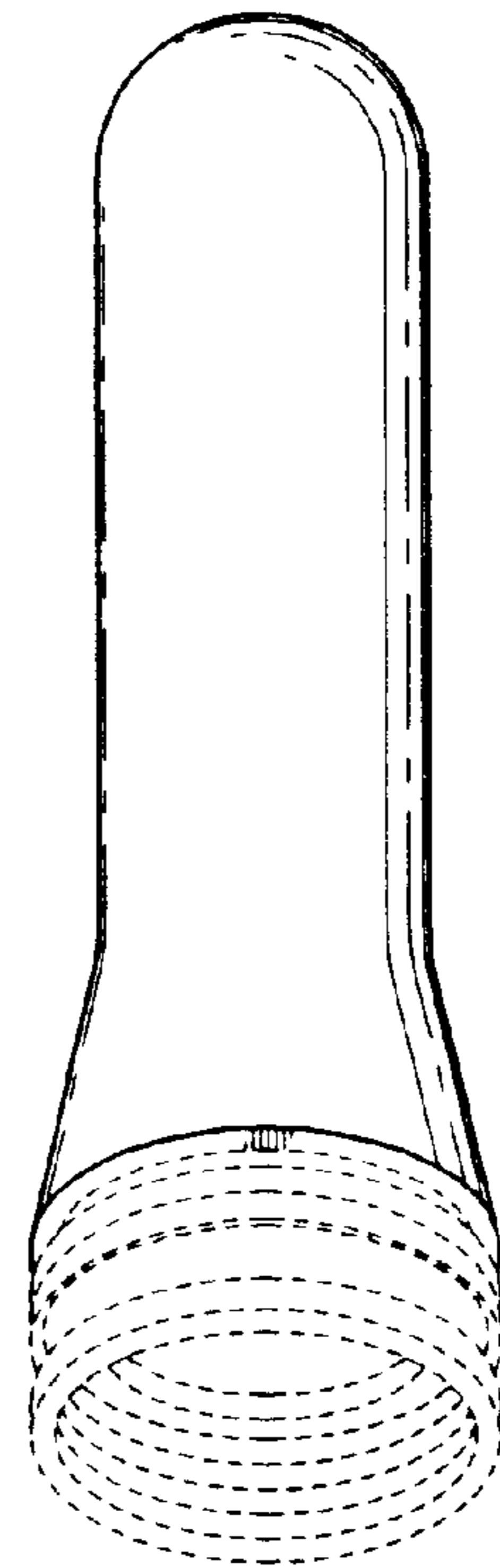

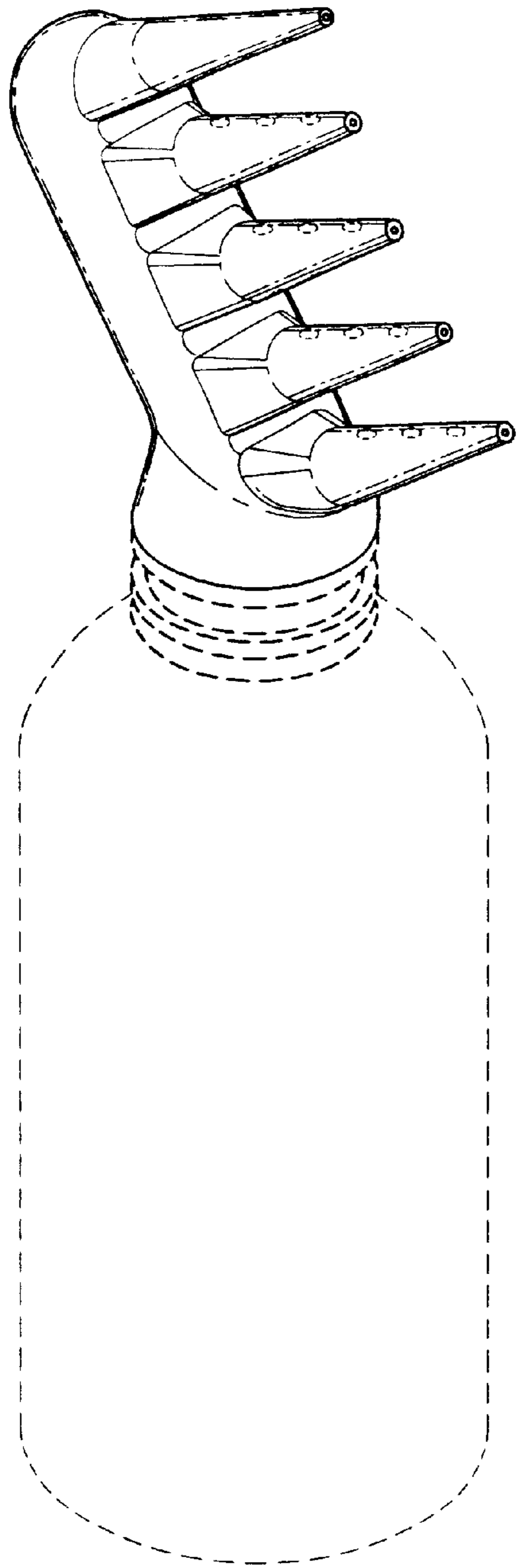

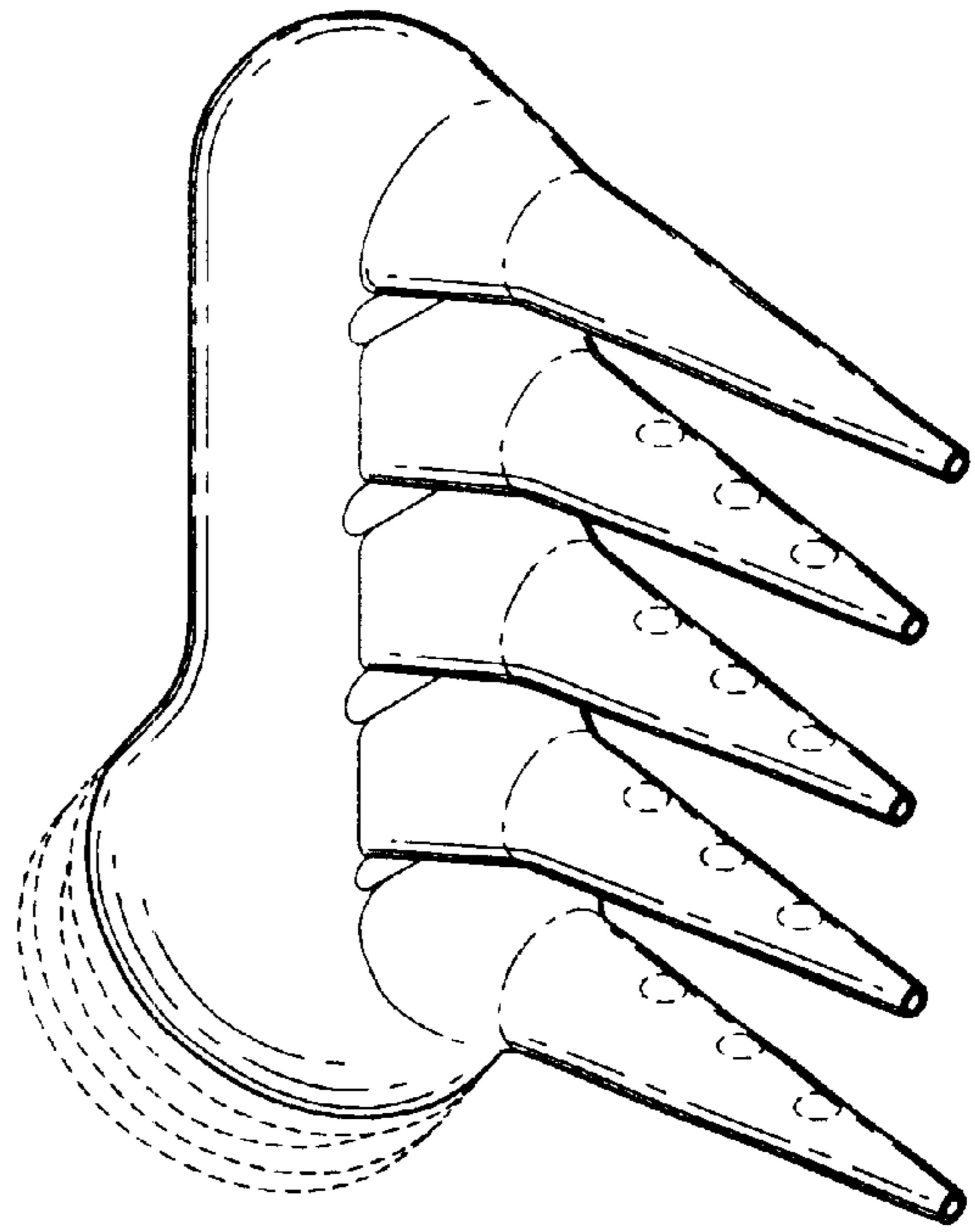

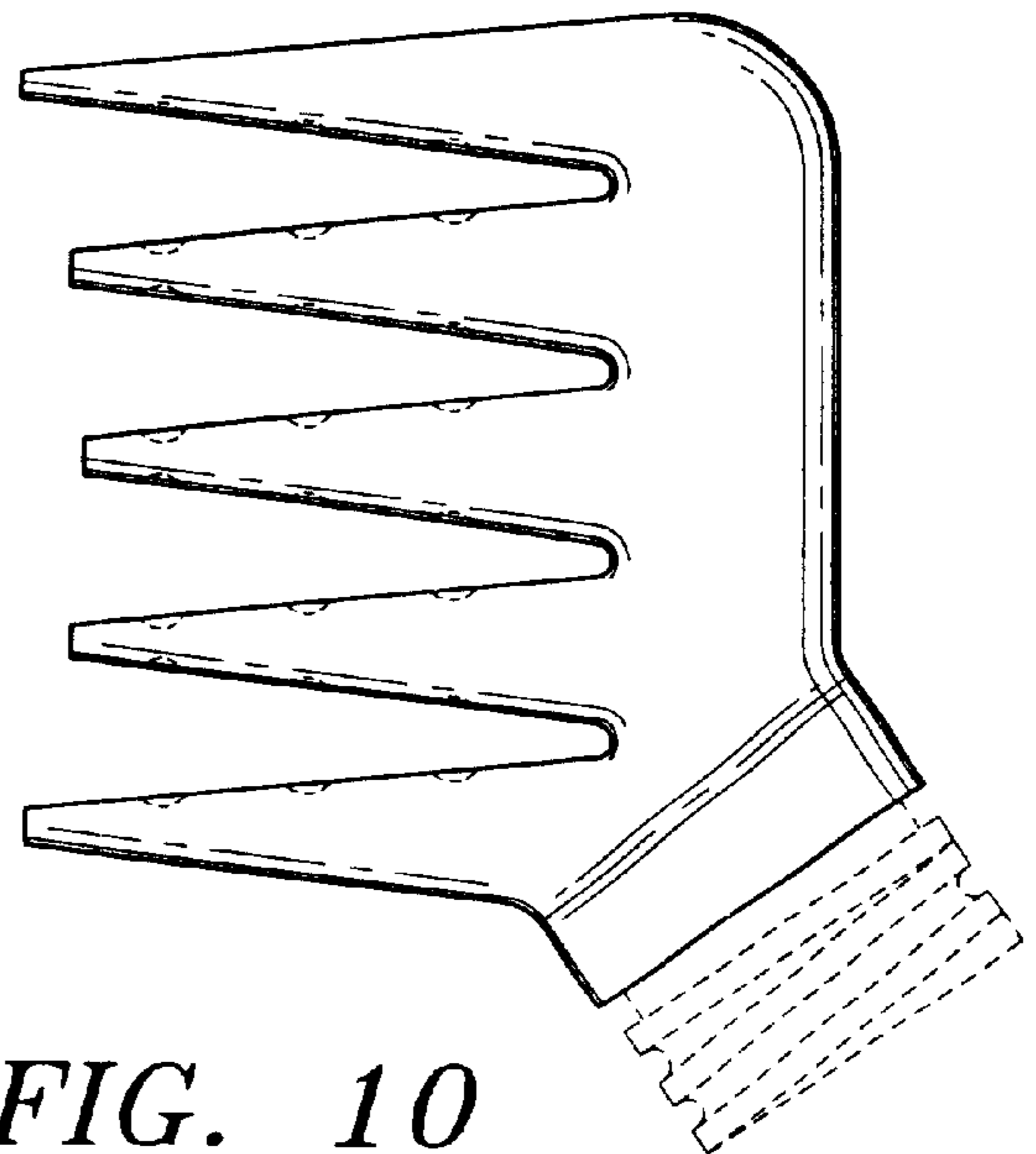

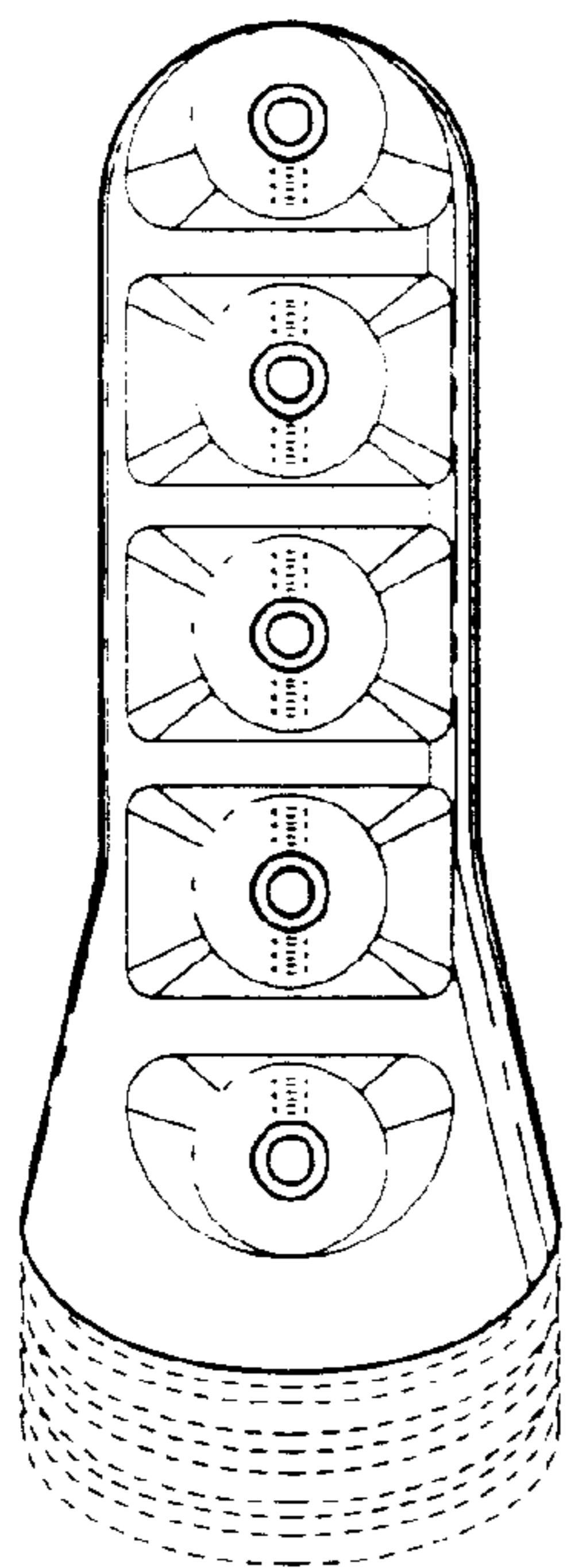

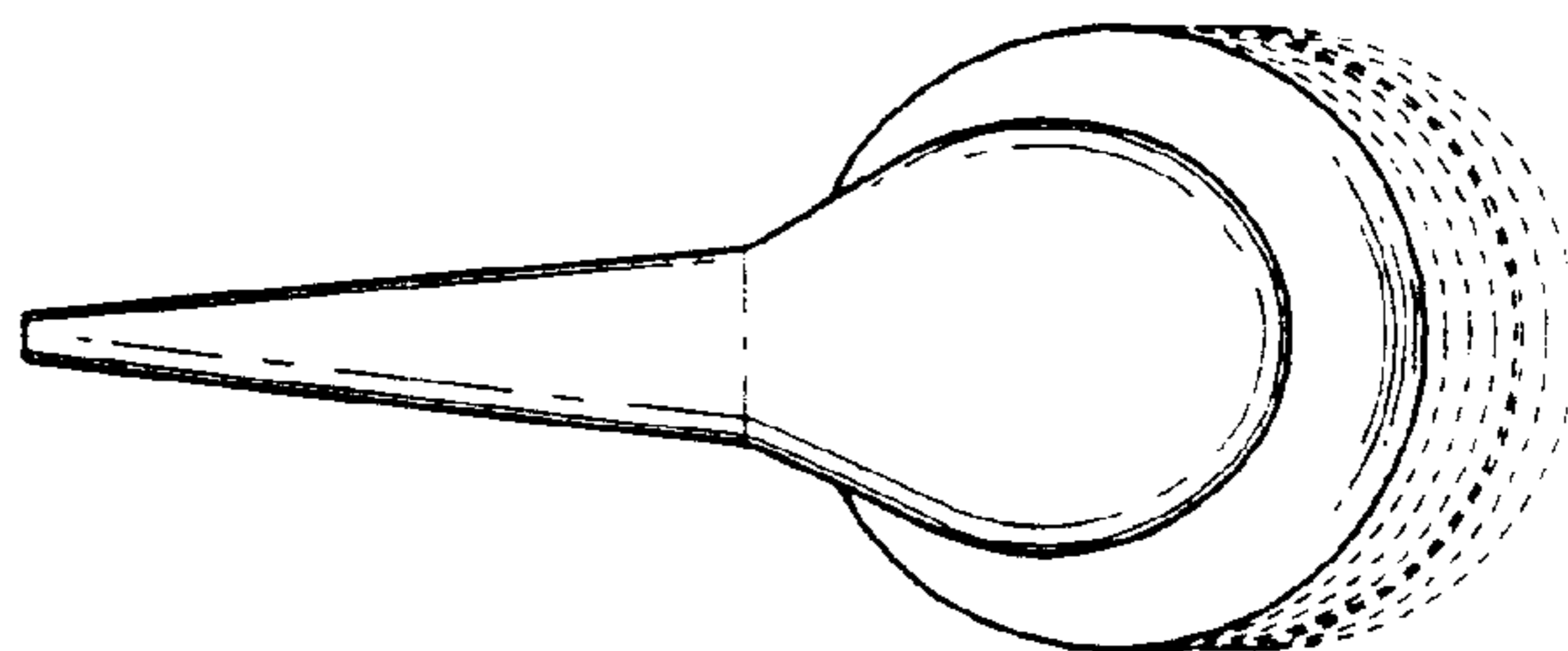

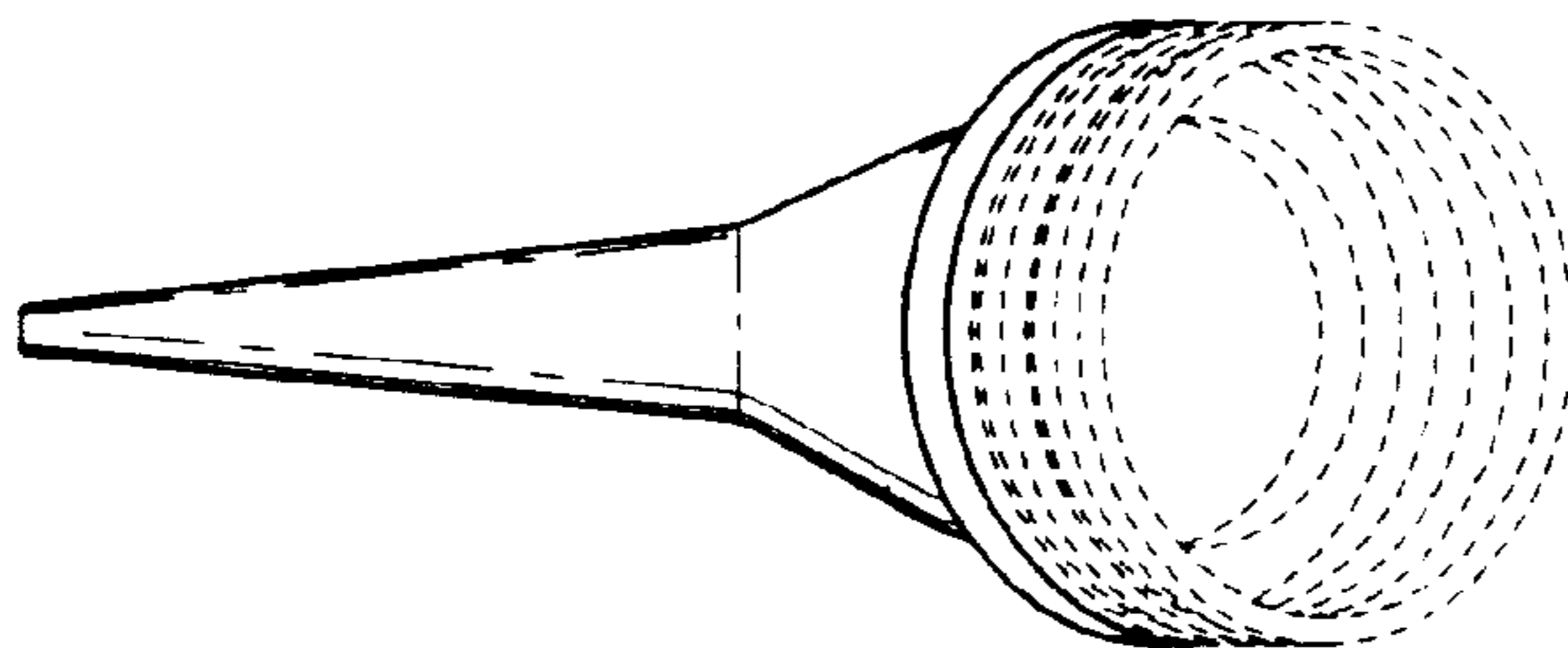

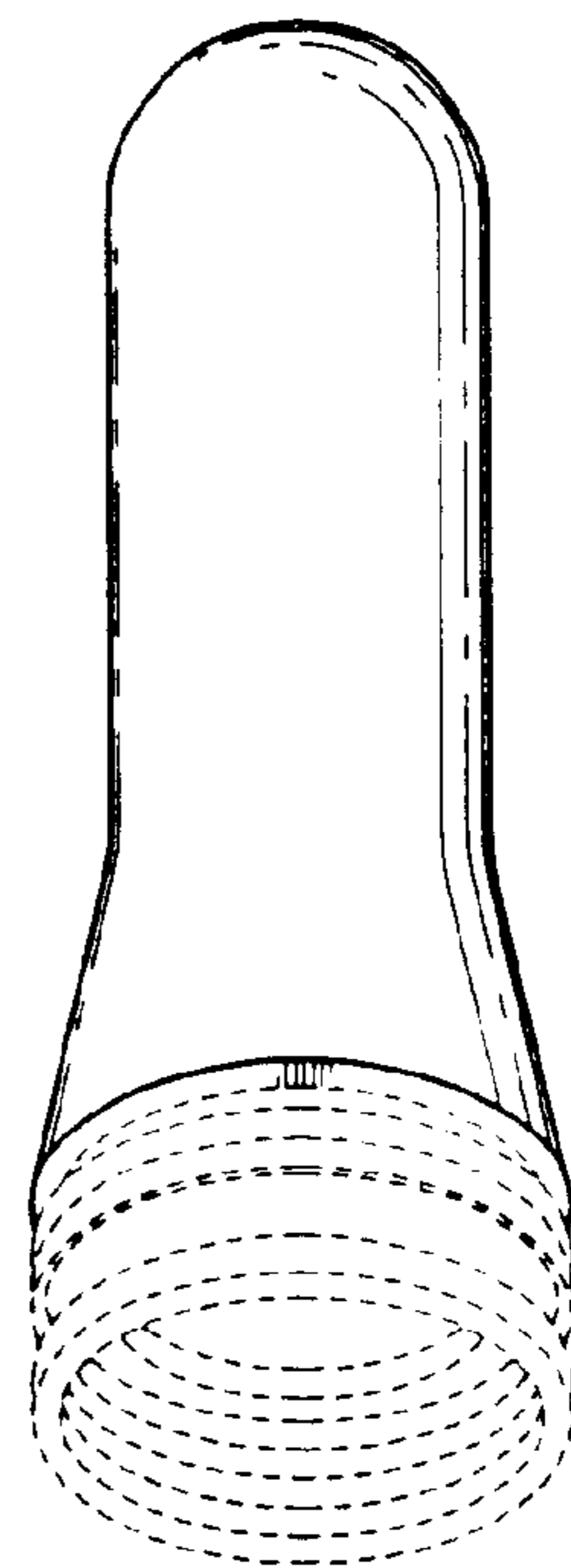

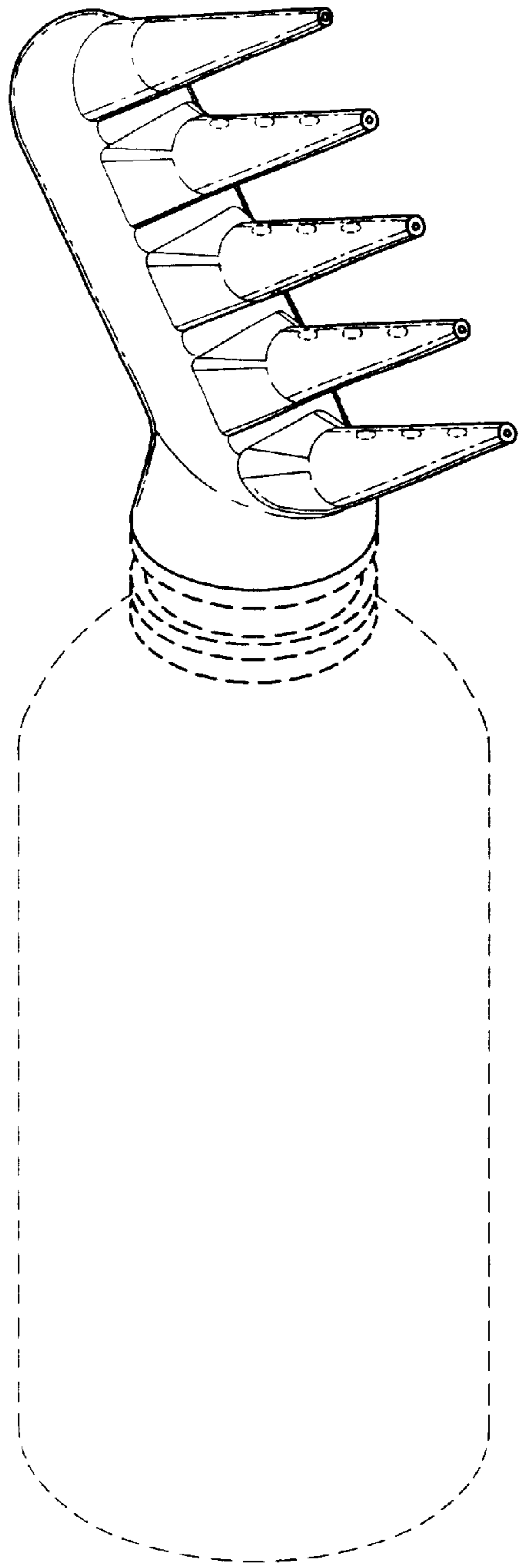

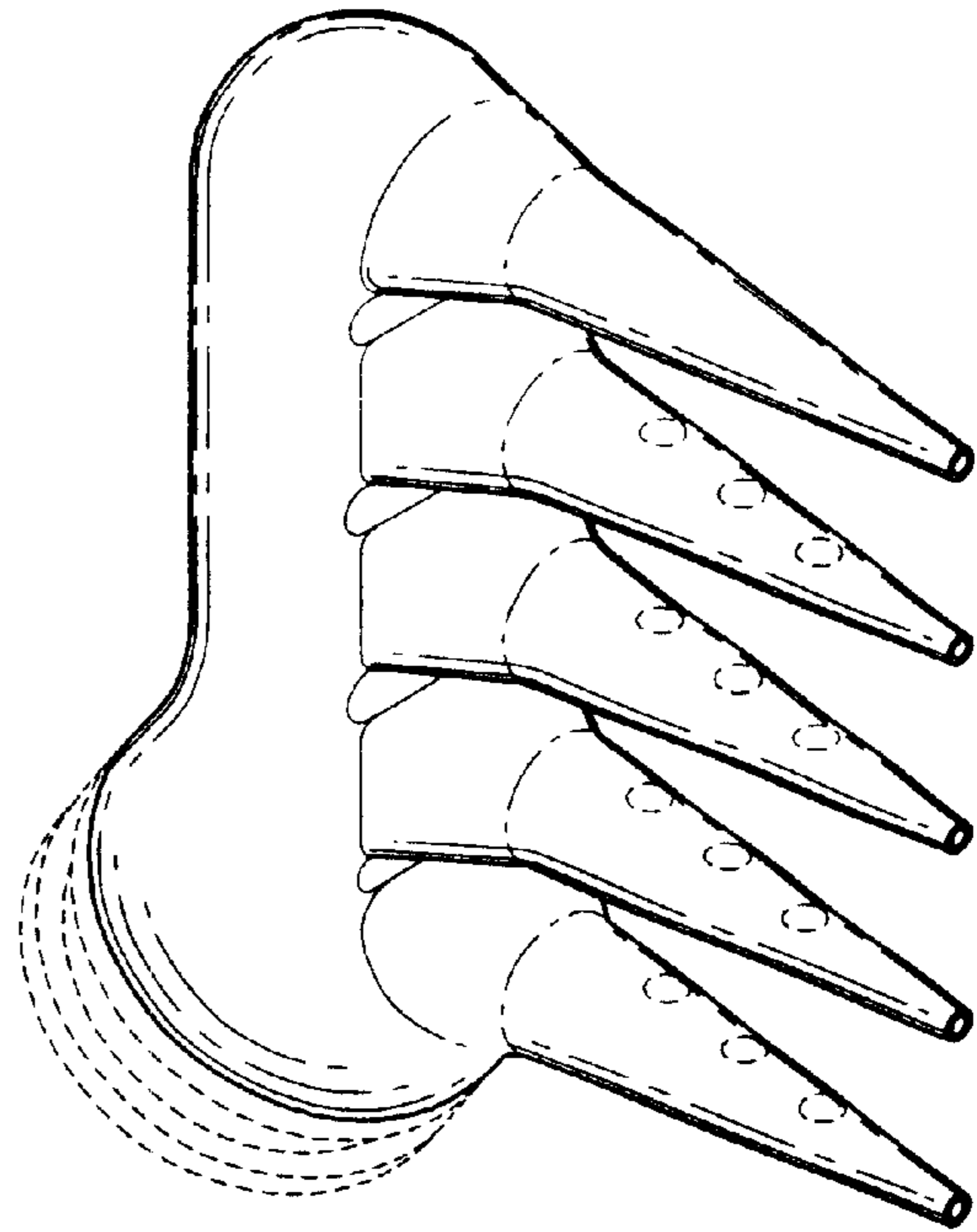

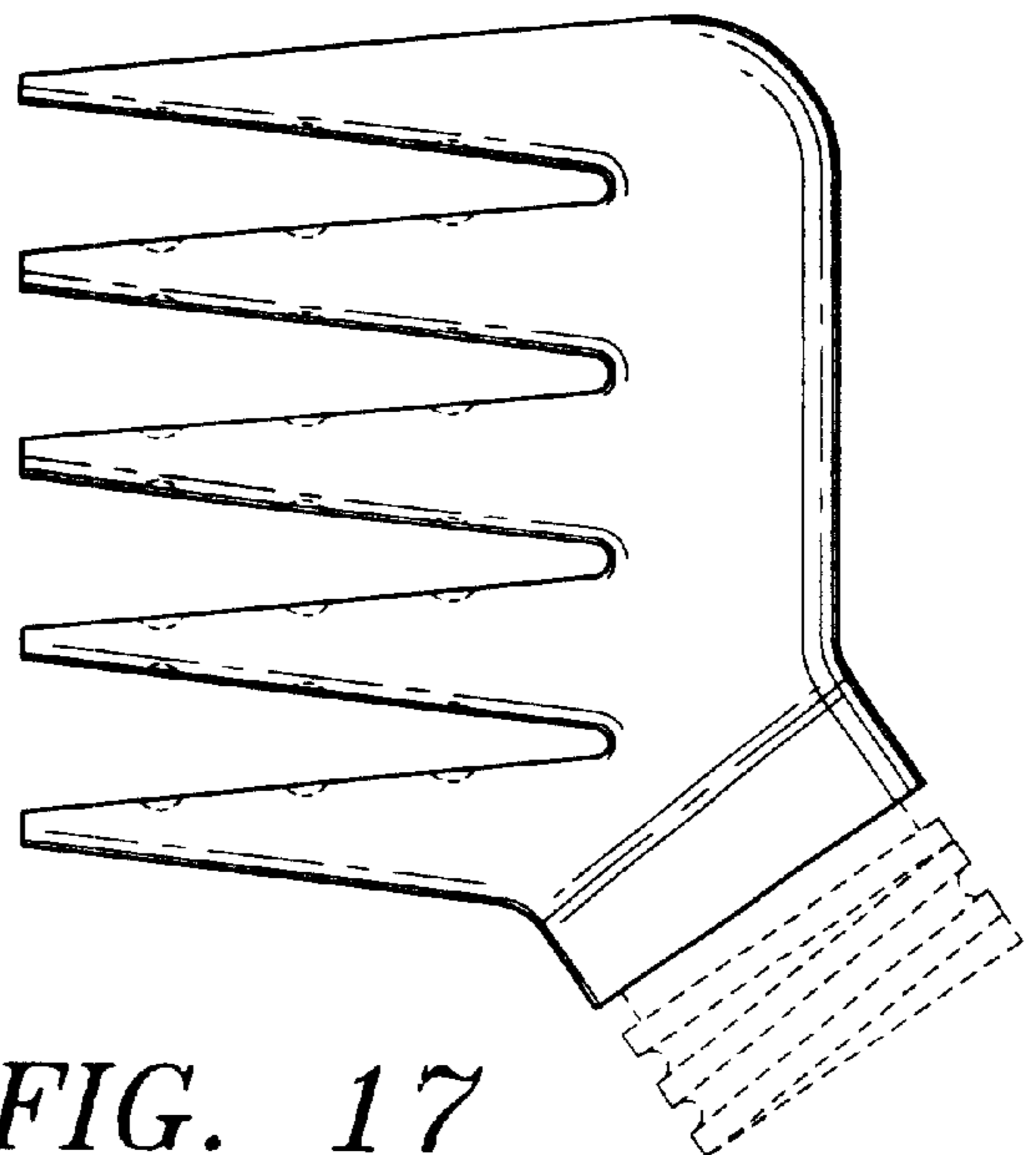

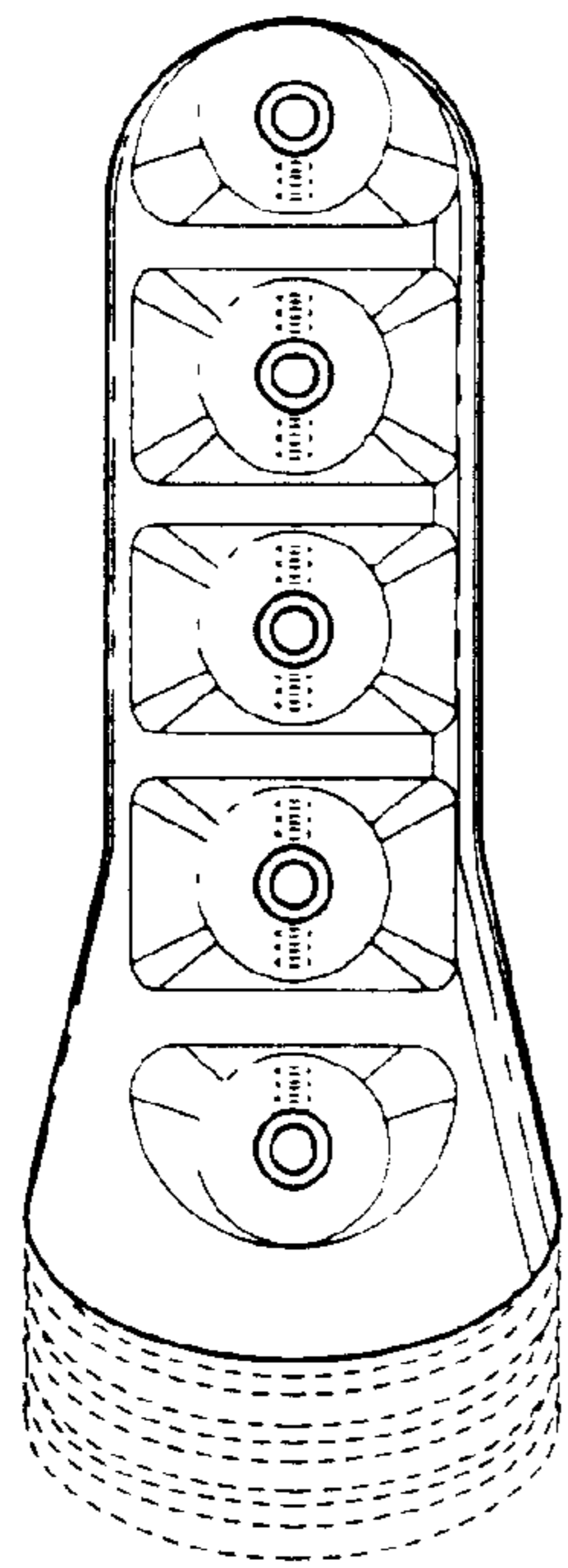

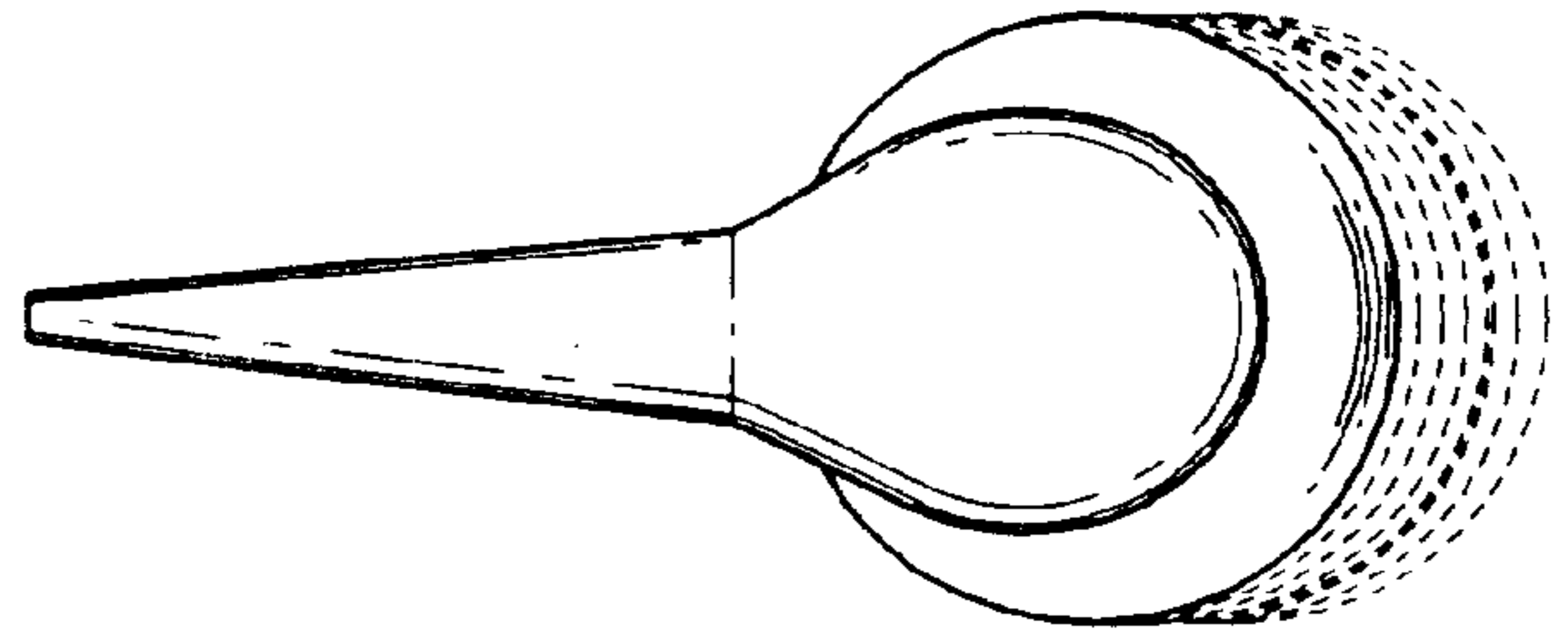

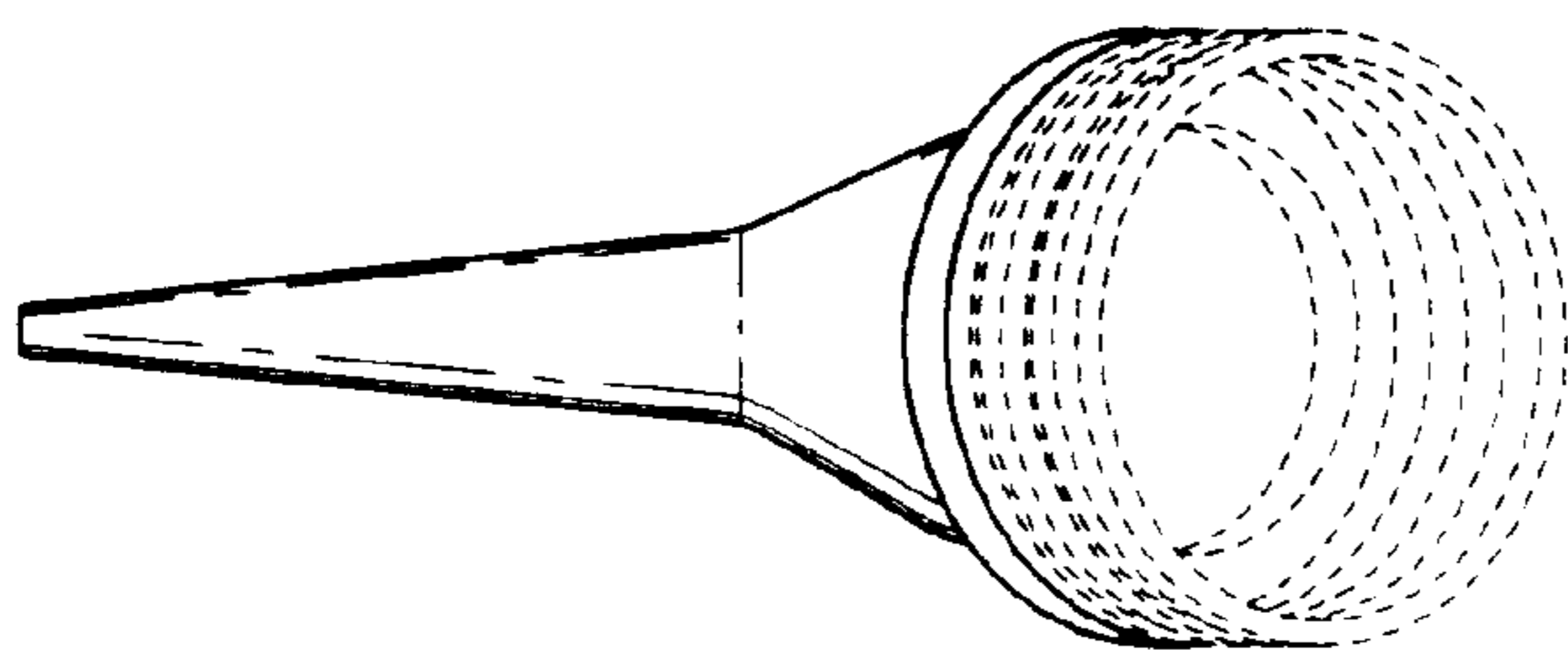

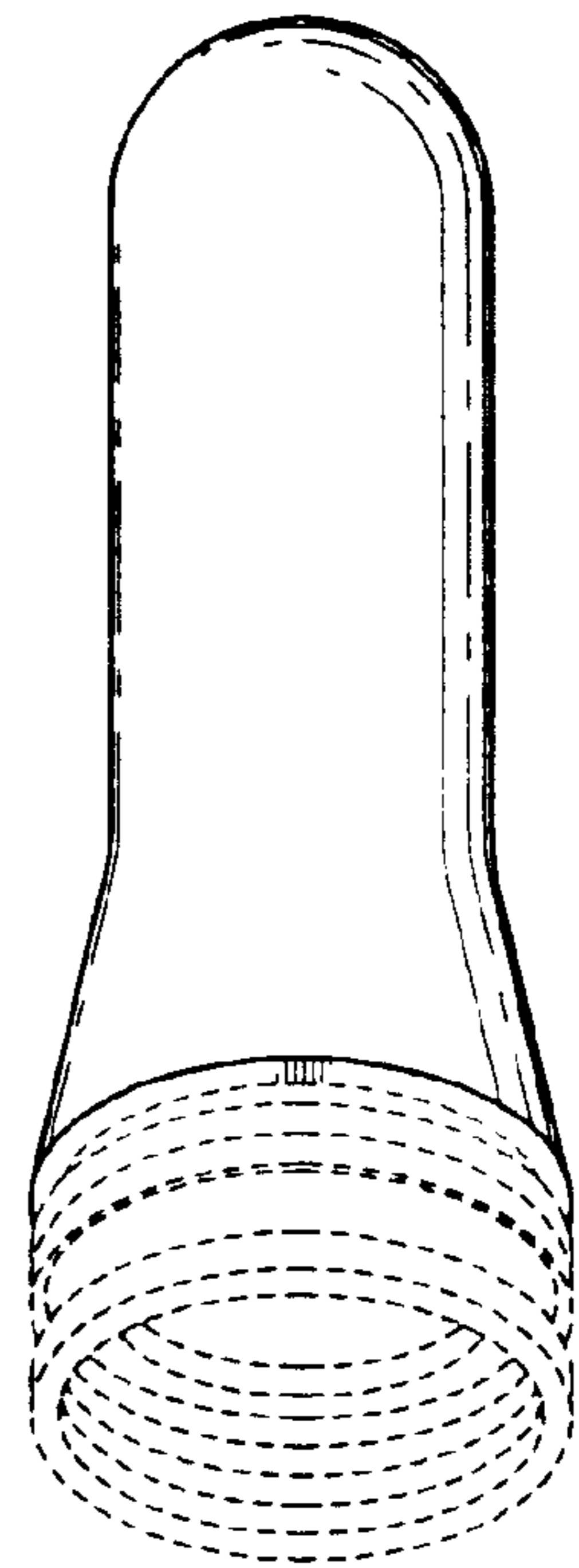

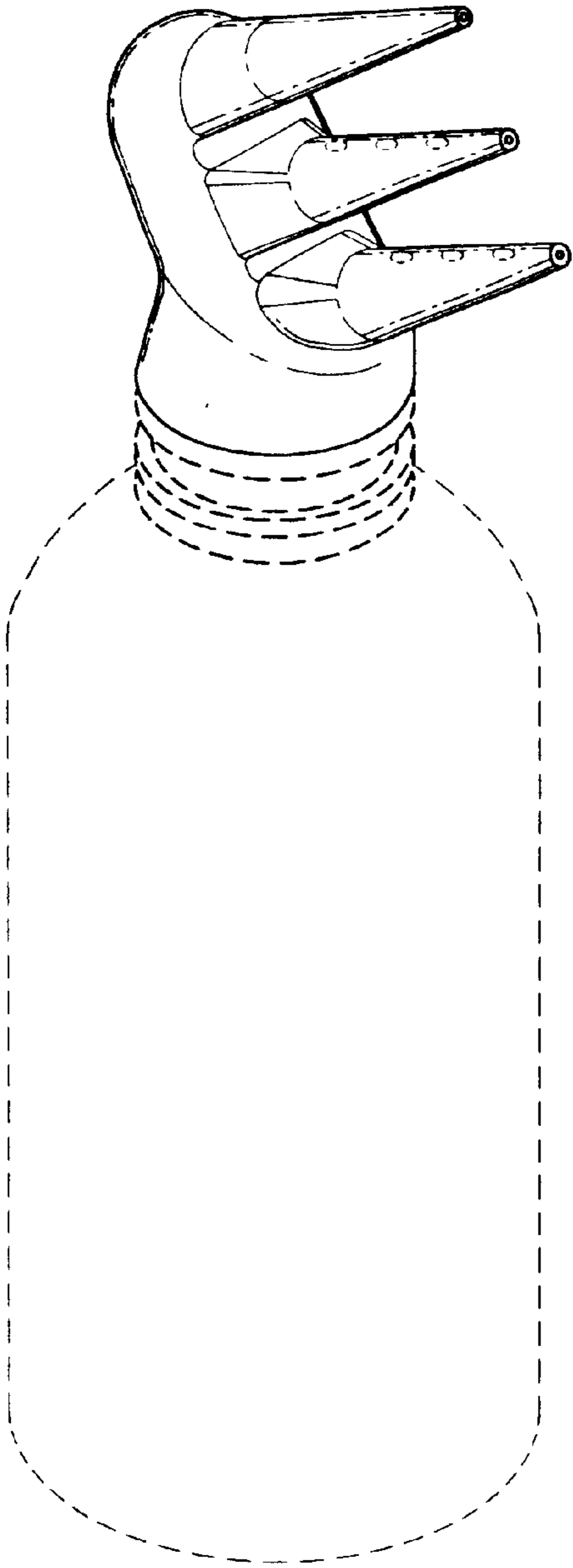

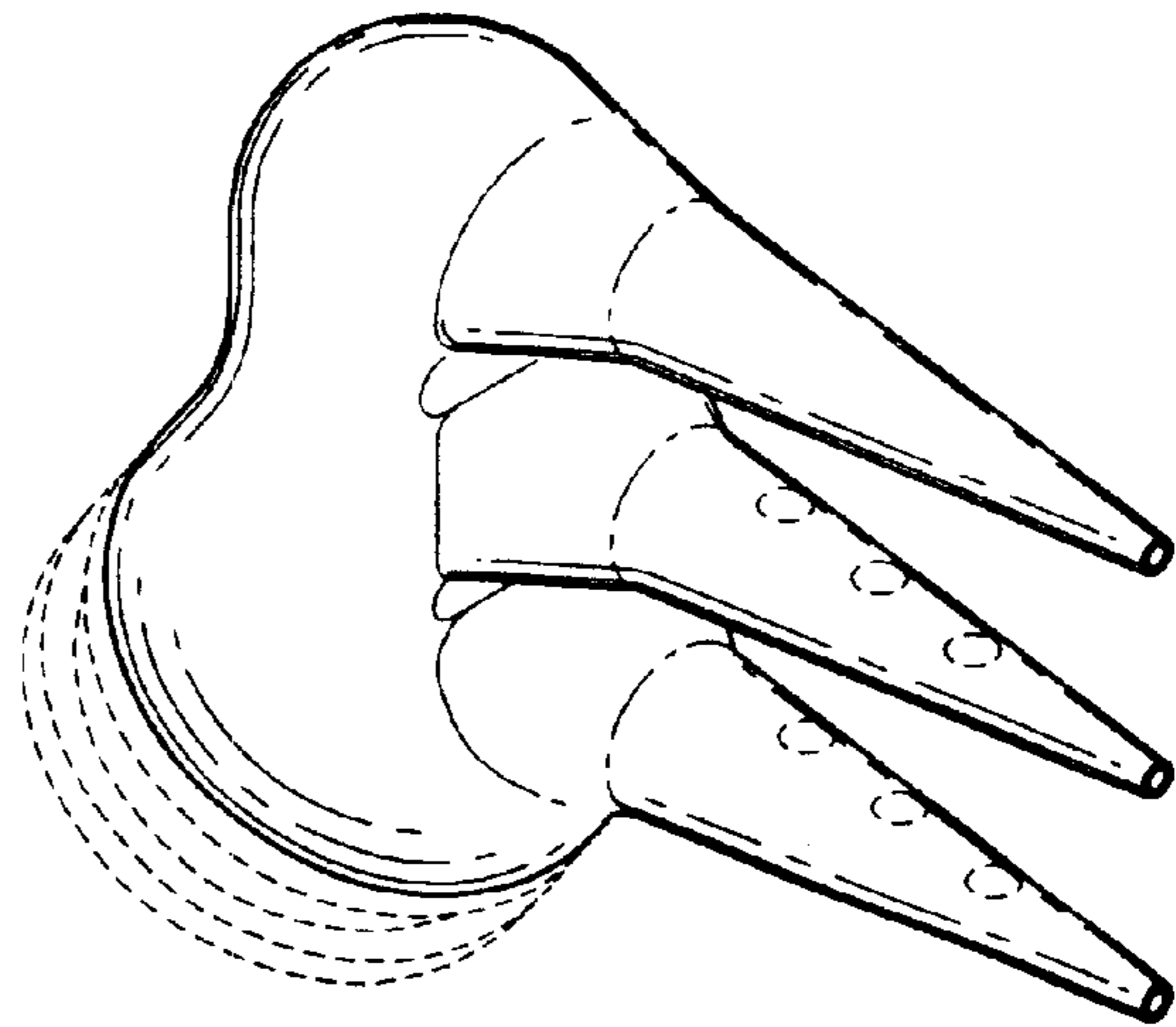

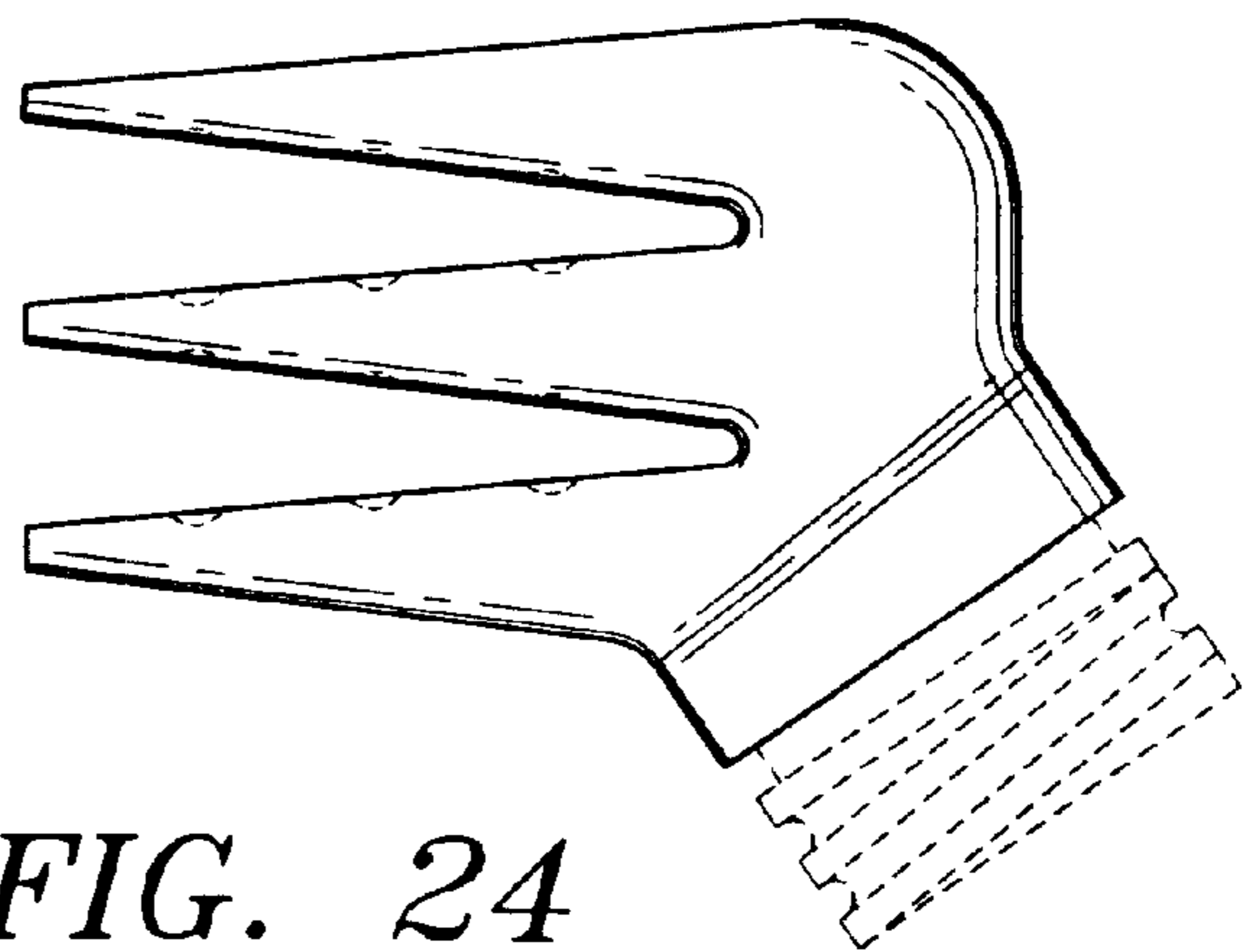

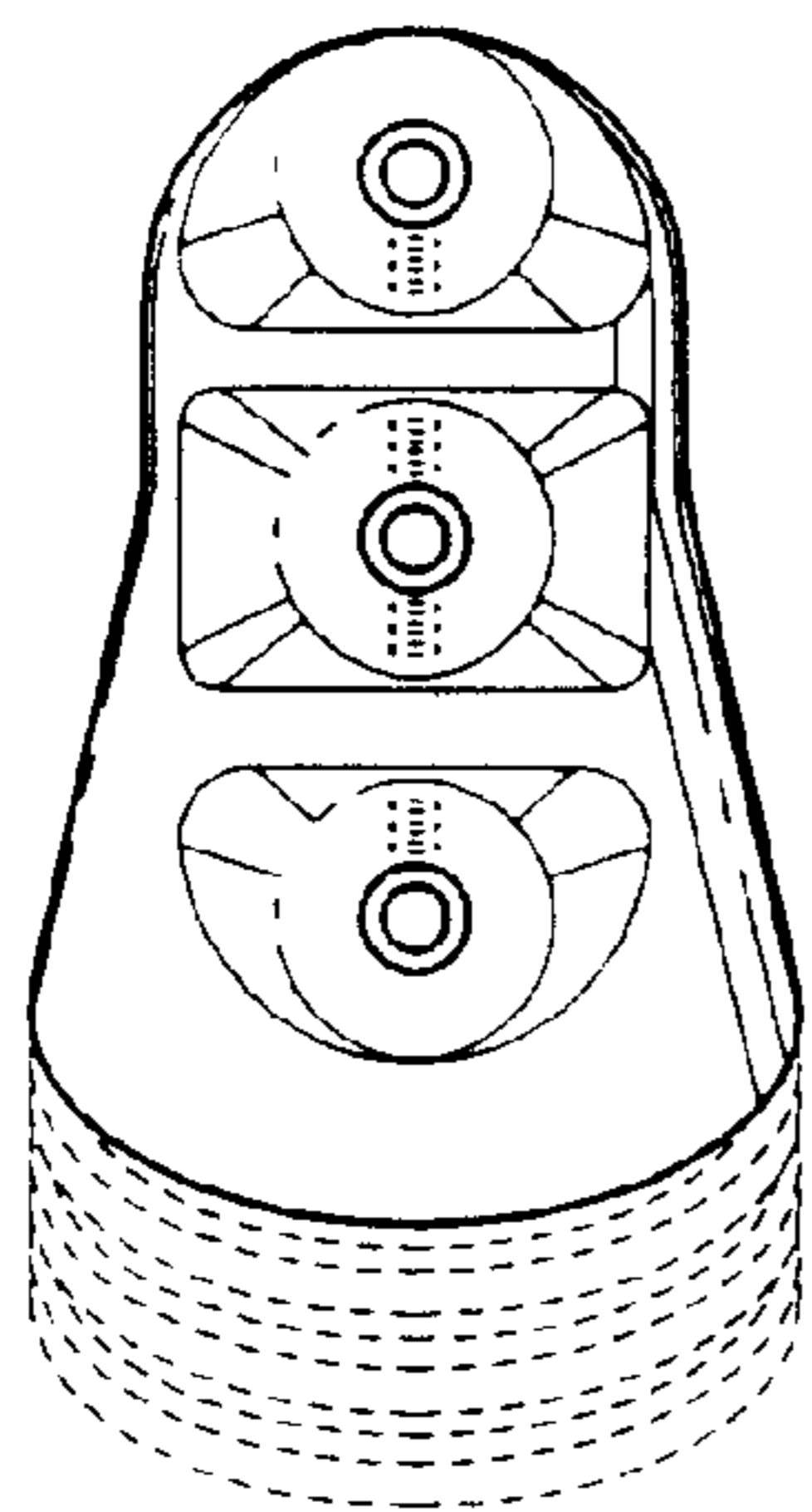

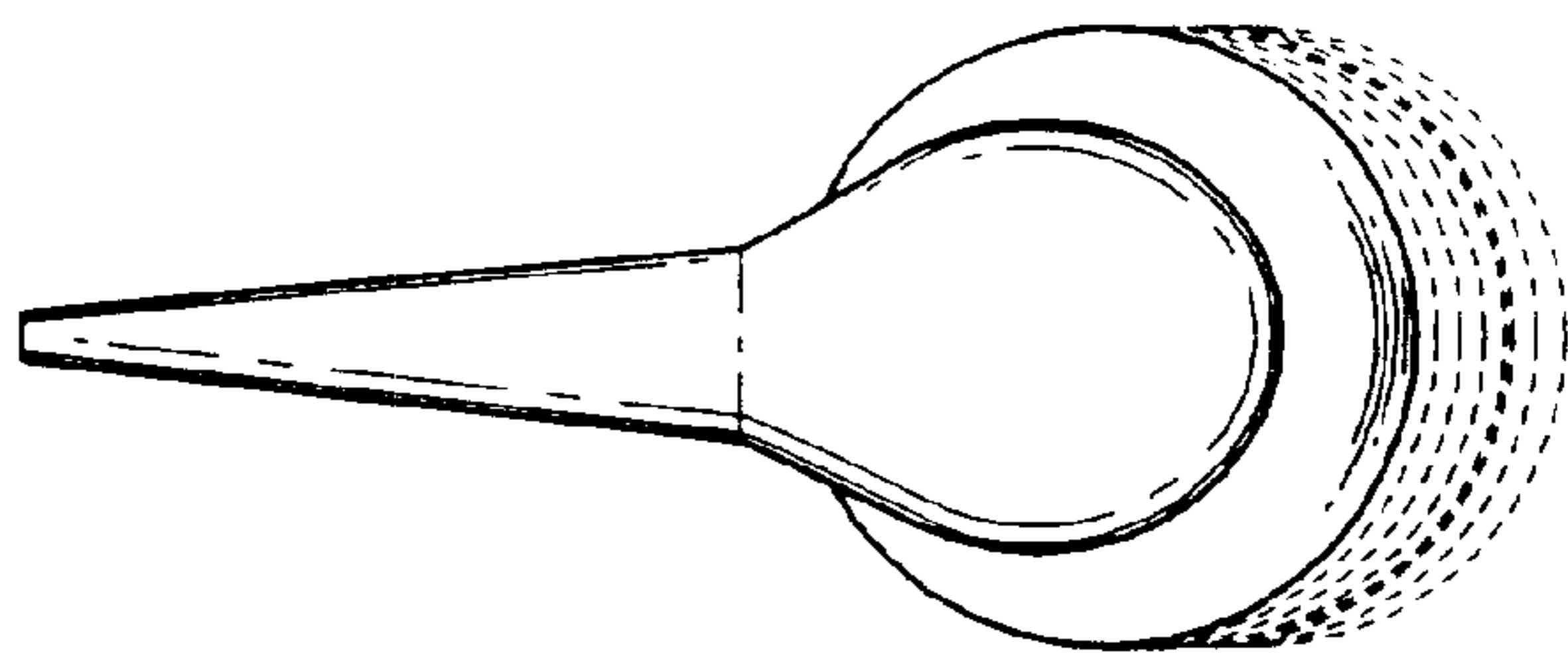

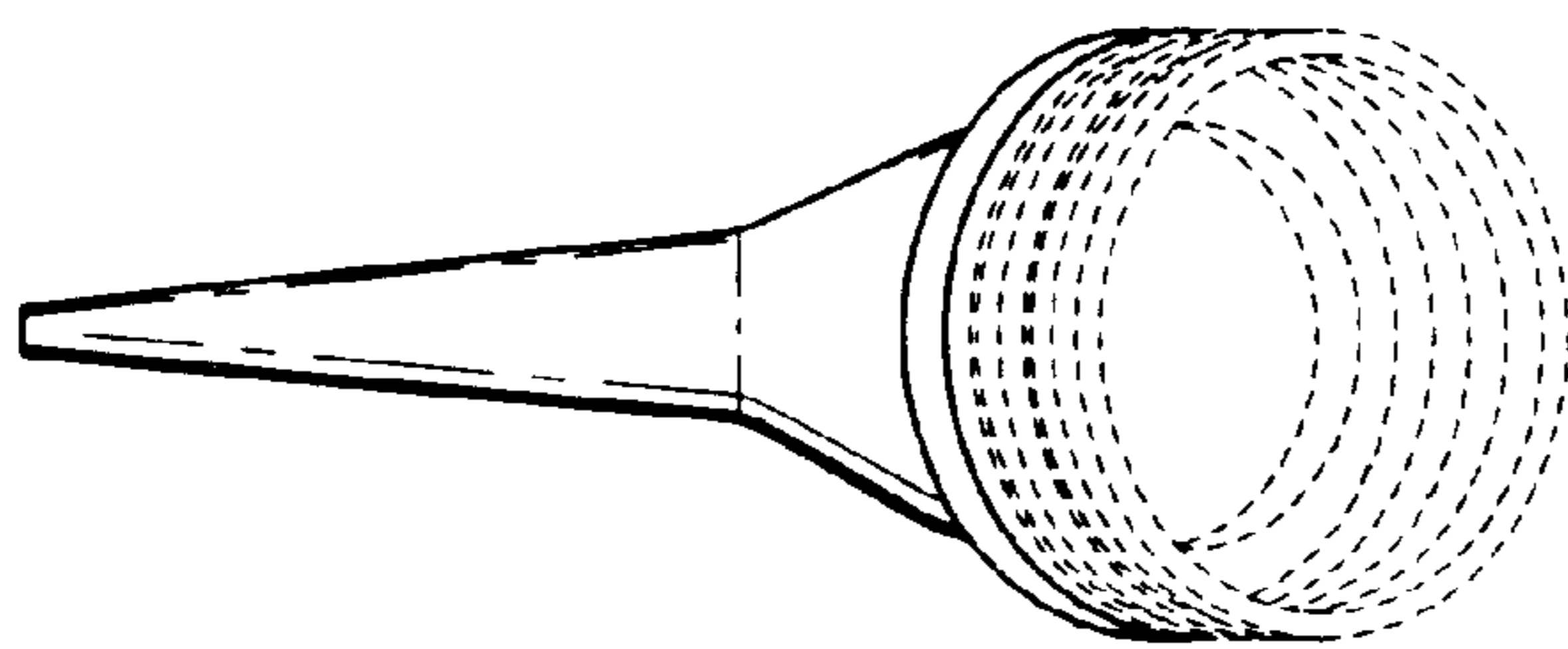

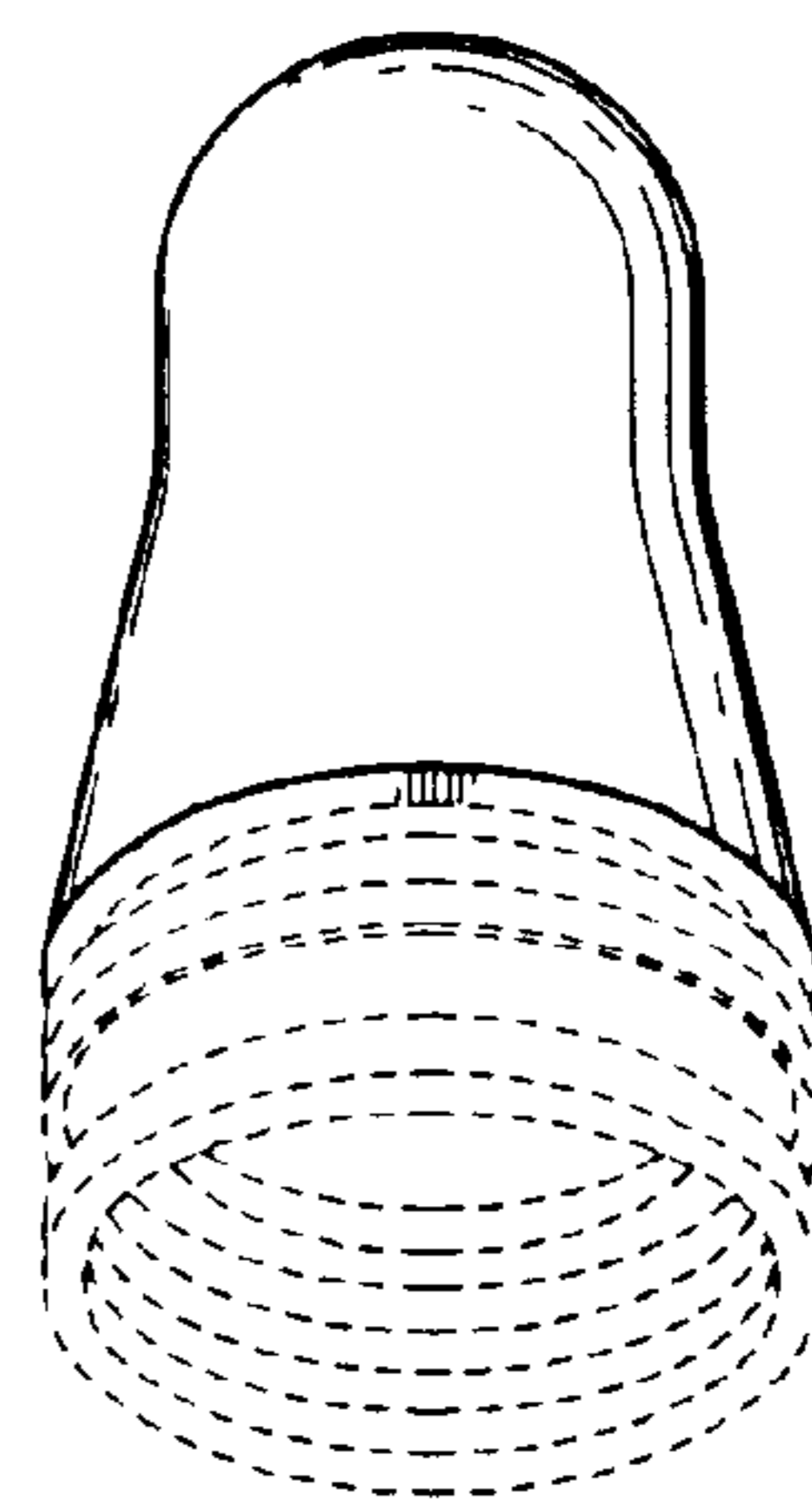

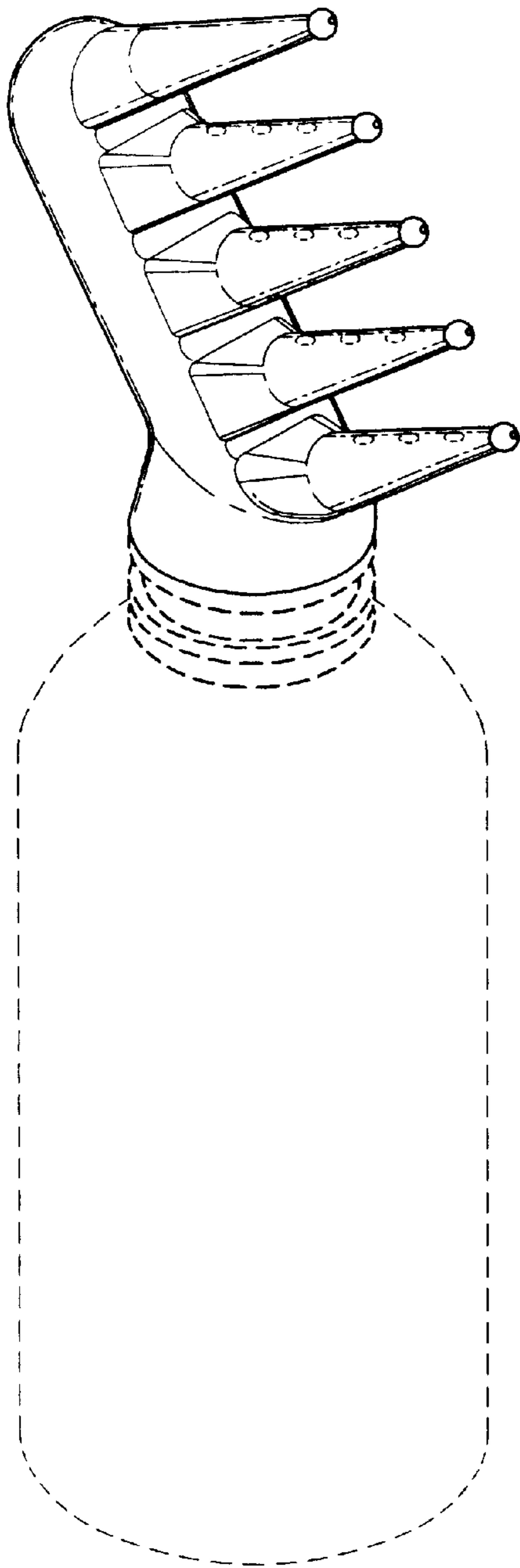

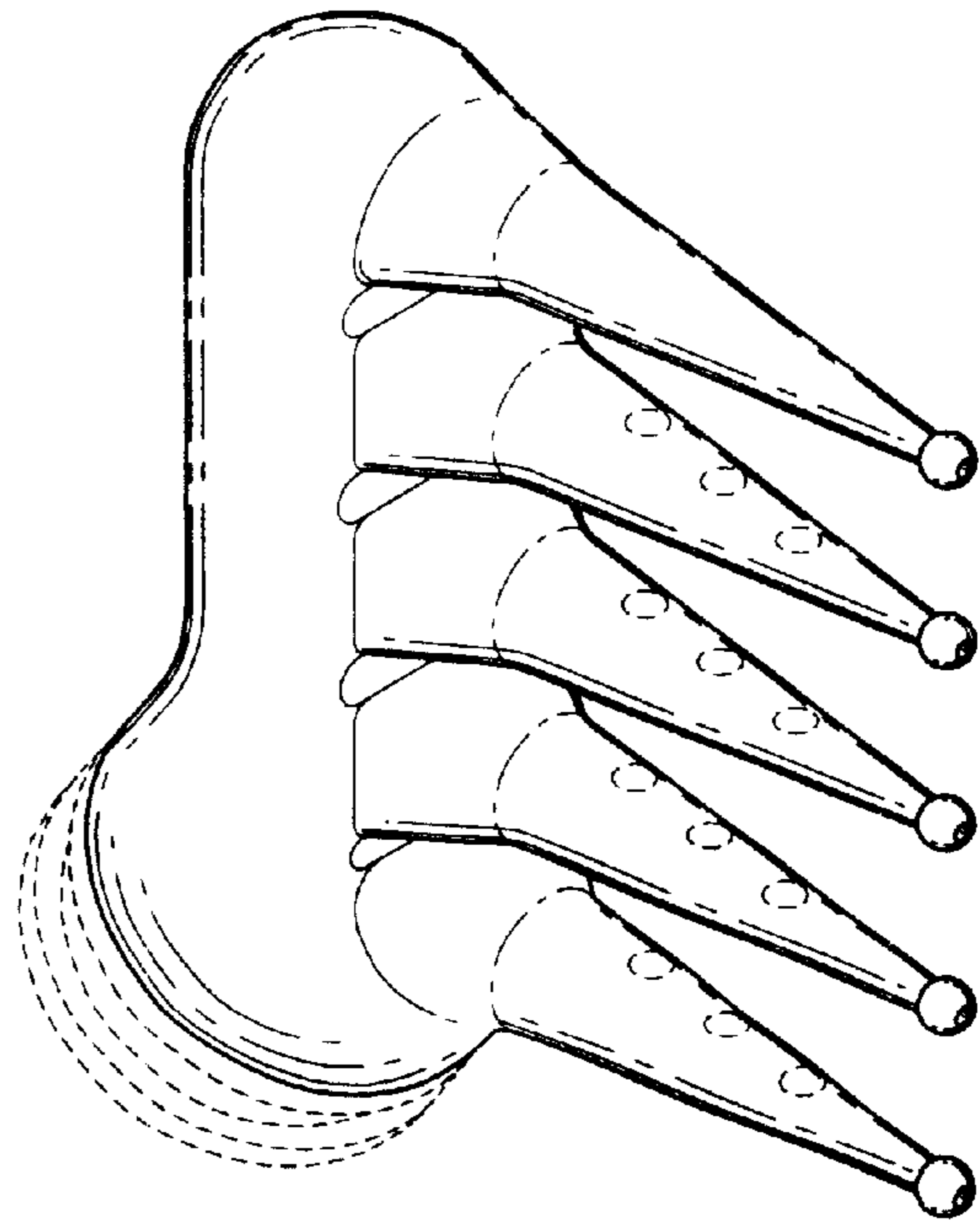

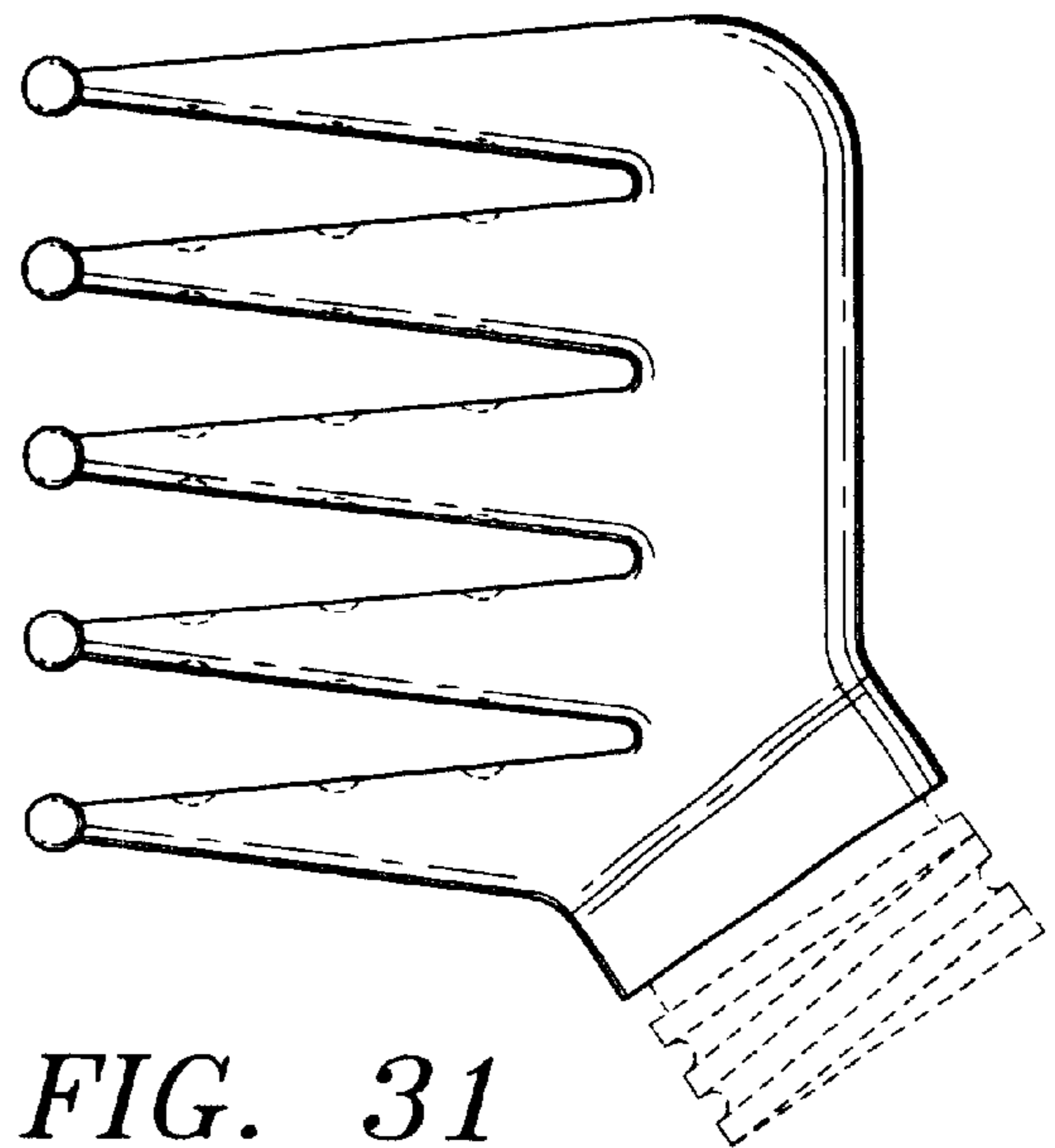

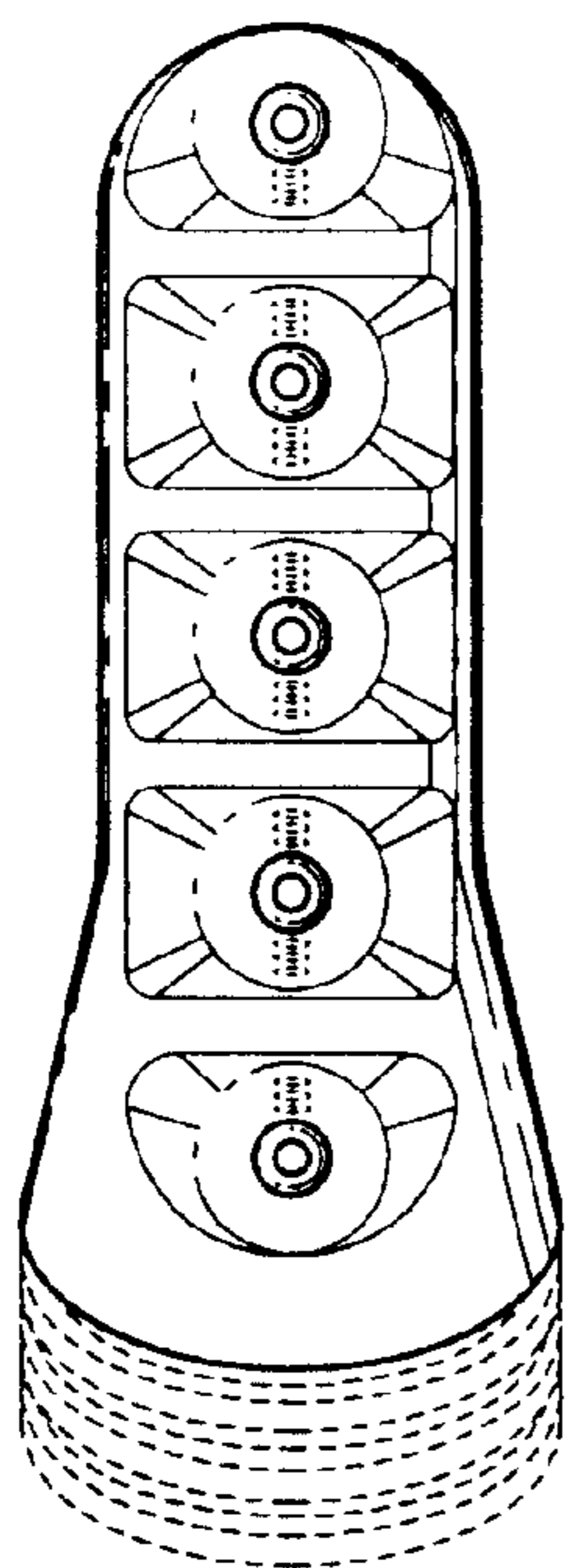

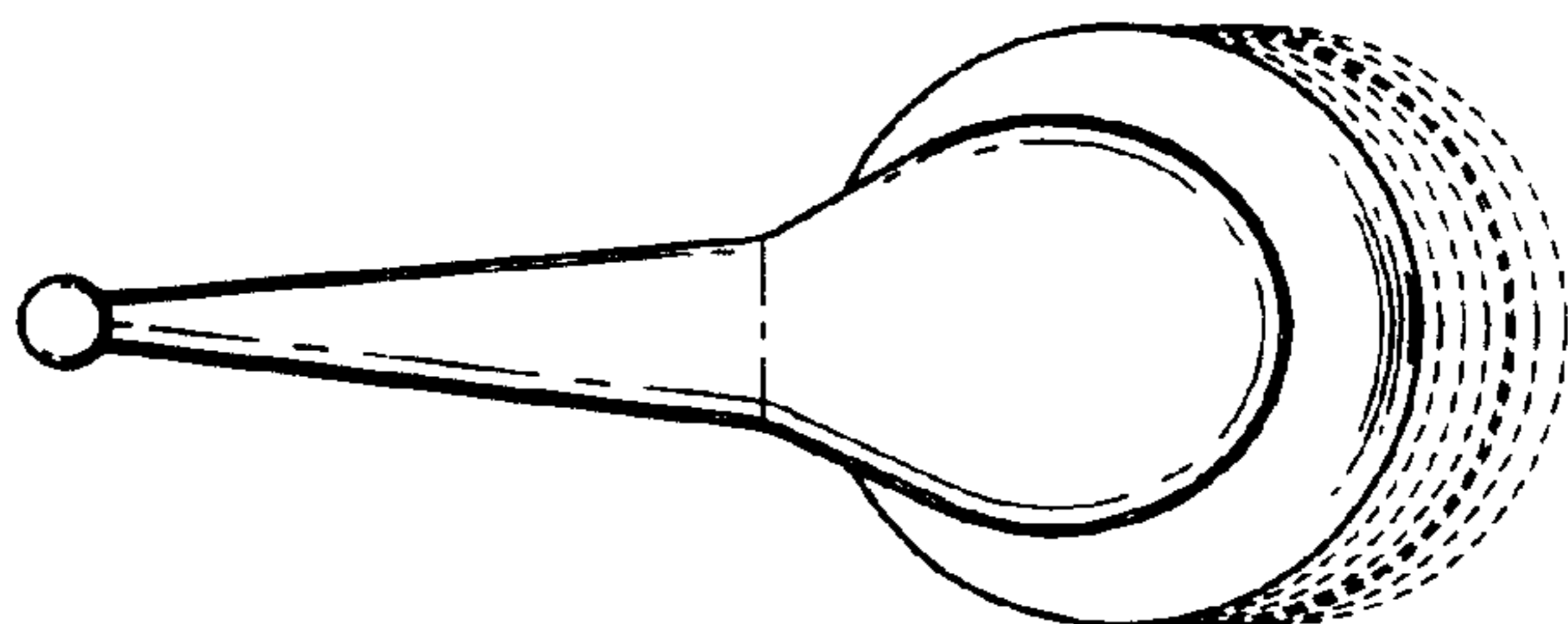

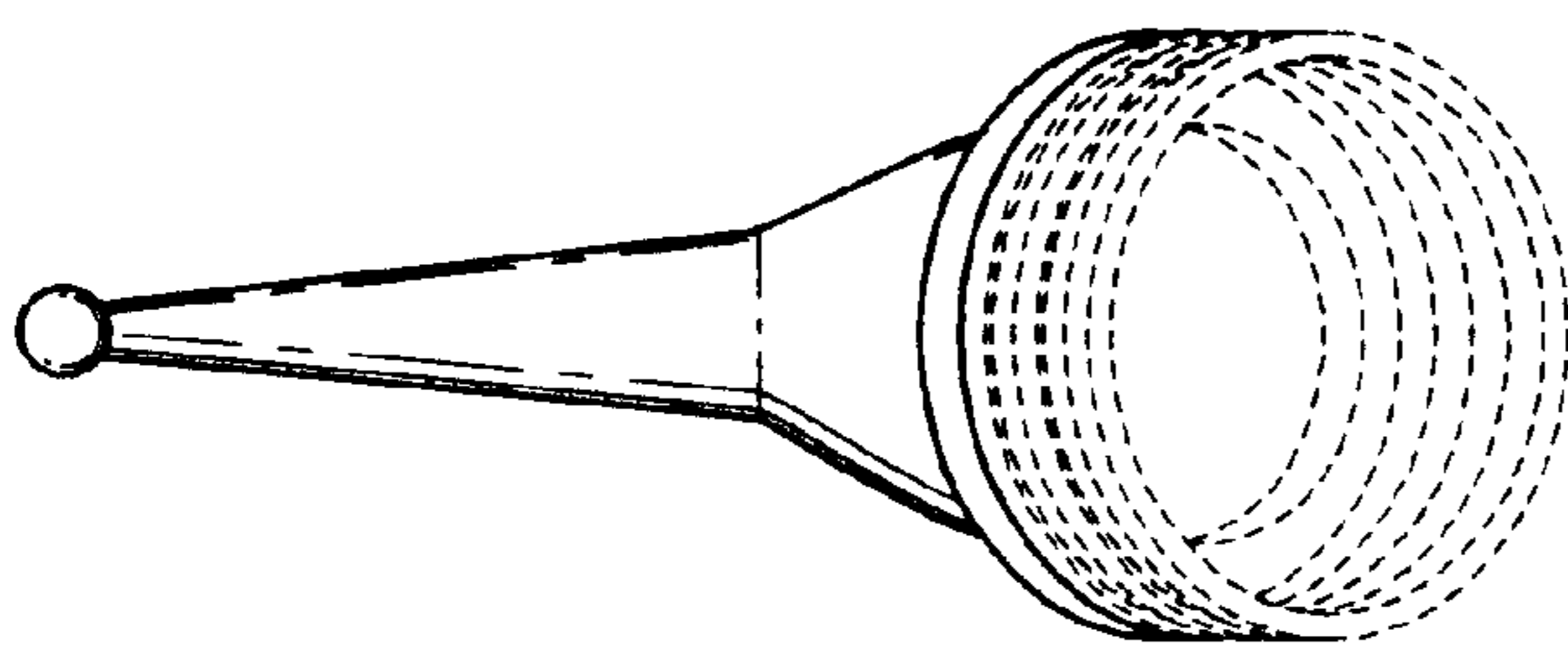

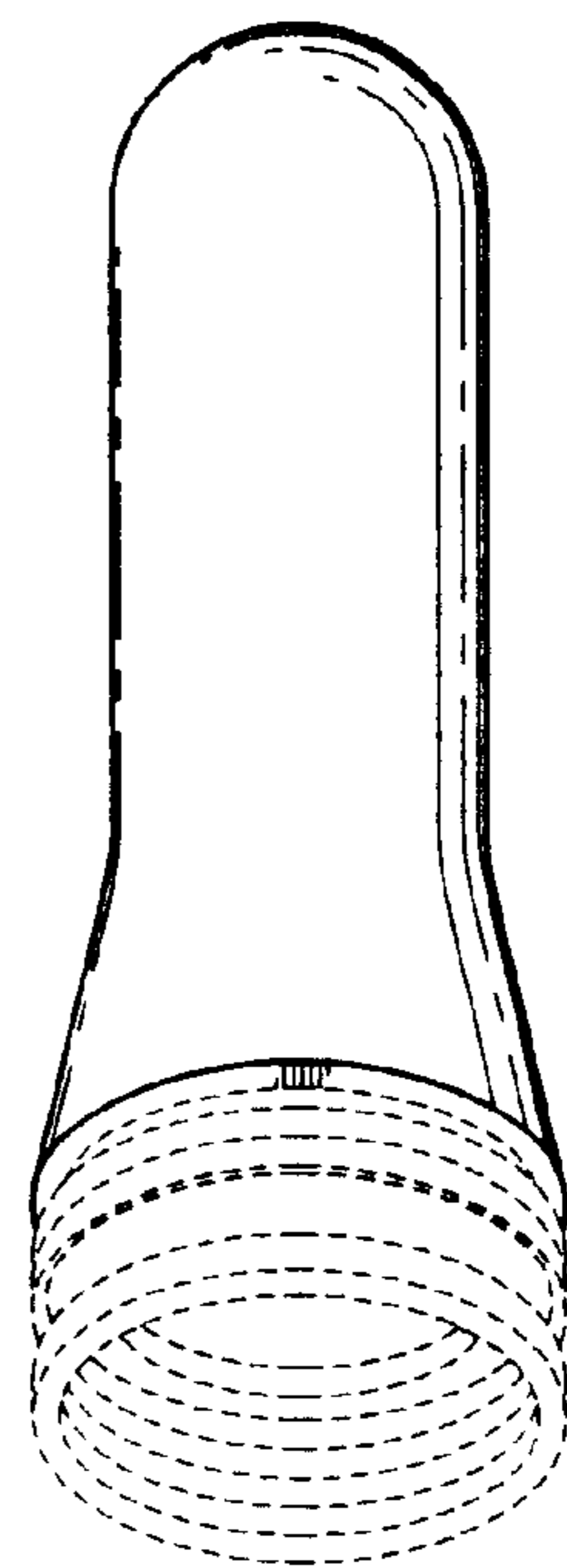
