(57) **CLAIM**

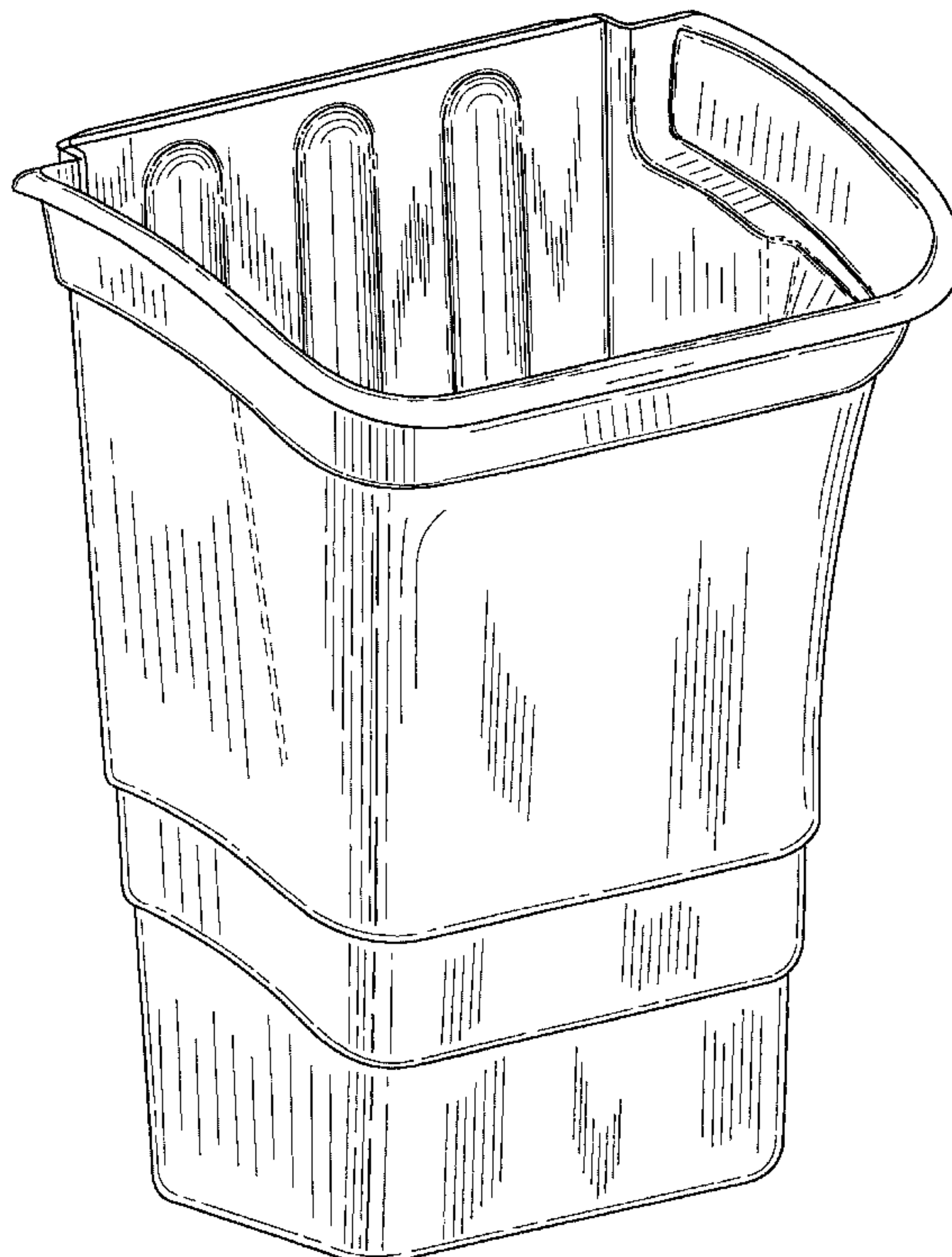
The ornamental design for a utility bin, as shown and described.

DESCRIPTION

FIG. 1 is a top frontal perspective view of a utility bin according to my new design;

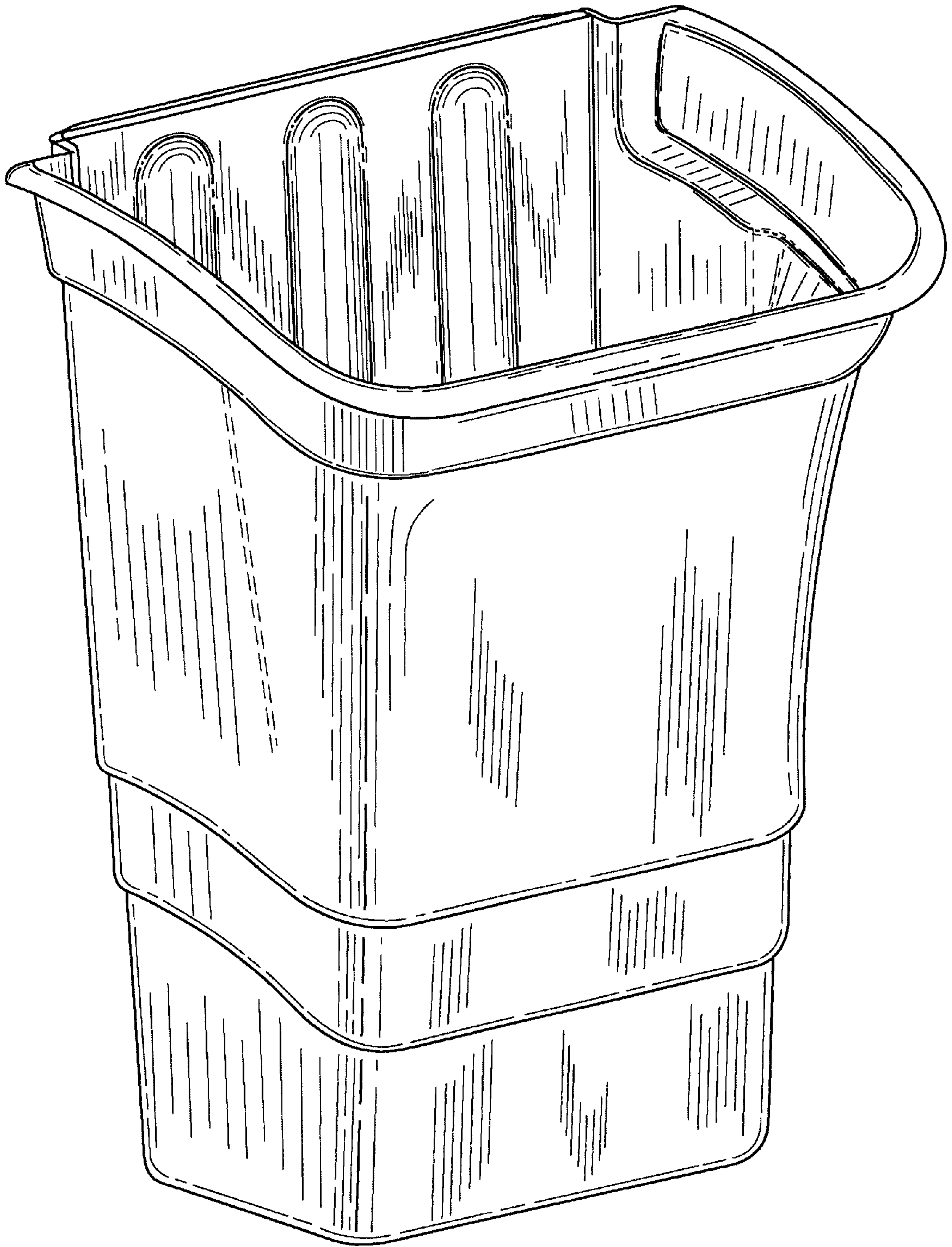

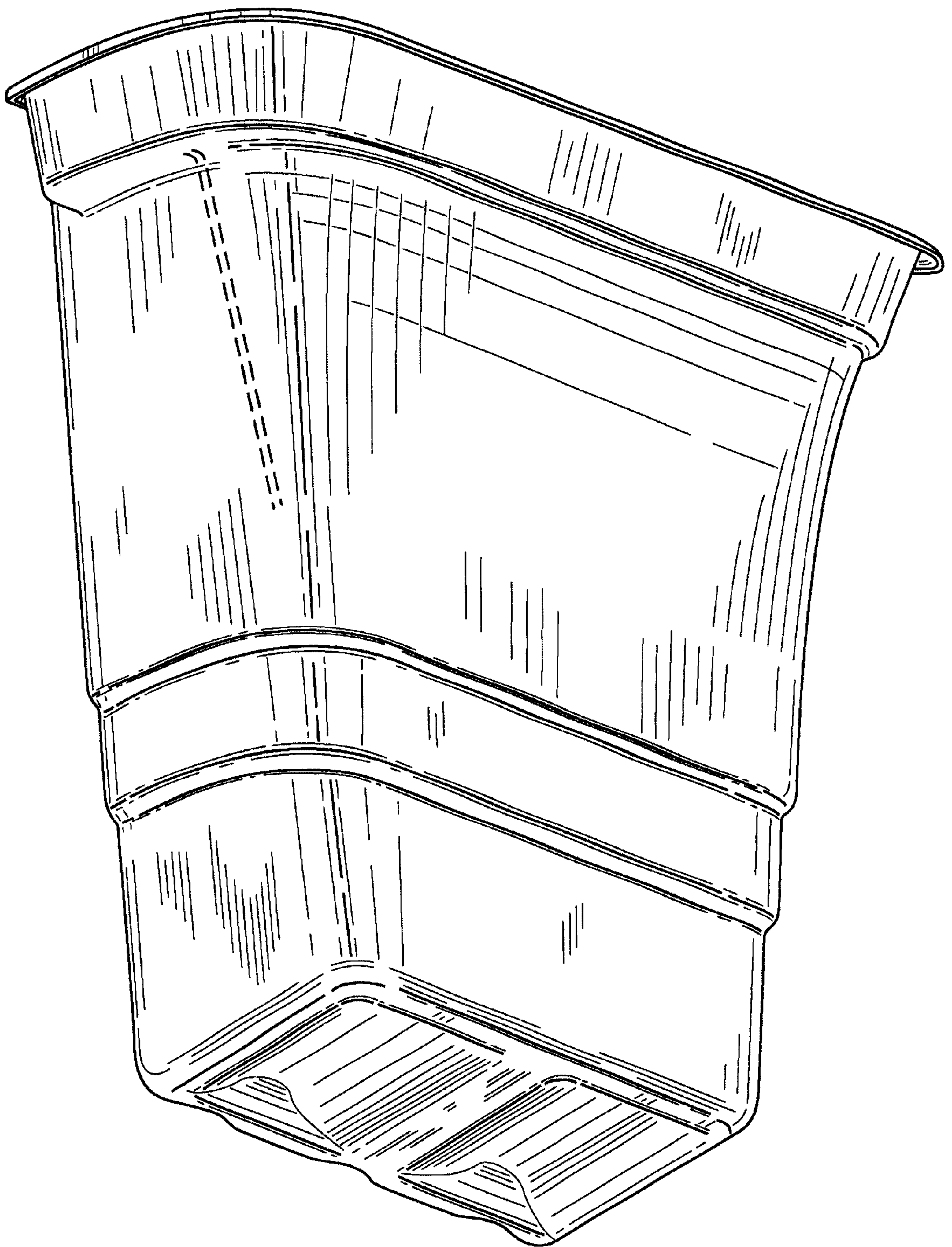

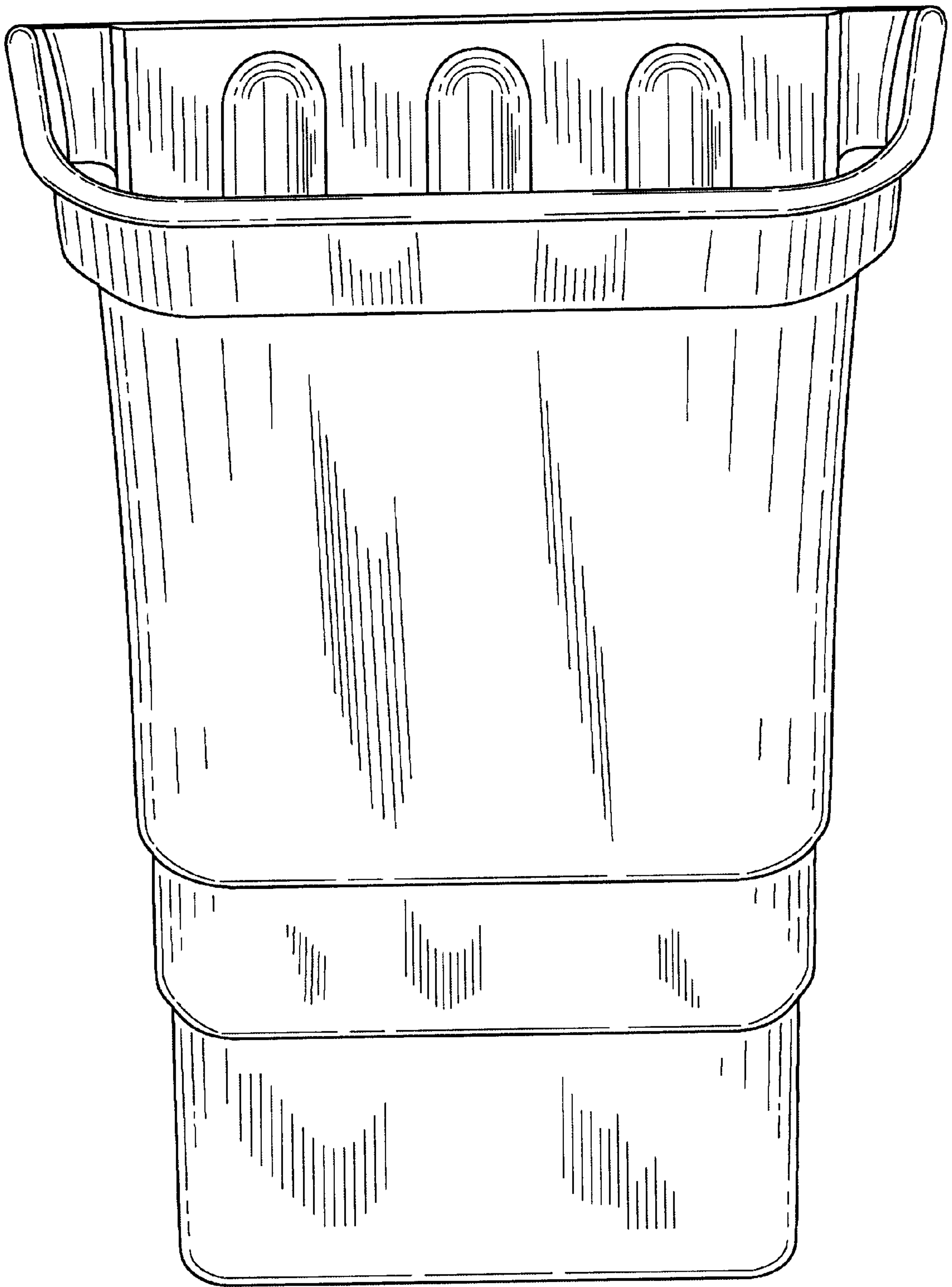

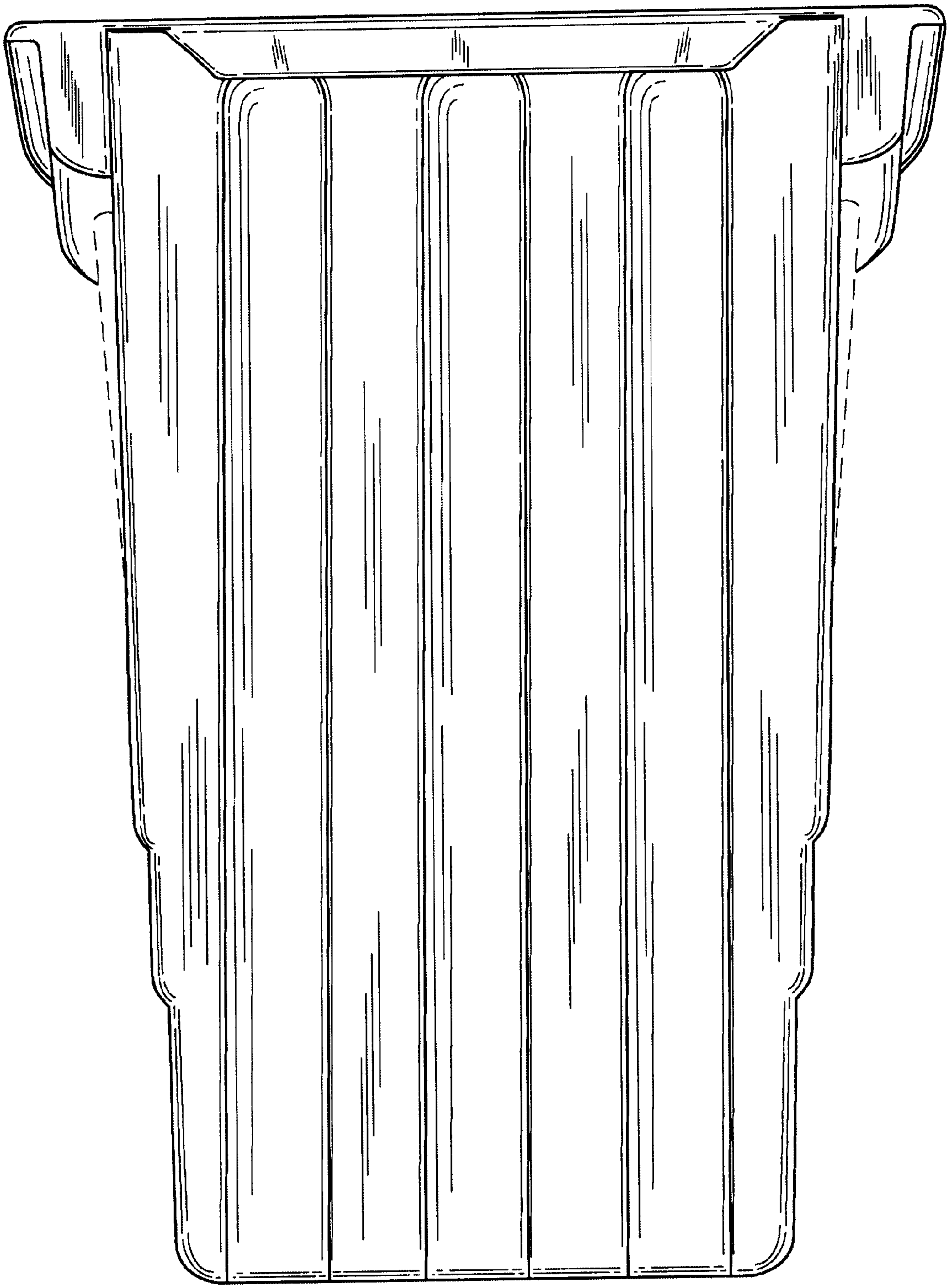

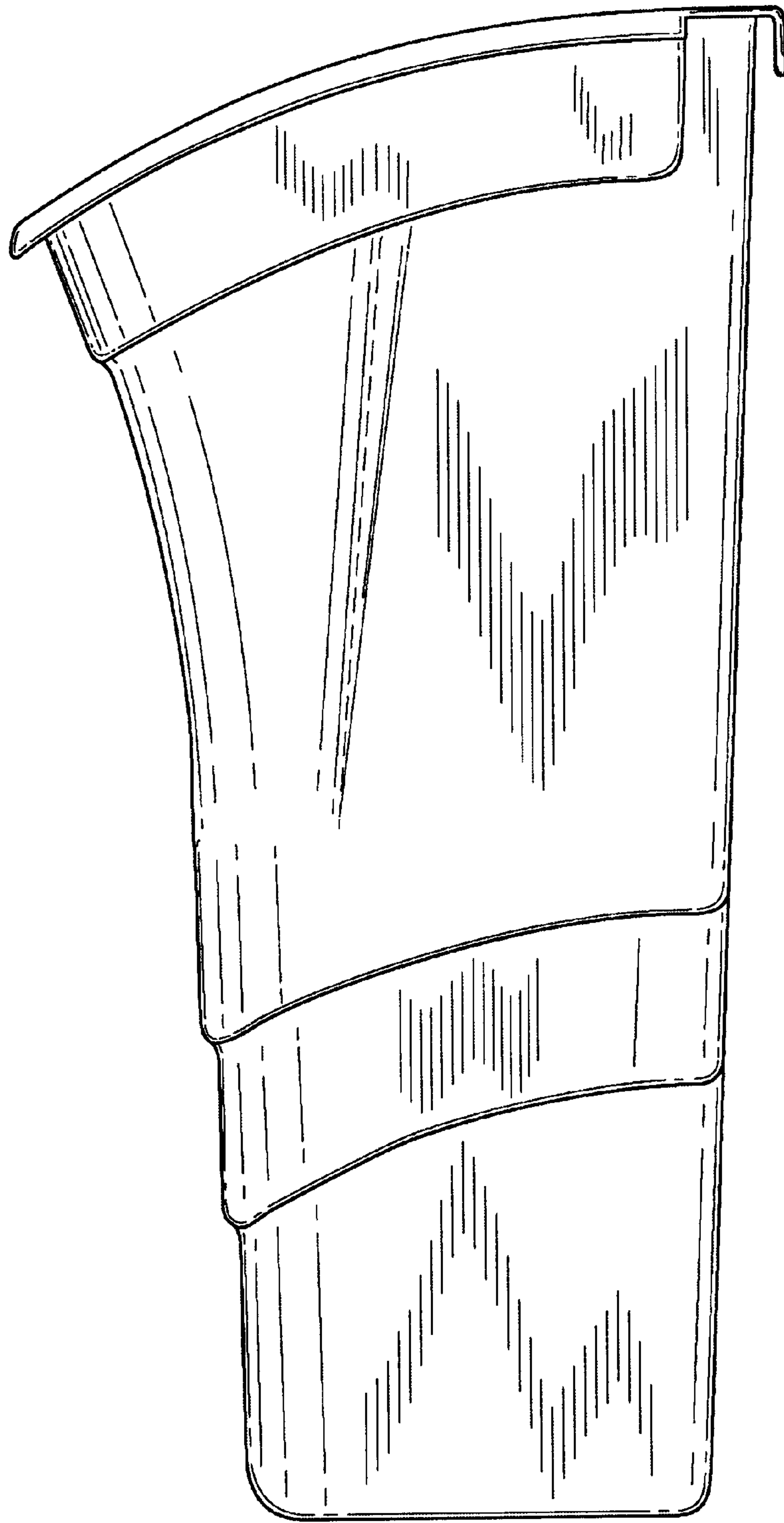

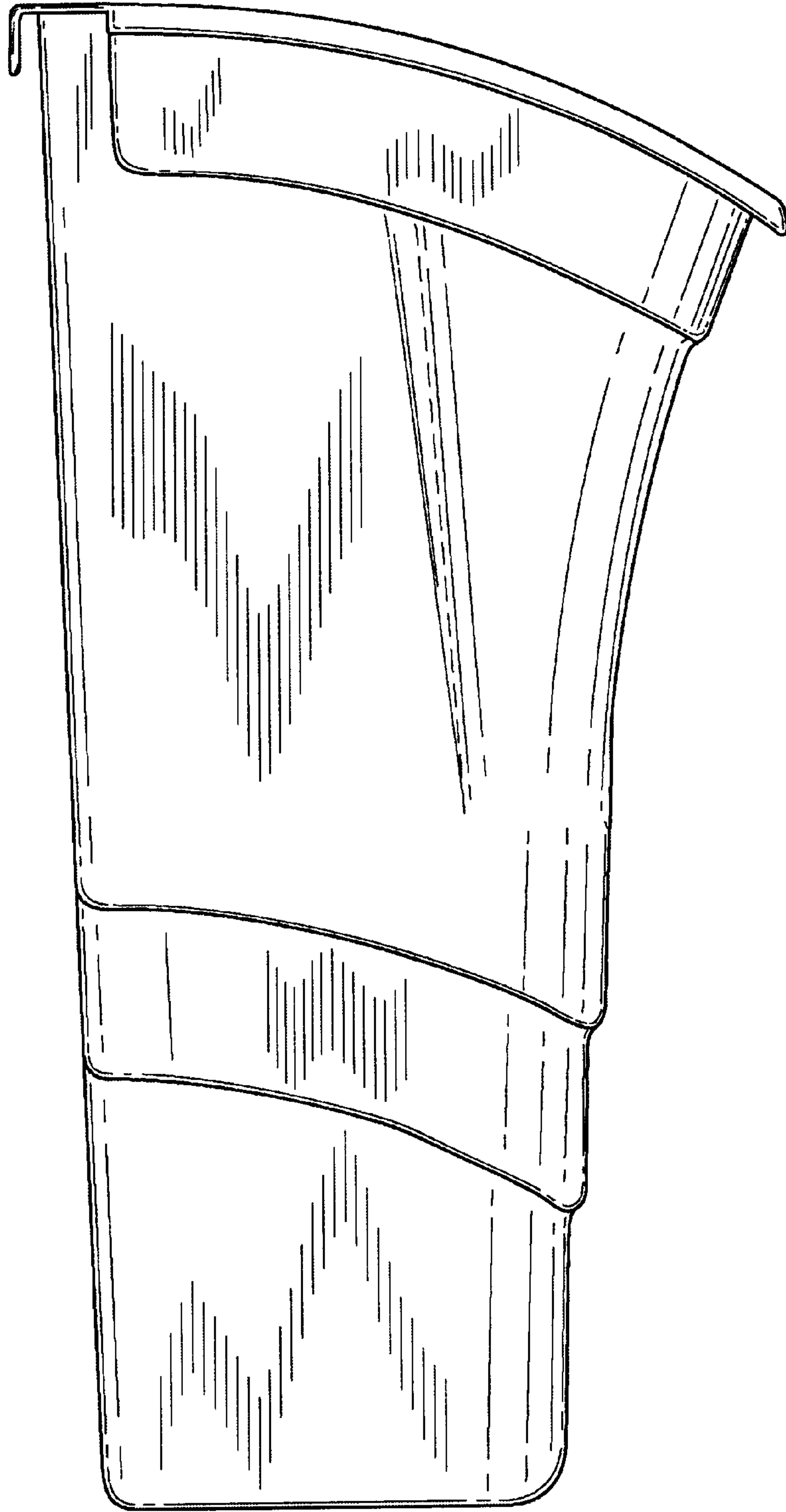

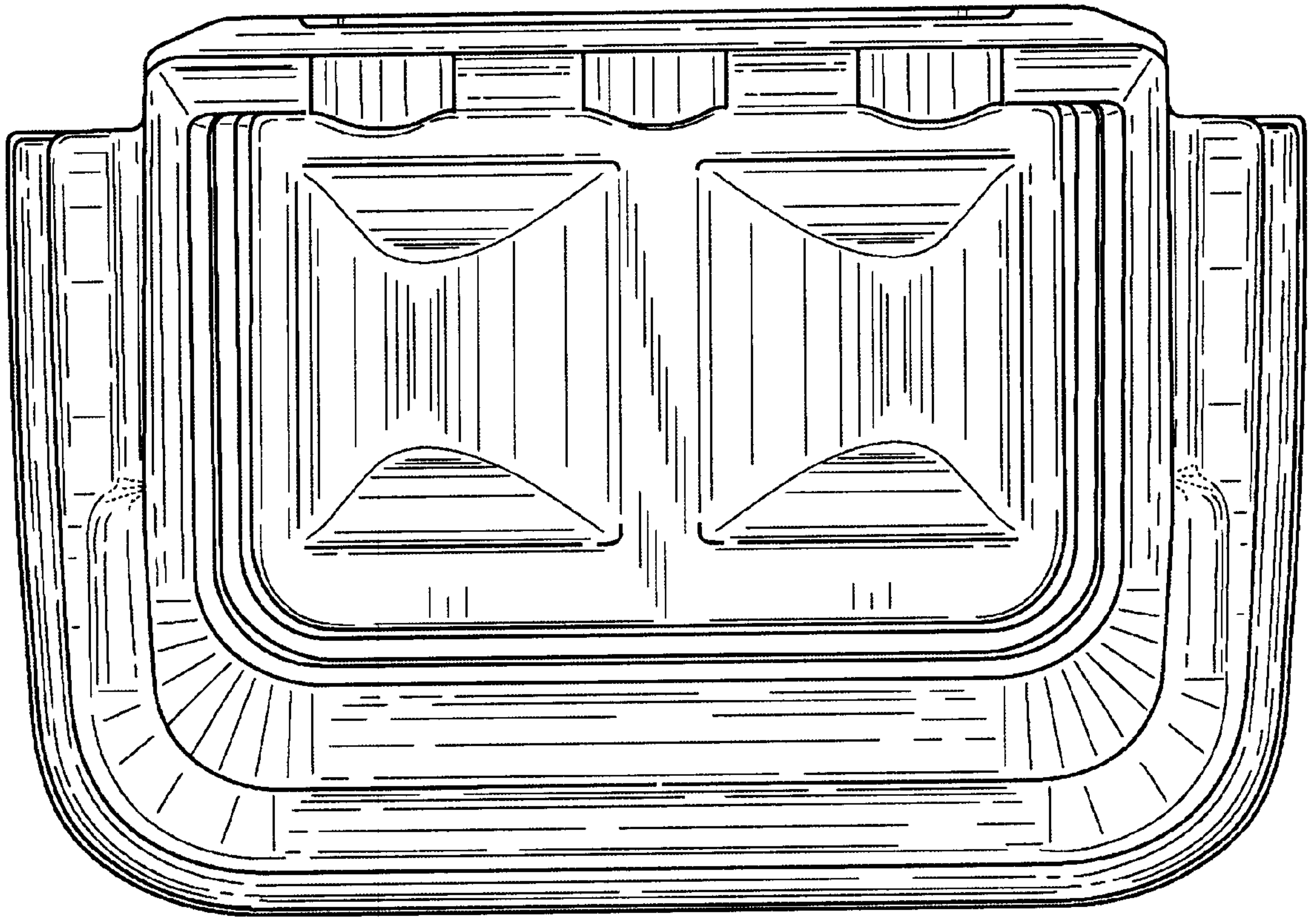

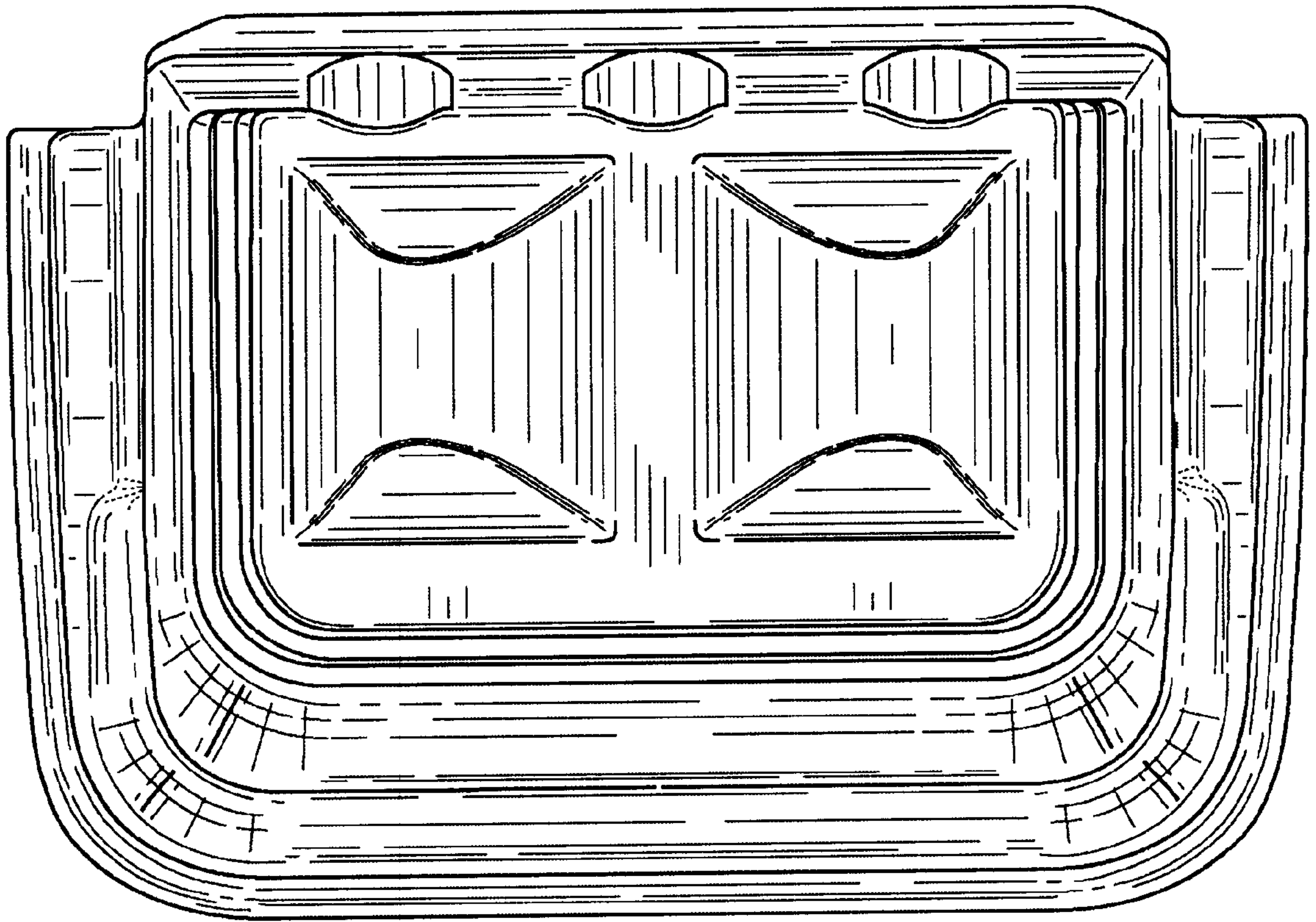
