(57) **CLAIM**

The ornamental design of a pen and pencil holder, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of our pen and pencil holder as seen from above;

FIG. 2 is a top plan view of our pen and pencil holder;

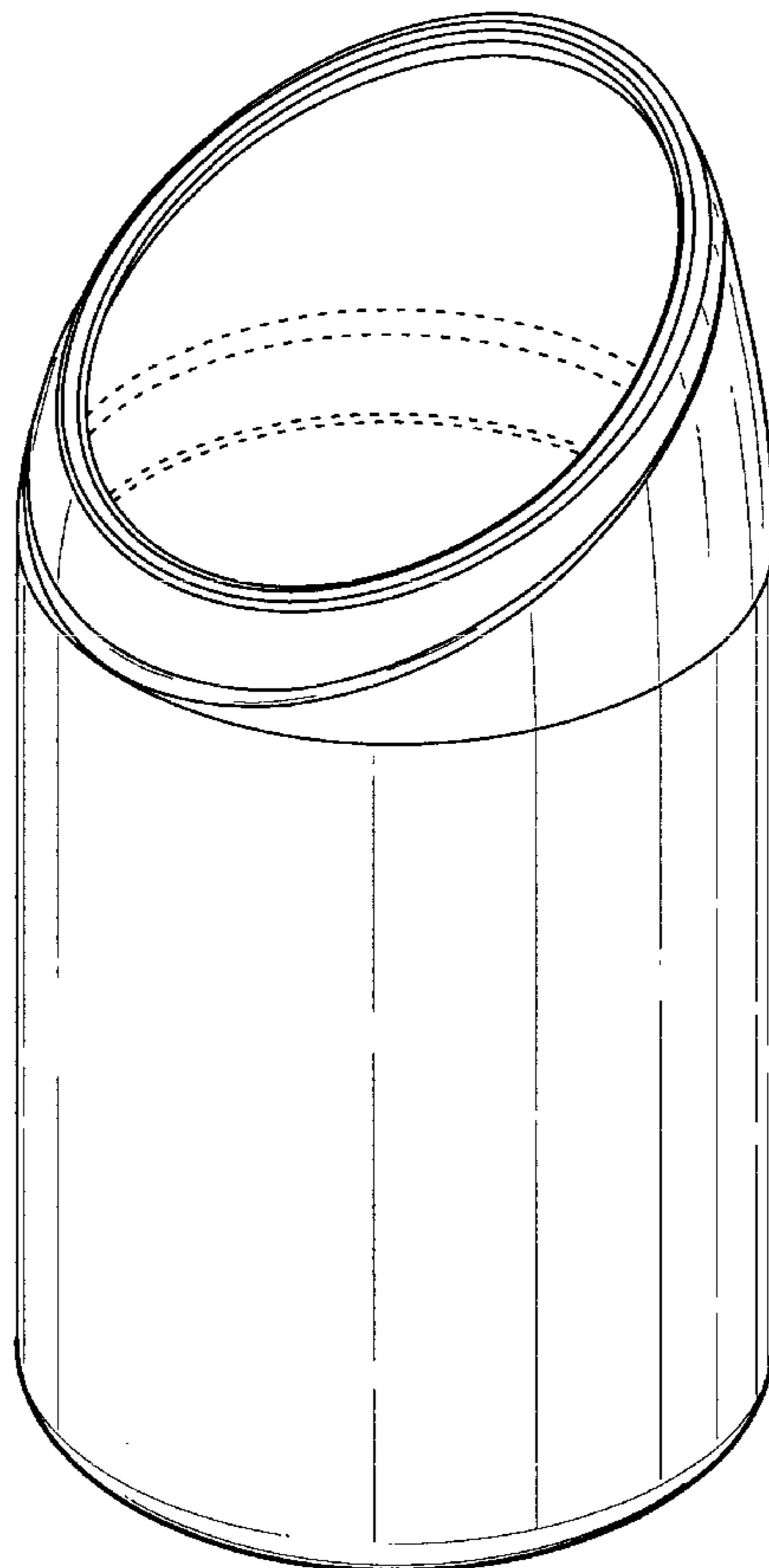
FIG. 3 is a rear elevation of our pen and pencil holder;

FIG. 4 is a side elevation of our pen and pencil holder taken from the left side thereof, it being understood that the right side is a mirror image of FIG. 4;

FIG. 5 is a front elevation of our pen and pencil holder; and, FIG. 6 is a bottom plan view of our pen and pencil holder.

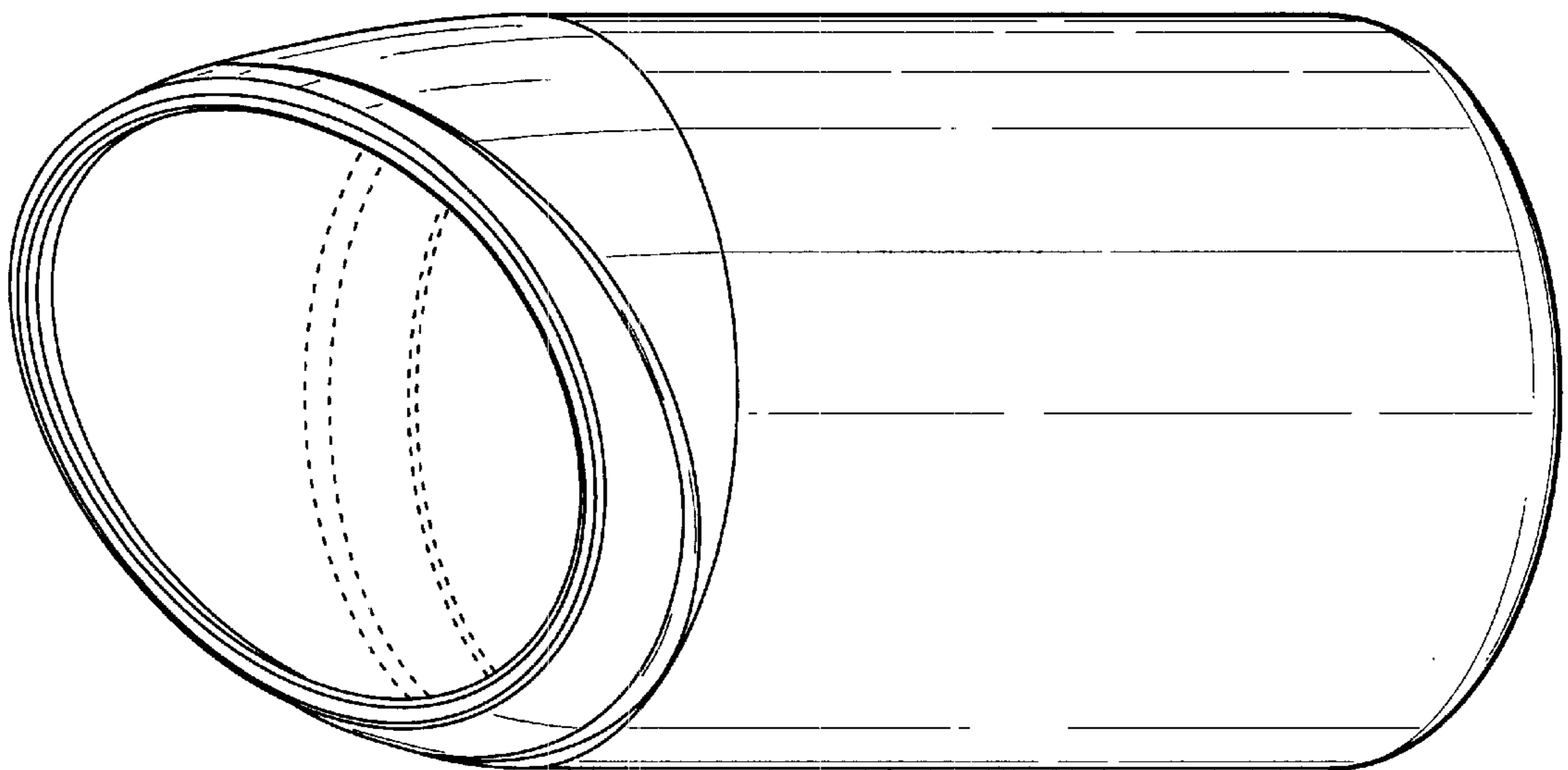

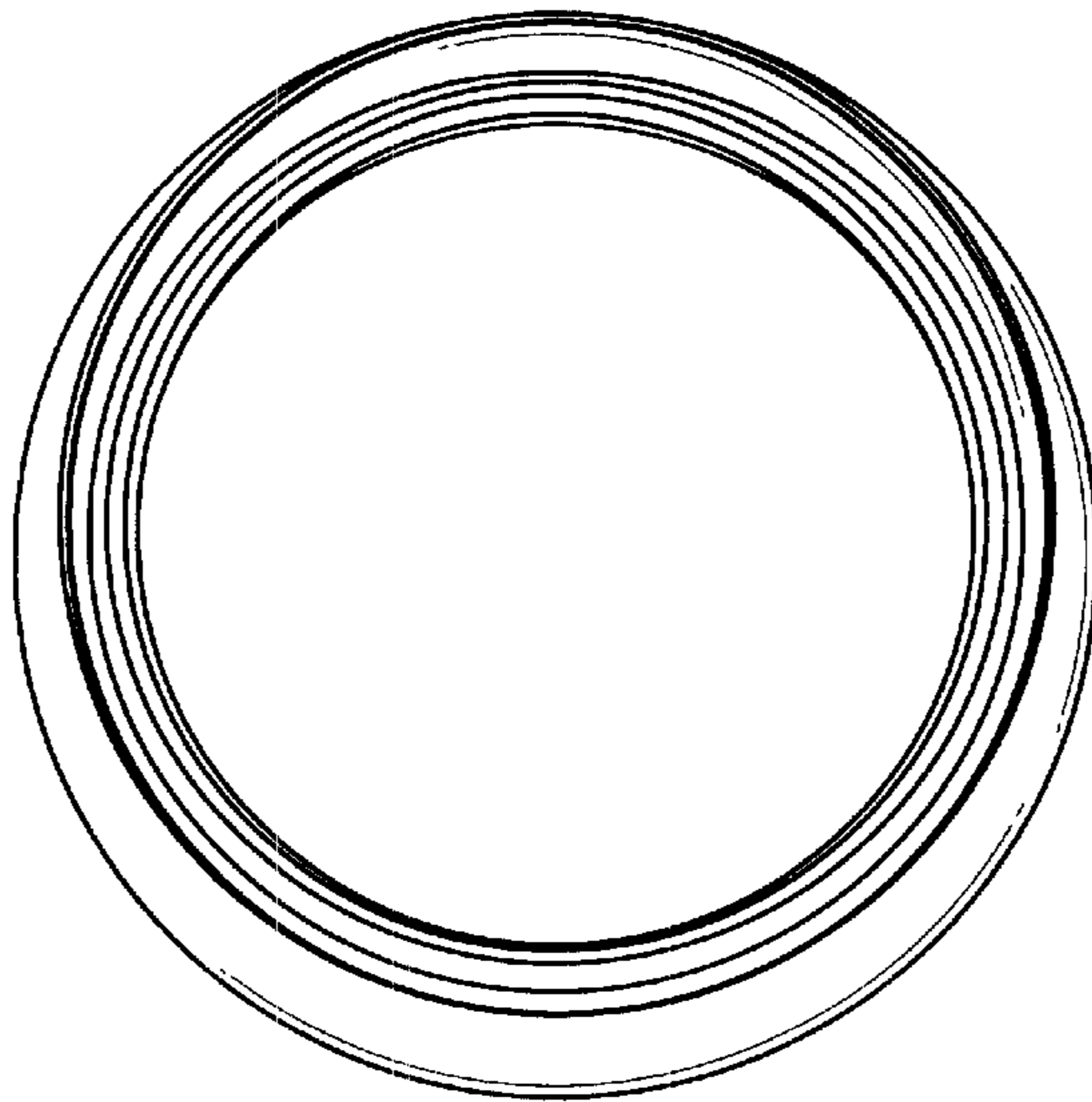

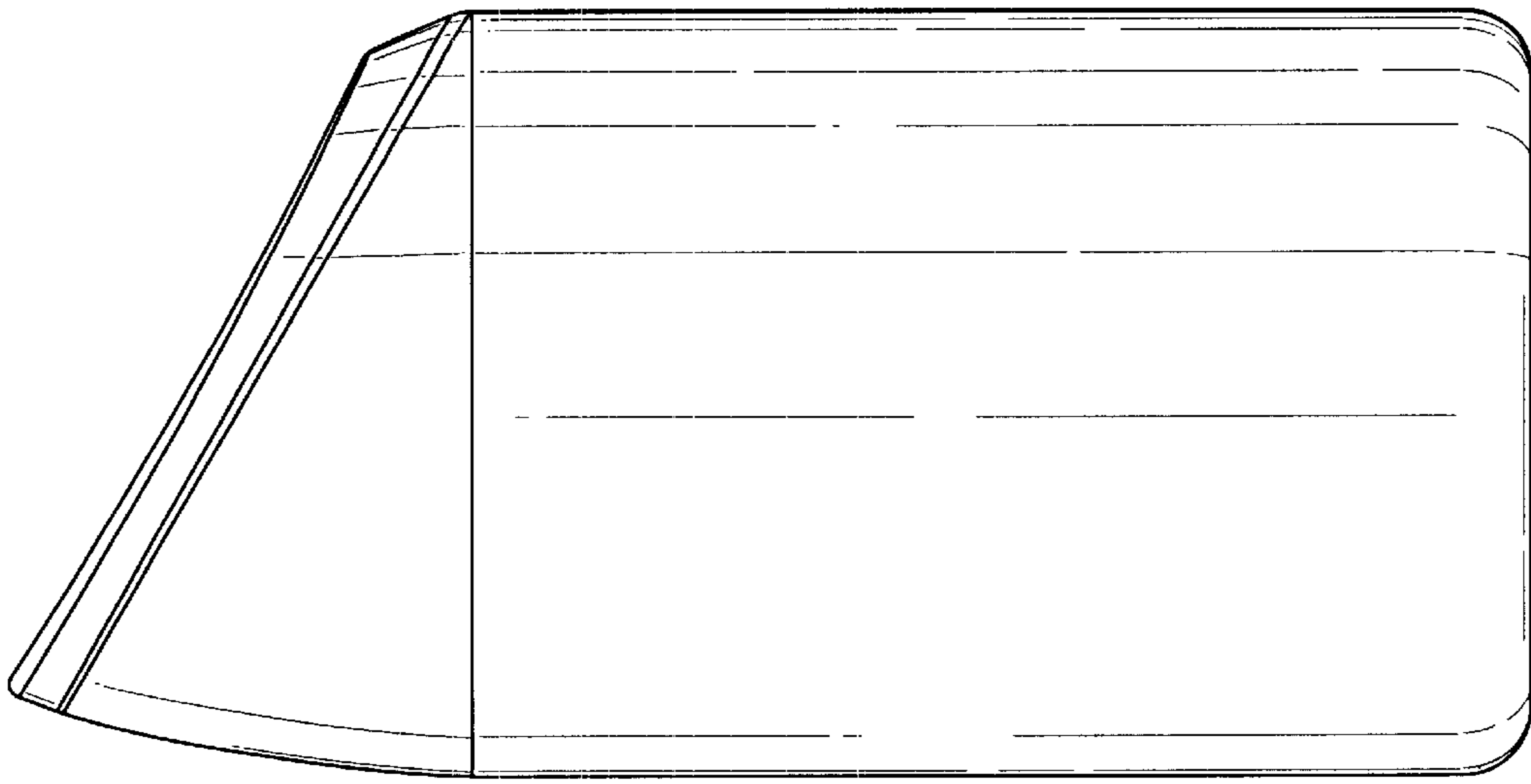

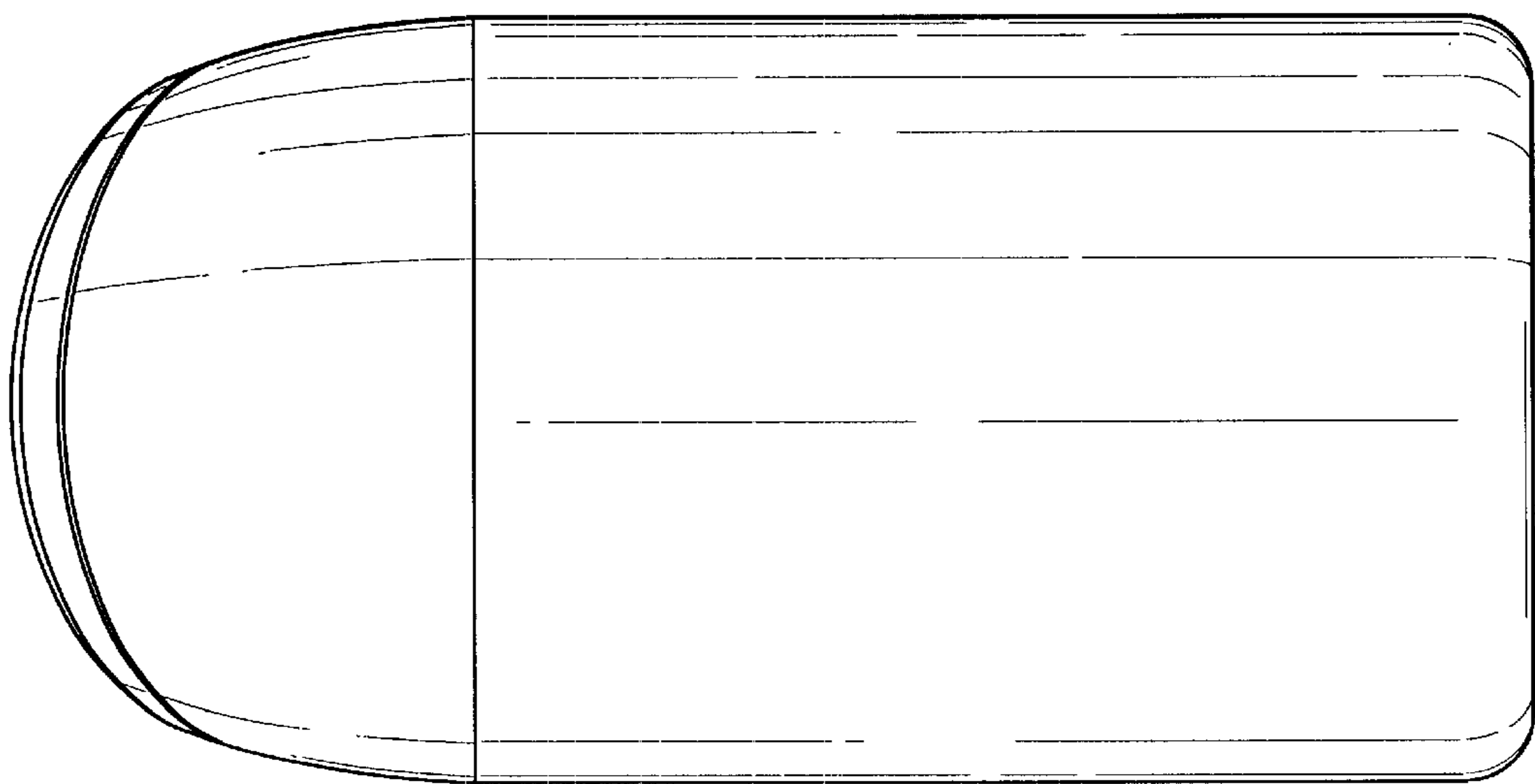

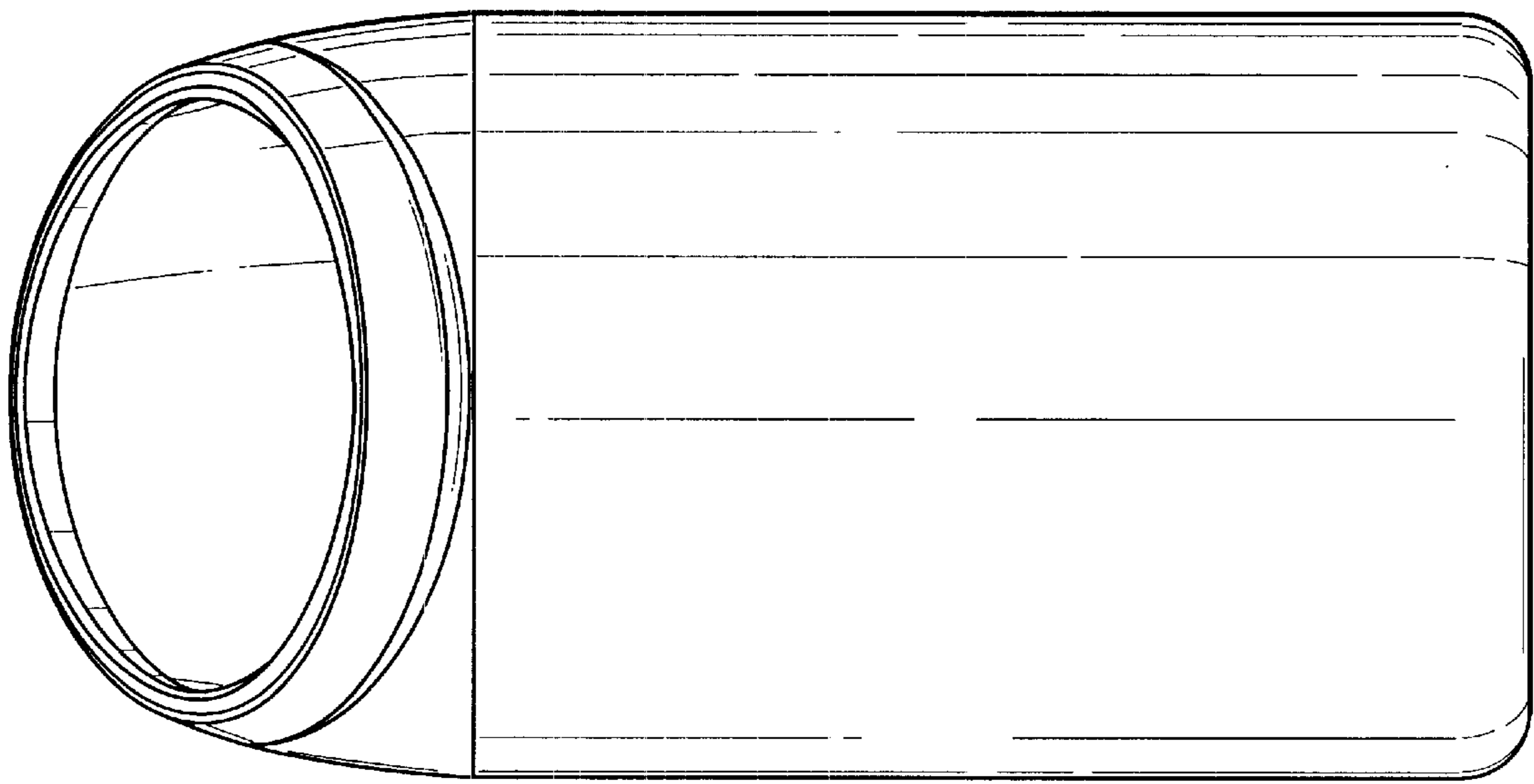

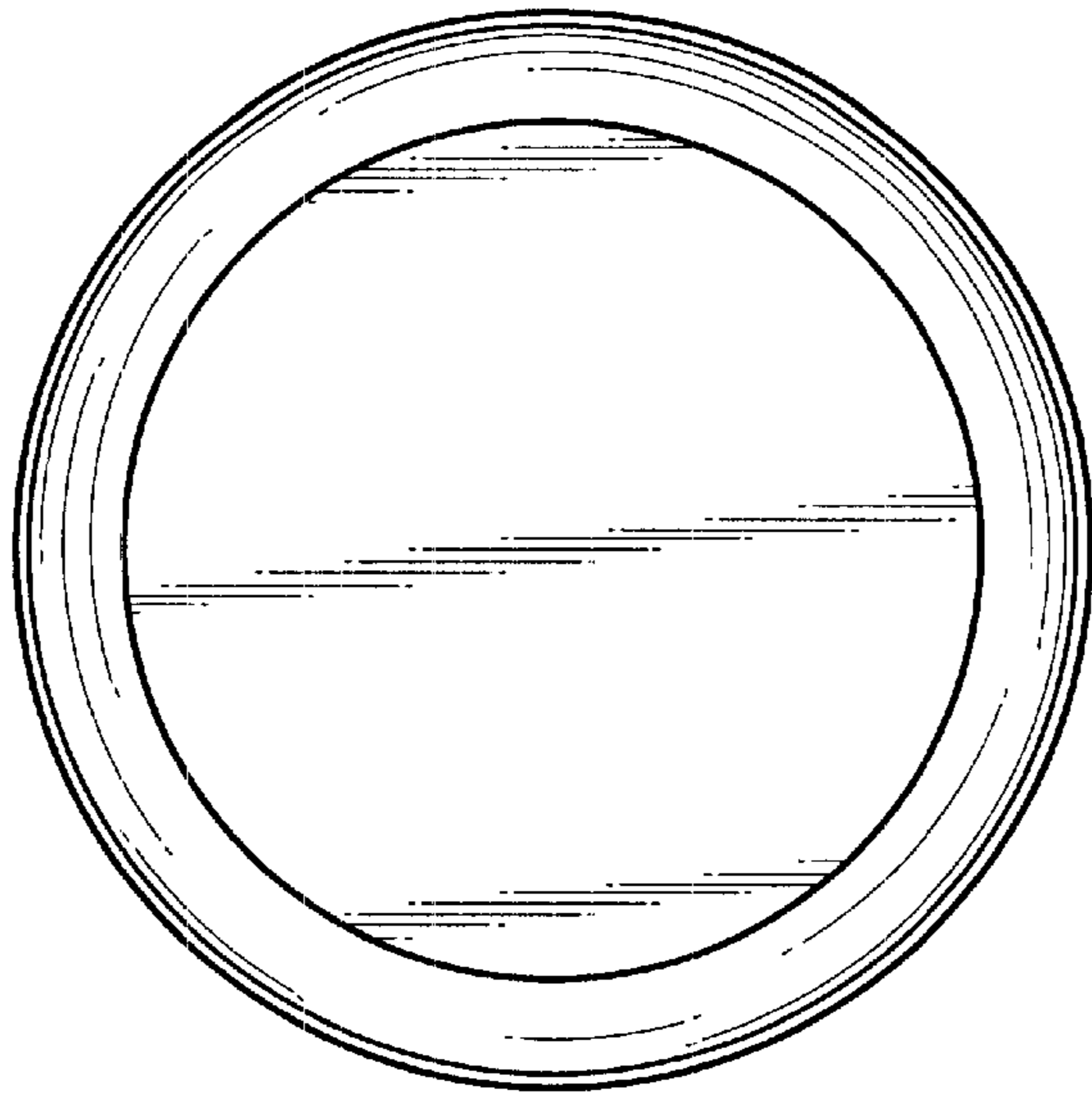
