(57) **CLAIM**

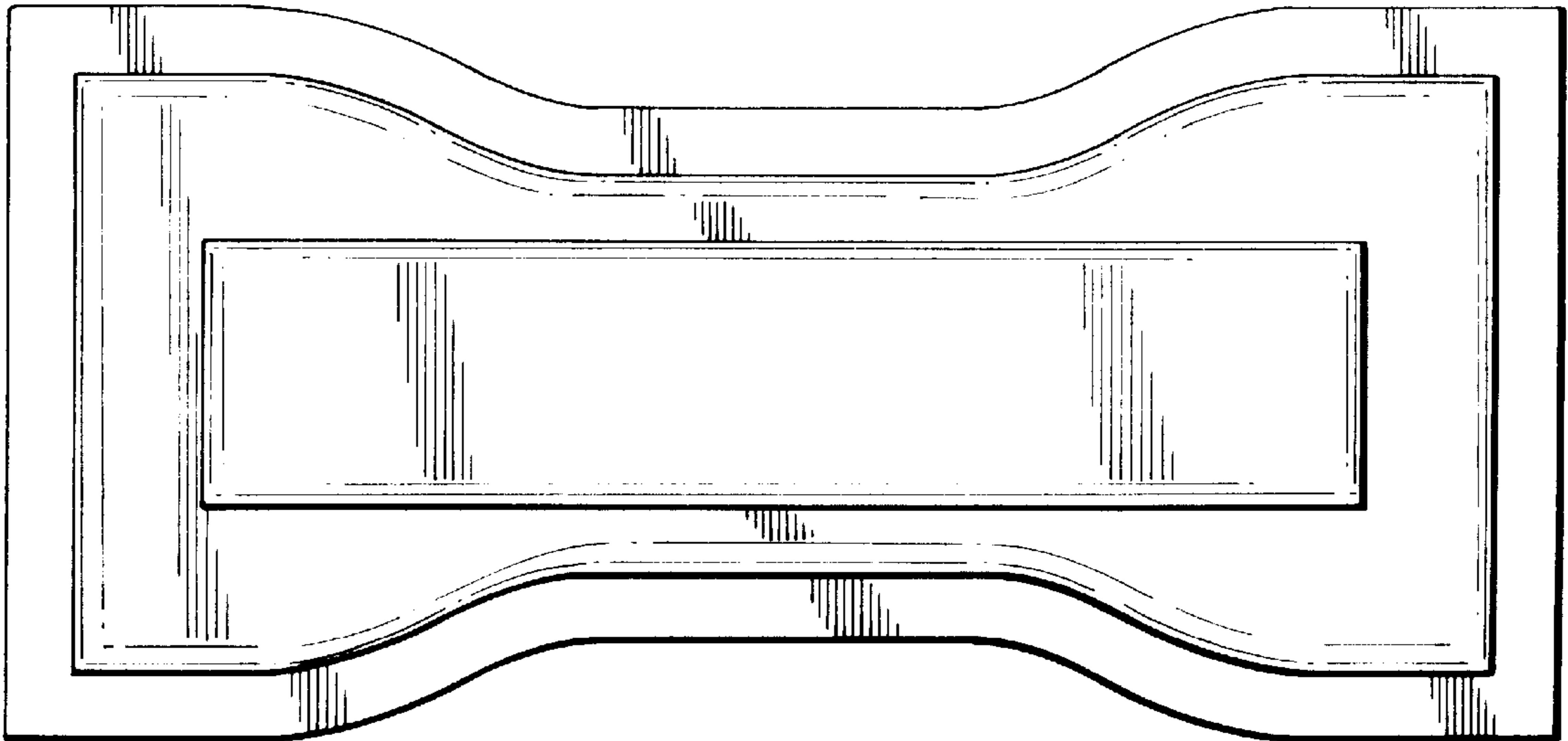
The ornamental design for an absorbent garment with supplemental pad insert, as shown and described.

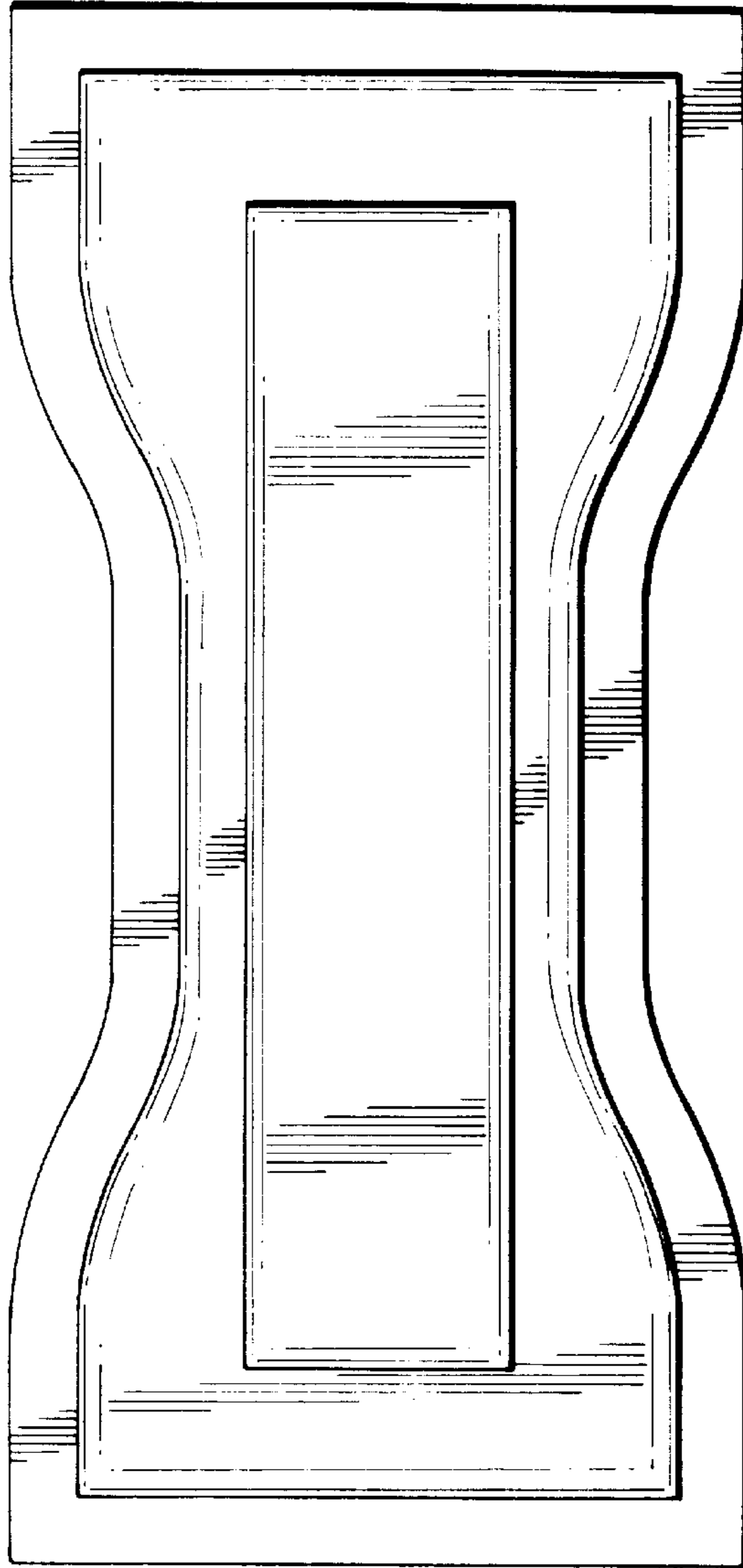

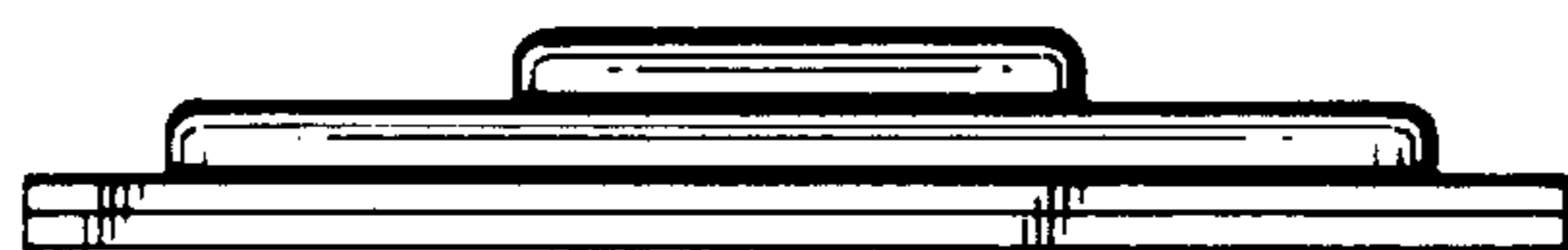

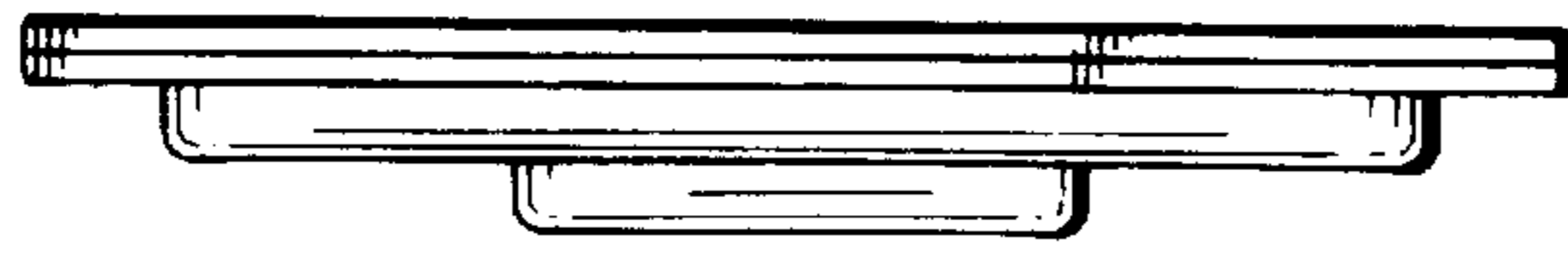
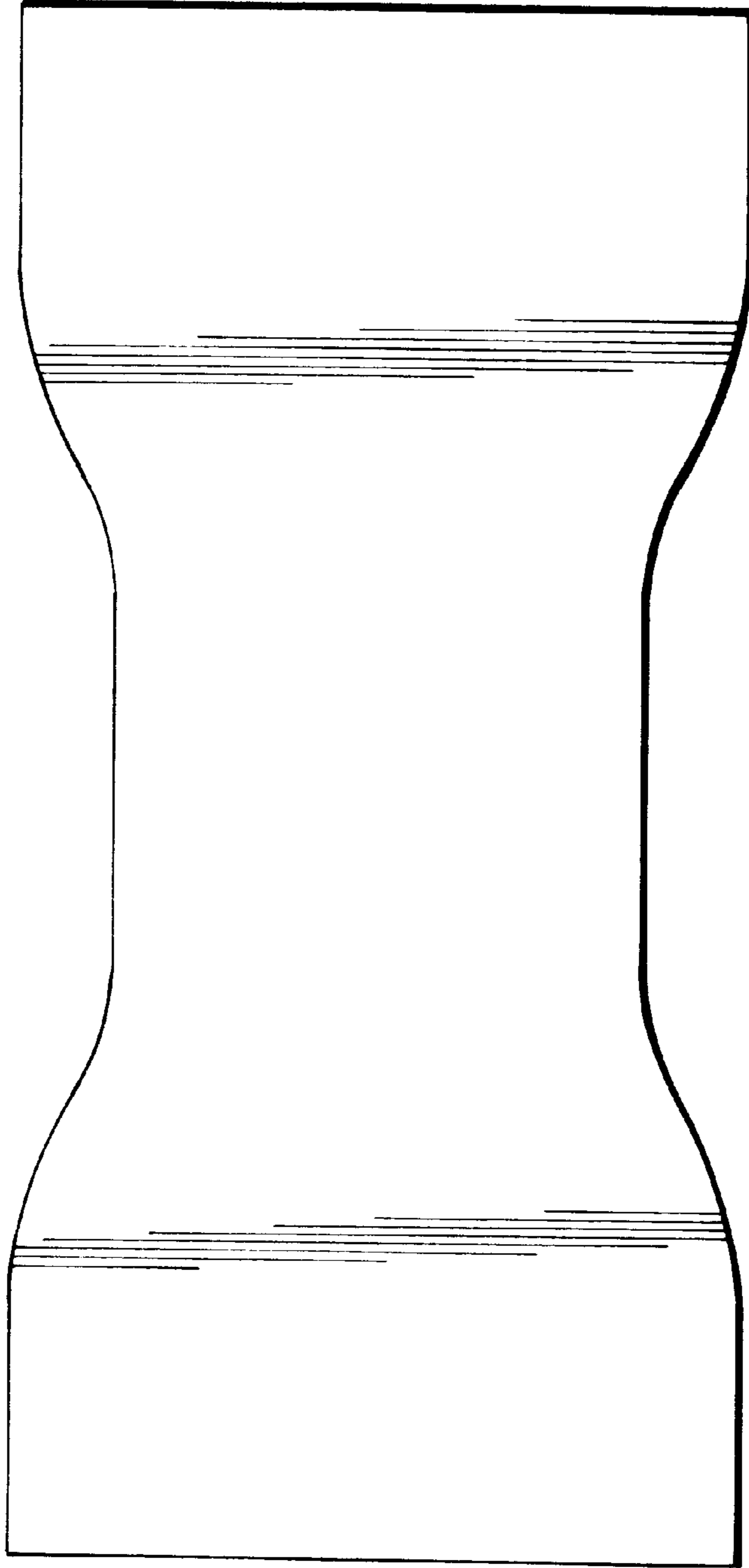
