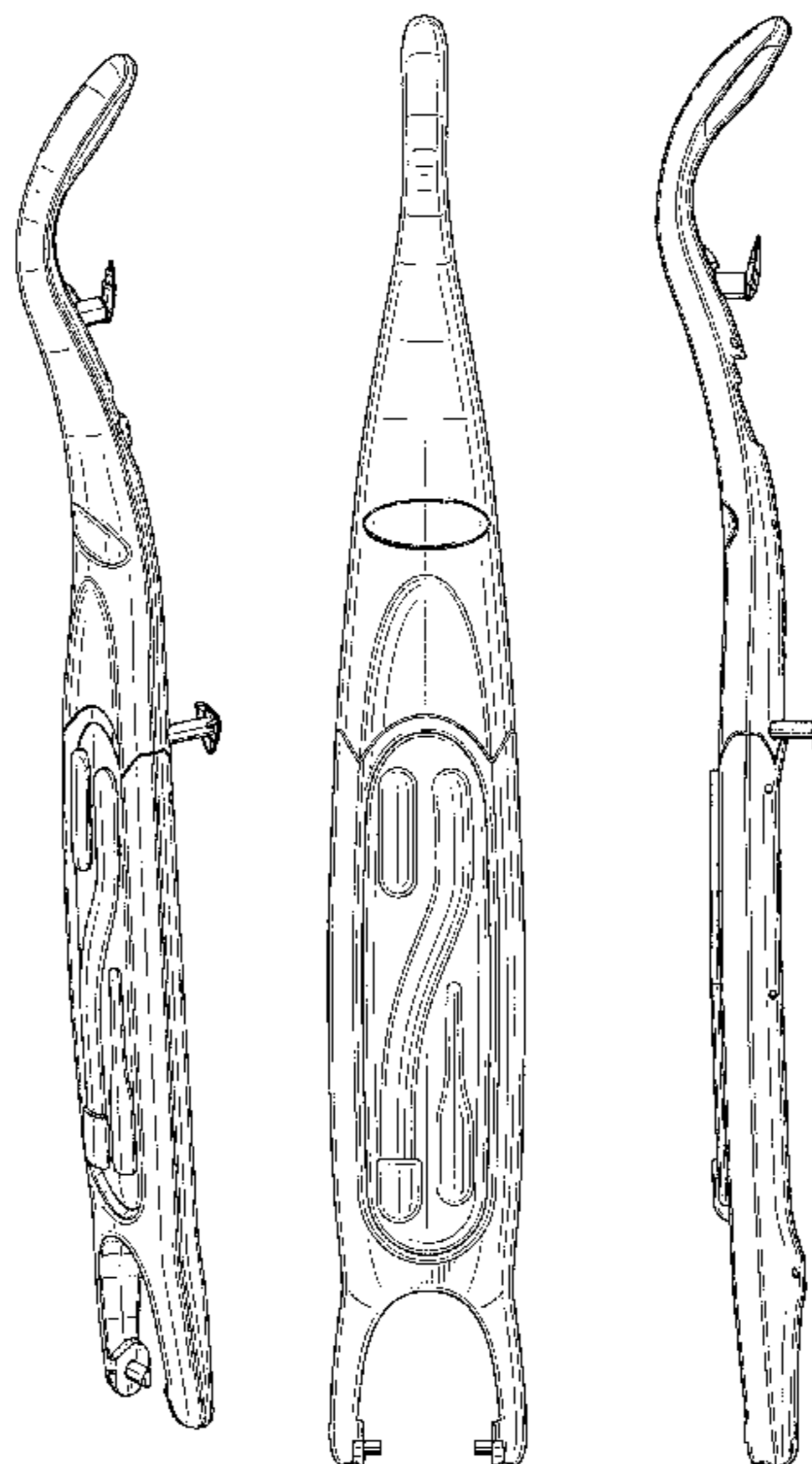
(57) **CLAIM**

We claim the ornamental design for a handle for a vacuum cleaner, as shown and described.

**DESCRIPTION**

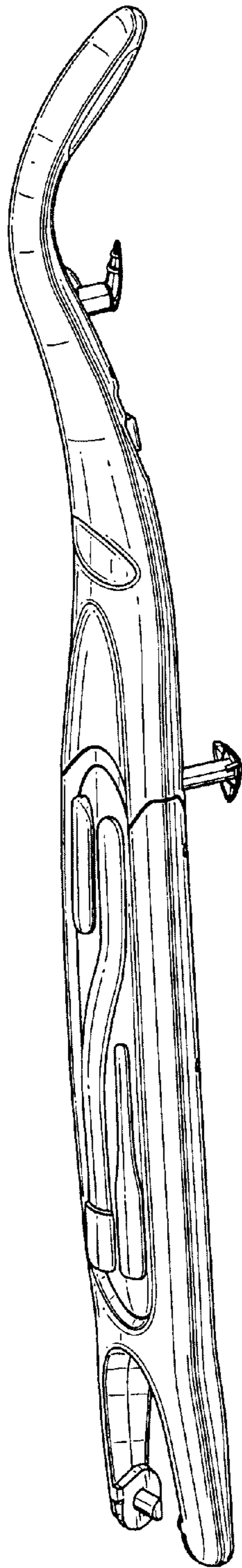

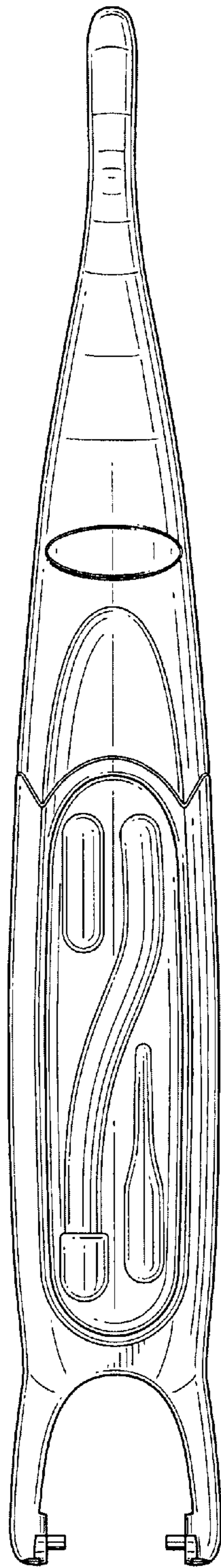

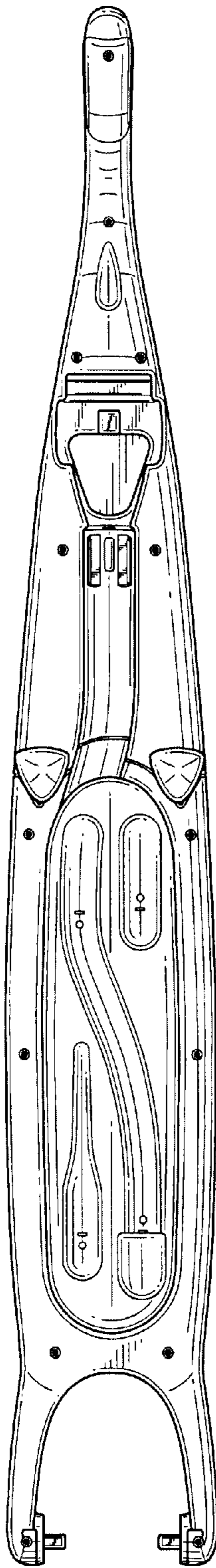

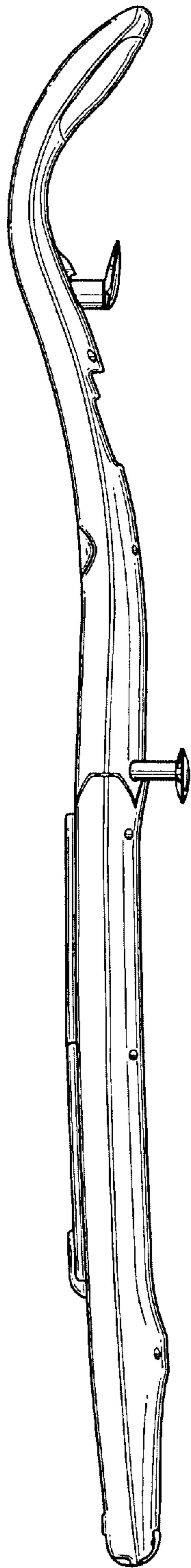

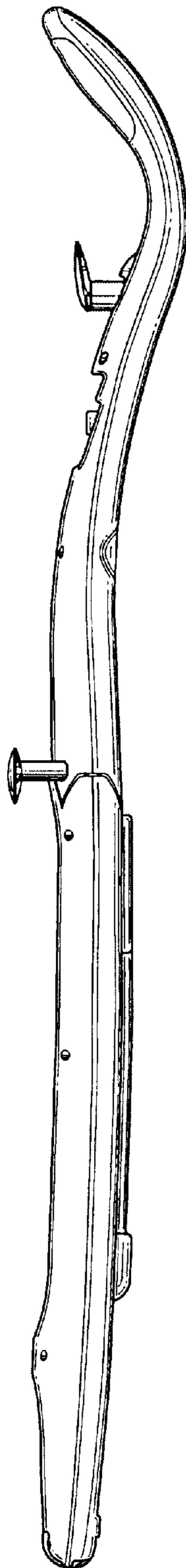

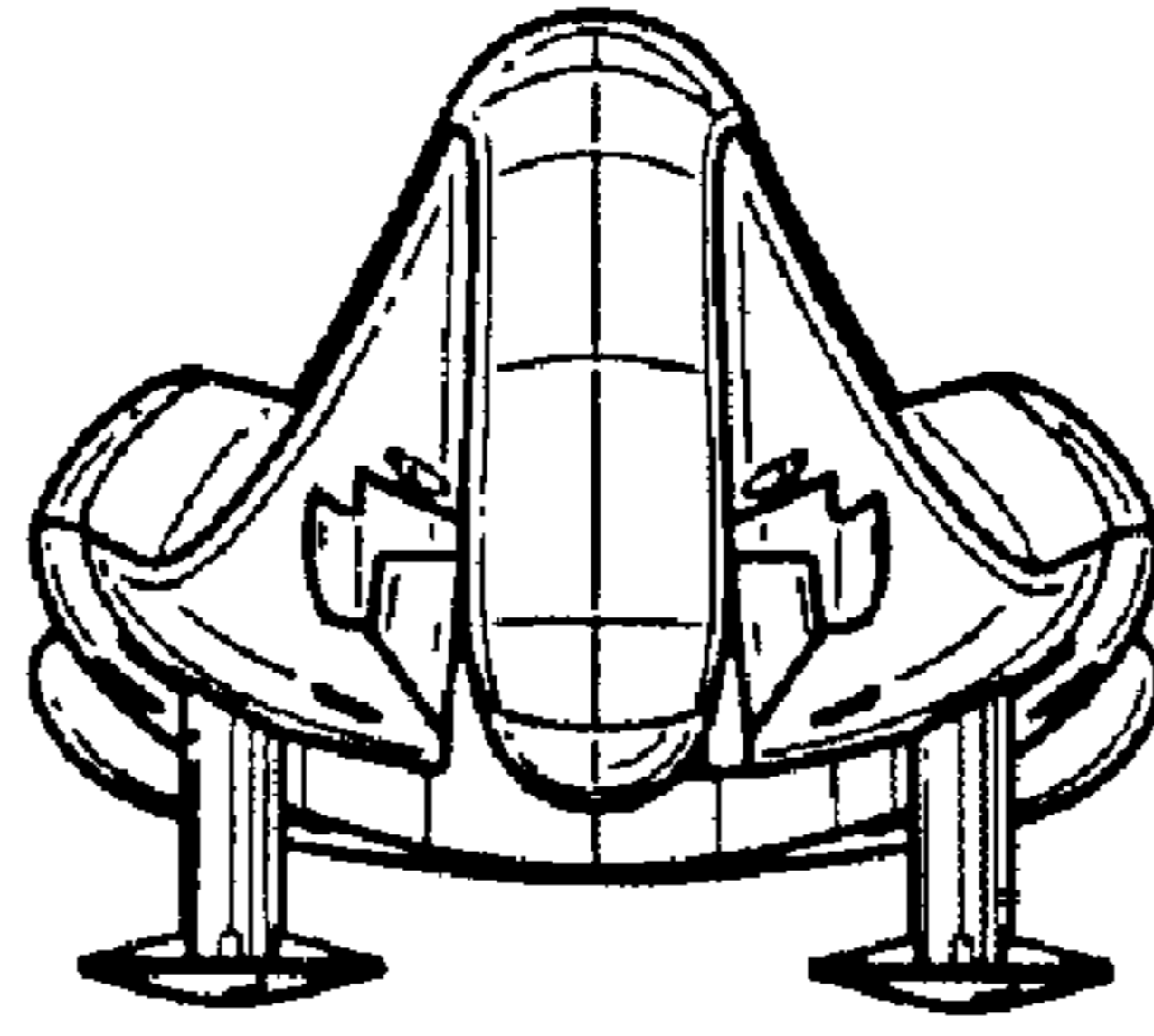

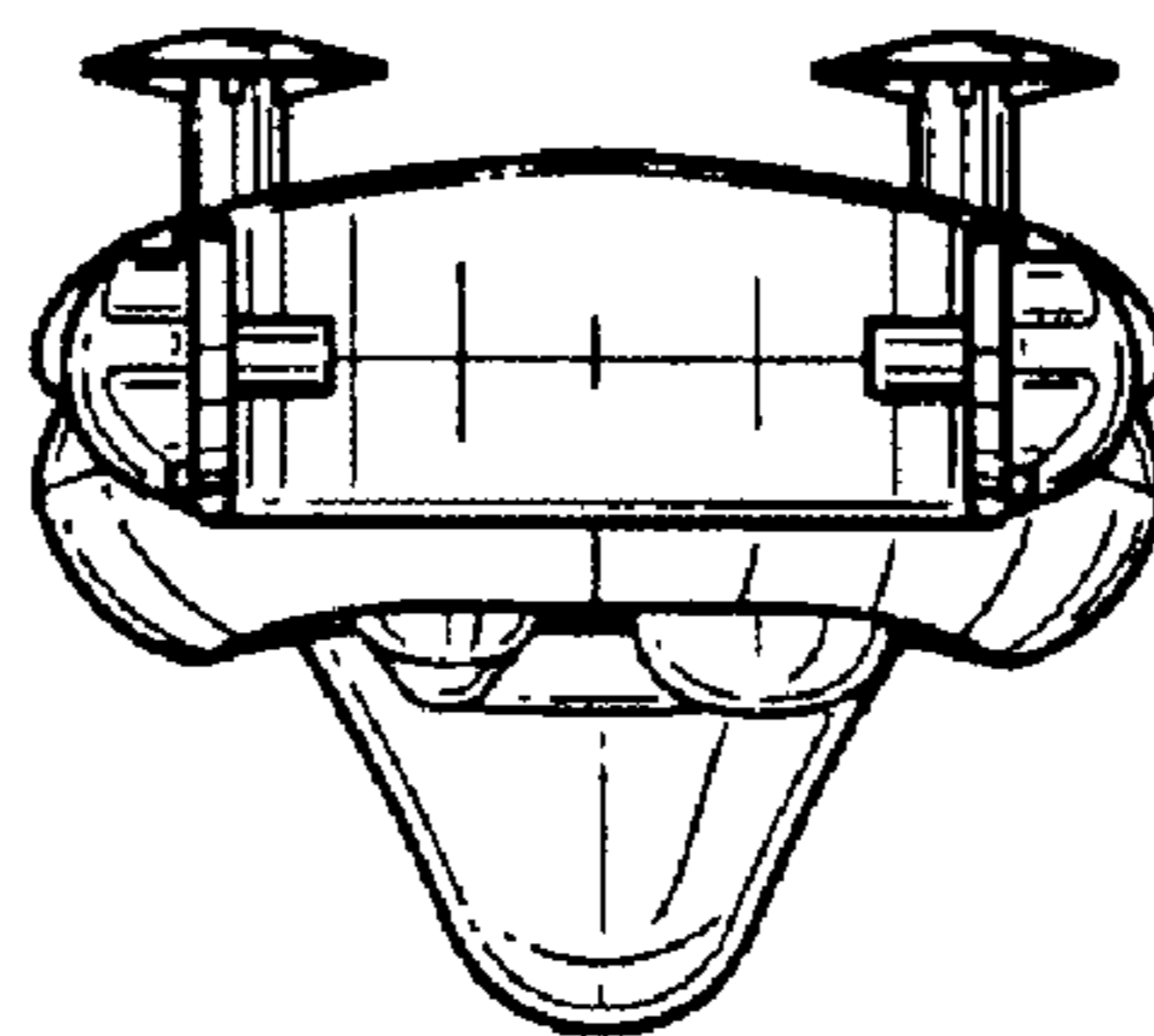
