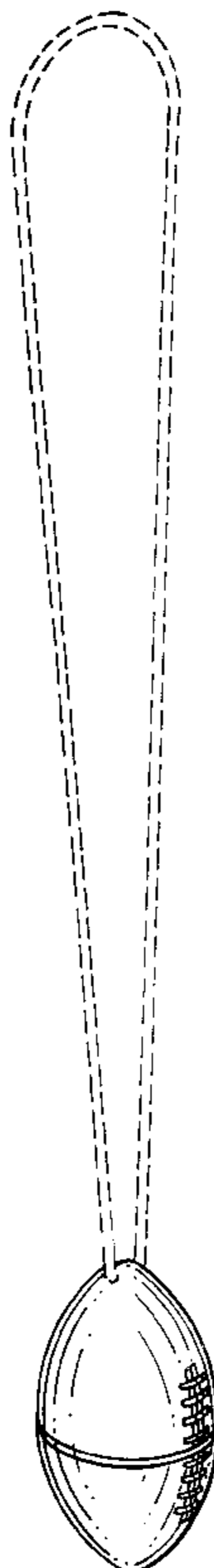
The ornamental design for a waterproof floatable container,  
as shown and described.

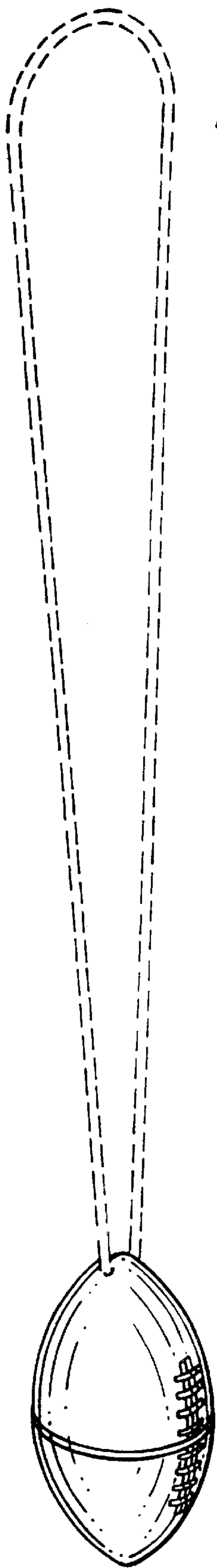
**DESCRIPTION**

 thereof.

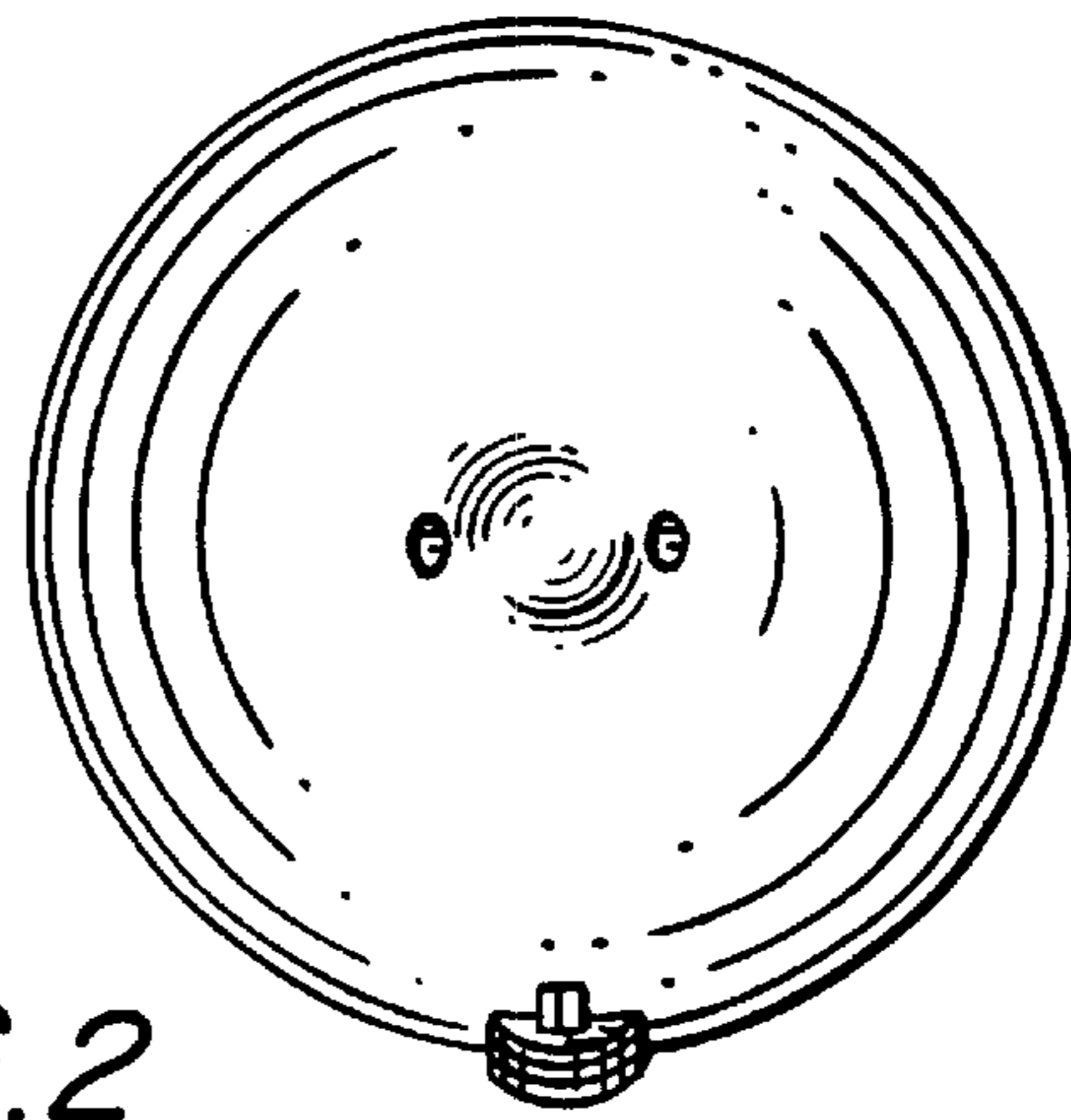
The broken line showing of a neck strap in FIGS. 1 and 7 is

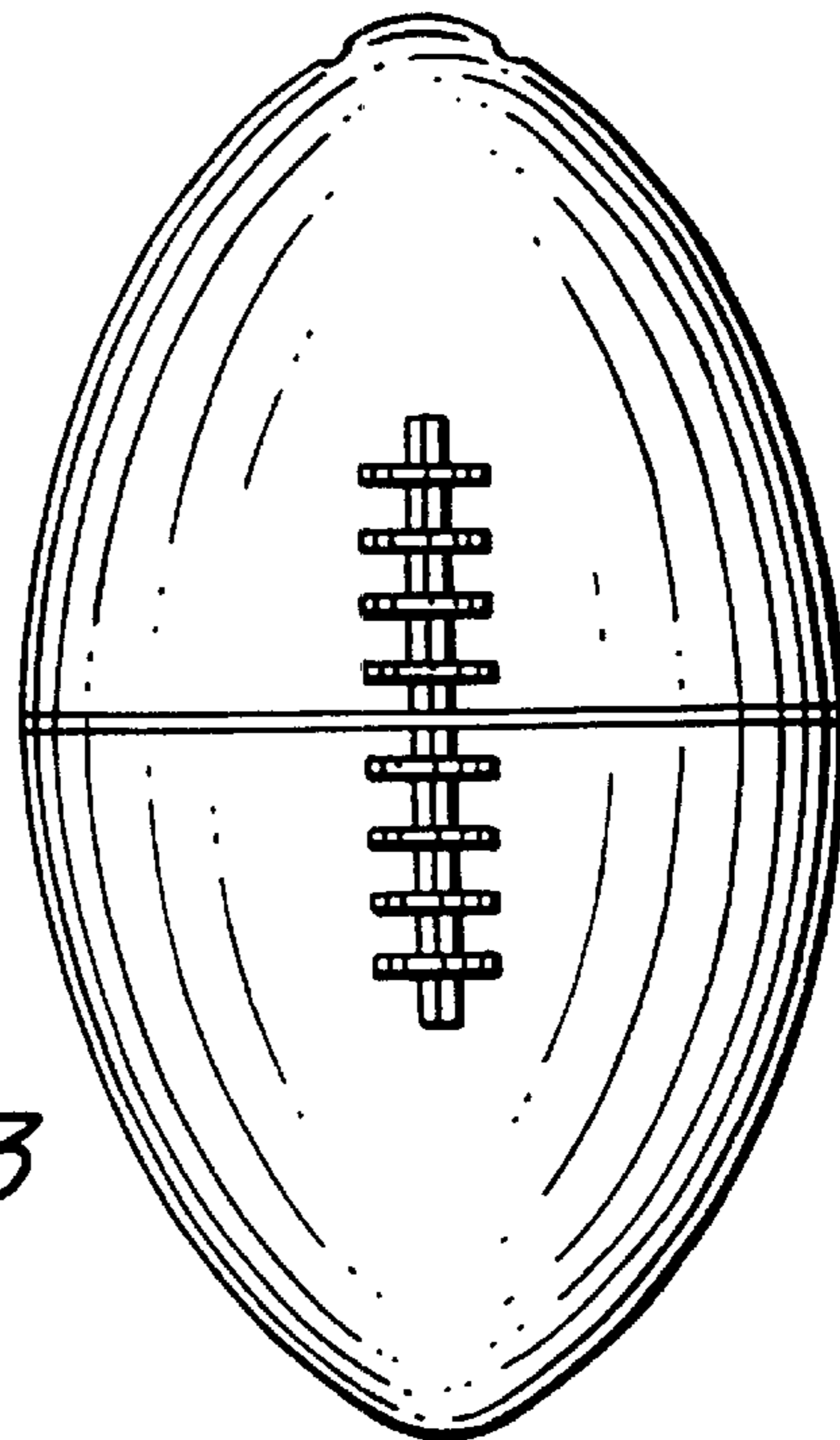

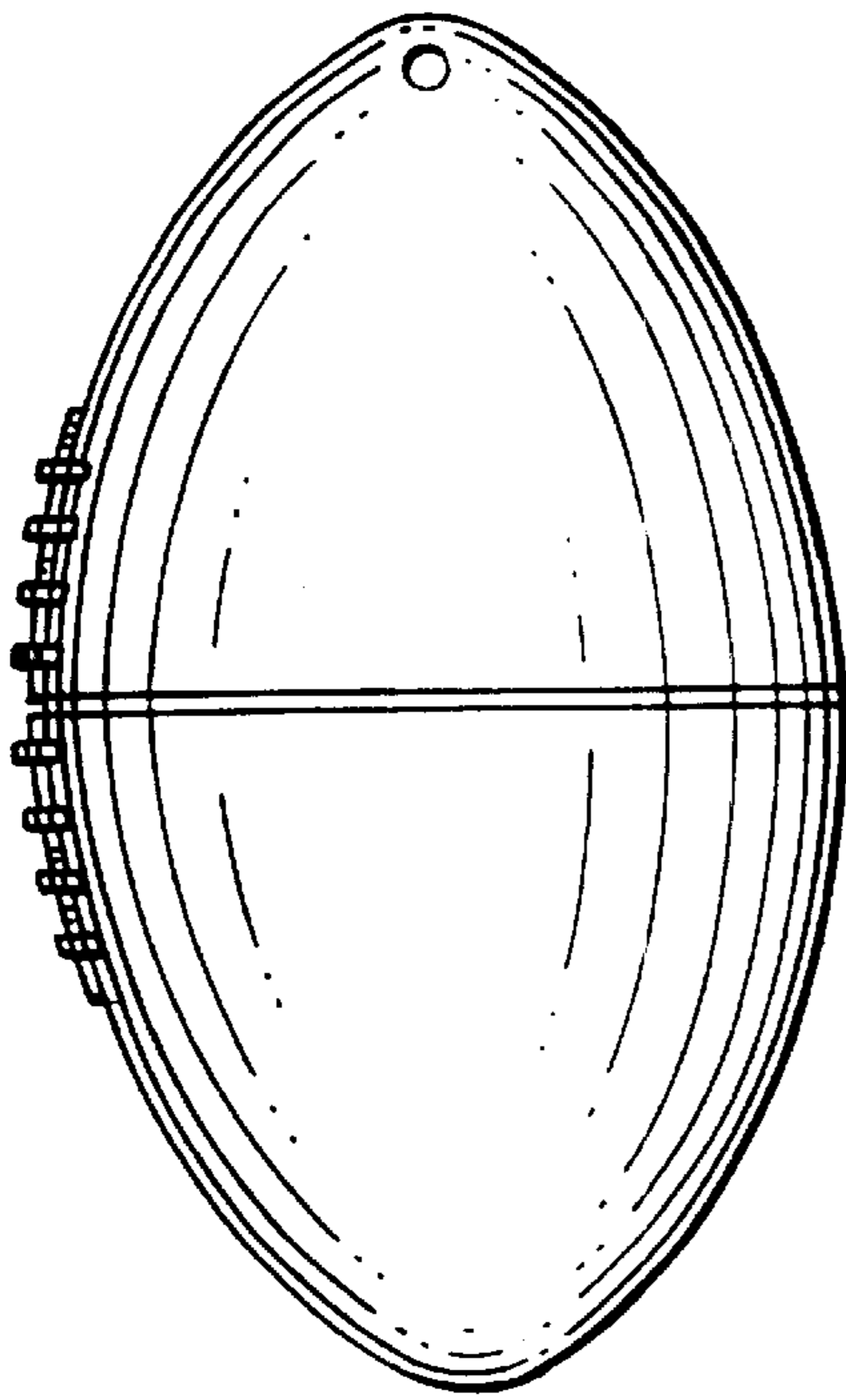

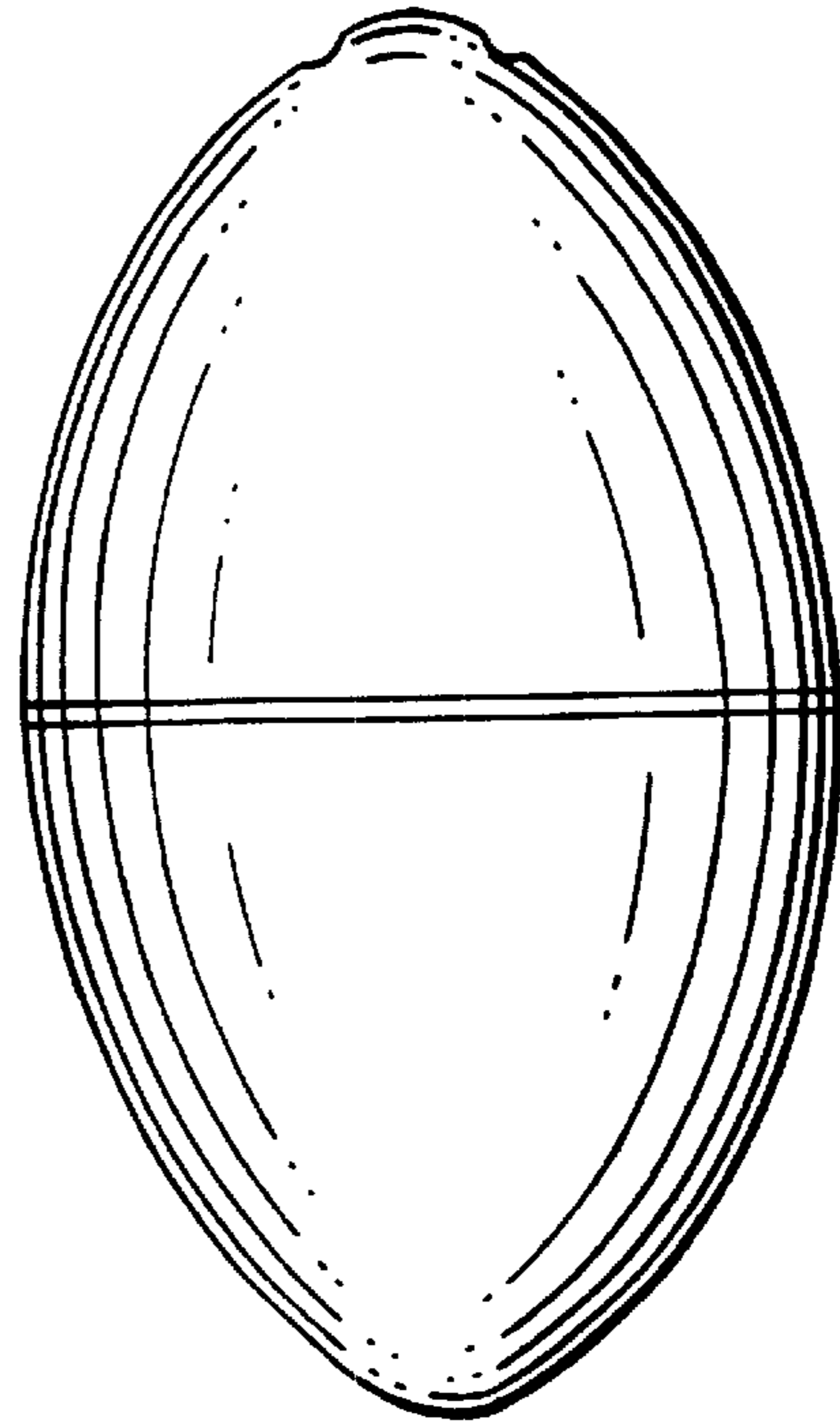

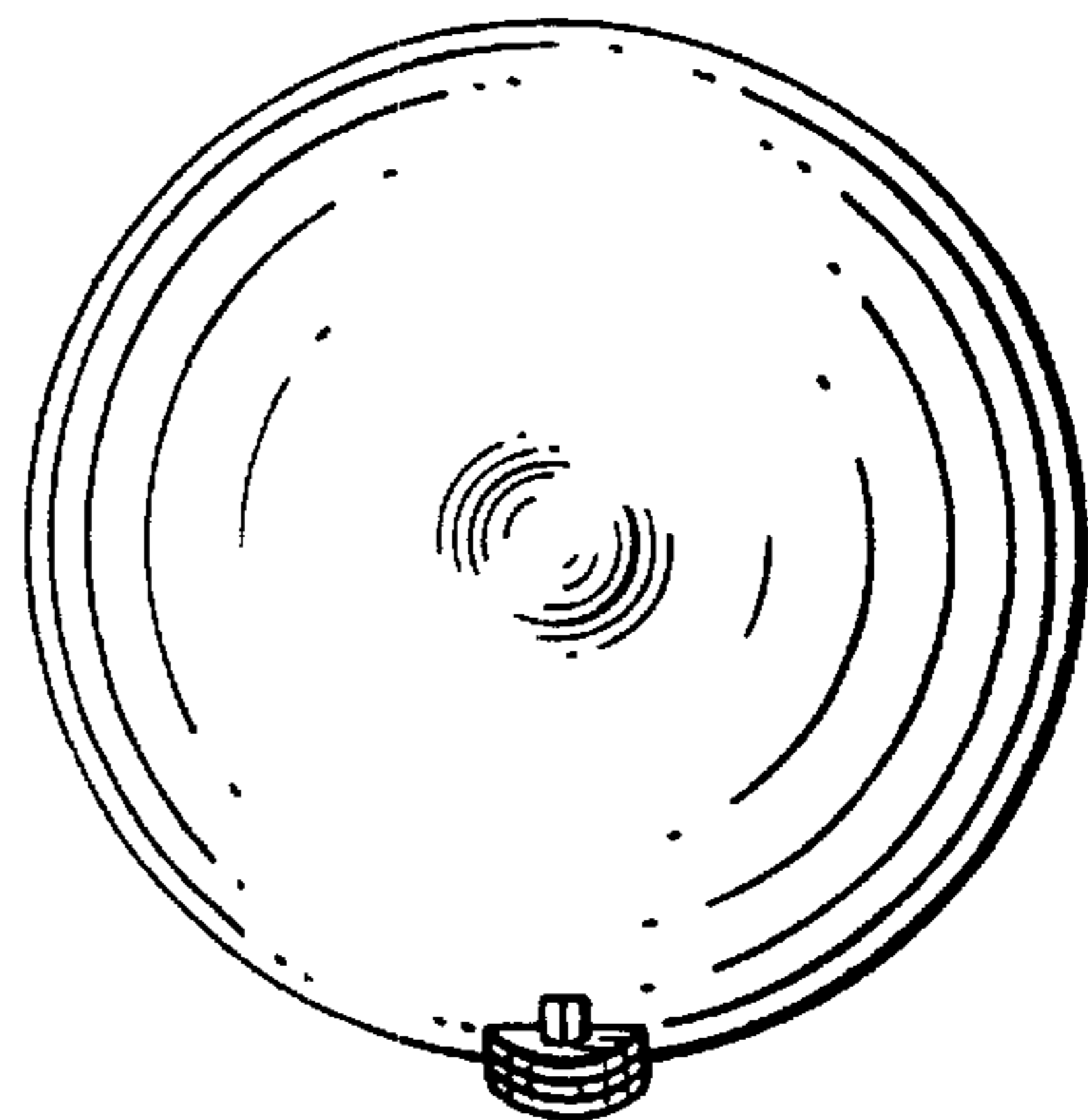

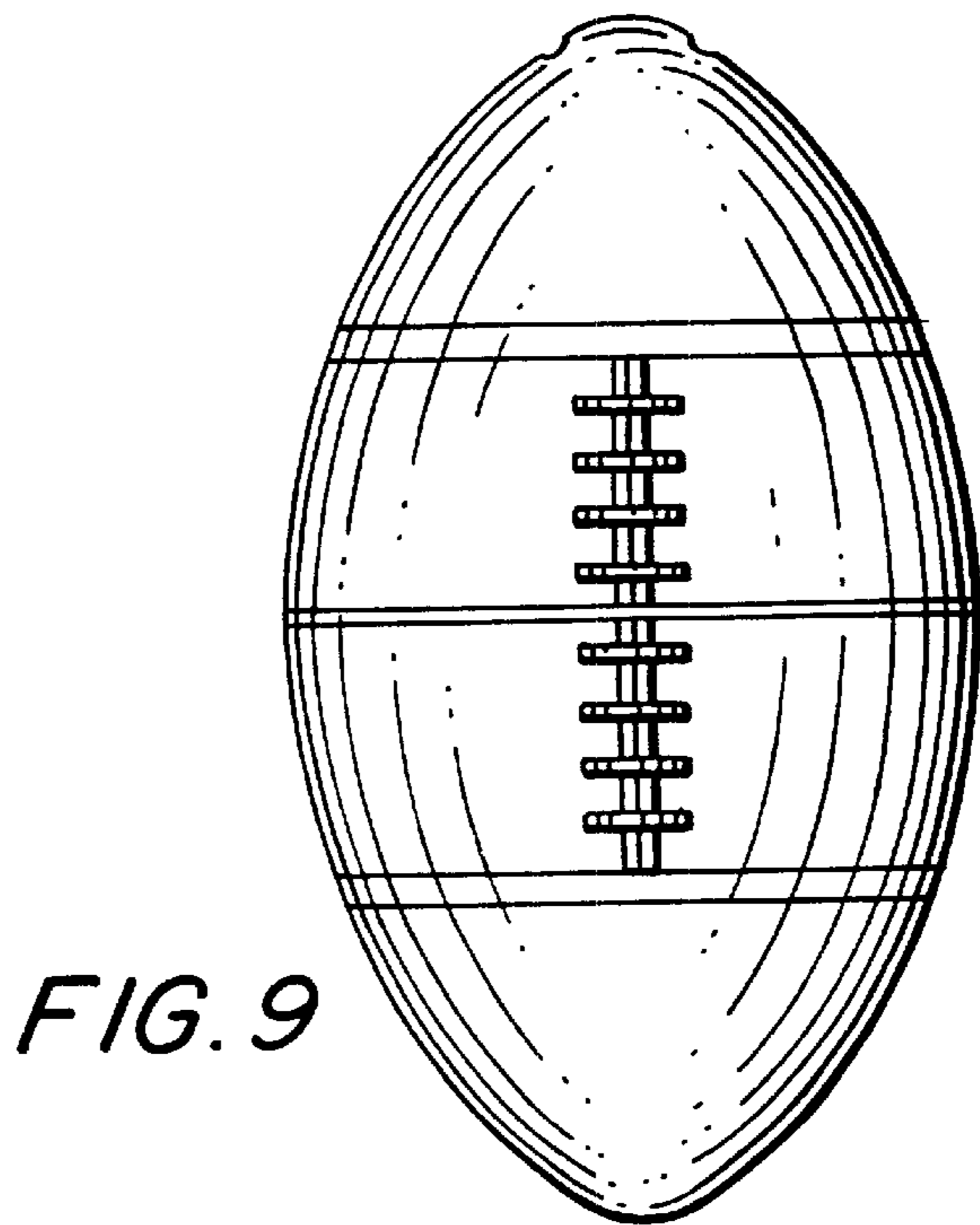
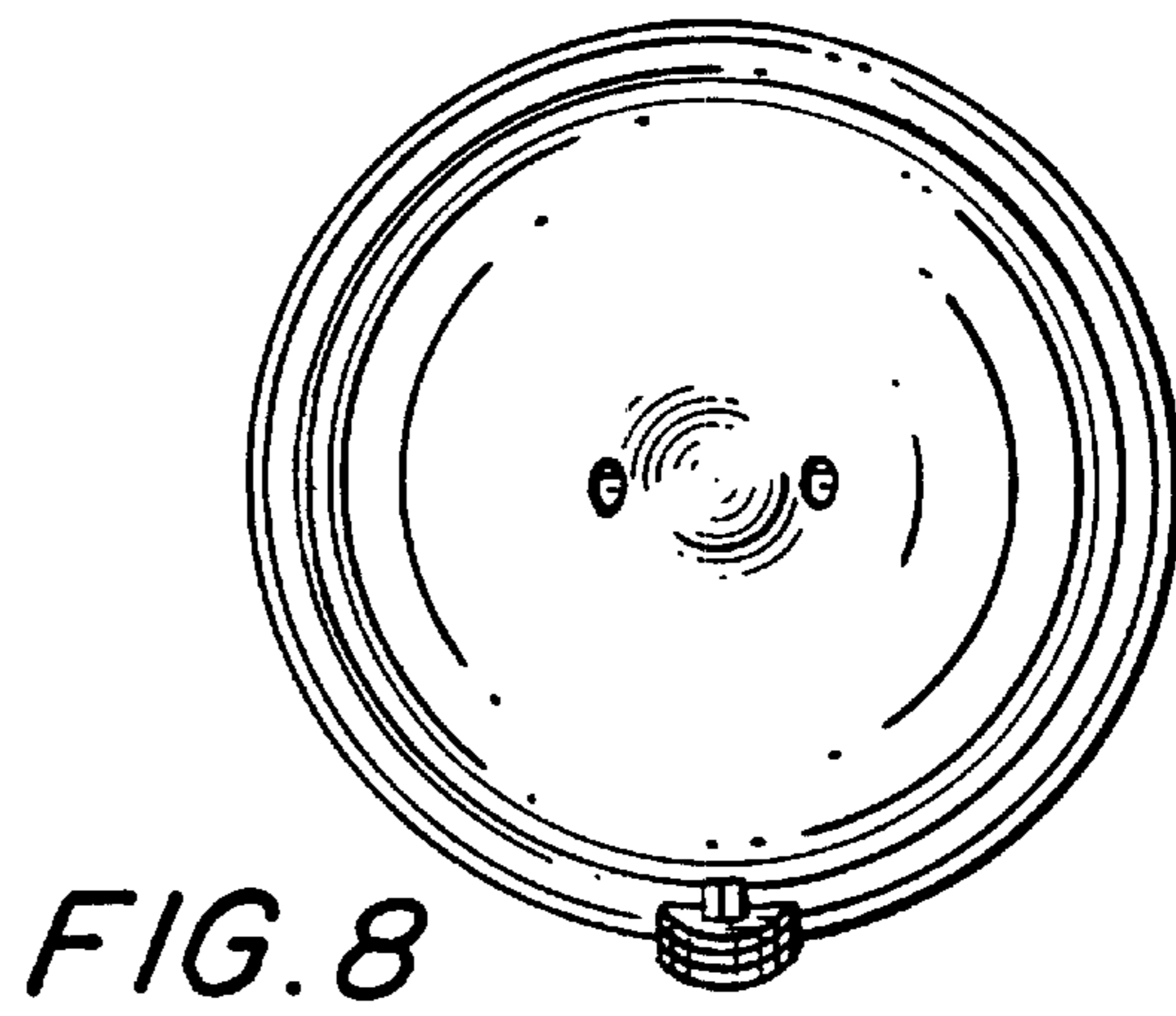
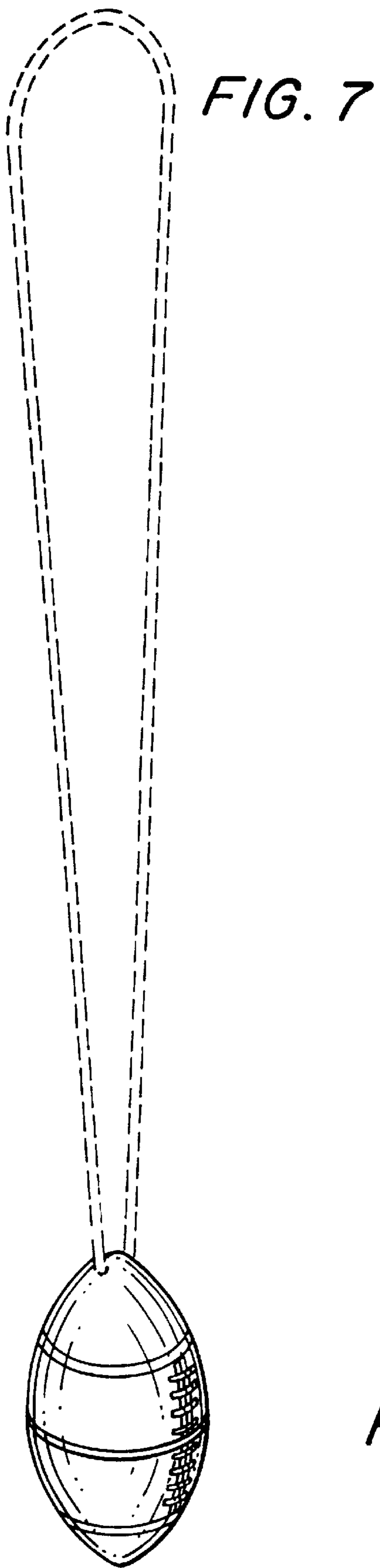

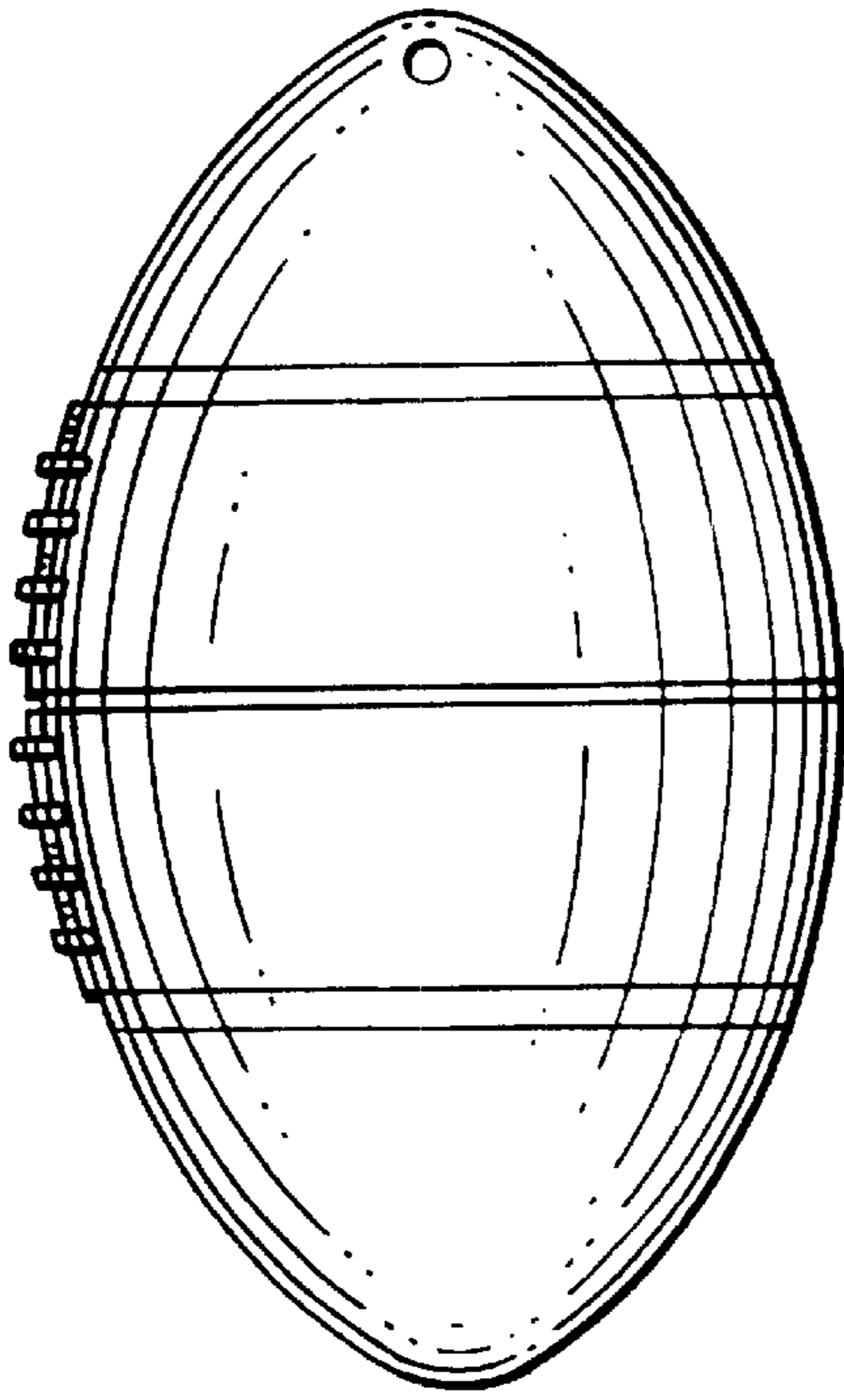

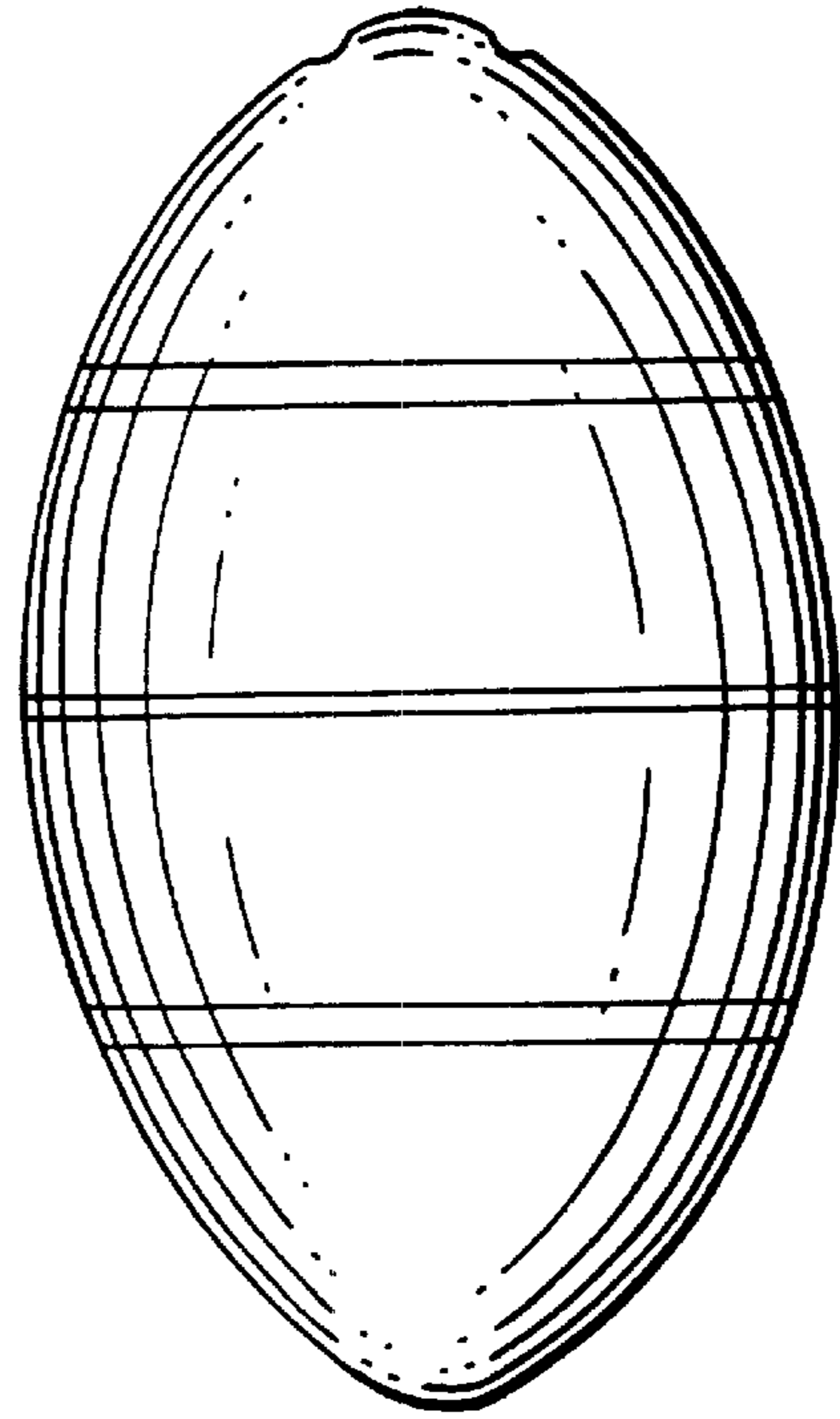
