The ornamental design for eating utensil with toothpick incorporated therein, as shown and described.

DESCRIPTION

FIG. 17 is a rear elevational view thereof;

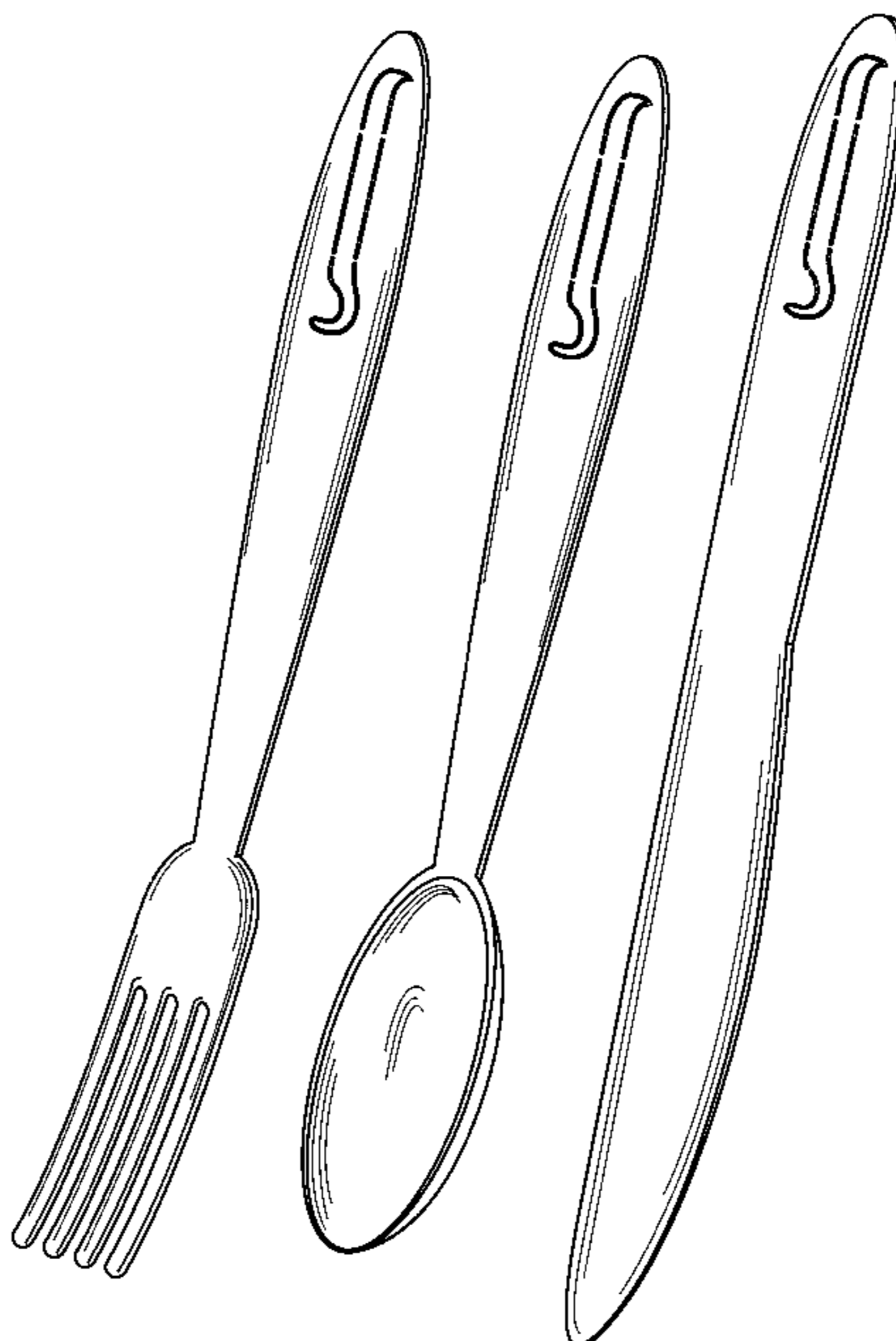
FIG. 18 is a left side elevational view thereof;

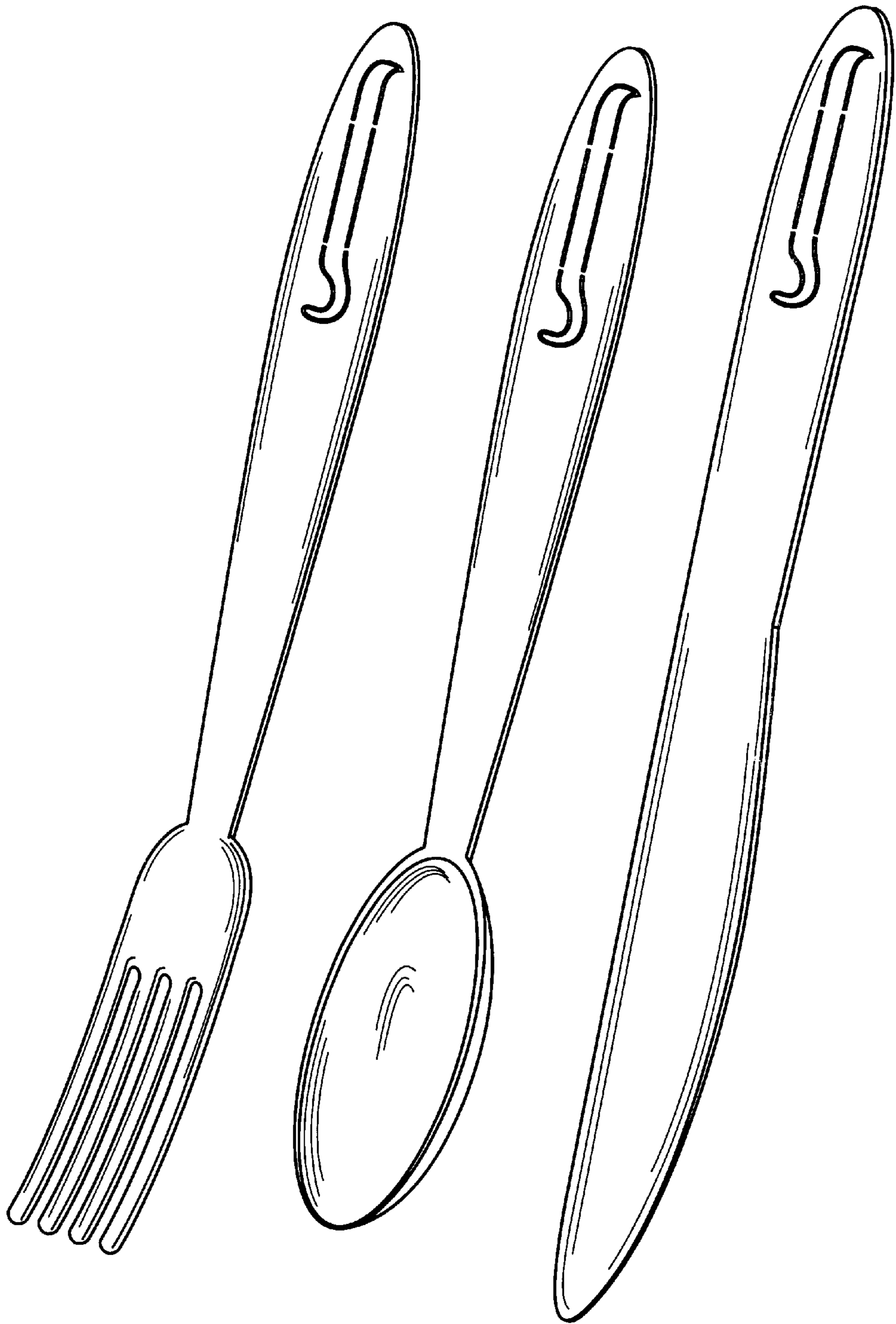

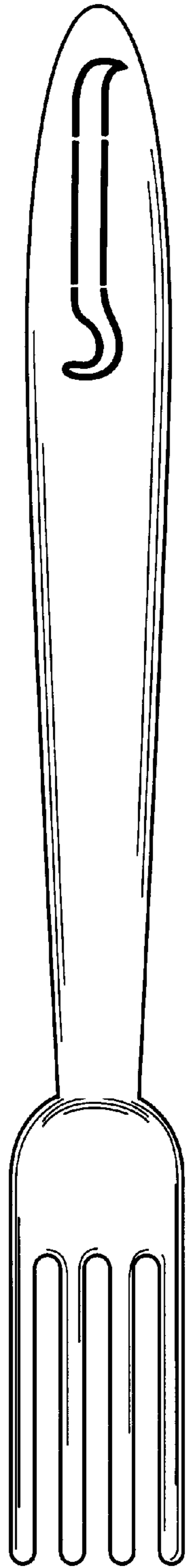

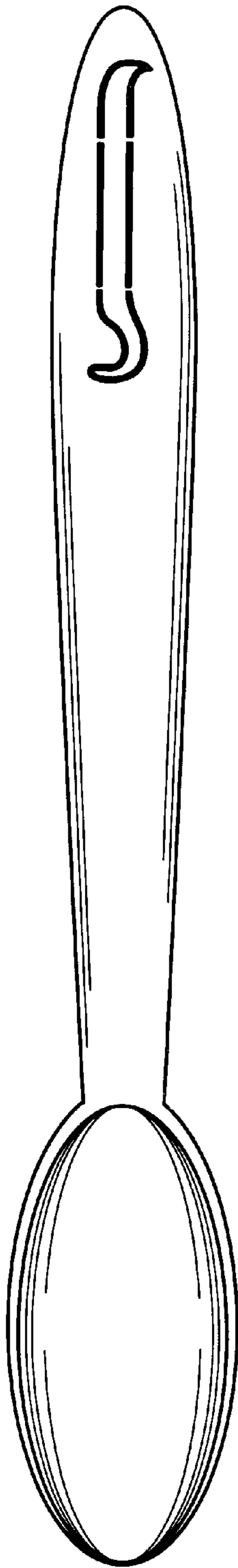

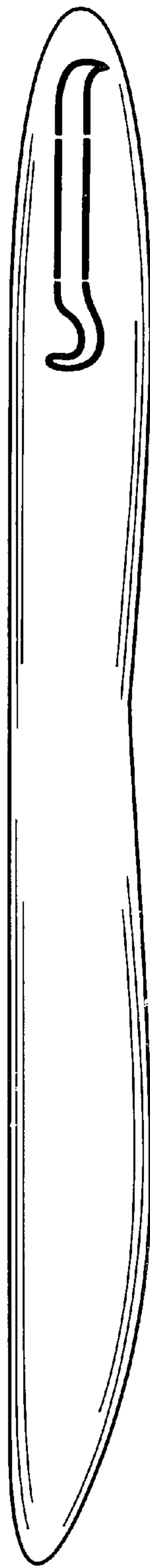

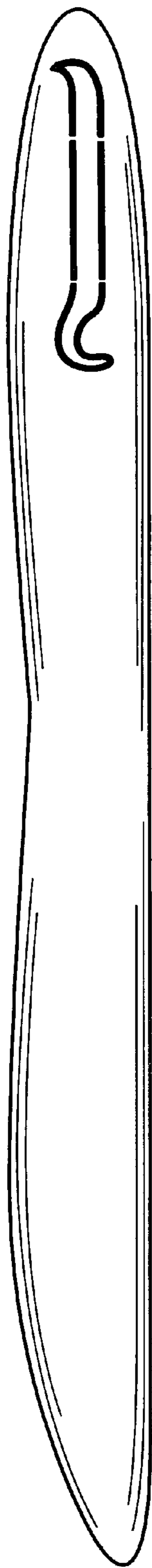

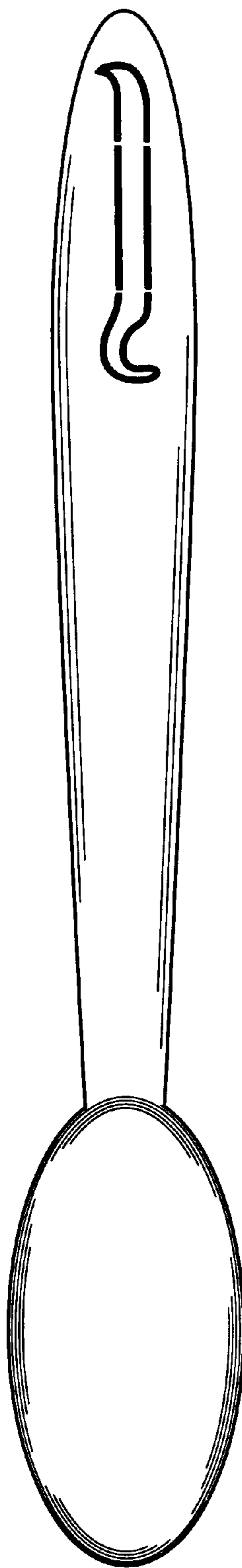

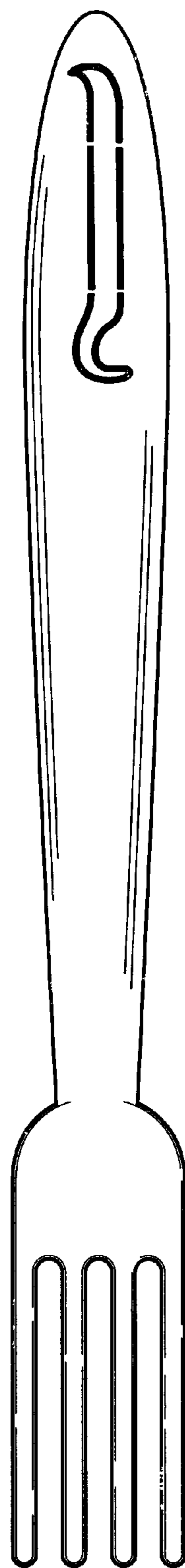

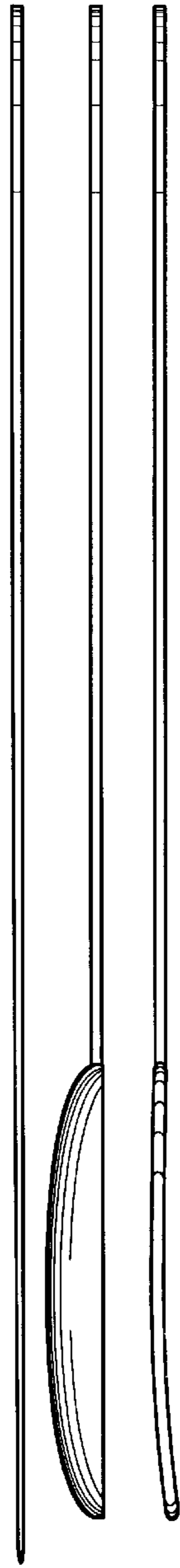

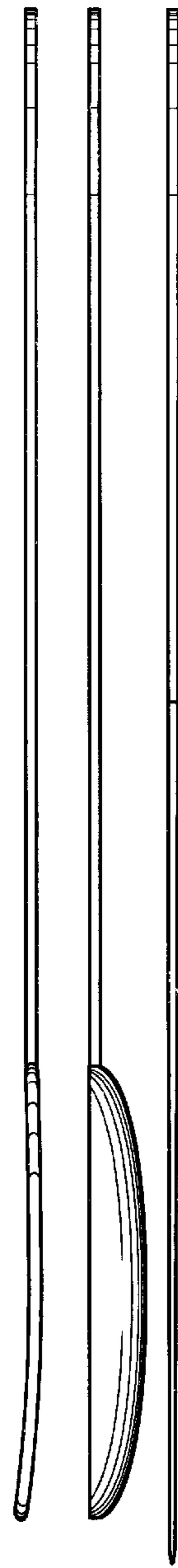

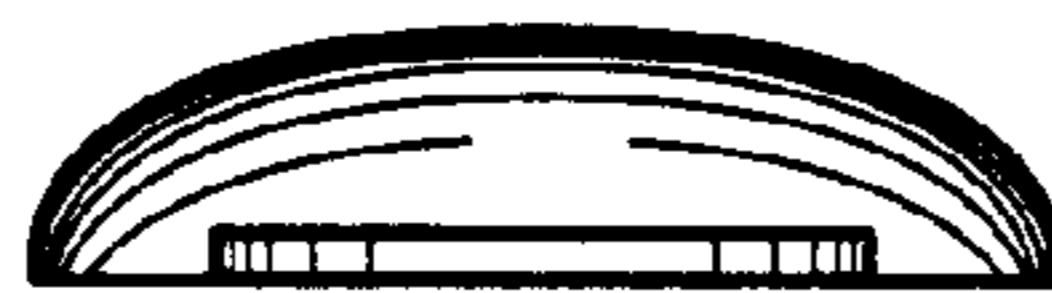

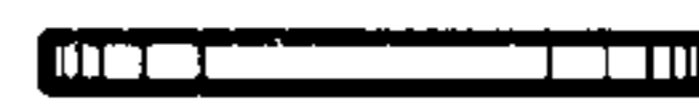
