(57) **CLAIM**

The ornamental design for a pneumatic fastener driving tool body, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of a pneumatic fastener driving tool body showing our new design;

FIG. 2 is an end elevation view thereof from the left of FIG. 1;

FIG. 3 is an end elevation view thereof from the right of FIG. 1;

FIG. 4 is a top plan view thereof;

FIG. 5 is a side elevation view thereof from the right of FIG. 2;

FIG. 6 is a side elevation view thereof from the left of FIG. 2; and,

FIG. 7 is a bottom plan view thereof.

The driving mechanism, magazine and brace shown in dashed lines form no part of the design.

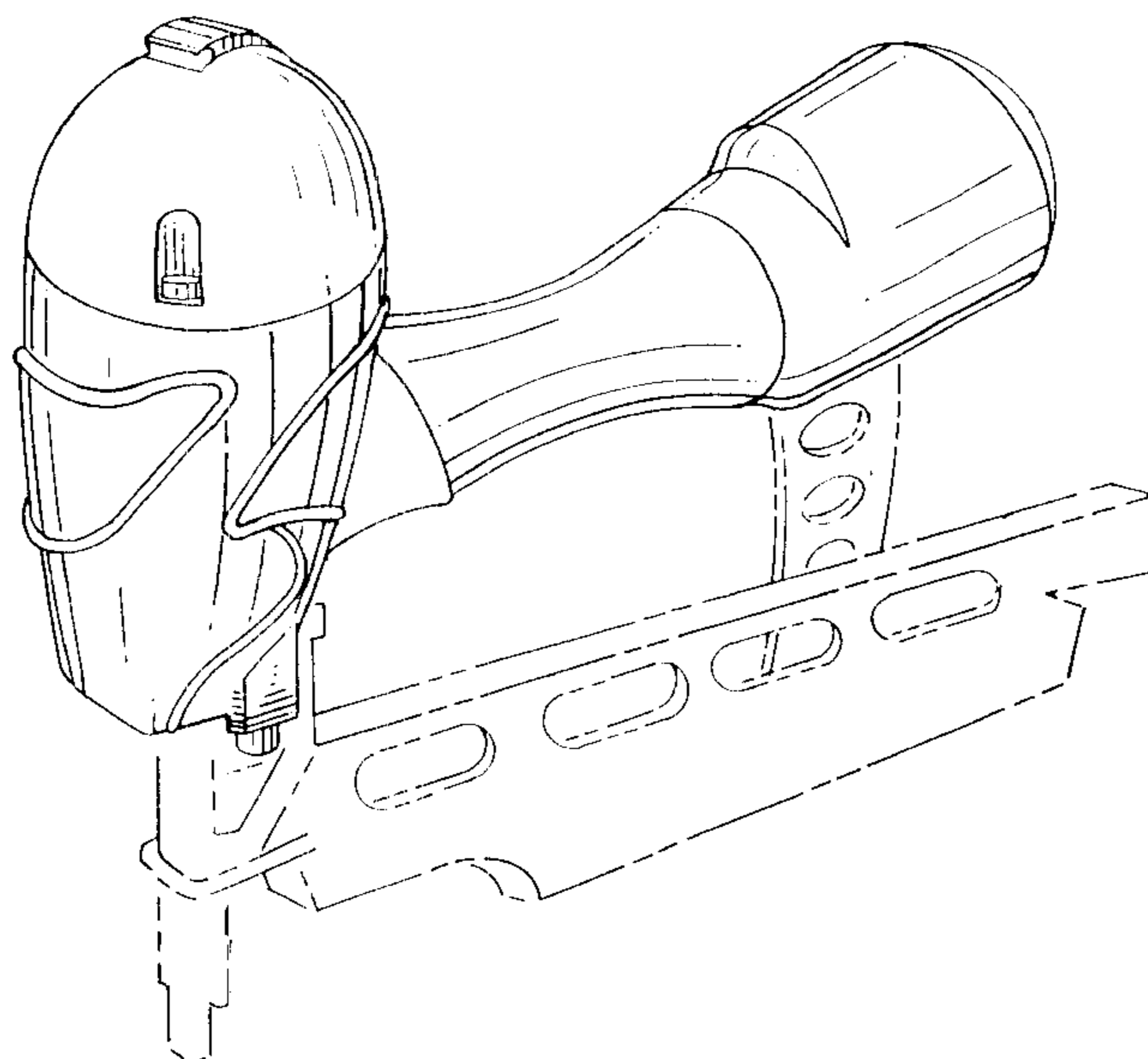

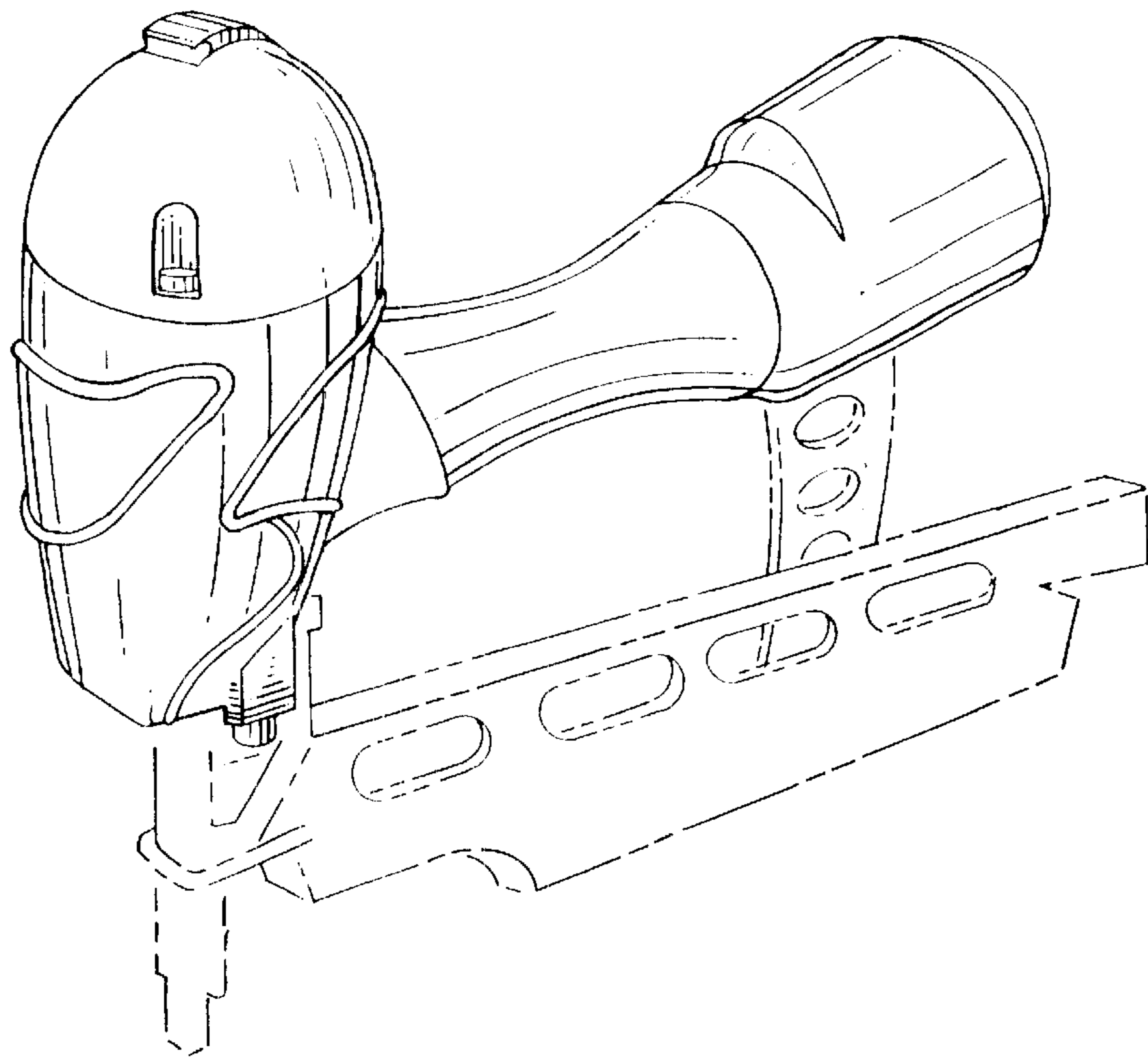

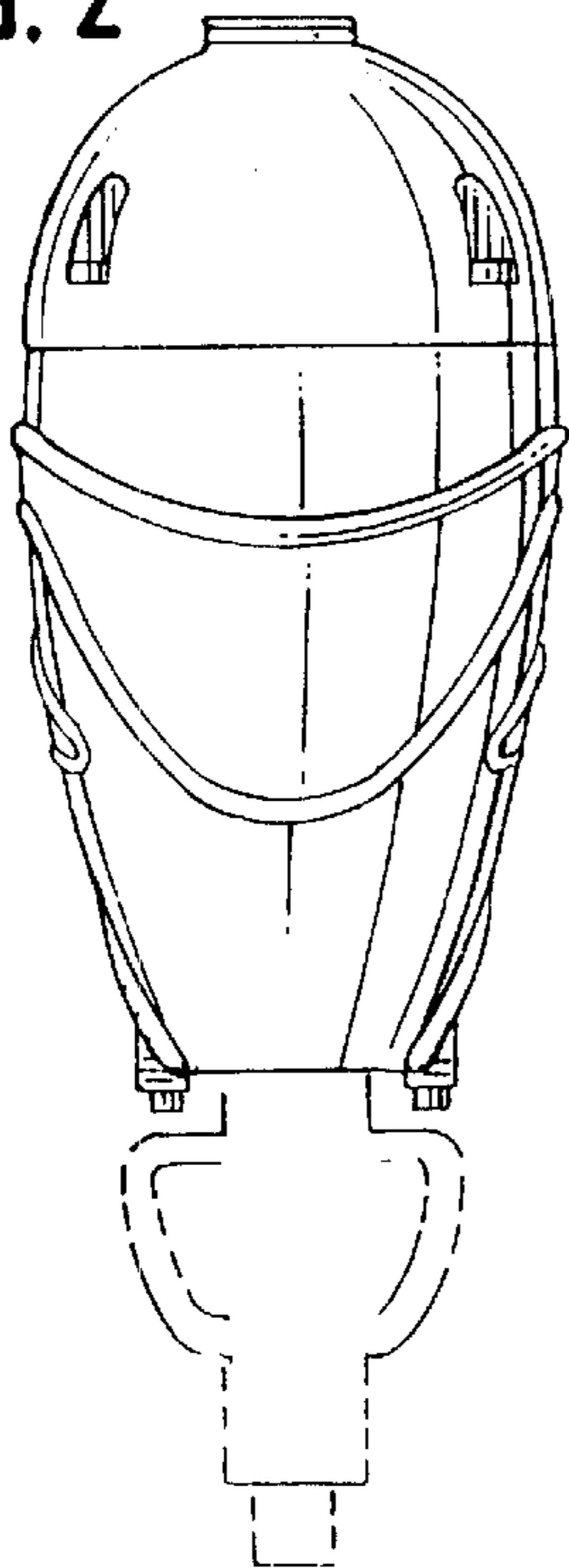

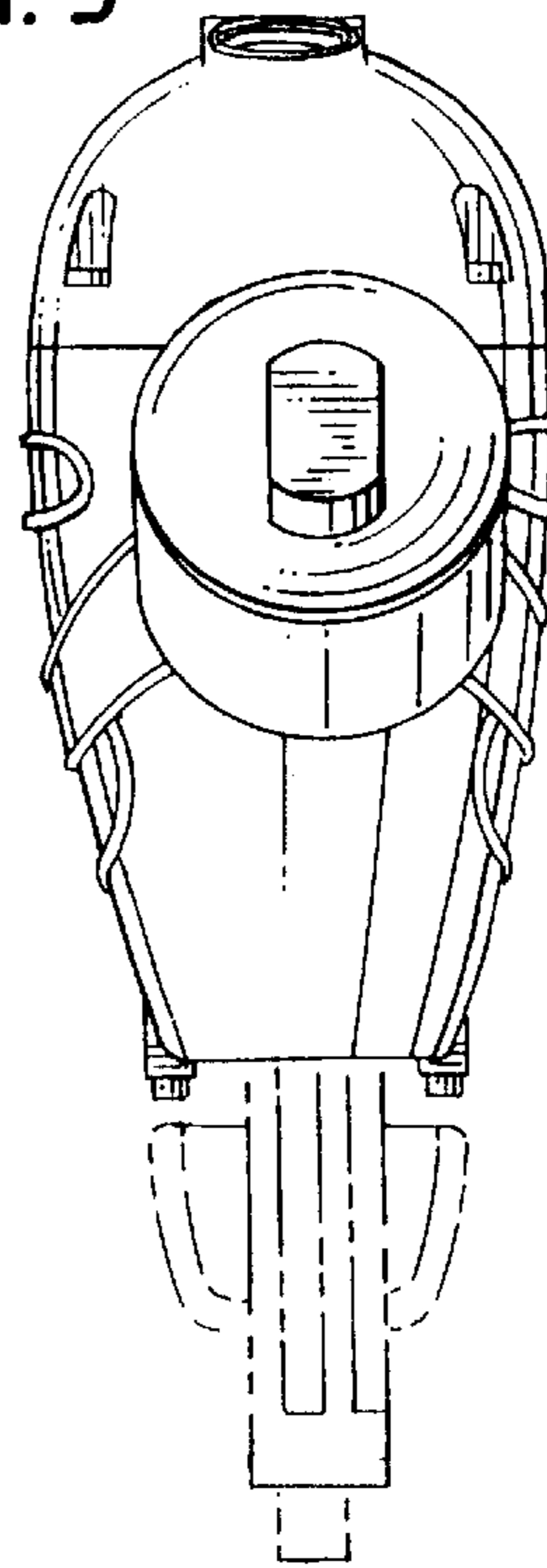

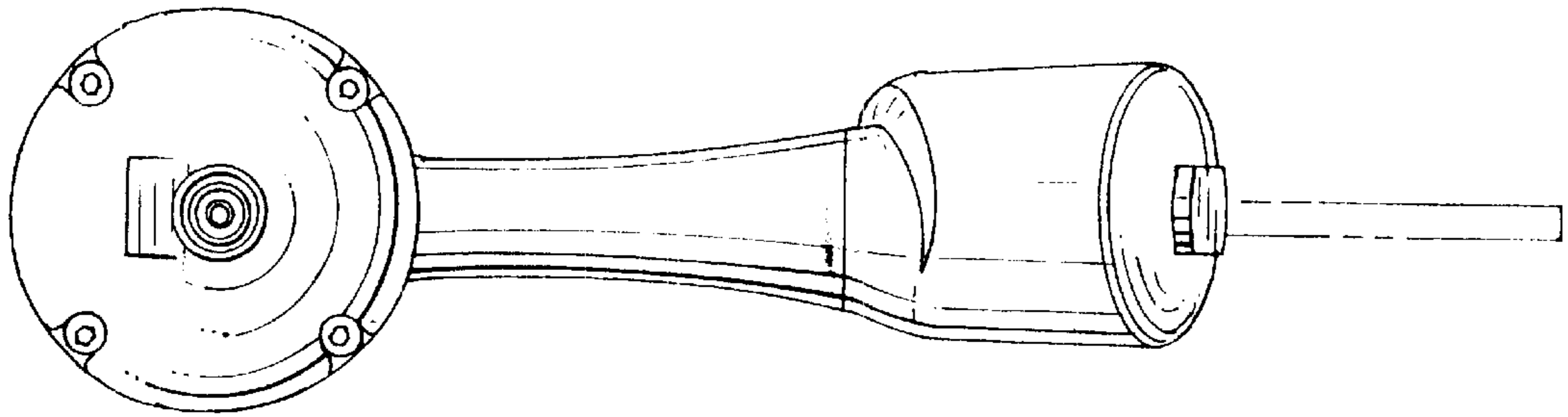

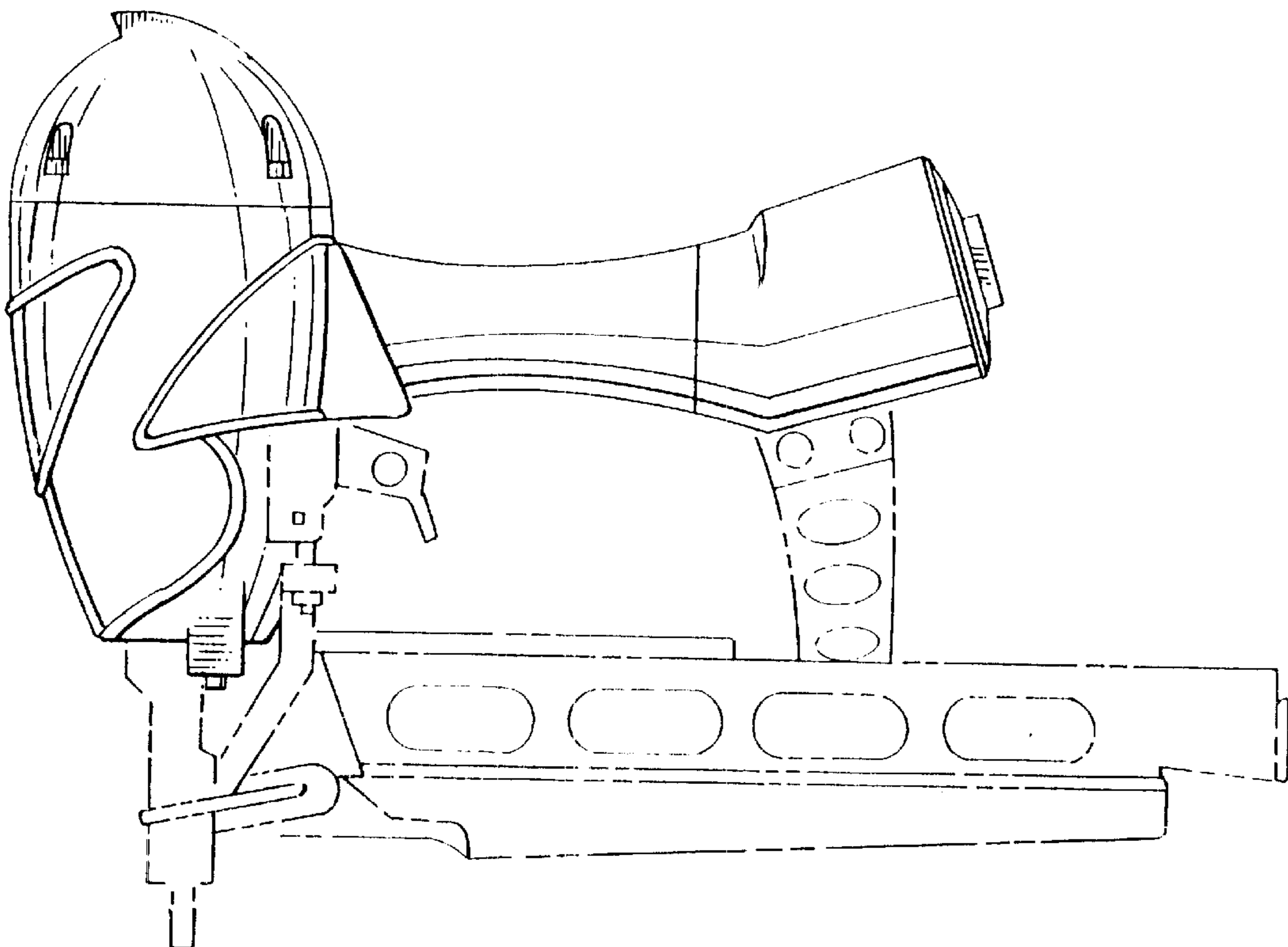

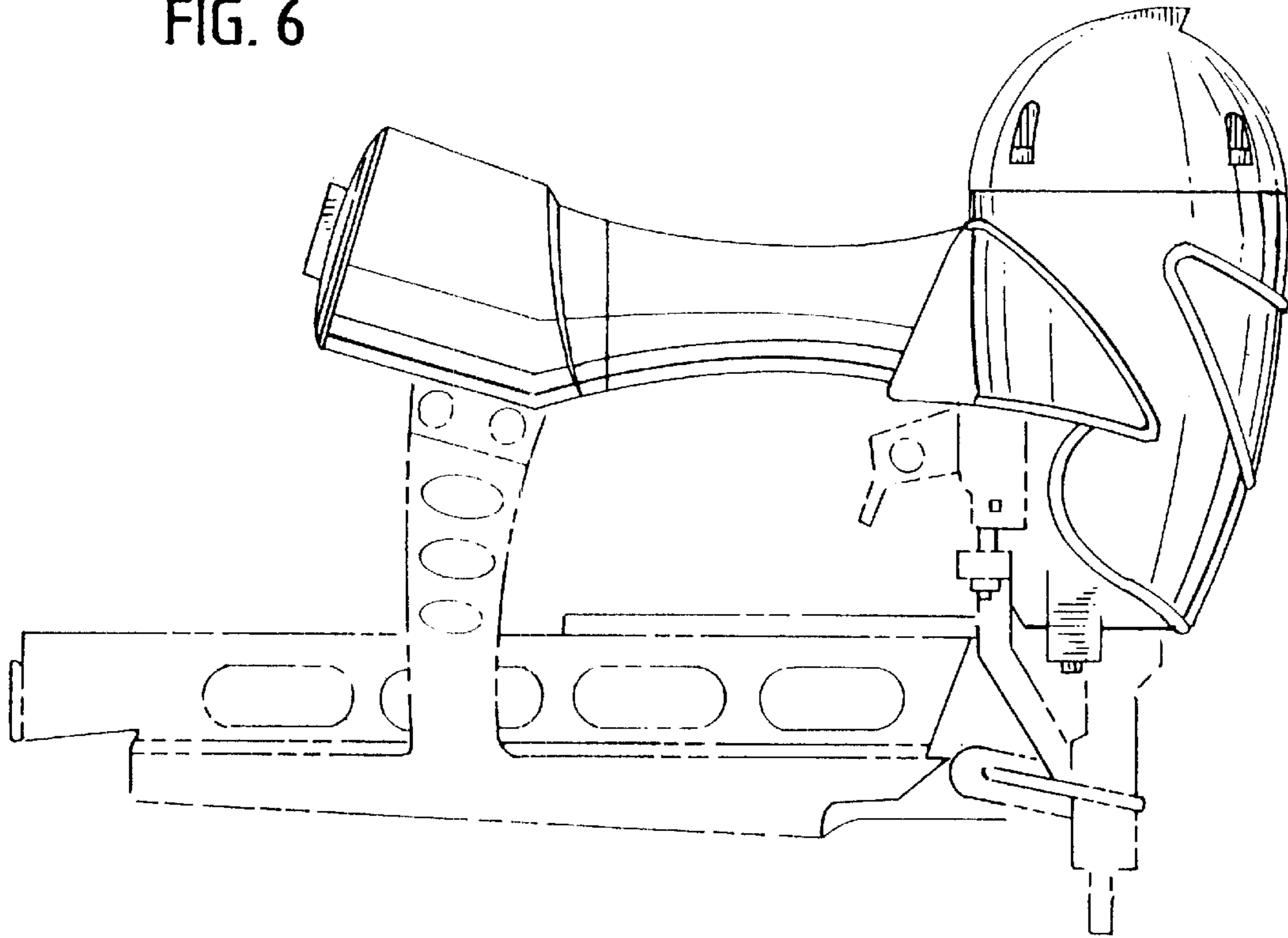
