FIG. 13 is a top plan view of FIG. 12; and,

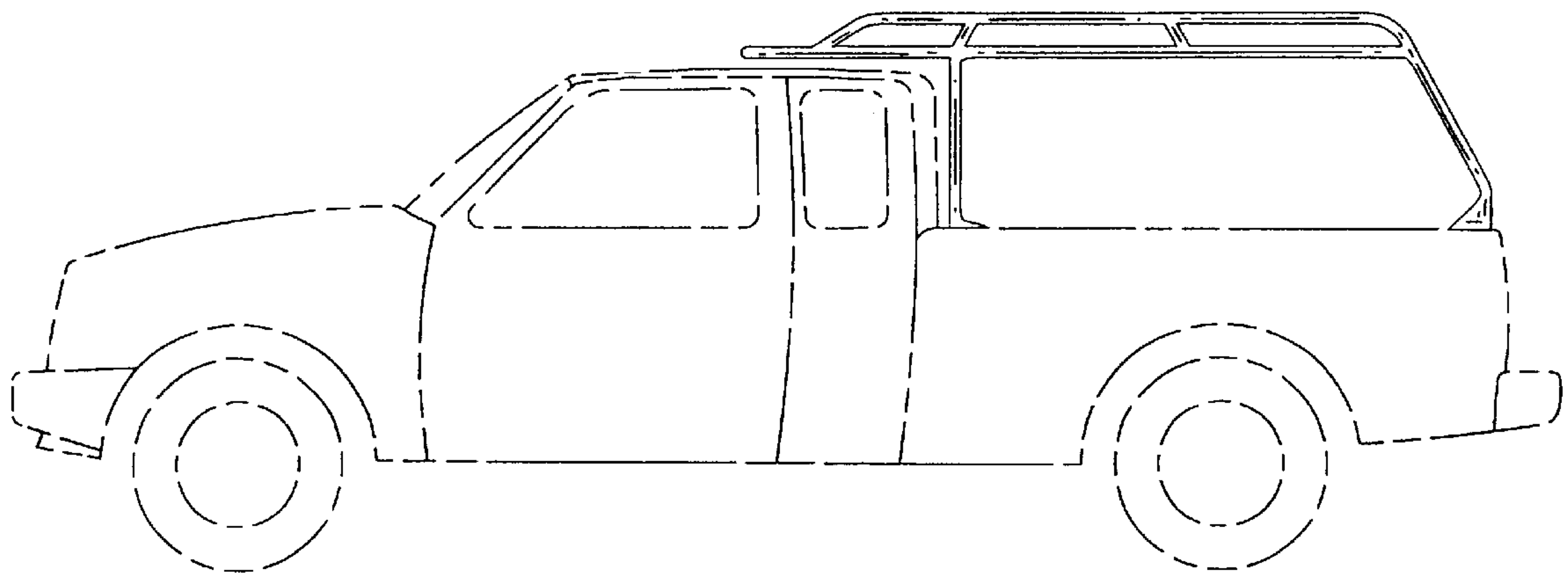
FIG. 14 is a rear view in elevation of the design of FIG. 12.

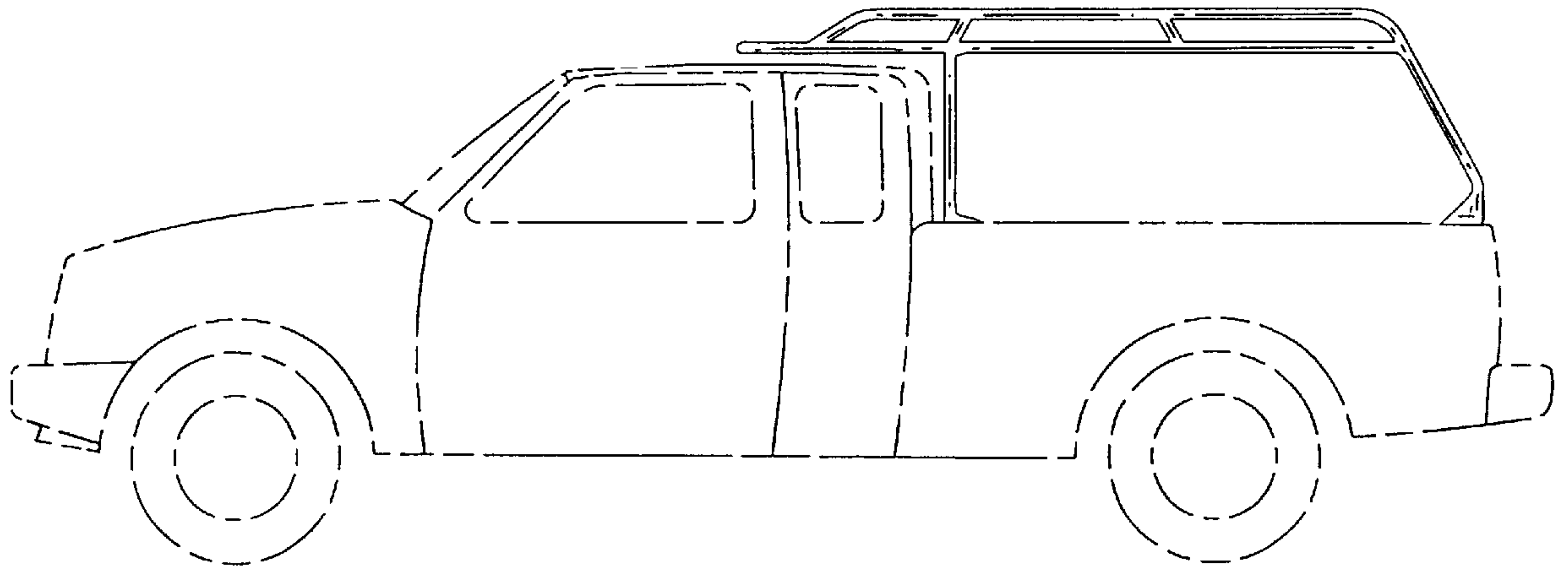

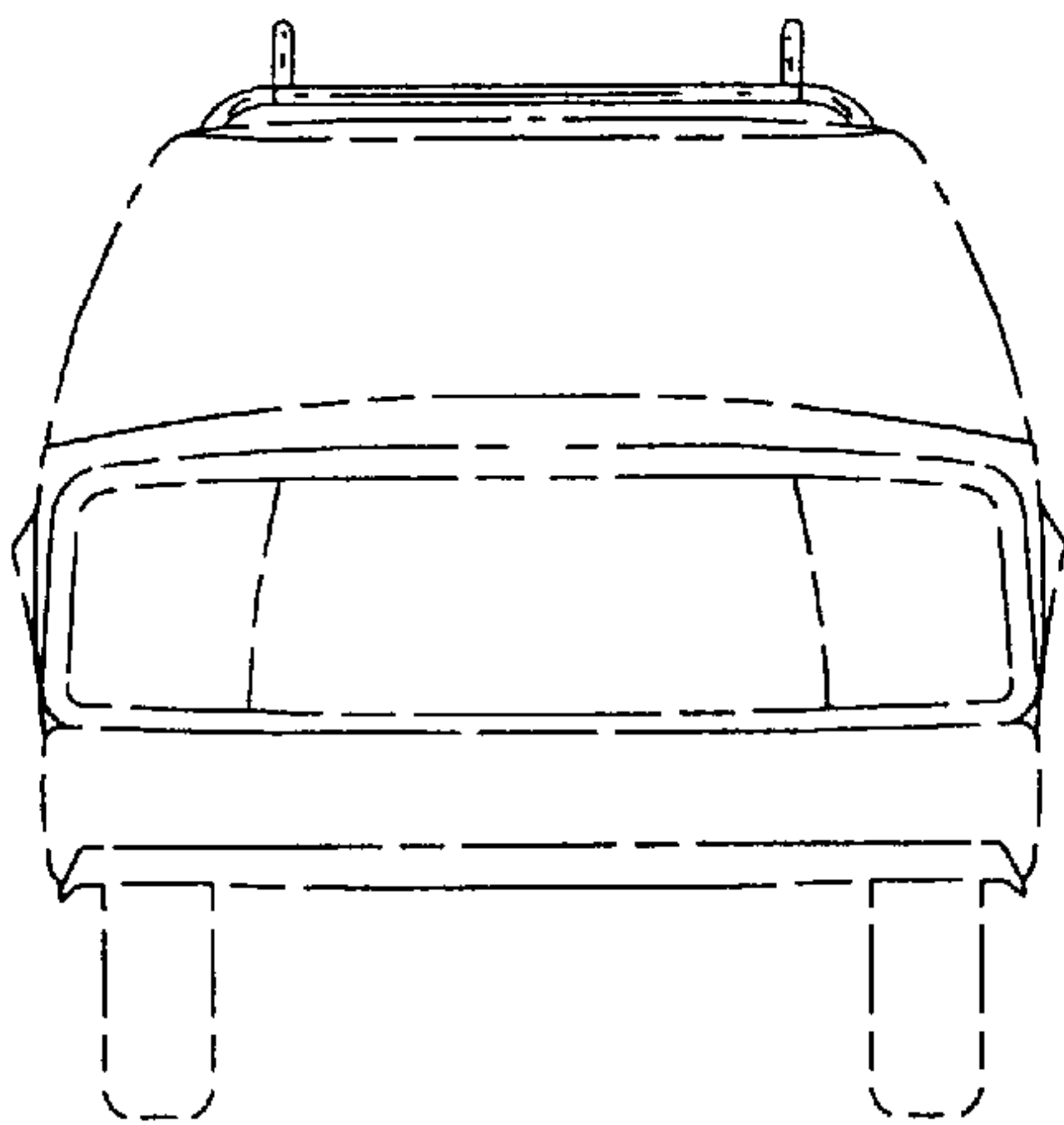

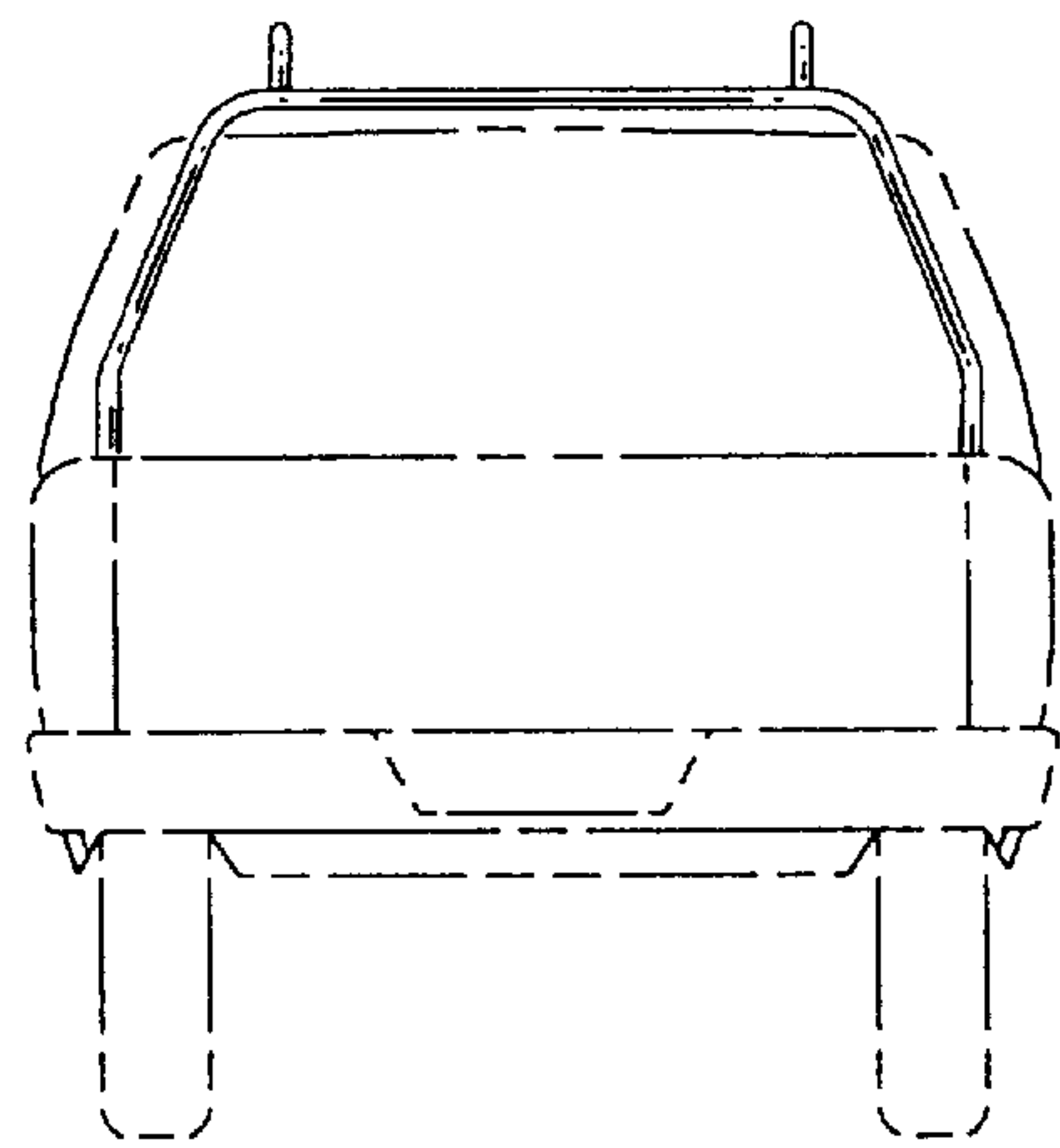

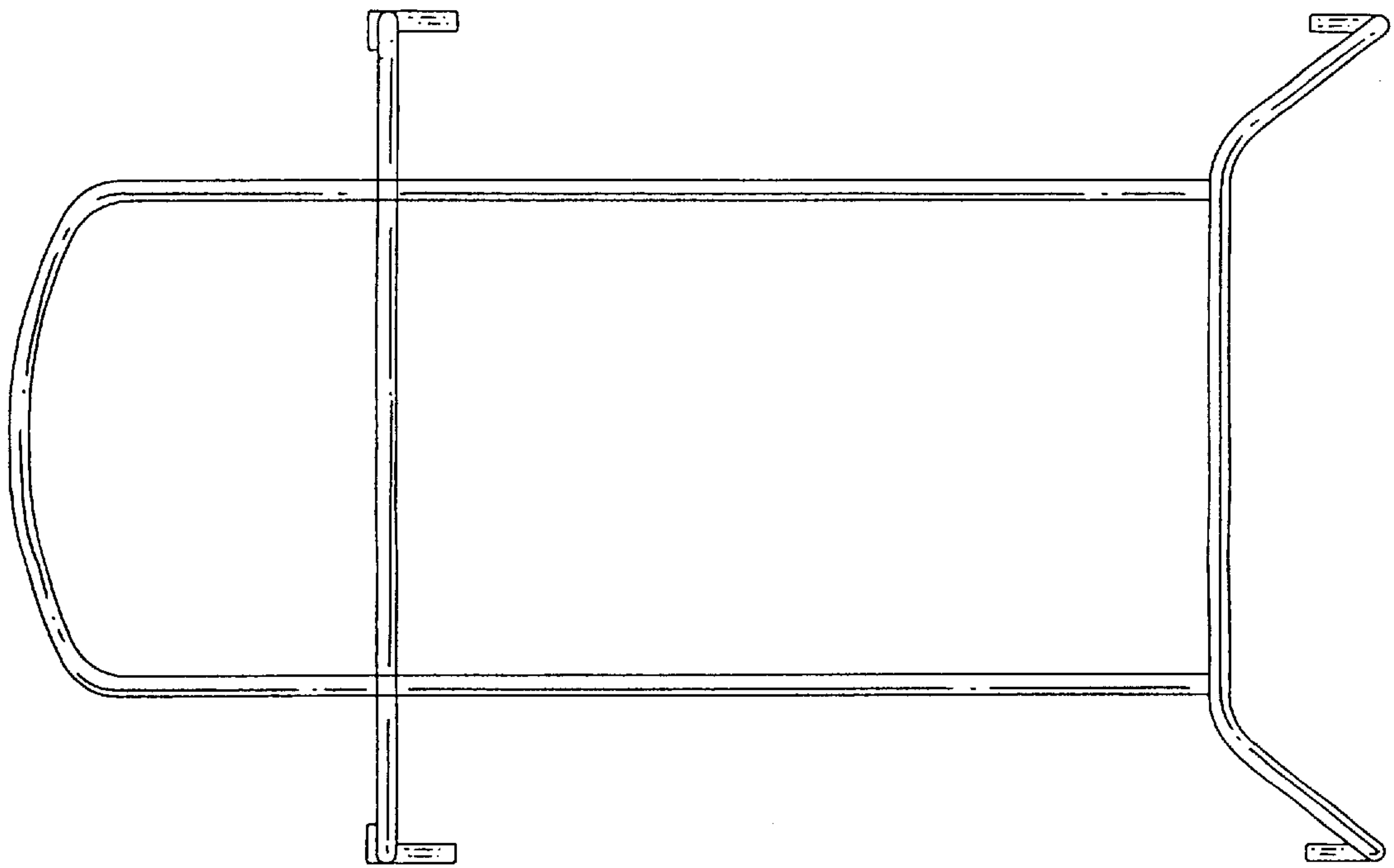

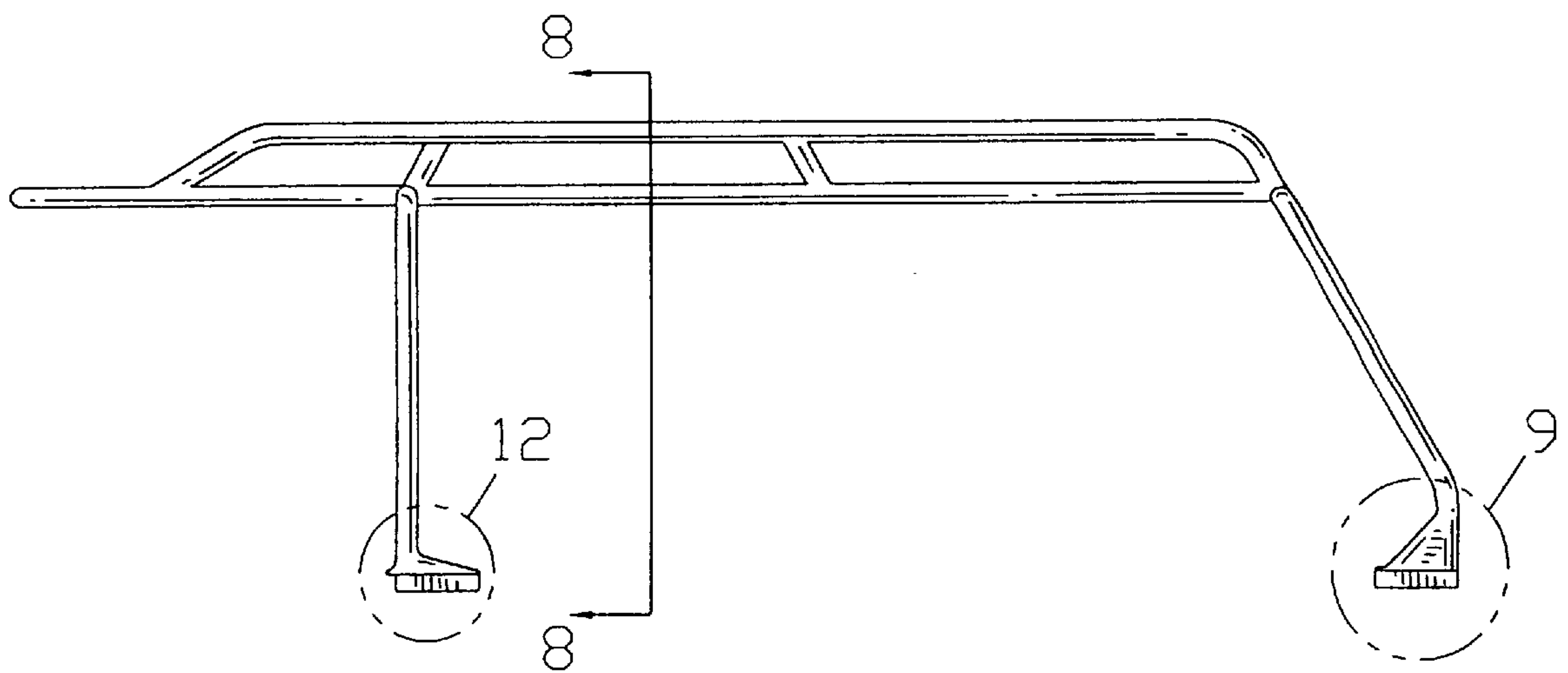

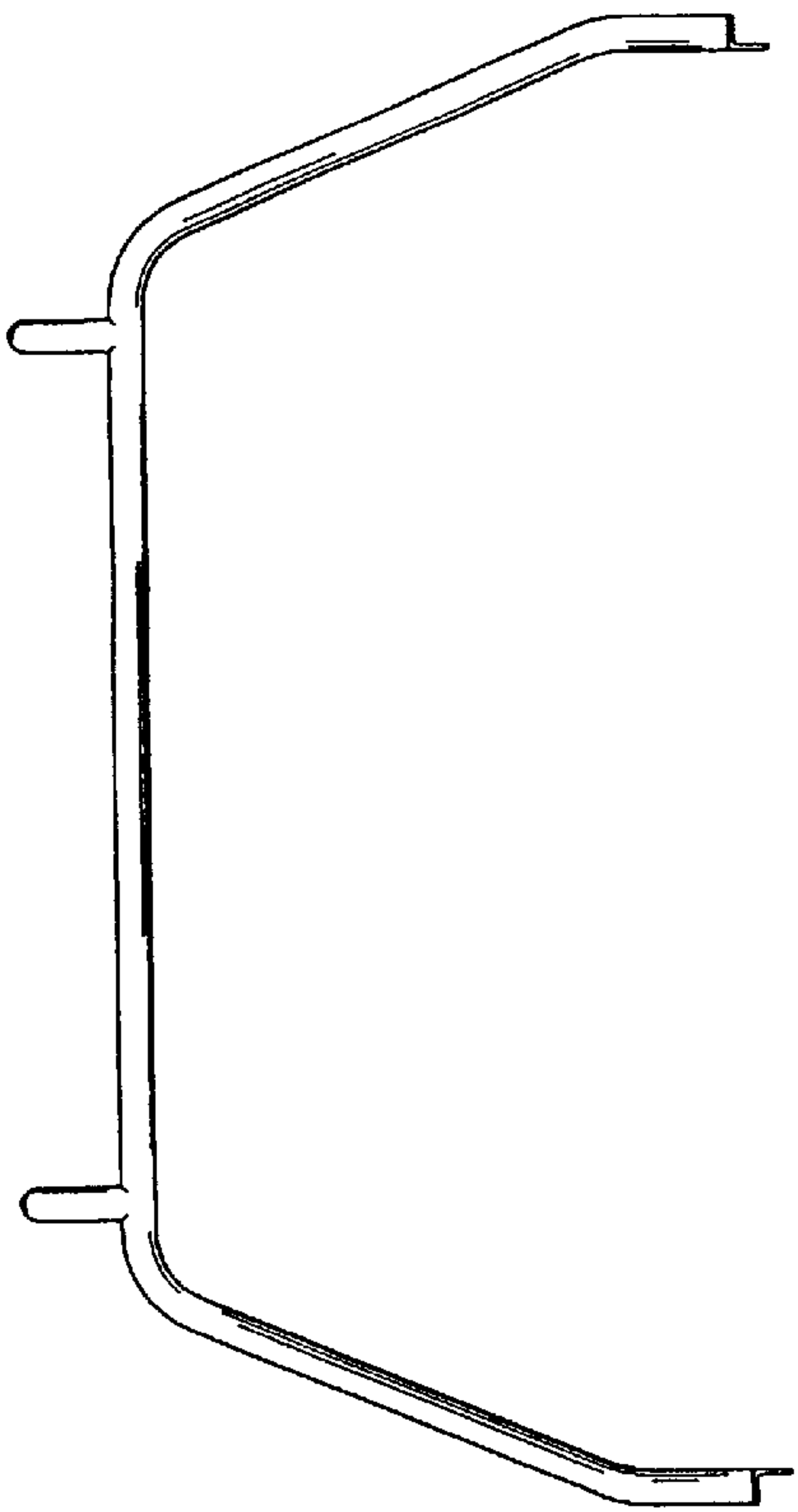

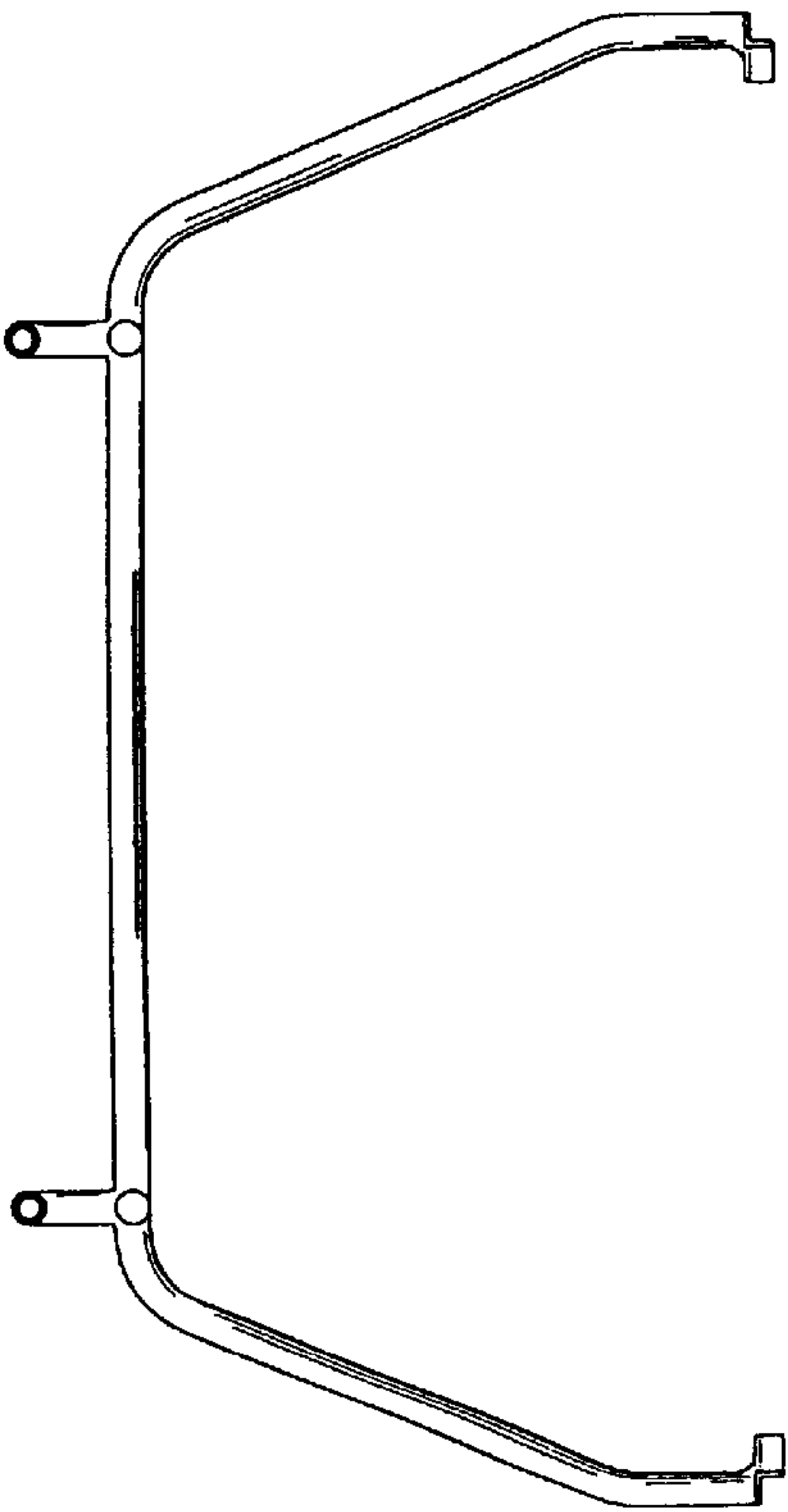

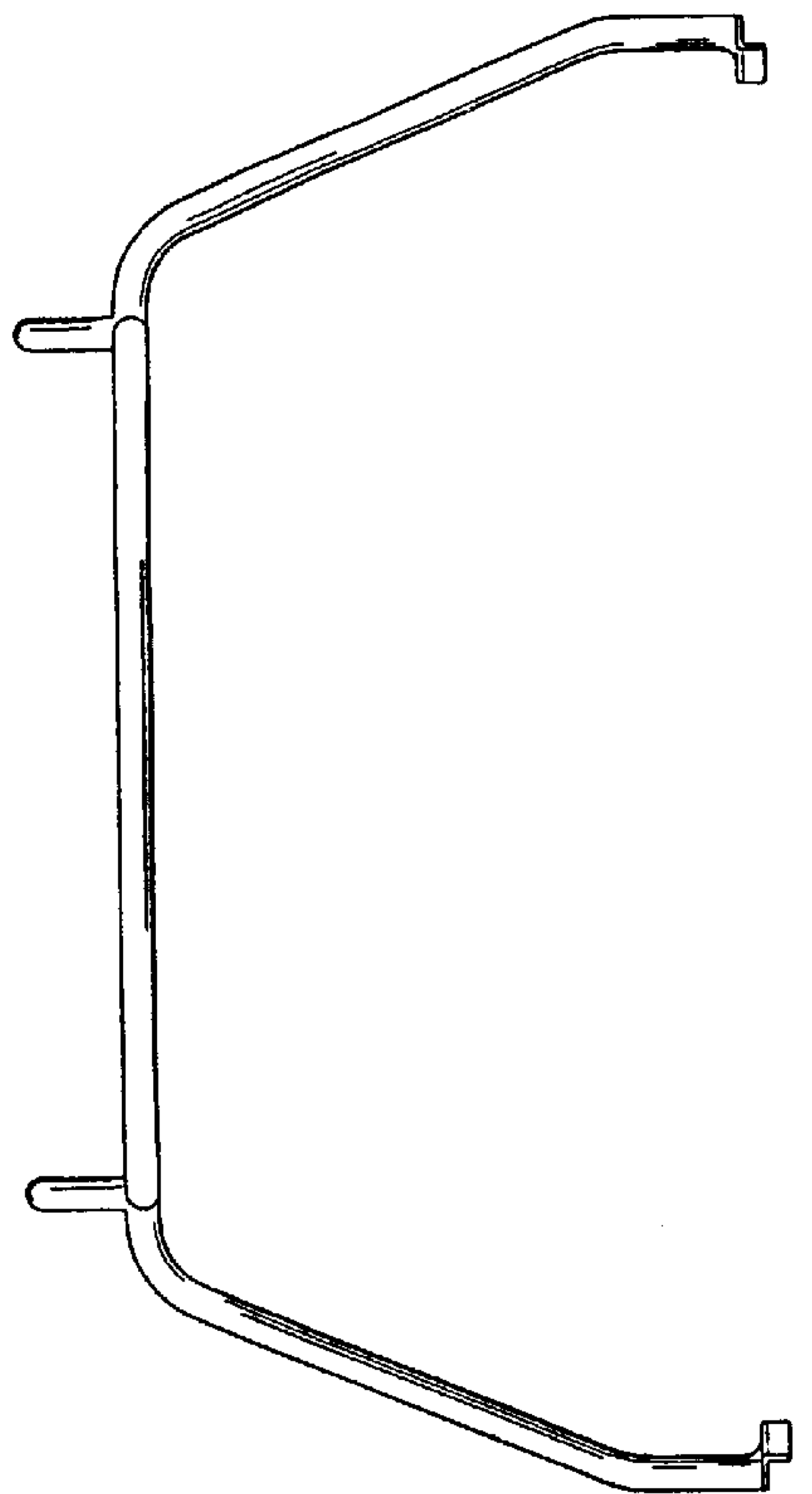

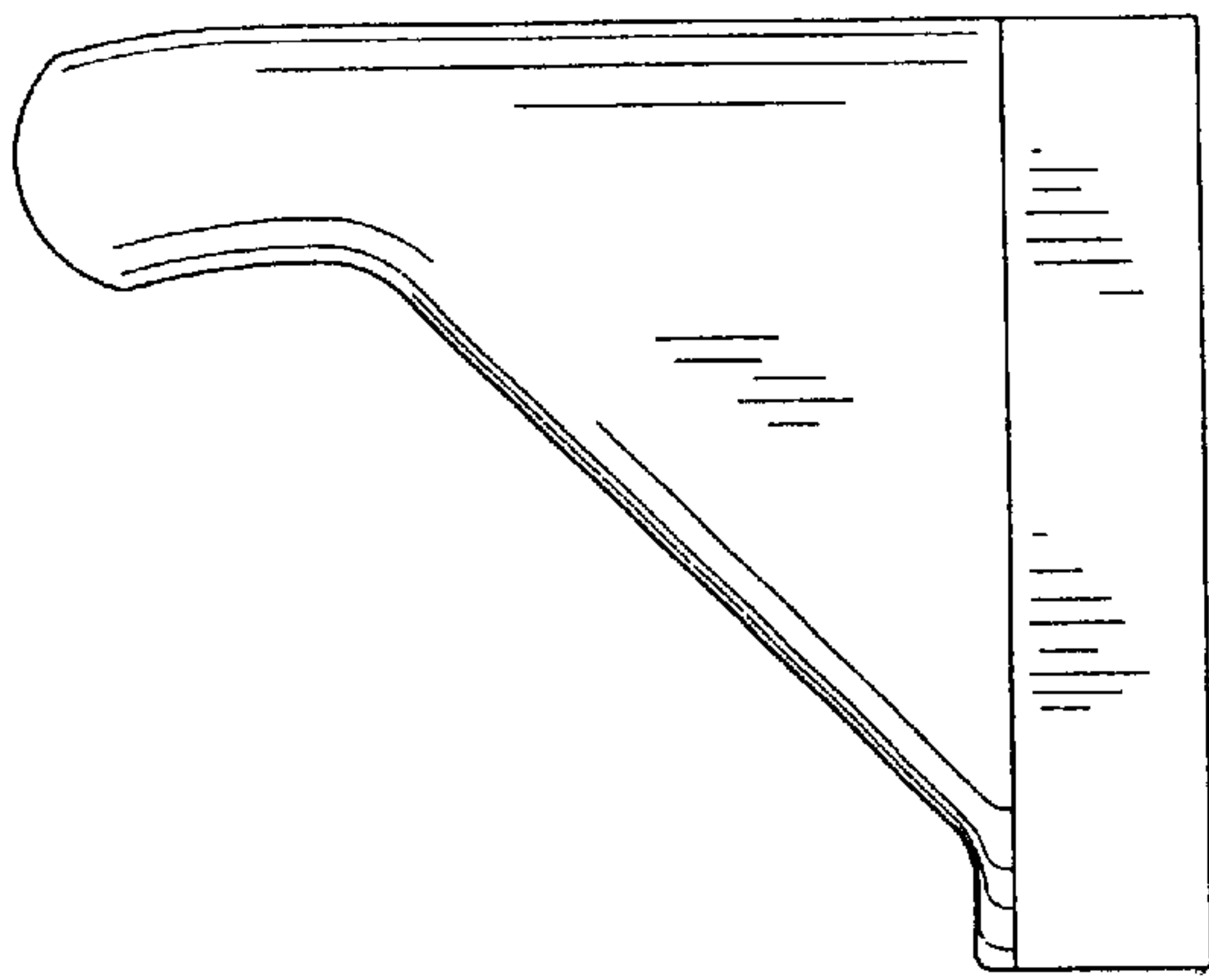

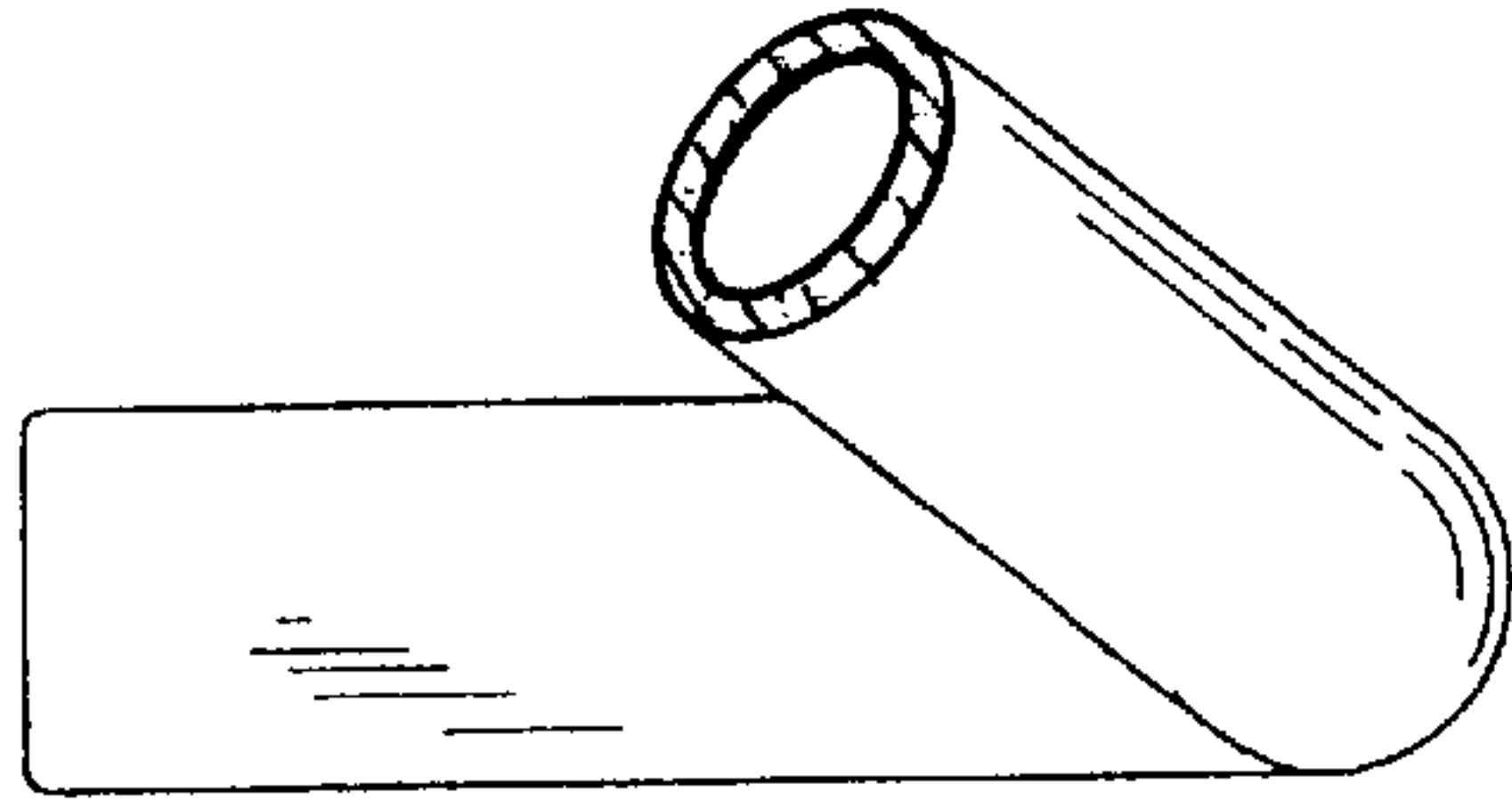

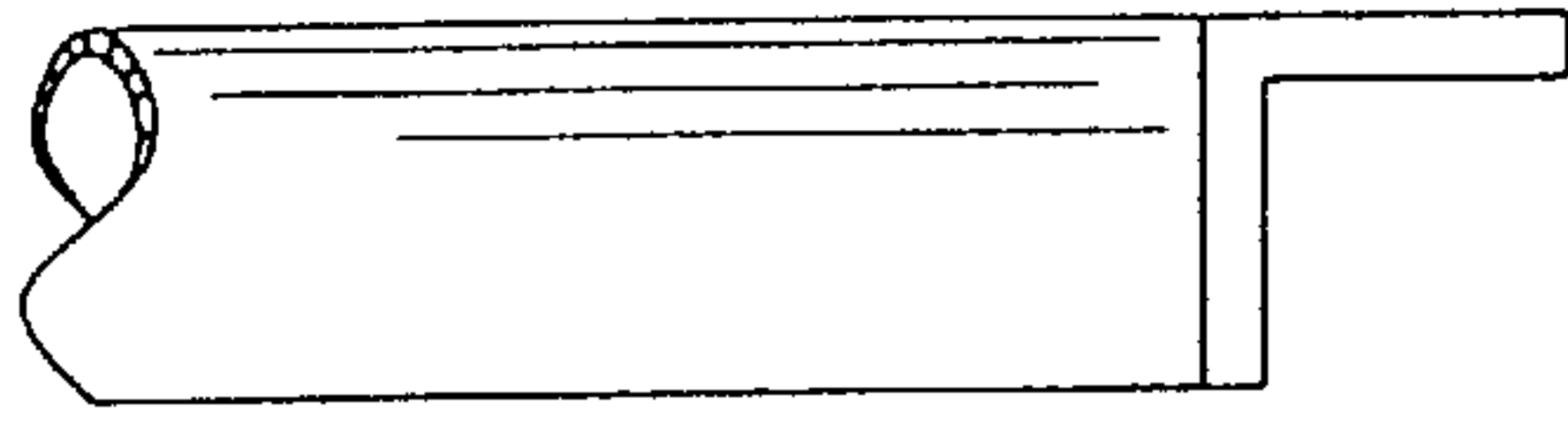

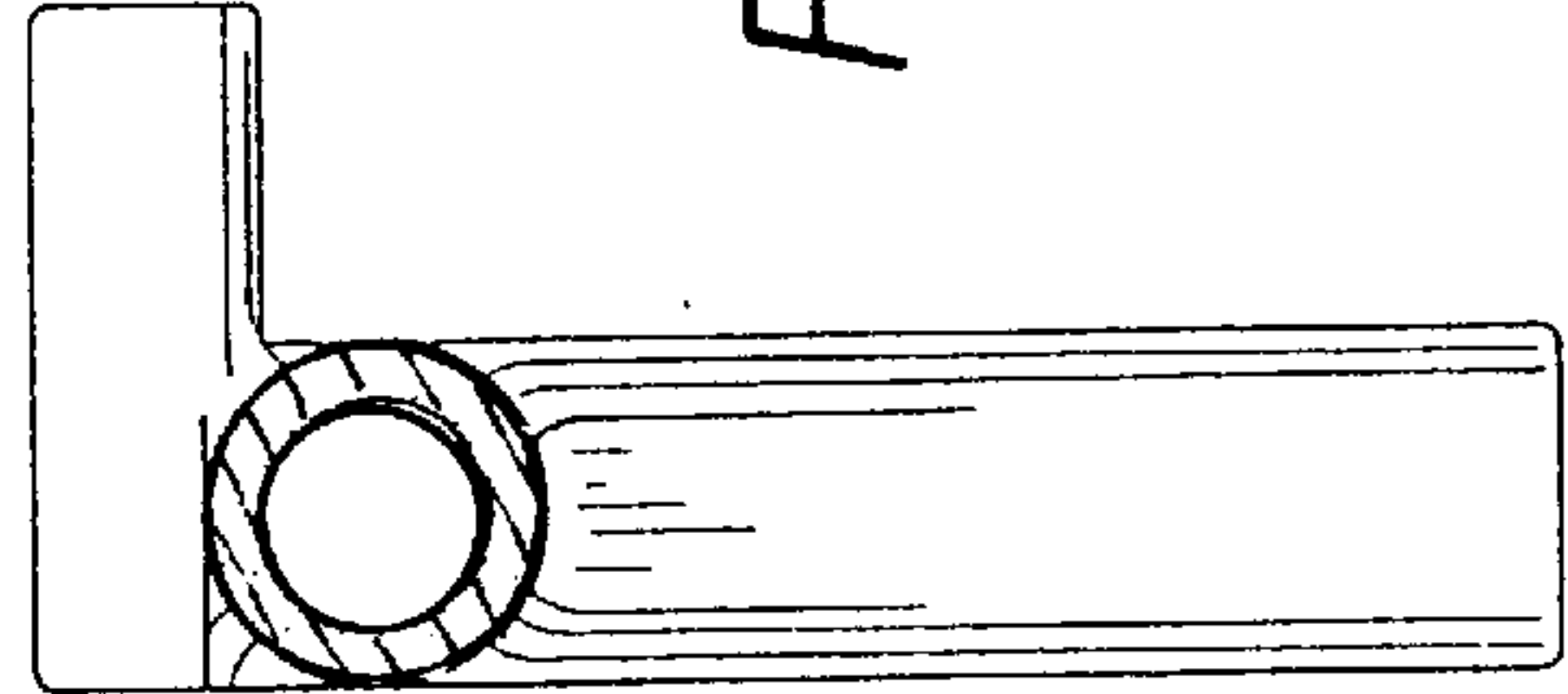

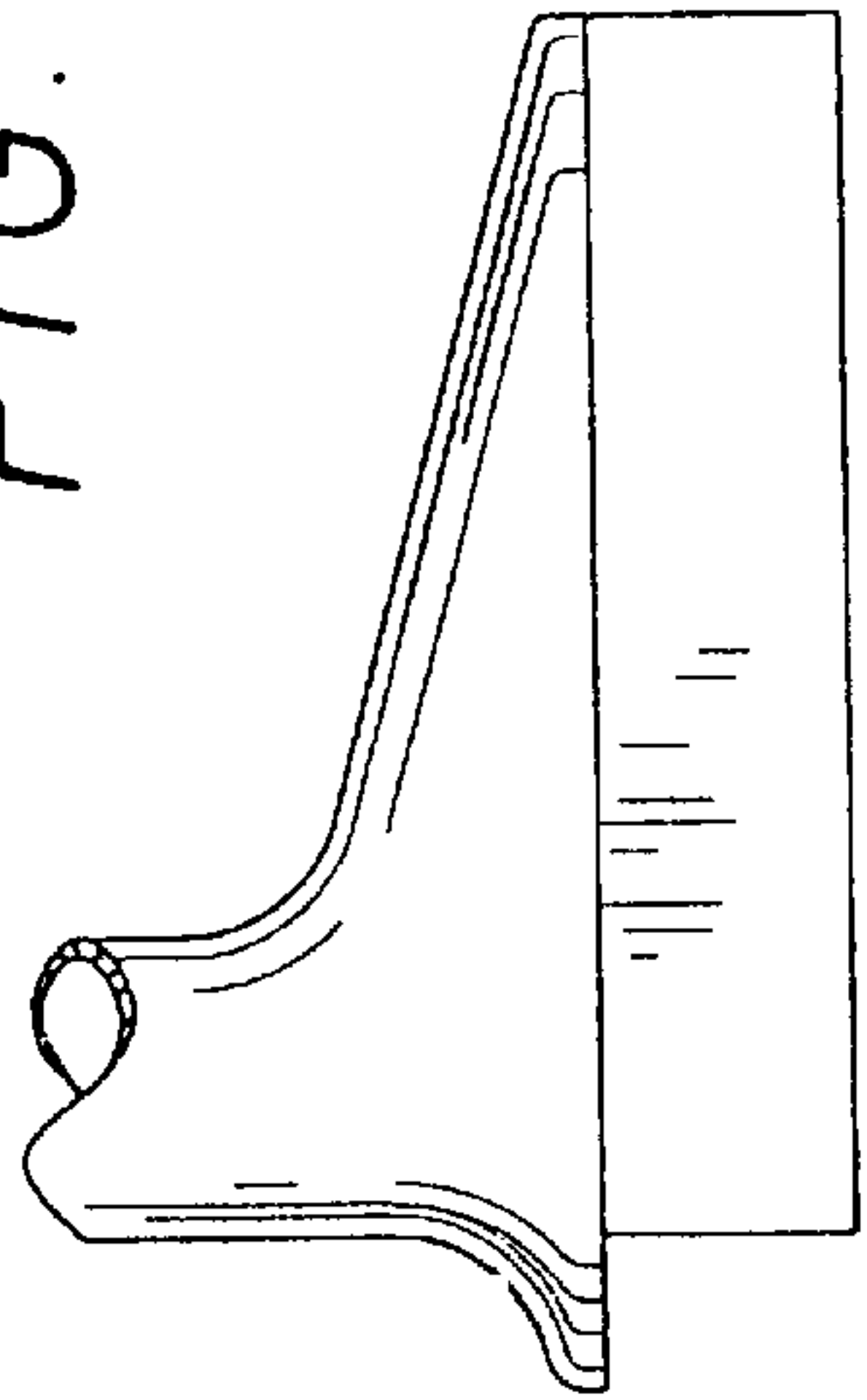
