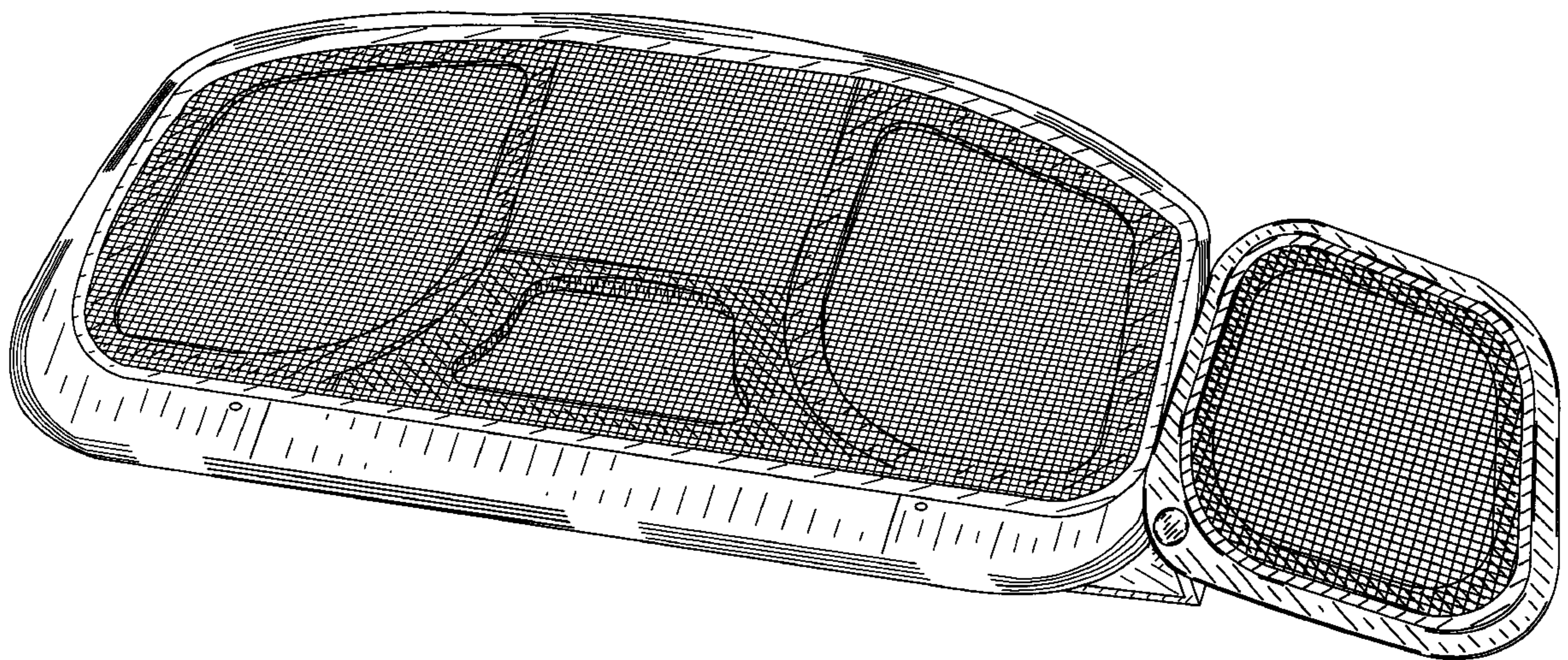
(57) **CLAIM**

The ornamental design for a computer accessories and mouse deck, as shown and described.

DESCRIPTION

FIG. 1 is a top perspective view of a computer accessories and mouse deck showing our new design; FIG. 2 is a front elevation view thereof; FIG. 3 is a rear elevation view thereof; FIG. 4 is an enlarged left side elevation view thereof; FIG. 5 is an enlarged right side elevation view thereof; FIG. 6 is a top view of a second embodiment of the computer accessories and mouse deck; FIG. 7 is a bottom plan view of FIG. 6; FIG. 8 is a top perspective view of a third embodiment of the computer accessories and mouse deck; FIG. 9 is a top perspective view of FIG. 1 showing the design in an alternative position; FIG. 10 is a top perspective view of FIG. 1 showing the design in another alternative position; FIG. 11 is a left side elevation of a fourth embodiment of the computer accessories and mouse deck; and, FIG. 12 is a bottom perspective view of FIG. 11.

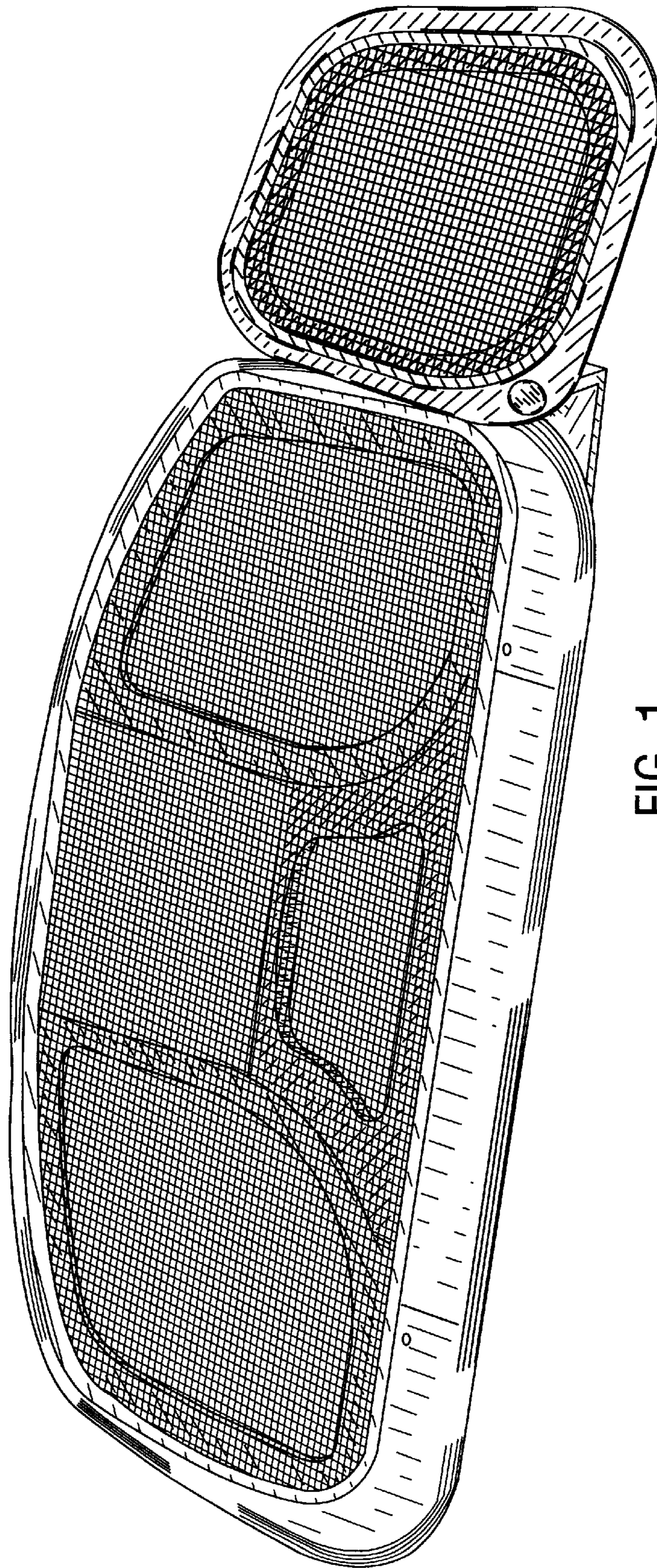

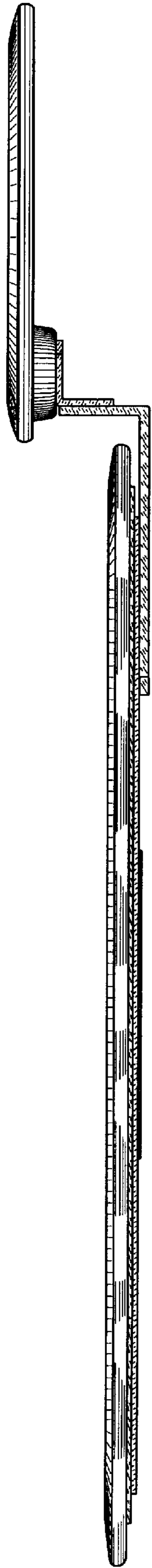

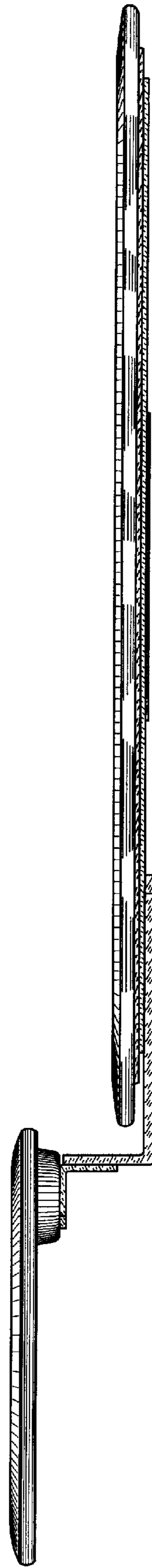

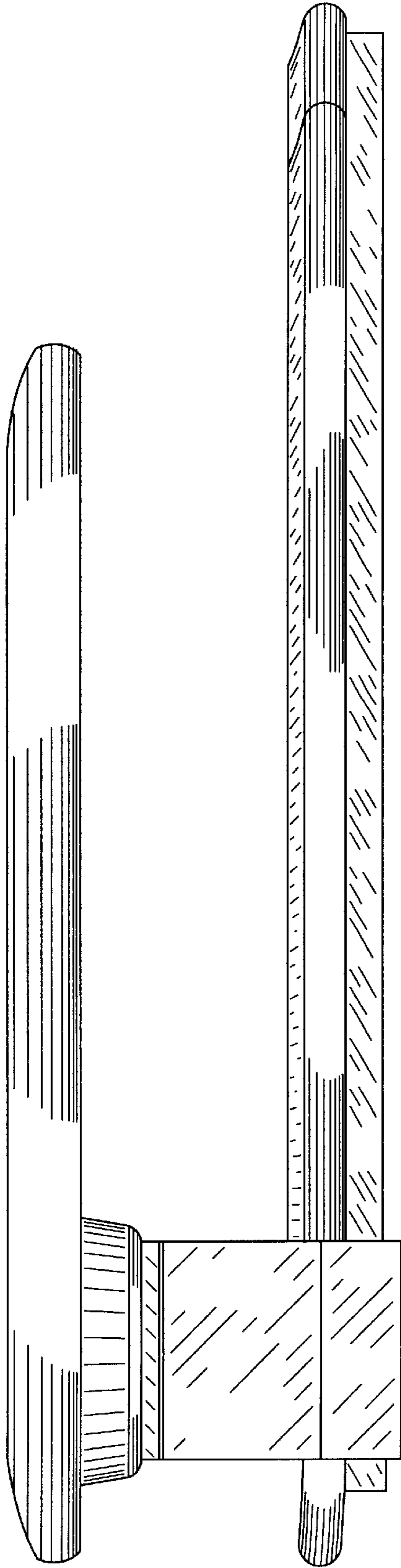

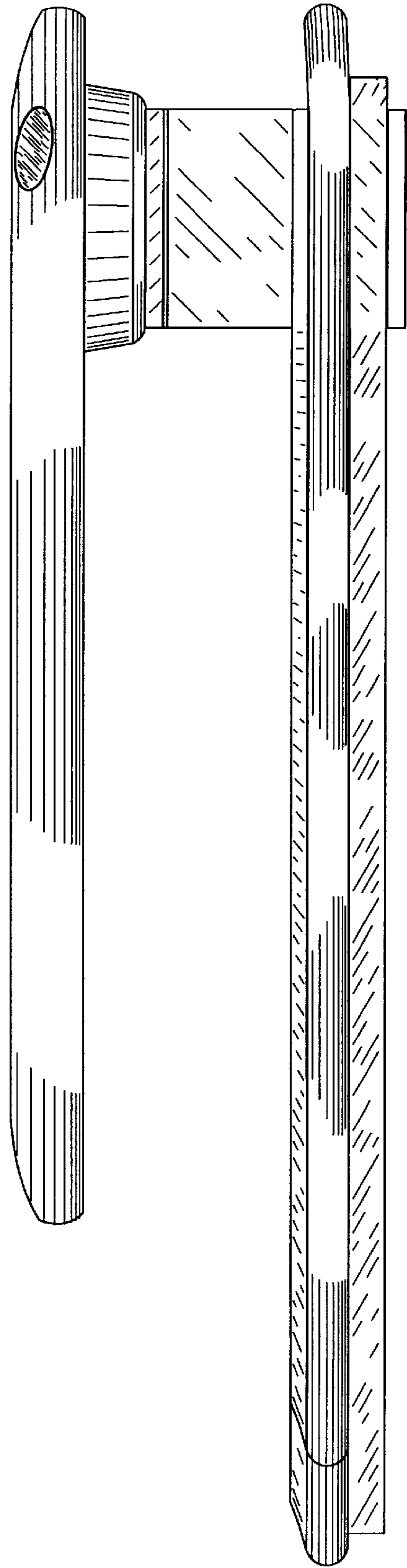

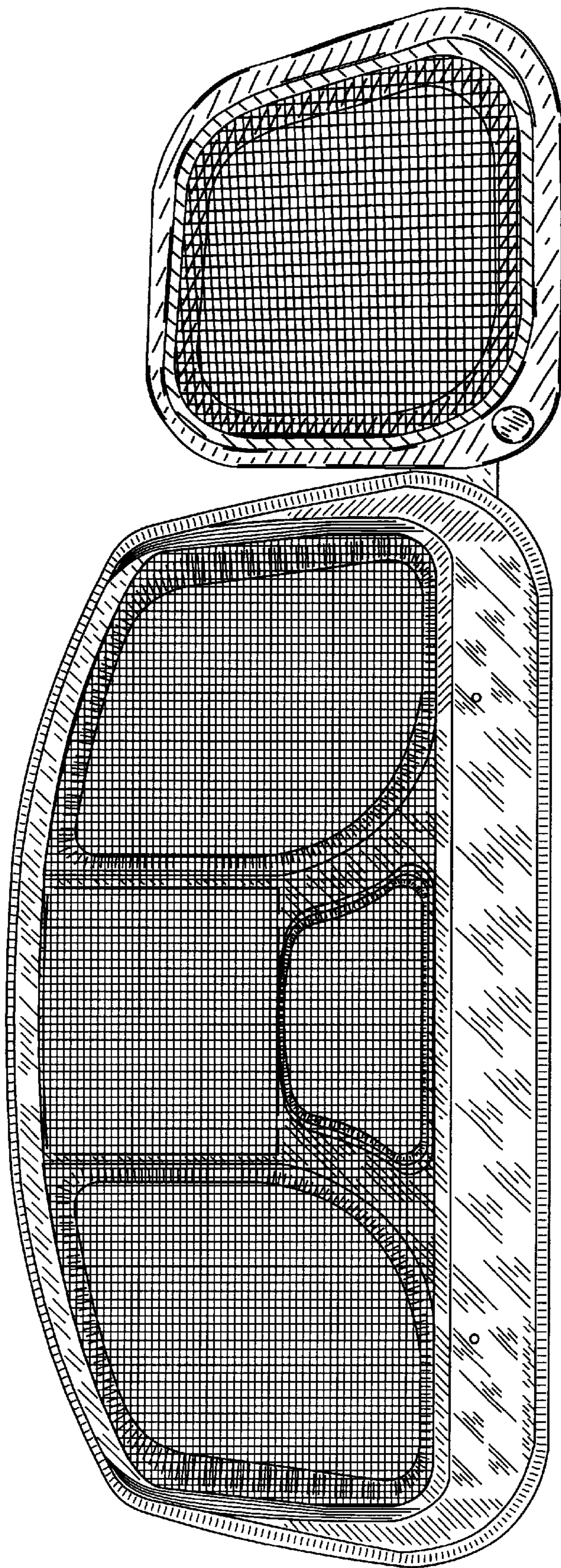

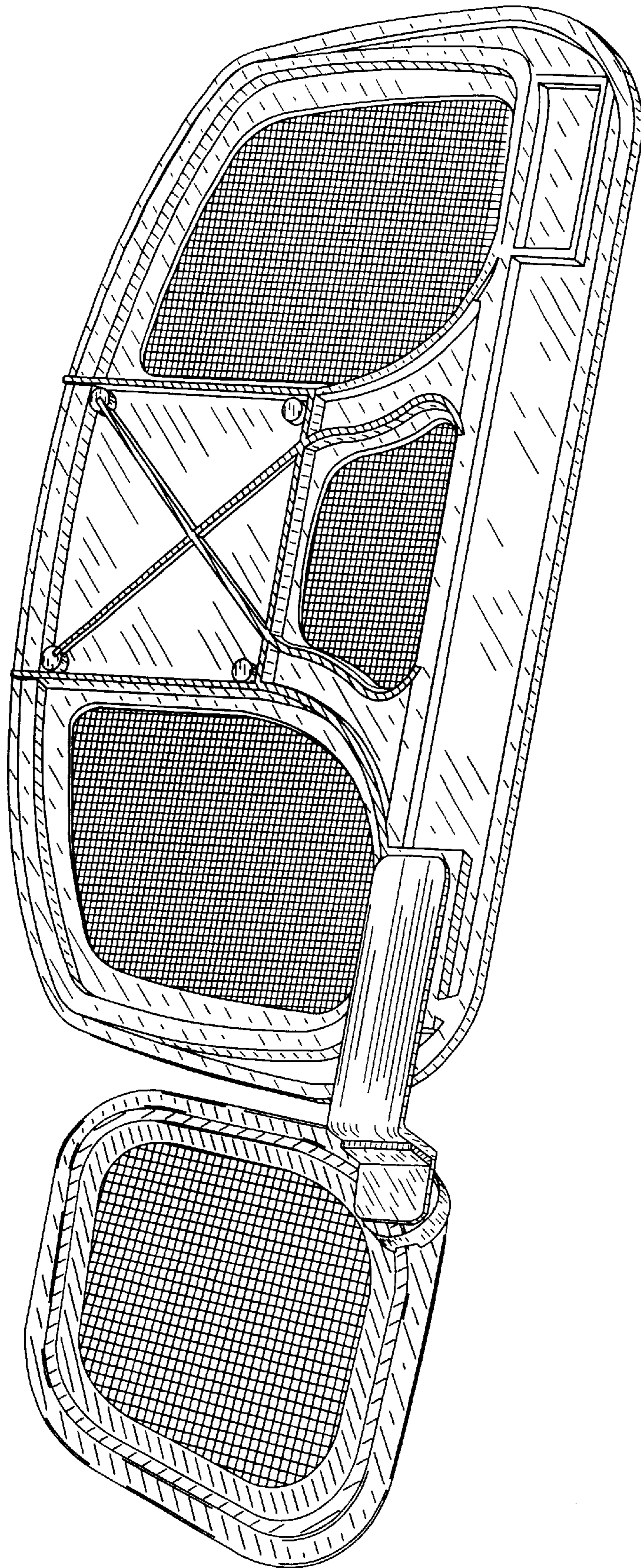

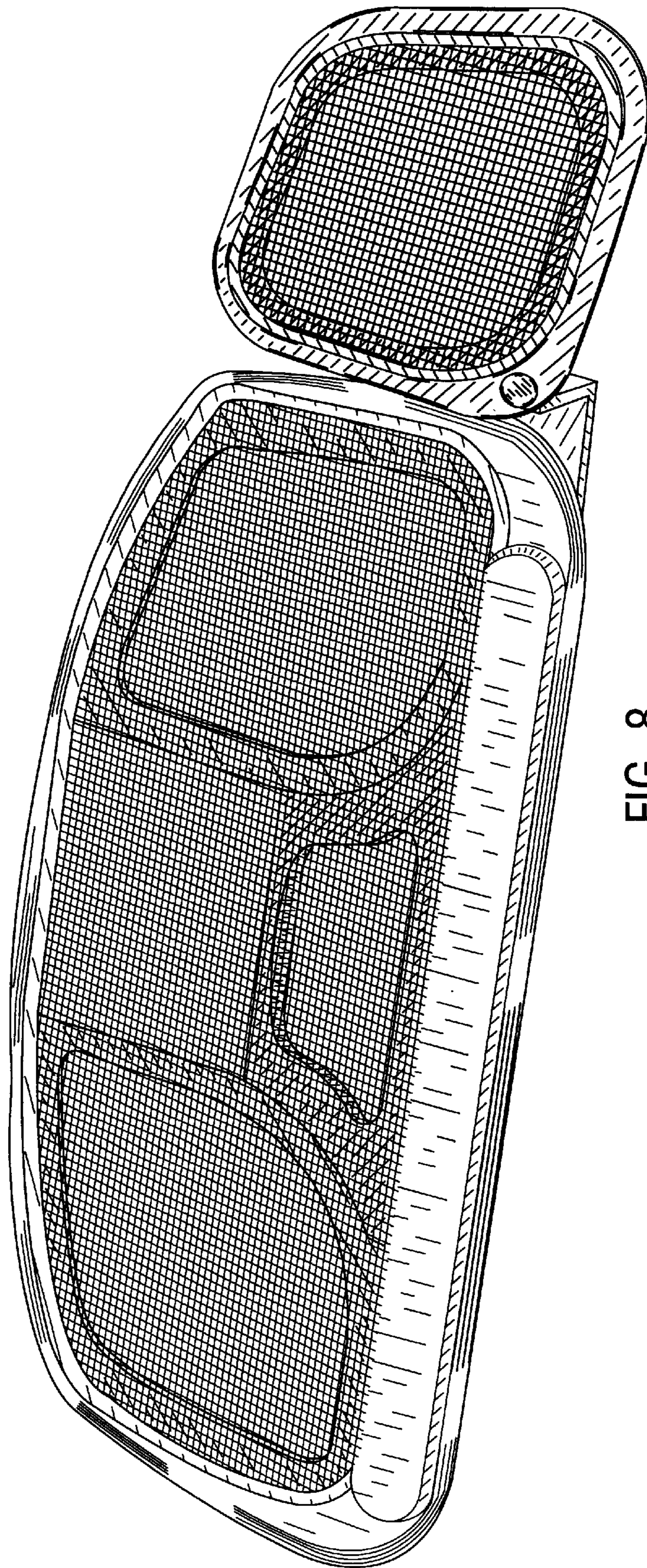

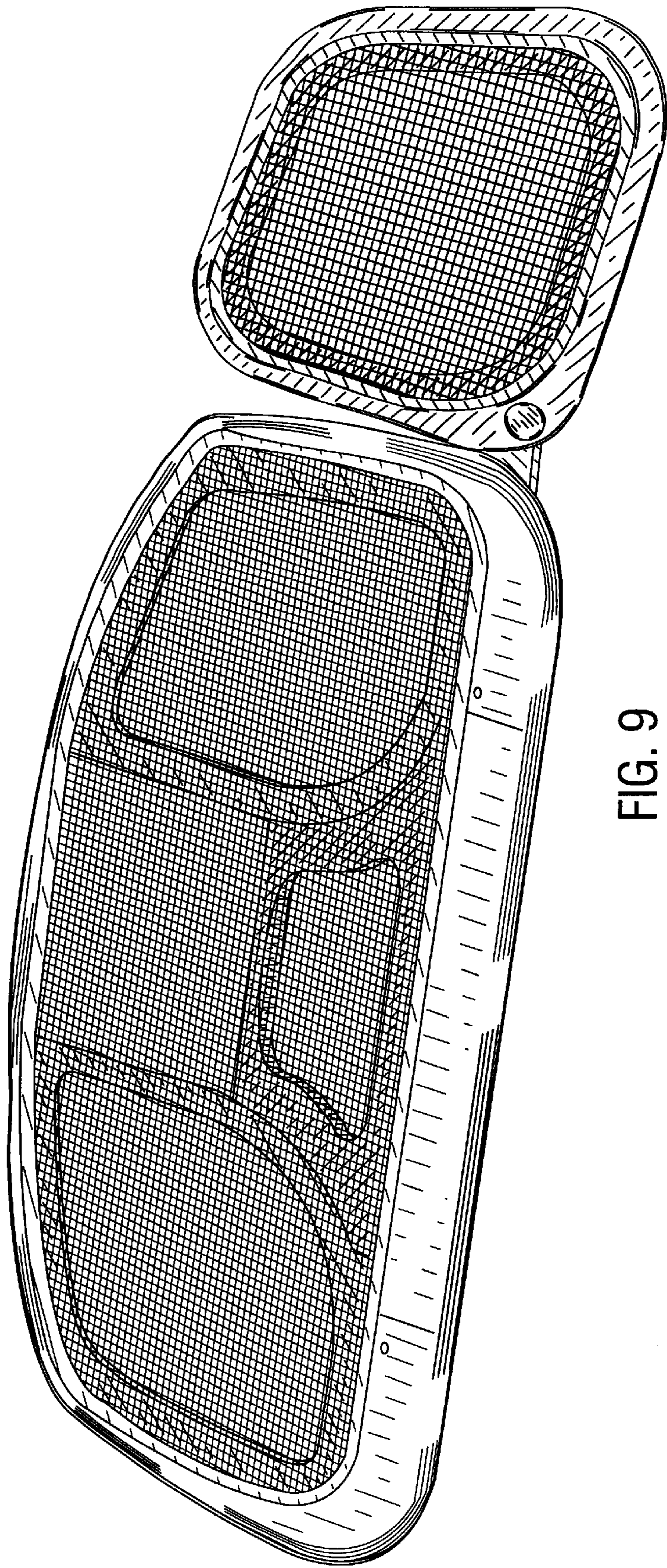

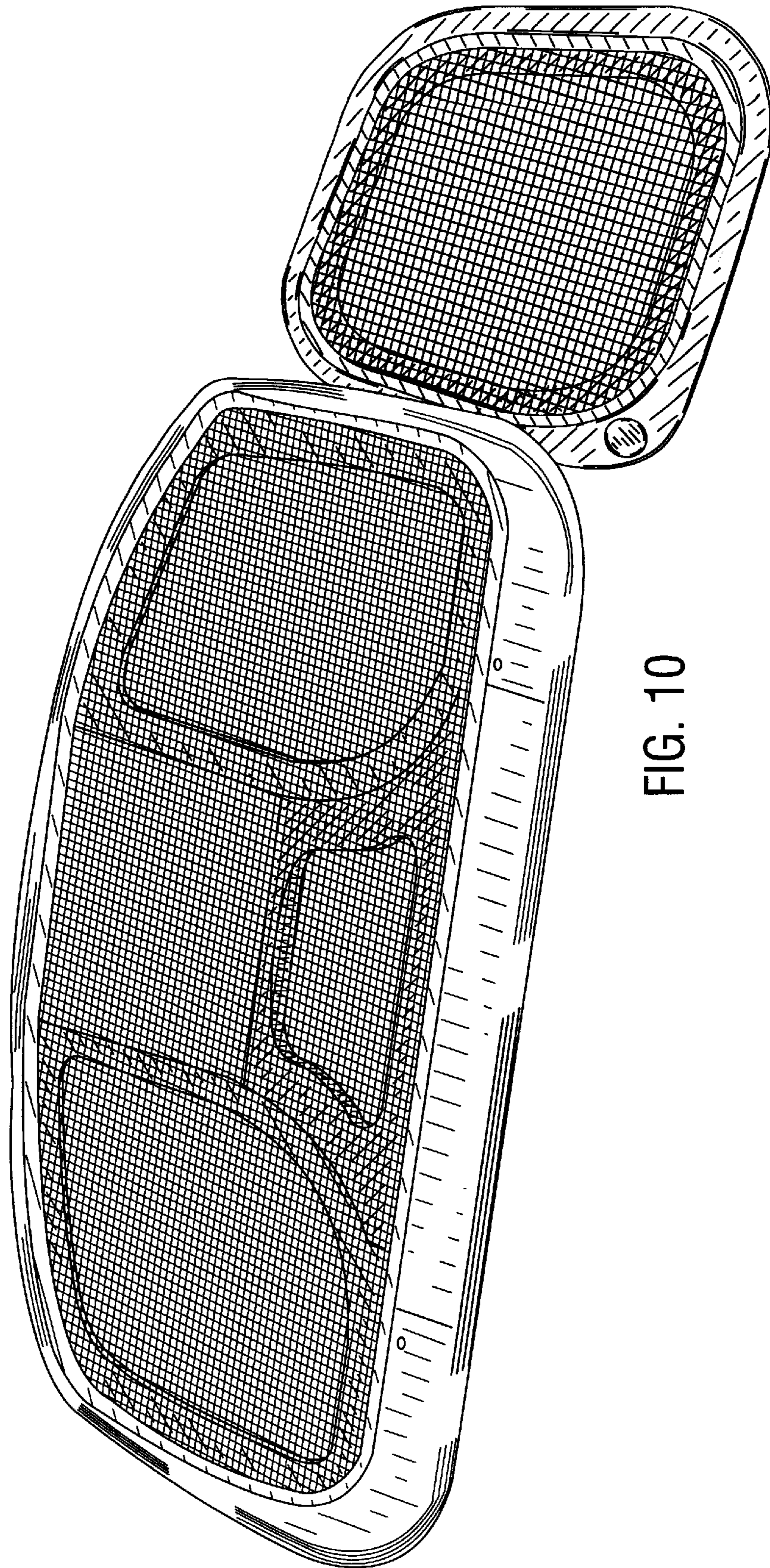

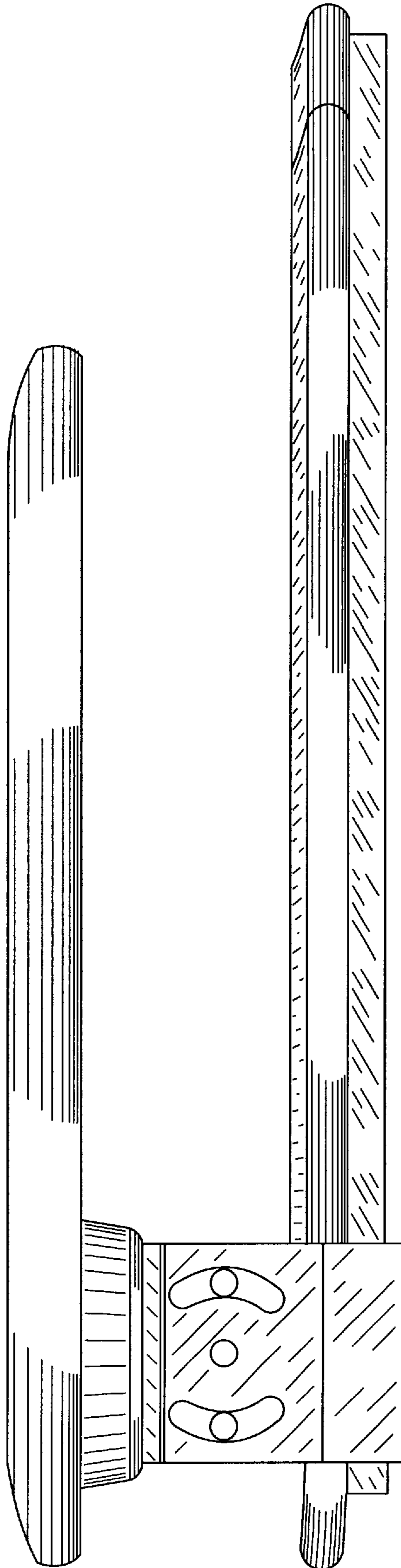

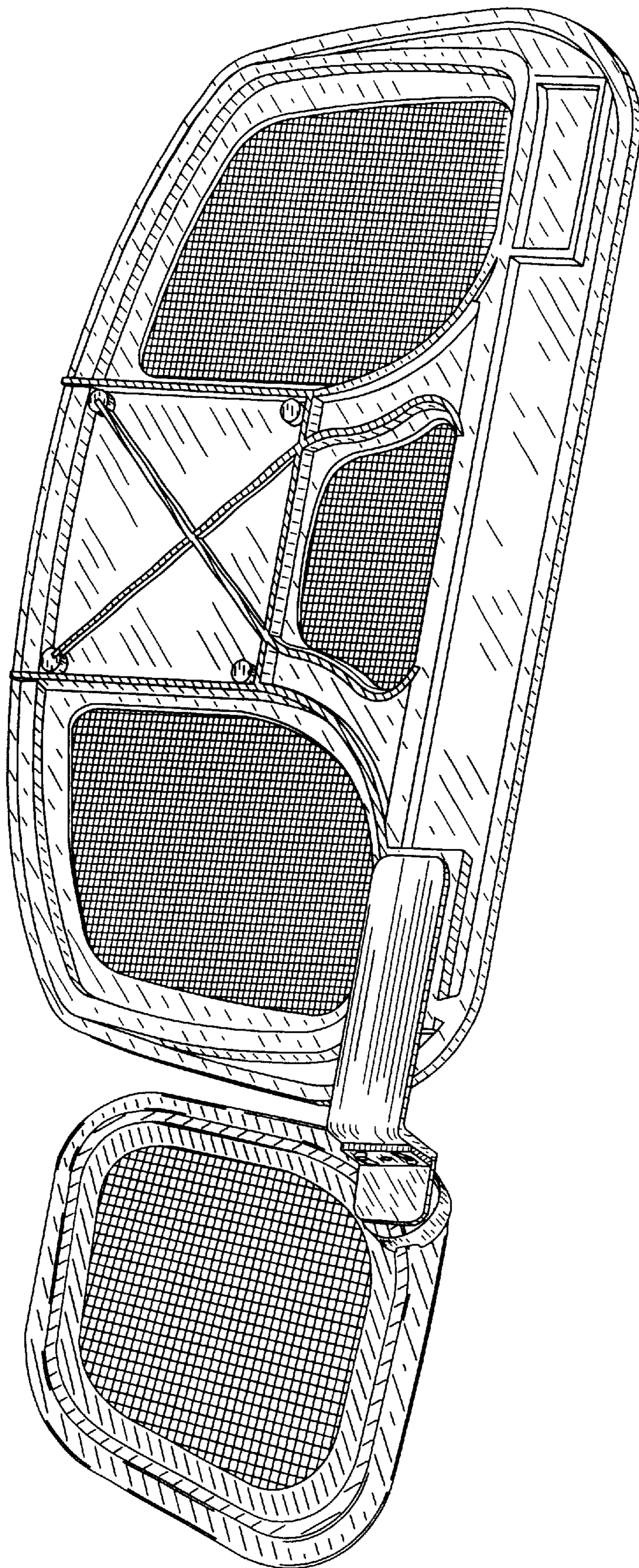
