(57) **CLAIM**

The ornamental design for an office-use device with scissors, as shown and described.

**DESCRIPTION**

FIG. 1 is a front elevational view showing my new design for an office-use device with scissors;

FIG. 2 is a top plan view thereof;

FIG. 3 is a bottom plan view thereof;

FIG. 4 is a rear elevational view thereof;

FIG. 5 is a right side elevational view thereof;

FIG. 6 is left side elevational view thereof;

FIG. 7 is a front elevational view thereof similar to FIG. 1, with the scissors extended;

FIG. 8 is a front elevational view thereof similar to FIG. 1, with the magnifying glass extended;

FIG. 9 is a front elevational view thereof similar to FIG. 1, with the stapler section extended;

FIG. 10 is a bottom plan view thereof similar to FIG. 3, with the tape measure in extended position;

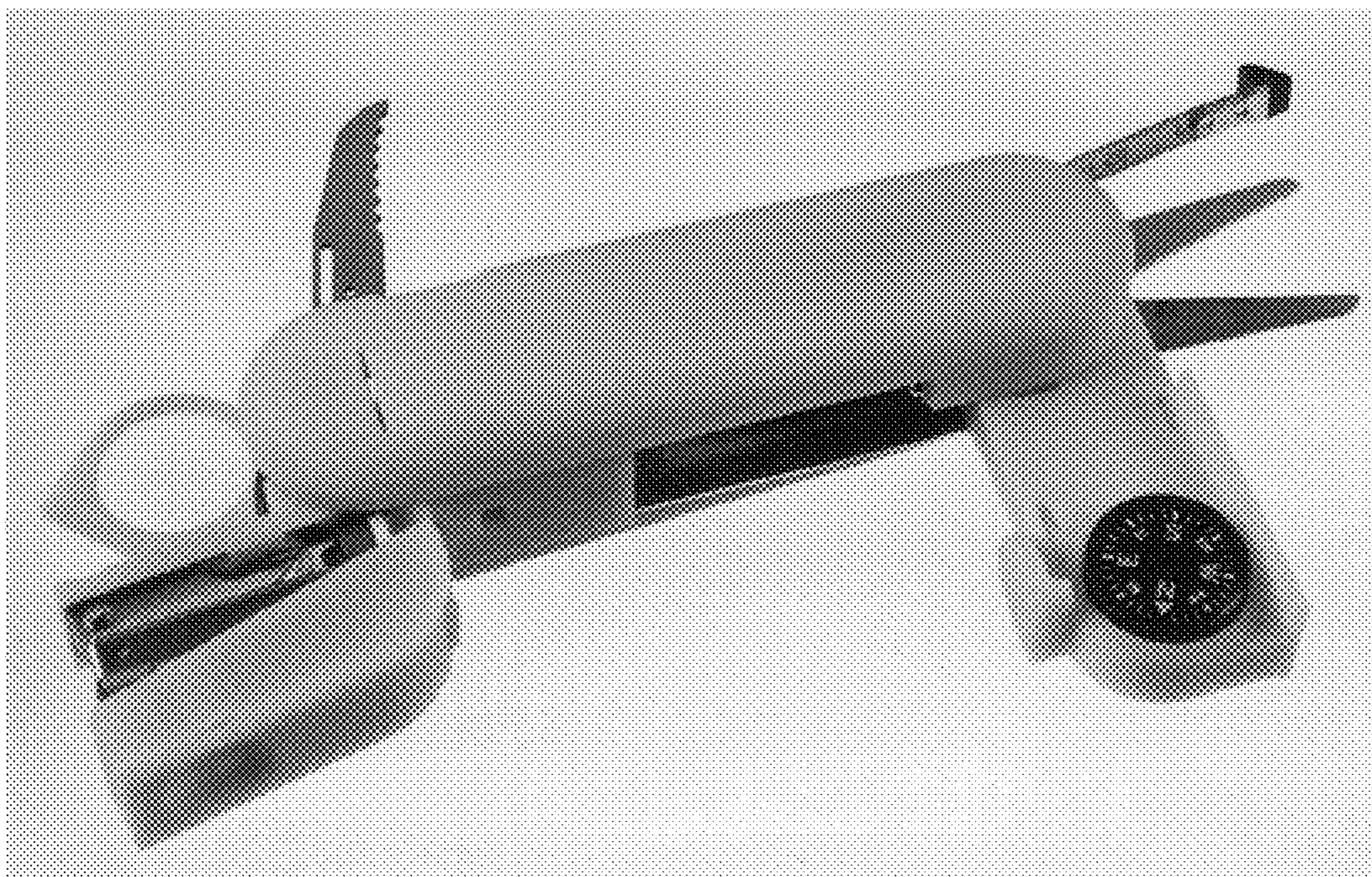
FIG. 11 is a rear elevational view thereof similar to FIG. 4, with the cutter blade in extended position;

FIG. 12 is a rear elevational view thereof similar to FIG. 4, with the compass in extended position;

FIG. 13 is a perspective view thereof as viewed from the bottom right, with the elements in extended position; and,

FIG. 14 is a perspective view thereof as viewed from the front.

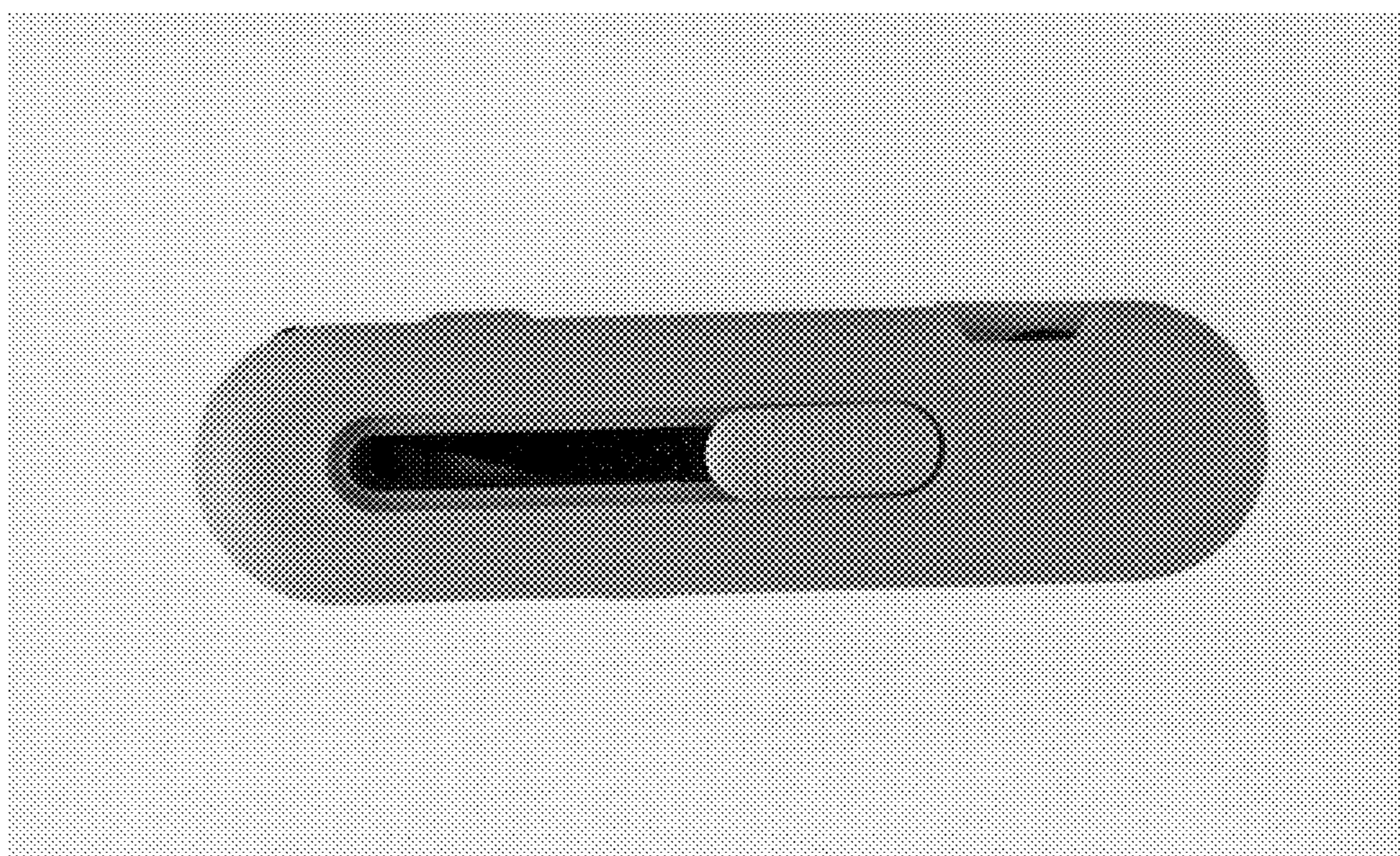

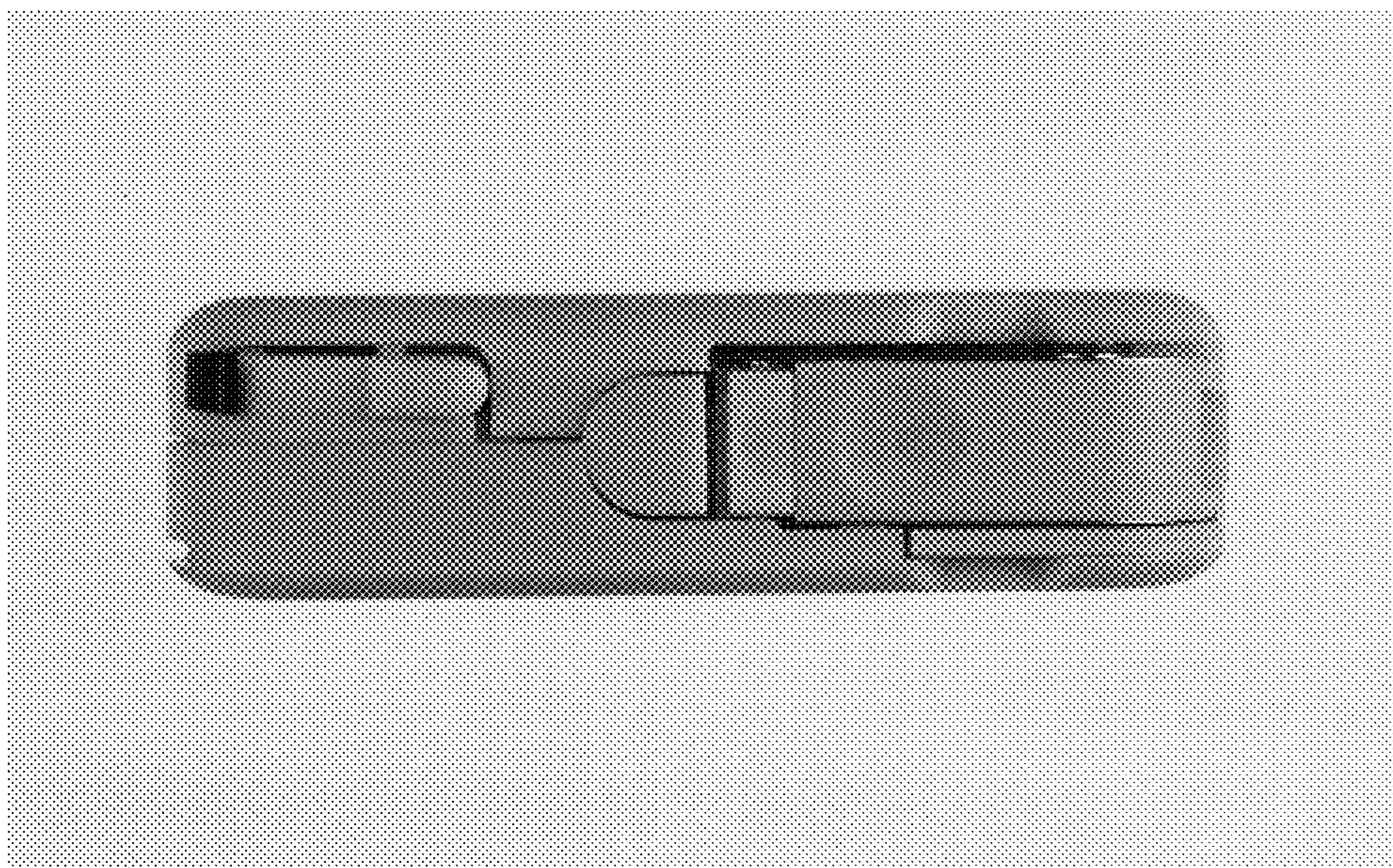

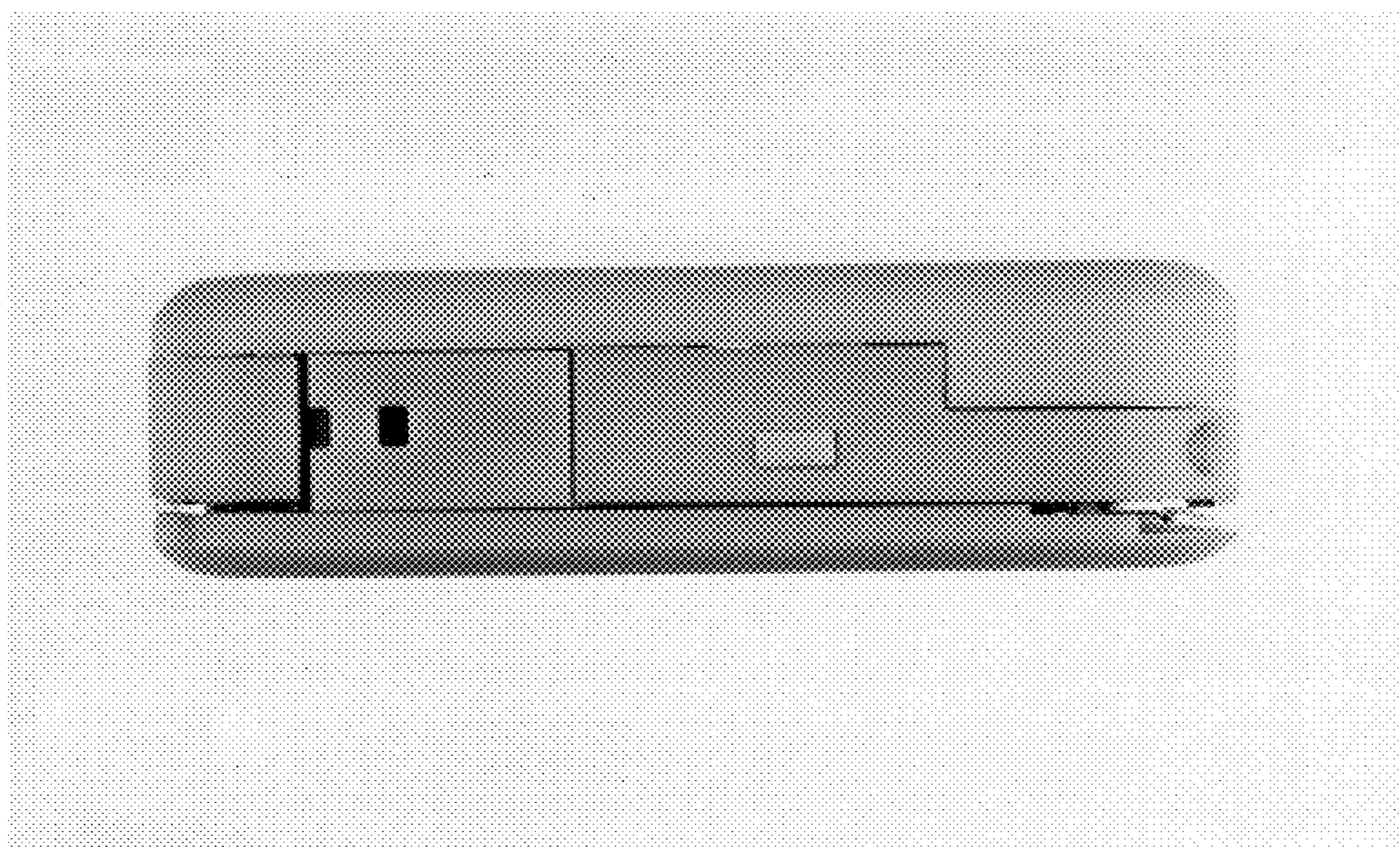

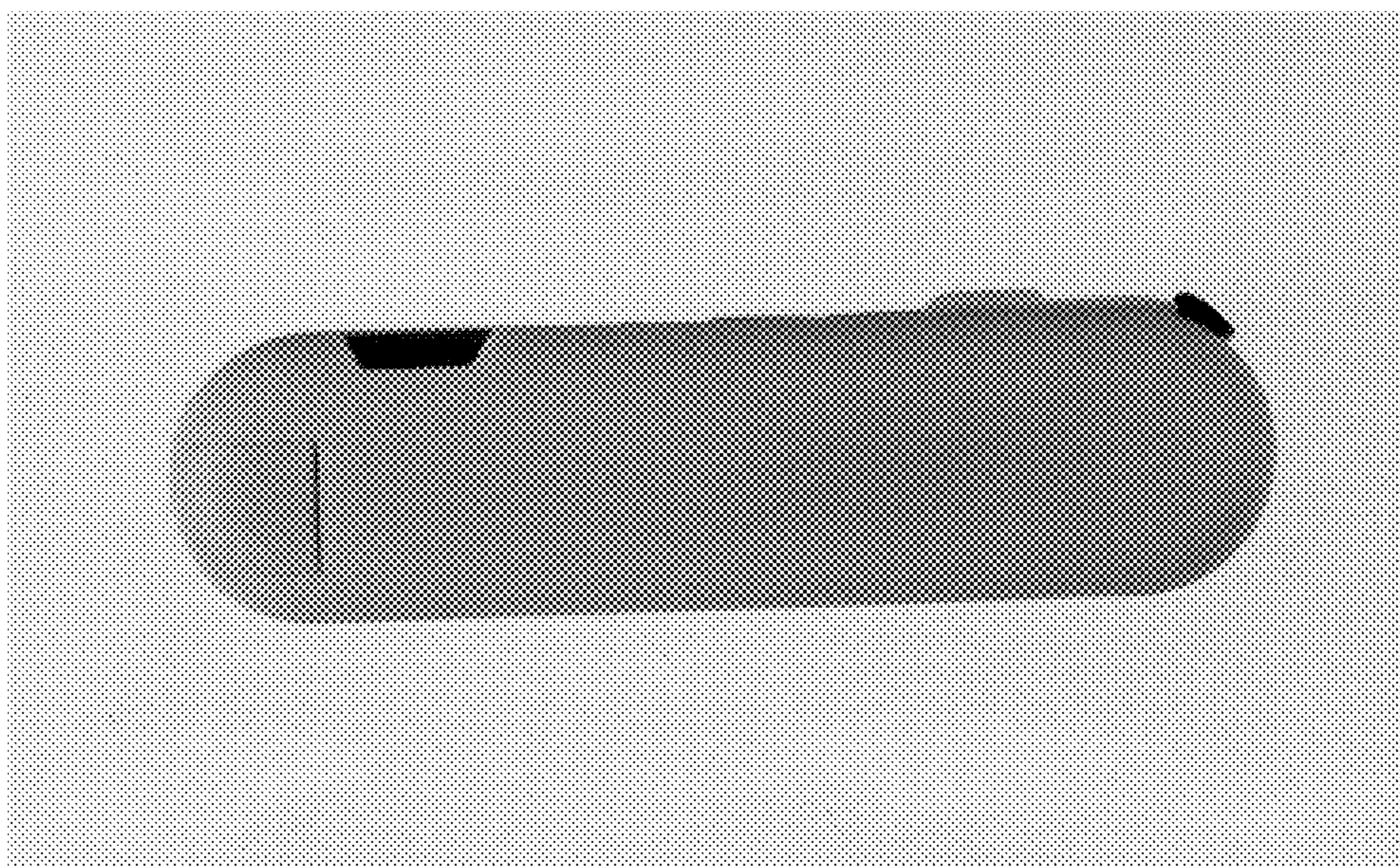

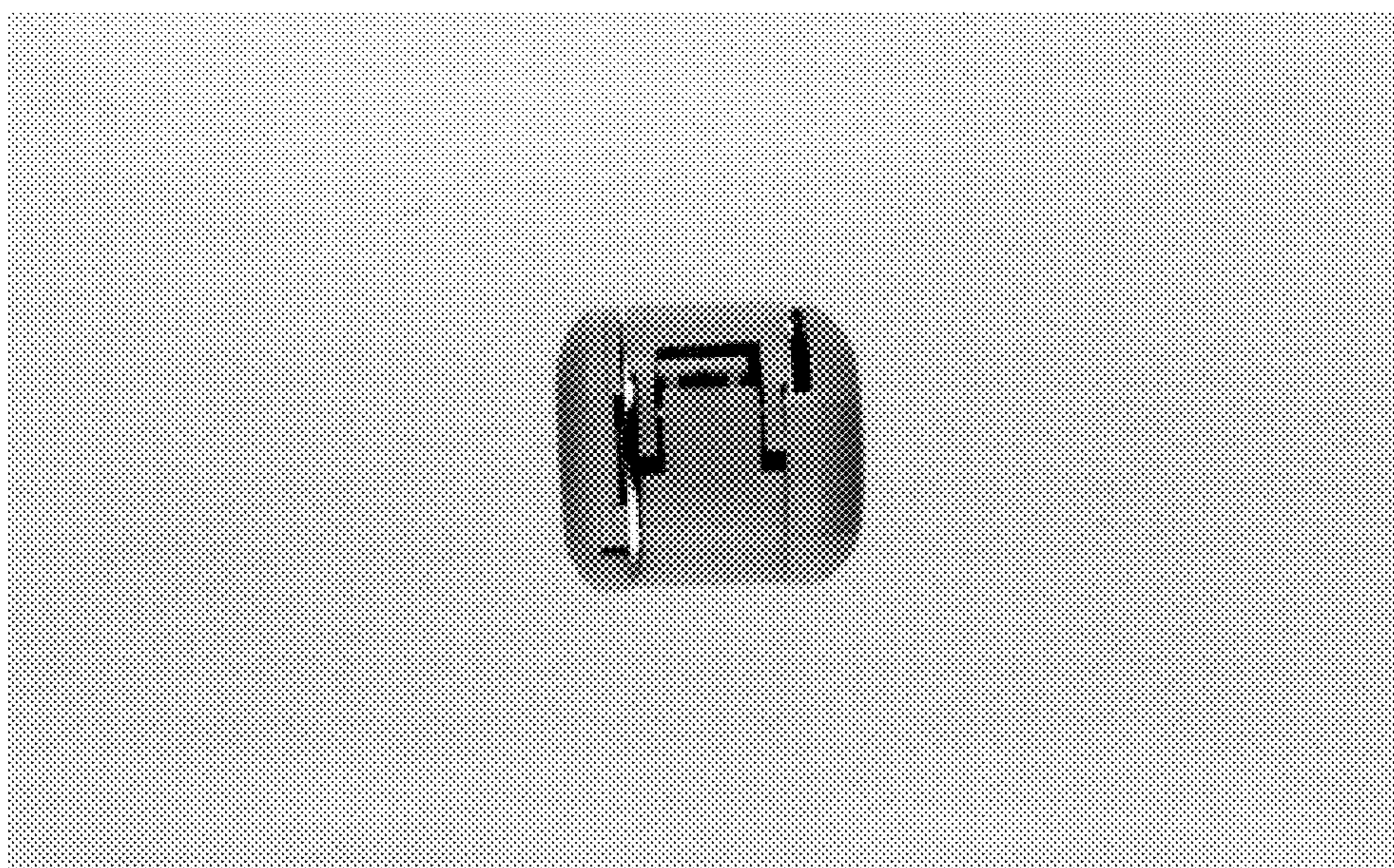

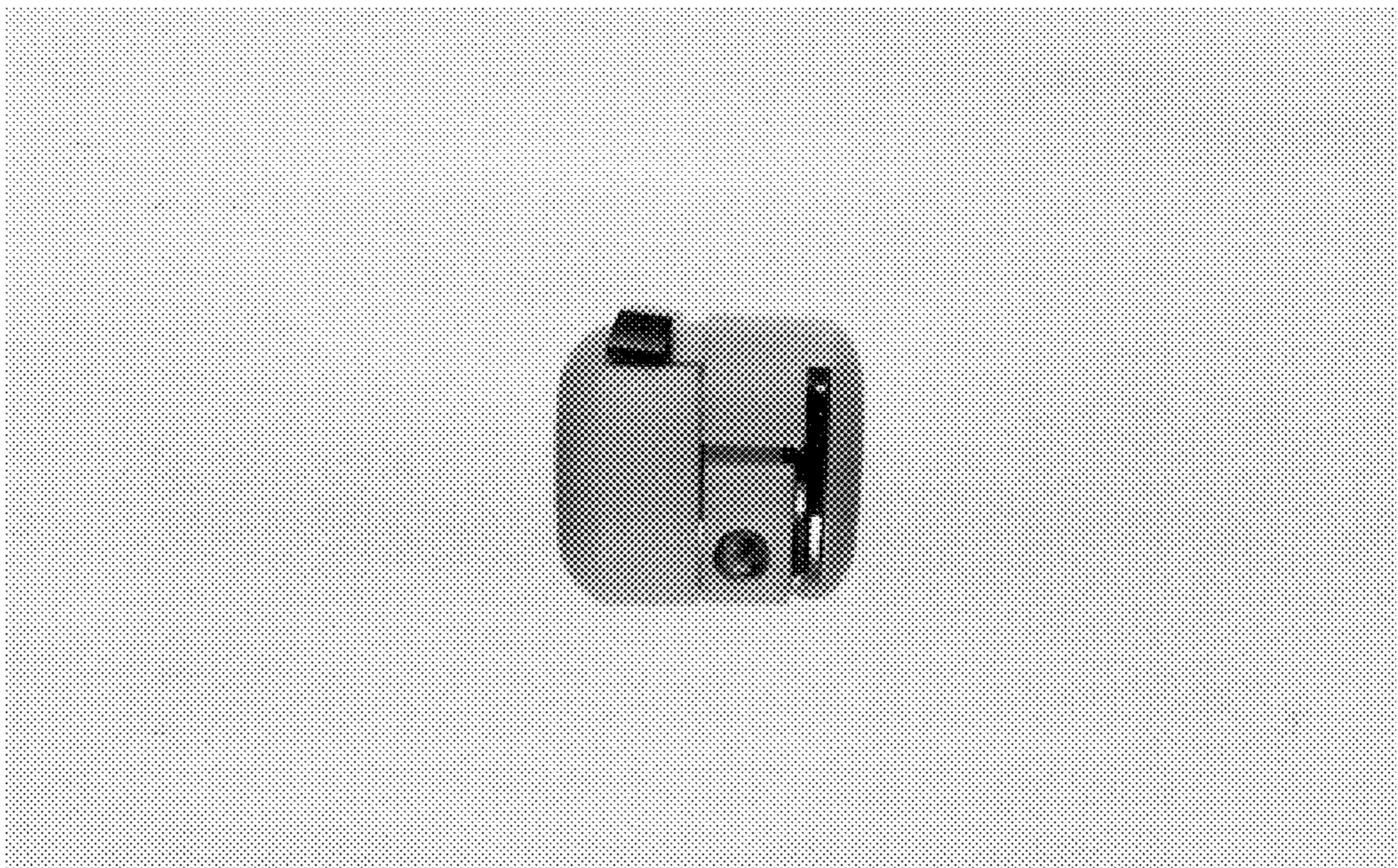

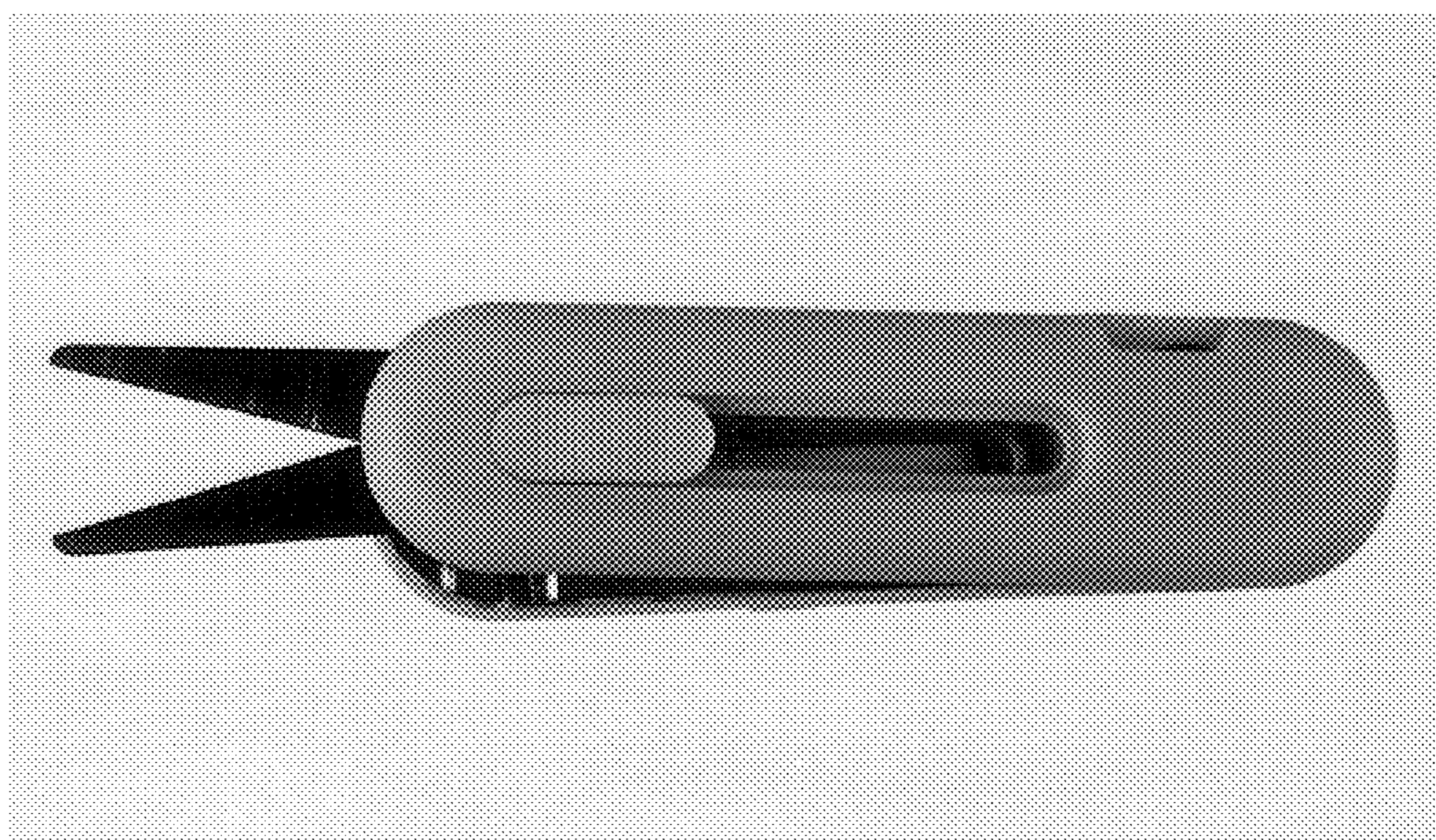

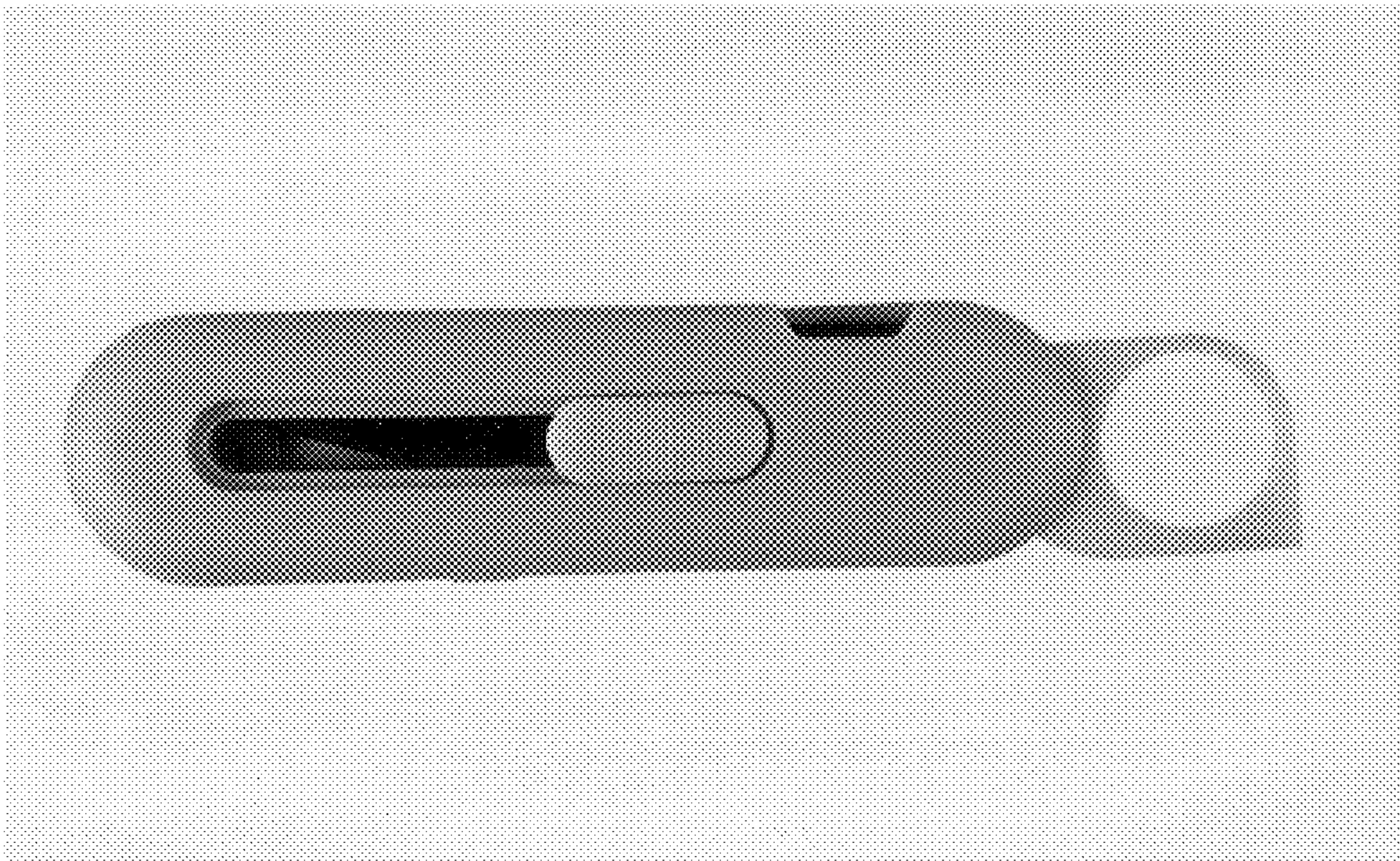

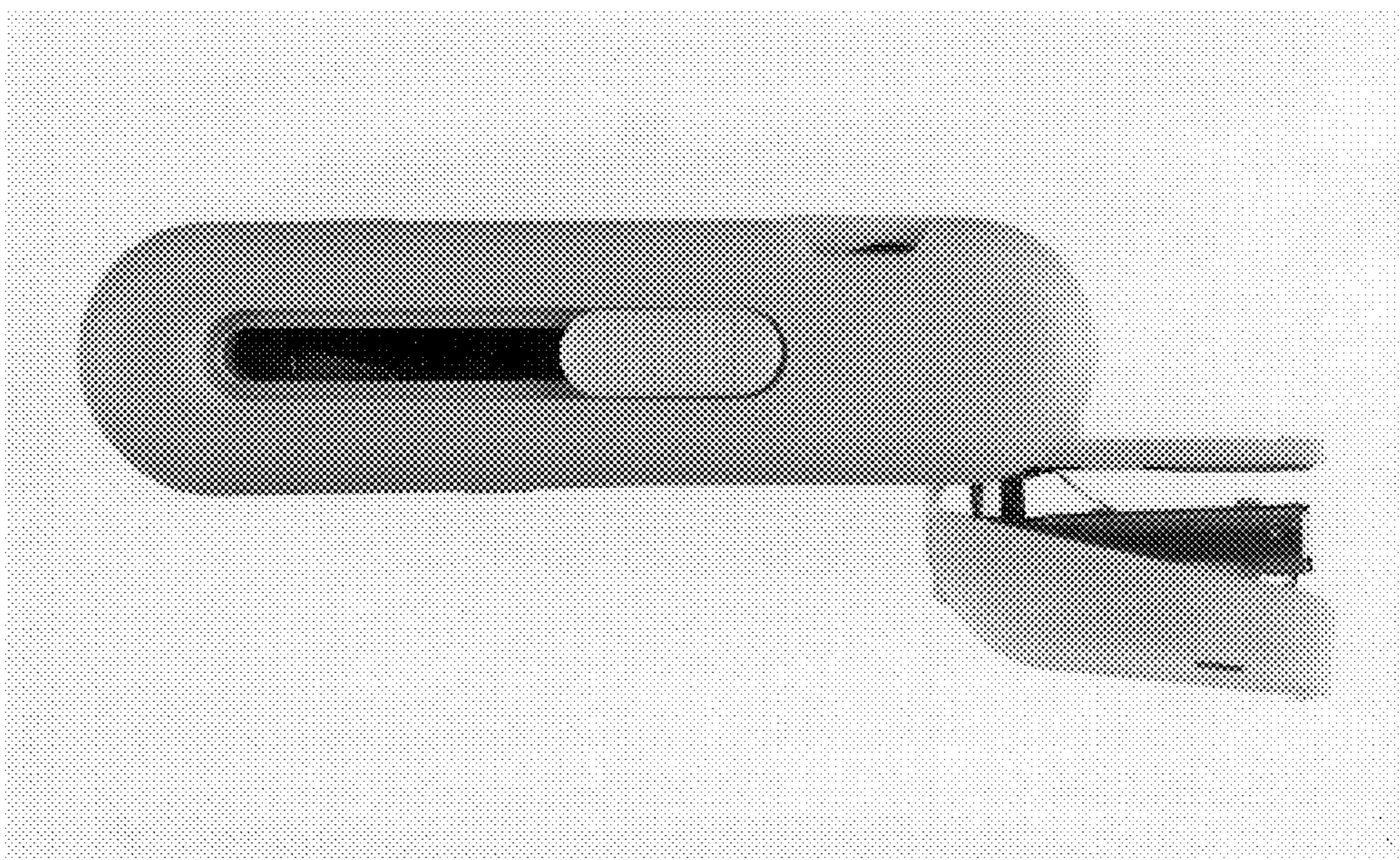

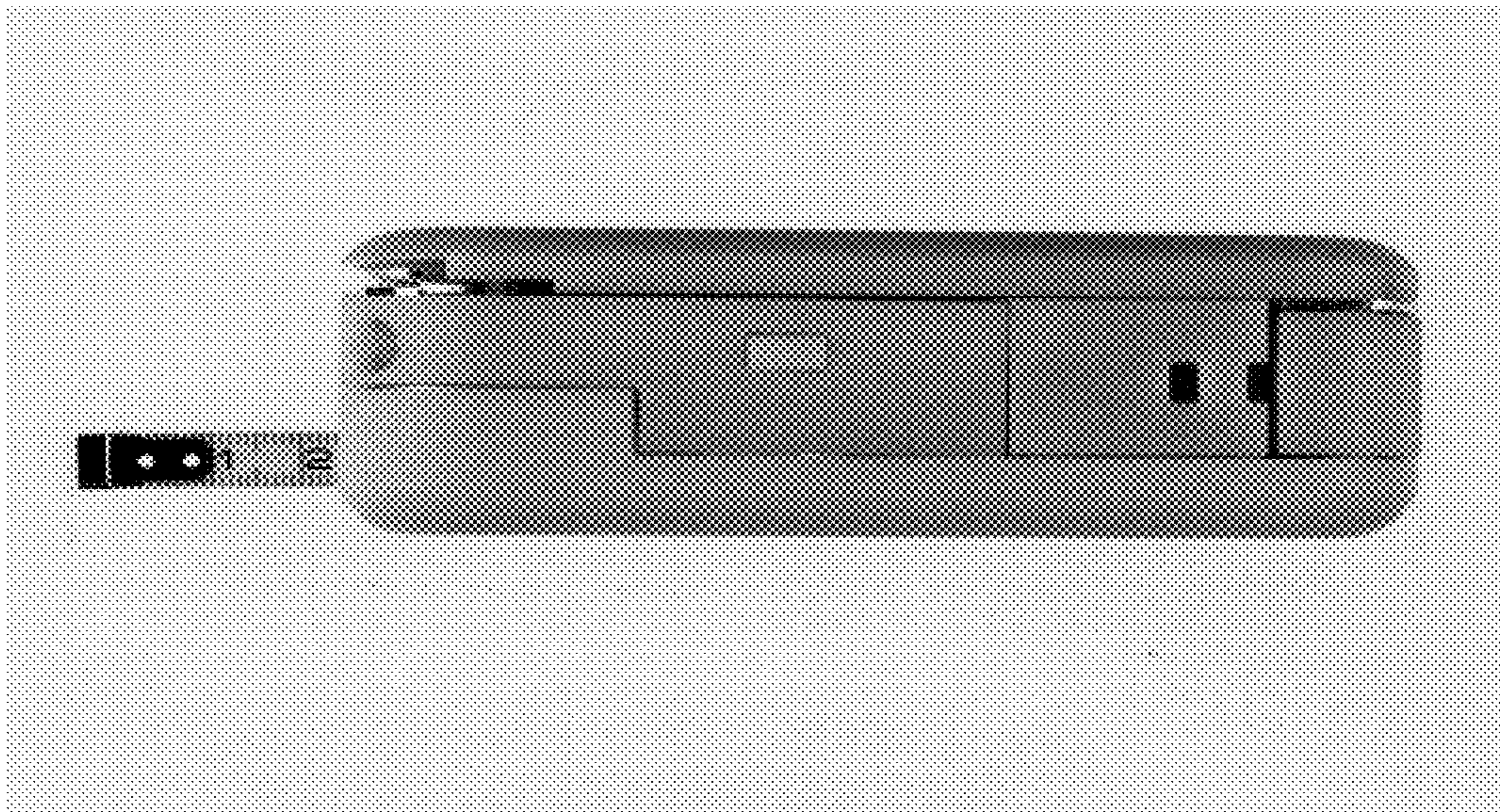

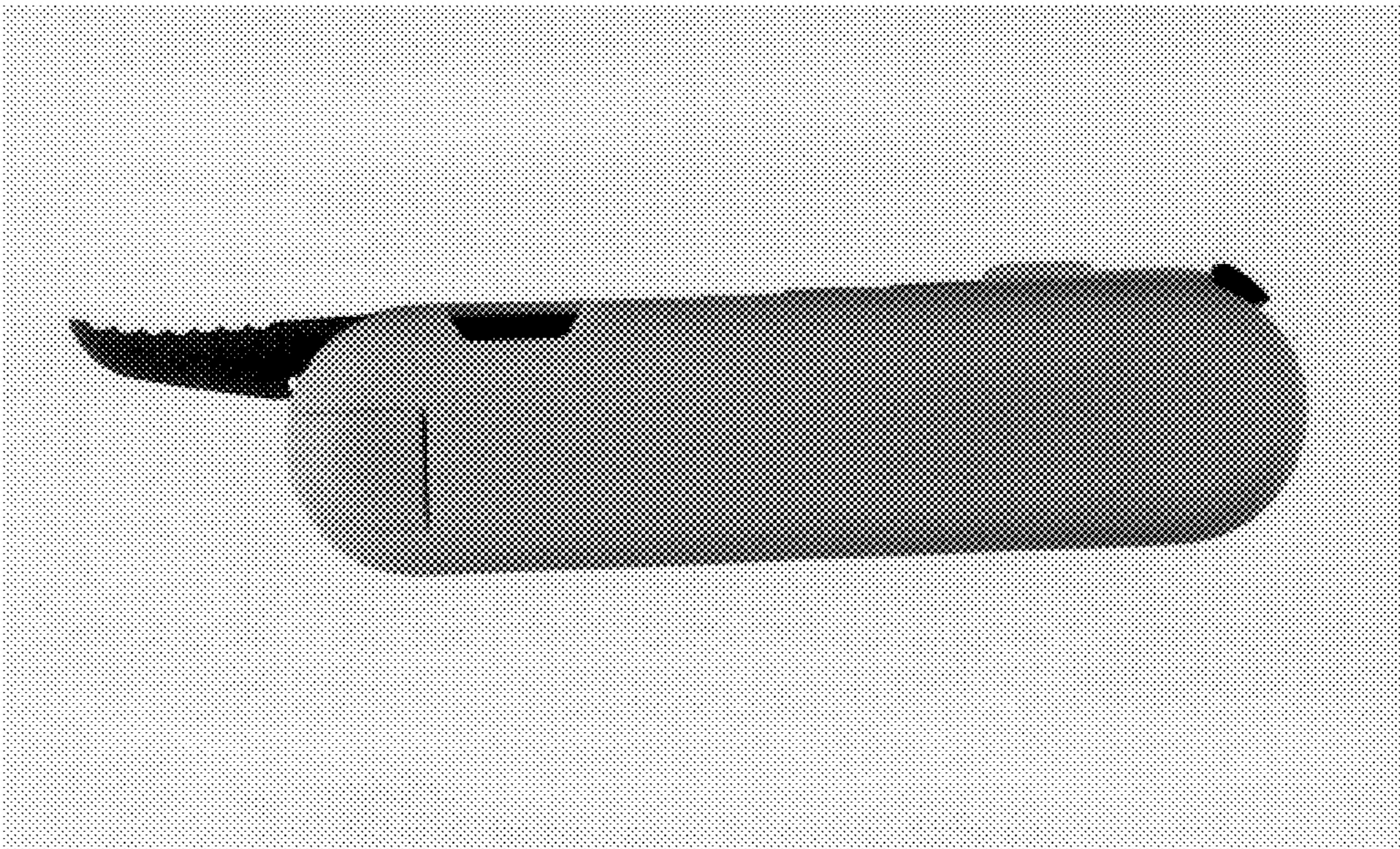

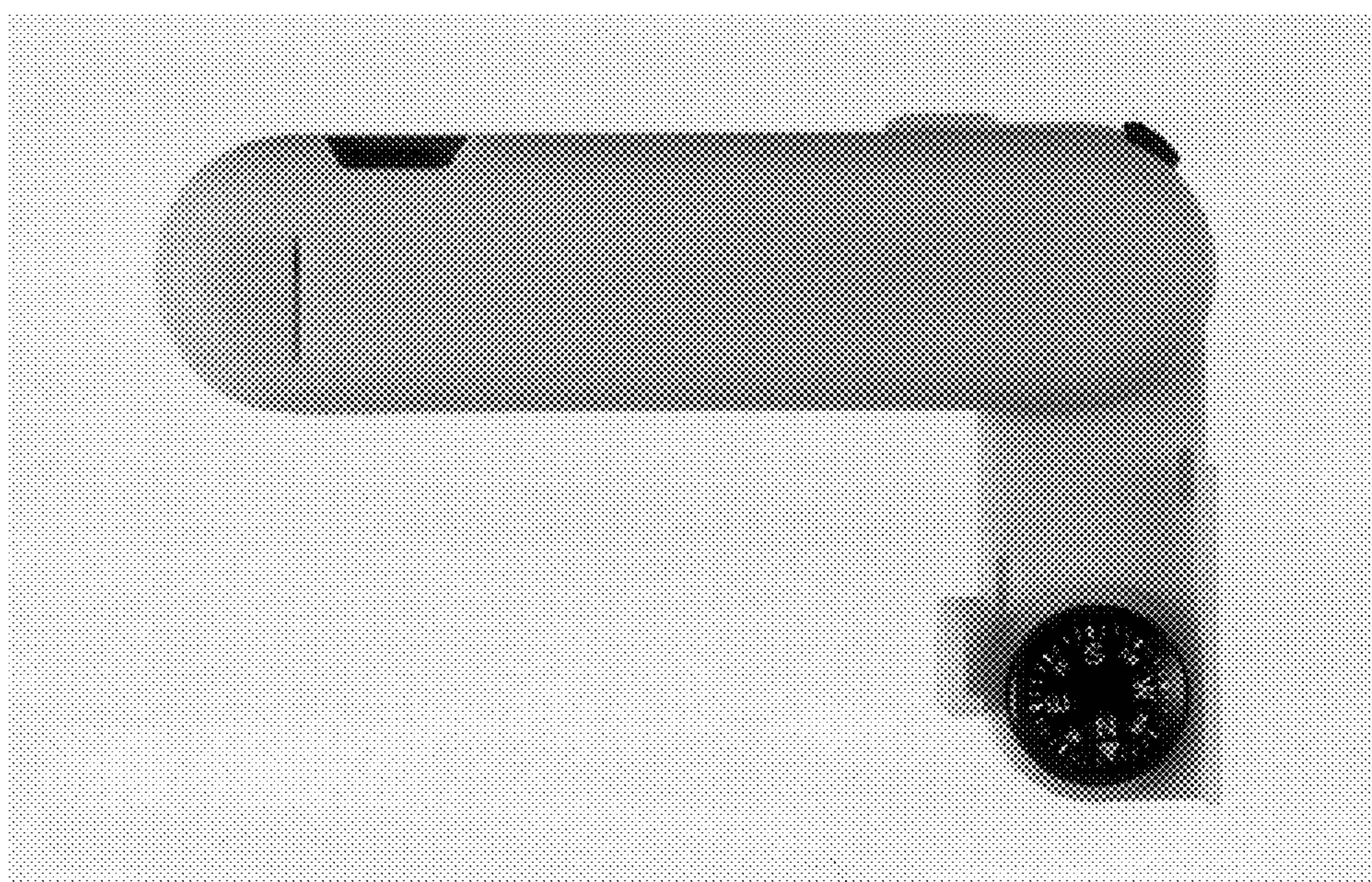

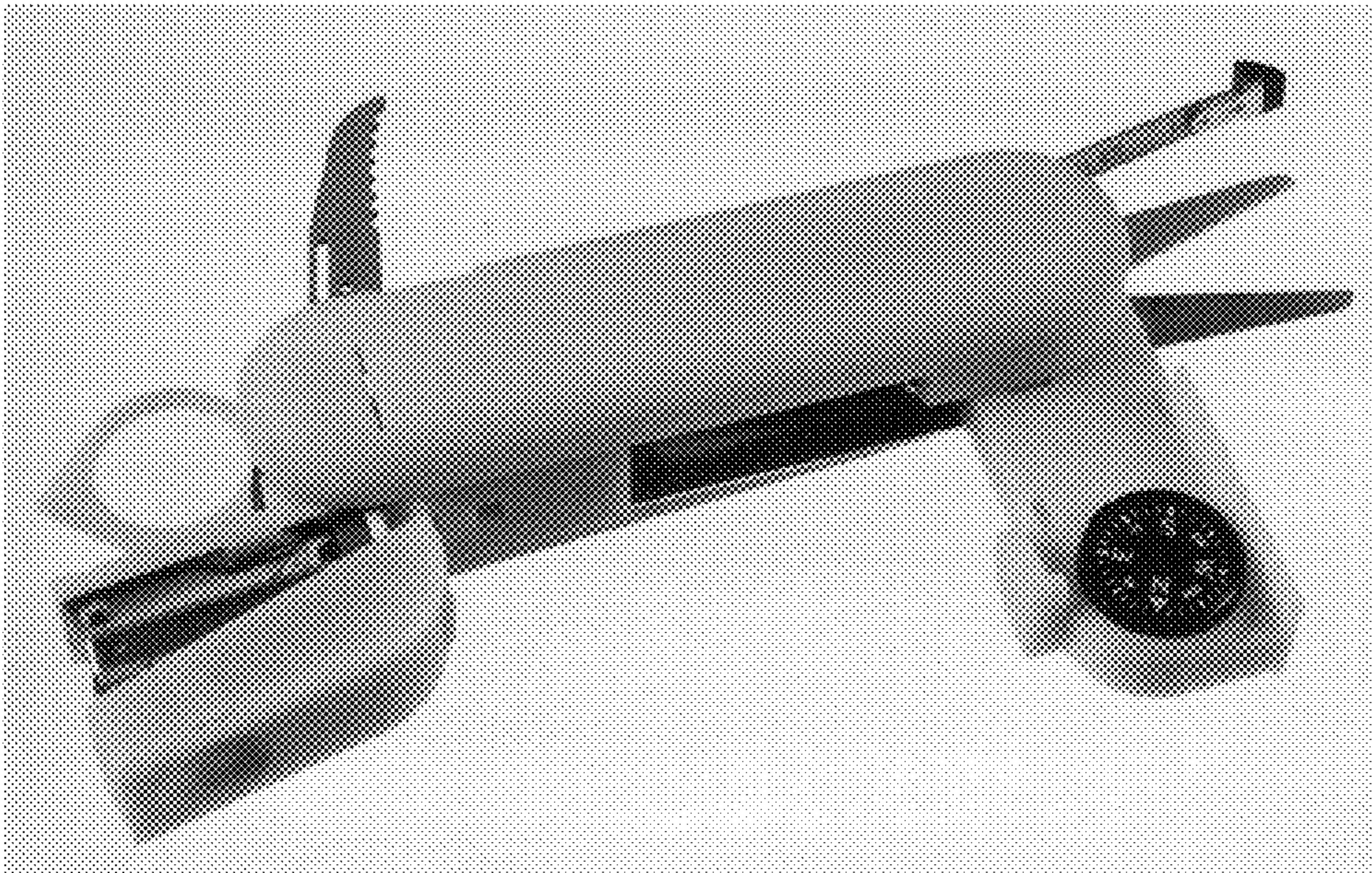

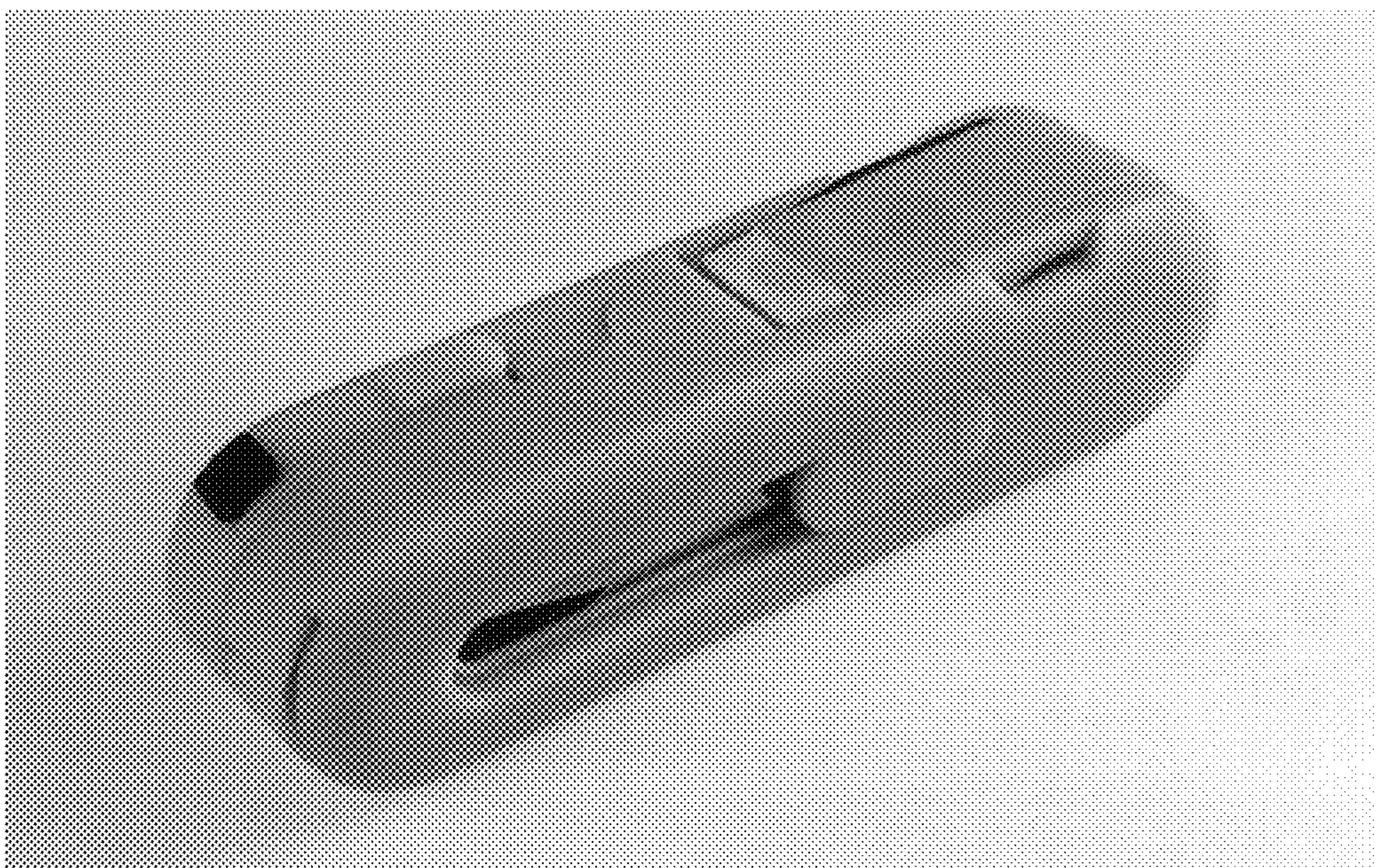
