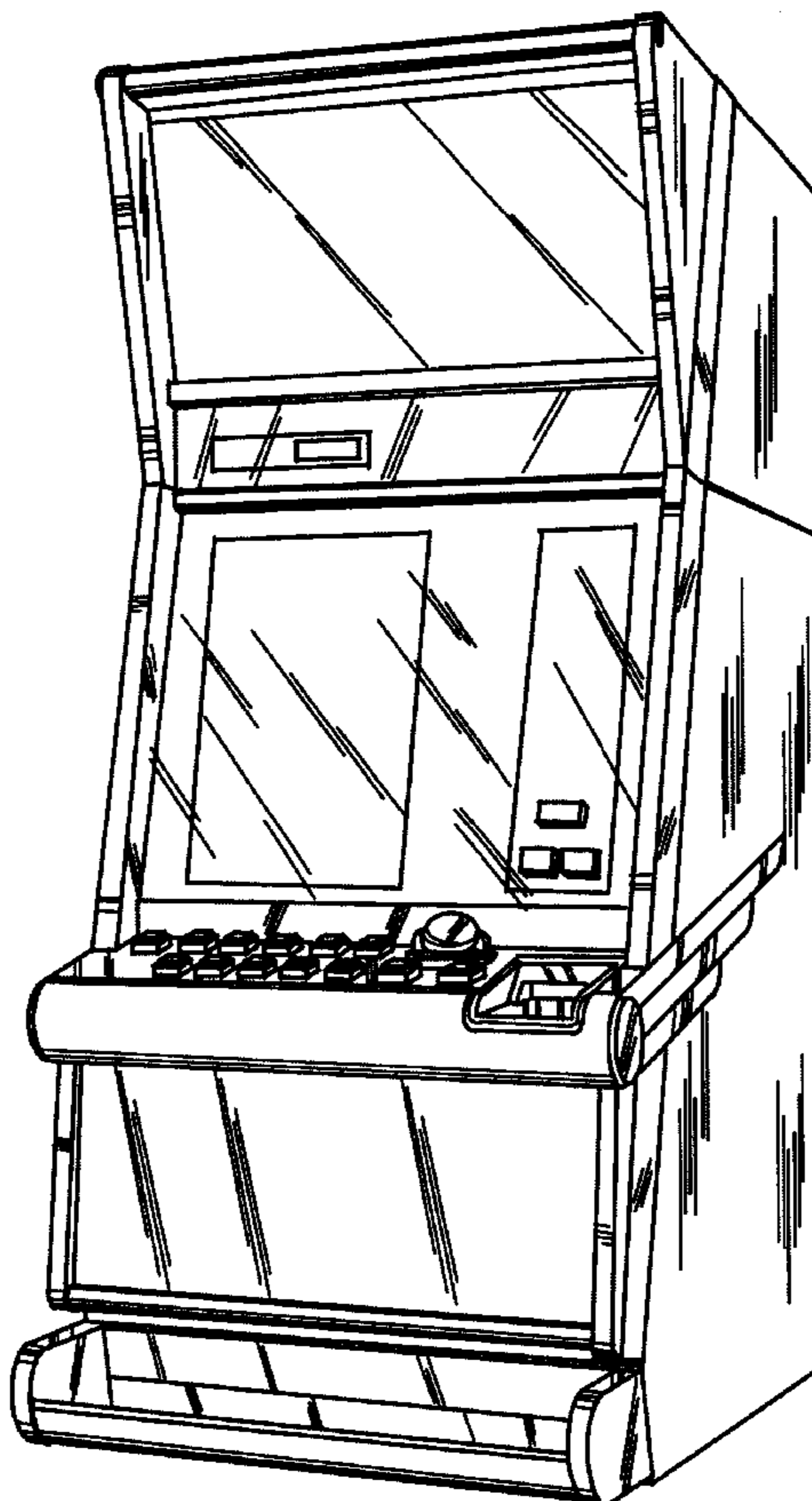
FIG. 1 is a perspective view of a first alternate embodiment of the winged game machine cabinet.

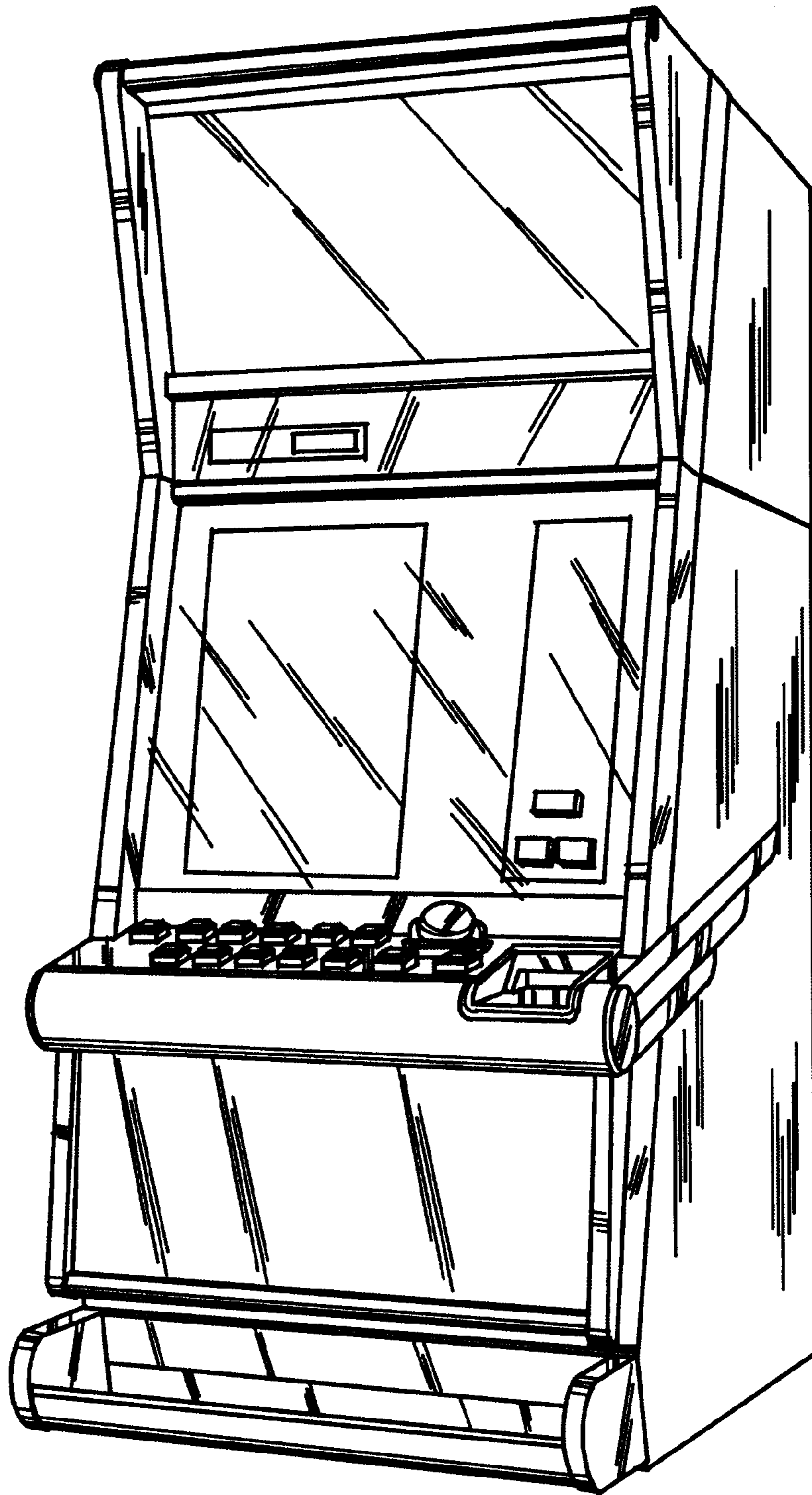

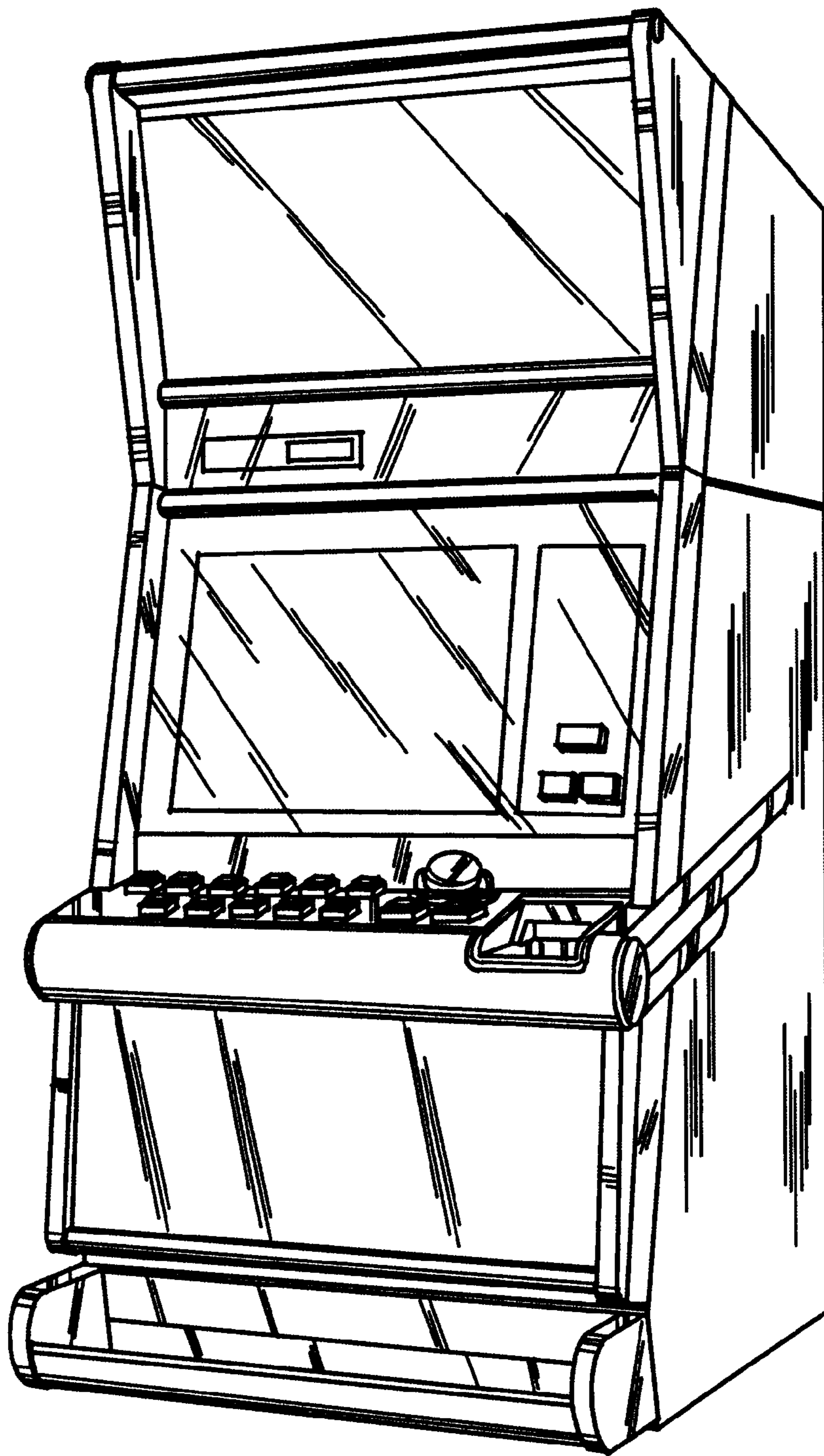

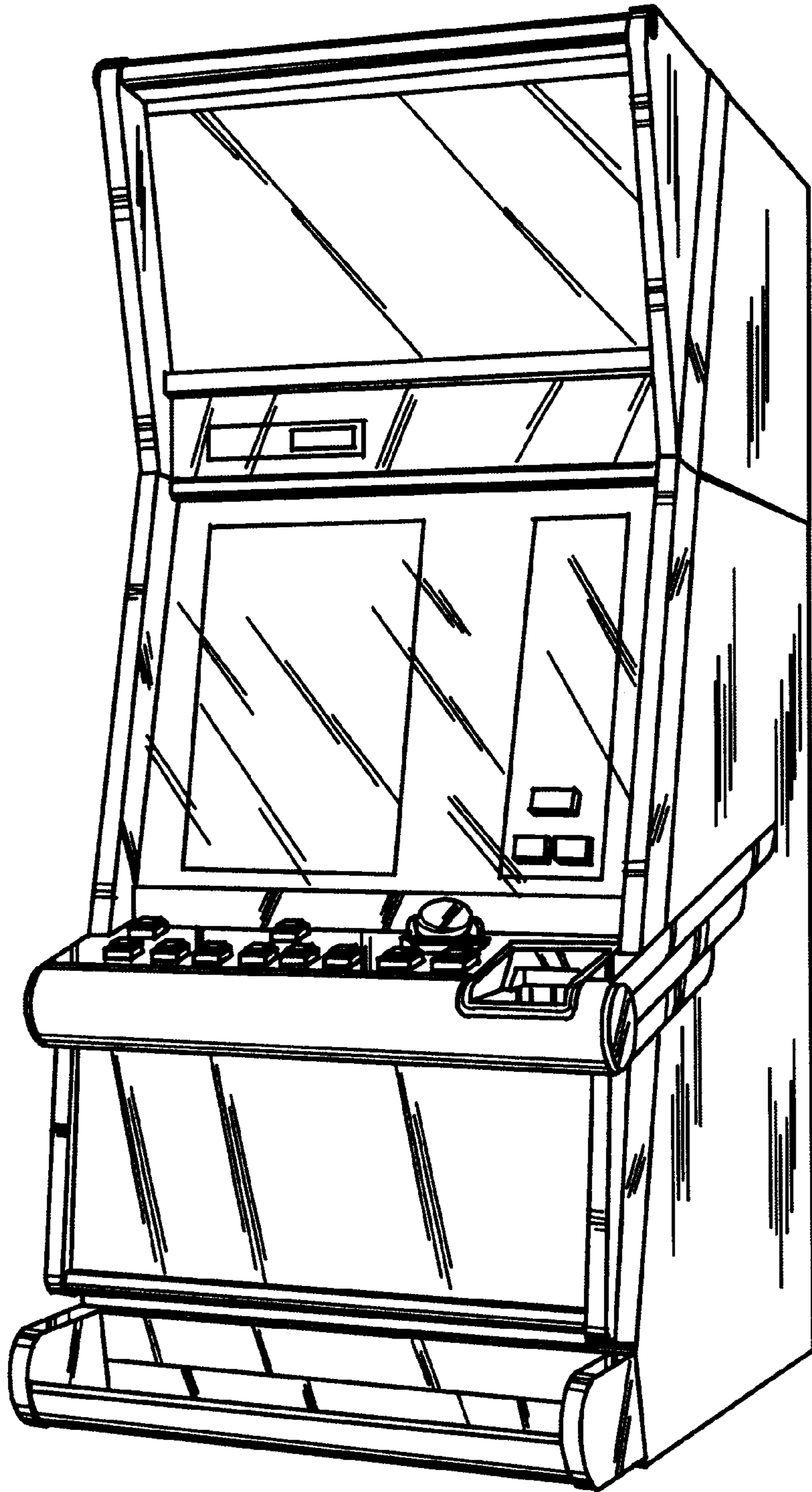

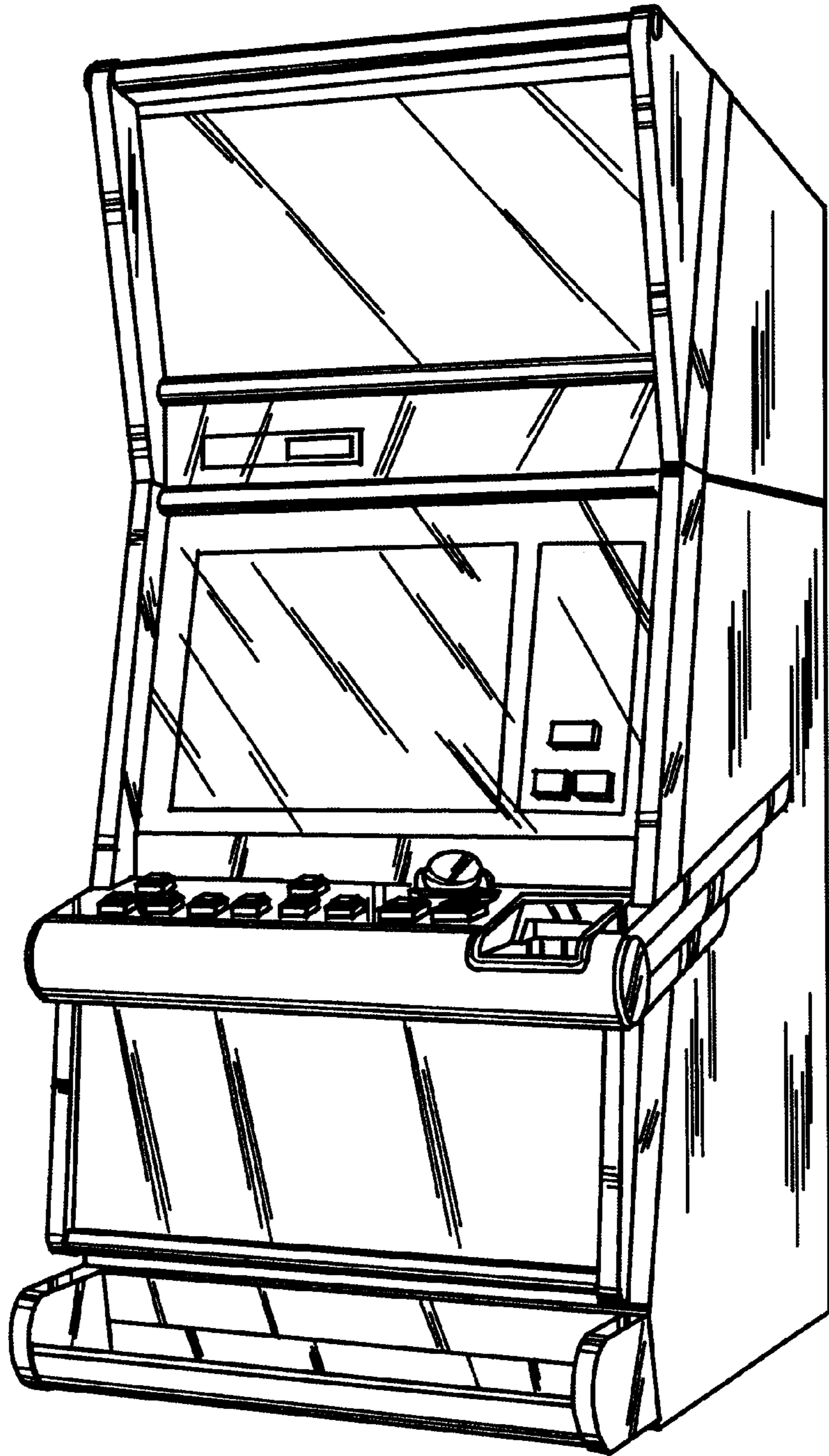

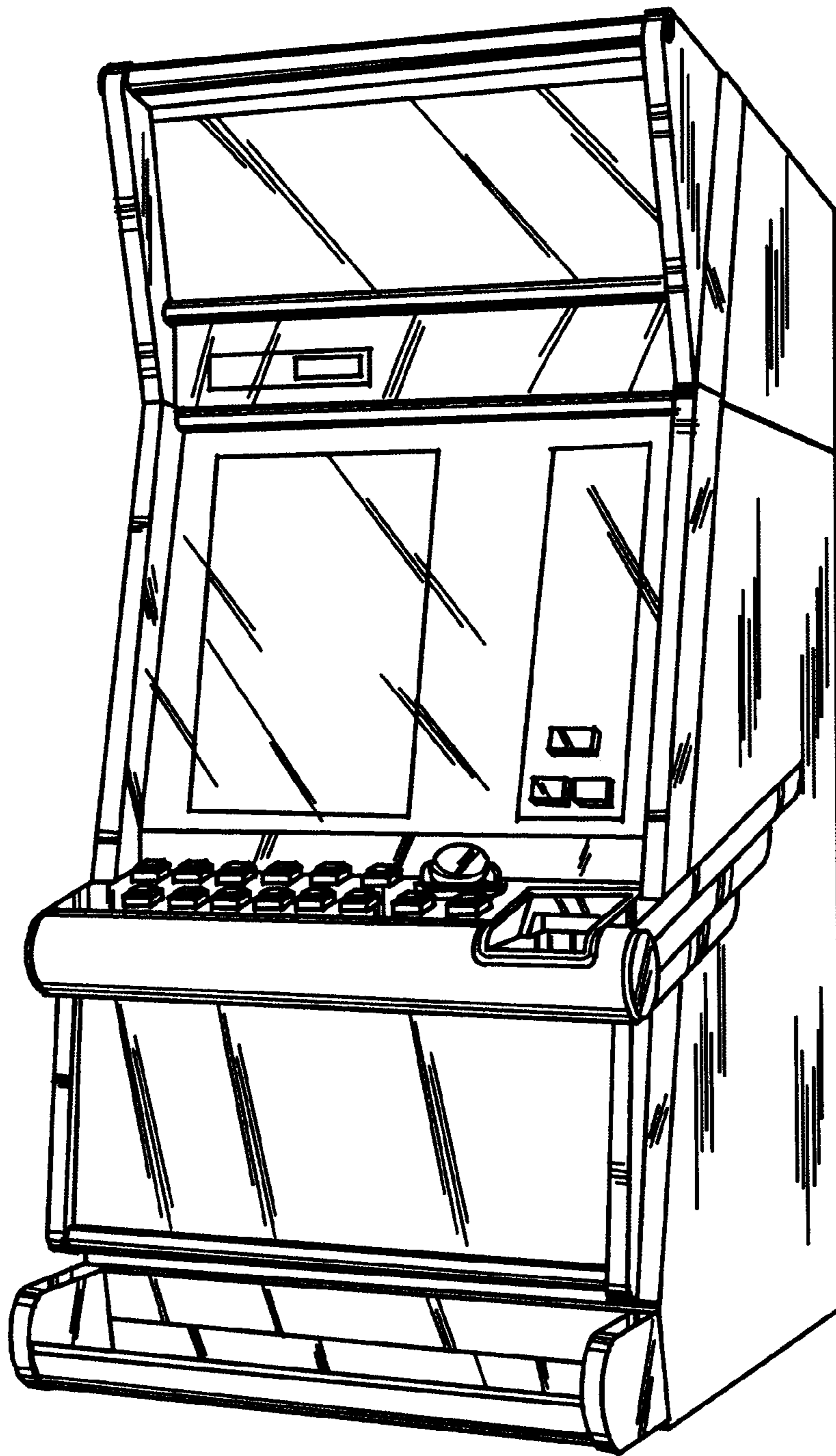

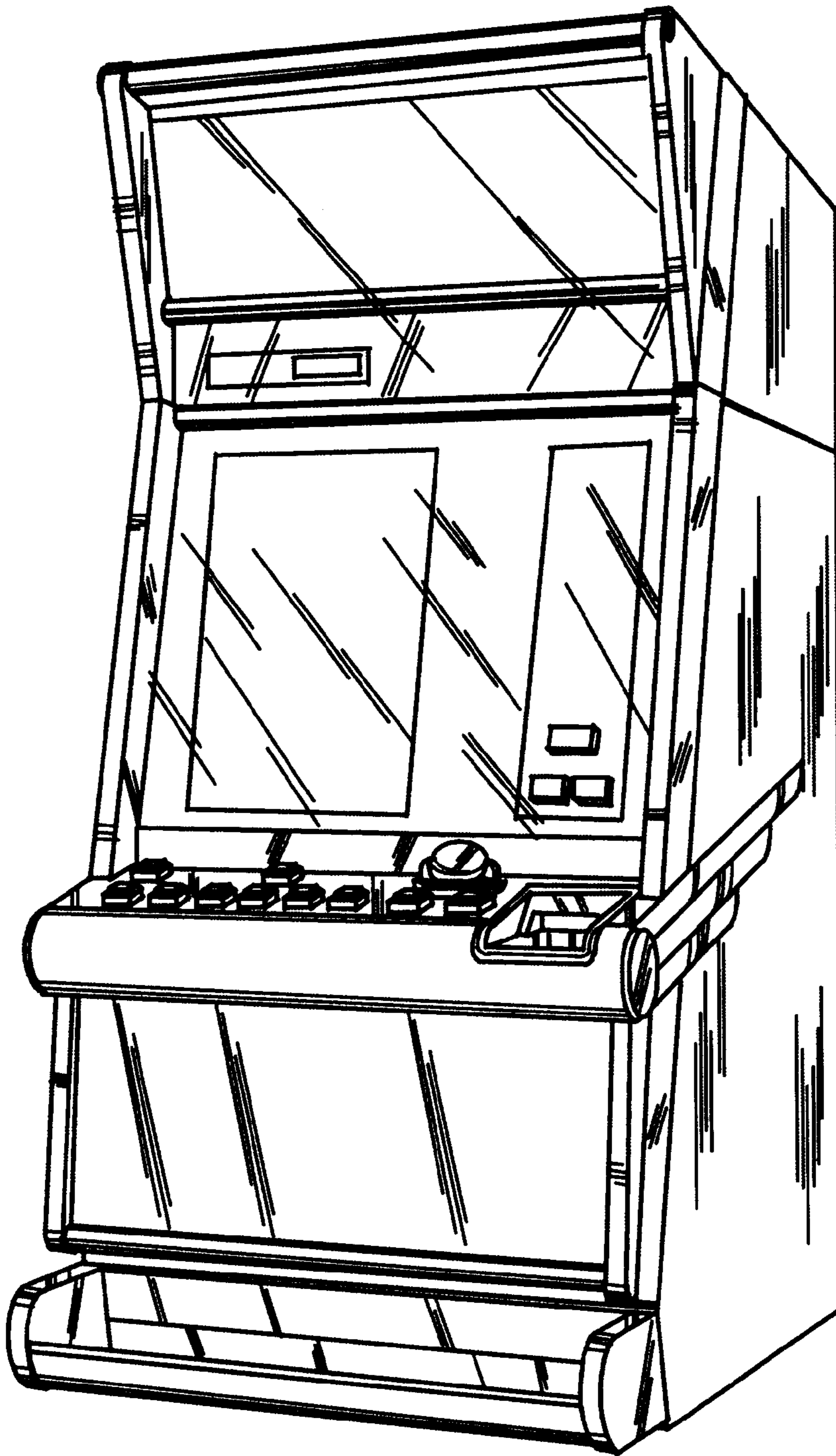
