(57) **CLAIM**

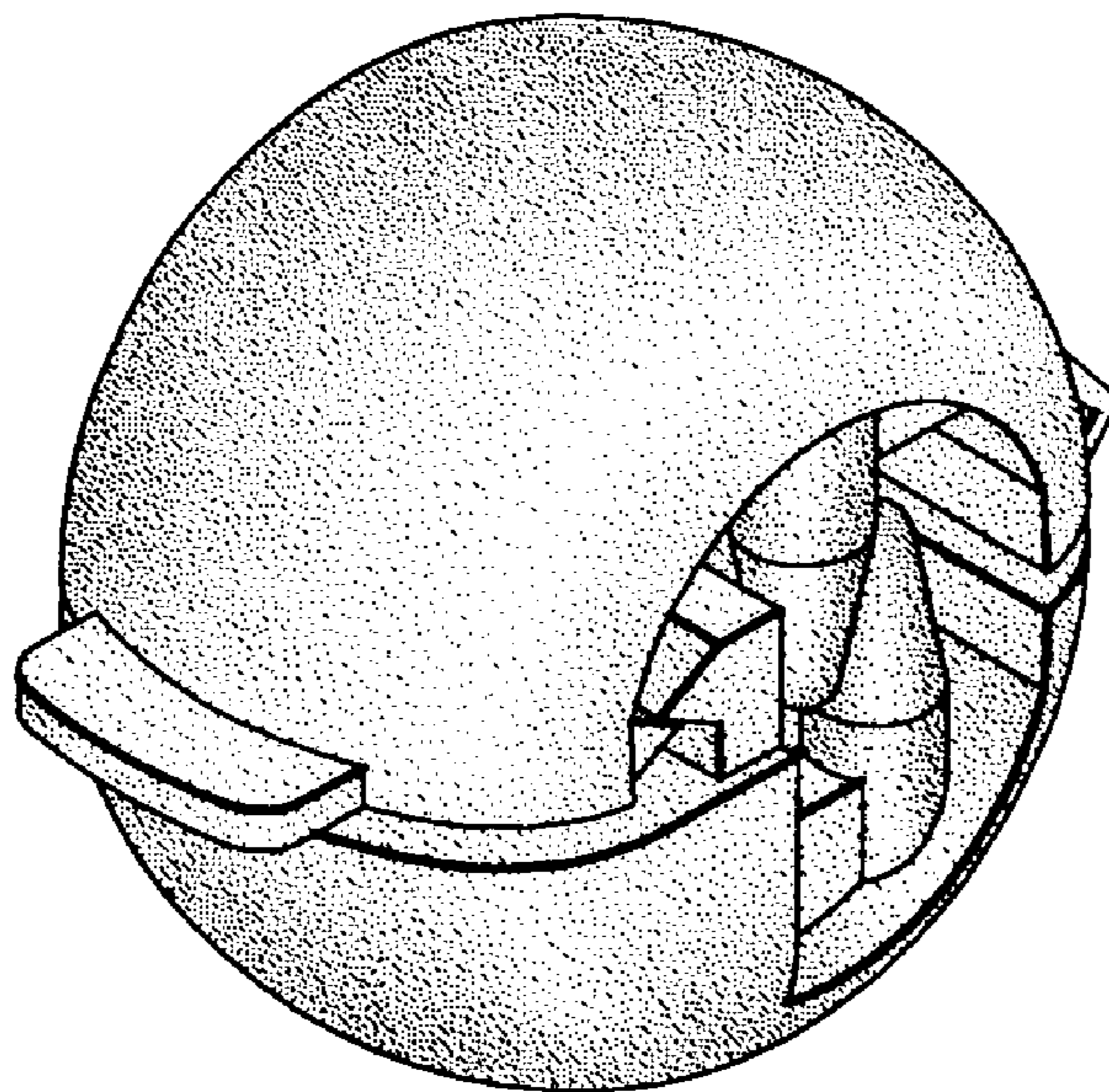
The ornamental design for a hair bead, as shown and described.

DESCRIPTION

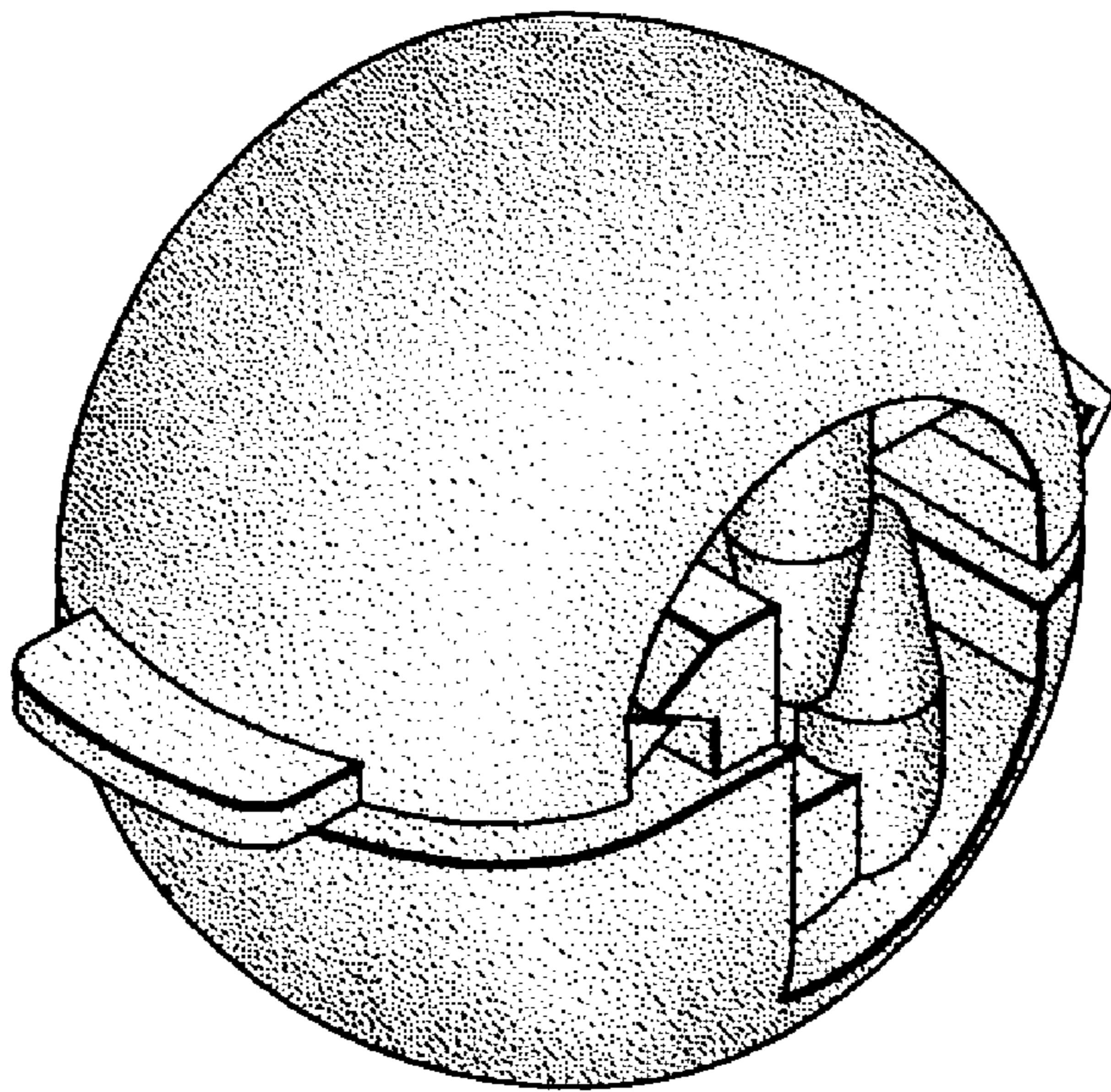

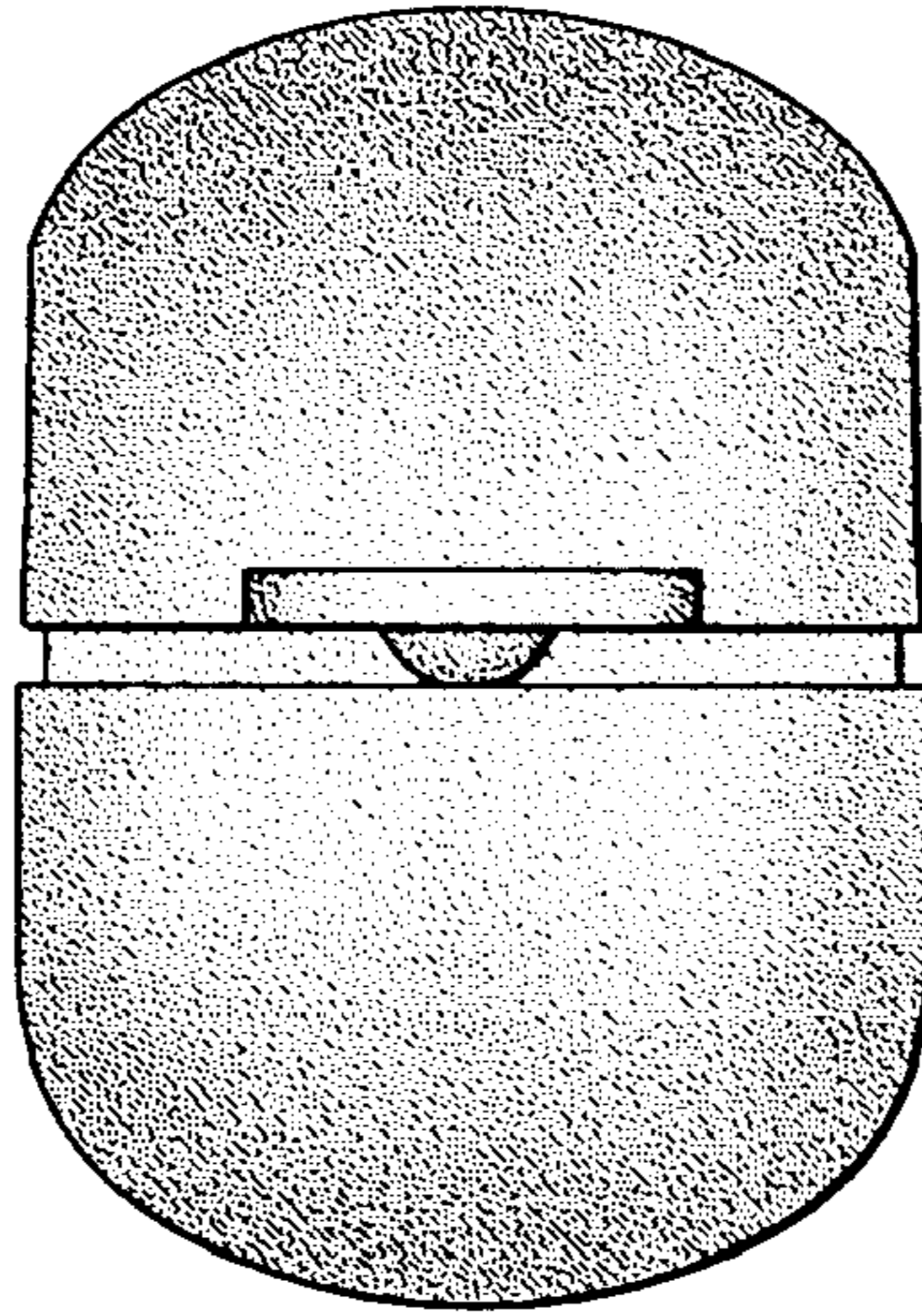

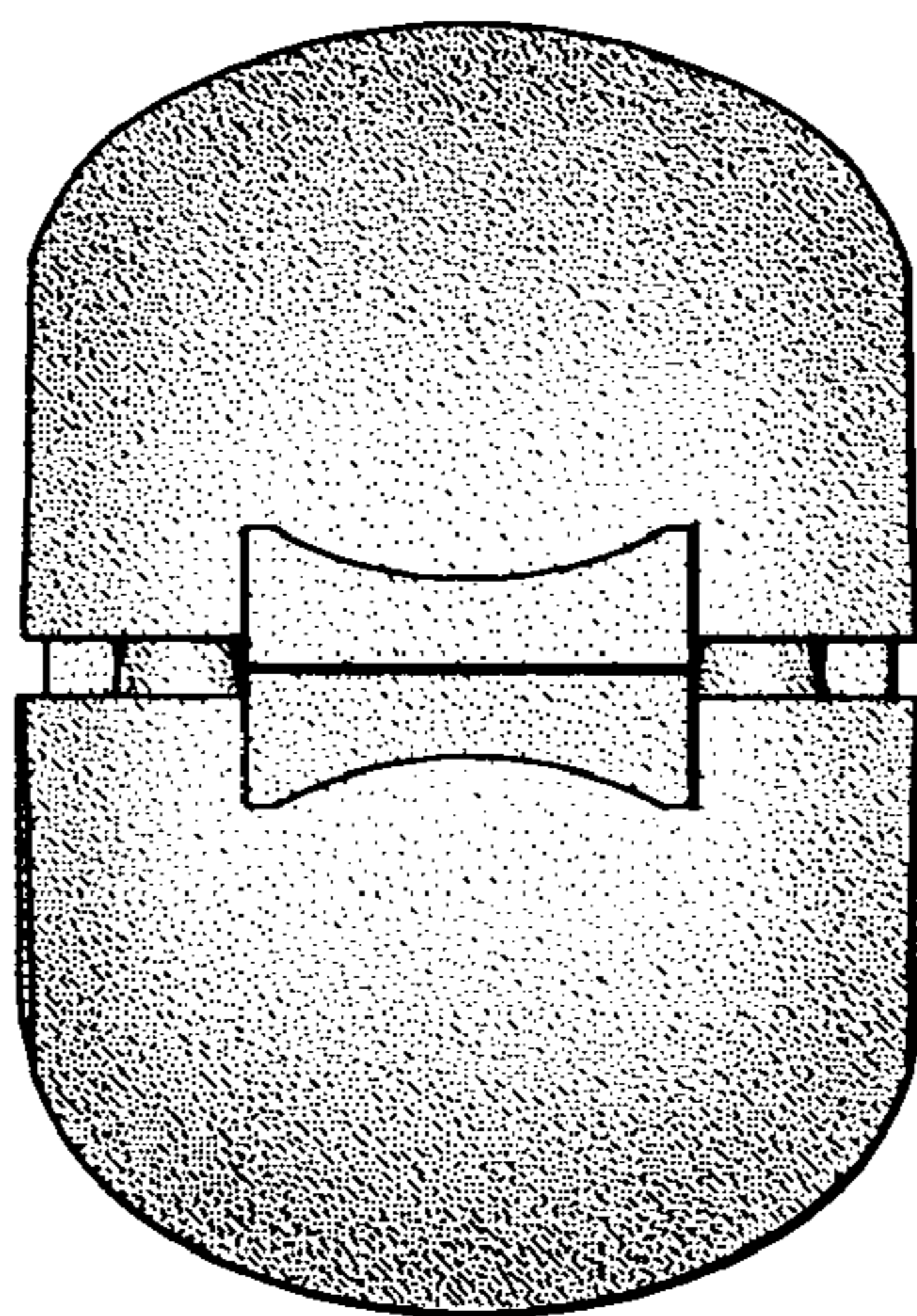

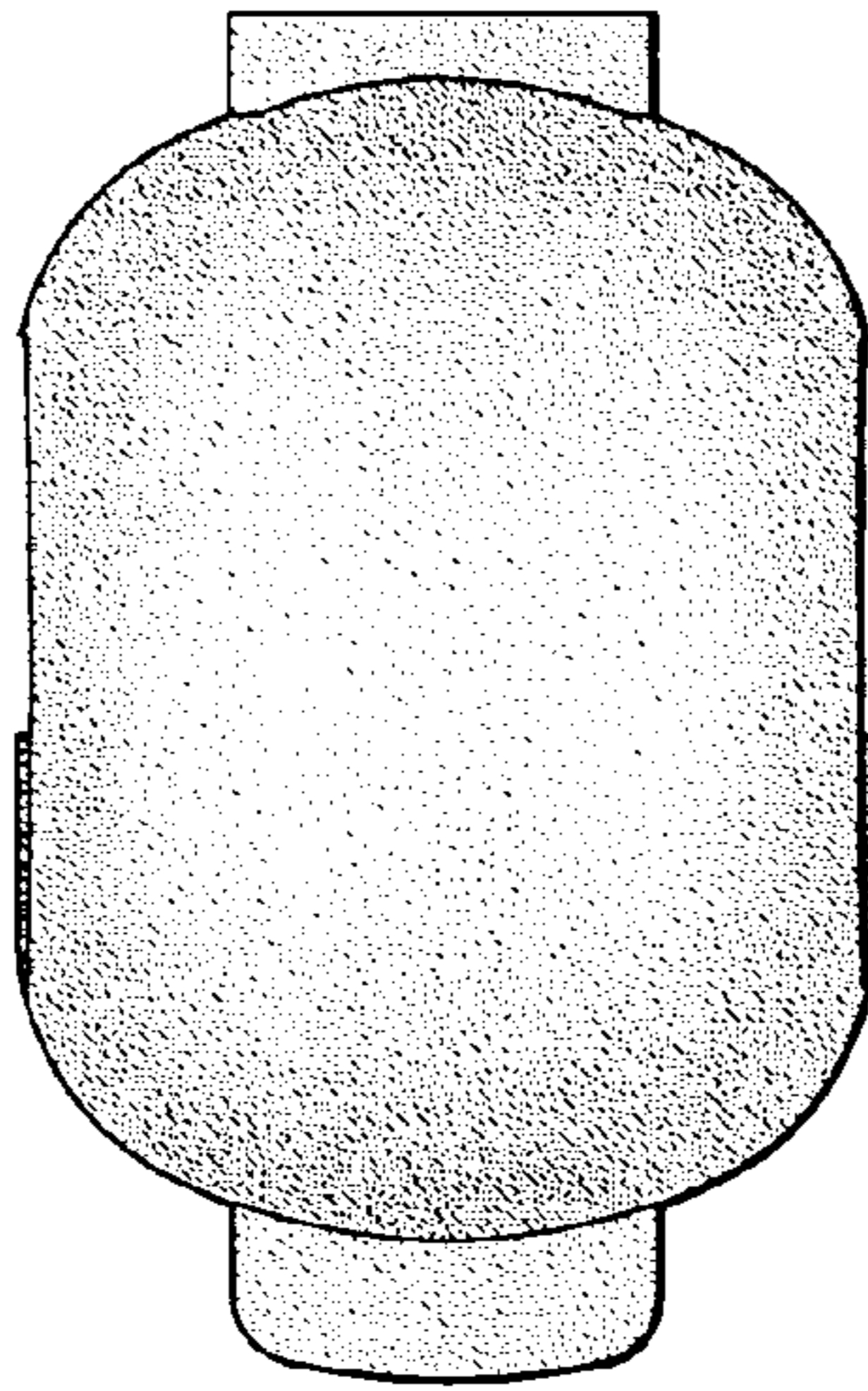

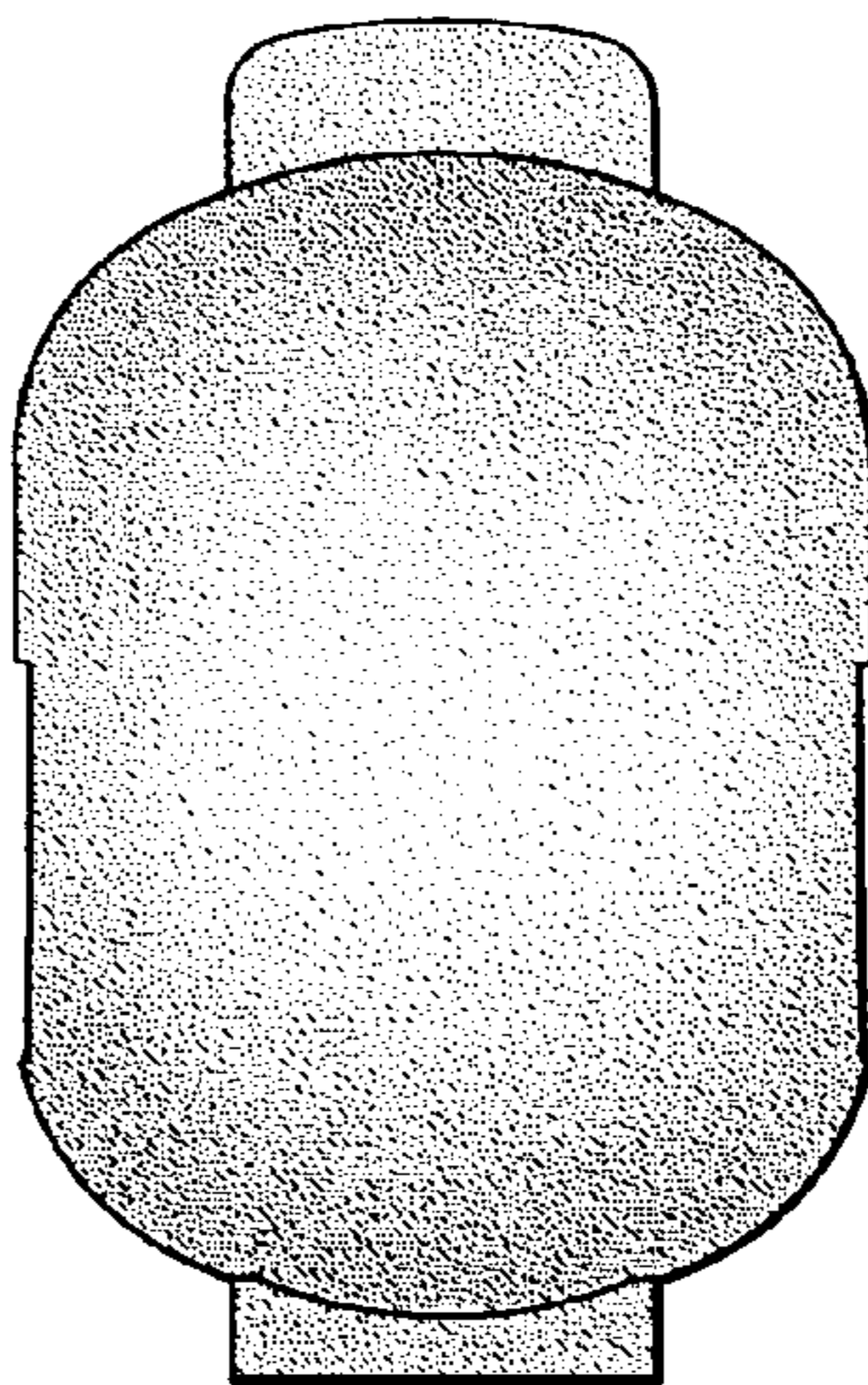

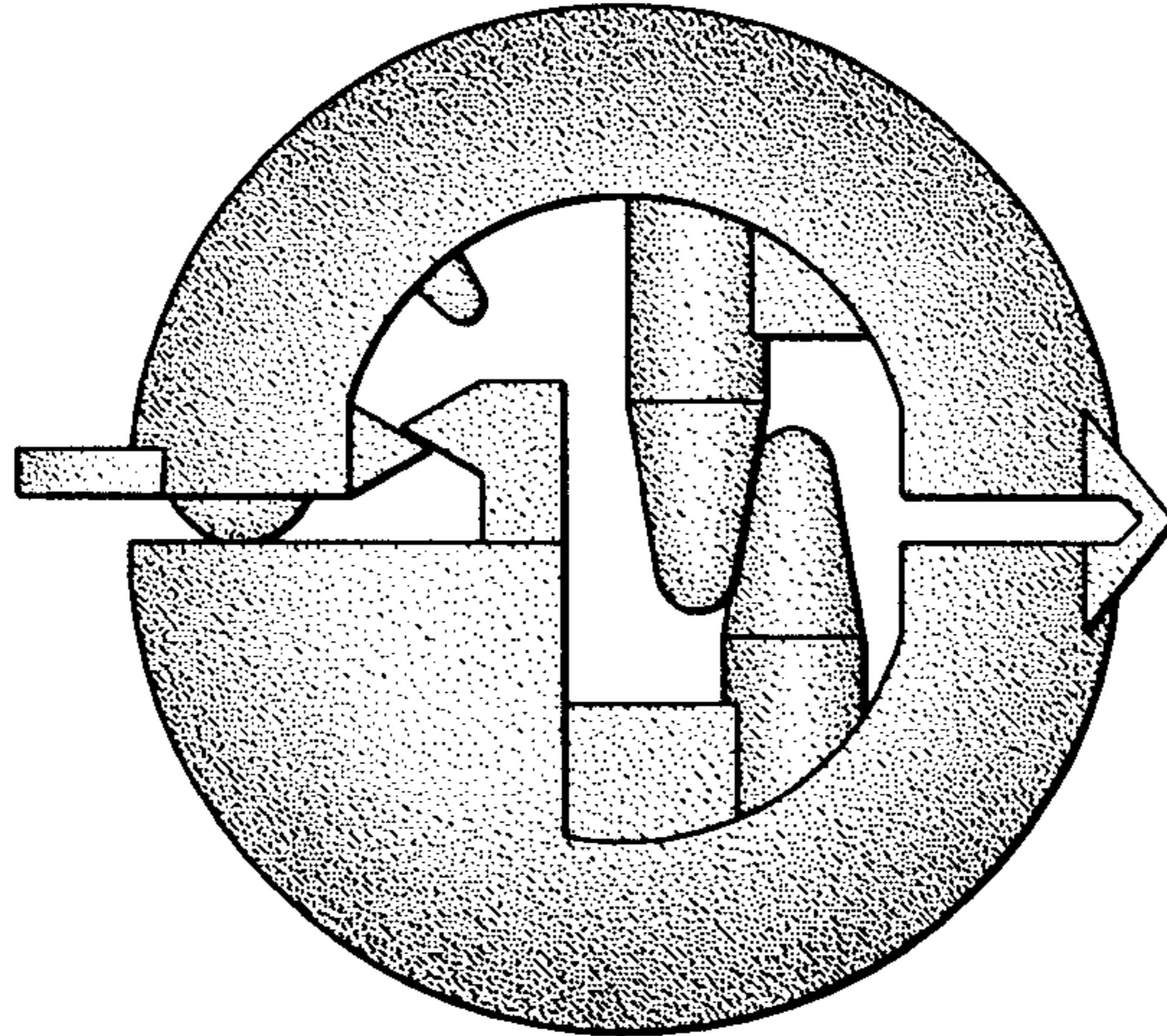

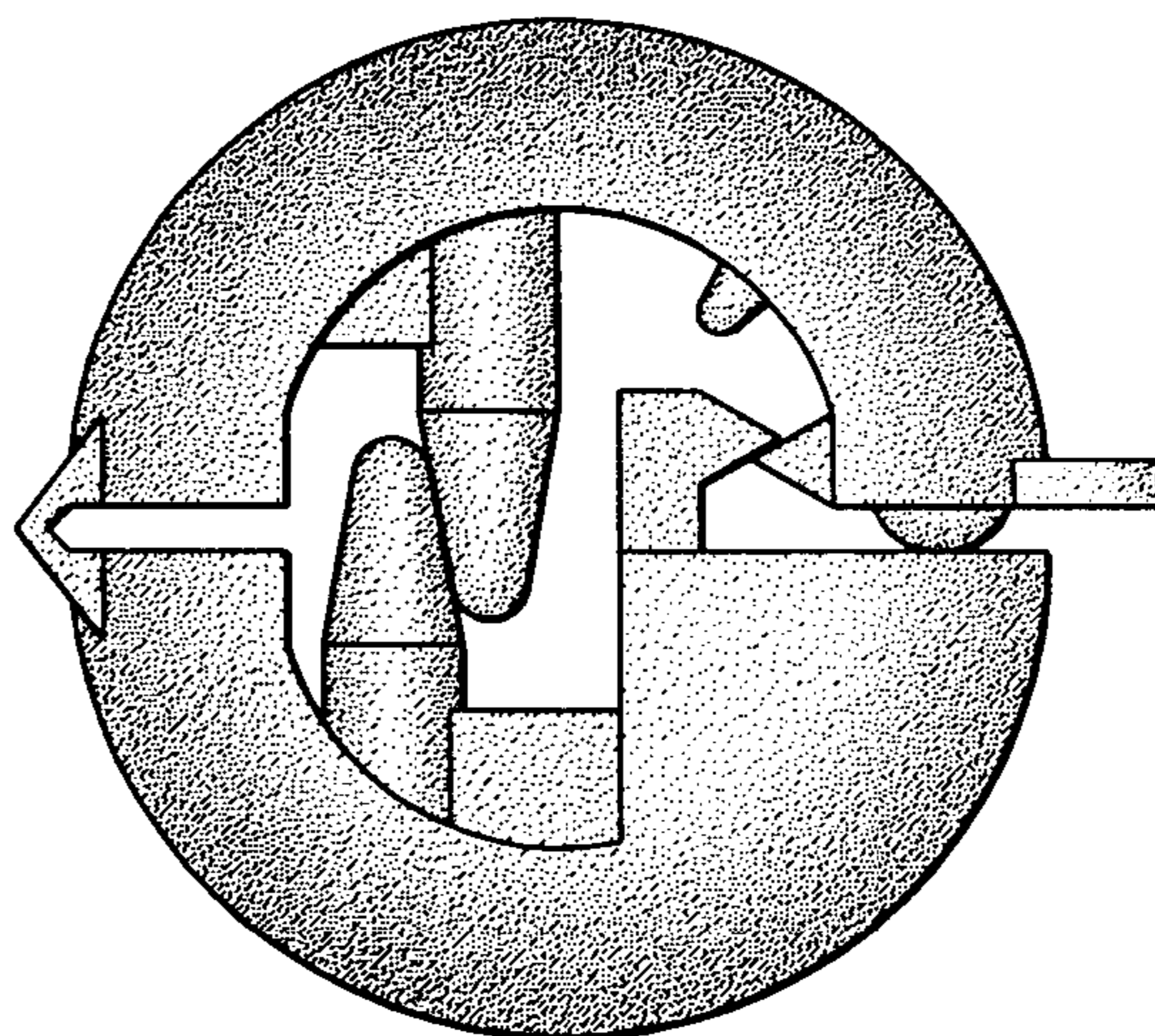
