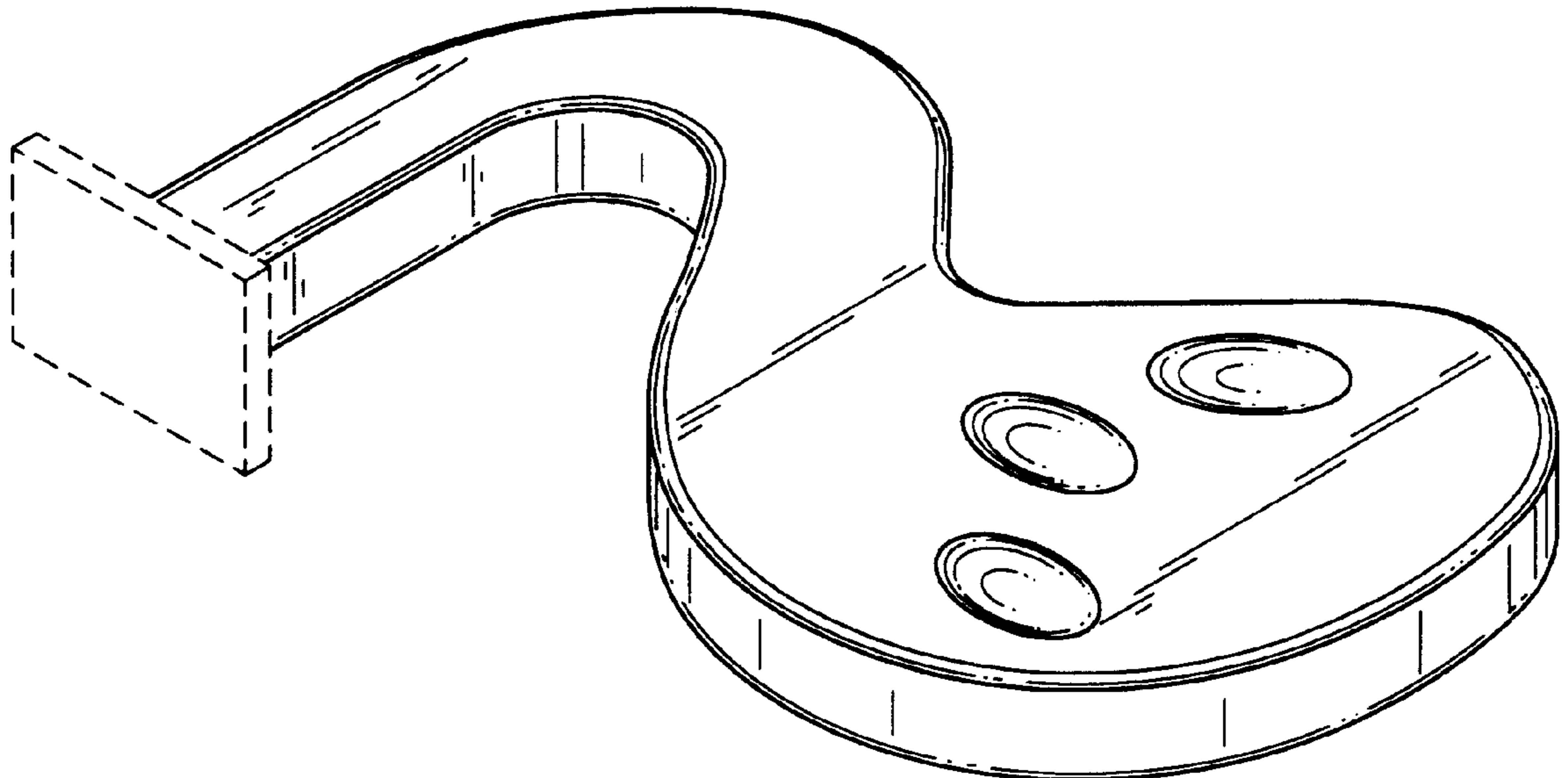
(57) **CLAIM**

The ornamental design for razor handle, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of a razor handle showing my new design;  
 FIG. 2 is a top plan view of the razor handle of FIG. 1;  
 FIG. 3 is a bottom plan view of the razor handle of FIGS. 1 and 2;  
 FIG. 4 is a rear elevation view of the razor handle of FIGS. 1, 2 and 3;  
 FIG. 5 is a front elevation view of the razor handle of FIGS. 1 through 4;  
 FIG. 6 is a right side elevation view of the razor handle of FIGS. 1 through 5; and,  
 FIG. 7 is a left side elevation view of the razor handle of FIGS. 1 through 6.  
 I further disclaim and do not include as part of my invention the razor head, which is shown with broken lines, which are included to show the environment in which the design is used.

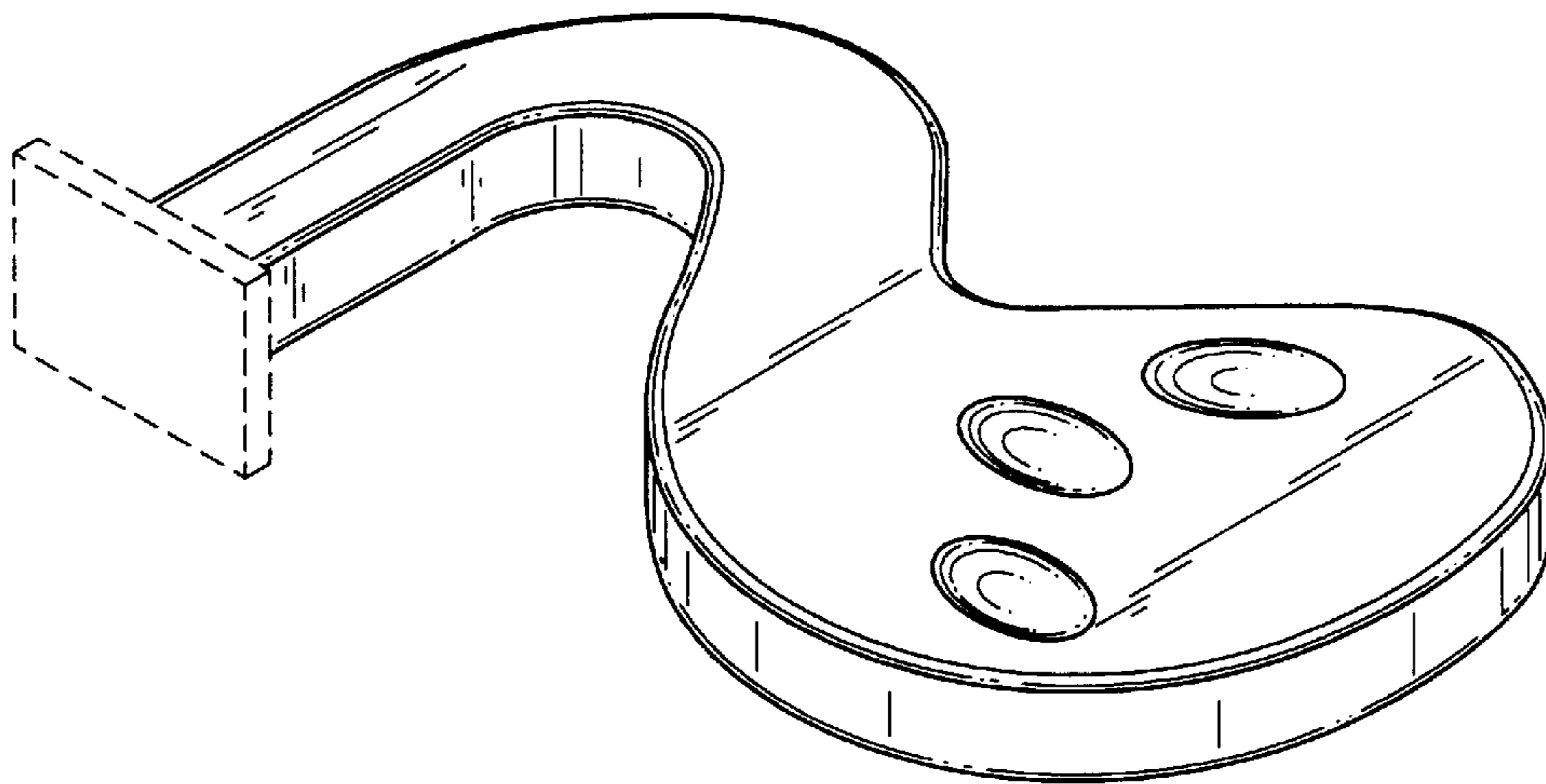

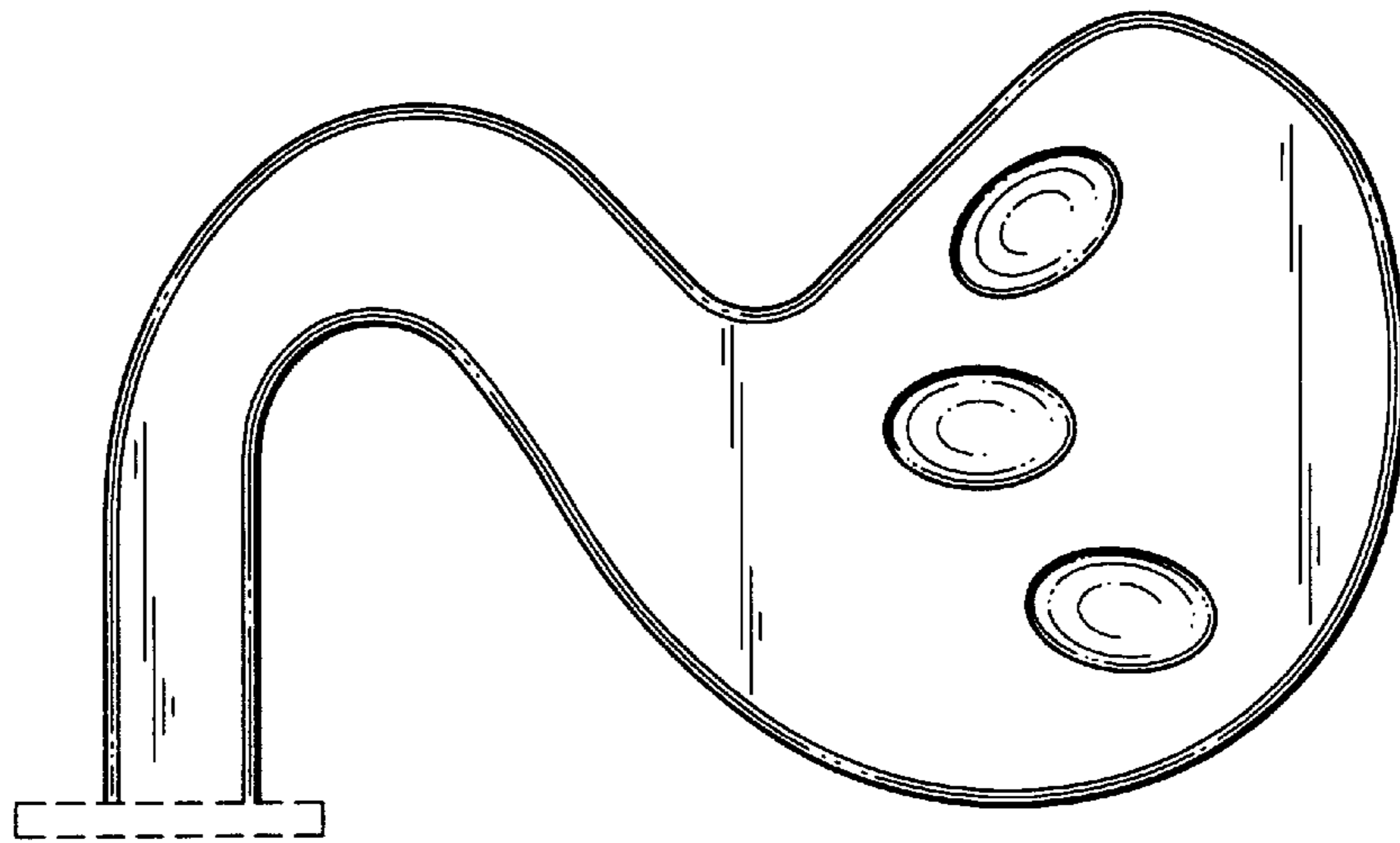

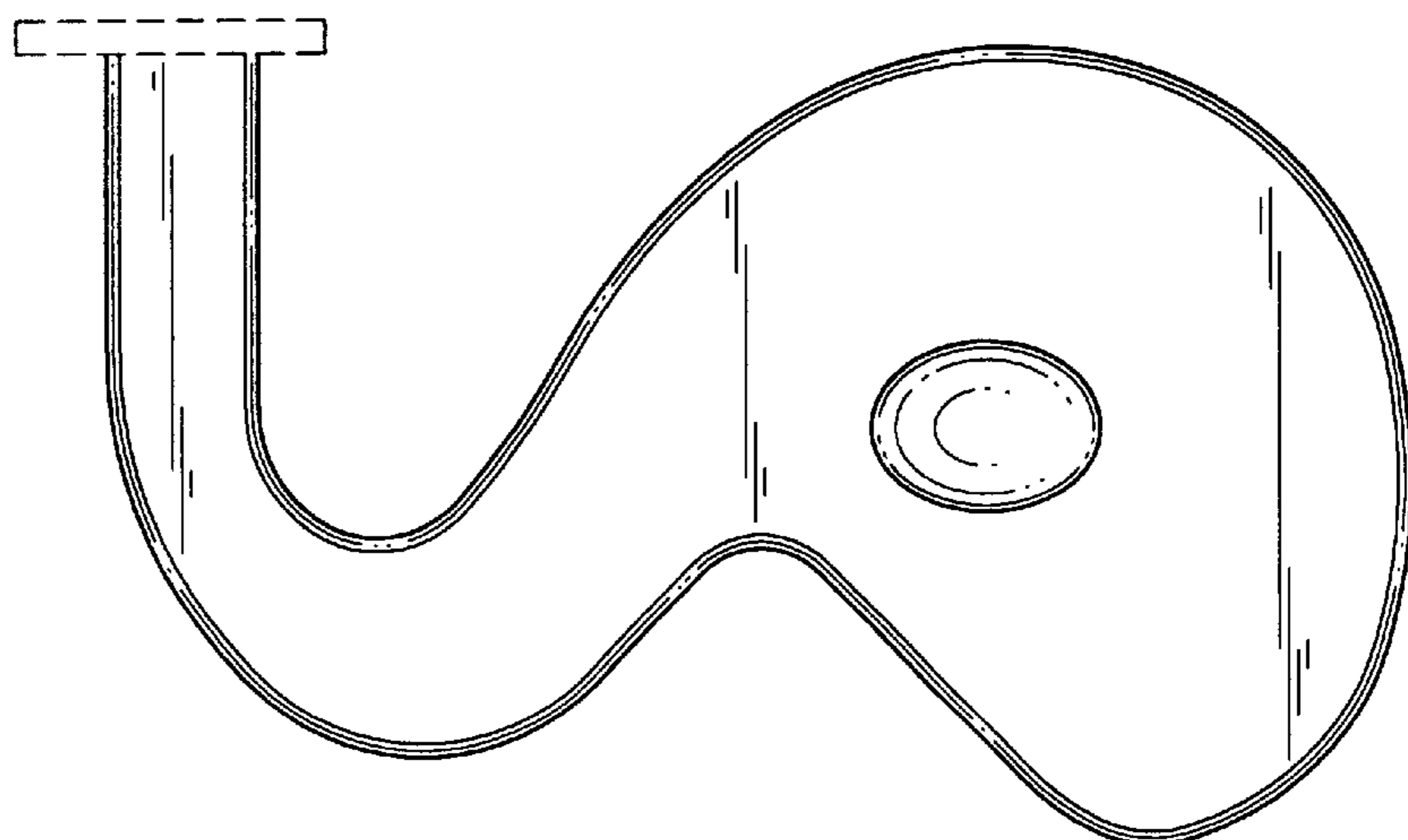

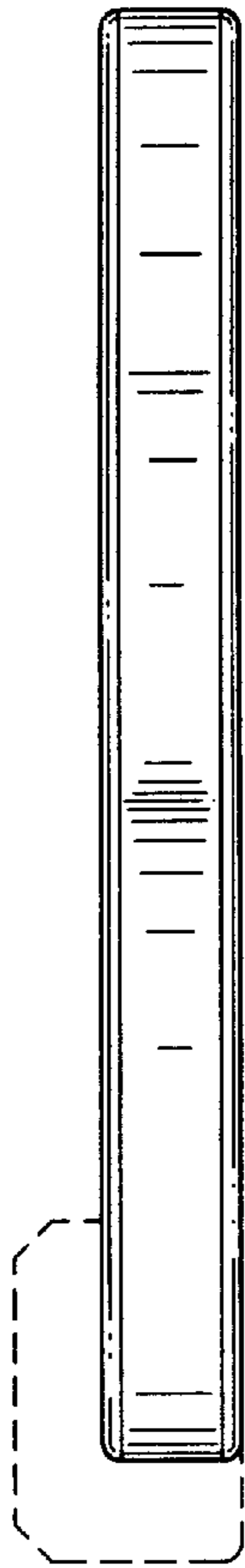

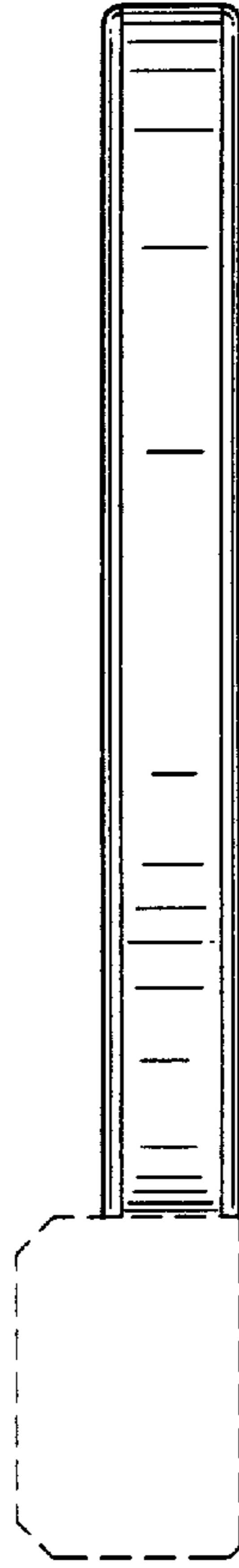

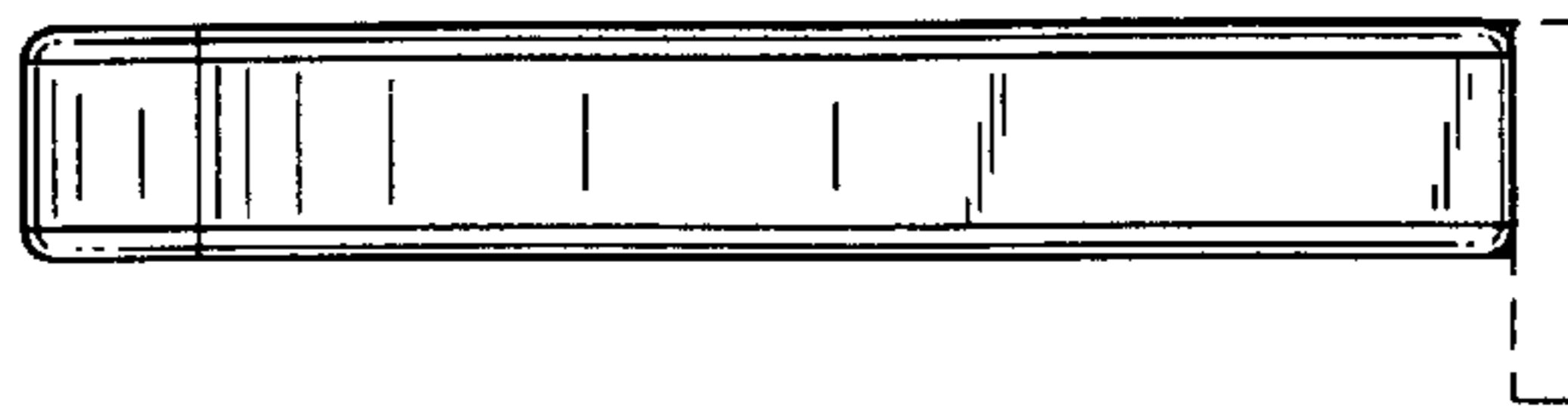

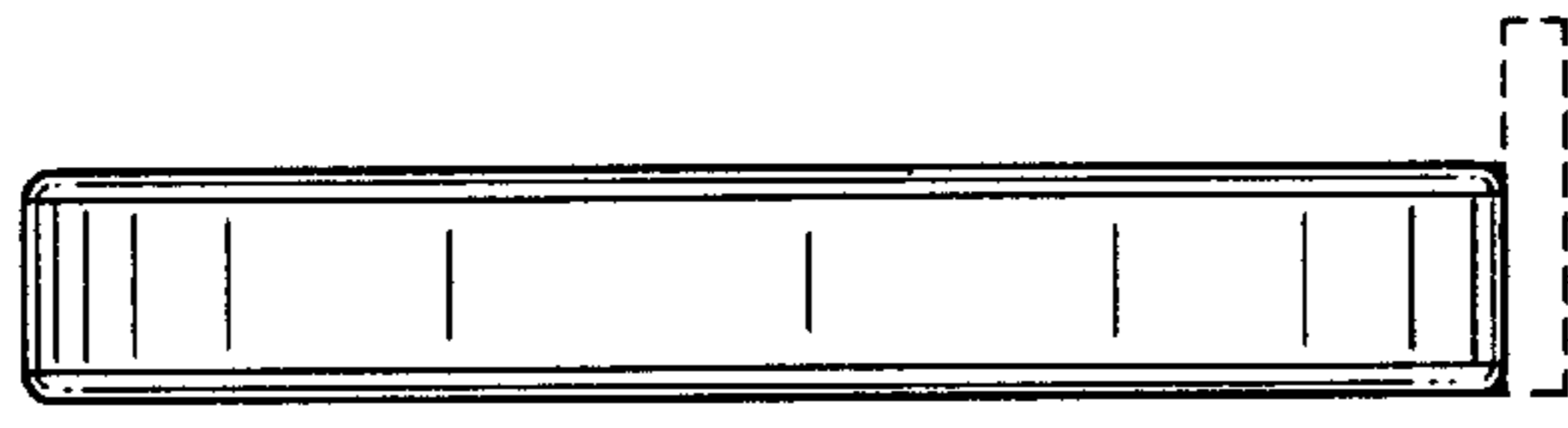
