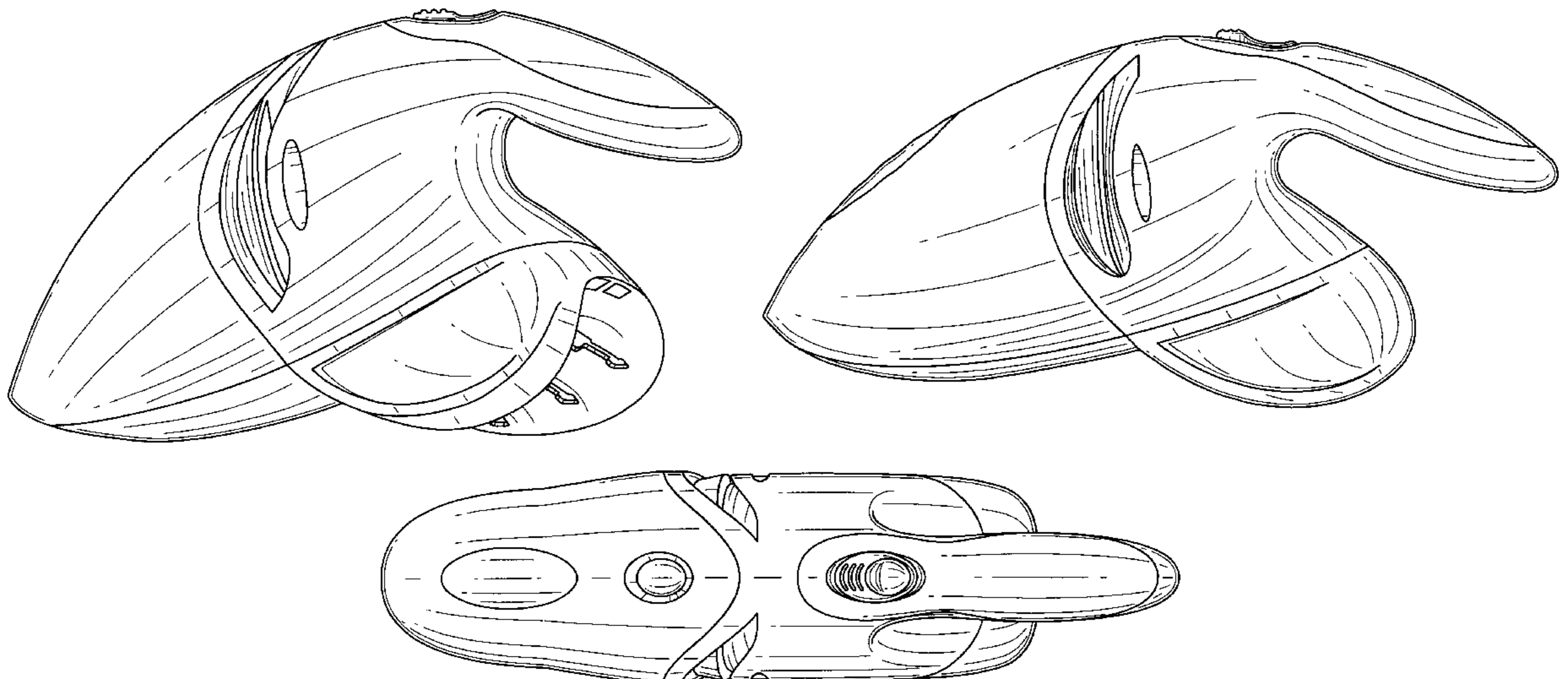
(57) **CLAIM**

The ornamental design for a hand held vacuum cleaner, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of hand held vacuum cleaner showing my new design;  
 FIG. 2 is a front perspective view thereof;  
 FIG. 3 is a side view thereof taken from the side illustrated in FIG. 1;  
 FIG. 4 is a side view of the side opposite that illustrated in FIG. 3;  
 FIG. 5 is a top view thereof;  
 FIG. 6 is a bottom view thereof;  
 FIG. 7 is a front view thereof; and,  
 FIG. 8 is a rear view.

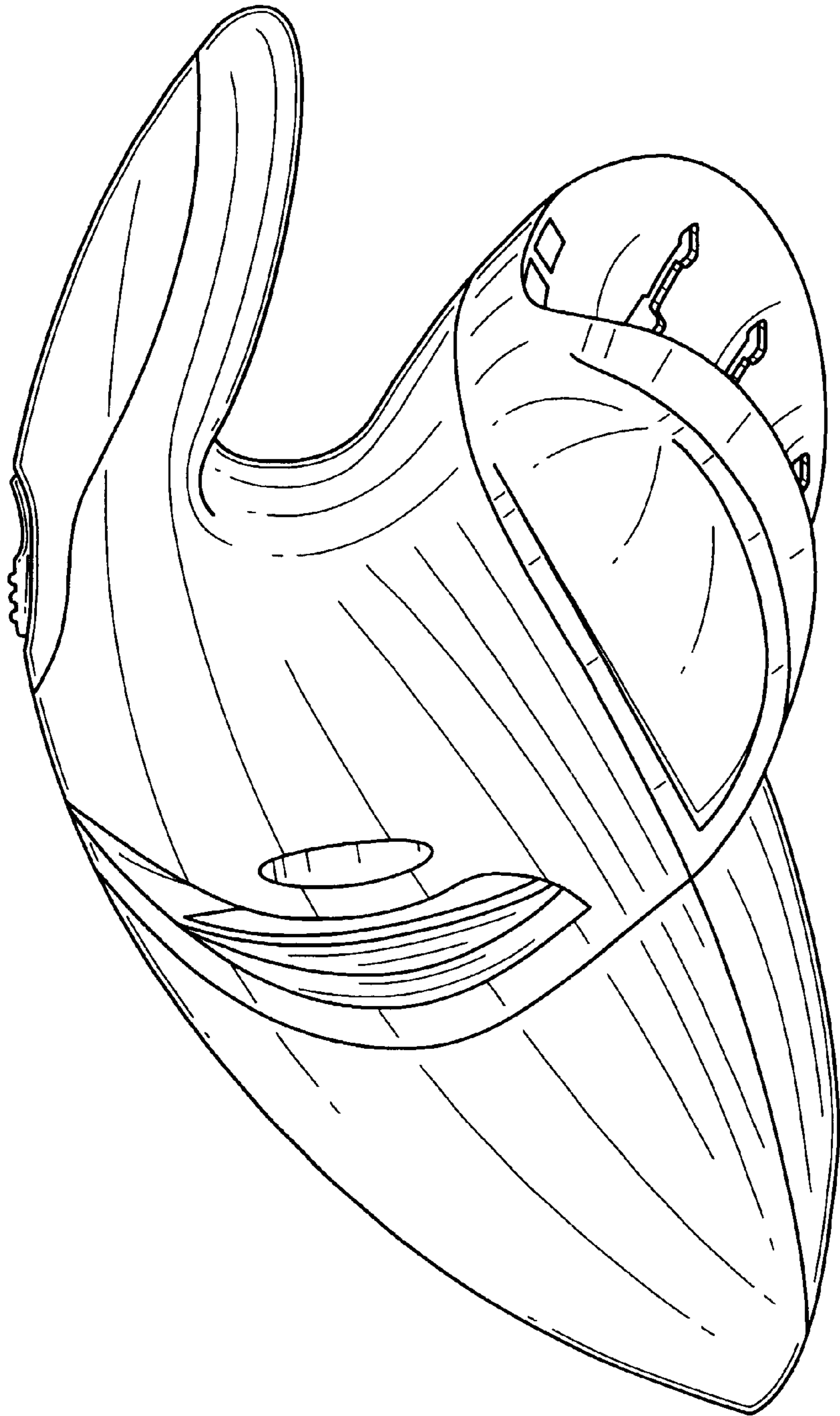

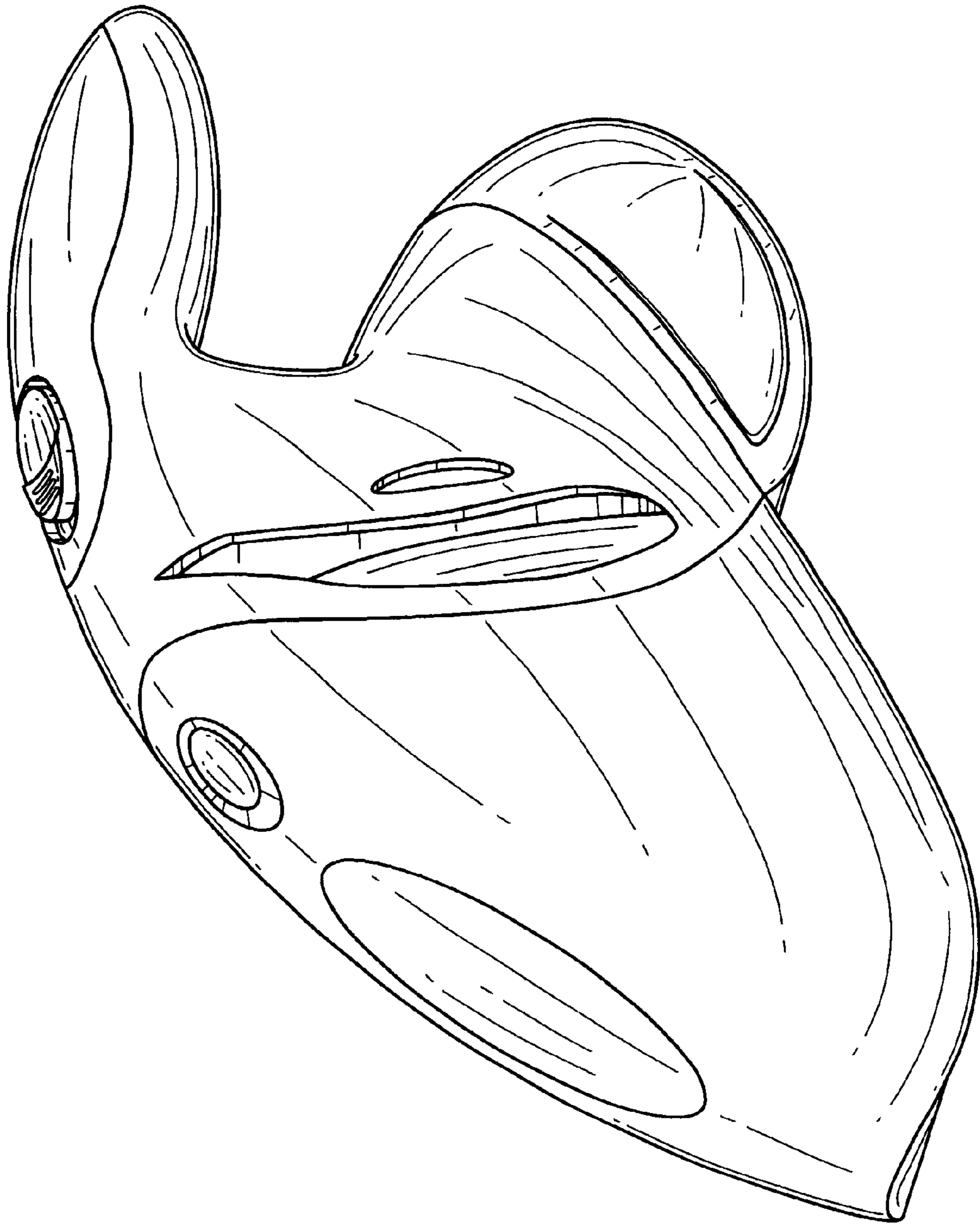

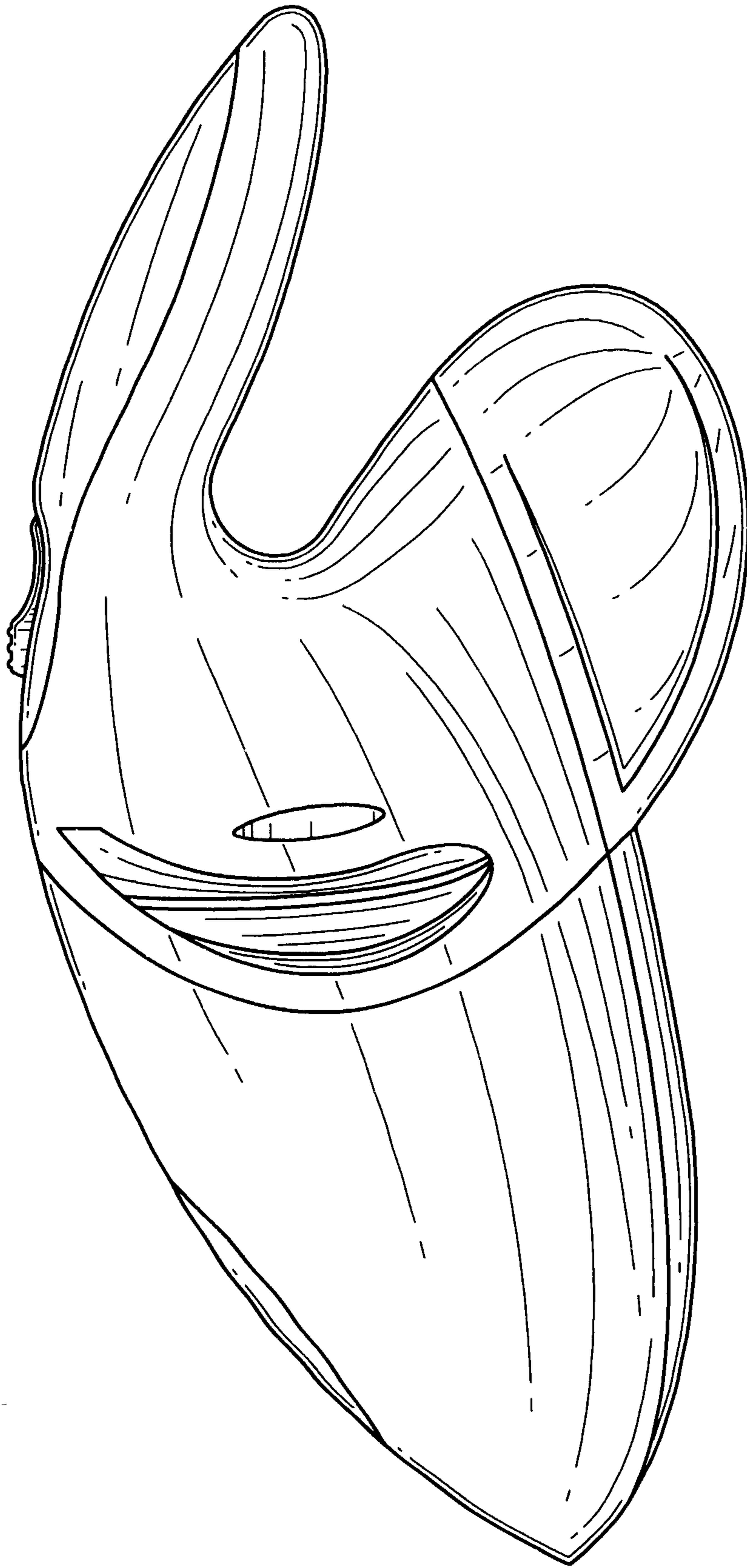

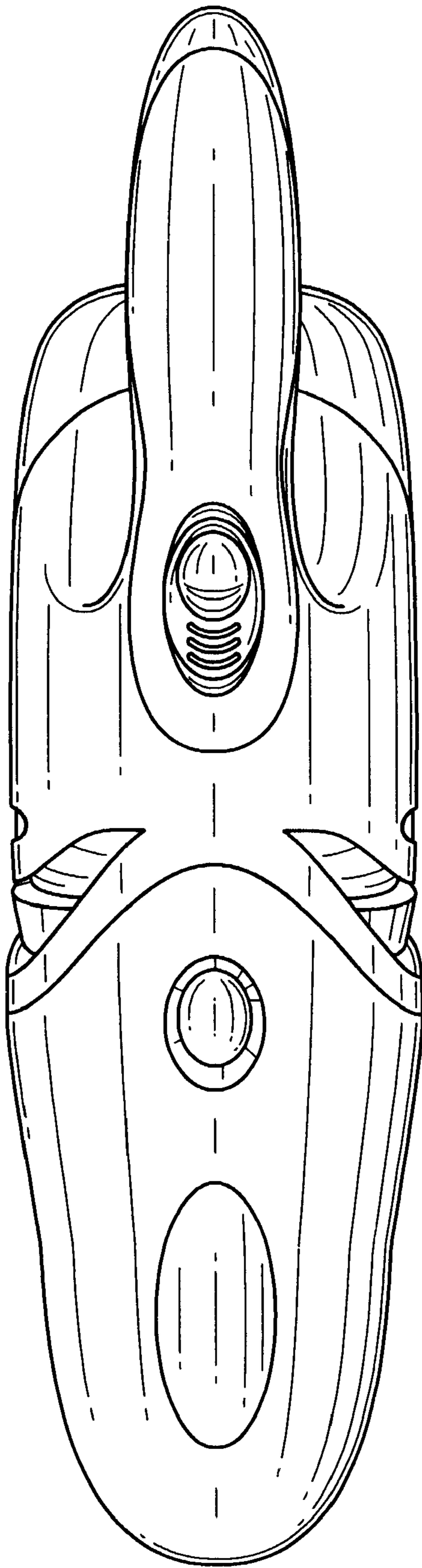

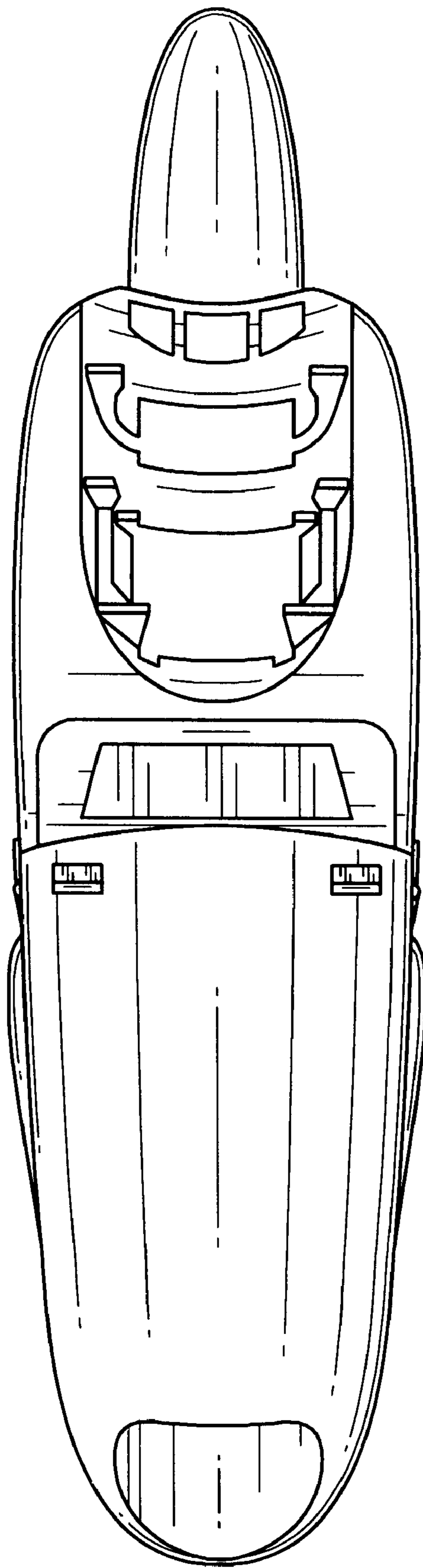

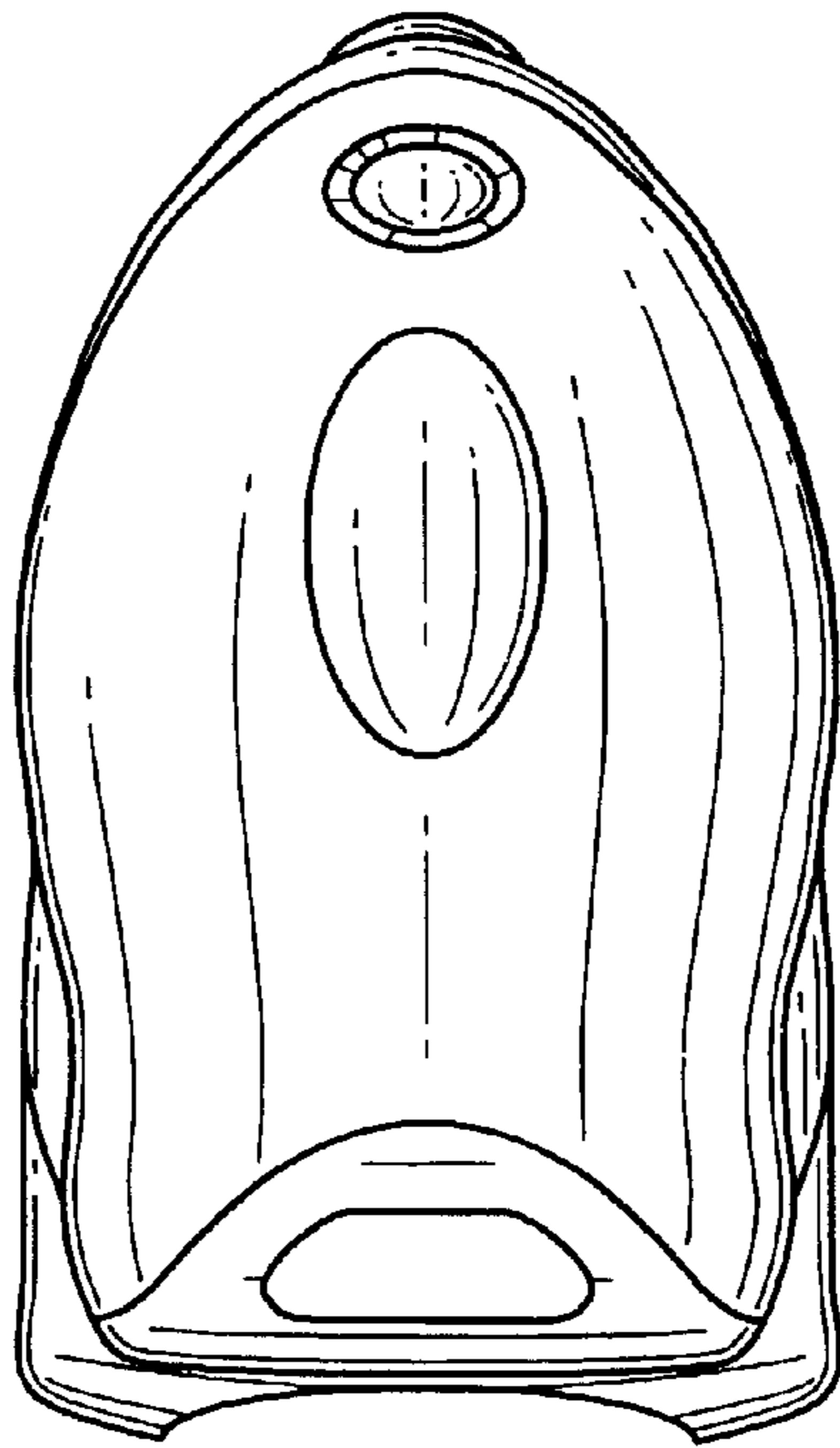

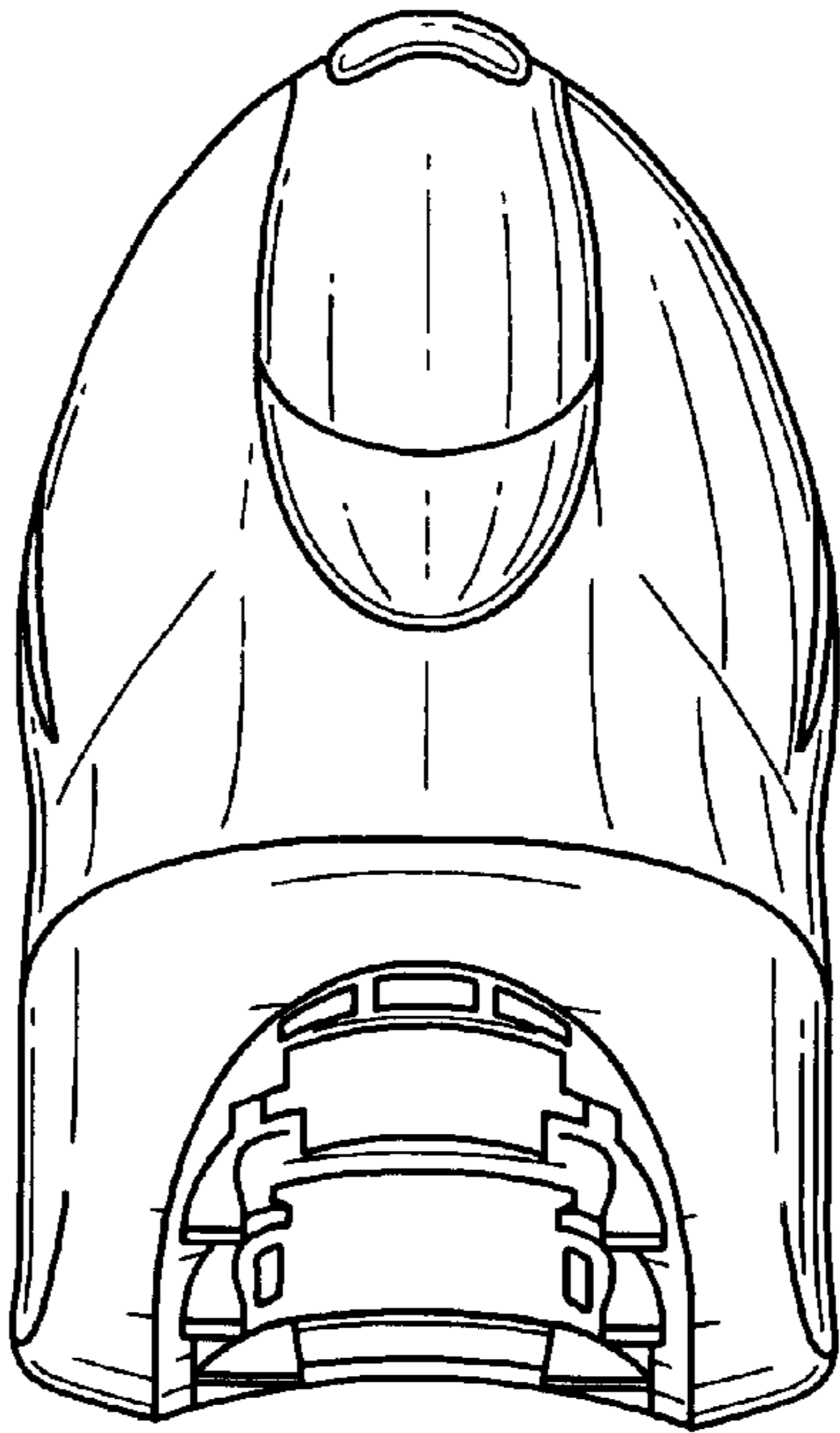
