FIG. 12 is a top plan view of the second embodiment of the design, the sole difference being the configuration of the club head.

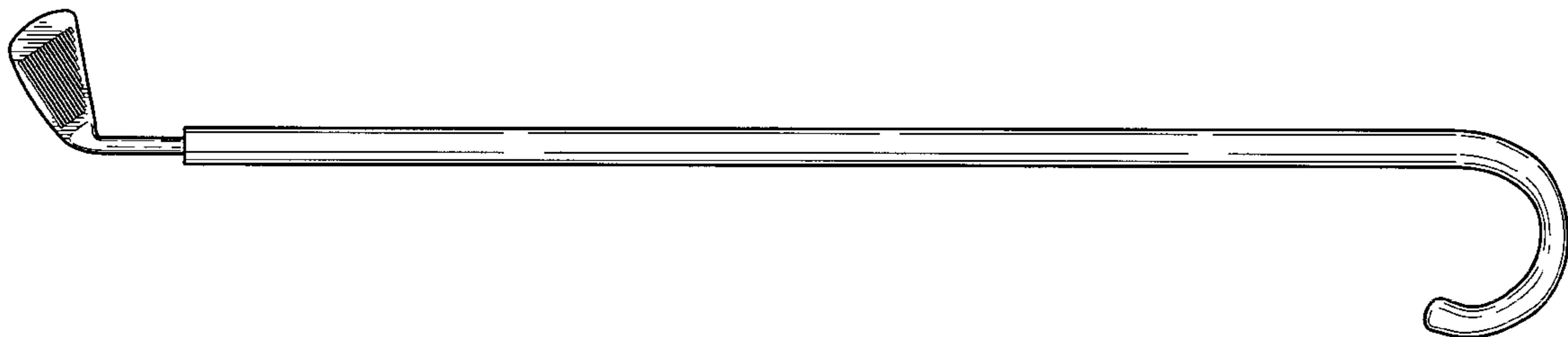

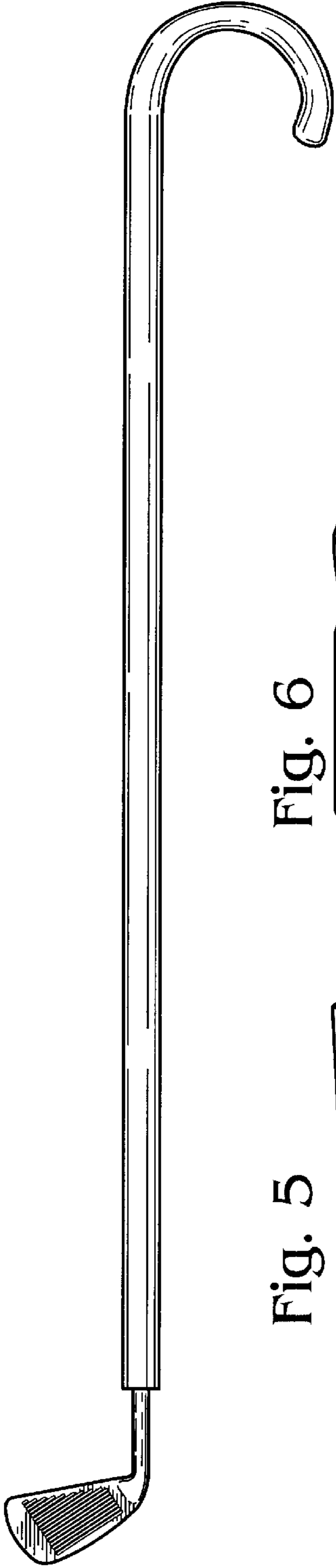

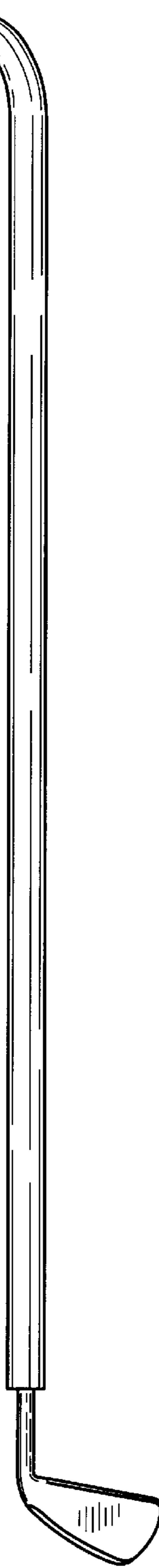

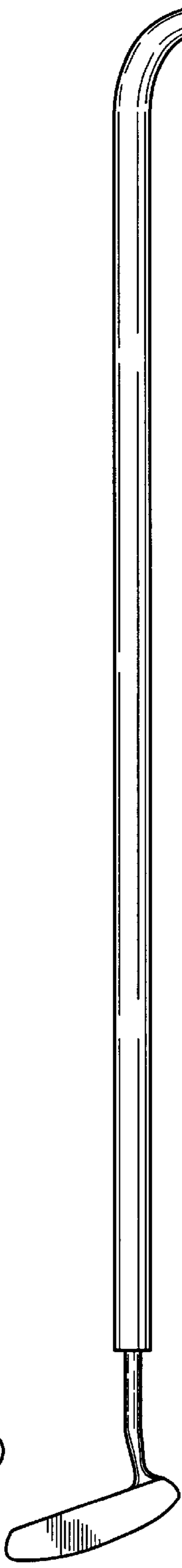

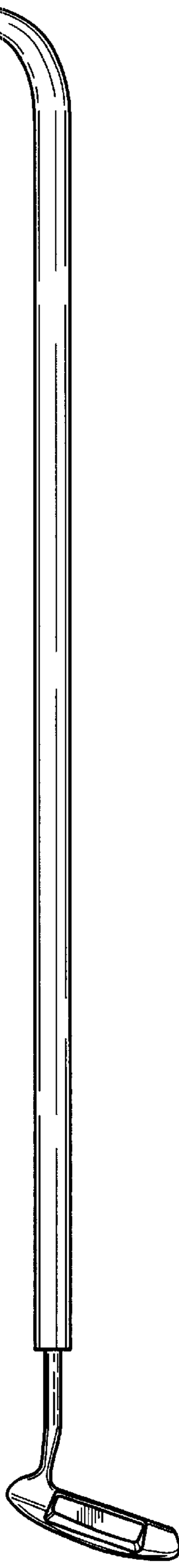

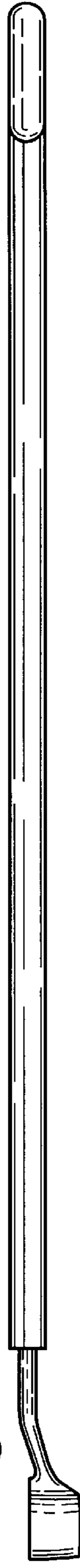
