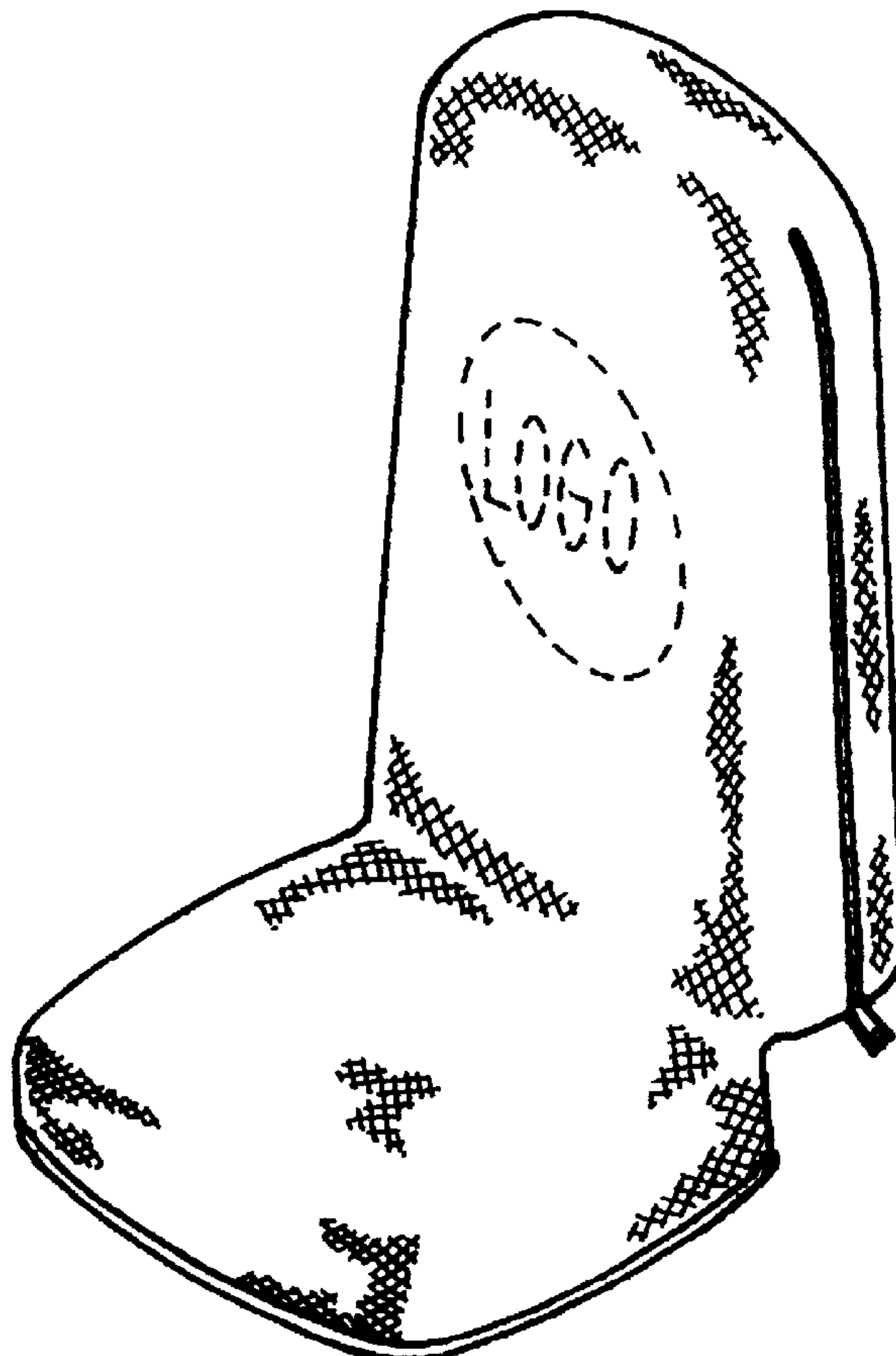
(57) **CLAIM**

**DESCRIPTION**

FIG. 1 is a perspective view of a seat cover embodying the design of the present invention.  
FIG. 2 is a front elevational view thereof;

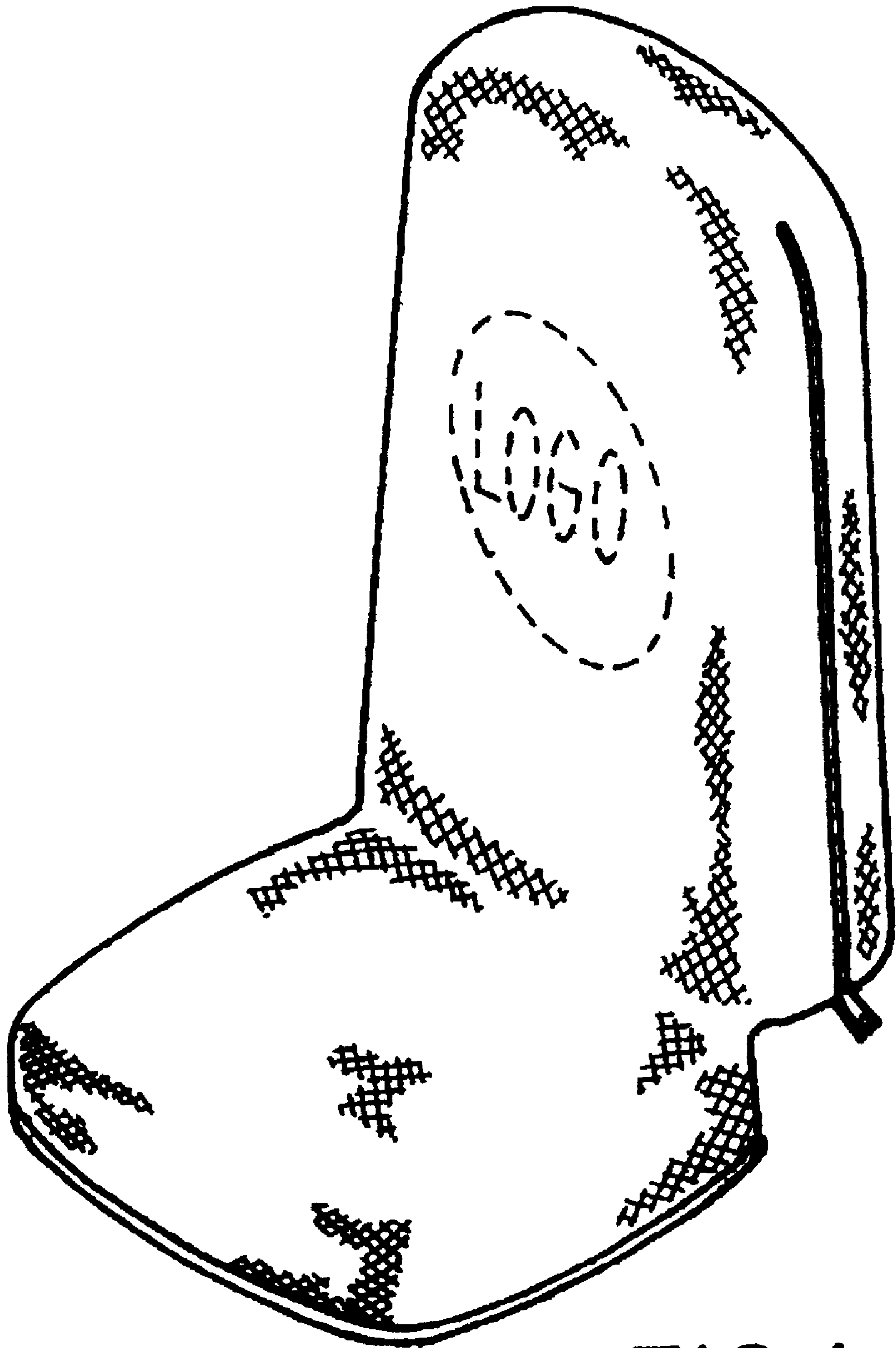

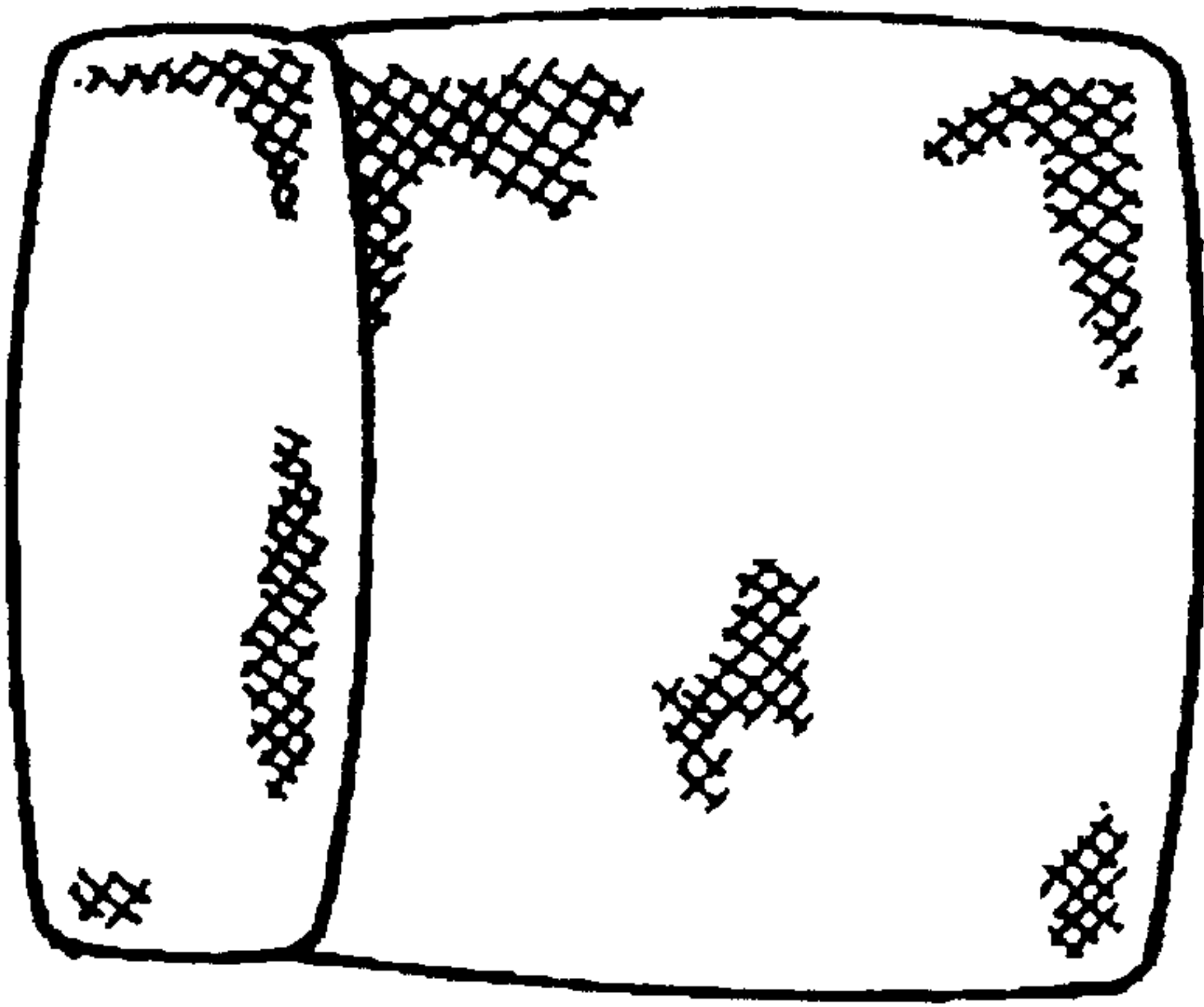

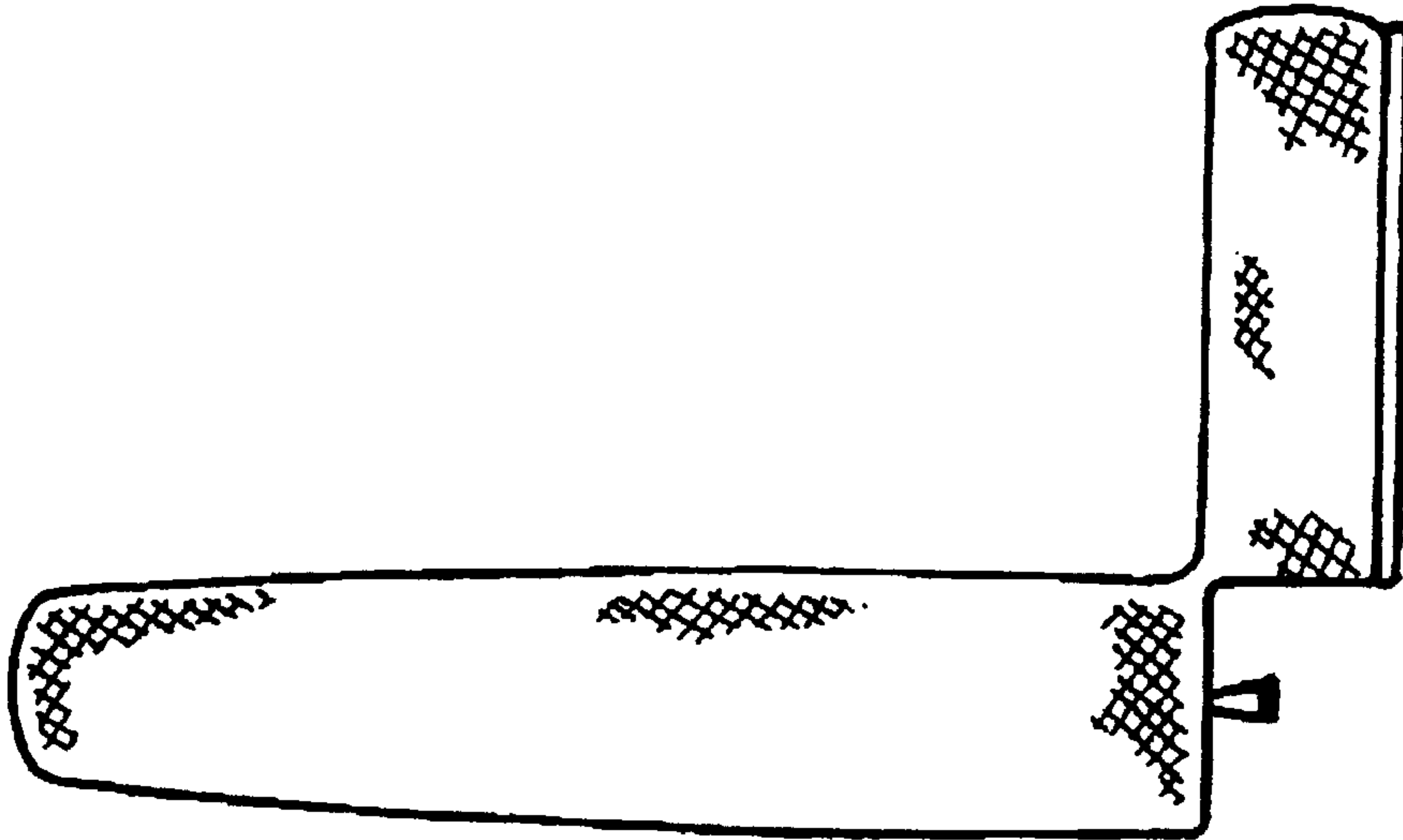

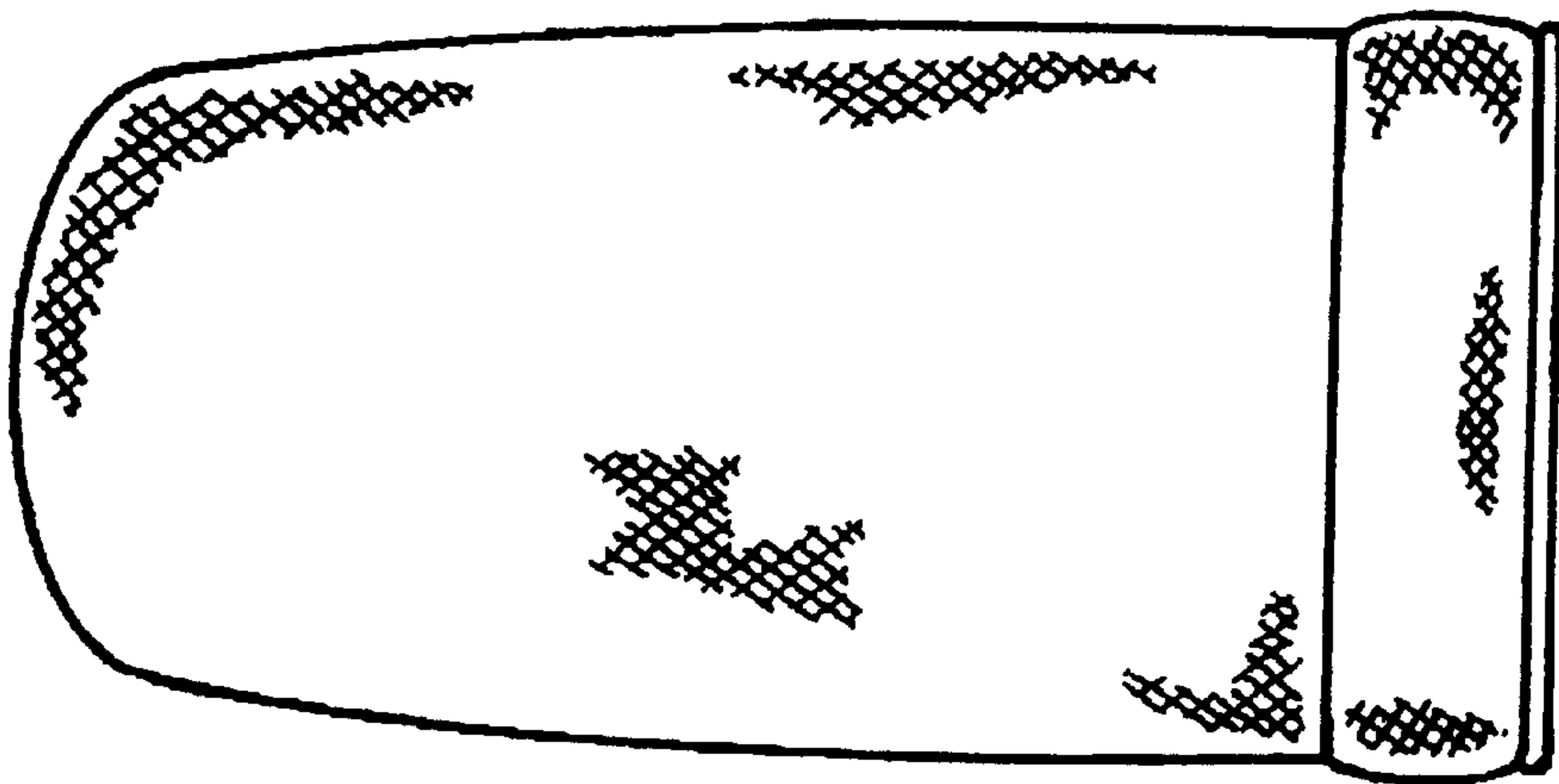

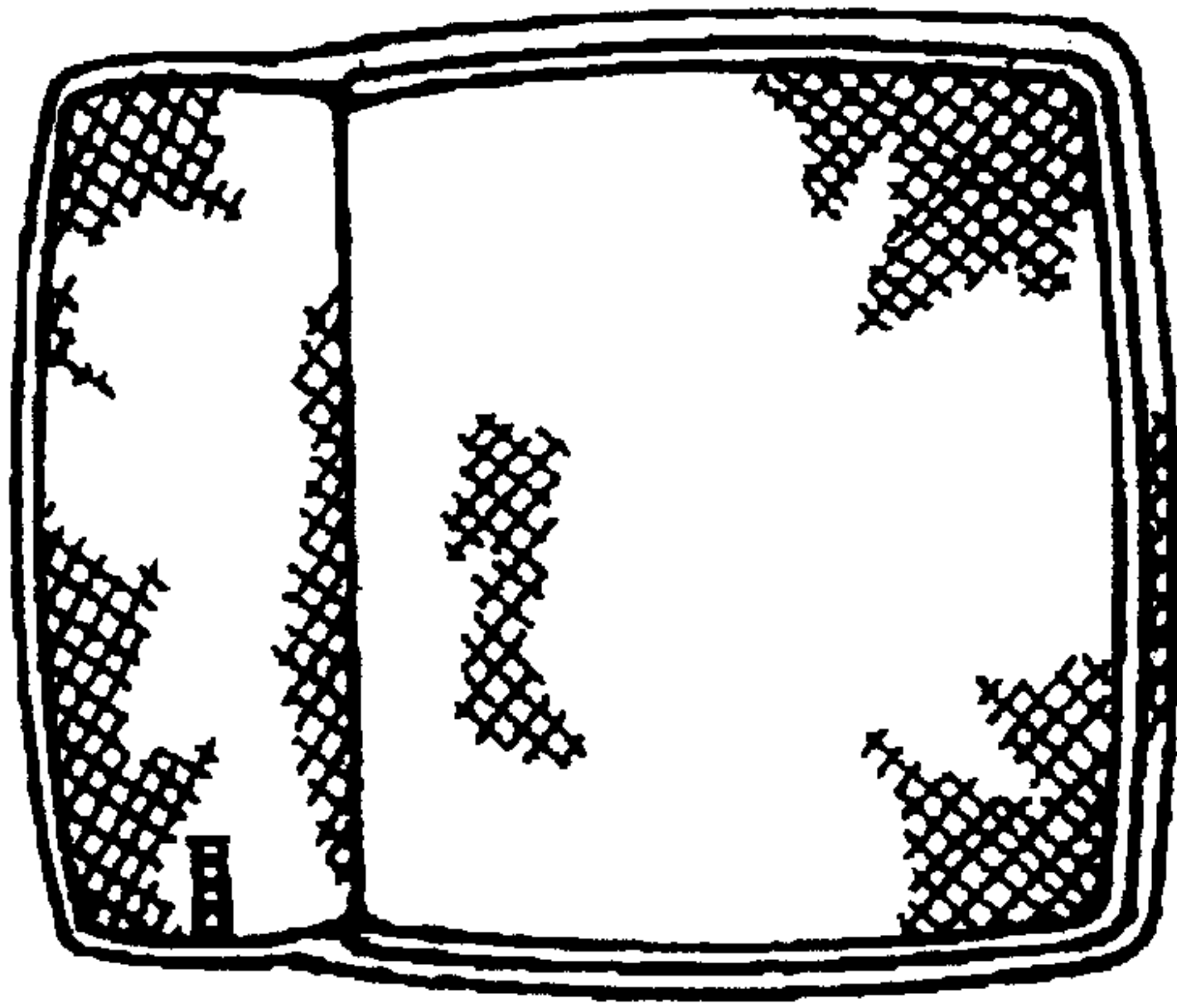

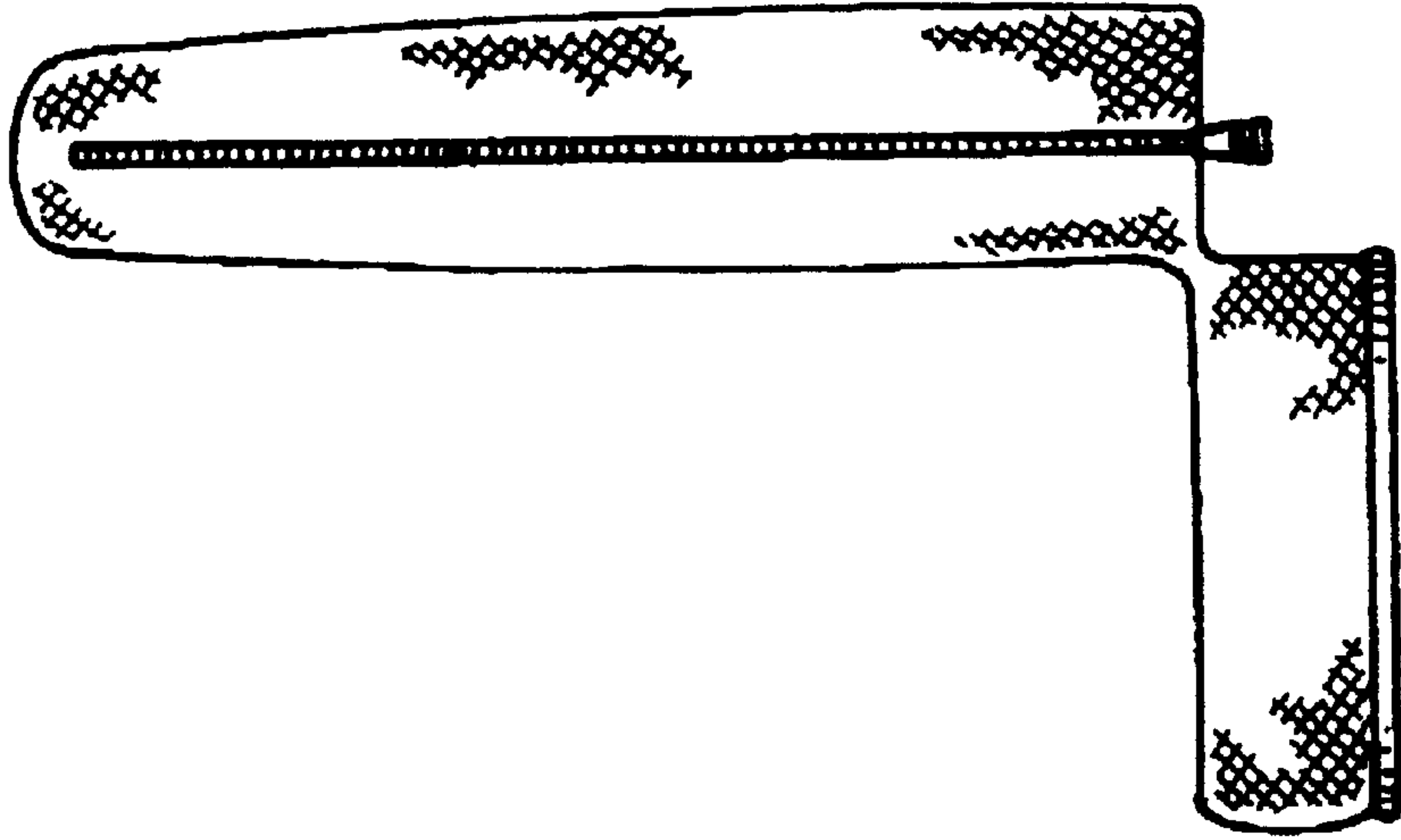

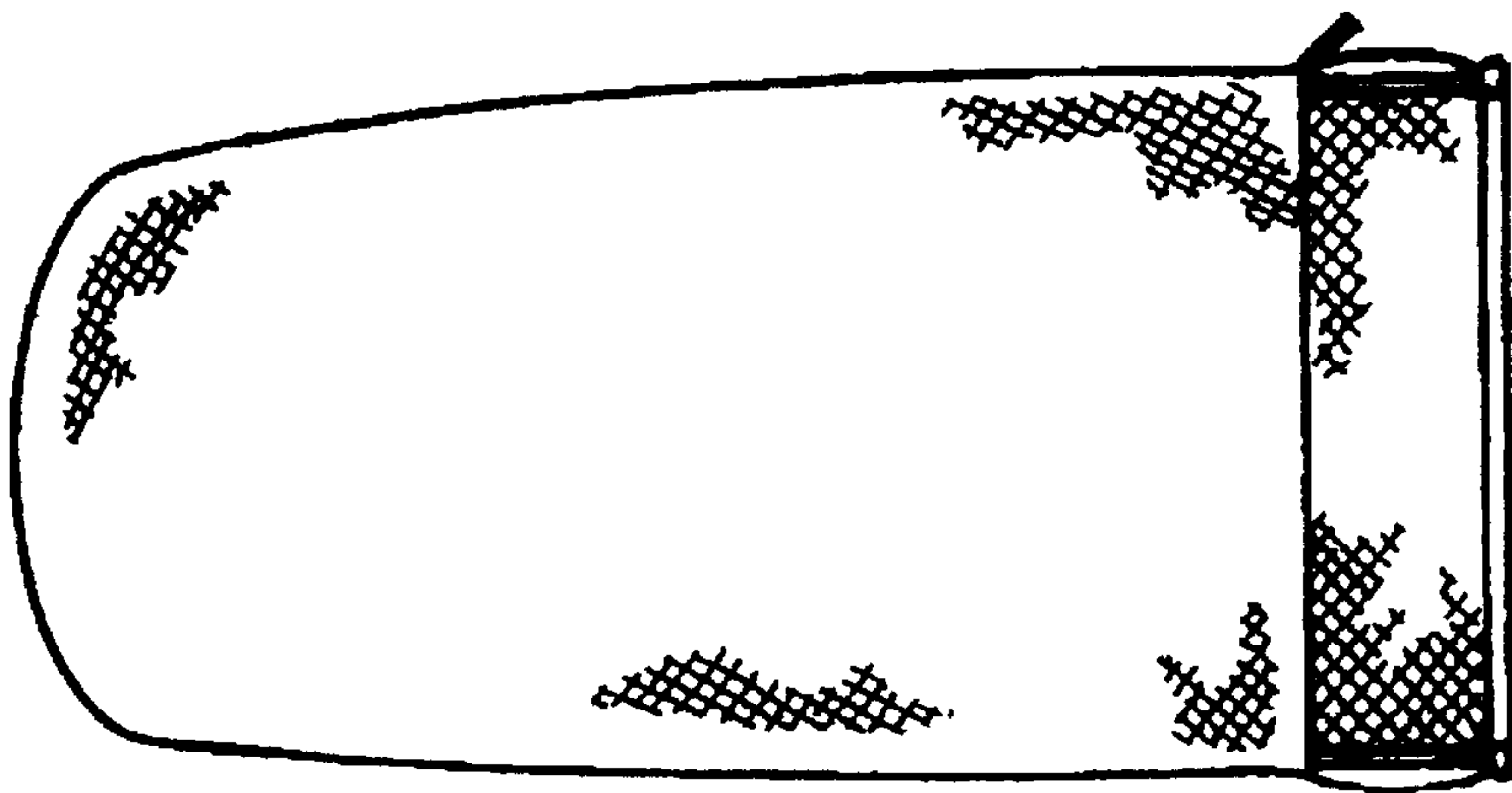
